The ornamental design for an electromagnetic valve assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a top and right front perspective view of an electromagnetic valve assembly, showing our design; FIG. 2 is a top and left rear perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof.

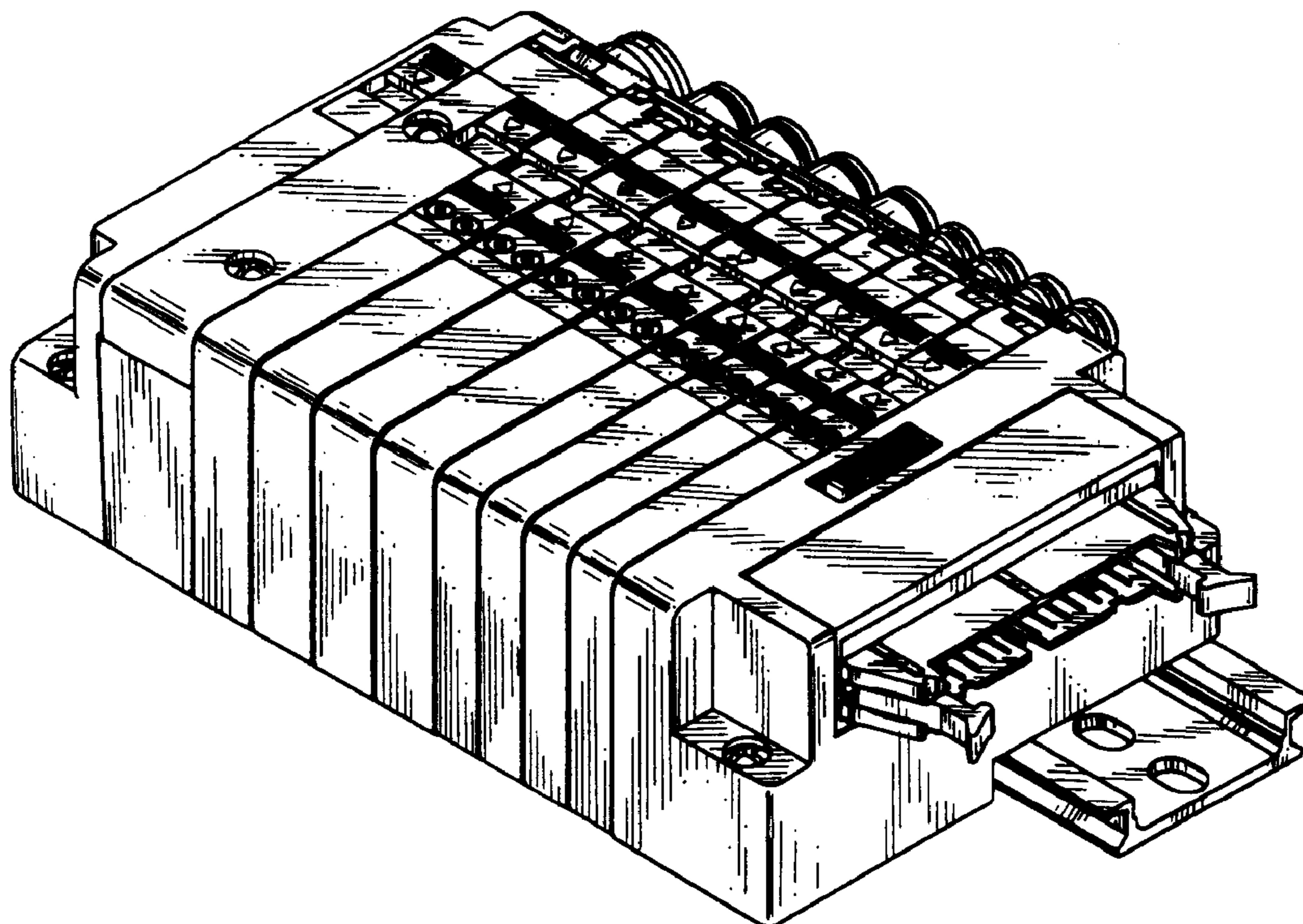

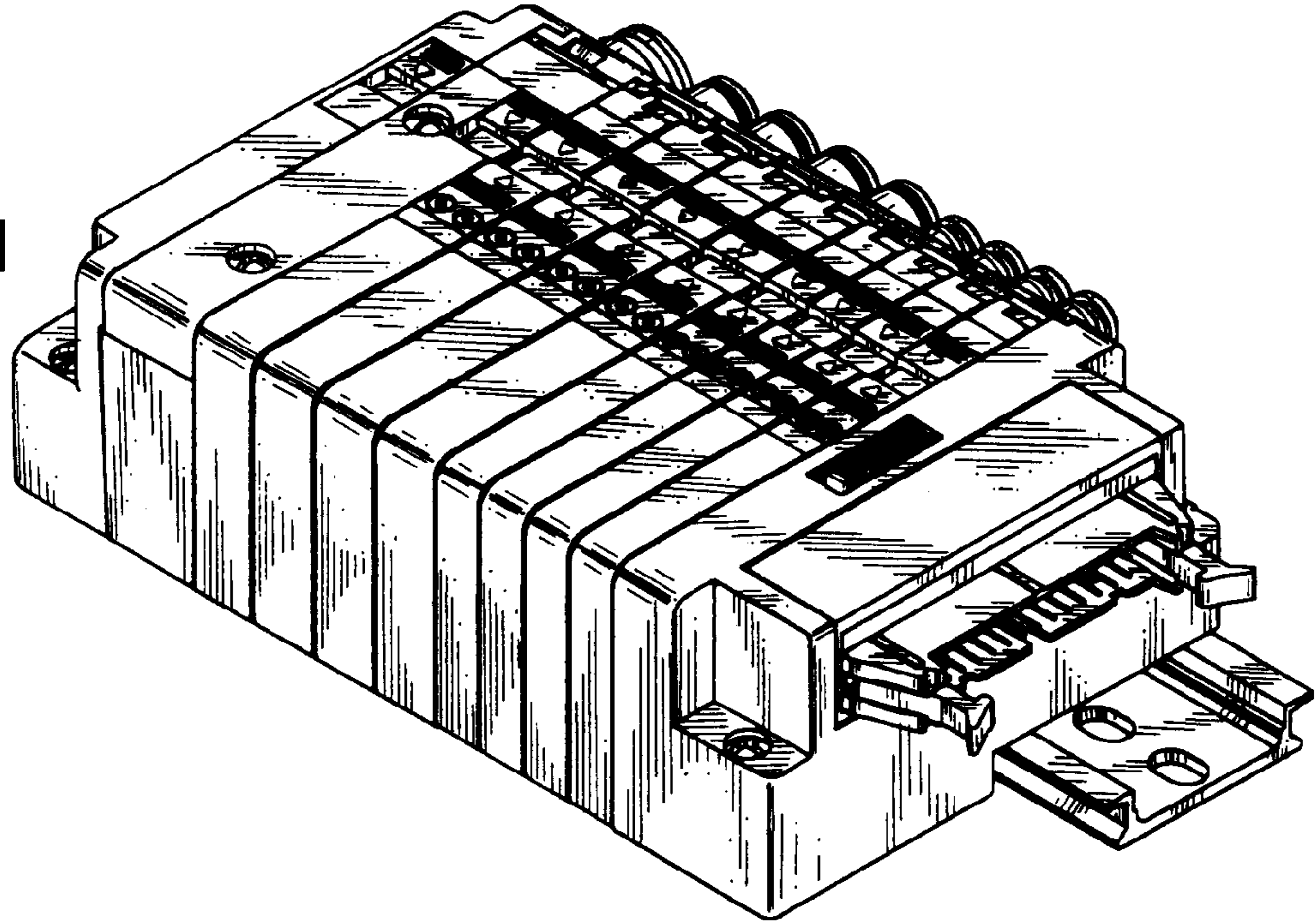

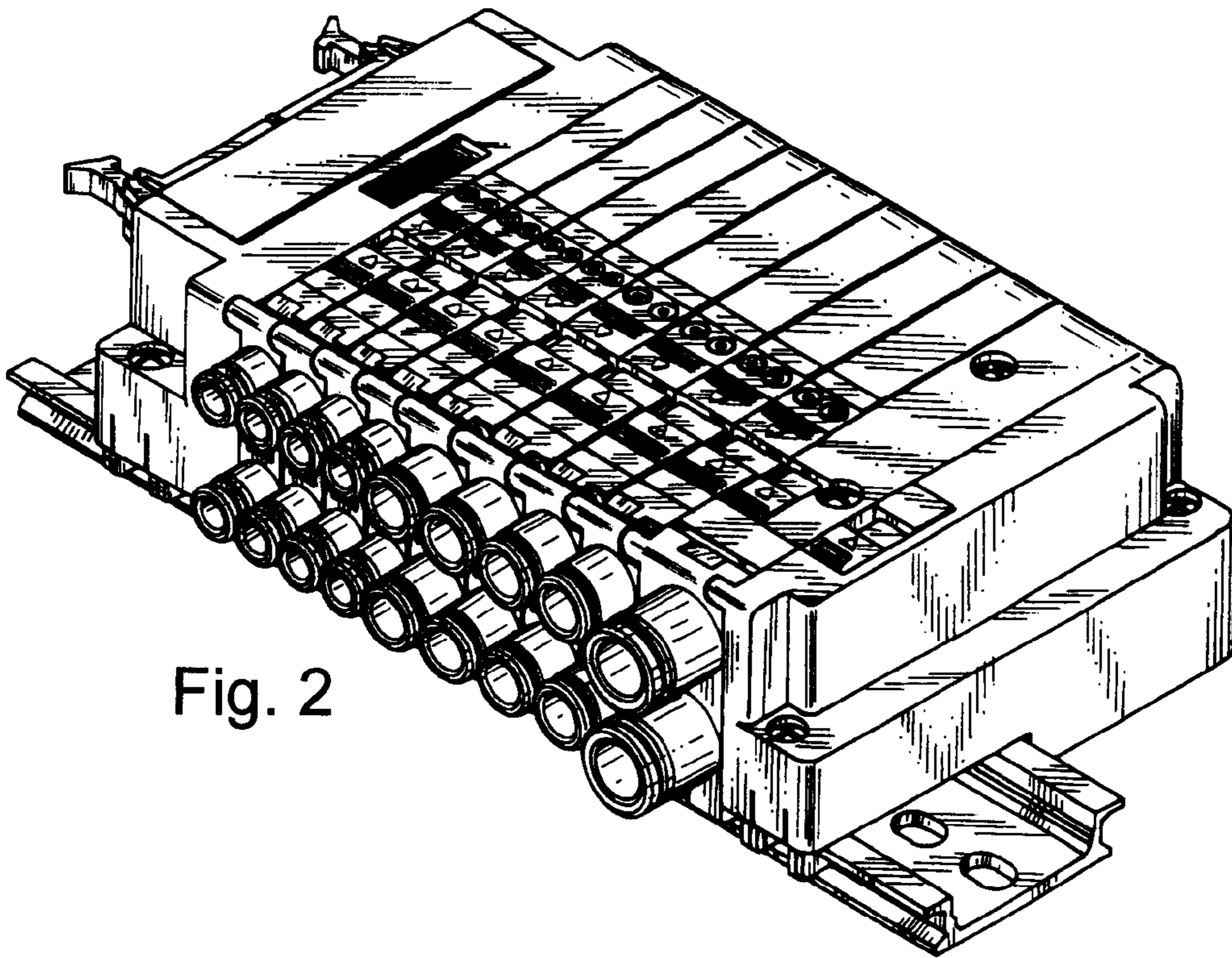

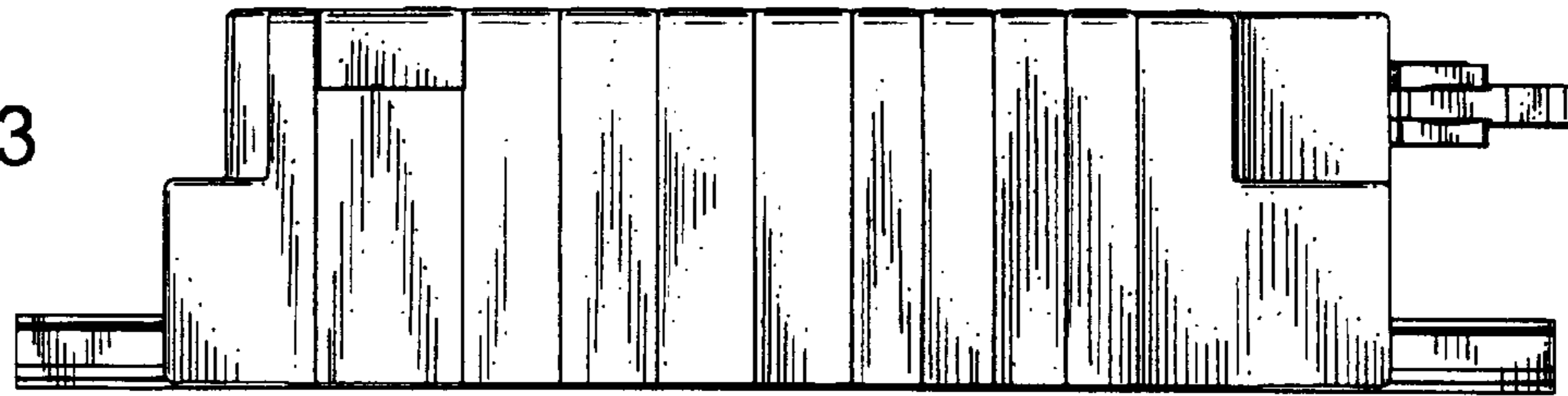

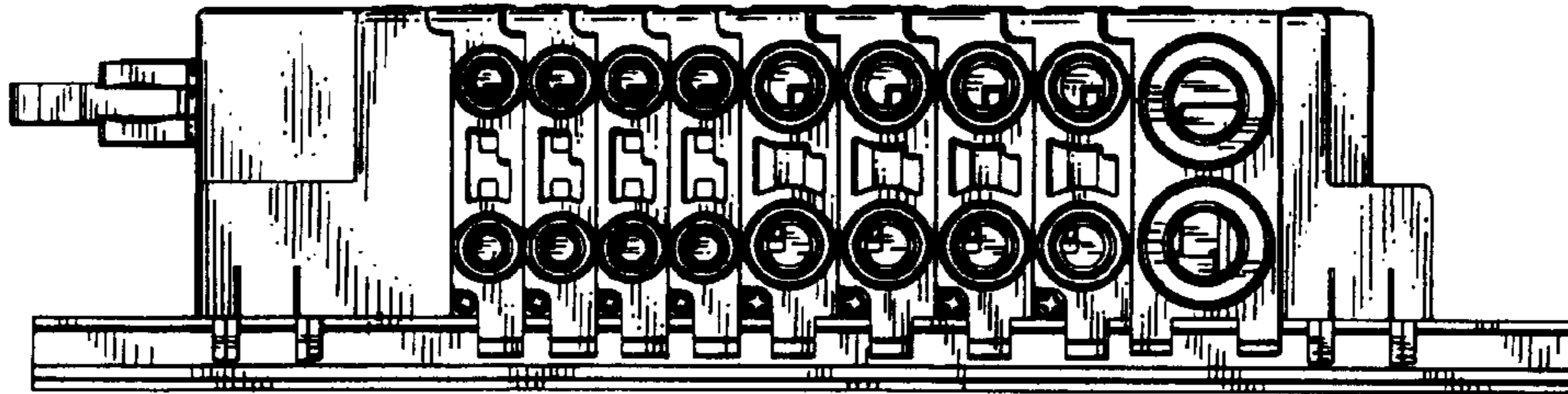

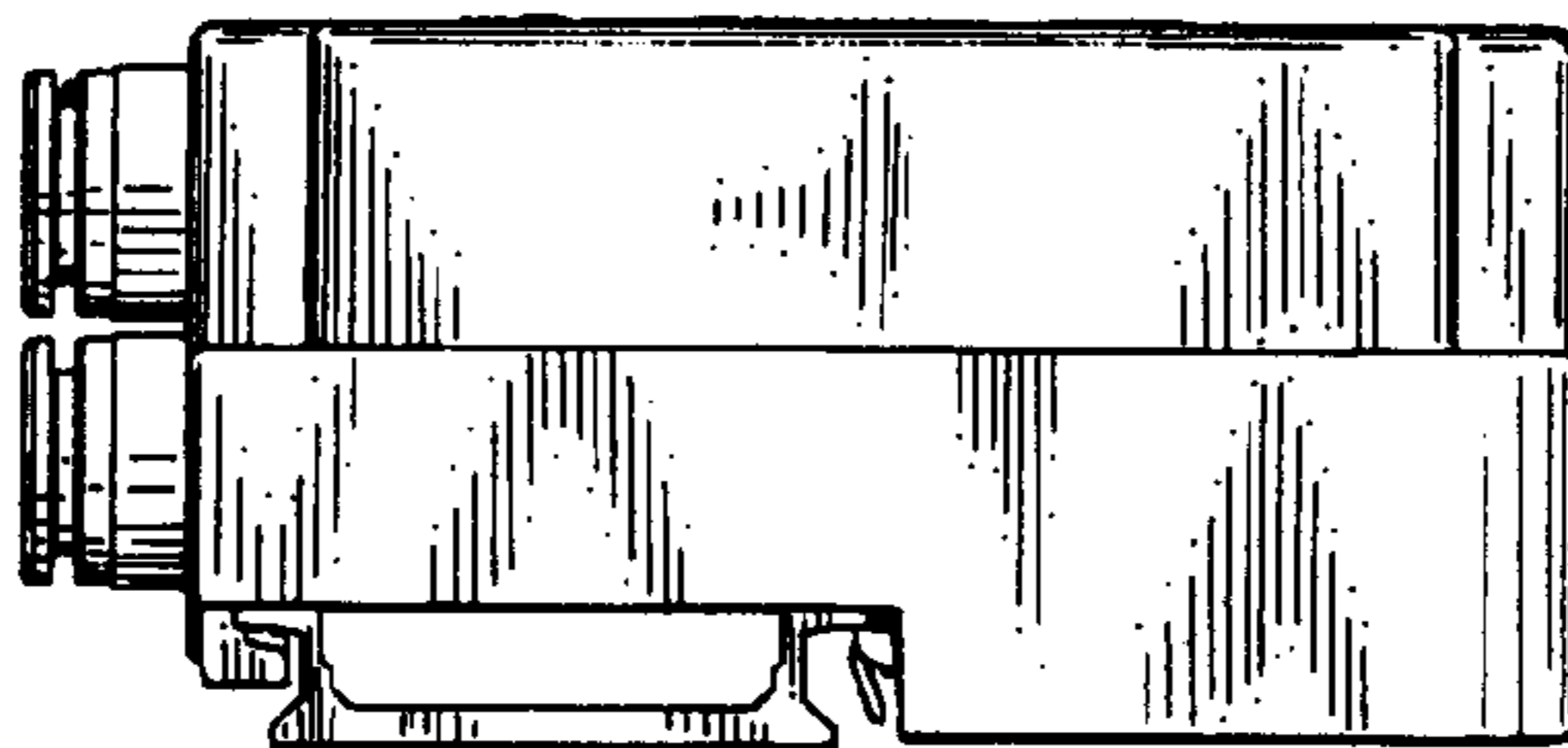
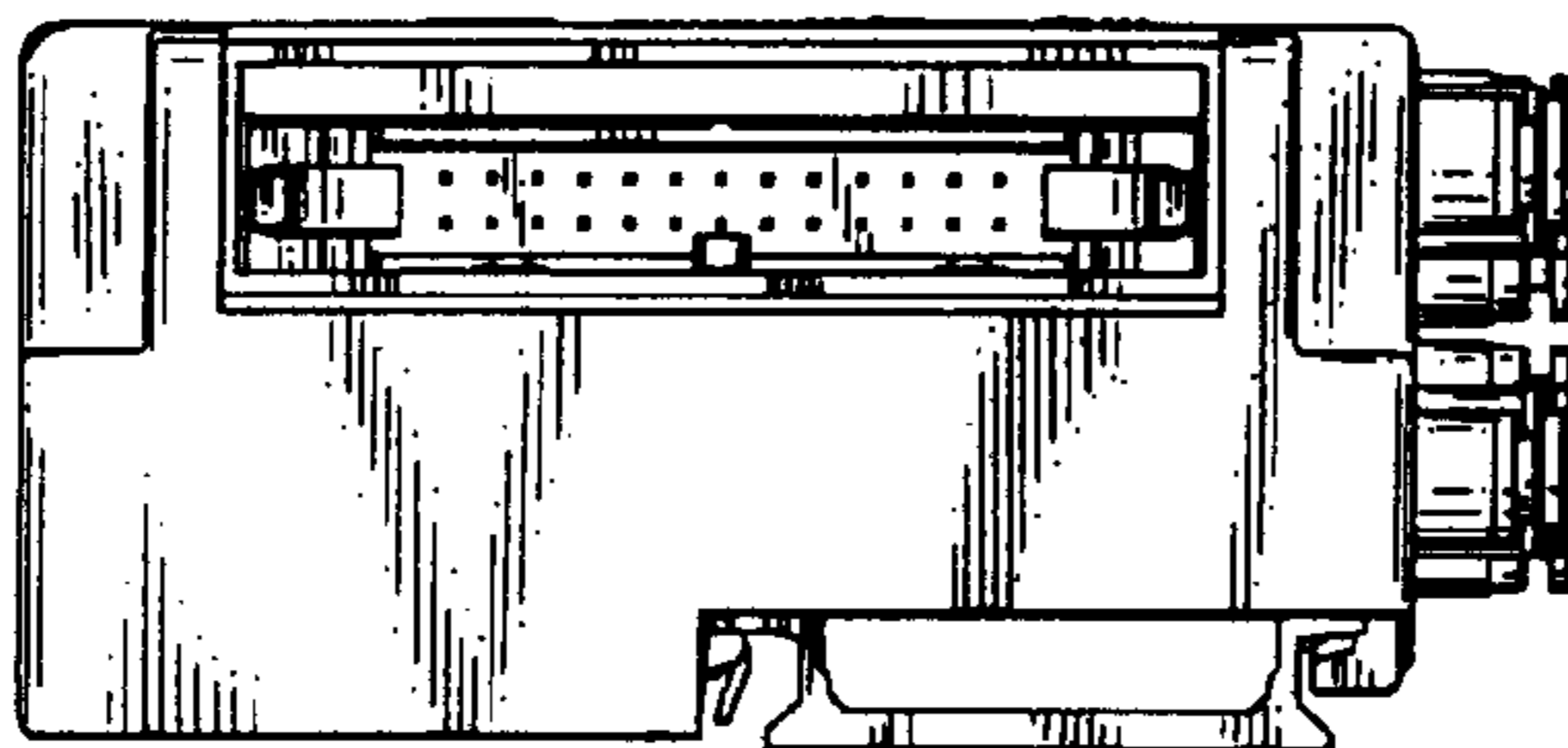

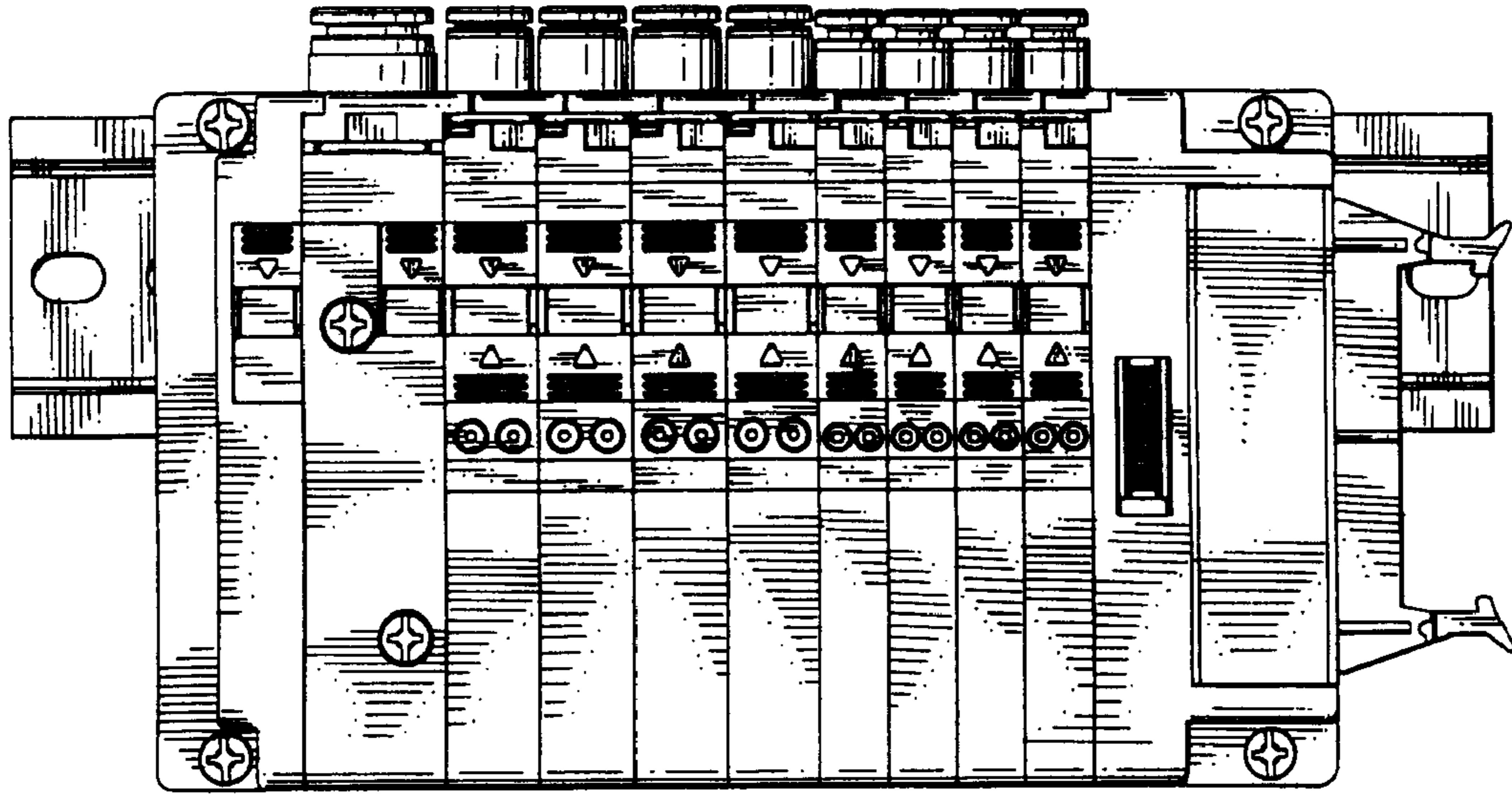

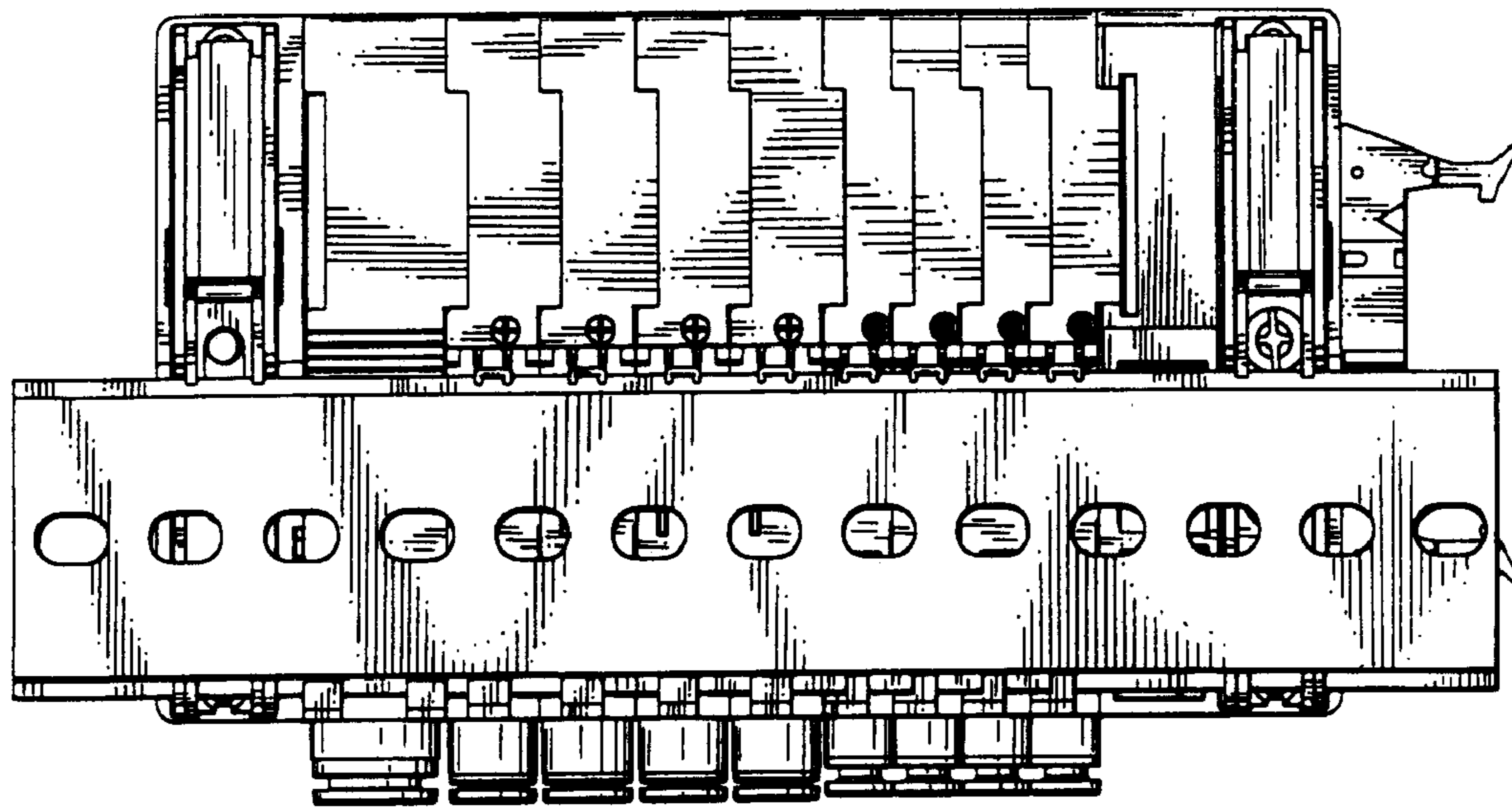
