FIG. 2 is a top view of the cosmetic container of FIG. 1;

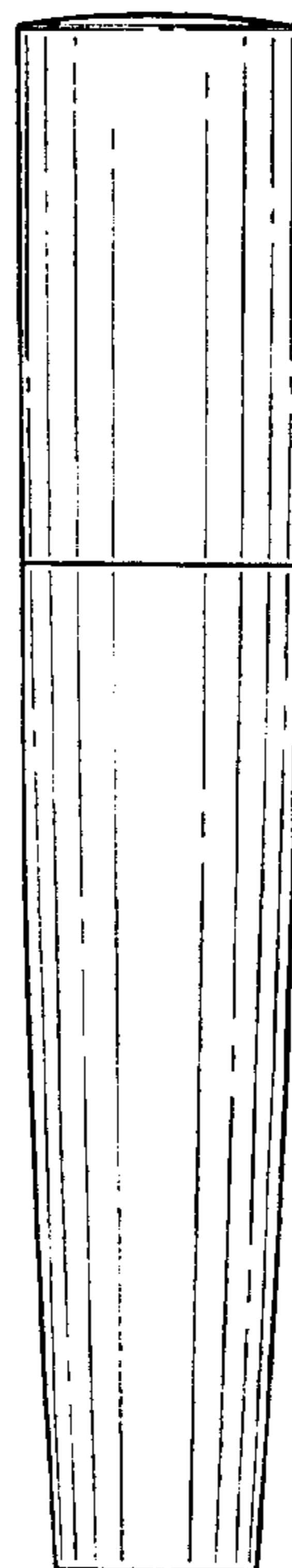
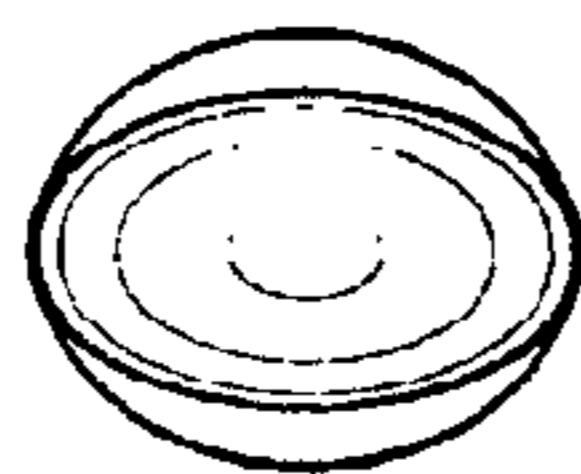
FIG. 3 is a front view of the cosmetic container of FIG. 1,

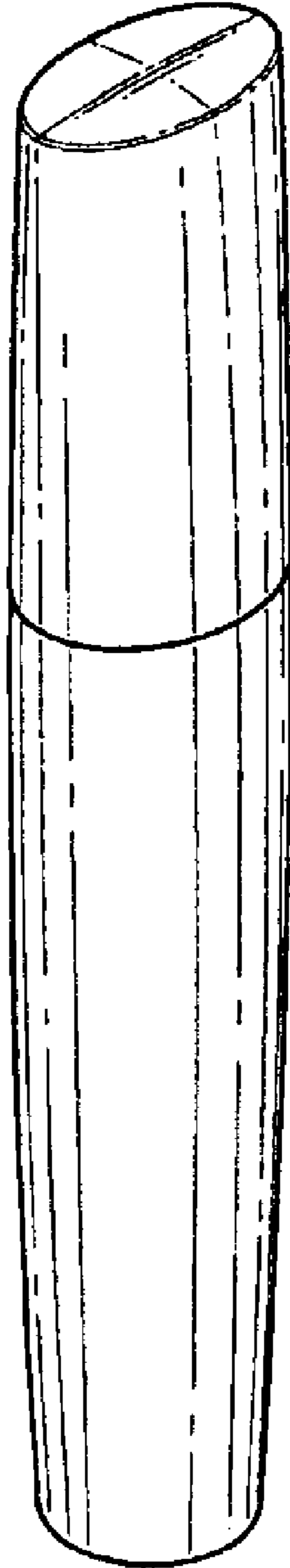

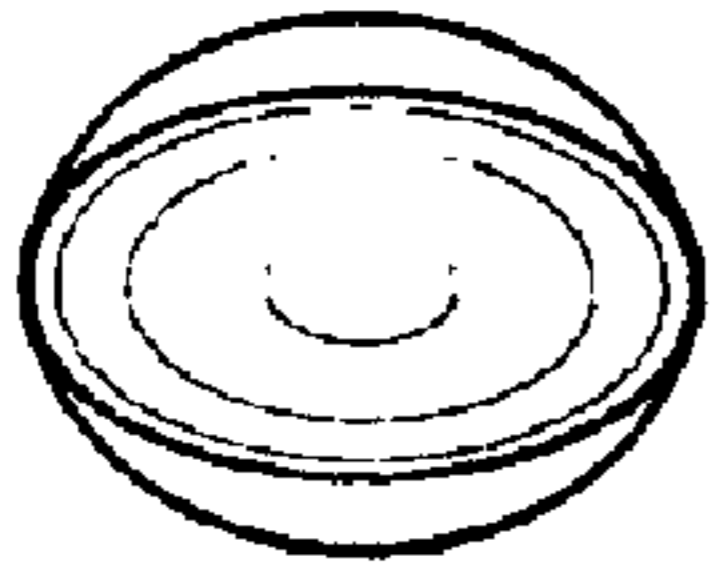

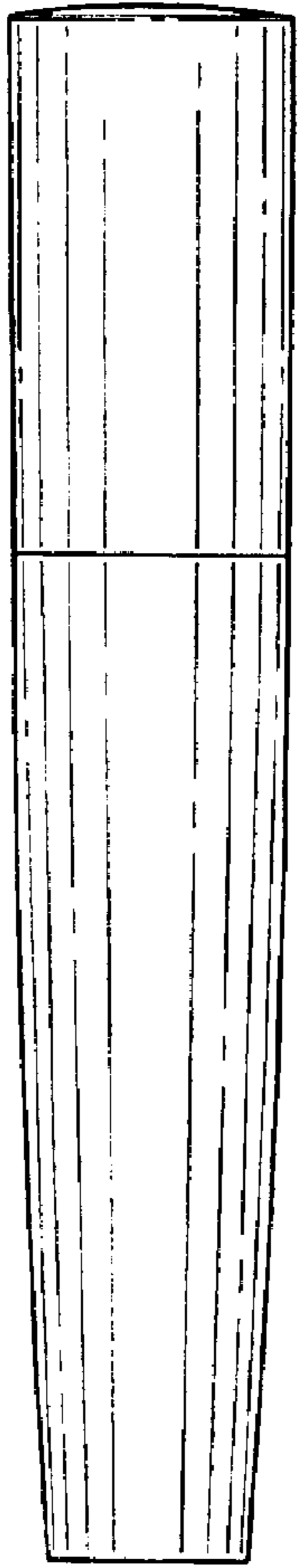

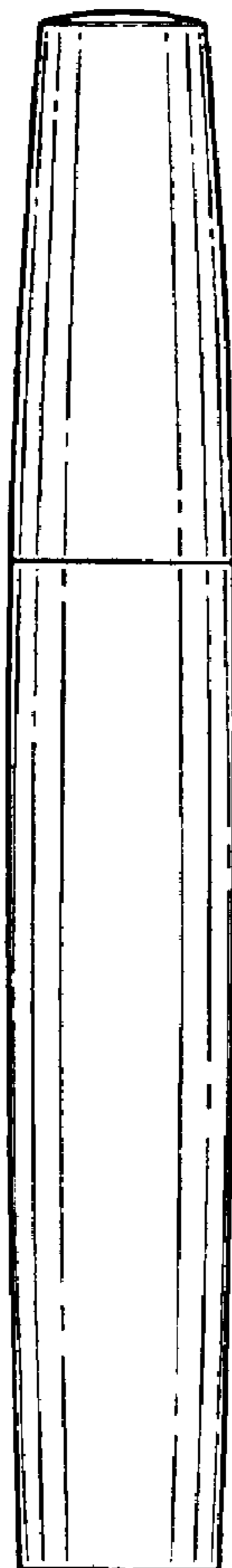
