DESCRIPTION

FIG. 1 is a front perspective view of a tin purse showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a top plan view thereof;

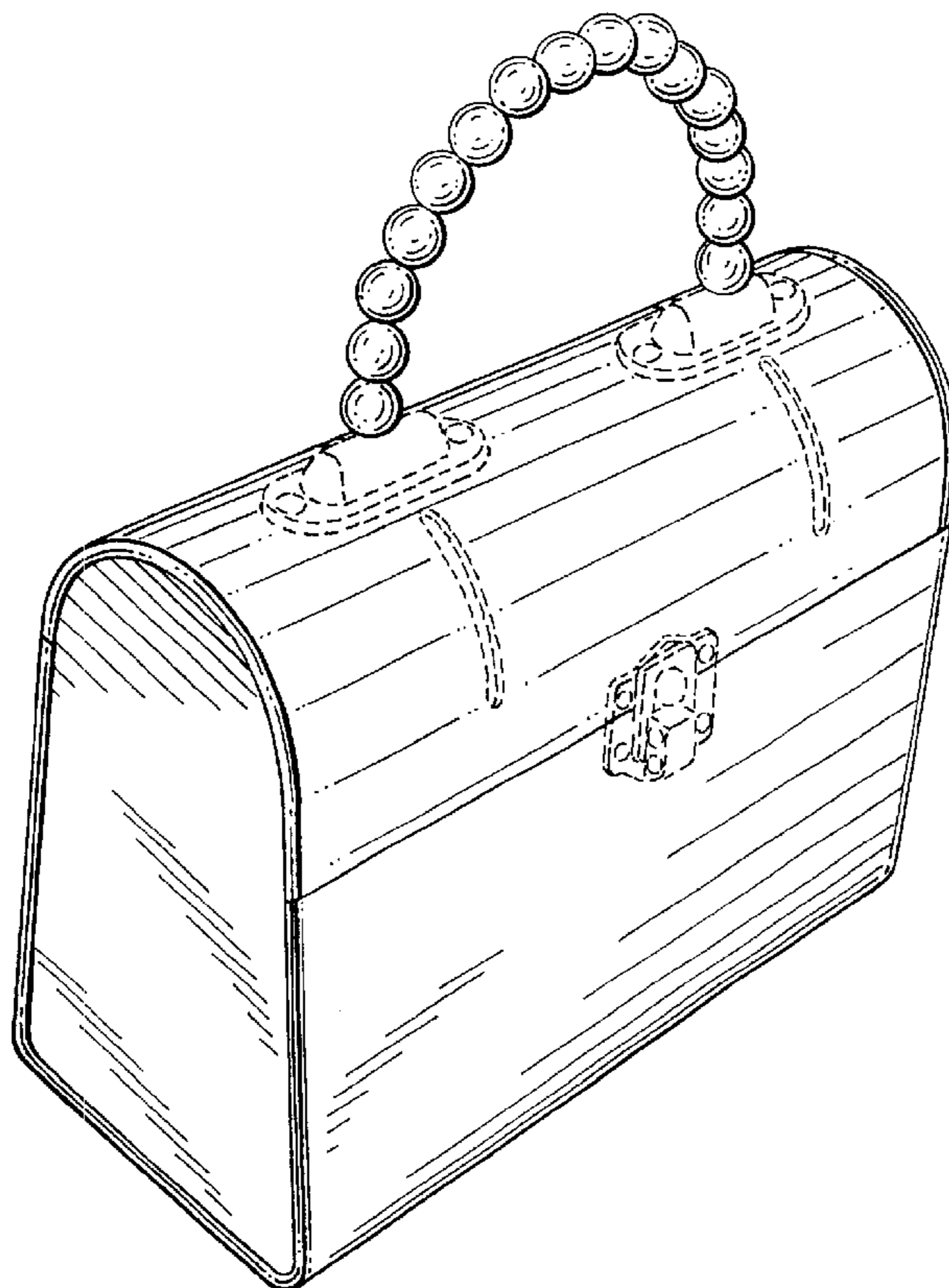
FIG. 4 is right side elevational view, the left side being a mirror image thereof;

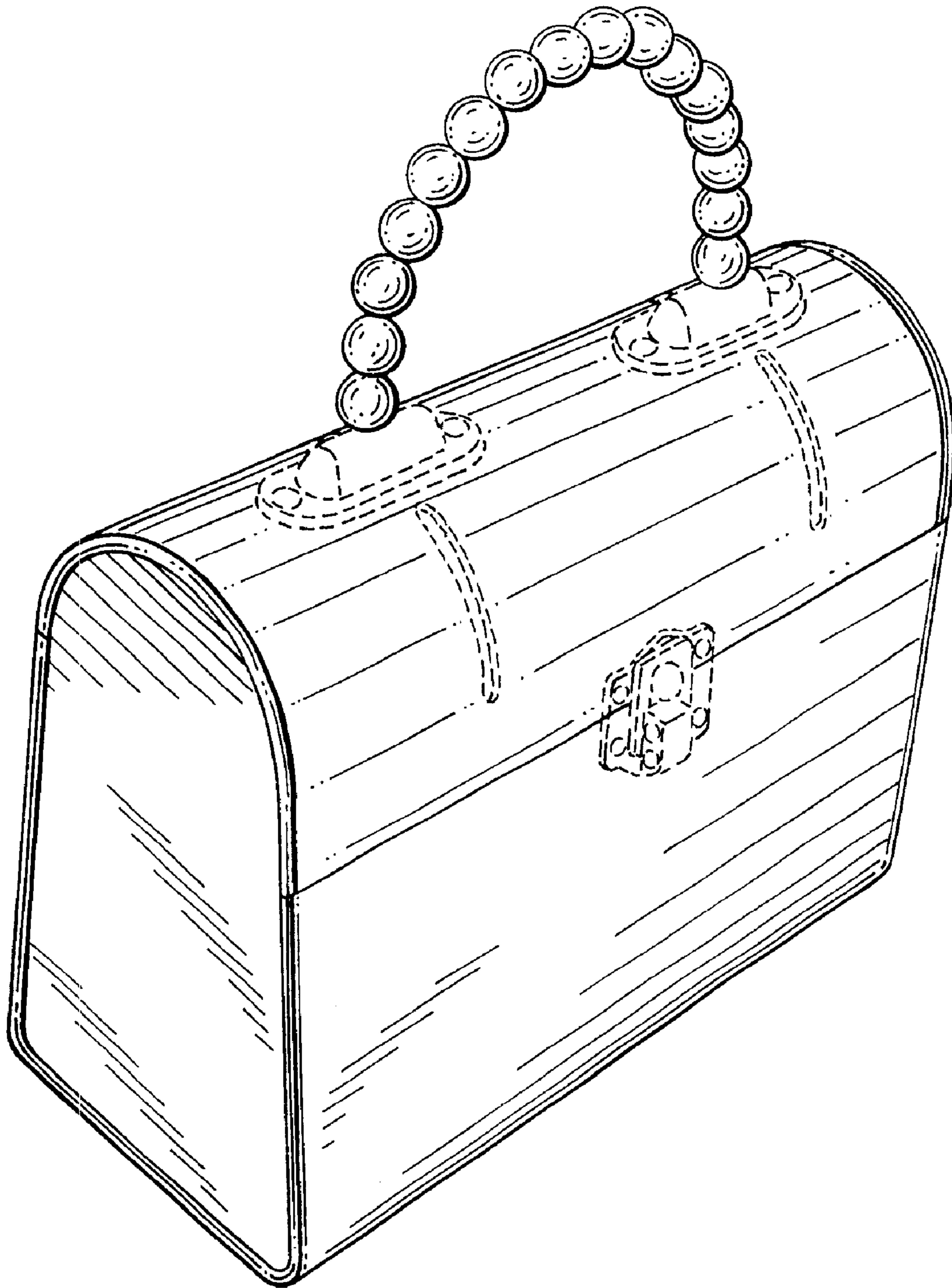

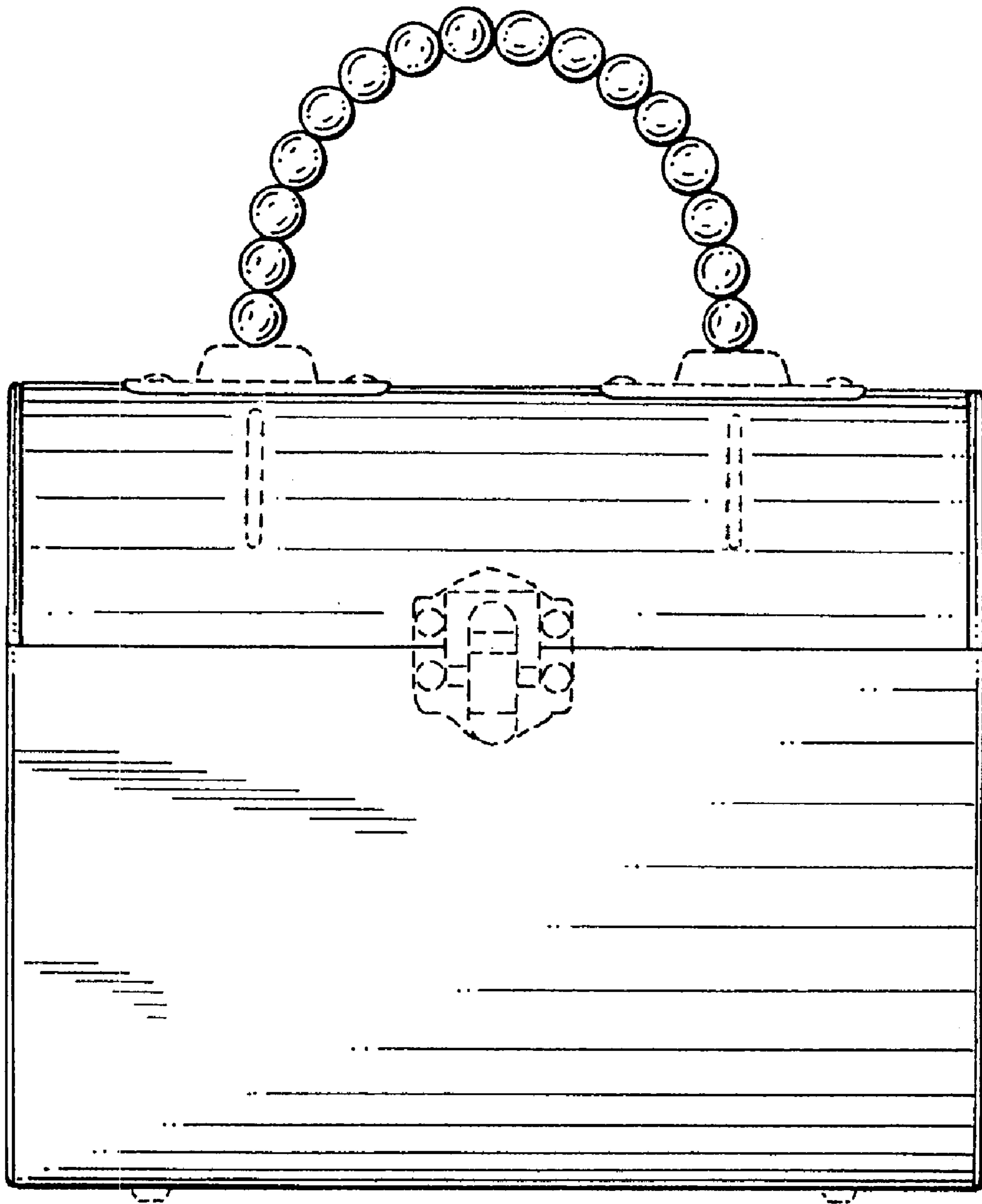

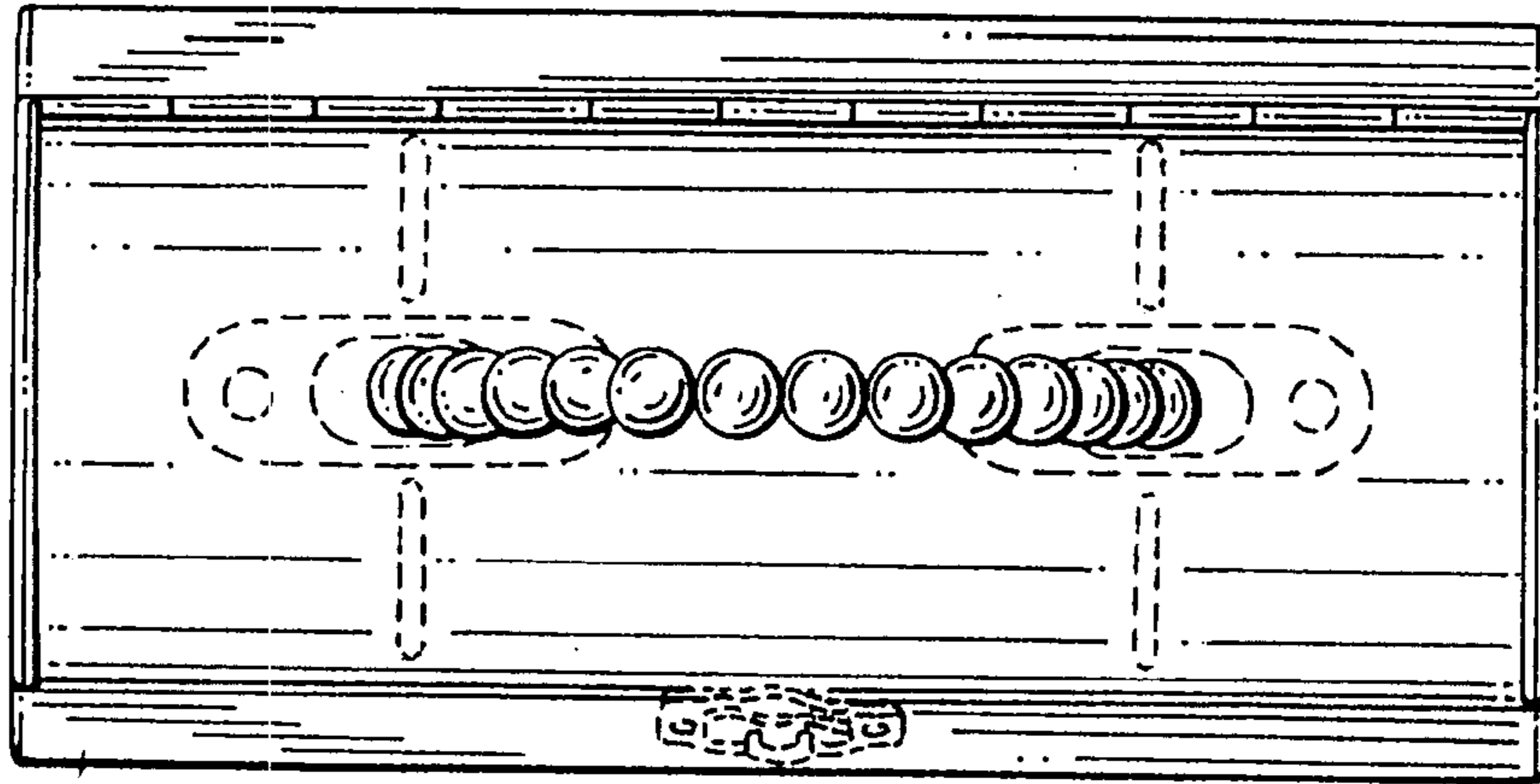

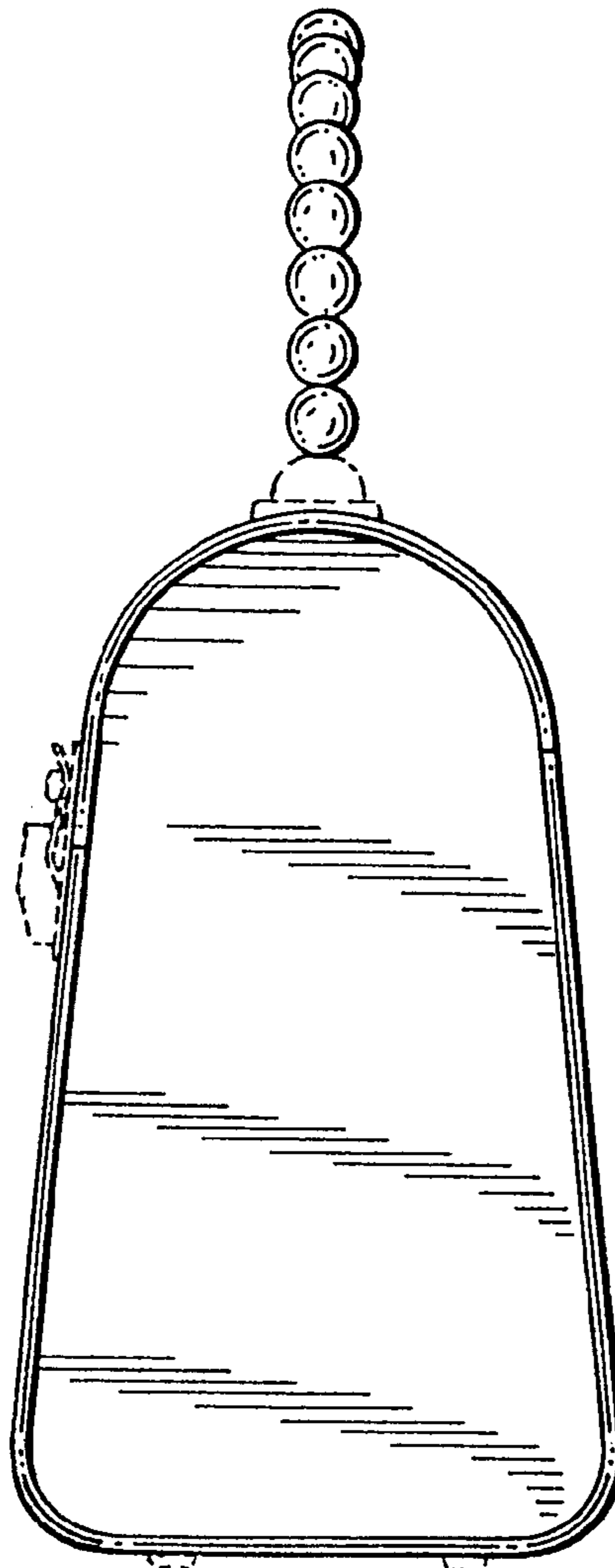

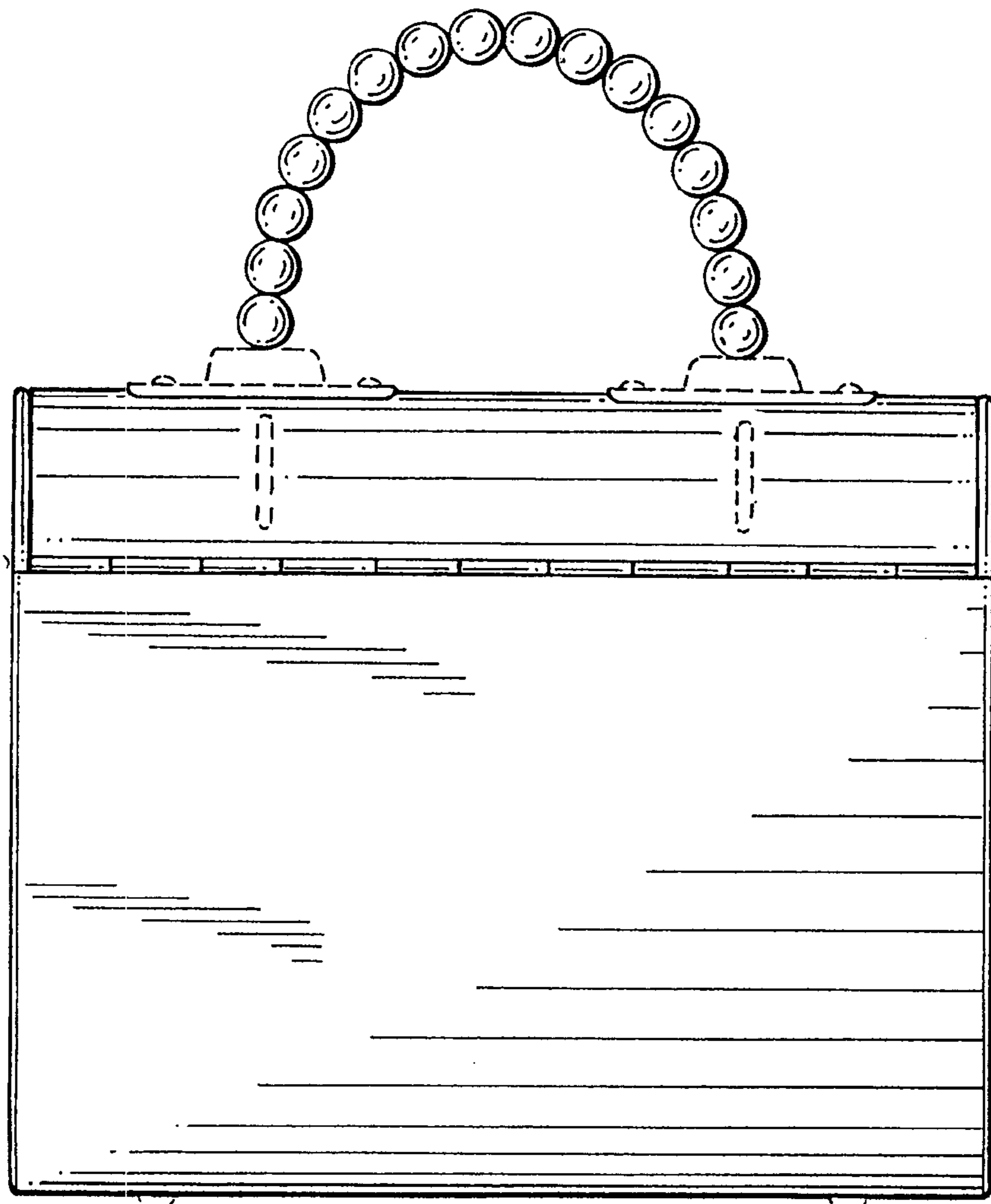

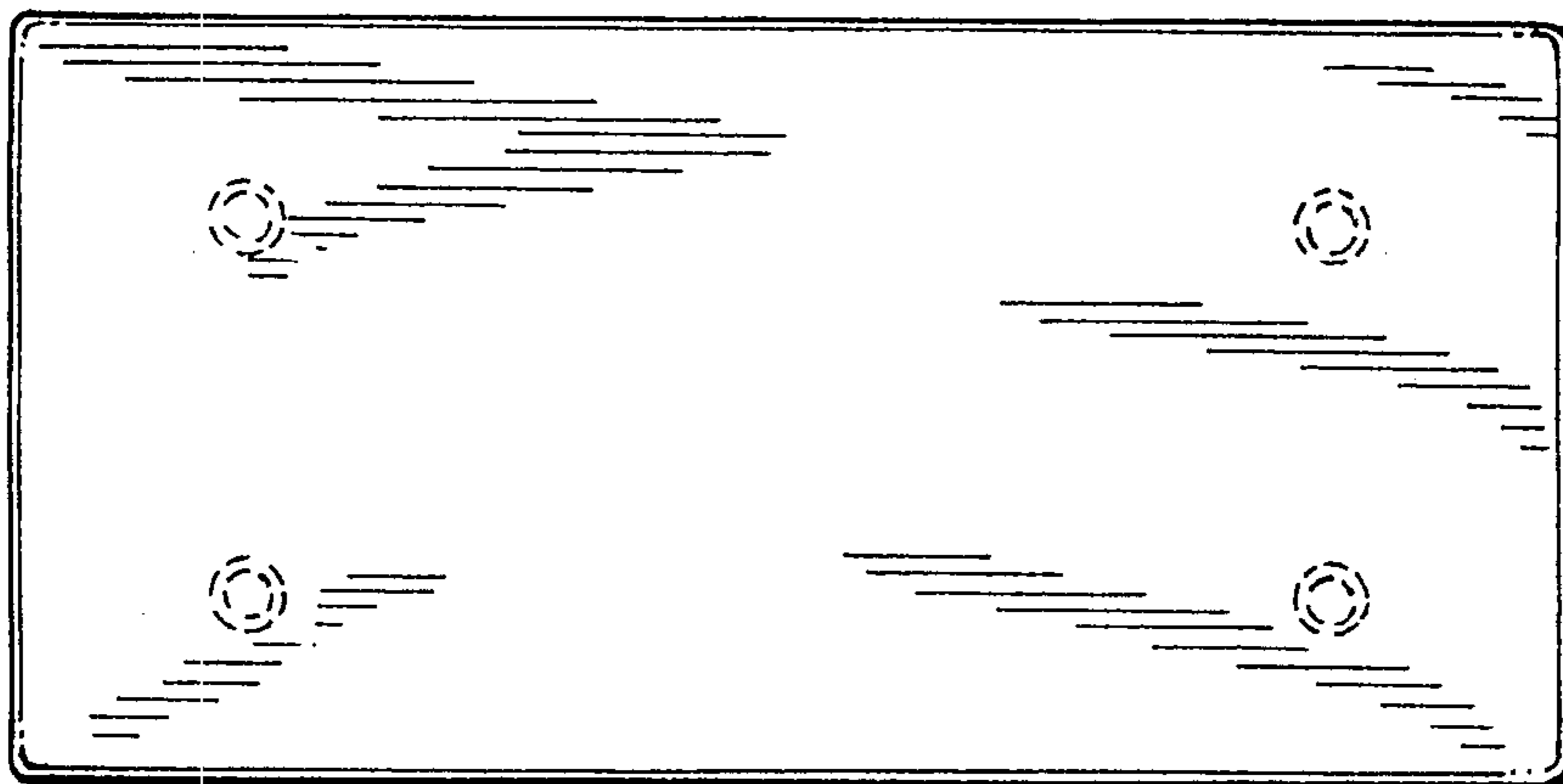
