DESCRIPTION

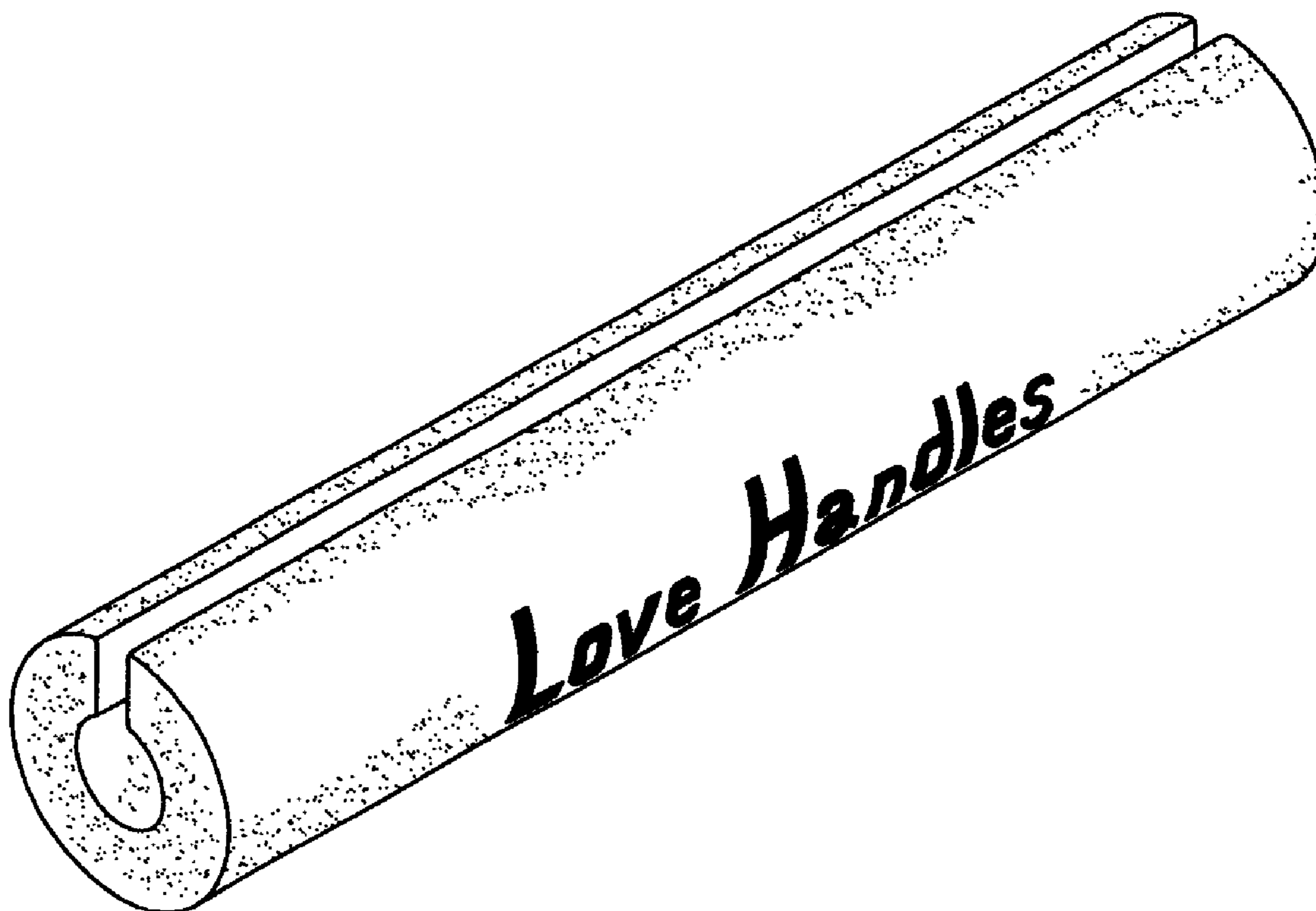

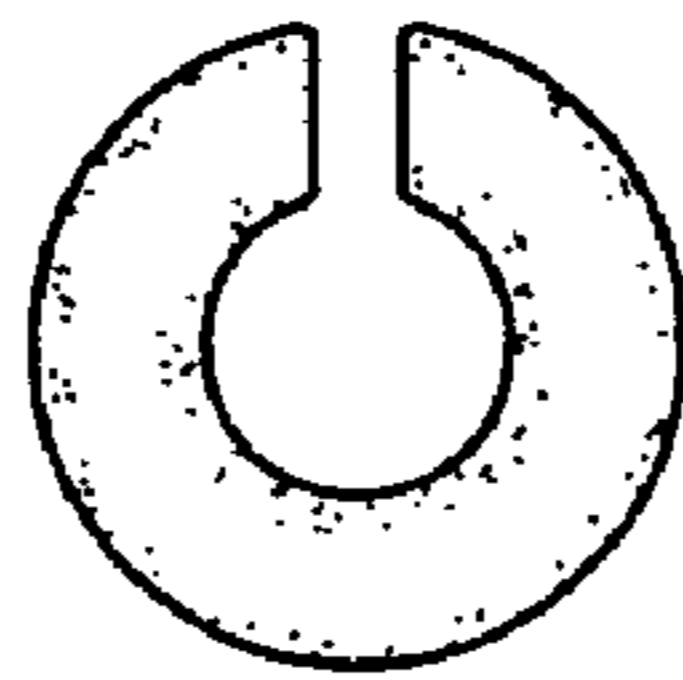

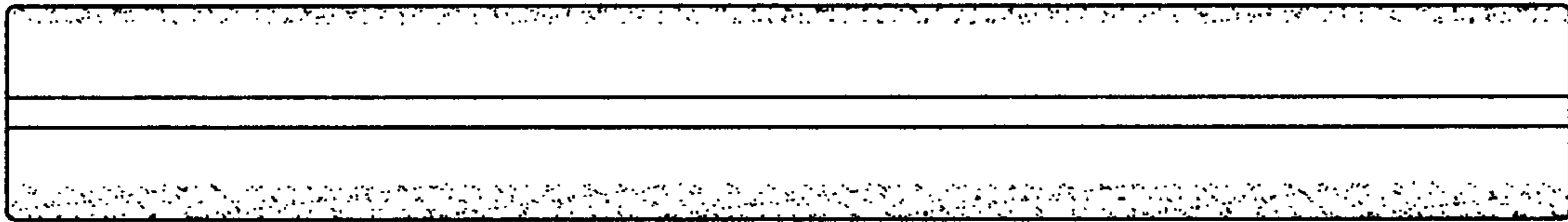

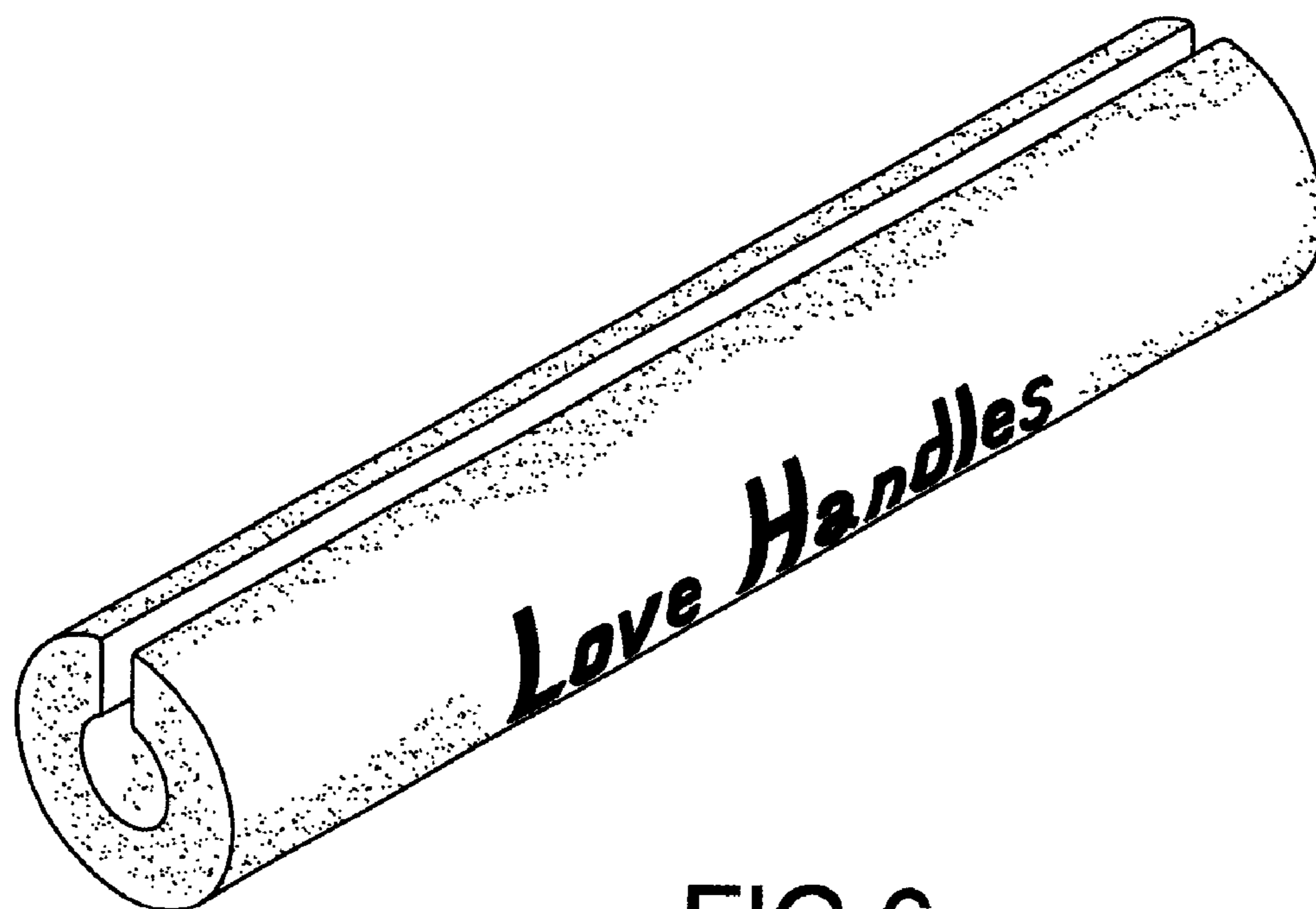
