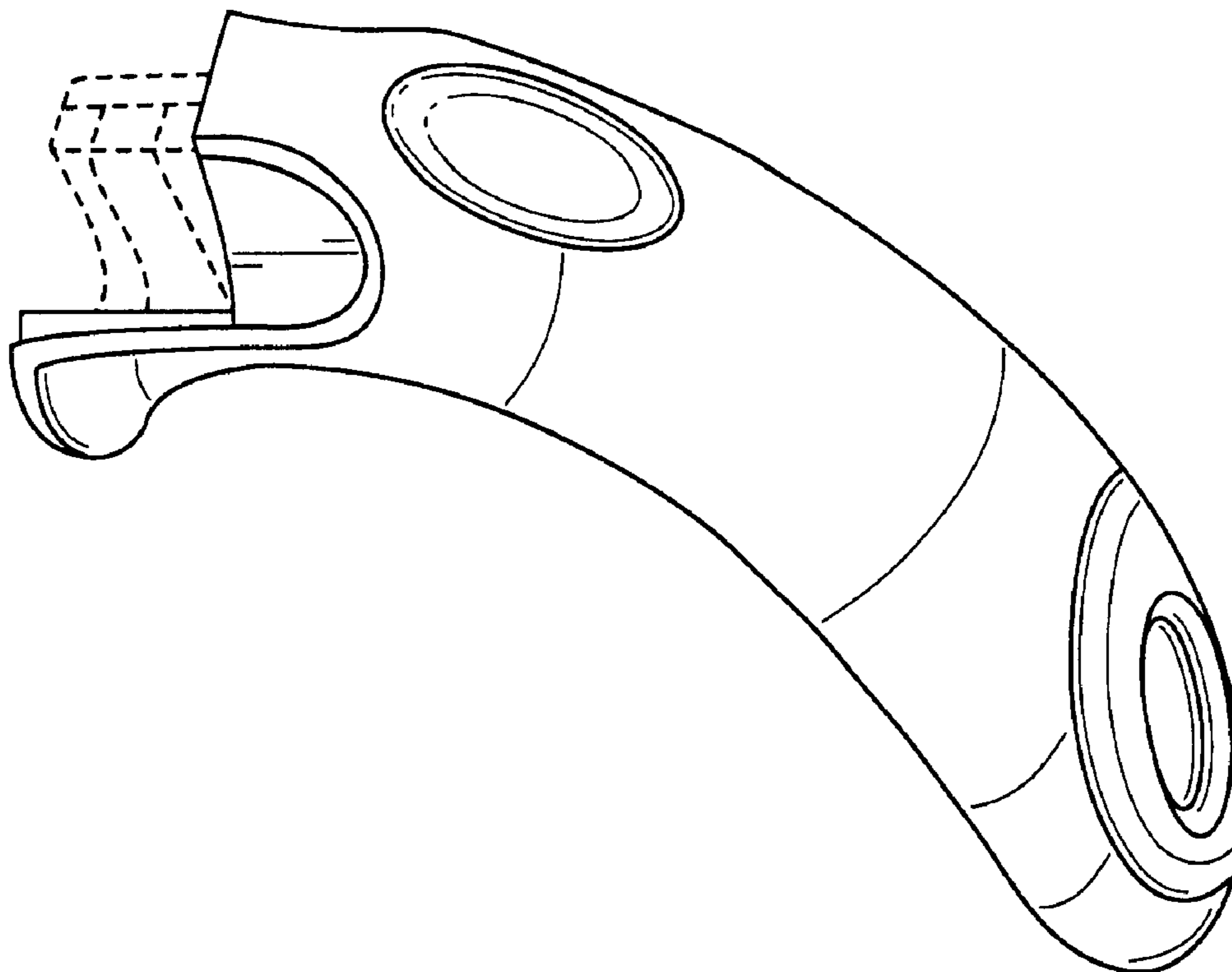
The ornamental design for a handle for an apparatus for preparing a hot beverage, as shown and described.

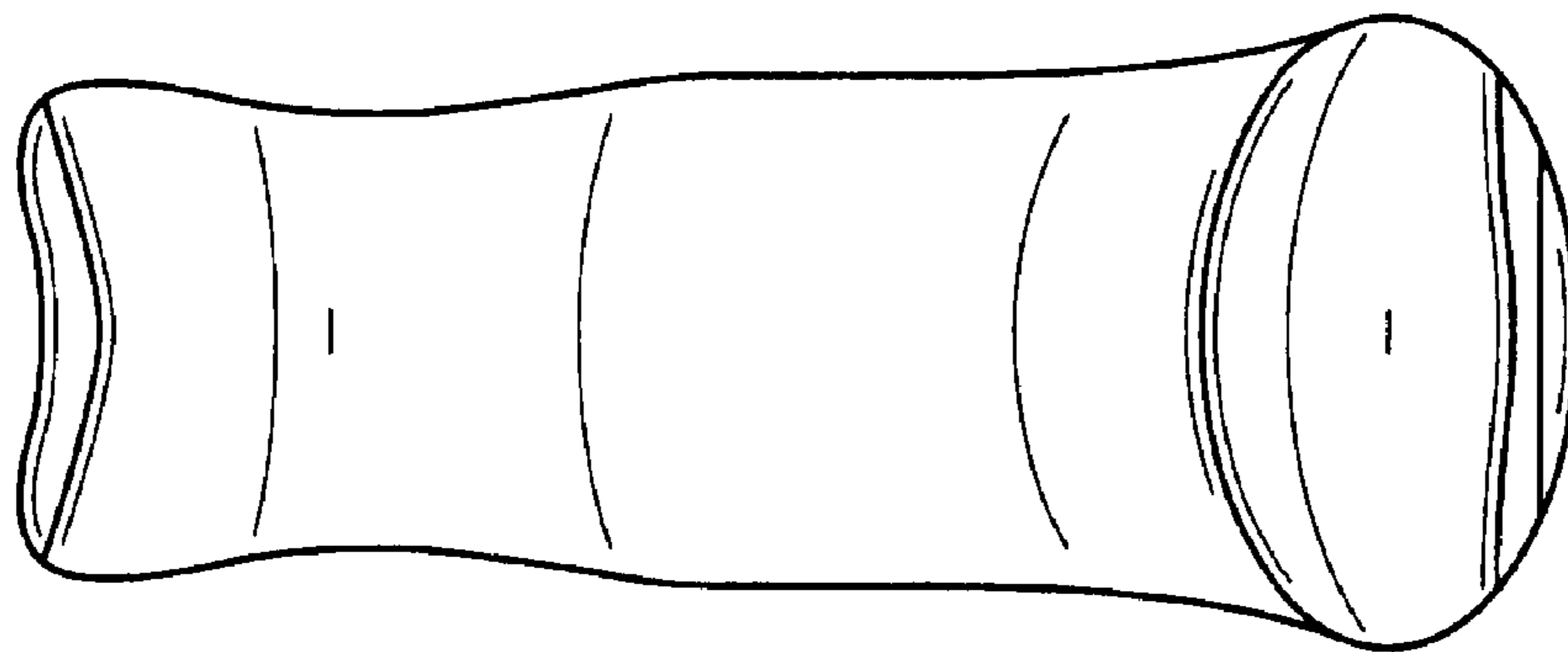

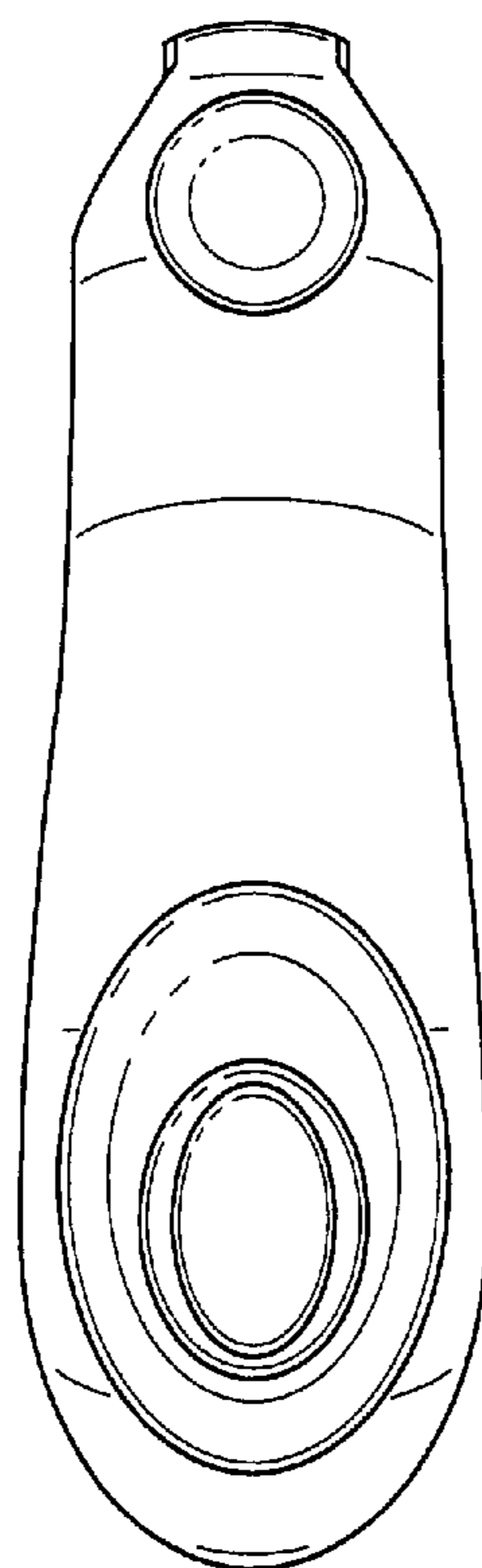

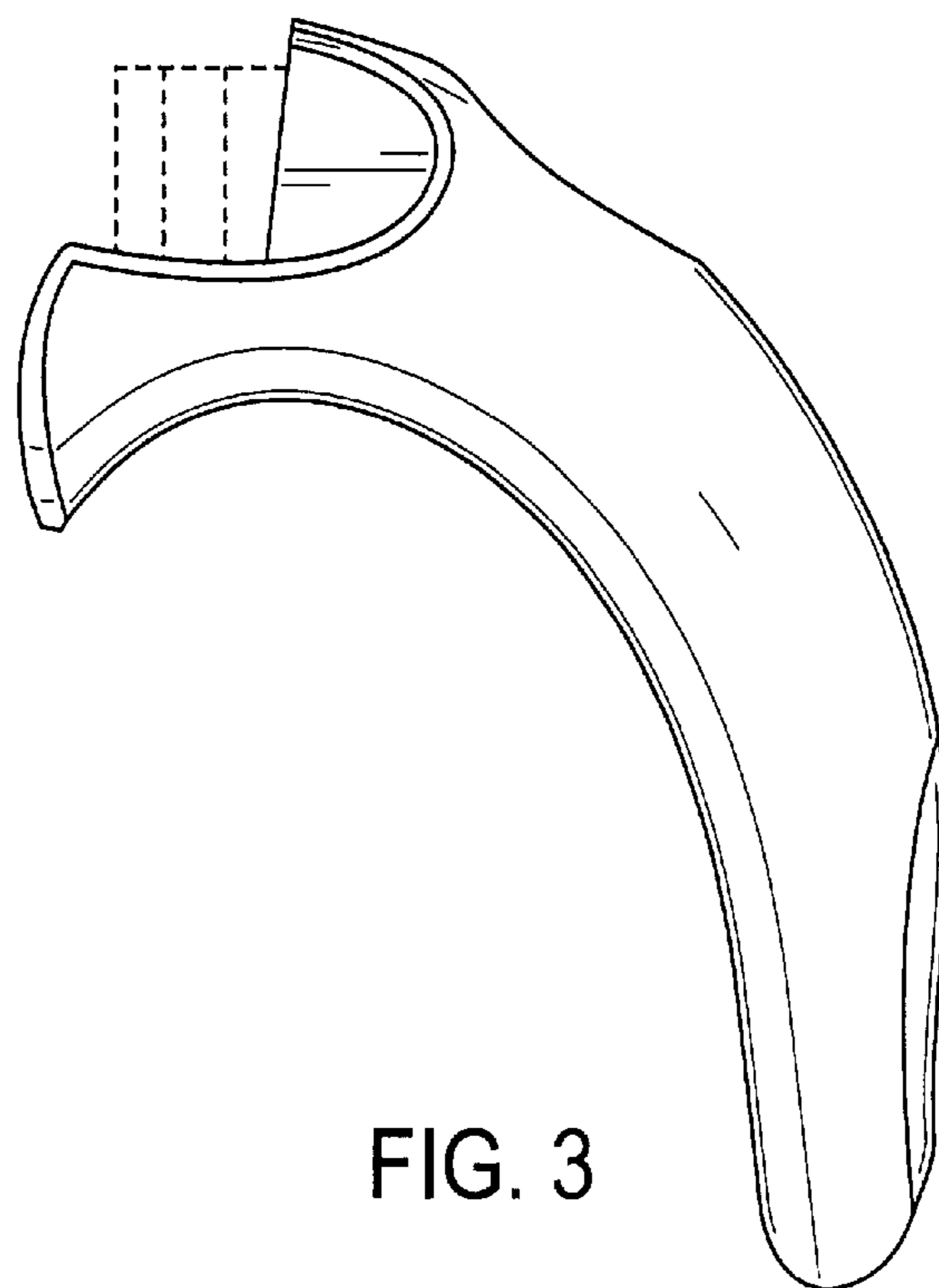

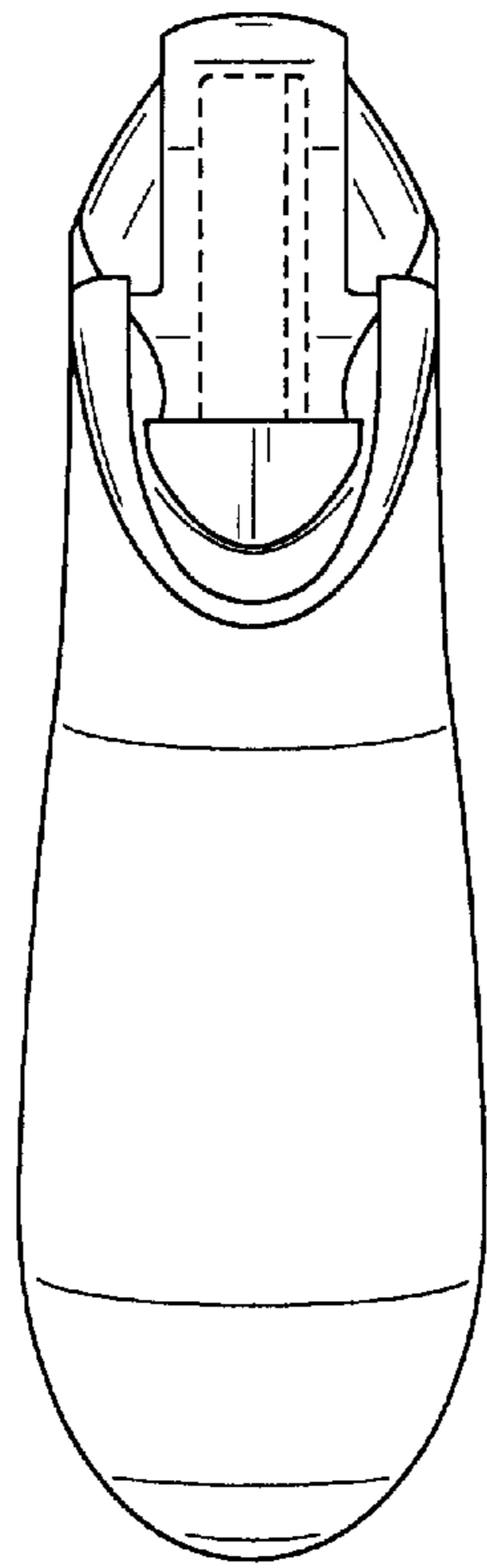

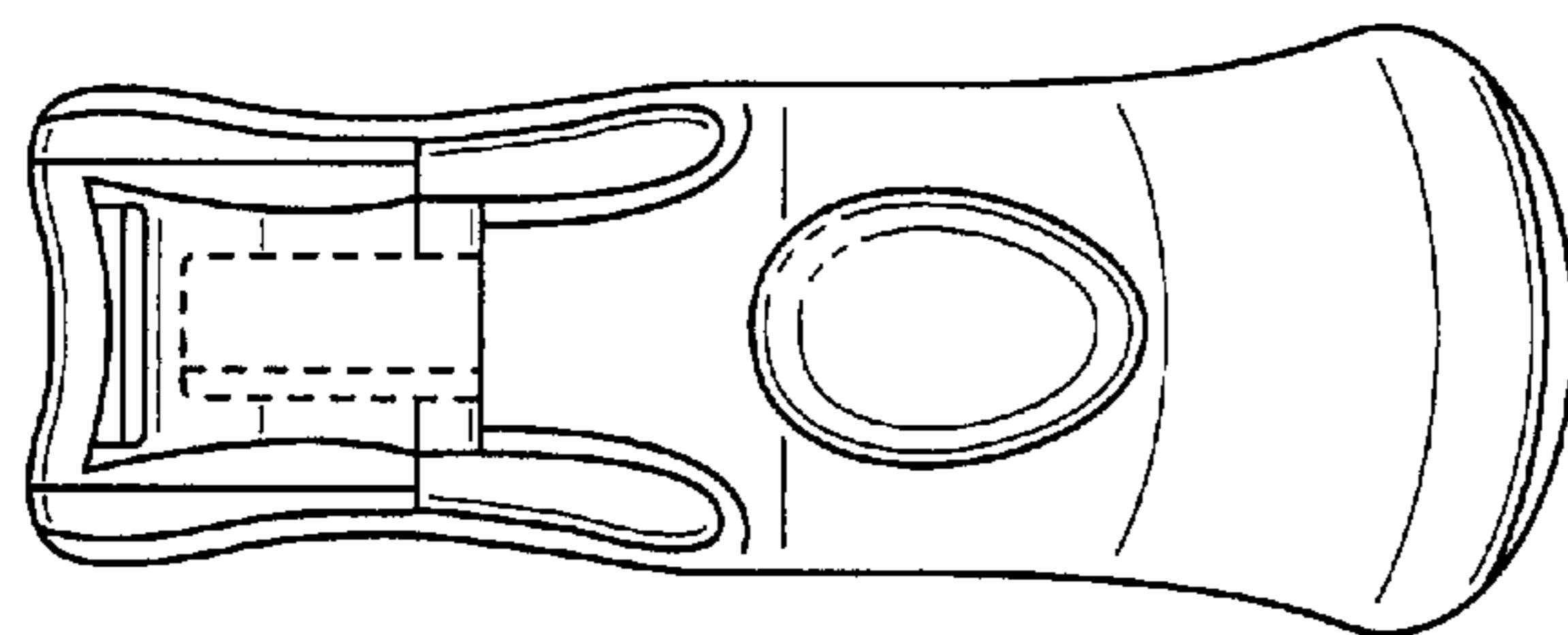

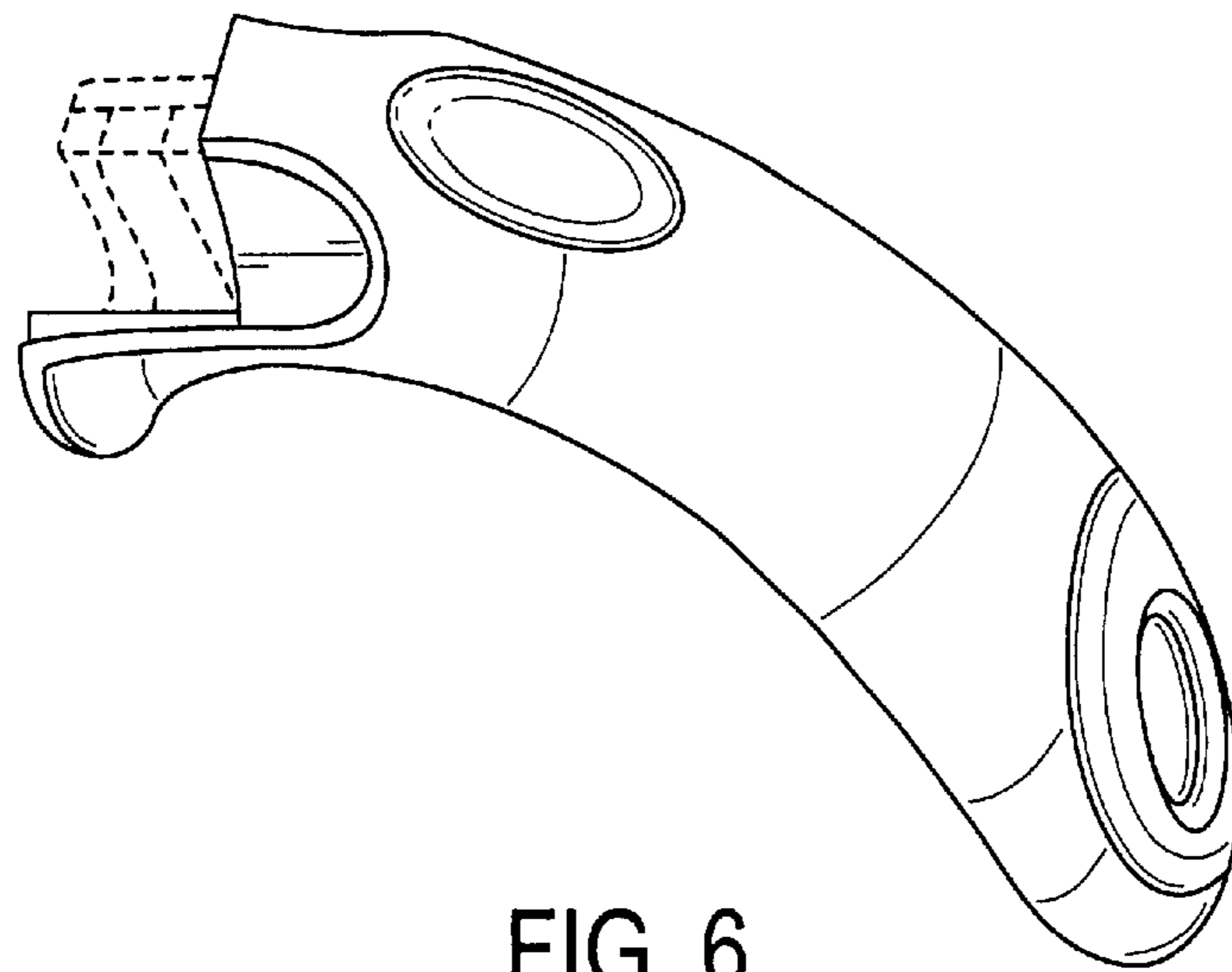

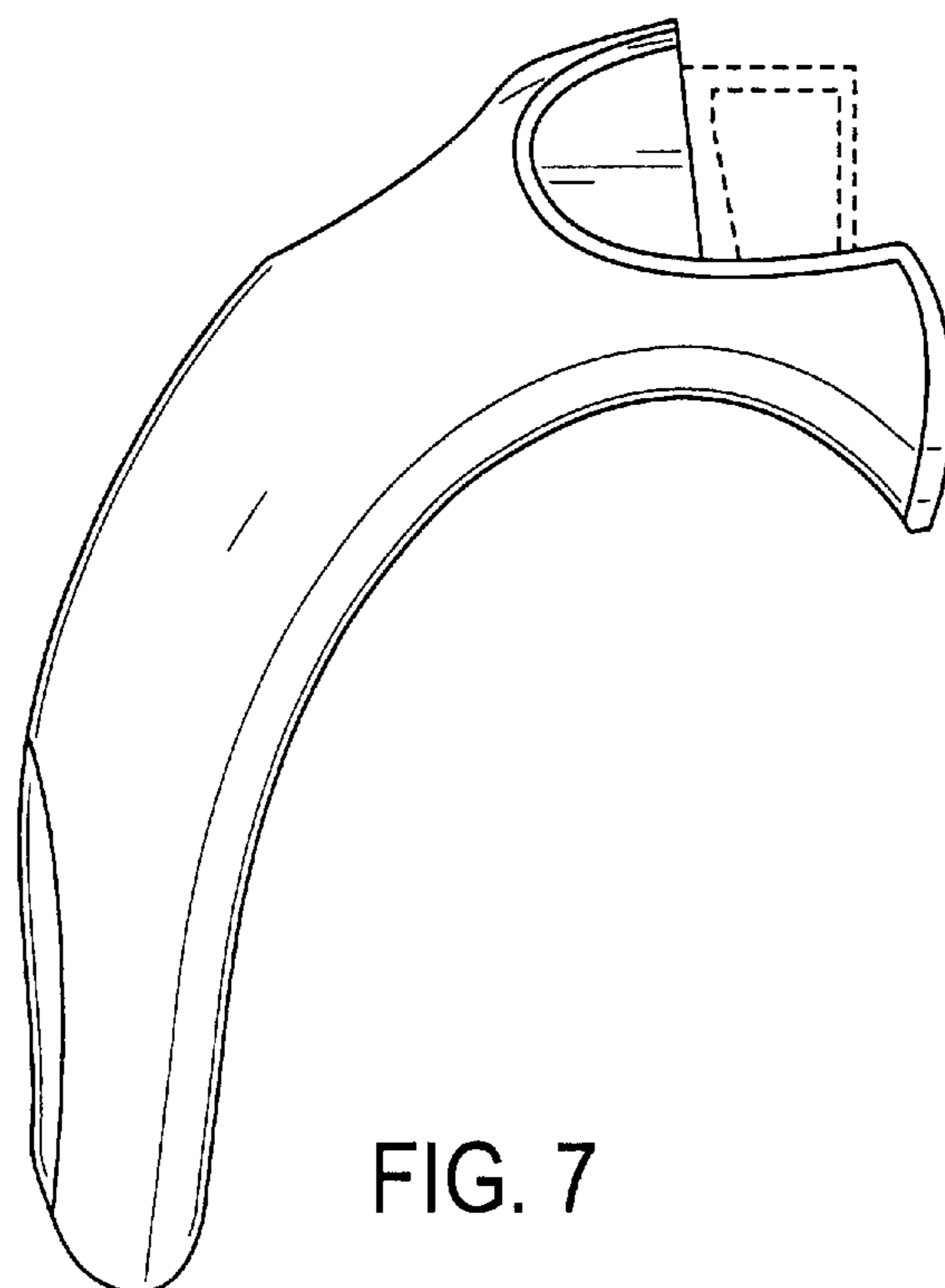
