(57) **CLAIM**

I claim the ornamental design for a bottle handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bottle handle of the design according to this invention.

FIG. 2 is a slightly oblique end perspective view of the bottle handle of the design according to this invention.

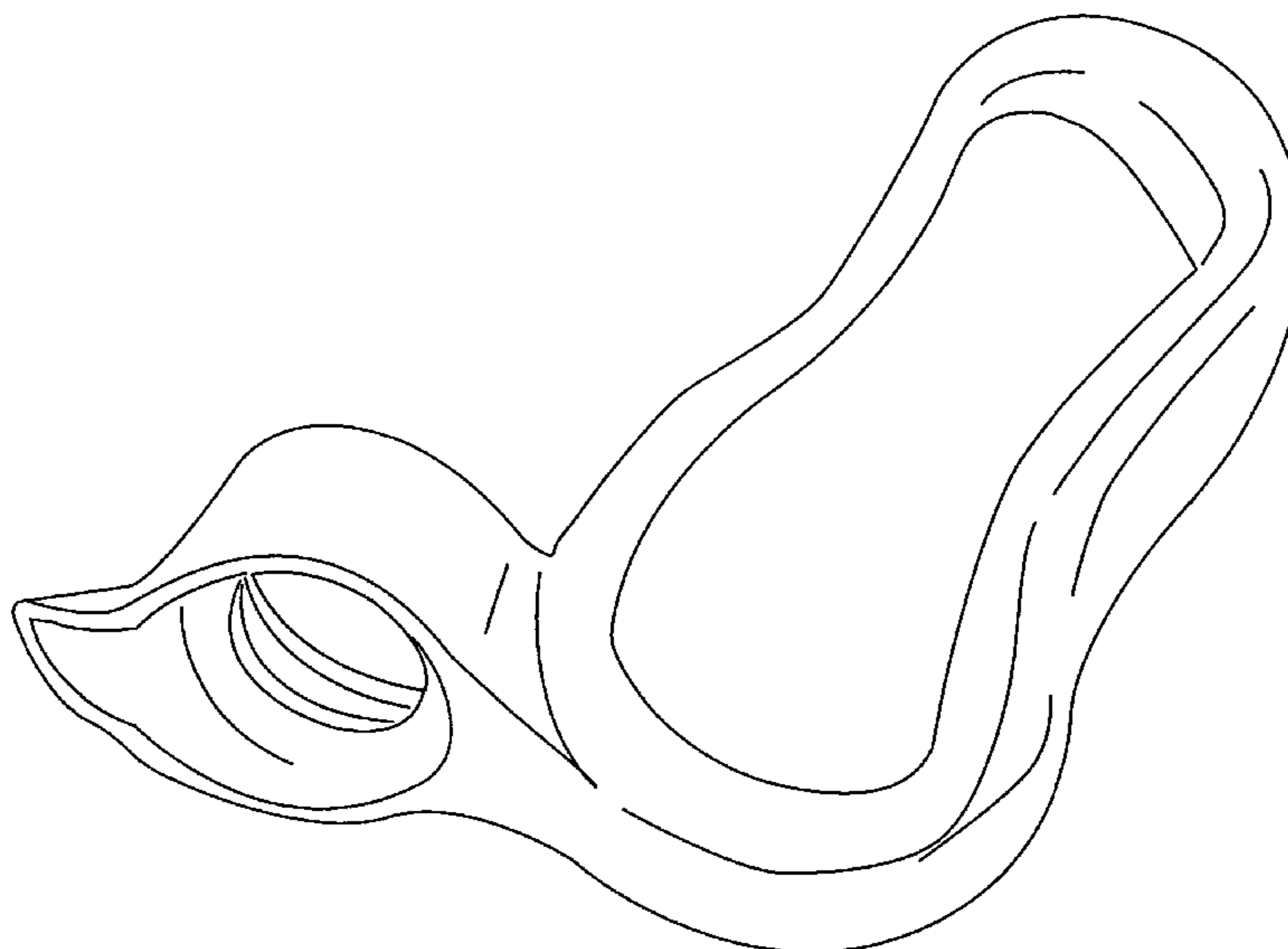
FIG. 3 is a side view of the bottle handle of the design according to this invention.

FIG. 4 is an end view of the bottle handle of the design according to this invention.

FIG. 5 is an end view of the bottle handle of the design according to this invention from the end of the bottle handle other than the end shown in FIG. 4 ; and,

FIG. 6 is an enlarged view of the portion of the bottle handle of the design according to this invention that engages the neck of the bottle.

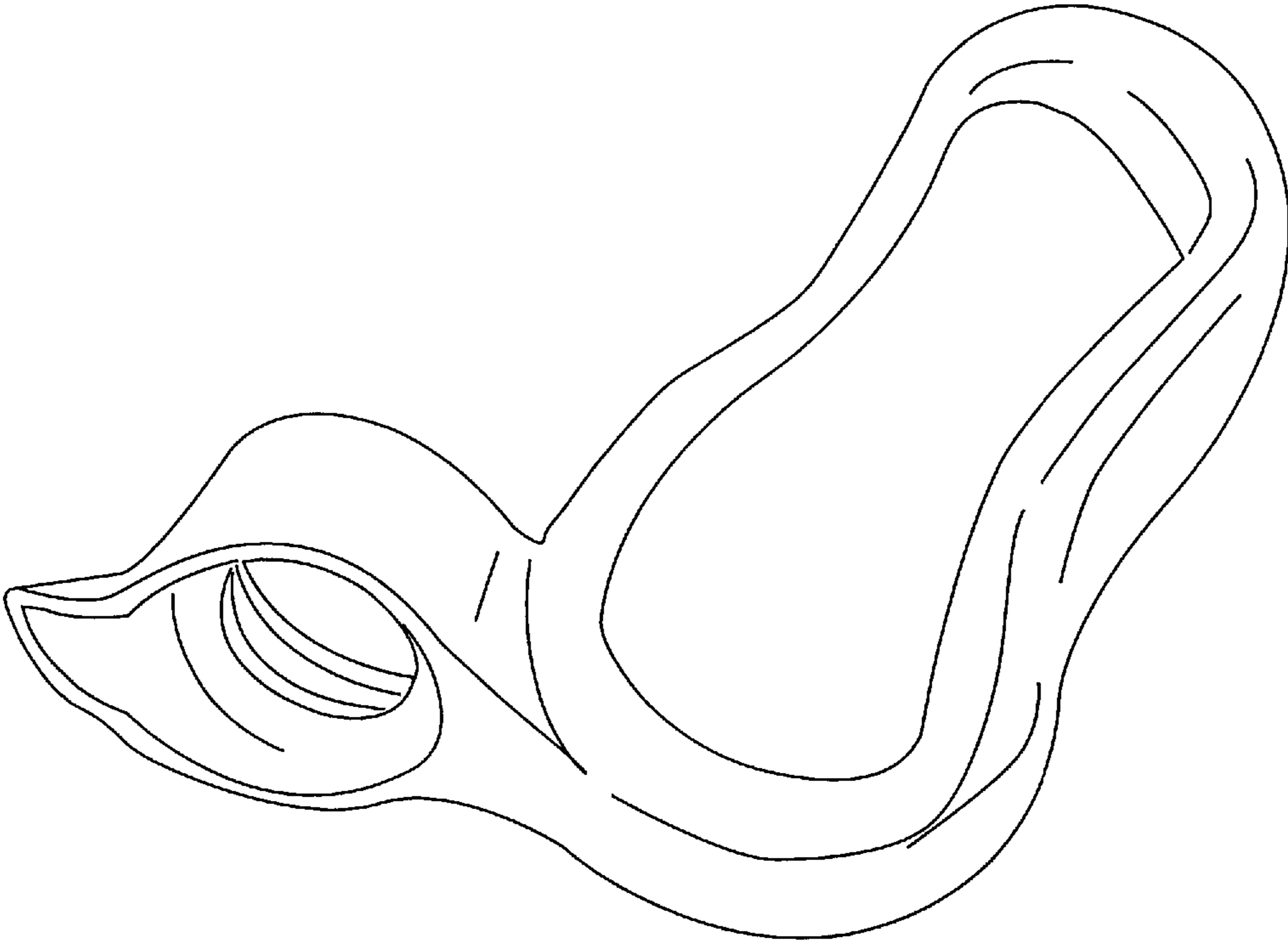

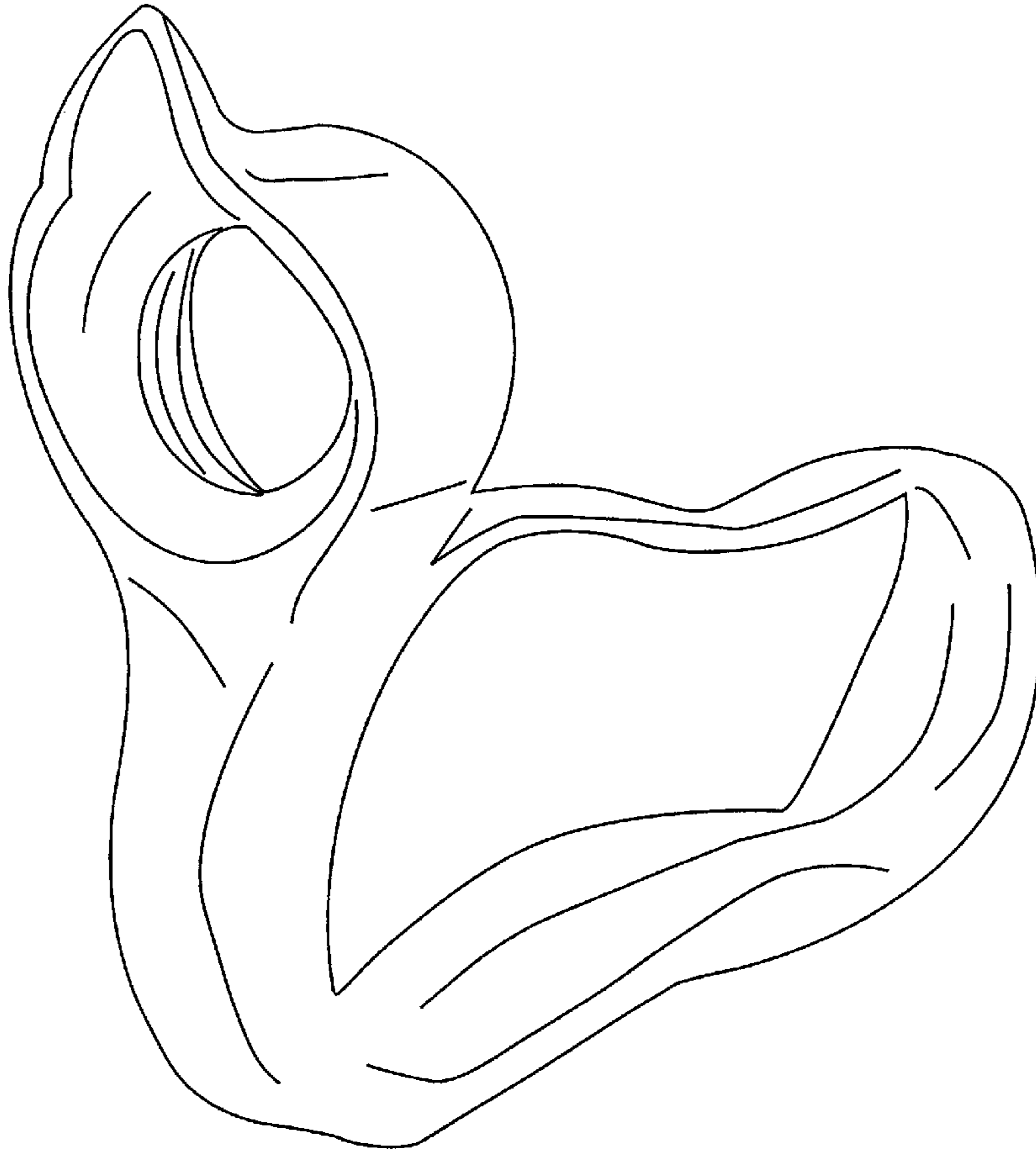

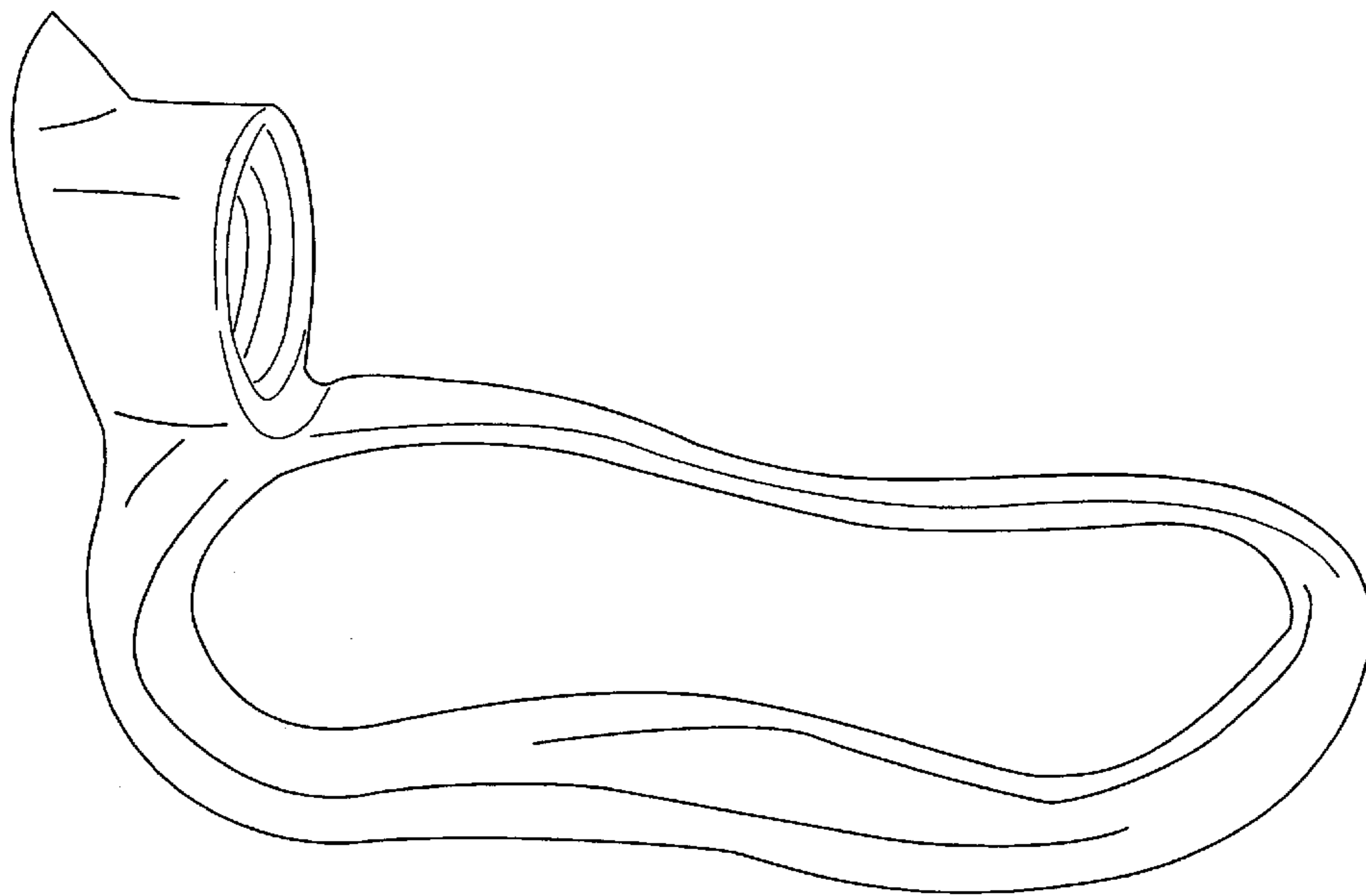

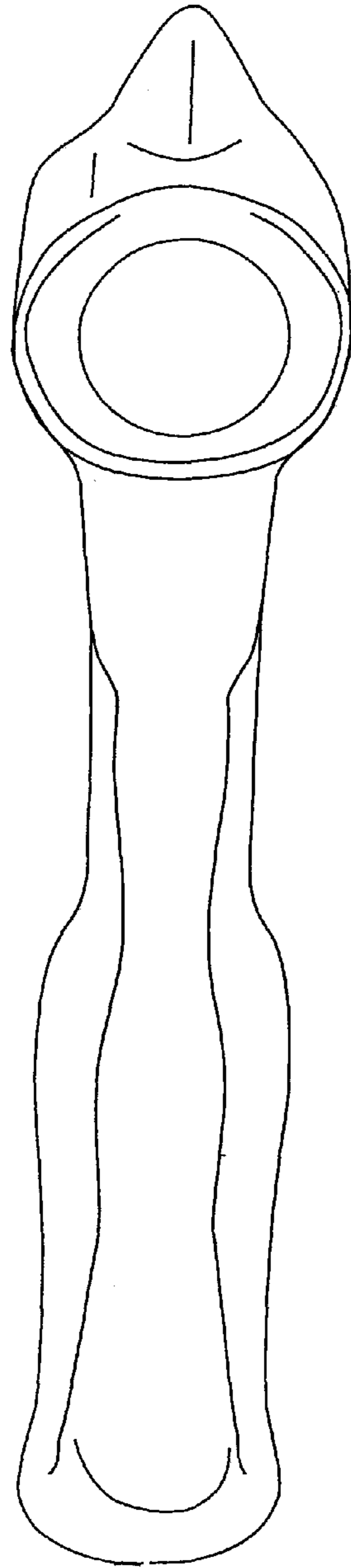

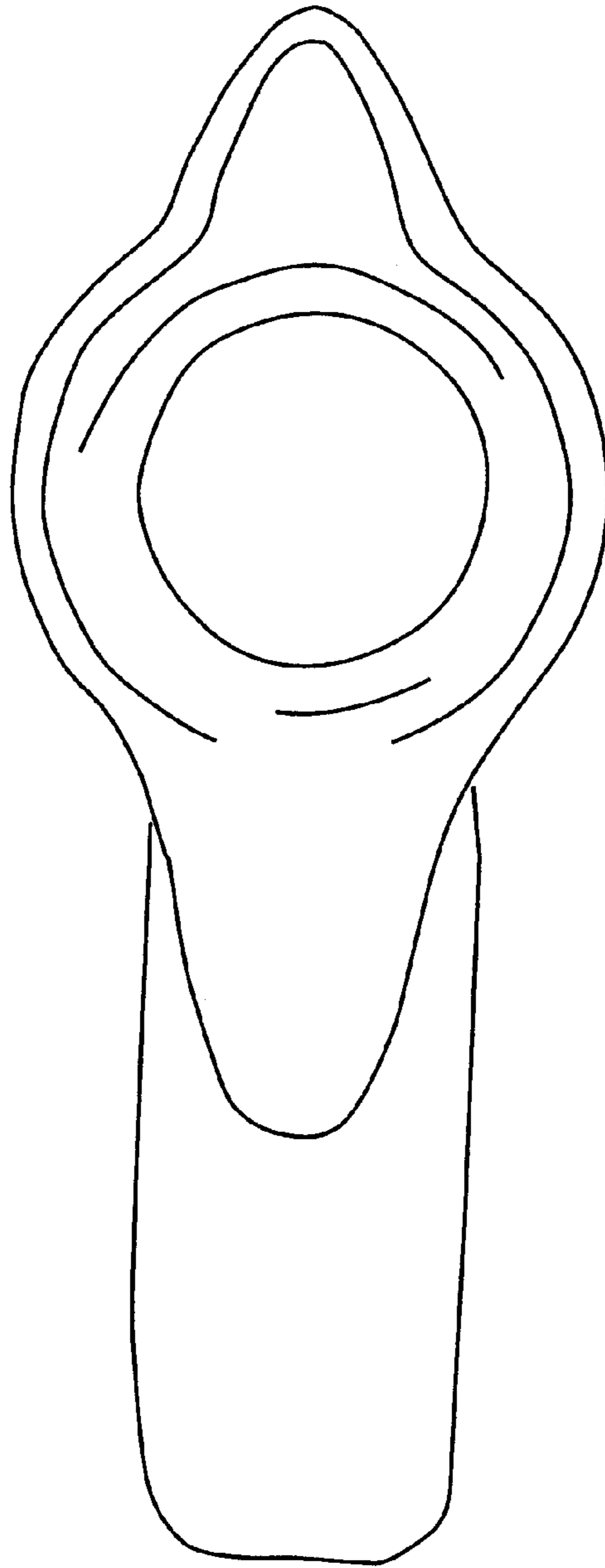

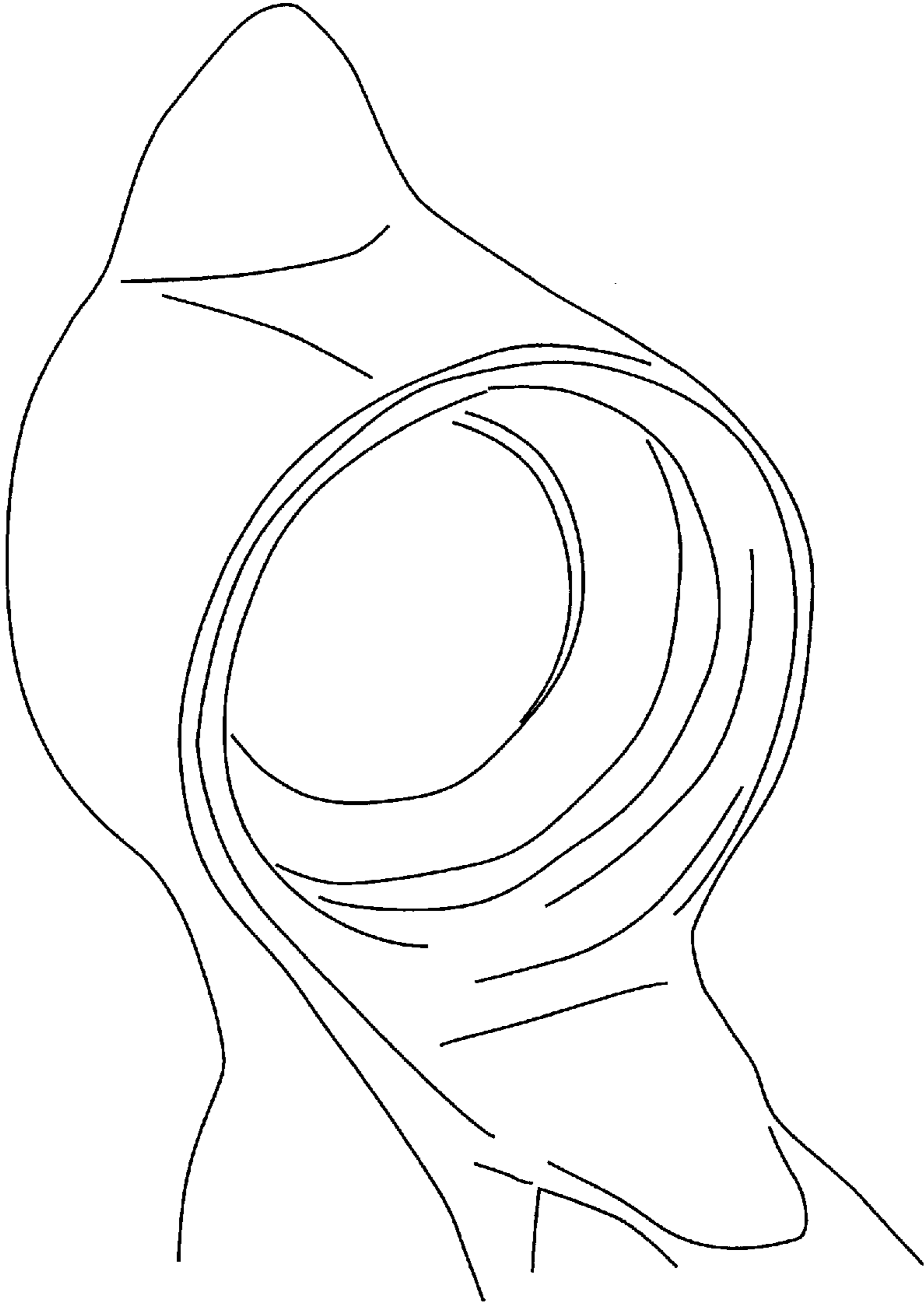
