(57) **CLAIM**

The ornamental design for a cap for a beverage bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective side and top view of one side of the cap for a beverage bottle of the present invention.

FIG. 2 is a front view of the cap of FIG. 1;

FIG. 3 is a left side view of the cap of FIG. 1, the right side being a mirror image thereof;

FIG. 4 is a rear view of the cap of FIG. 1; and,

FIG. 5 is a top view of the cap of FIG. 1.

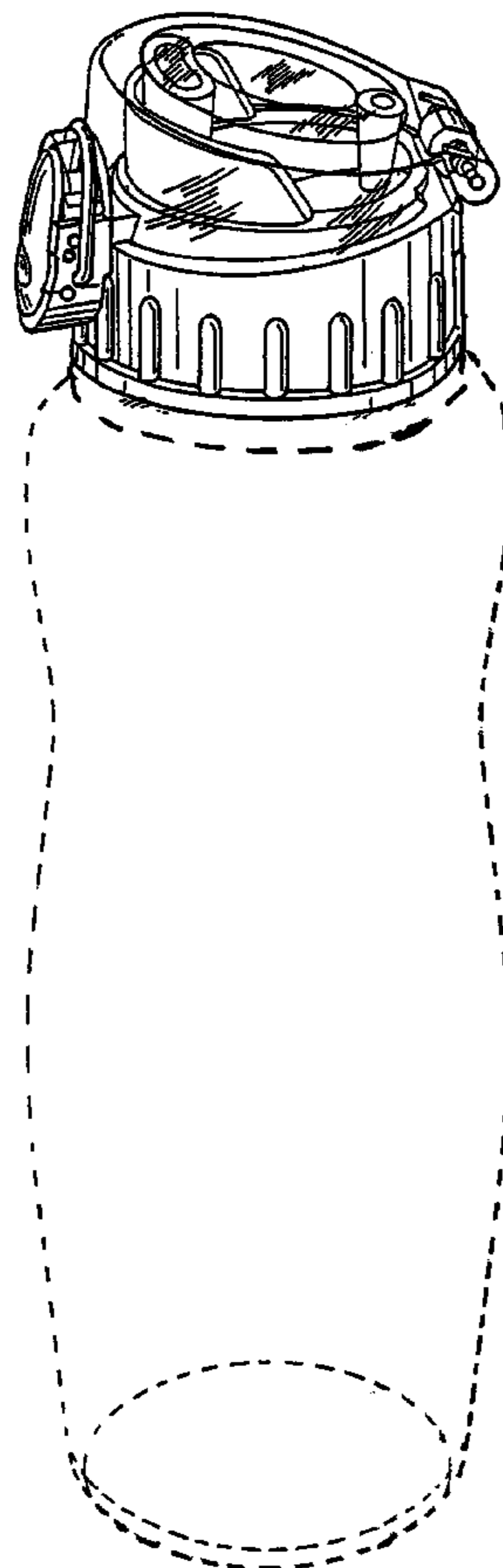

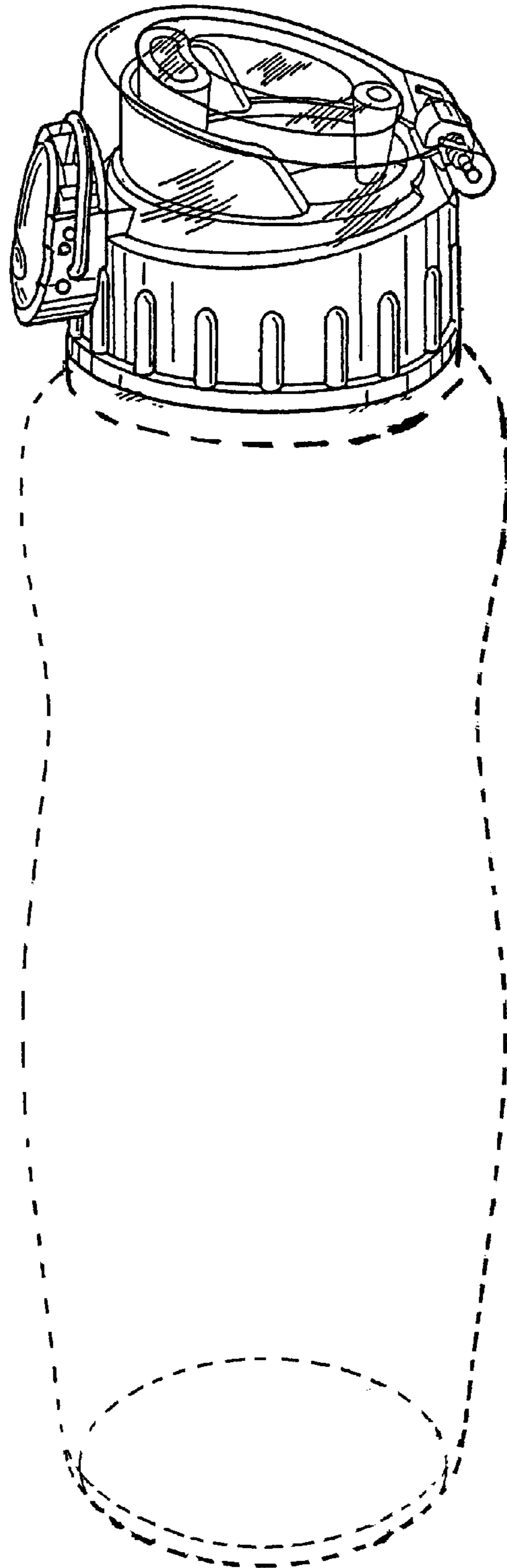

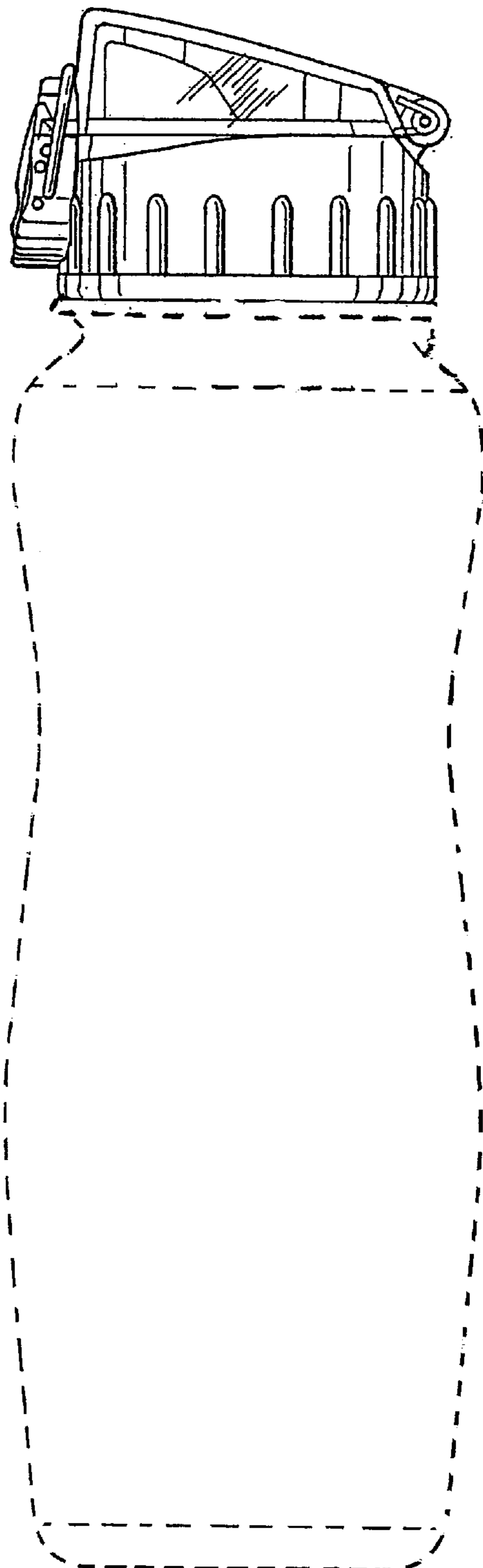
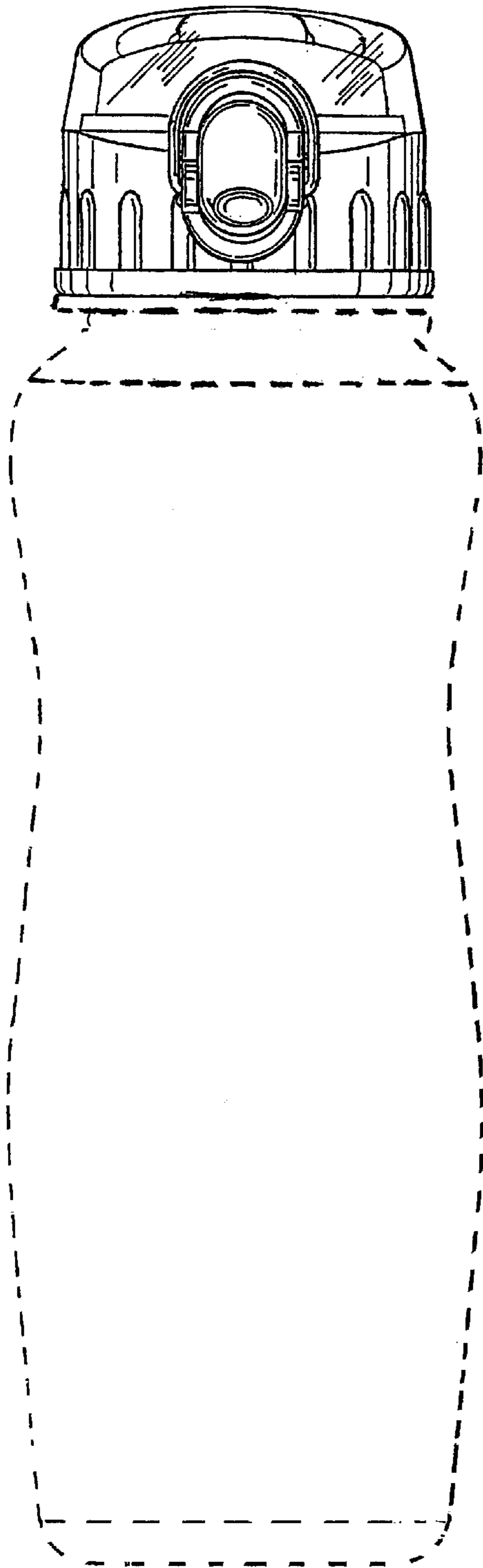

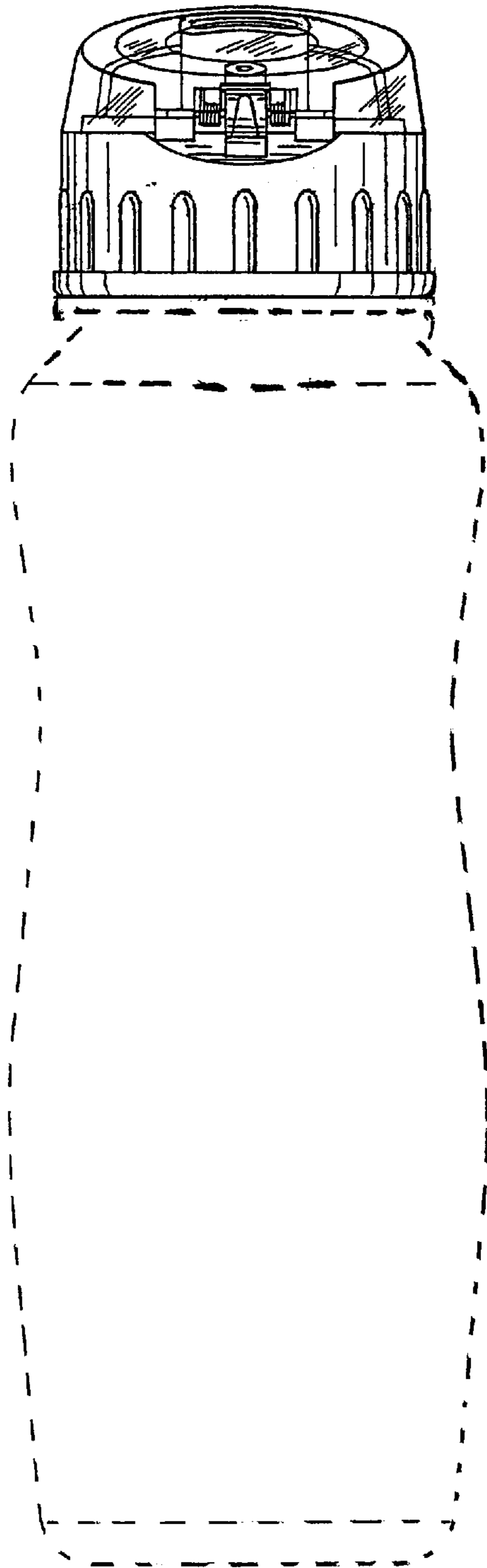
