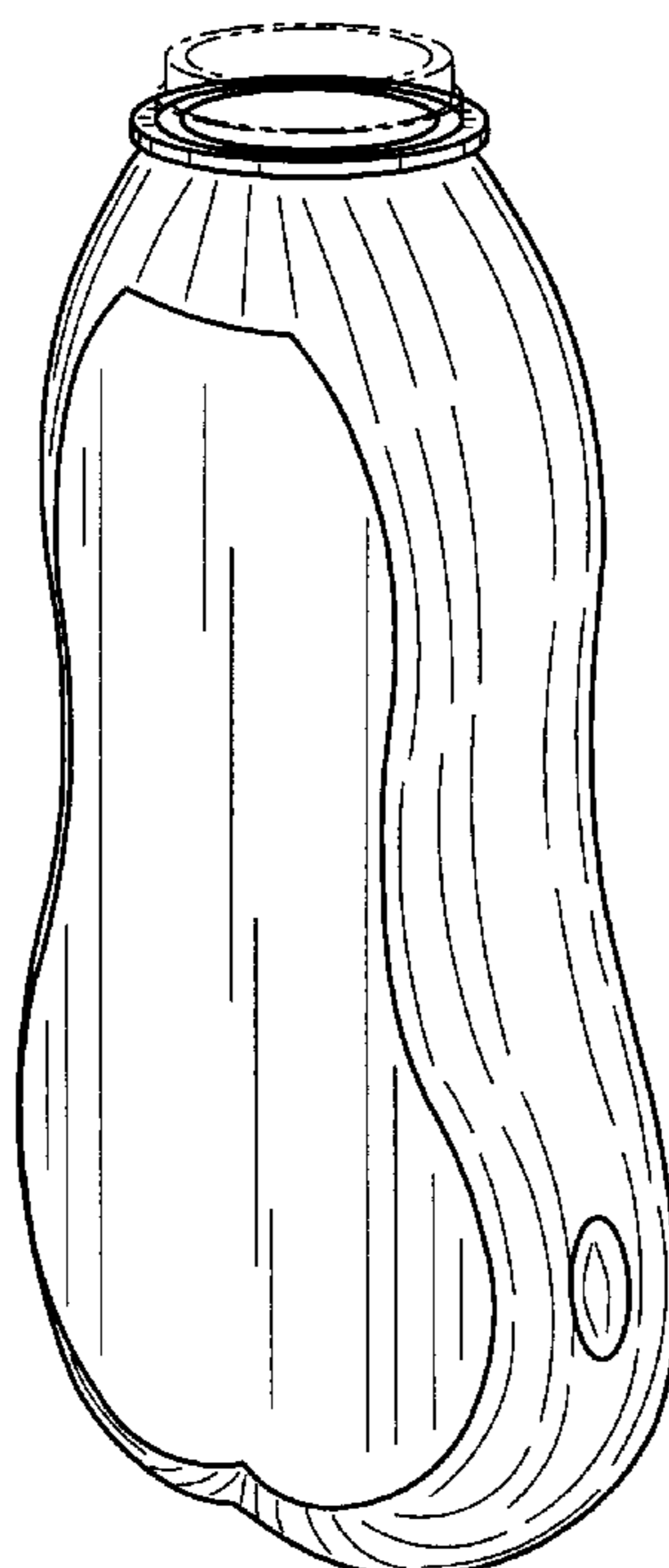
(57) **CLAIM**

The ornamental design for a bottle having shape of baby's bottom, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of the invention;  
 FIG. 2 is a front elevational view of the bottle shown in FIG. 1;  
 FIG. 3 is a right side elevational view of the bottle shown in FIG. 1 and the left side is identical;  
 FIG. 4 is a top plan view of the bottle shown in FIG. 1;  
 FIG. 5 is a bottom view of the bottle shown in FIG. 1;  
 FIG. 6 is a perspective view of a second embodiment of the invention;  
 FIG. 7 is a front elevational view of the bottle shown in FIG. 6;  
 FIG. 8 is a right side elevational view of the bottle shown in FIG. 6 and the left side is identical;  
 FIG. 9 is a top plan view of the bottle shown in FIG. 6; and,  
 FIG. 10 is a bottom view of the bottle shown in FIG. 6.

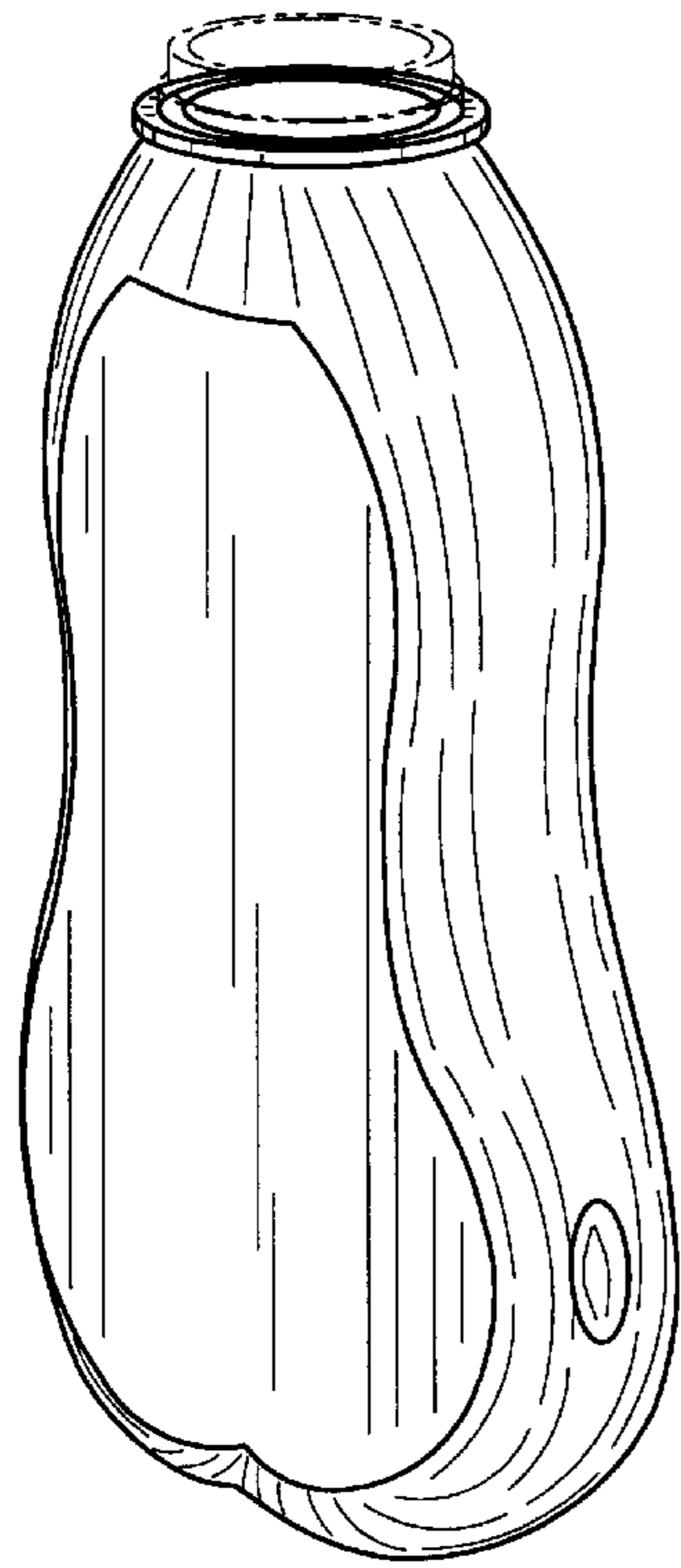

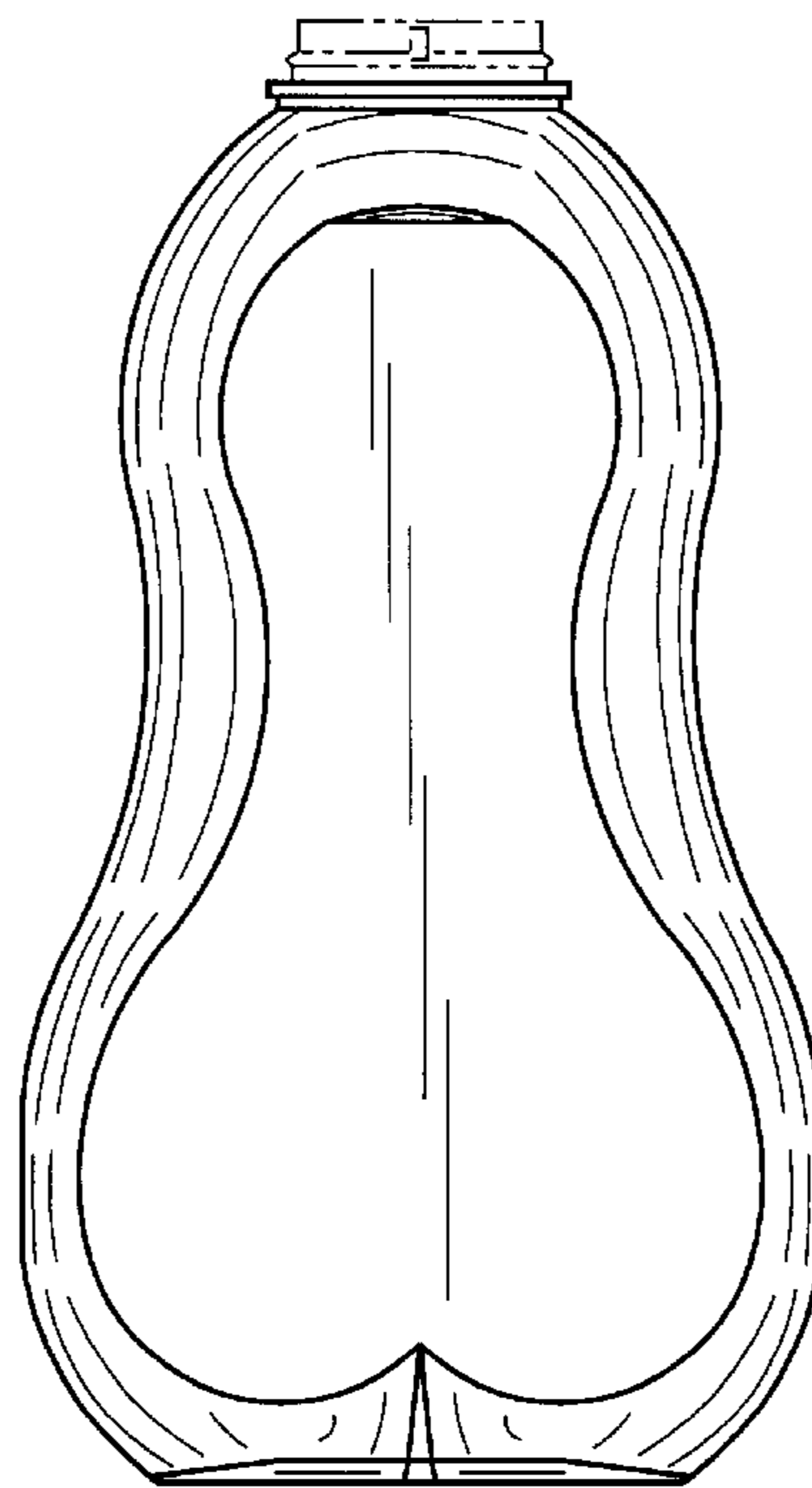

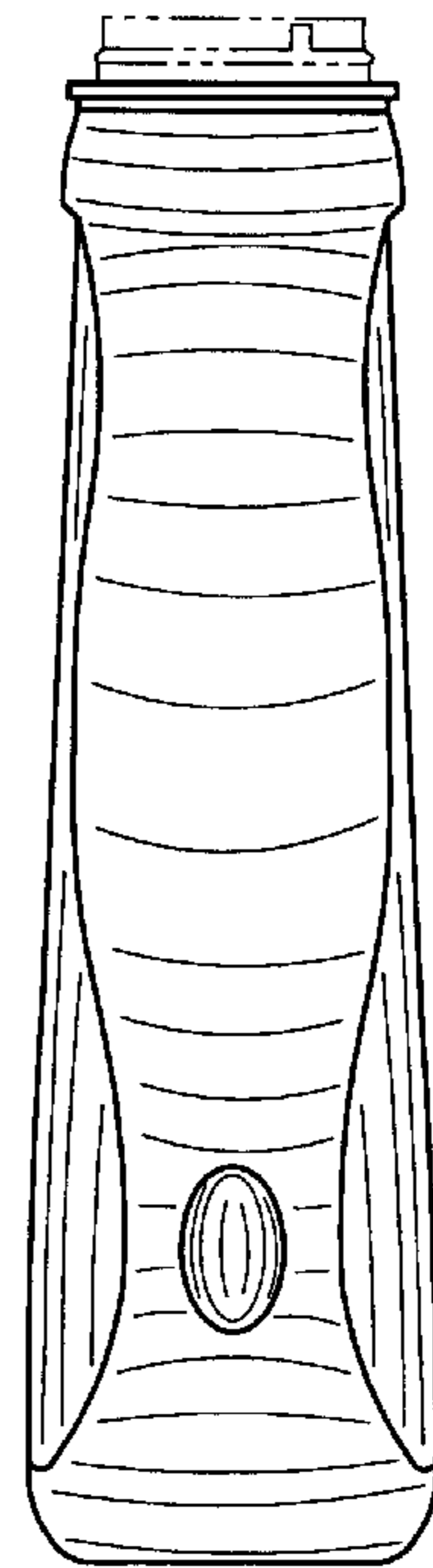

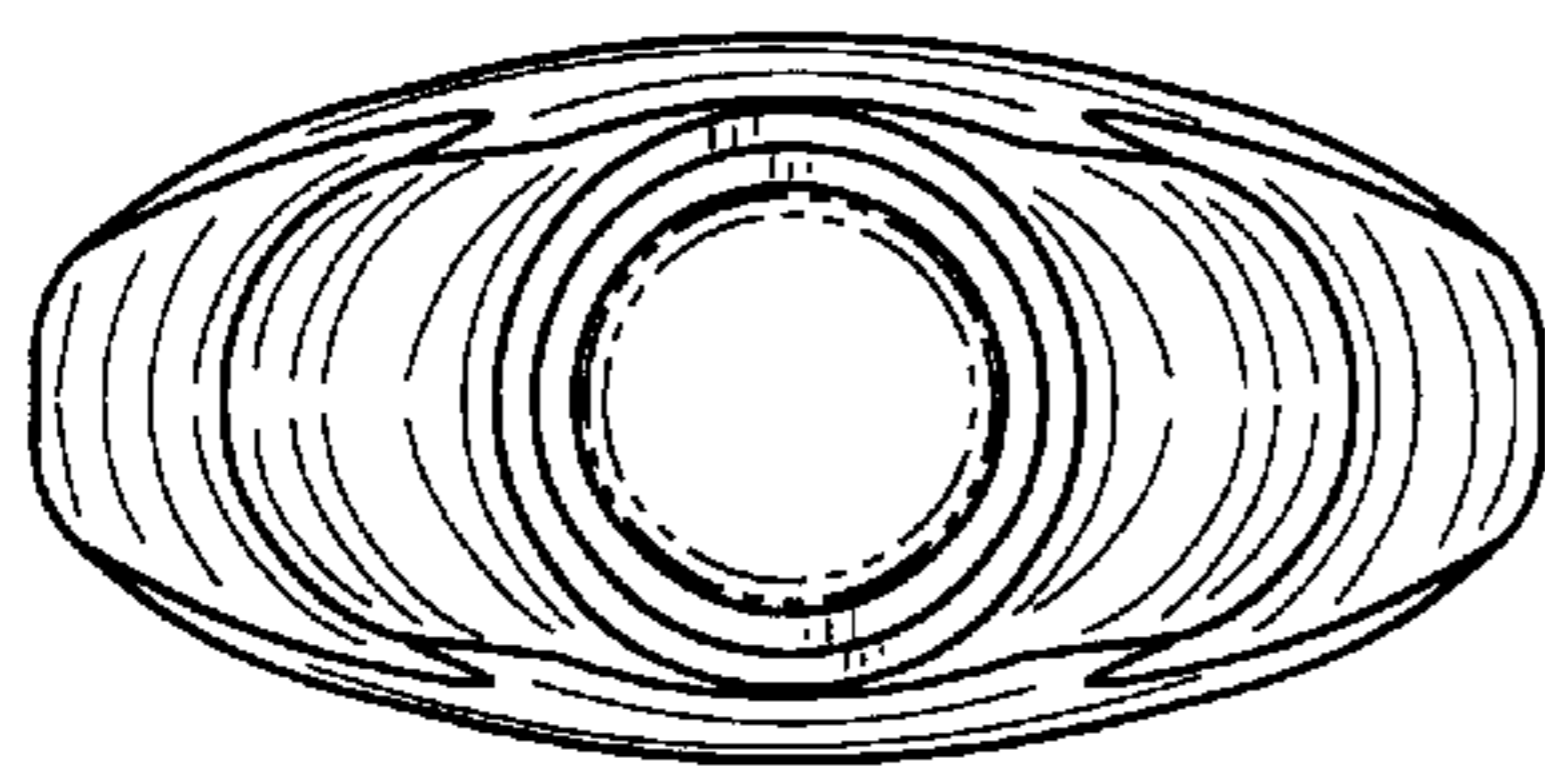

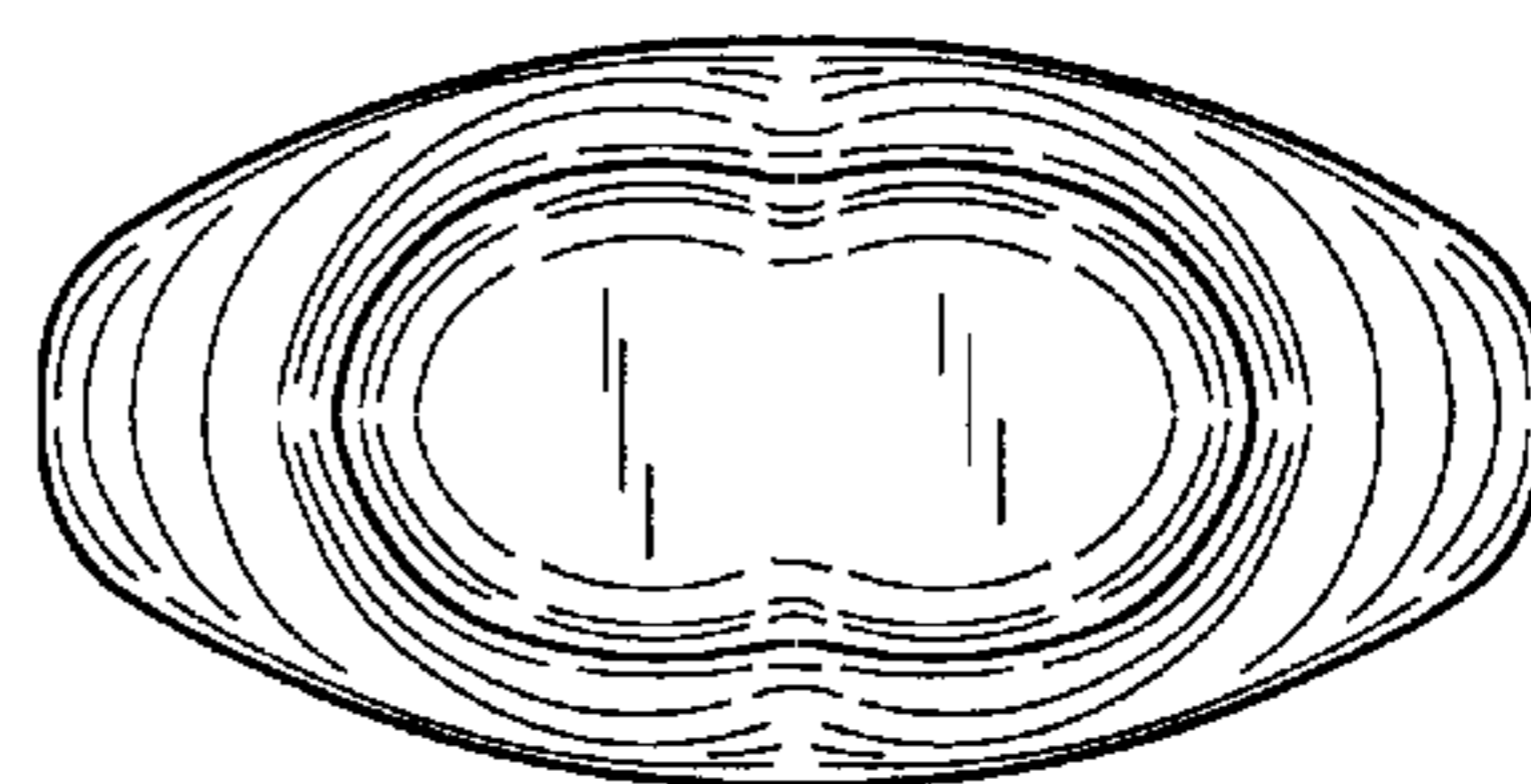

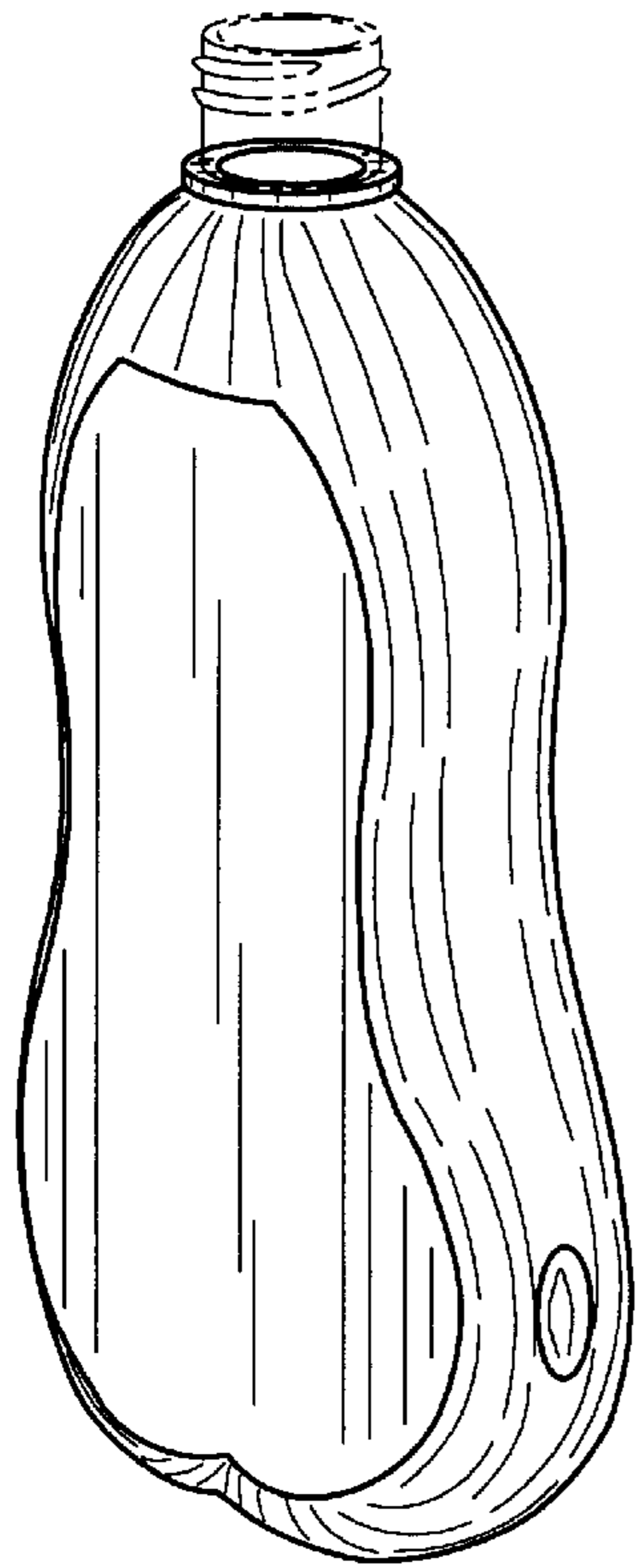

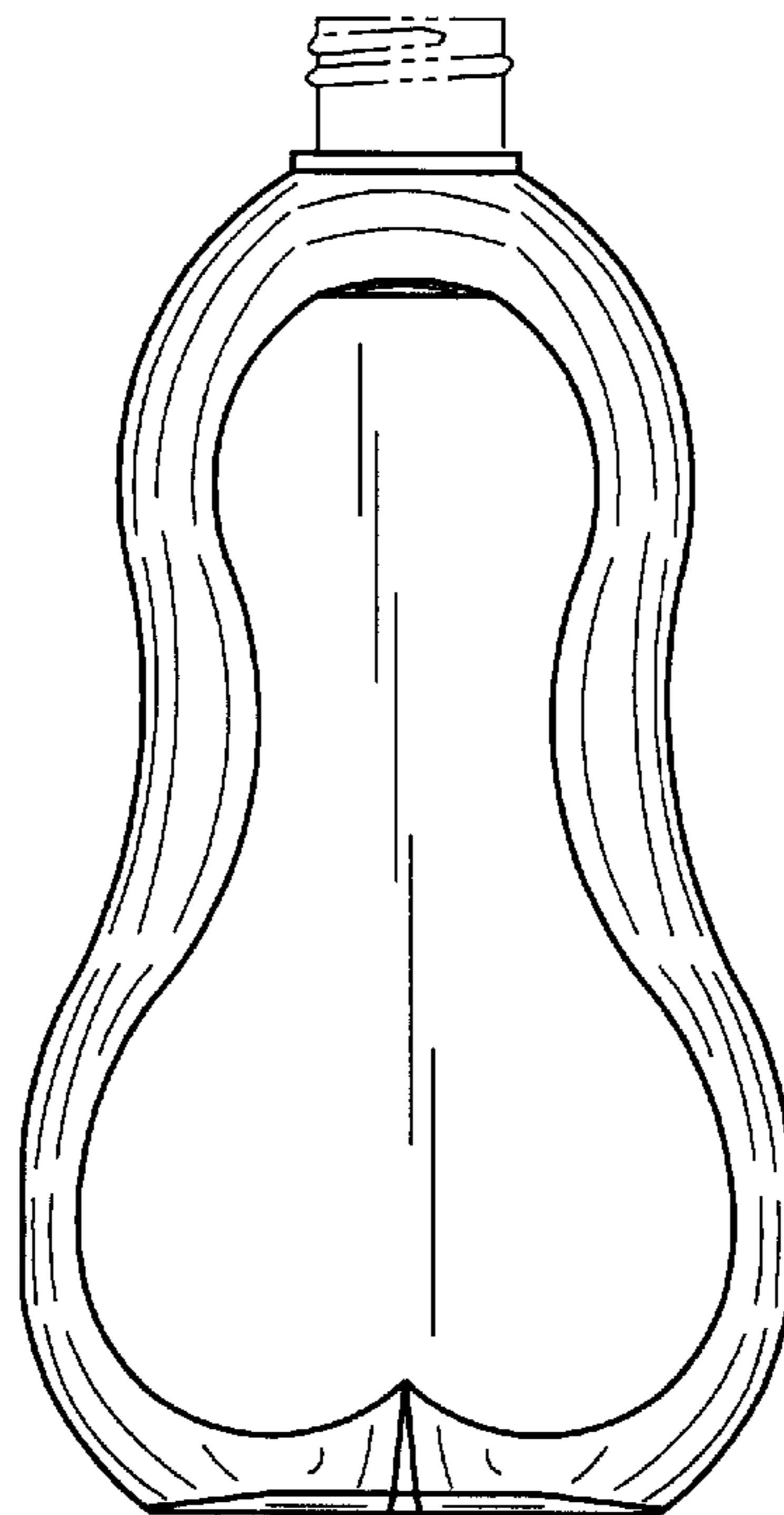

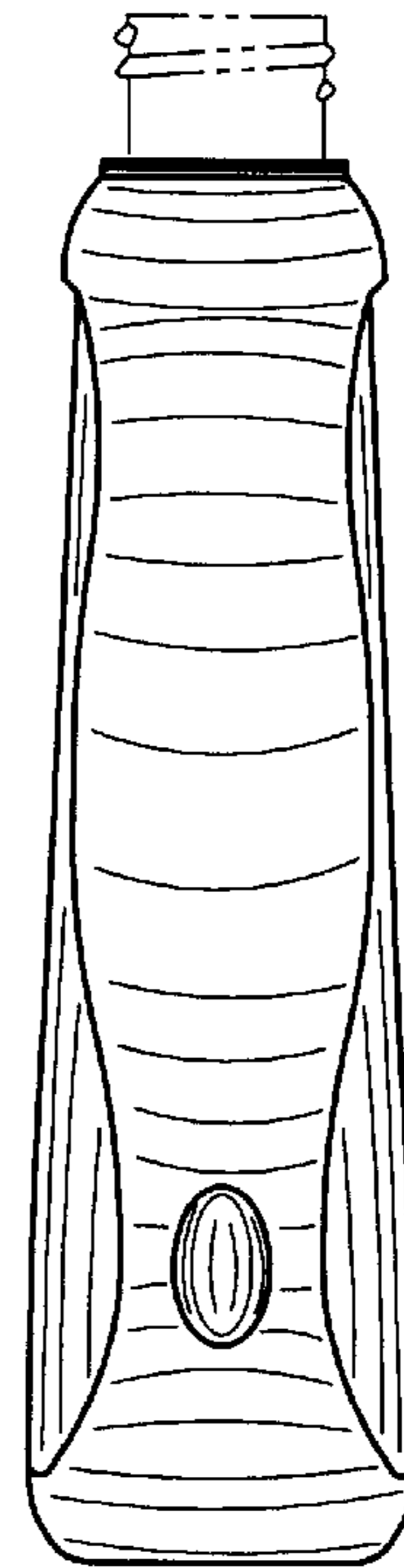

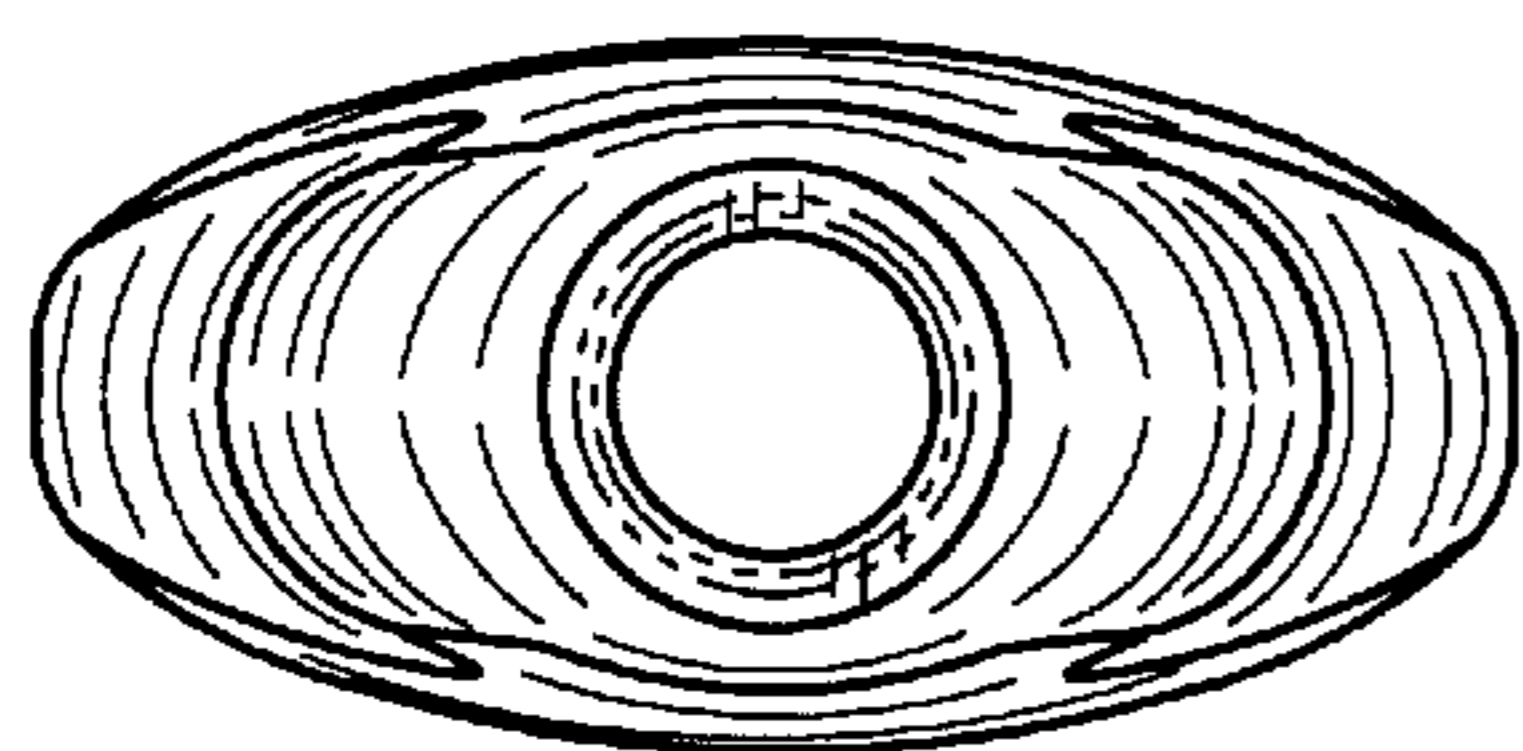

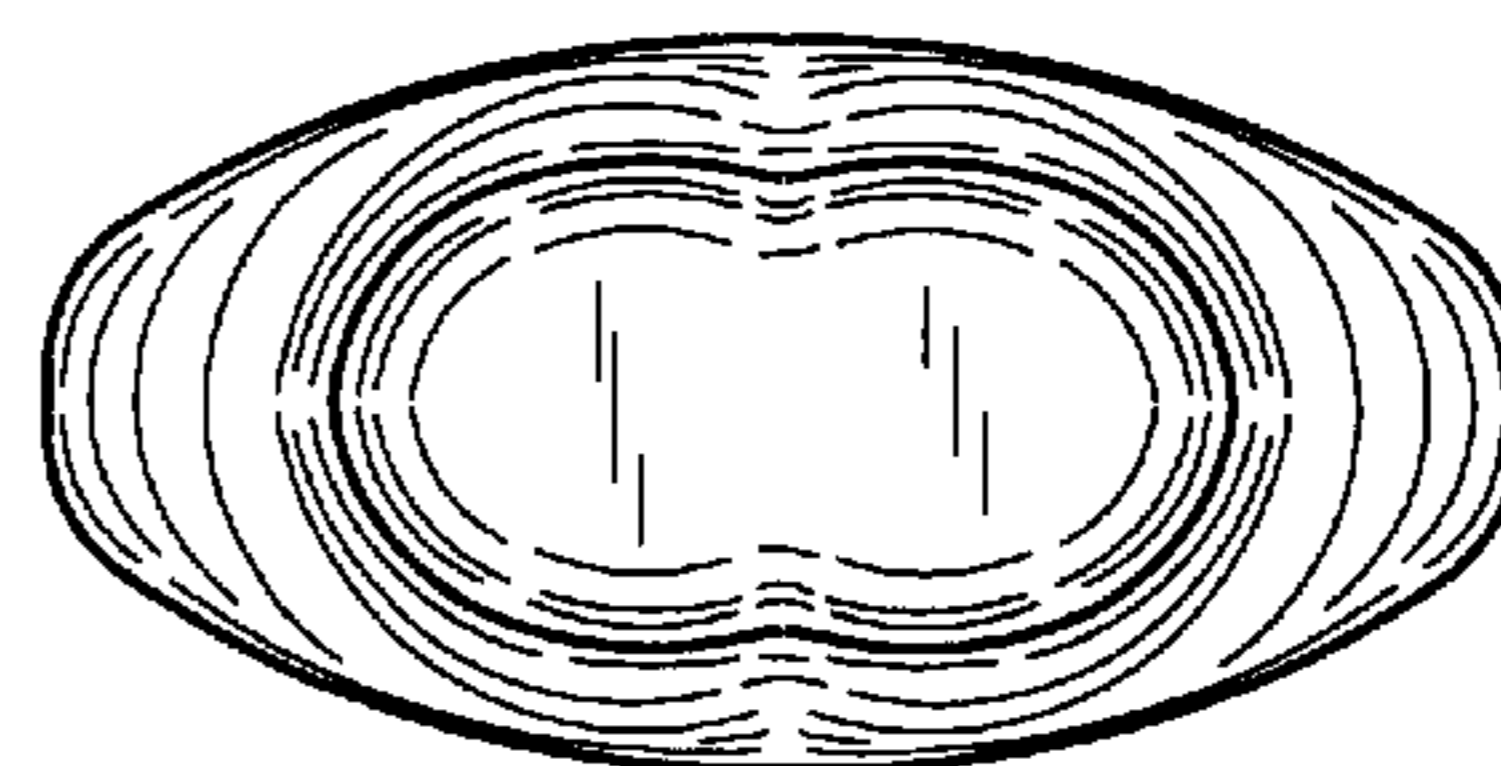
