(57) **CLAIM**

The ornamental design for a suction cup mounted shower container, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and right side perspective view of the present invention with the shower container portion and the suction cup portion of the suction cup mounted shower container shown in exploded condition;

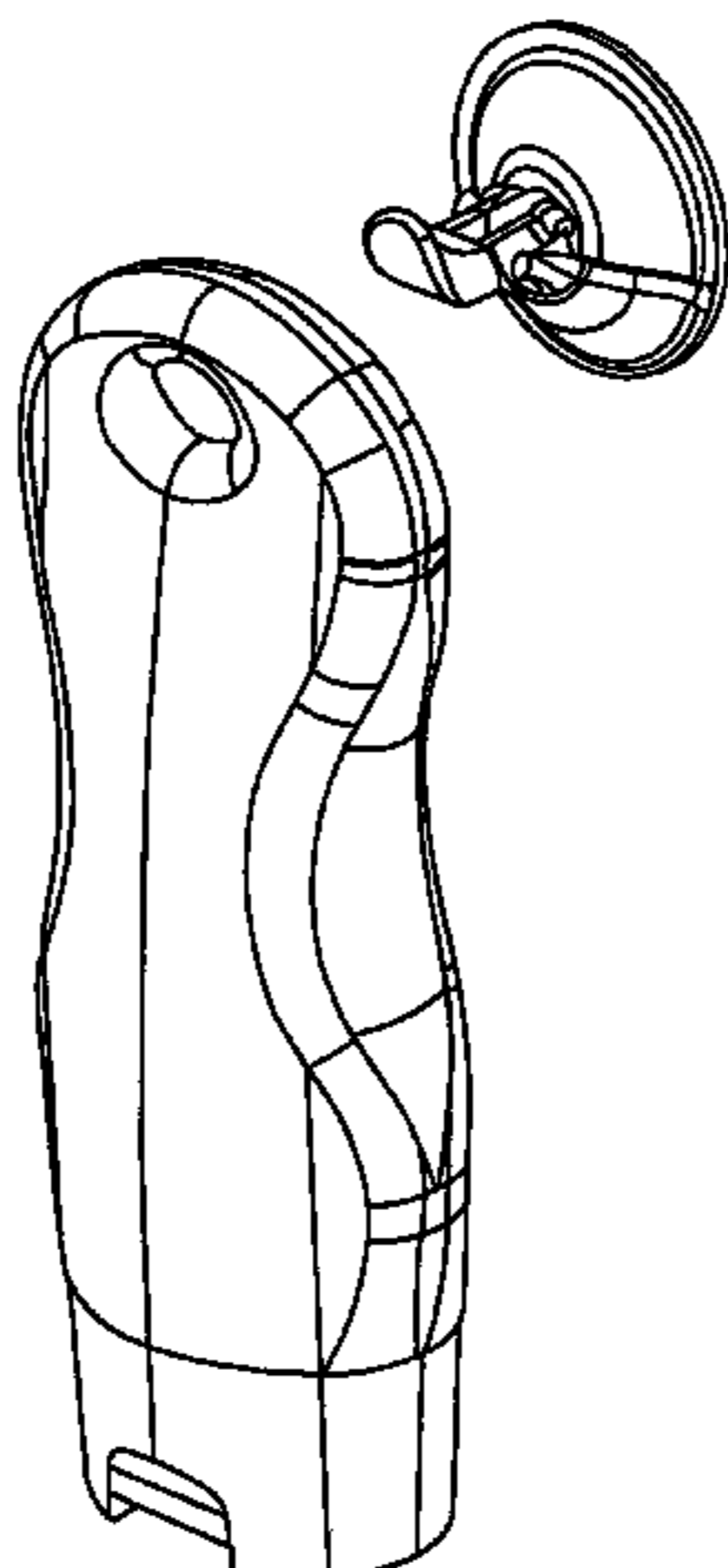


FIG. 2 is a front elevational view thereof, shown with the shower container portion and the suction cup portion of the suction cup mounted shower container shown in assembled condition;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 6 is a top plan view thereof, shown at an enlarged scale;

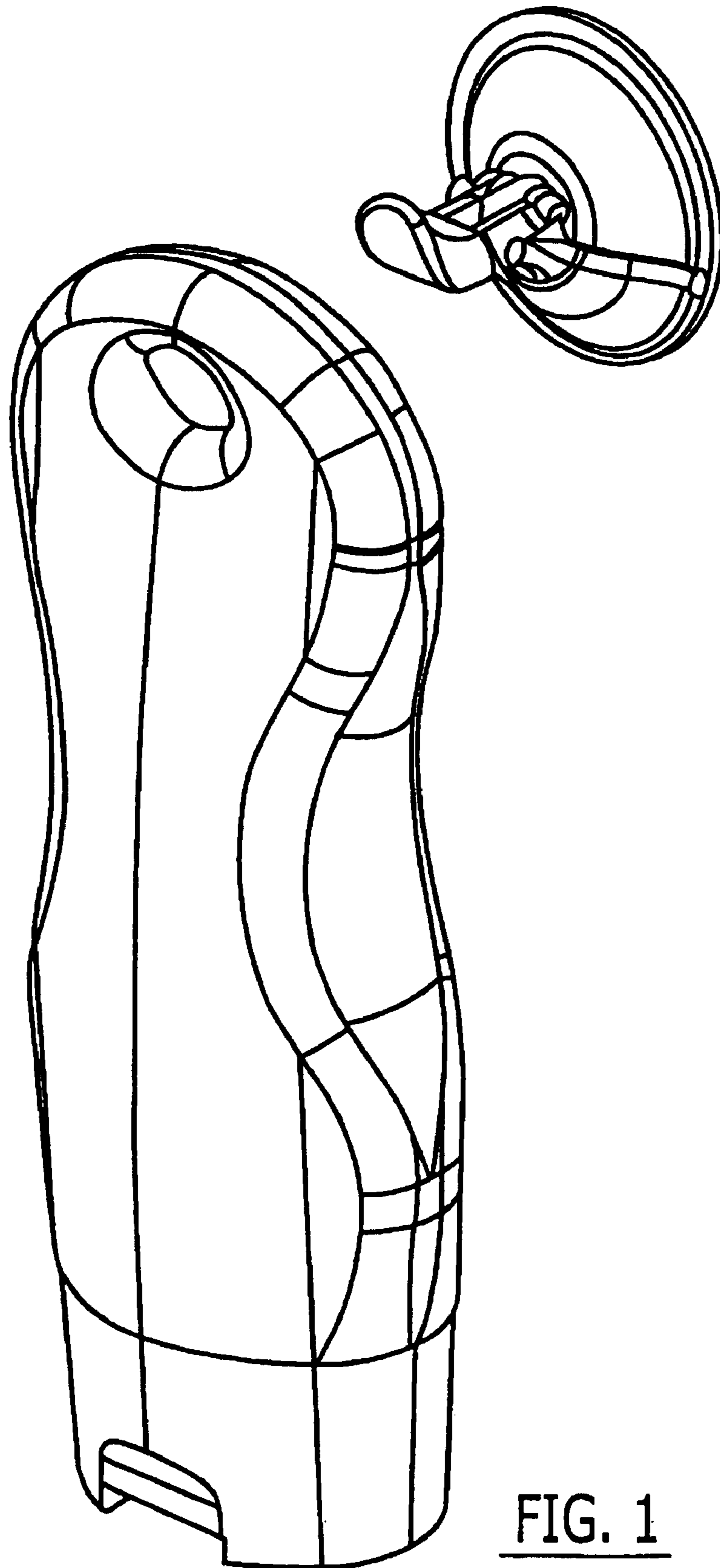

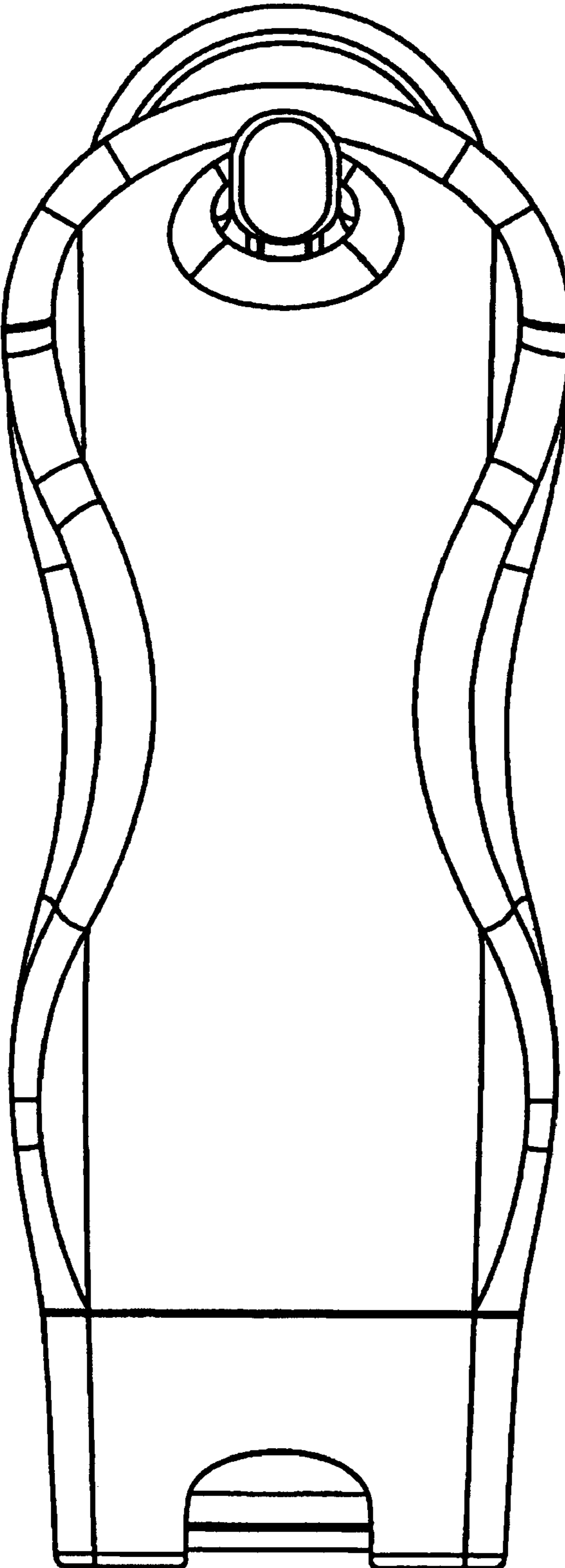

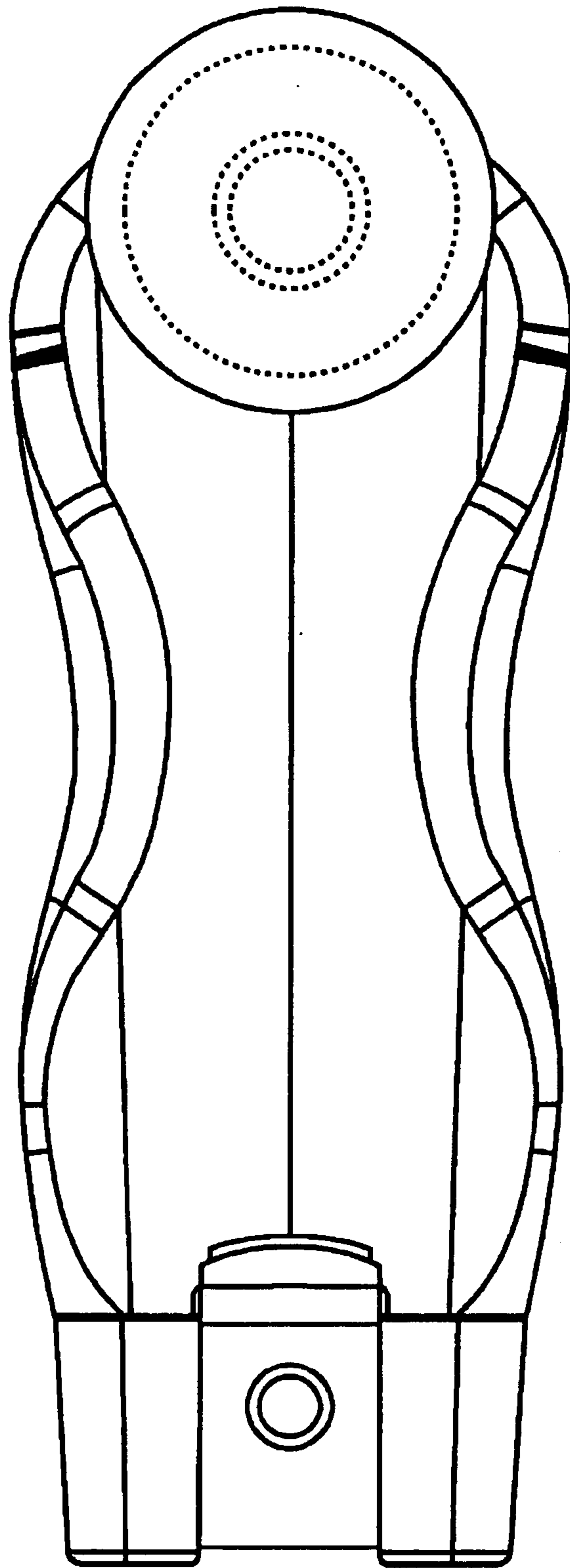

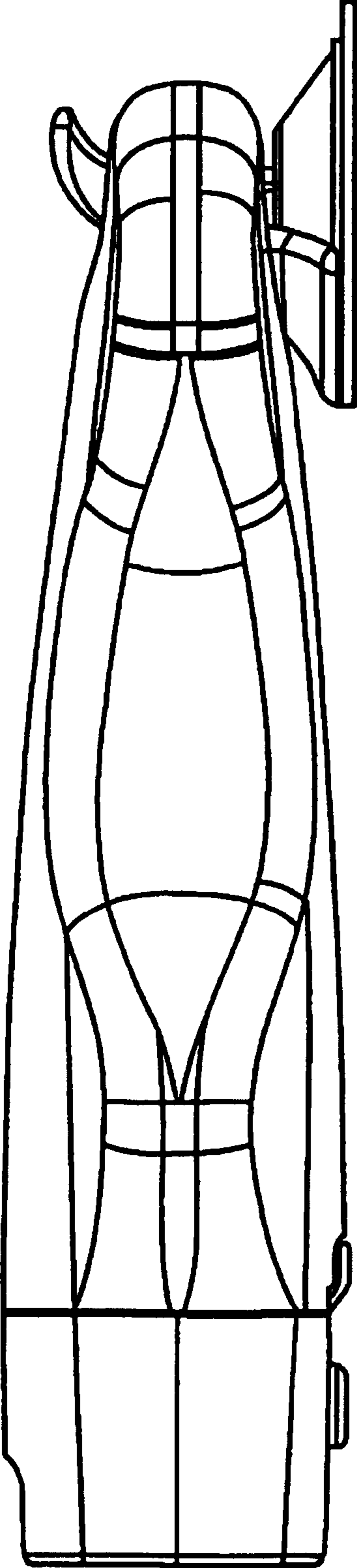

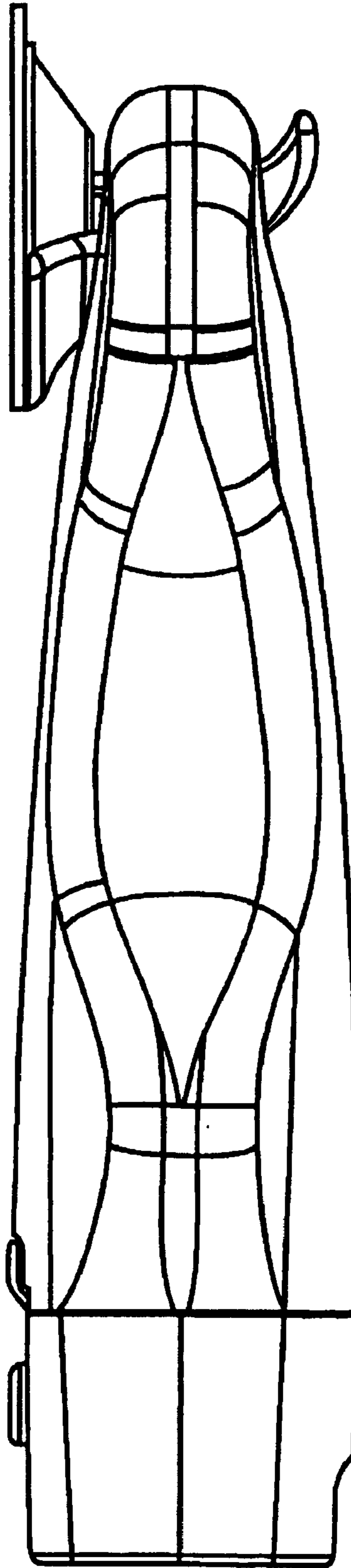

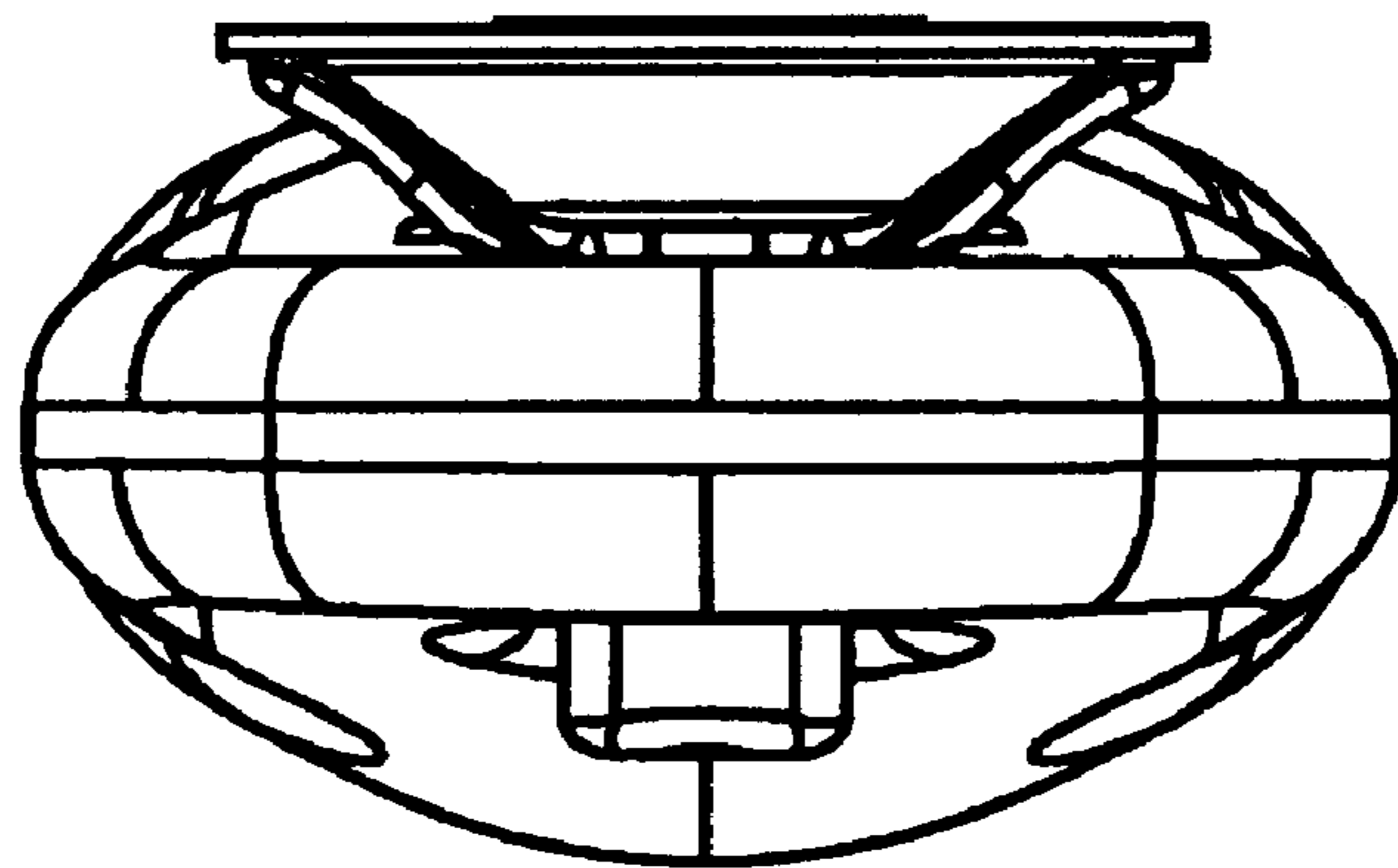

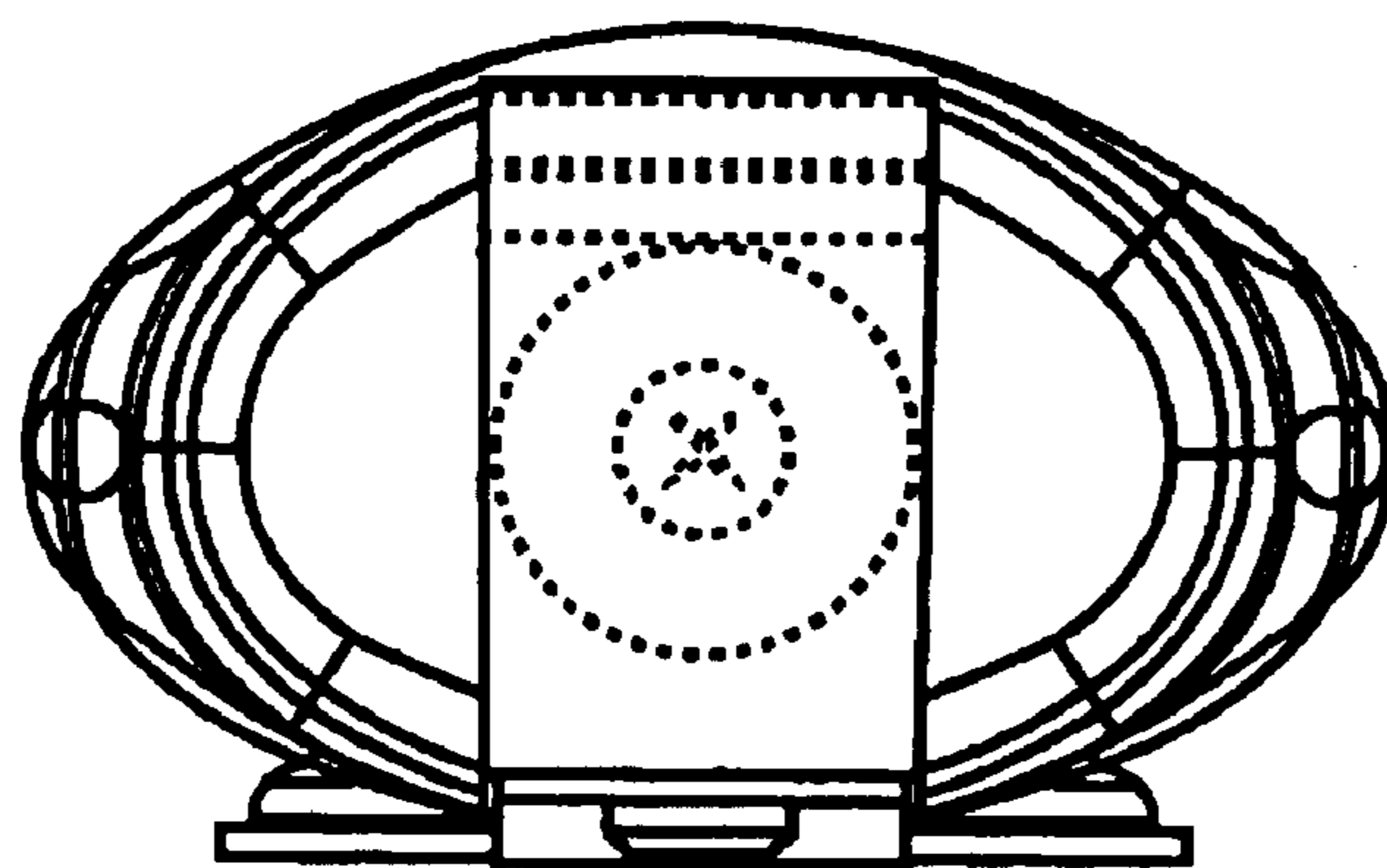
