DESCRIPTION

FIG. 1 is a top view of the brooch;
FIG. 2 is a left side view of the brooch;
FIG. 3 is a right side view of the brooch;
FIG. 4 is a front view of the brooch;
FIG. 5 is a rear view of the brooch;
FIG. 6 is a perspective view of the brooch on a bag; and,

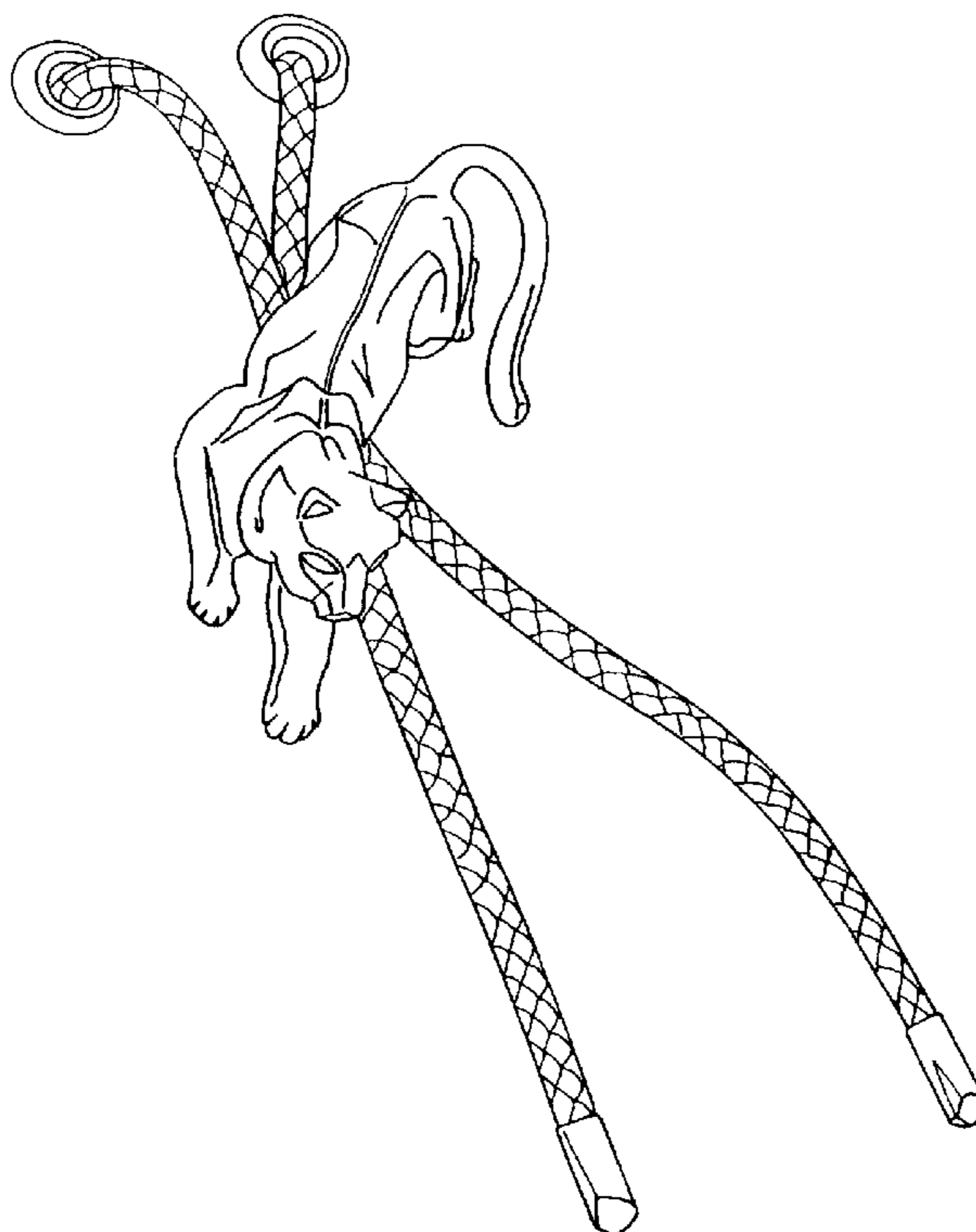

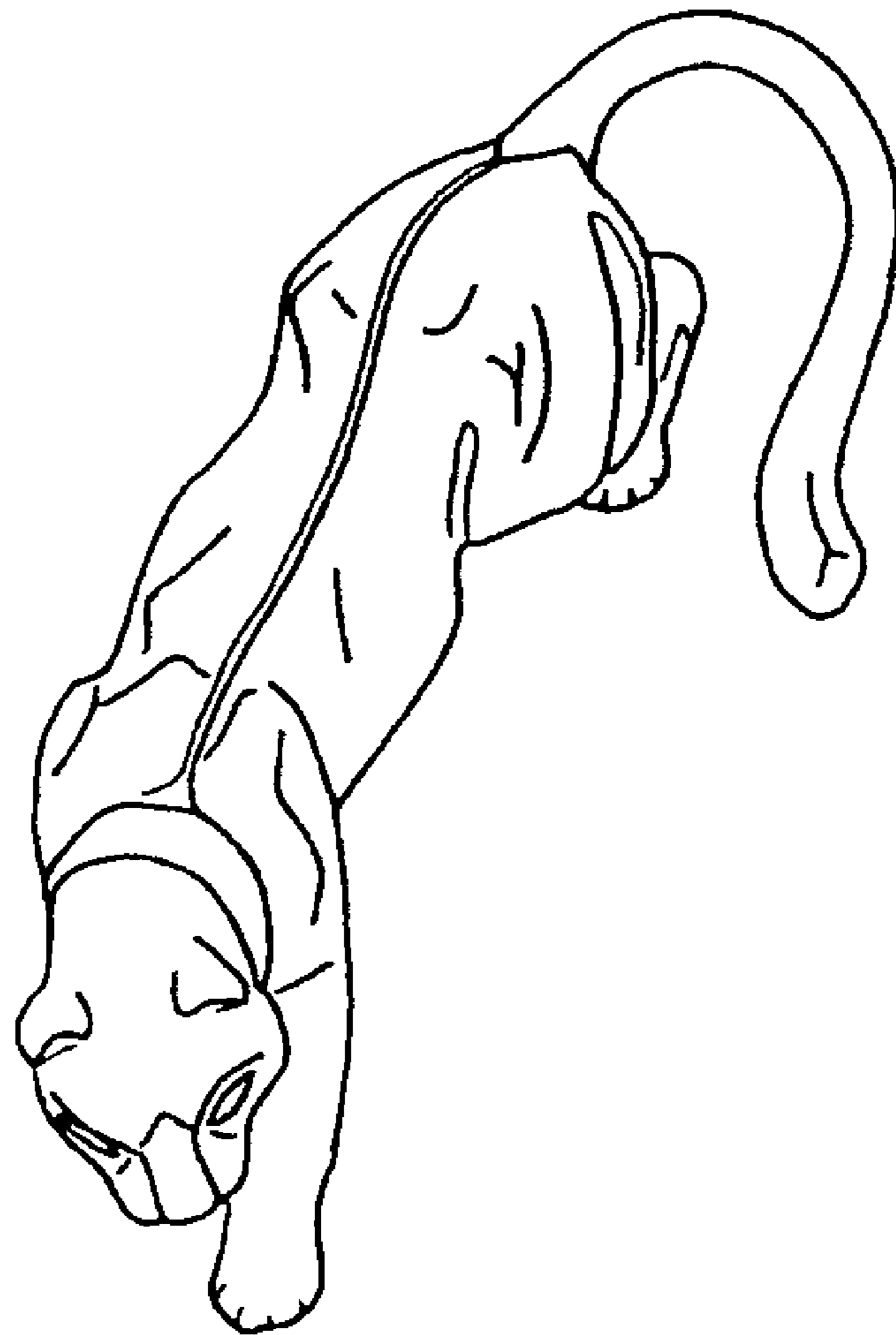

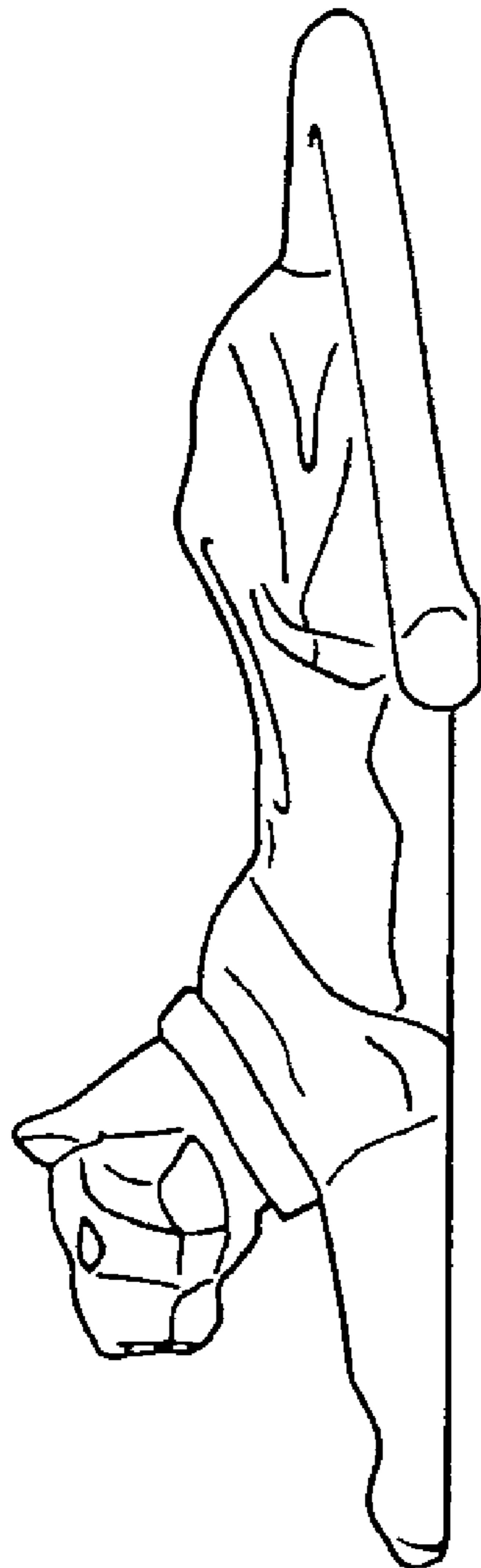

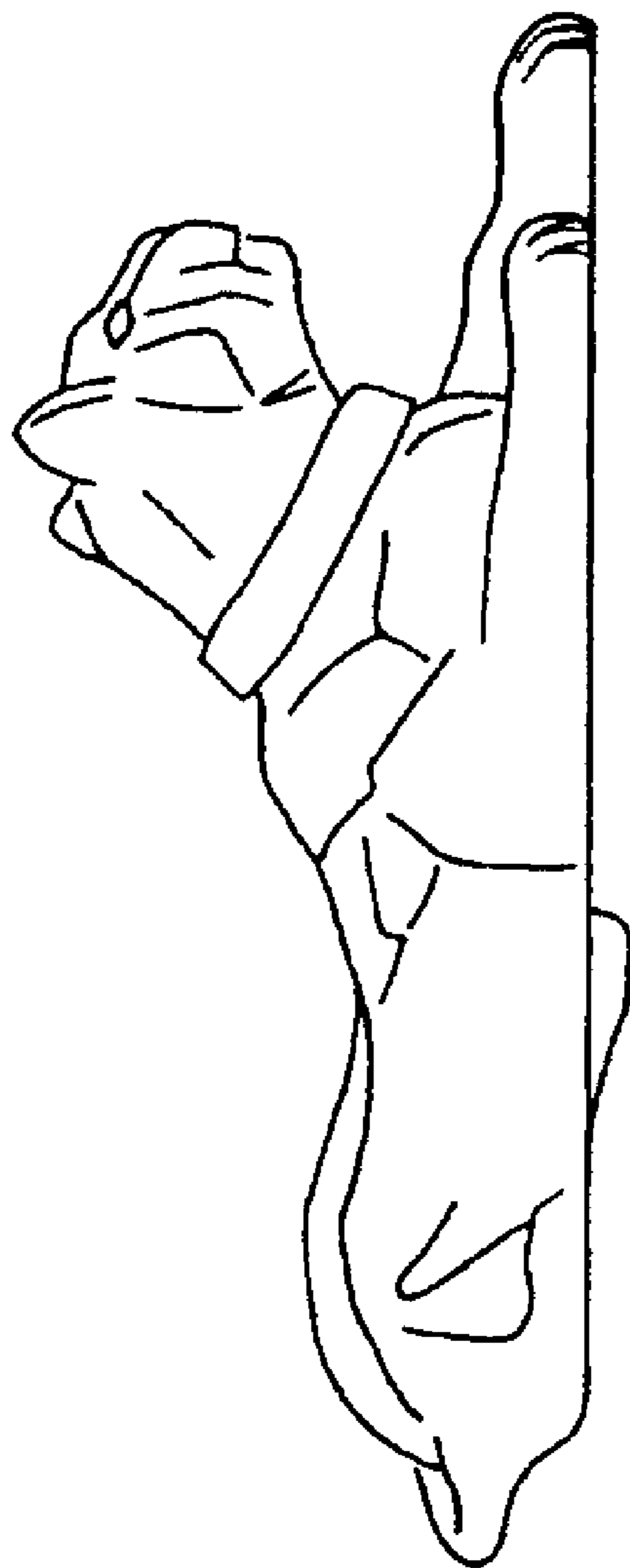

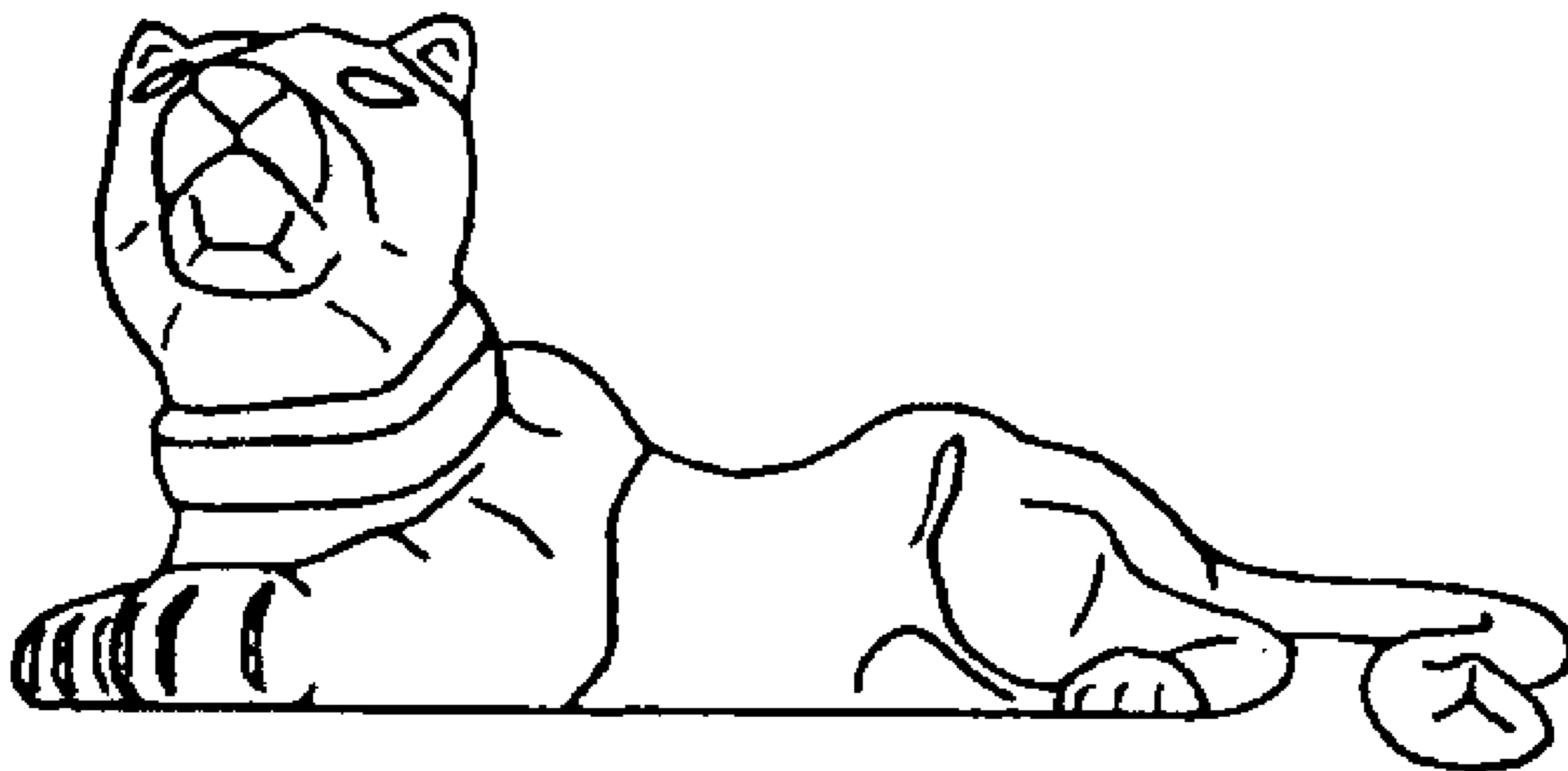

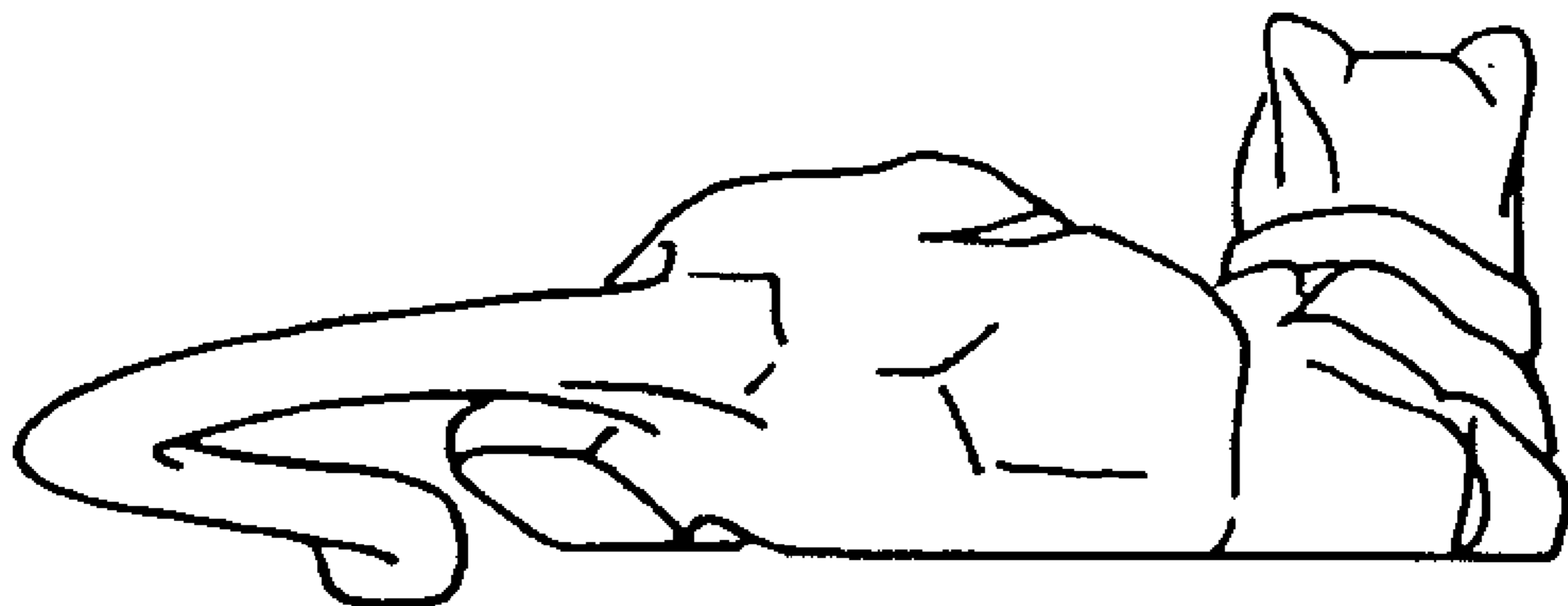

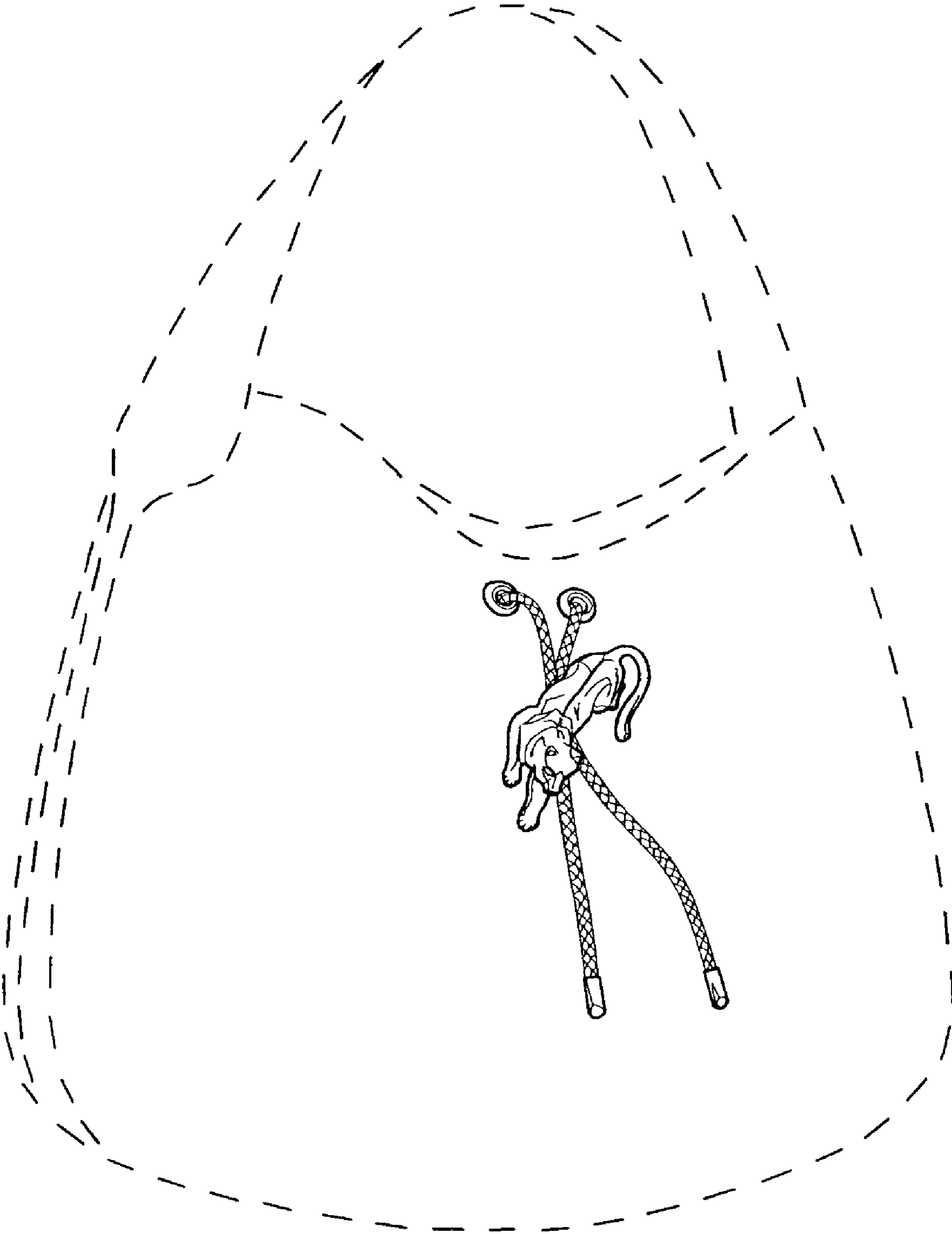
