(57) **CLAIM**

I claim the ornamental design for an object made of glass/gemstone, as shown and described.

DESCRIPTION

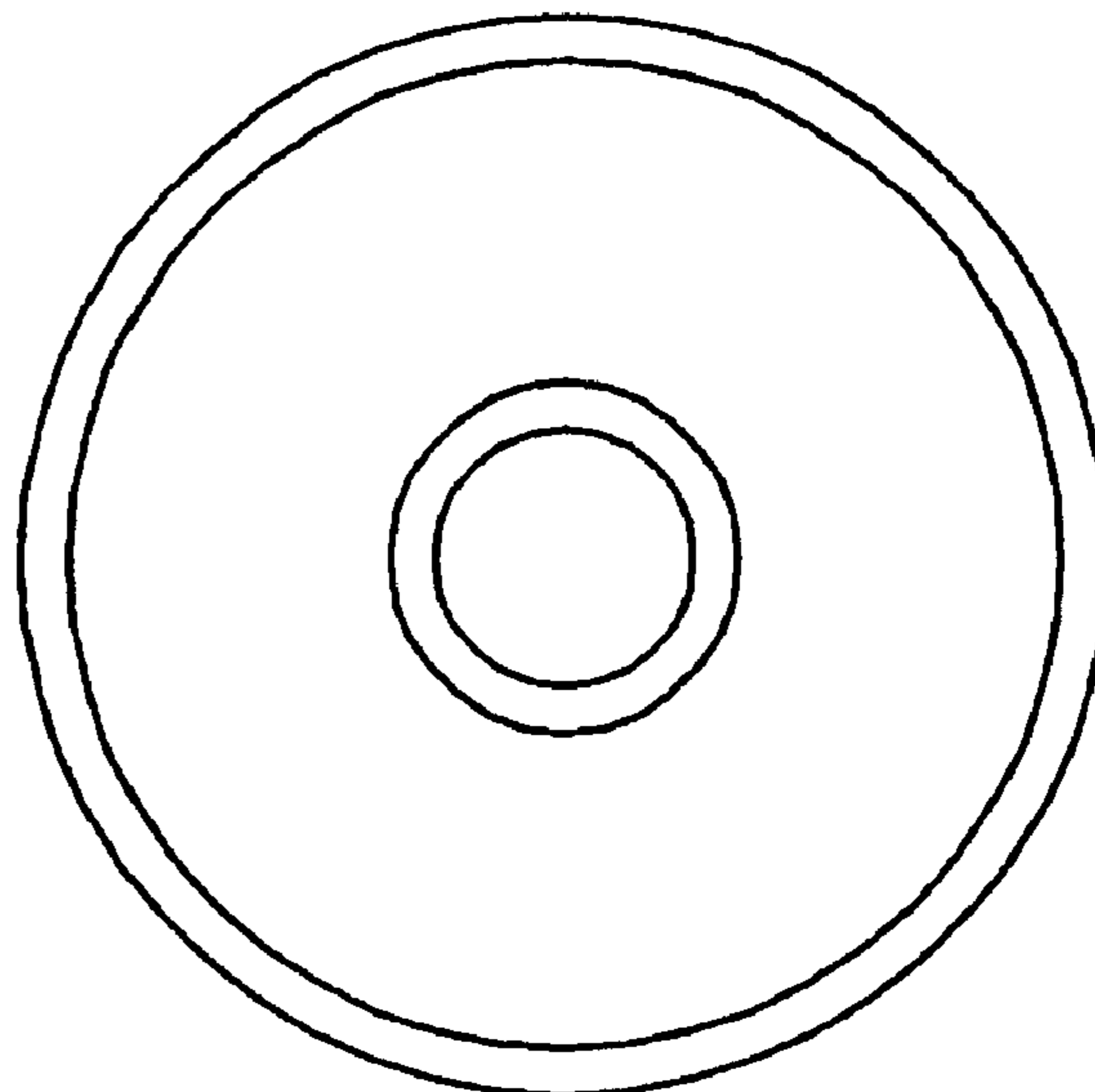
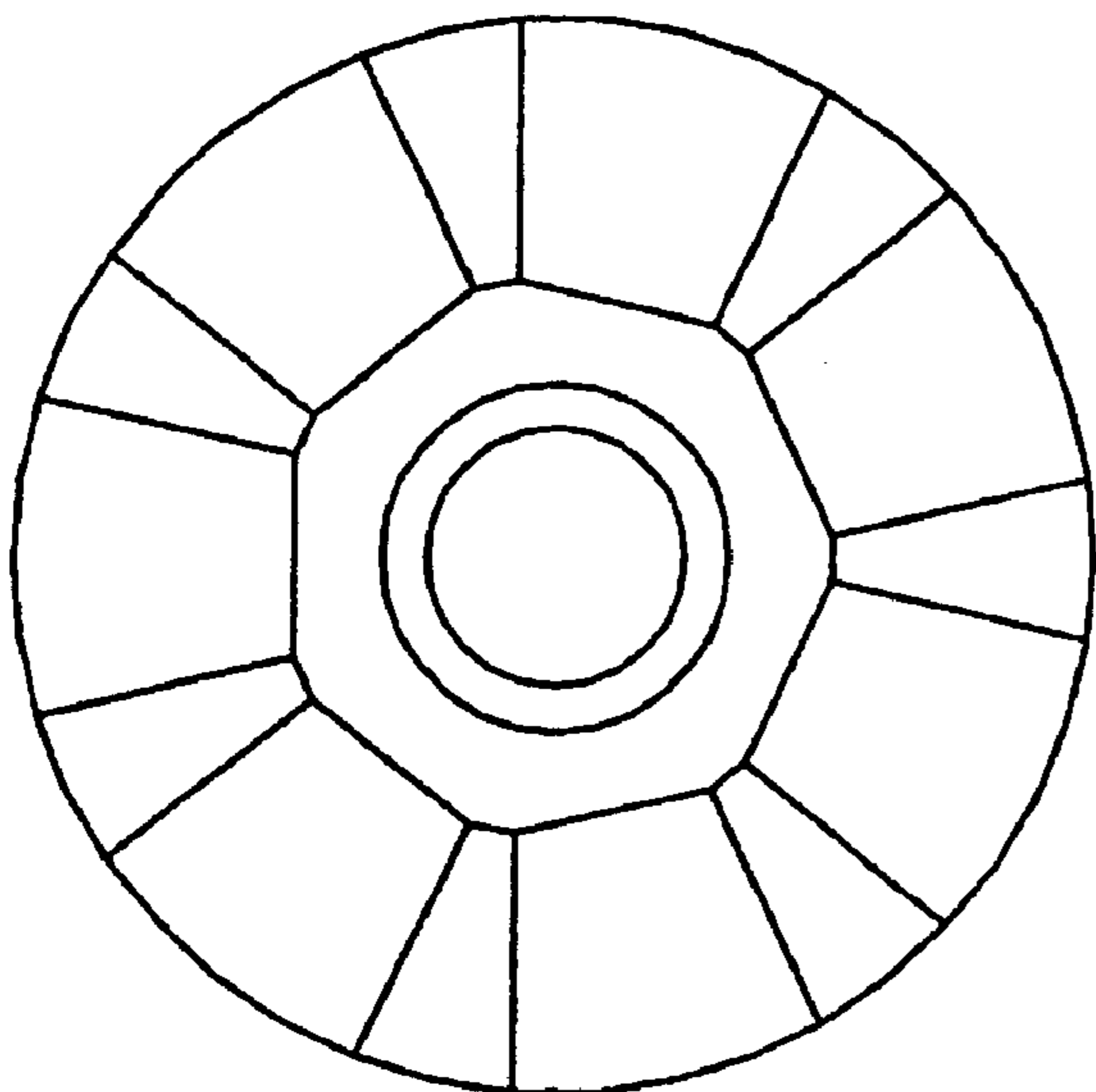

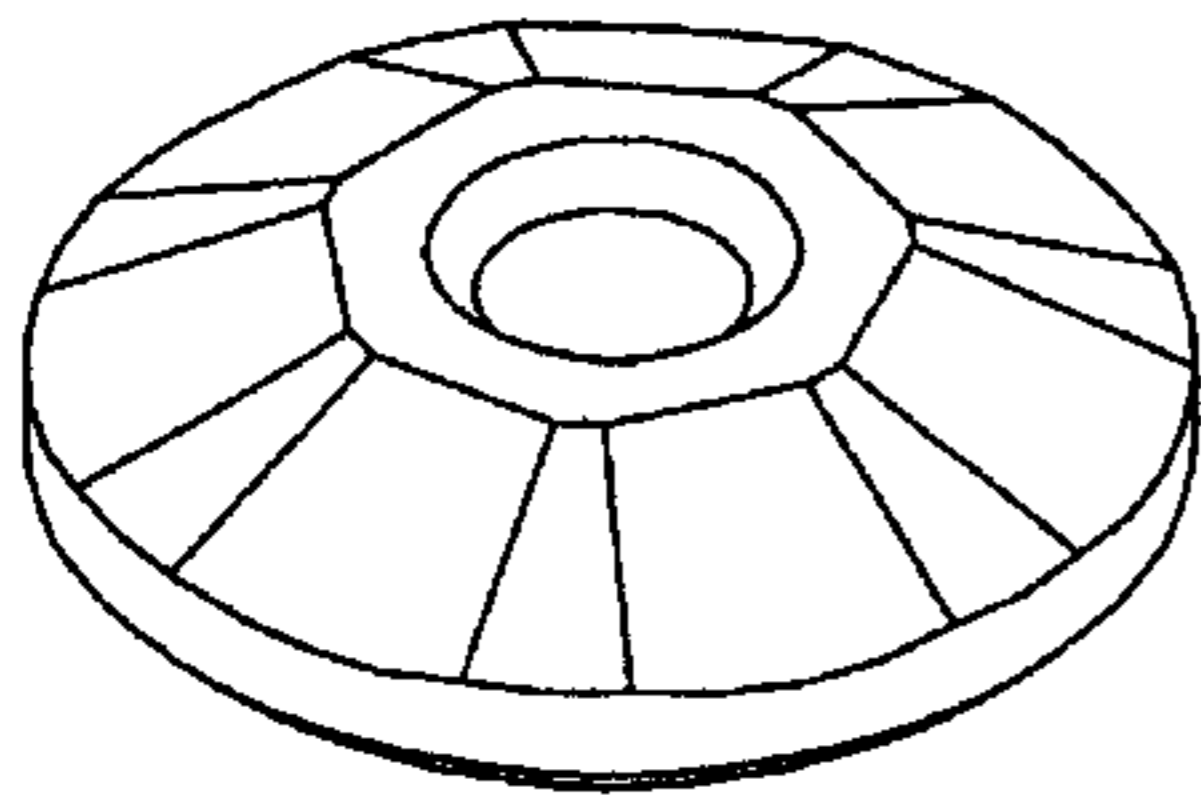

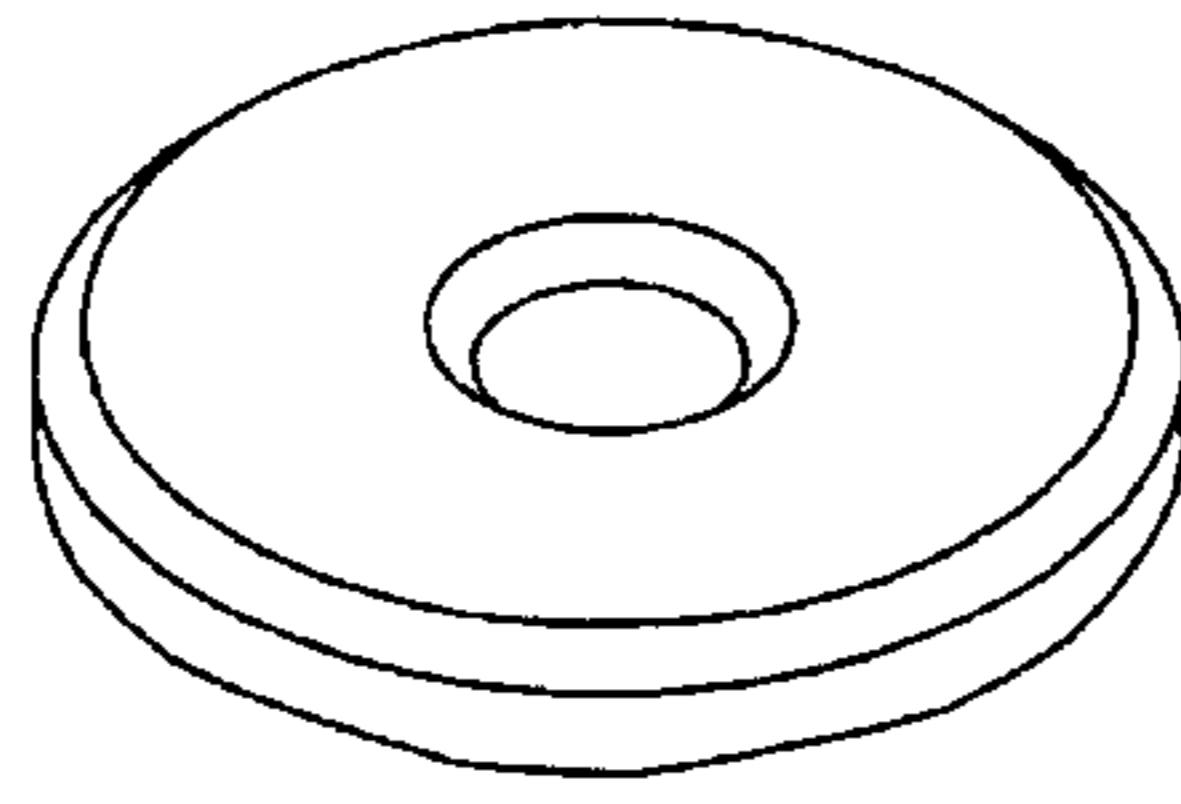

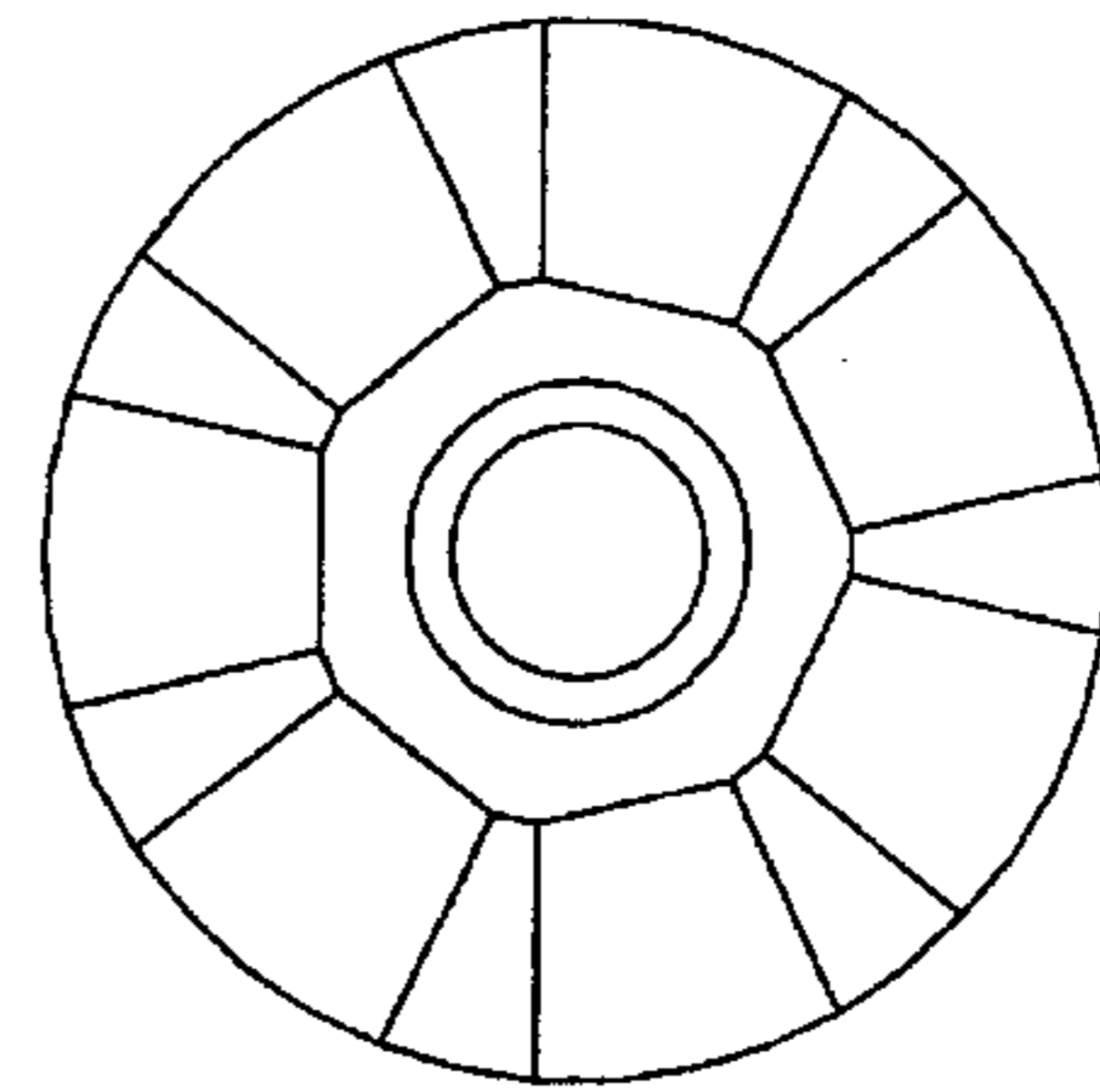

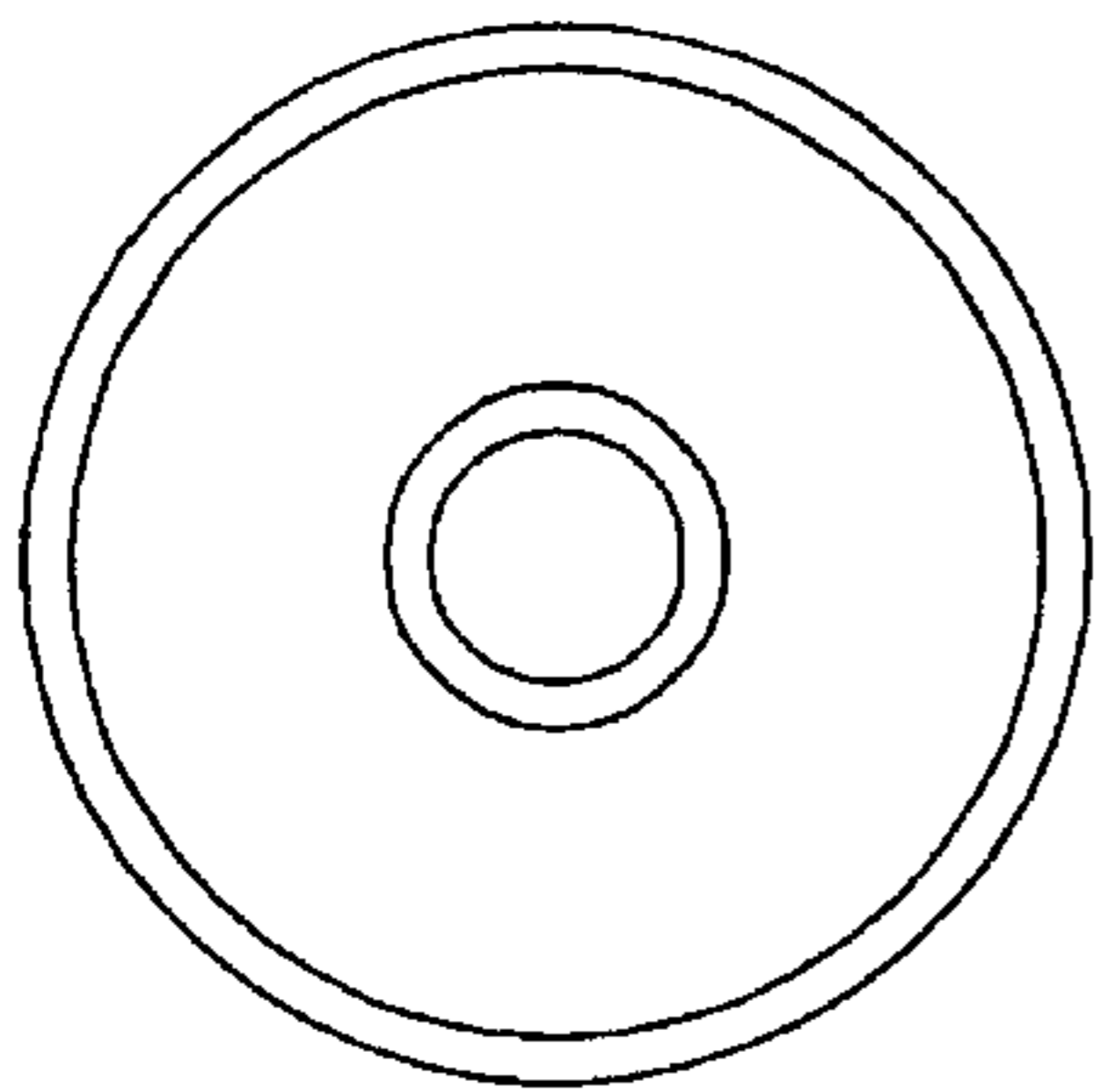

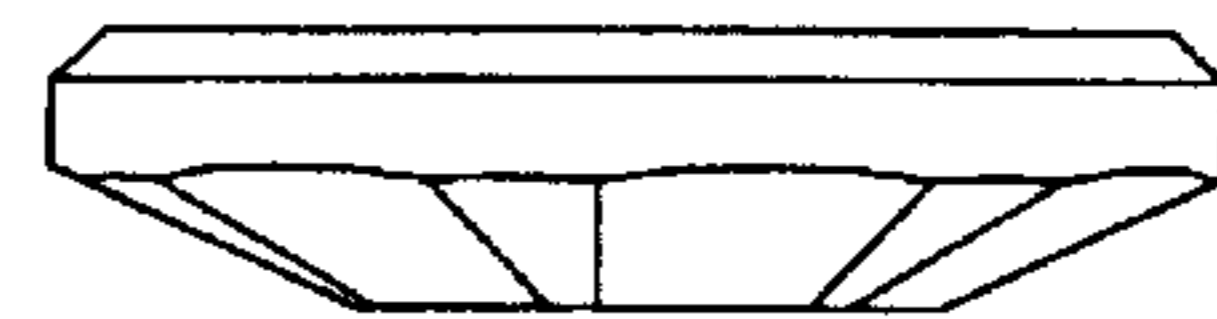

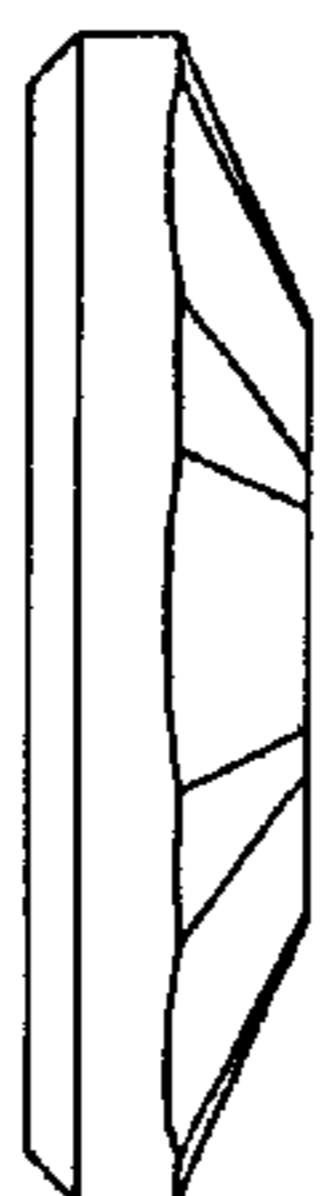

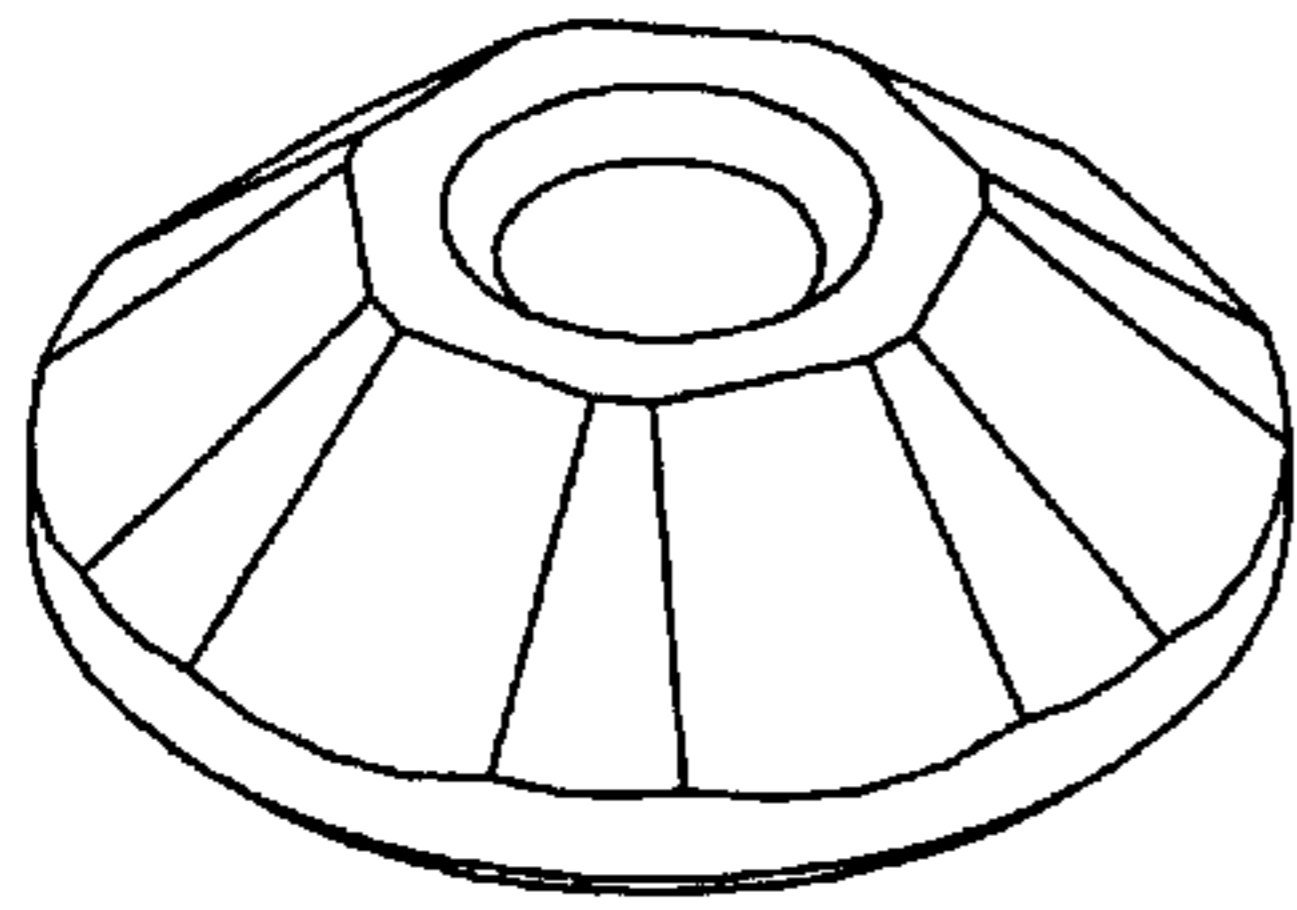

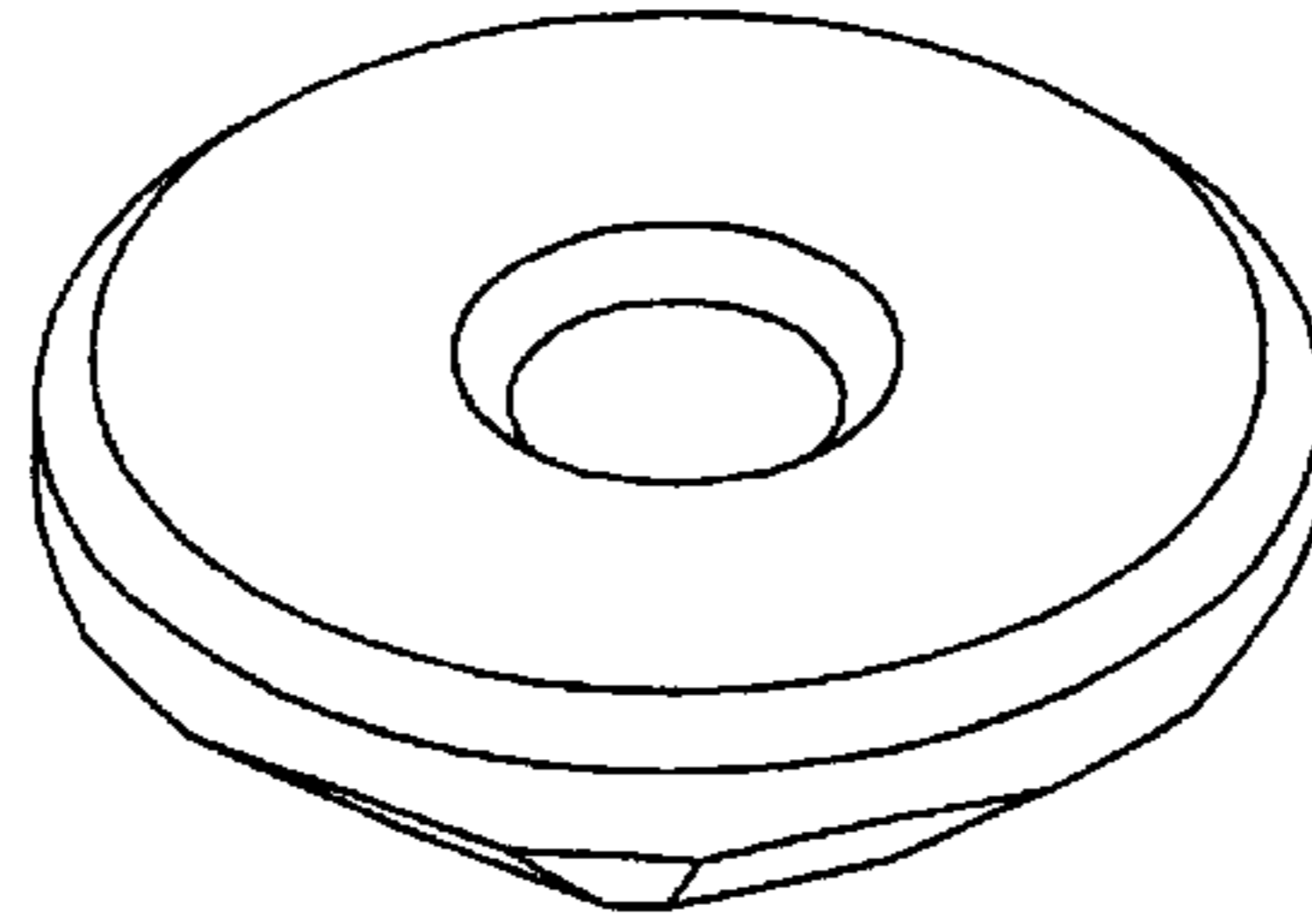

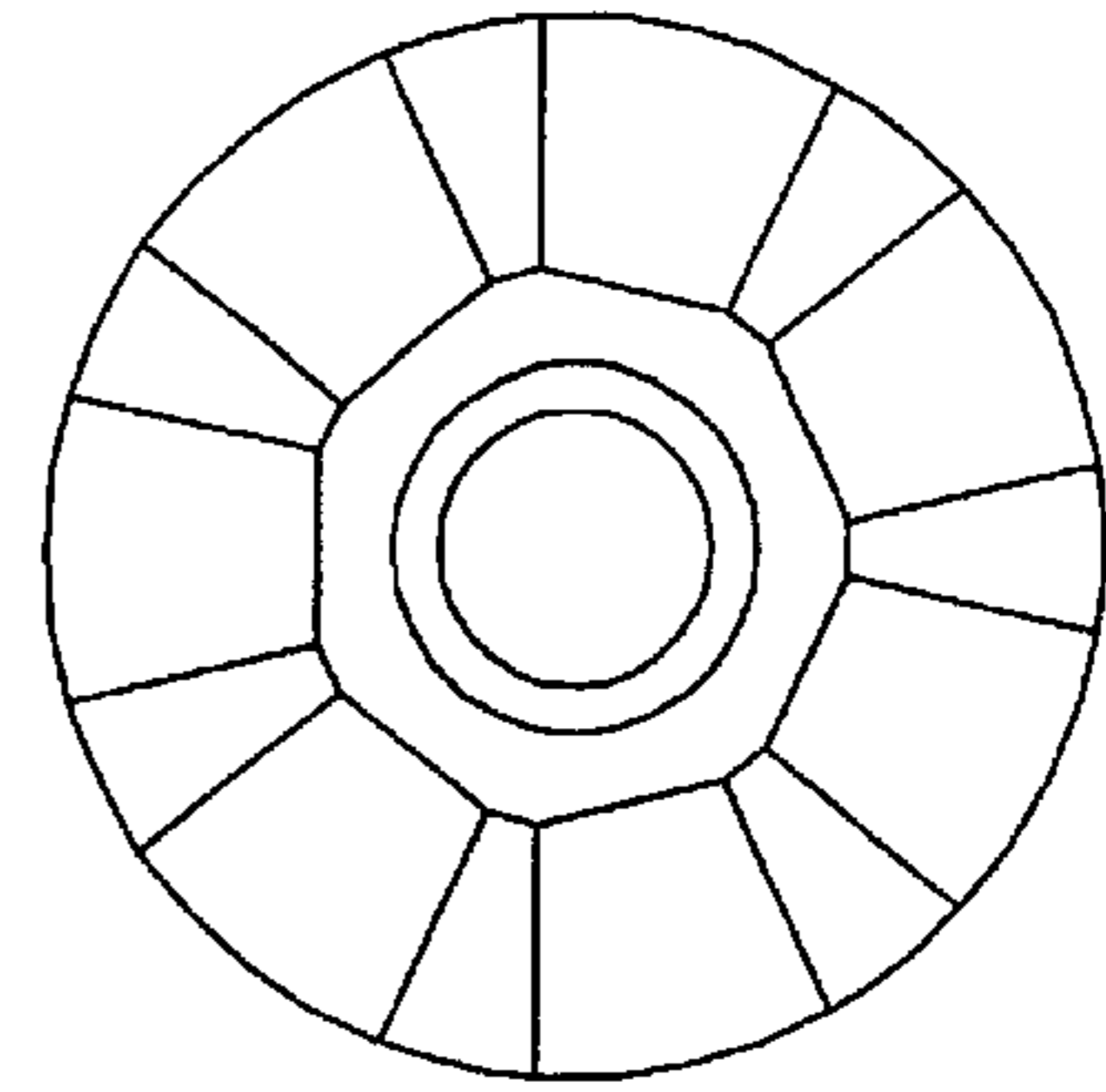

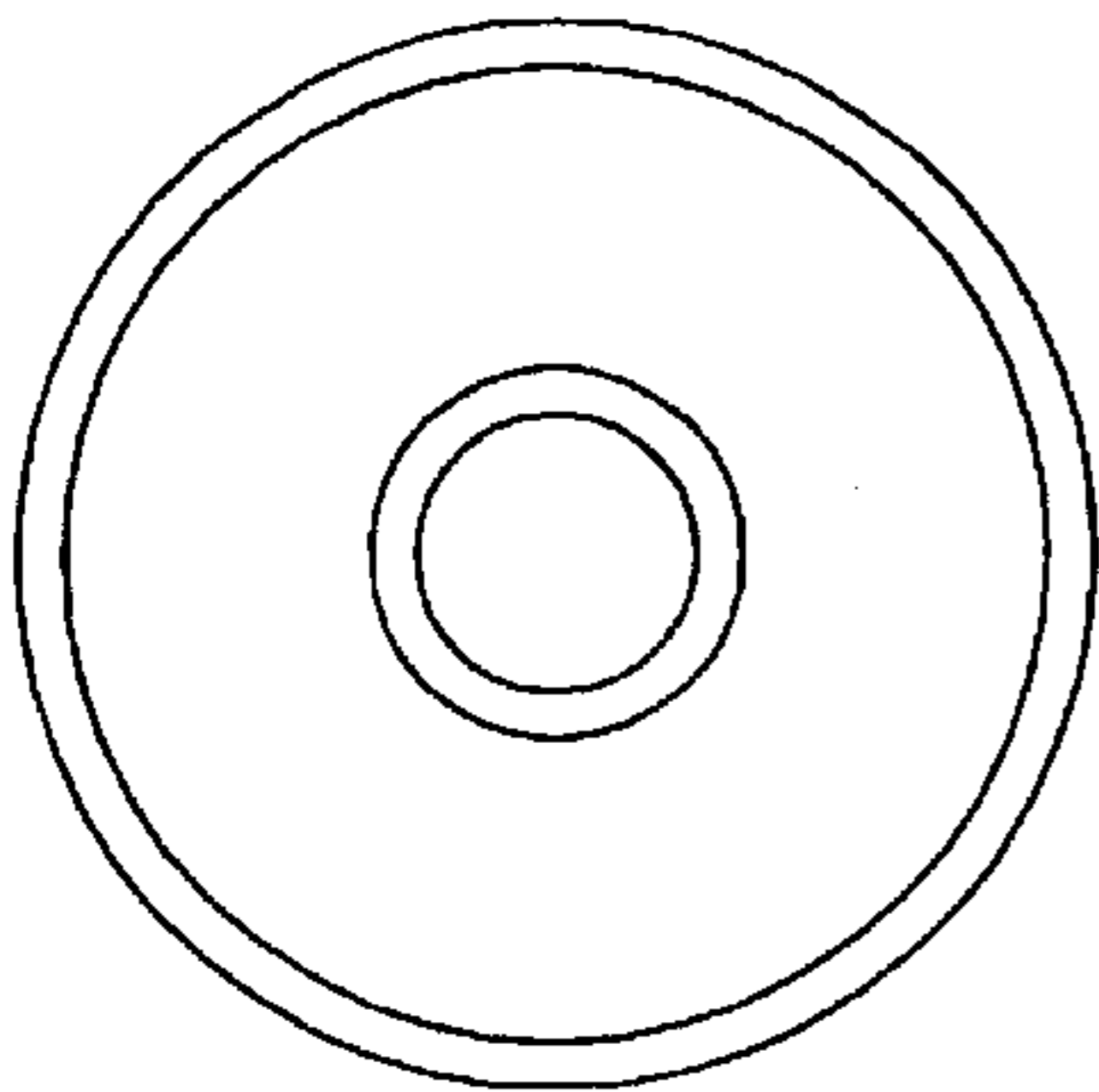

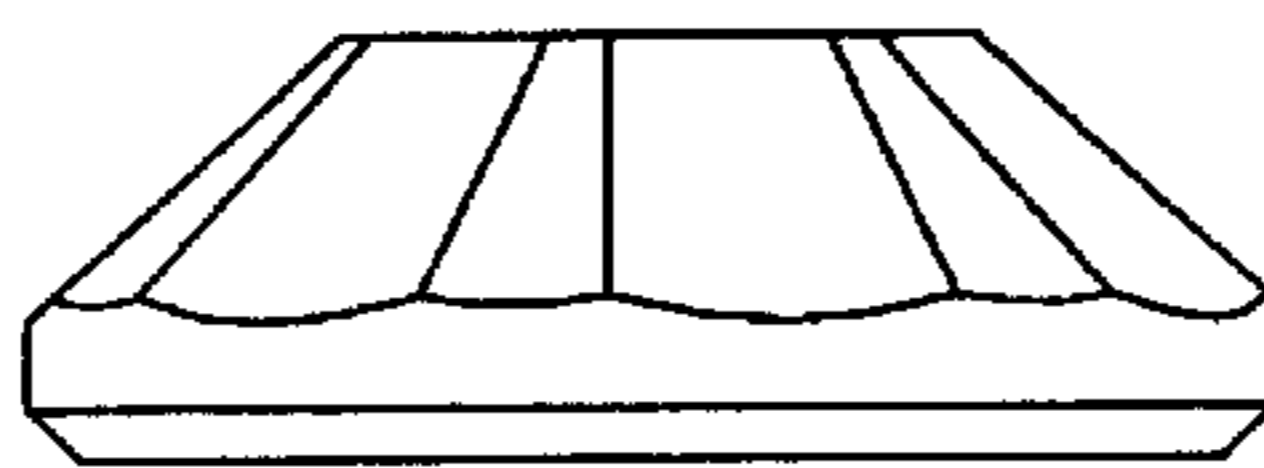

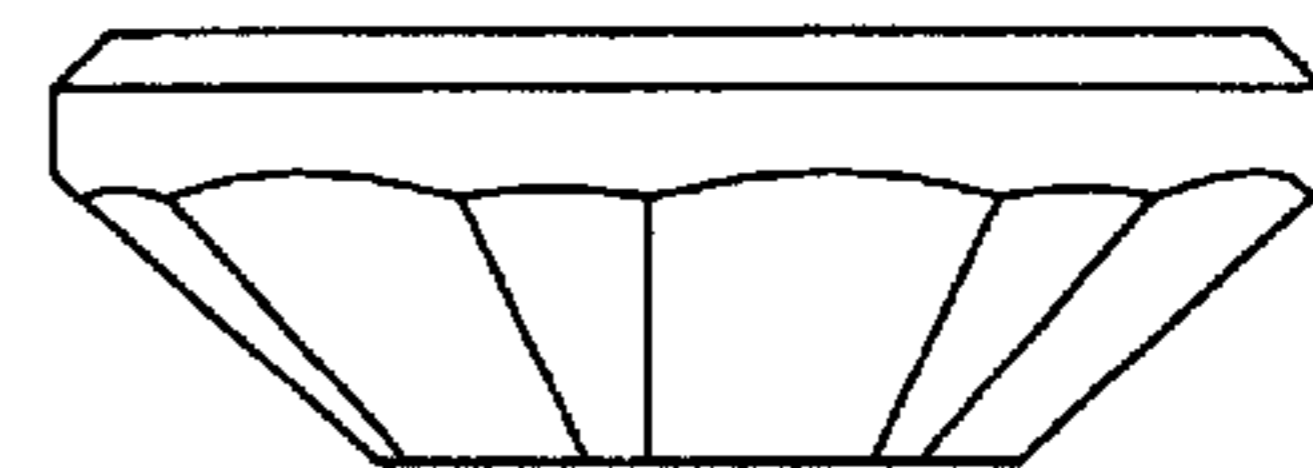

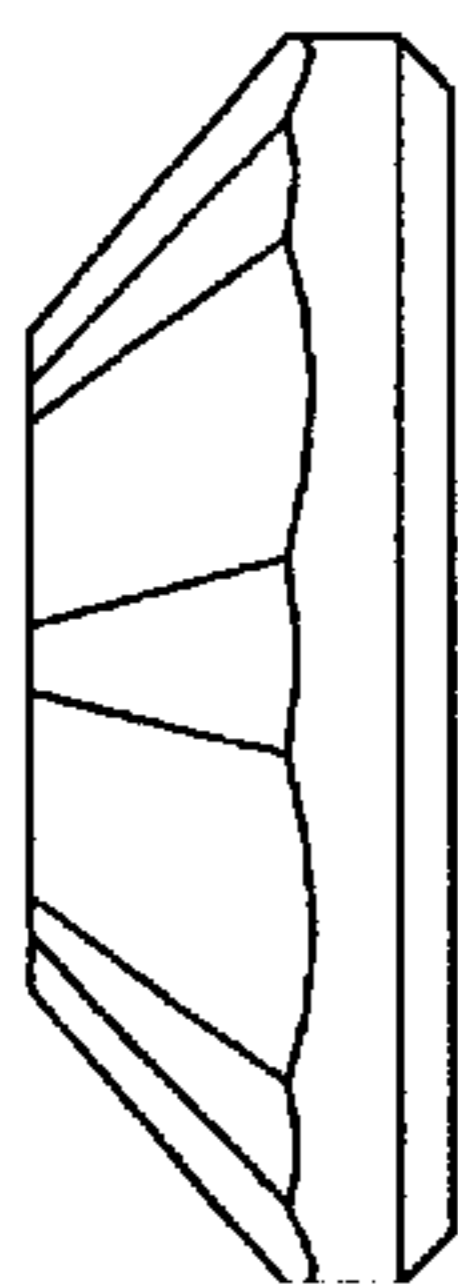
