(57) **CLAIM**

The ornamental design for a guard for derrick apparatus, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a design for a guard for derrick apparatus according to the present invention.

FIG. 2 is a first side perspective view of the guard of FIG. 1.

FIG. 3 is a second side perspective view of the guard of FIG. 1, opposite to the first side.

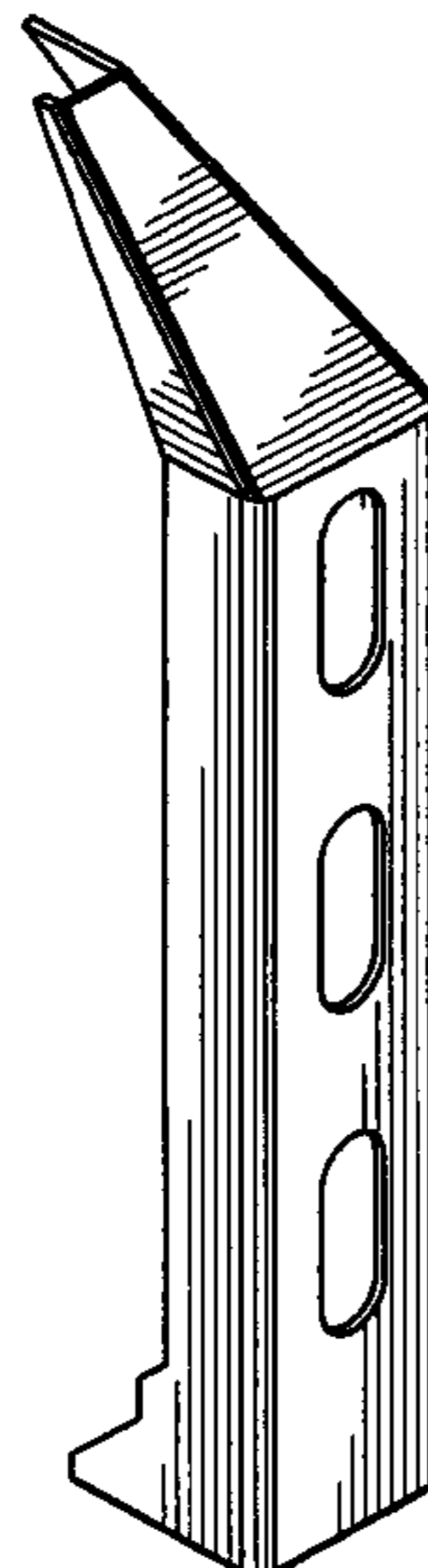
FIG. 4 is a first side view of the guard of FIG. 1.

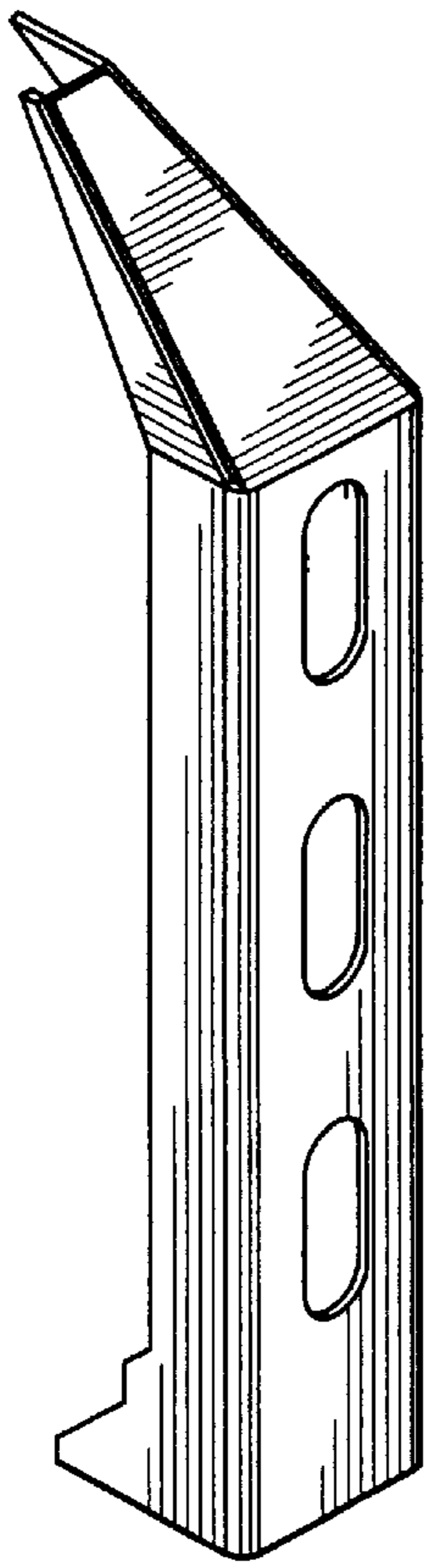

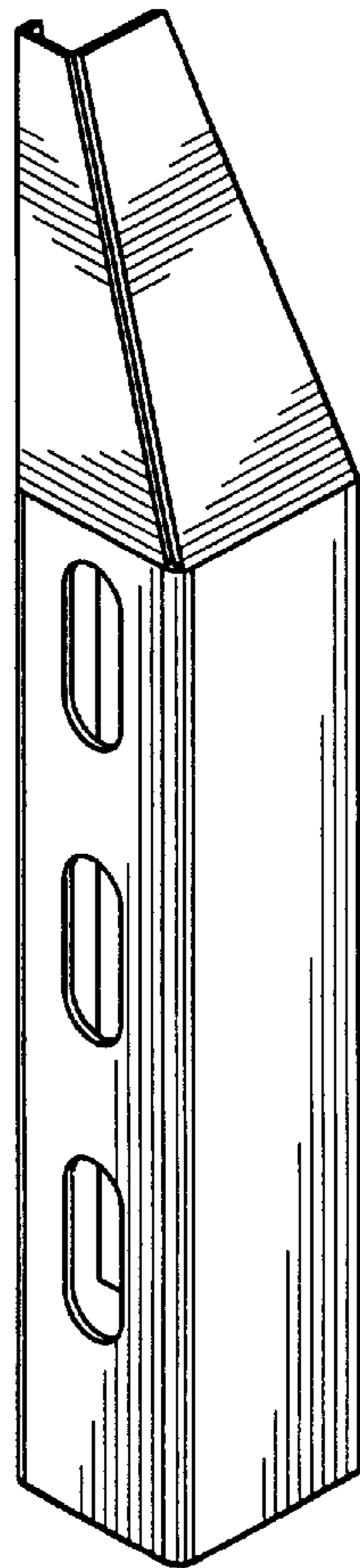

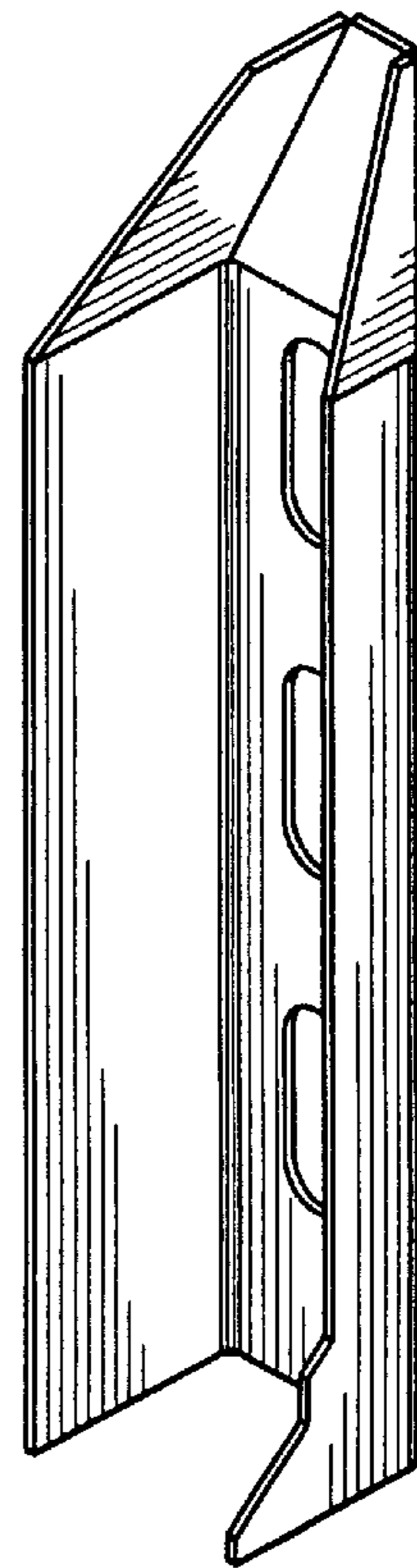

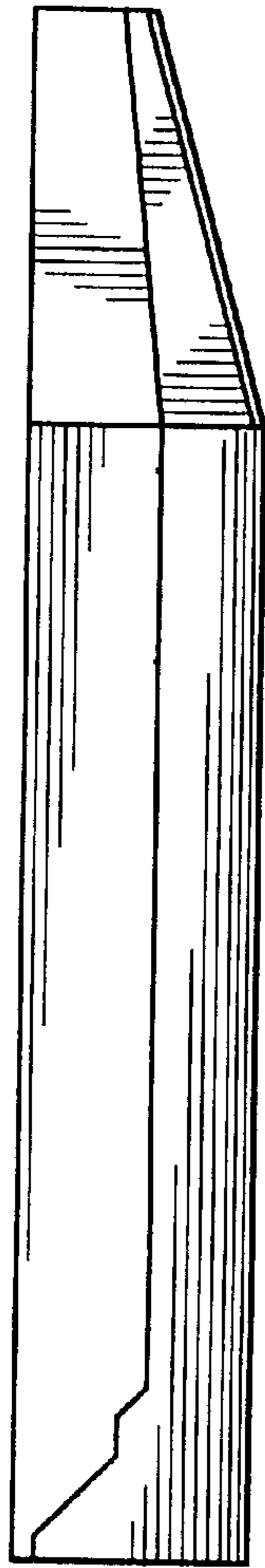

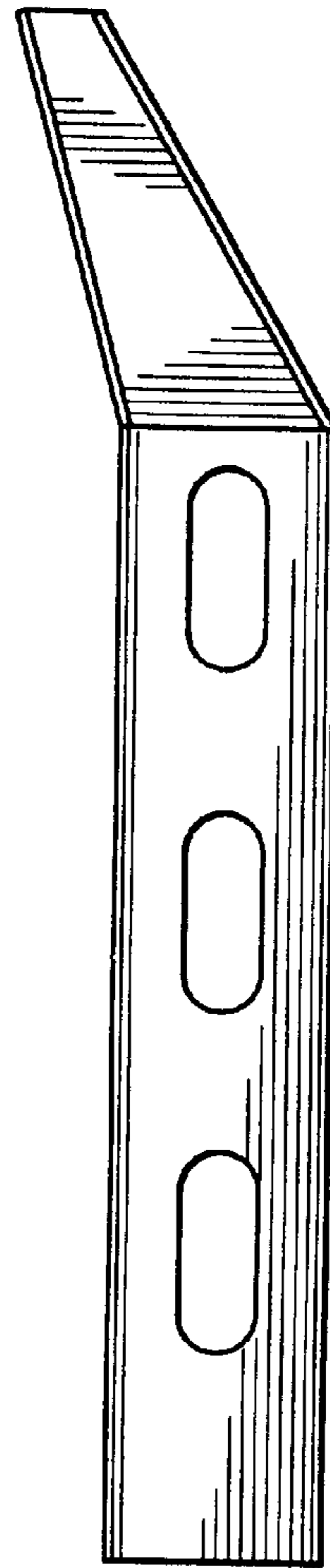

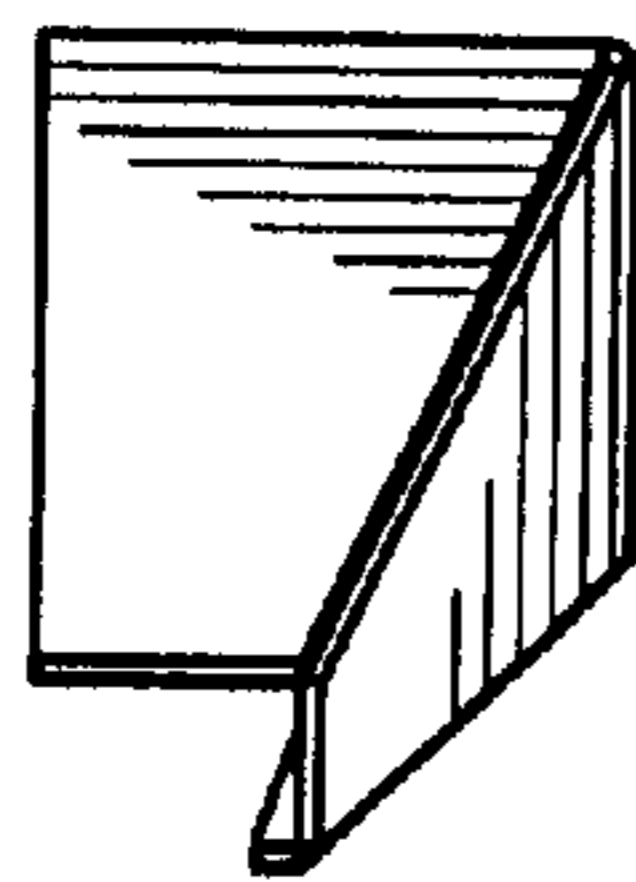

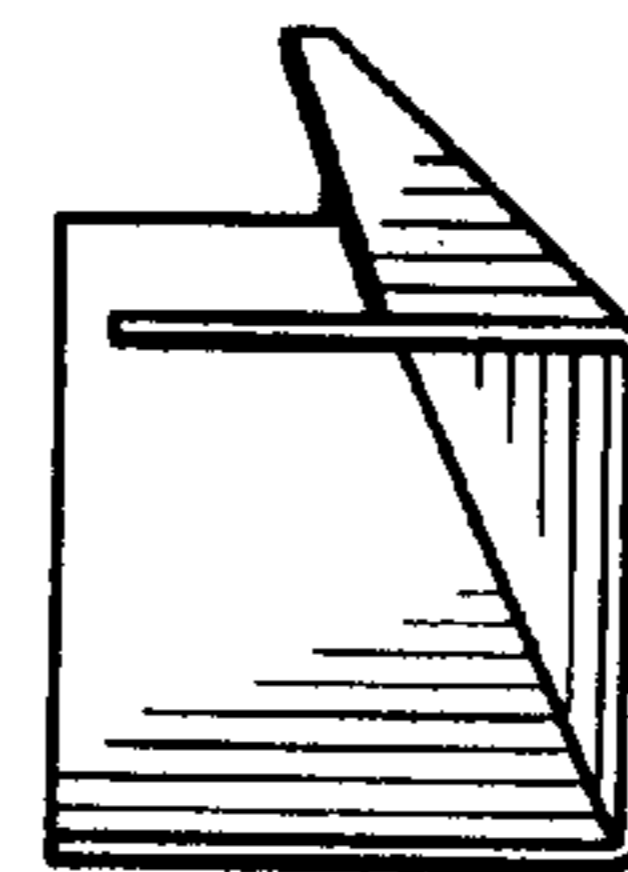
