FIG. 1 illustrates a side view of the palm-held liquid and lotion applicator and cover shown without the cover for clarity of illustration;

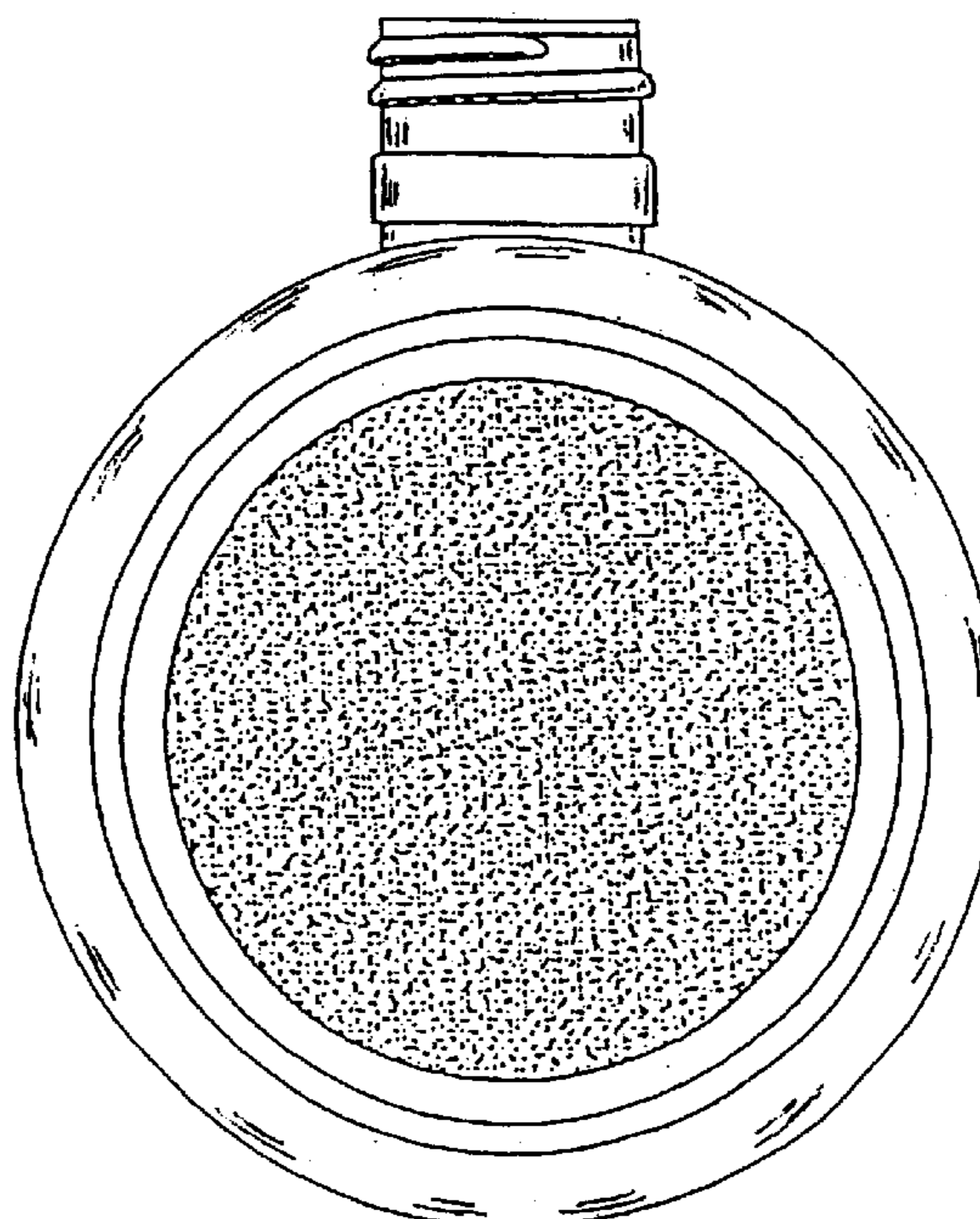
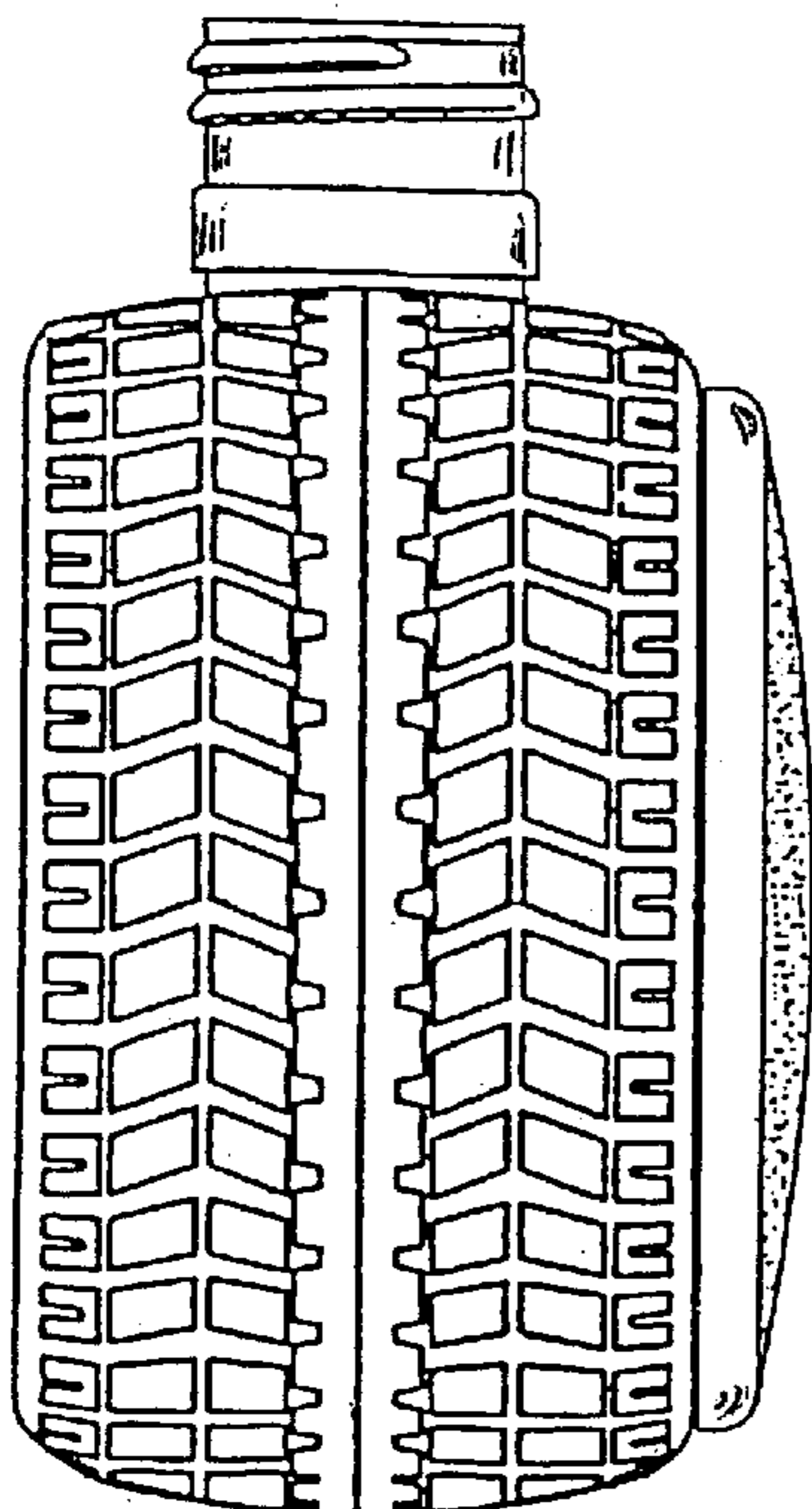
FIG. 2 illustrates a bottom plan view of FIG. 1;

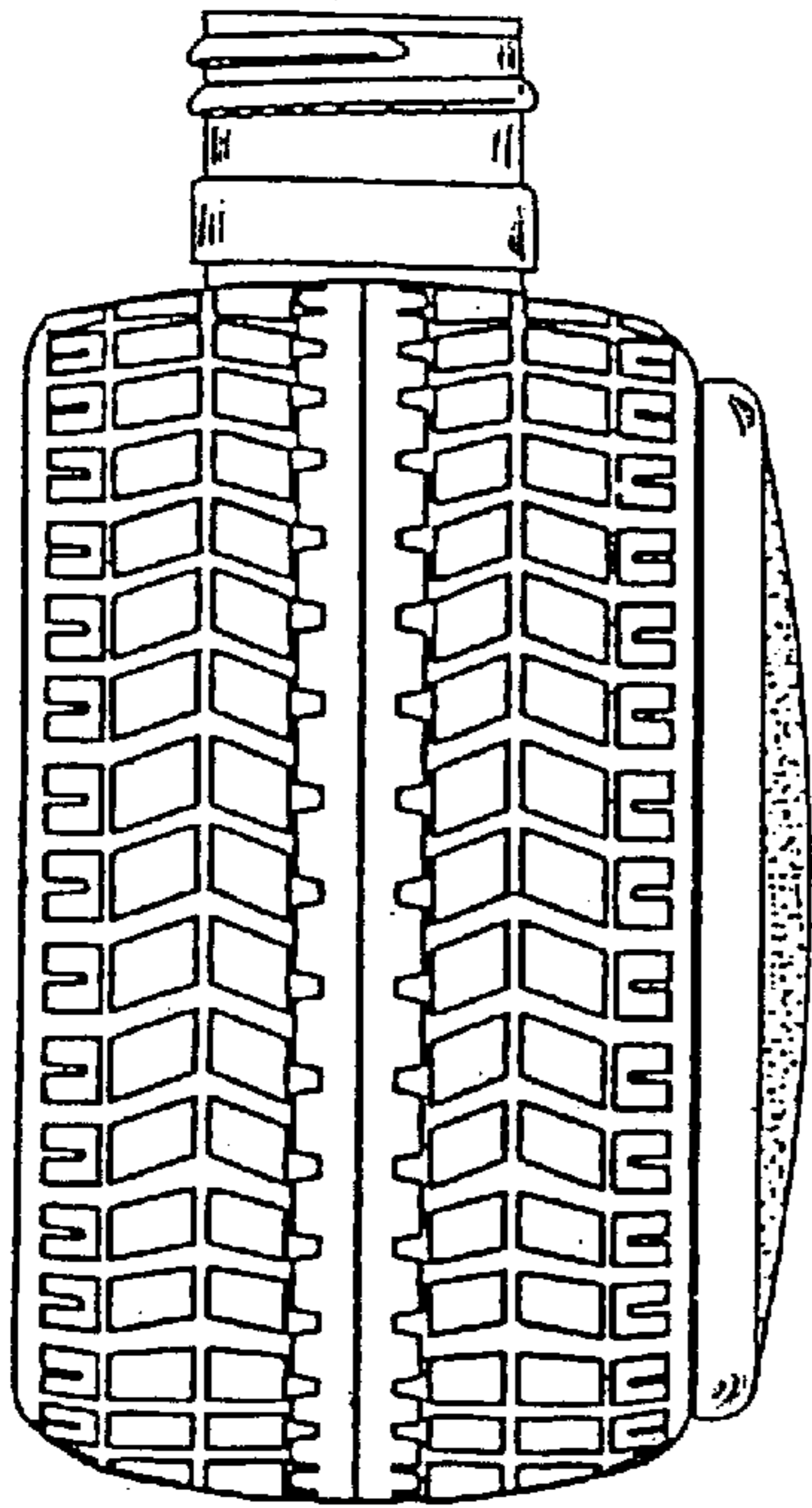

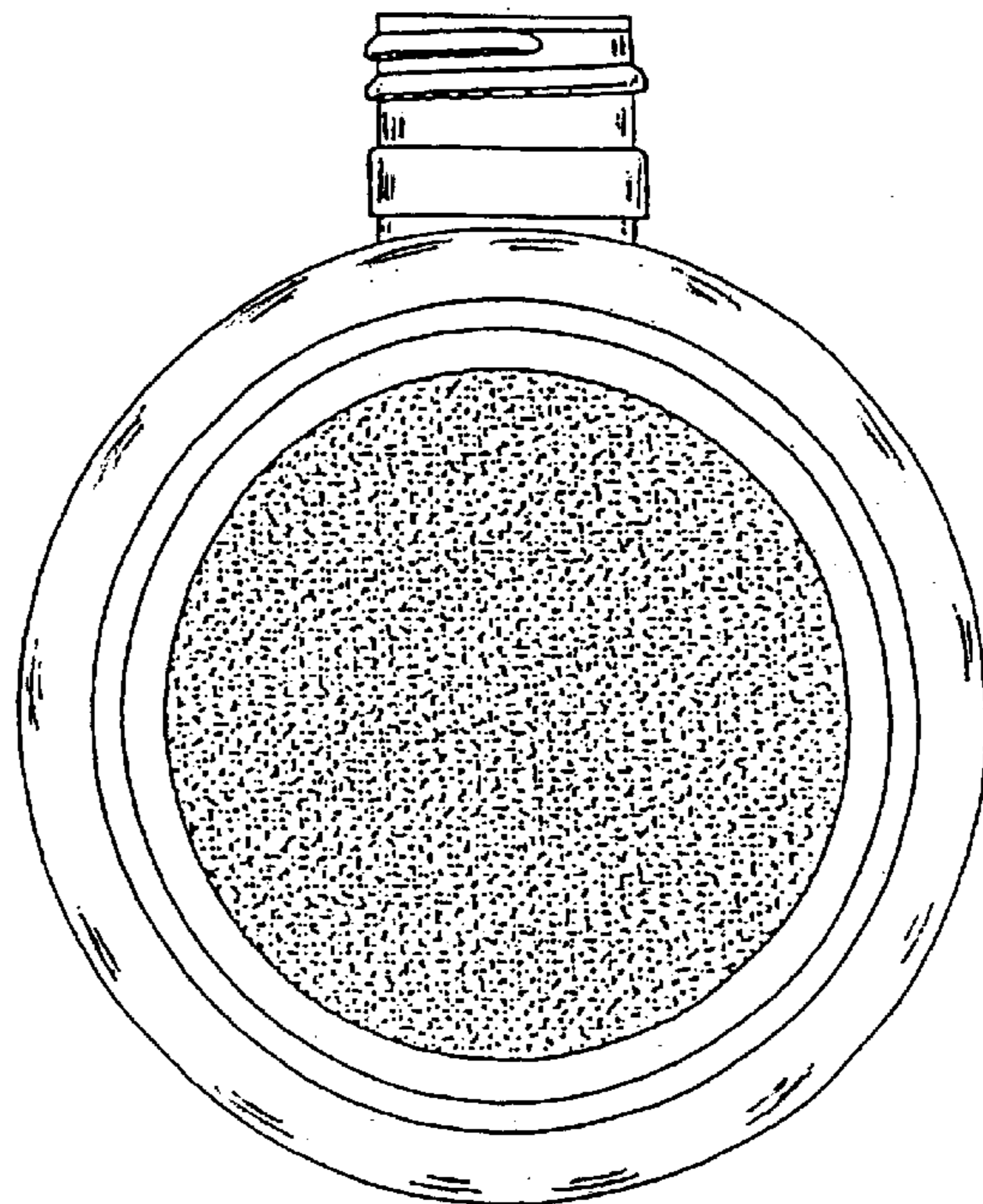

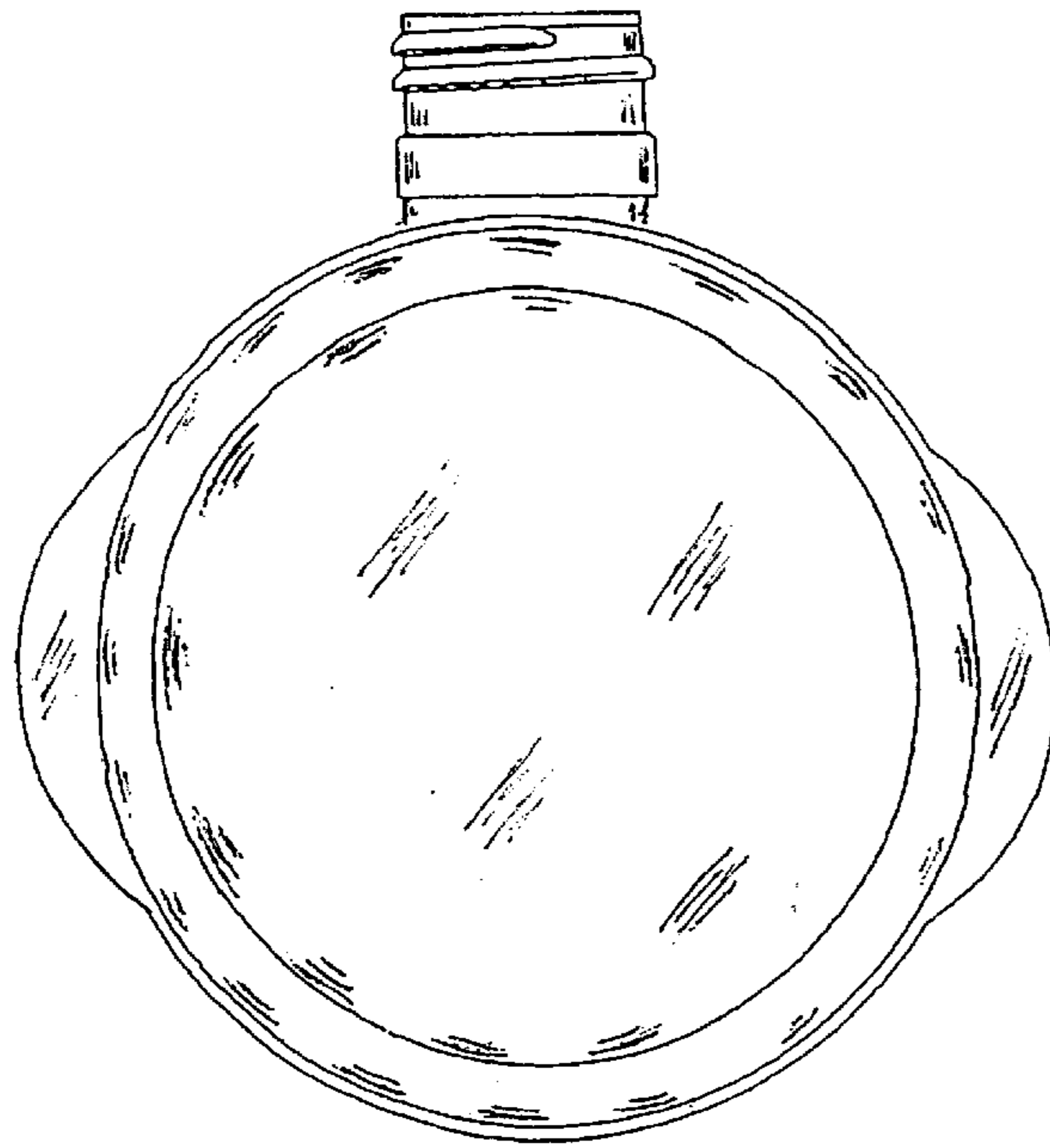

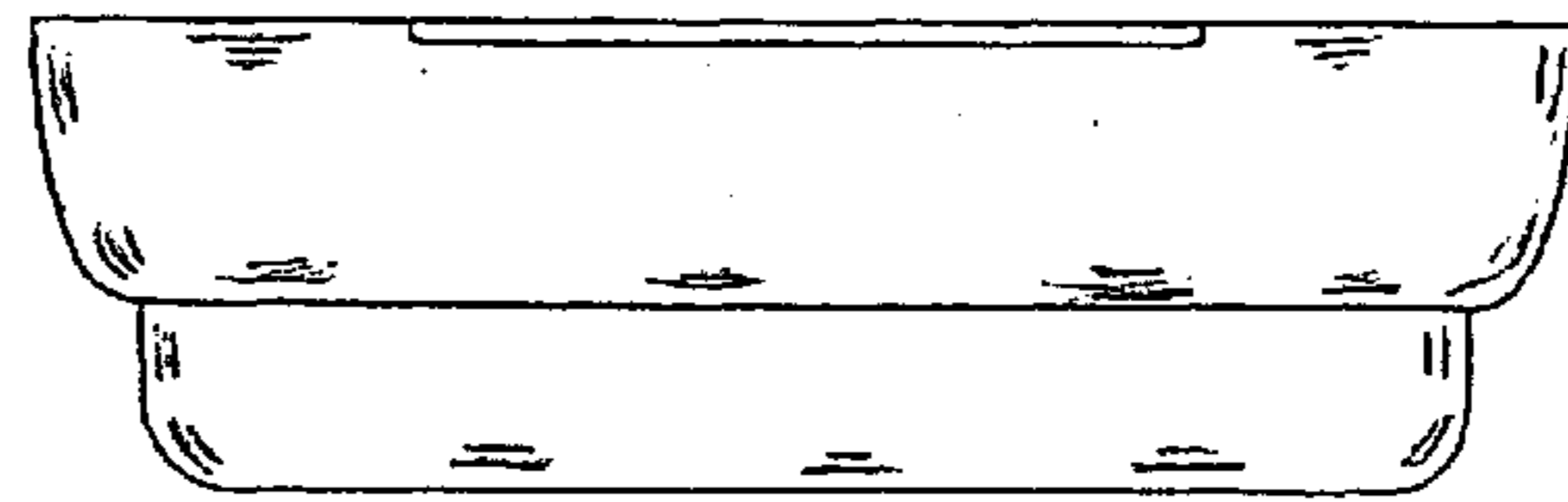

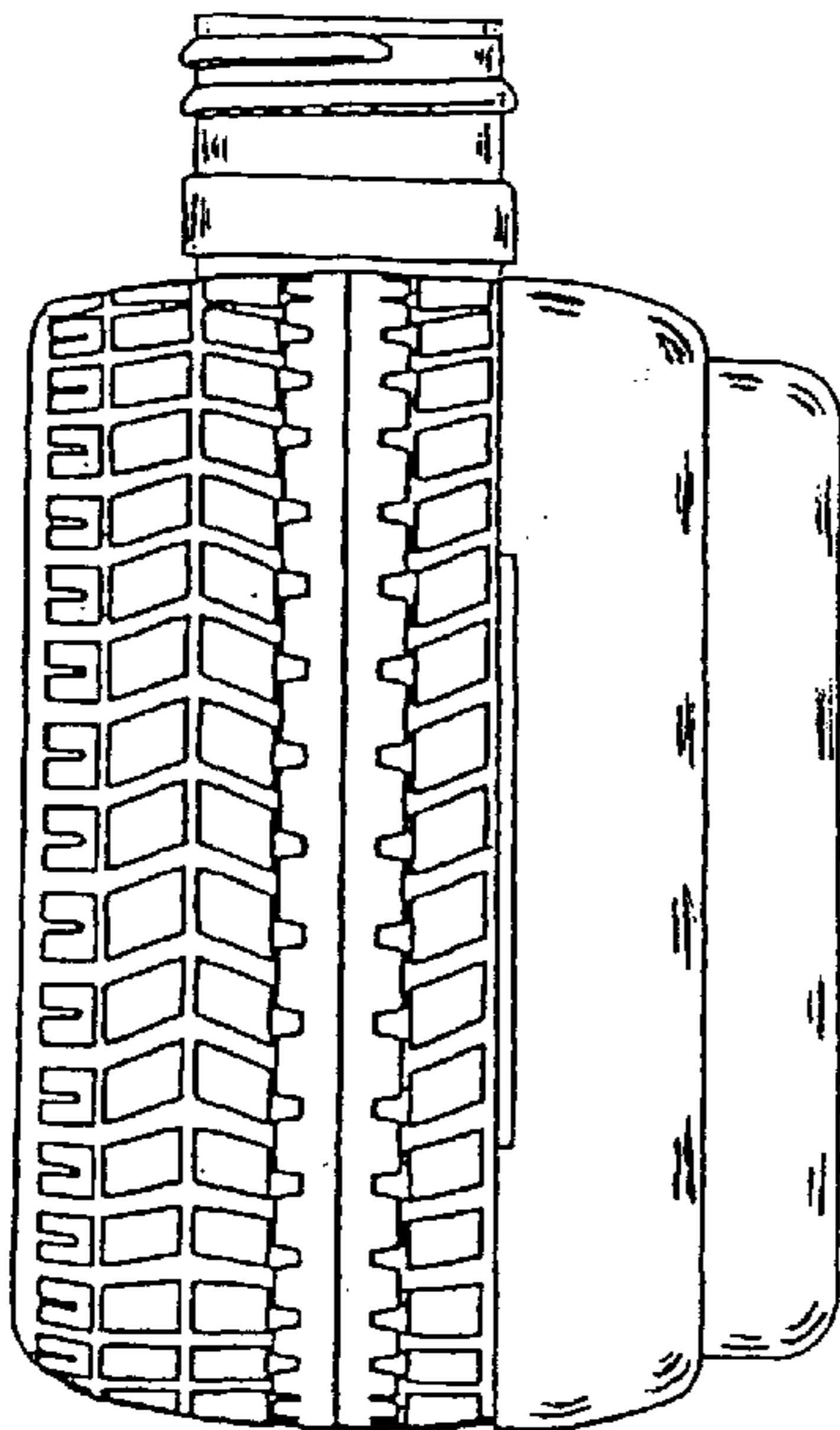
