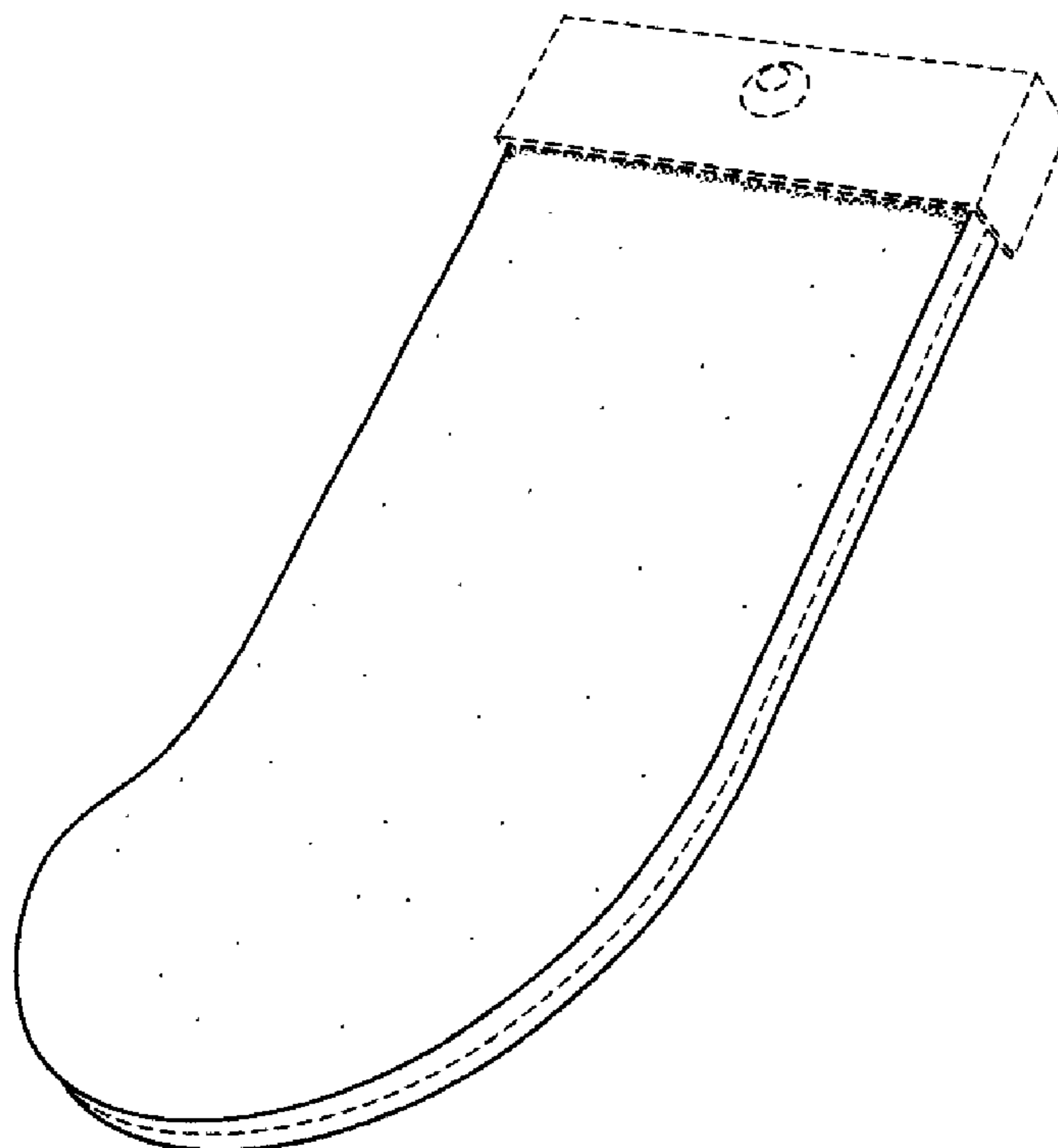
The ornamental design for a golf cleaning accessory, as shown and described.

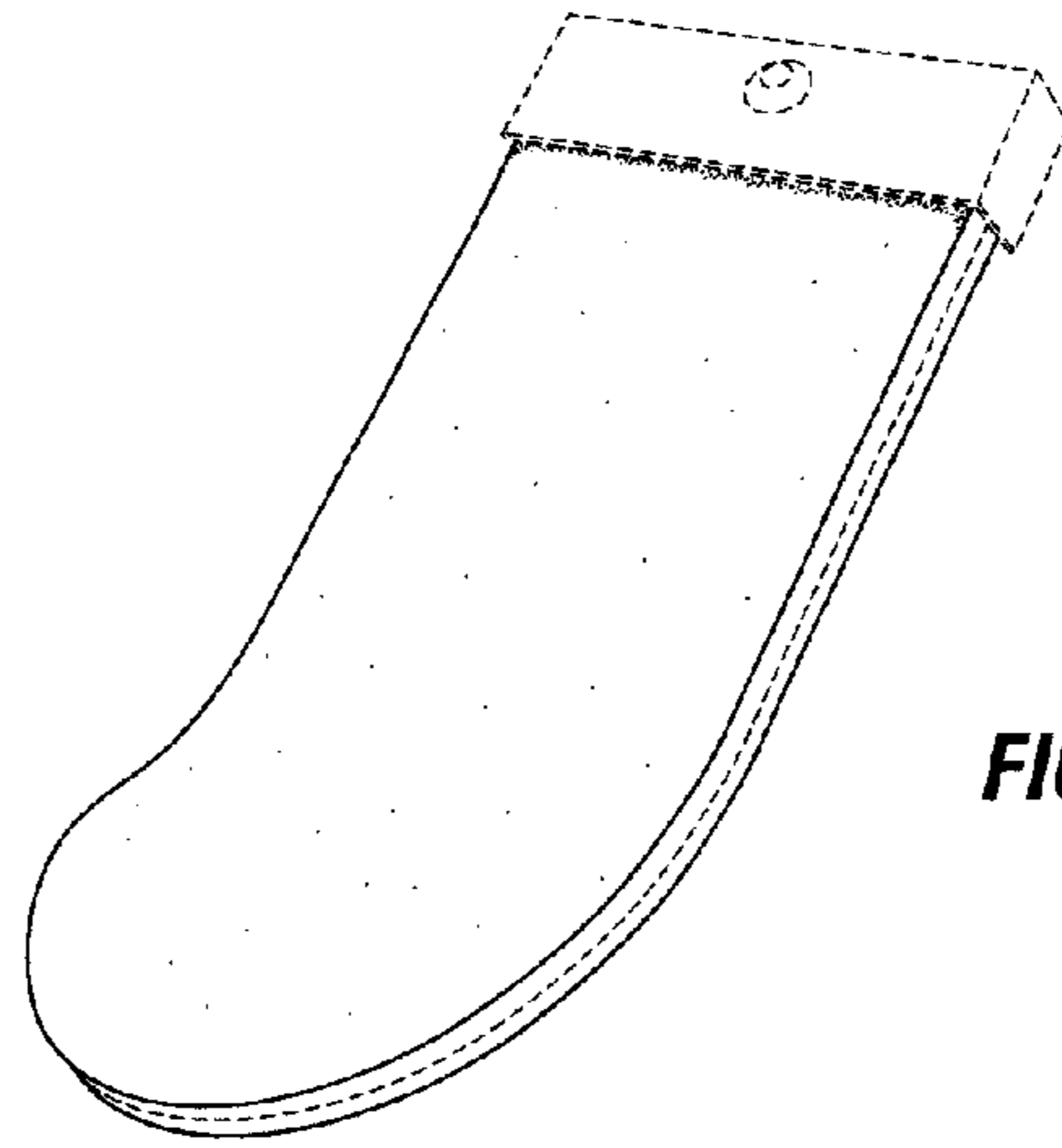
**DESCRIPTION**

 FIG. 7 is an opposite end view from FIG. 6 of the golf cleaning accessory.

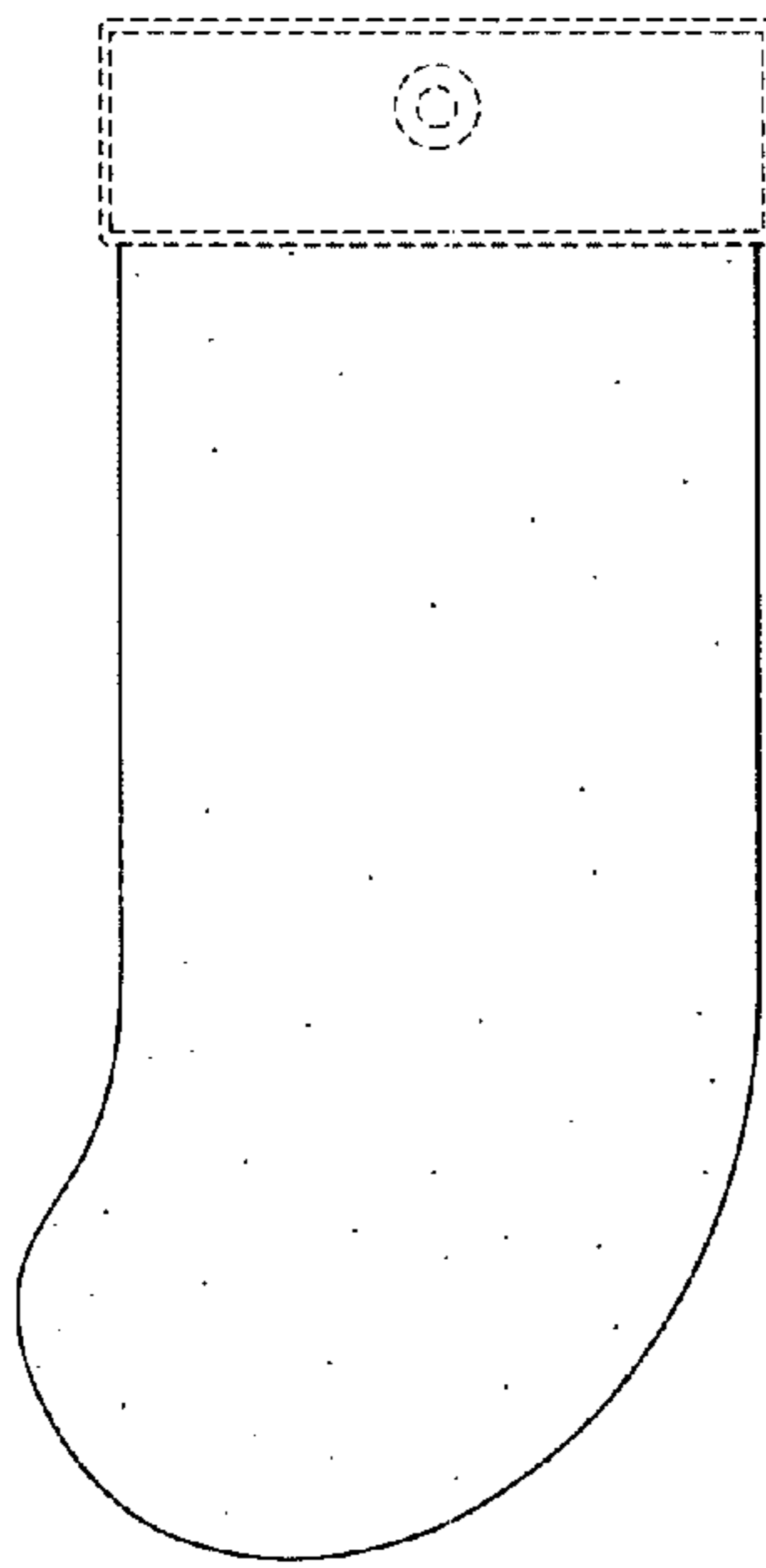

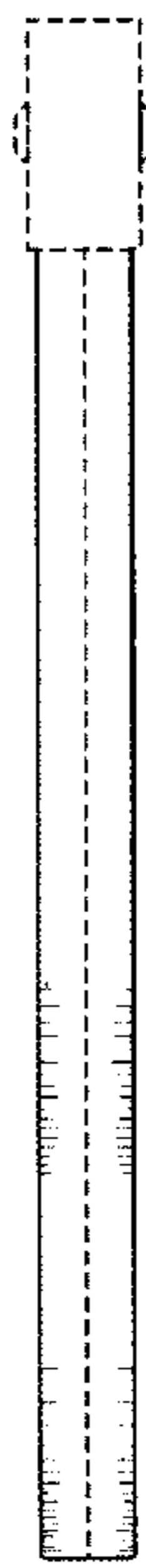




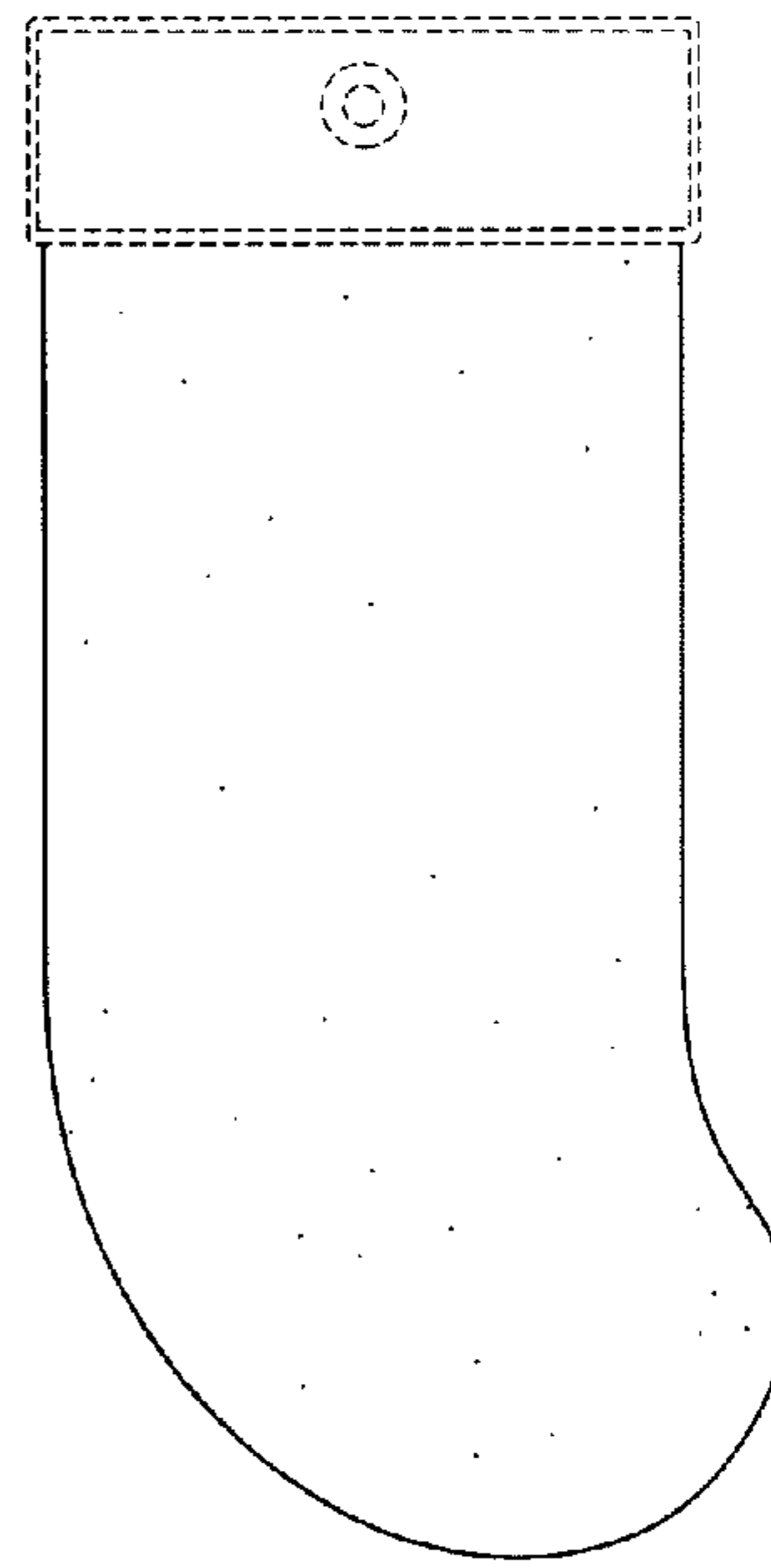

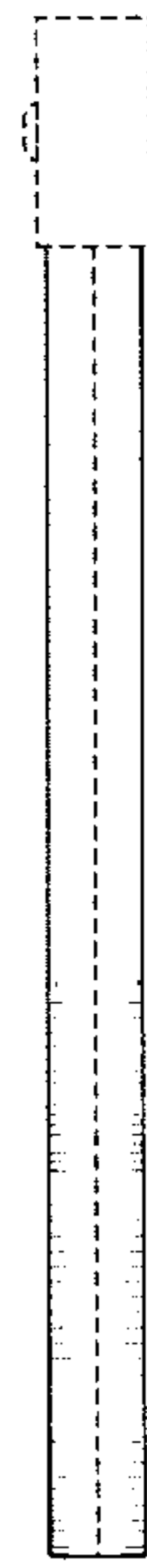

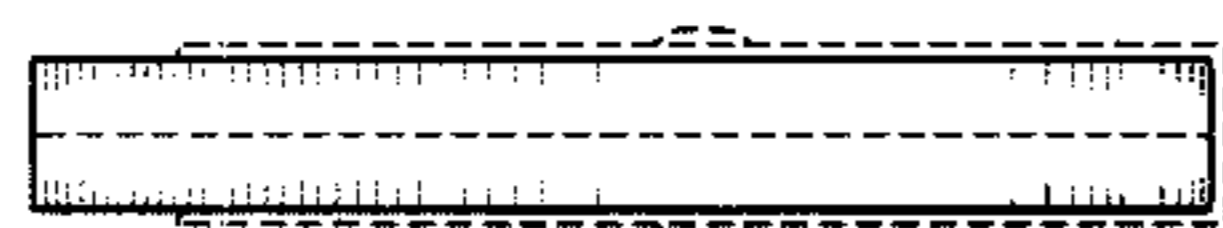

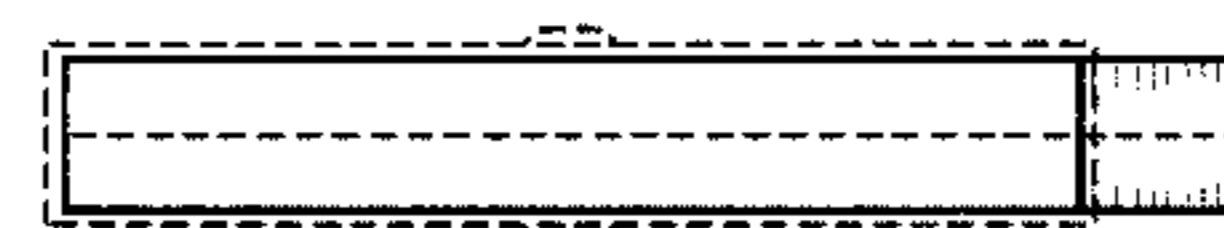
