(57) **CLAIM**

I claim the ornamental design for a golf cart, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a golf cart showing my new design;  
FIG. 2 is a right side view of the same, the left side view  
being symmetrical to the right side view;  
FIG. 3 is a top plan view of the same;  
FIG. 4 is a bottom view of the same;  
FIG. 5 is a rear view of the same; and,  
FIG. 6 is a perspective view of the same, wherein the broken  
line showing of environmental structure is for illustrative  
purposes only and forms no part of the claimed design.

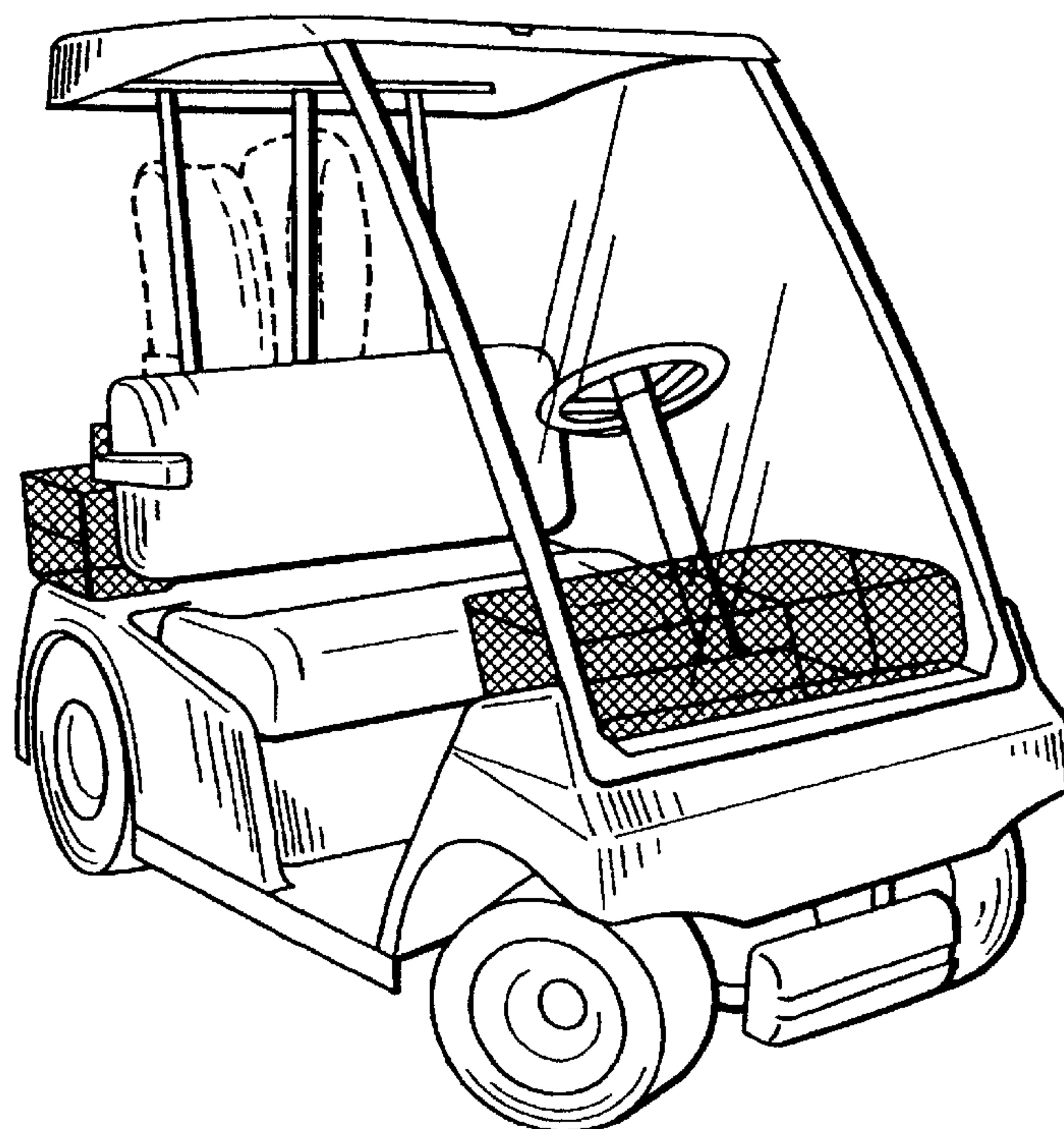

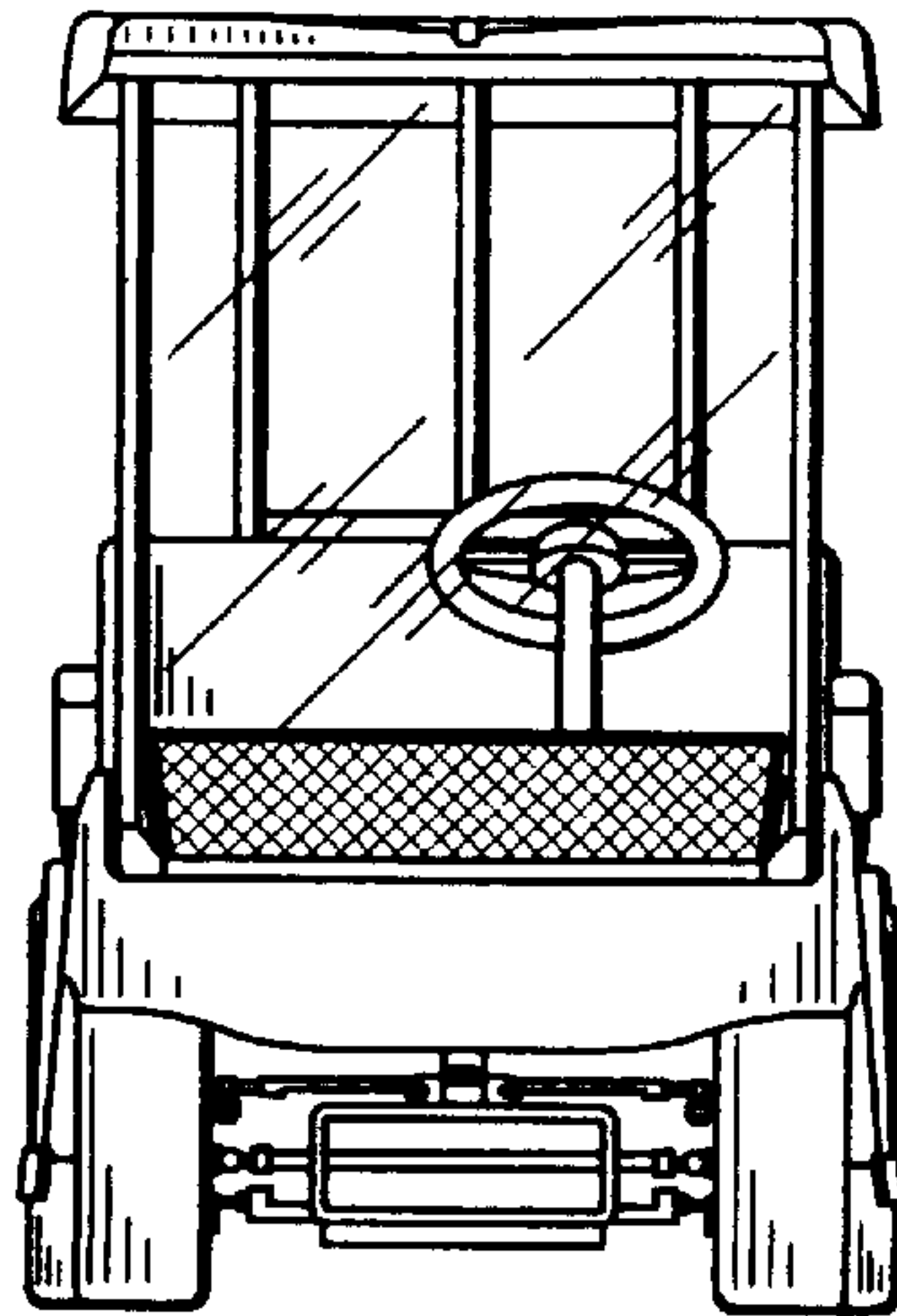

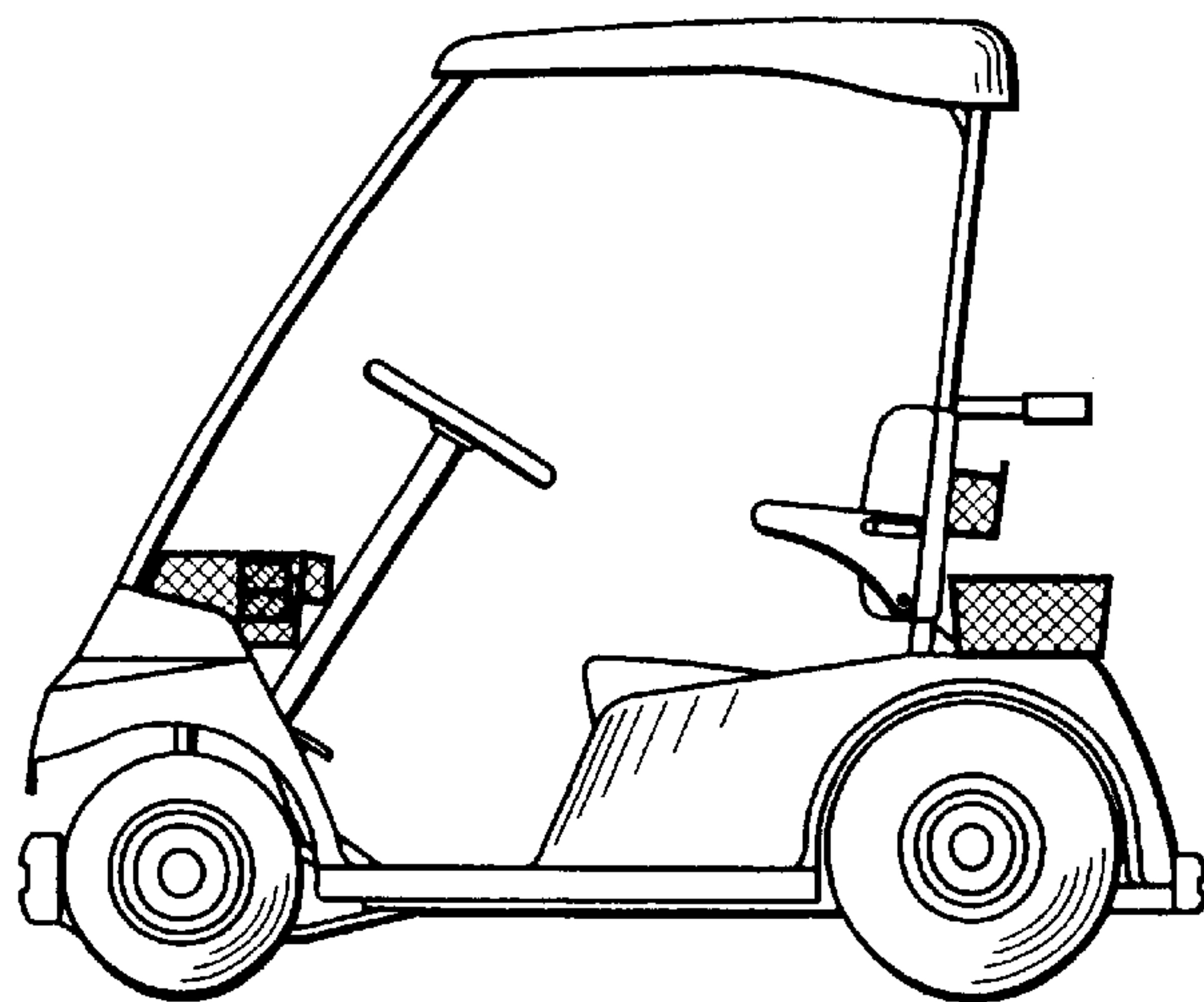

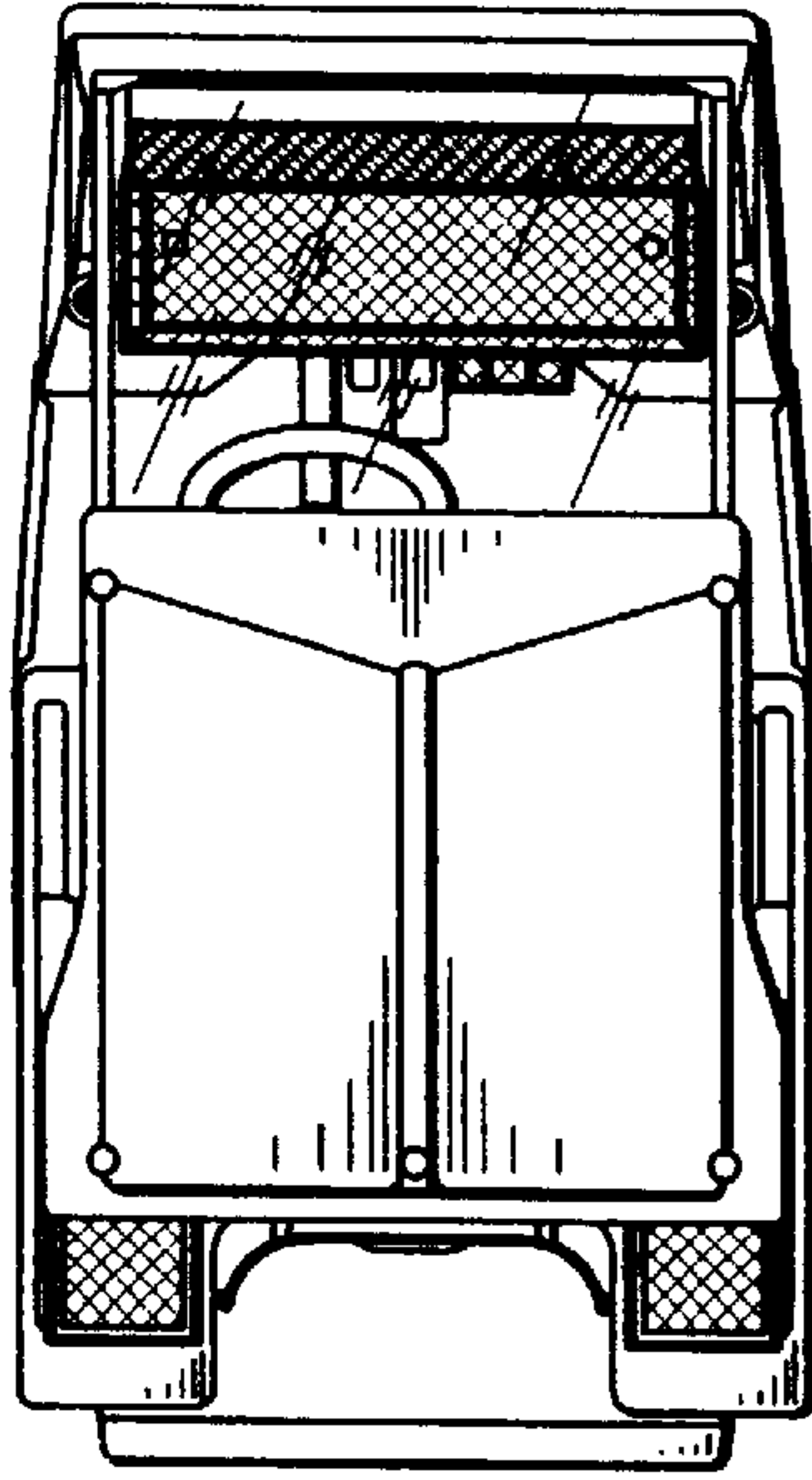

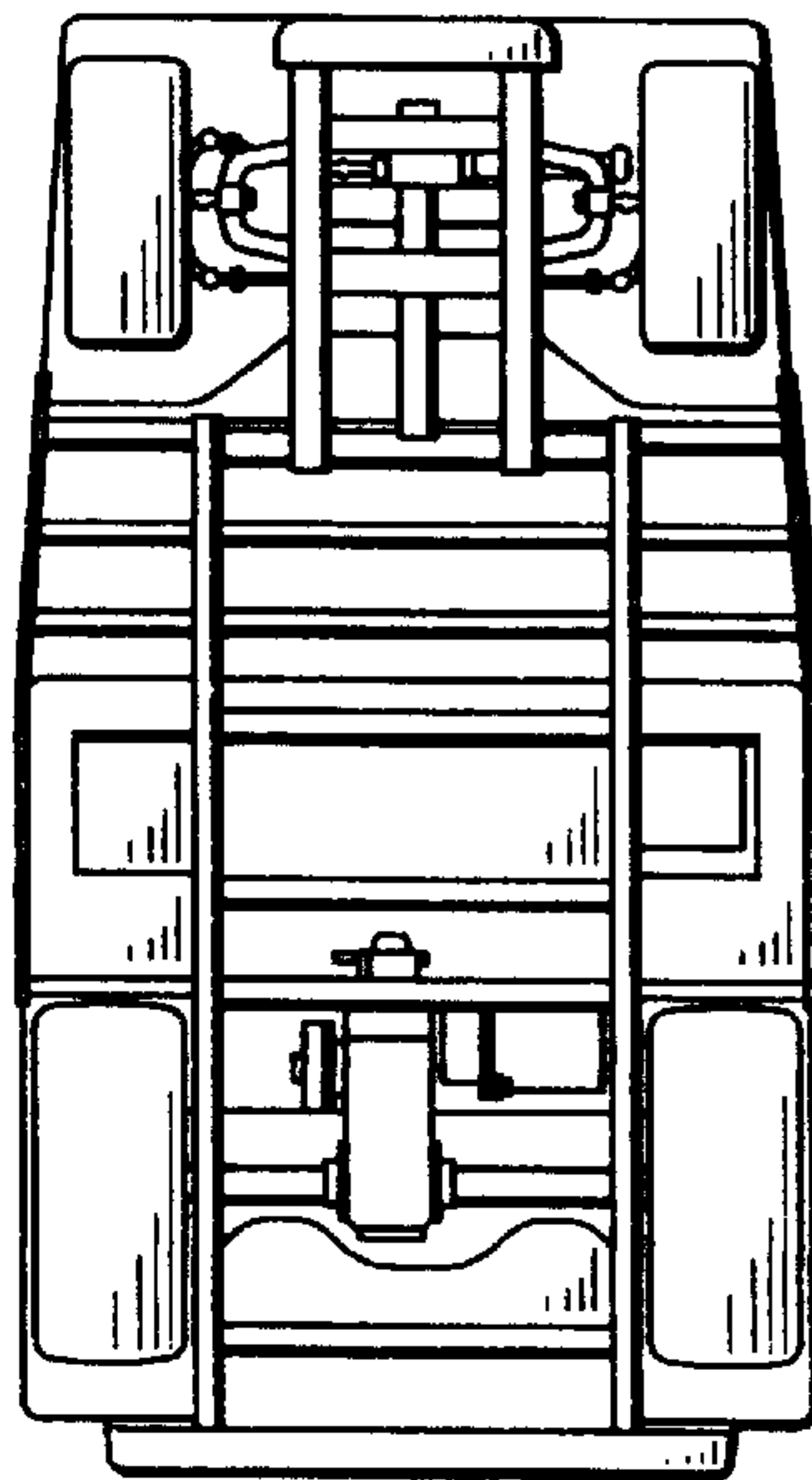

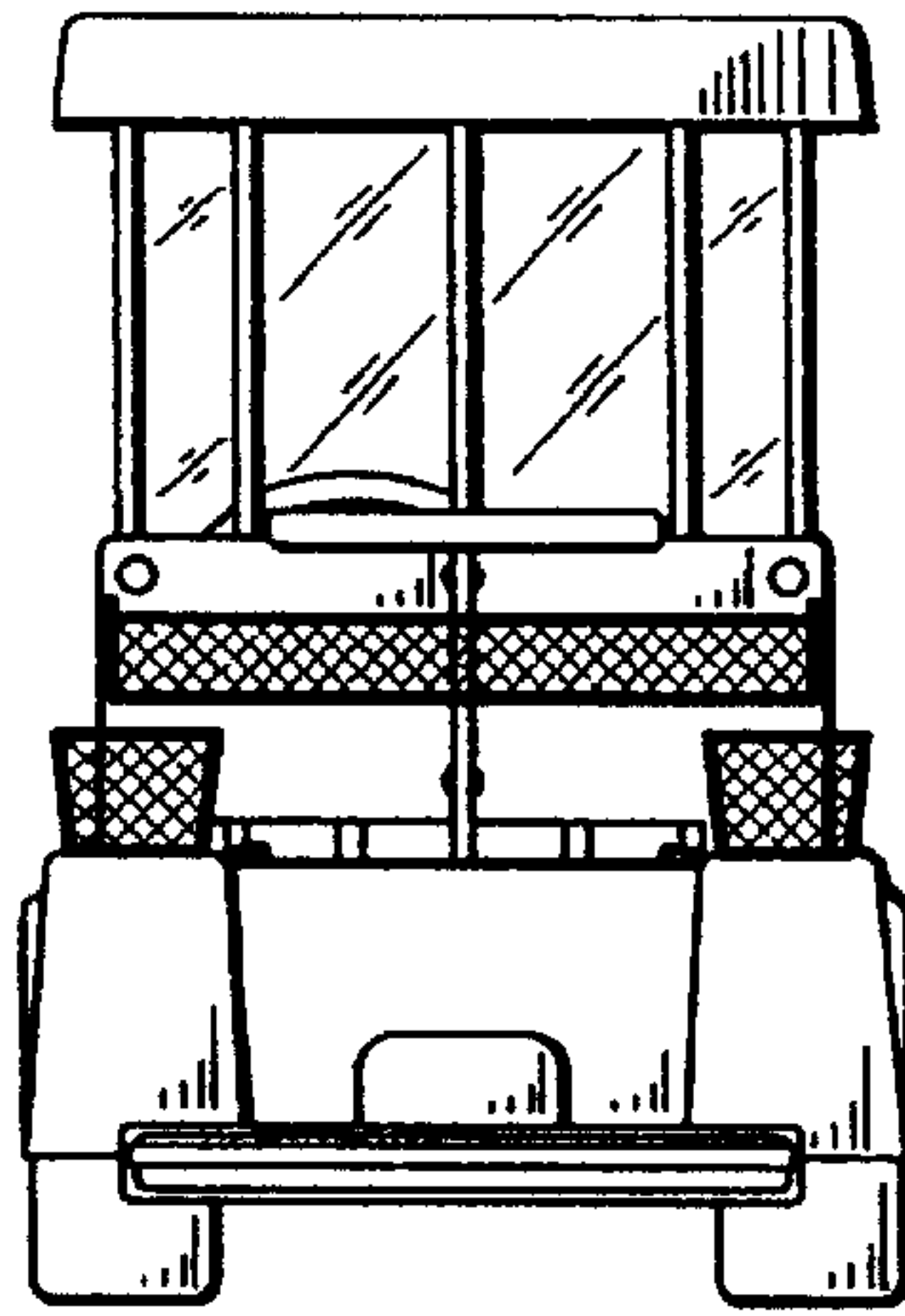
