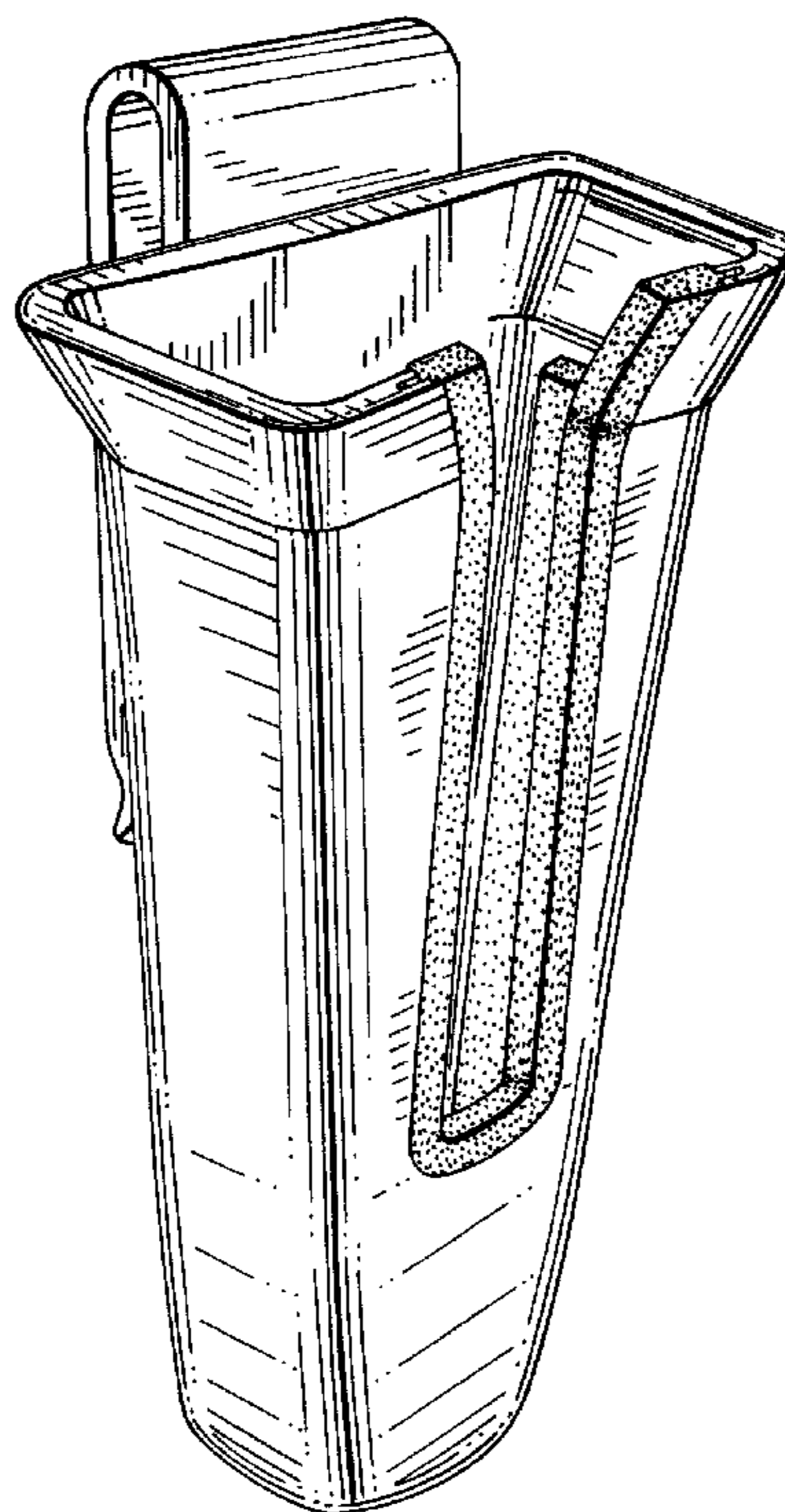
FIG. 1 is a top, front and left side perspective view;

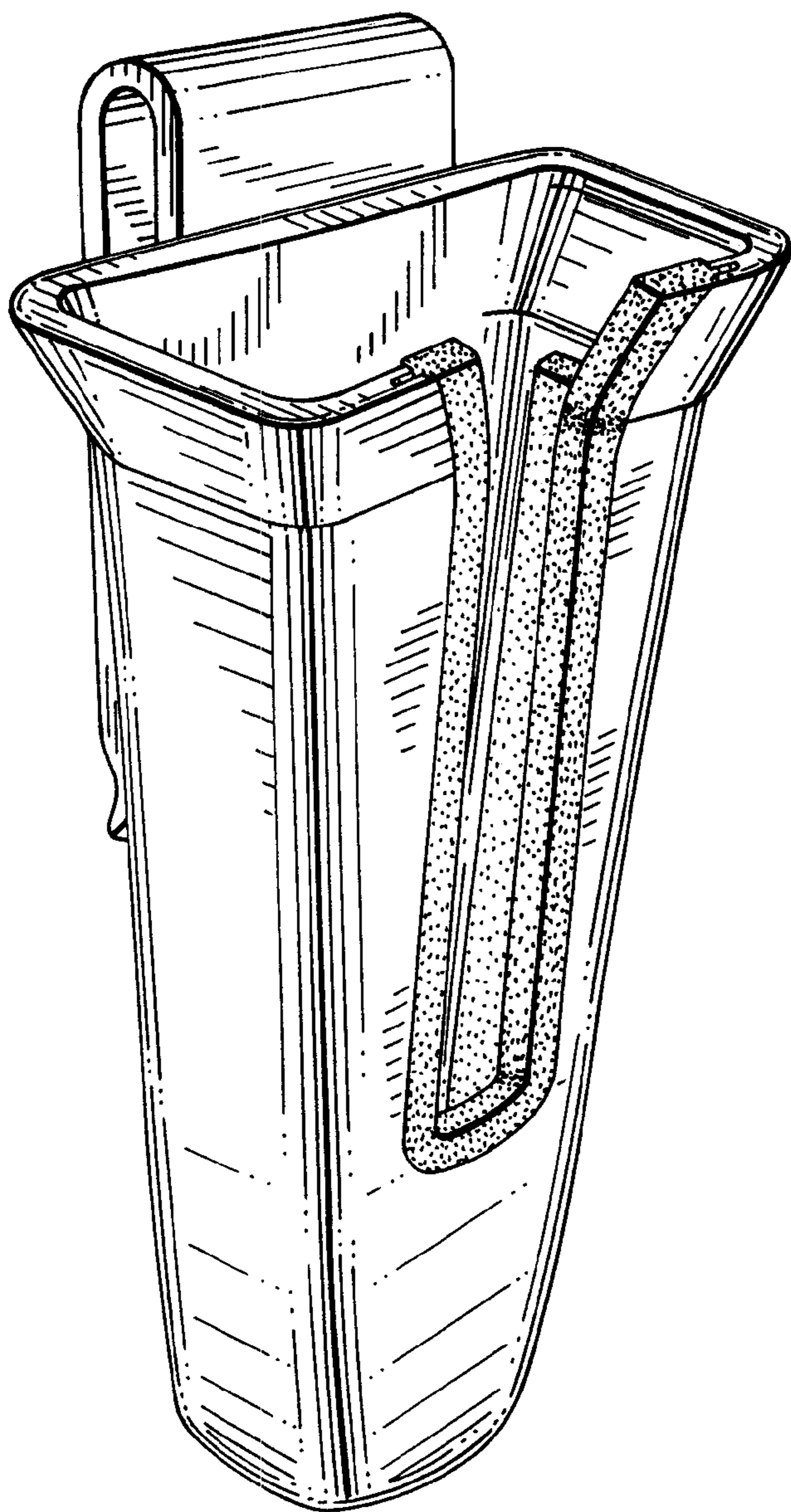

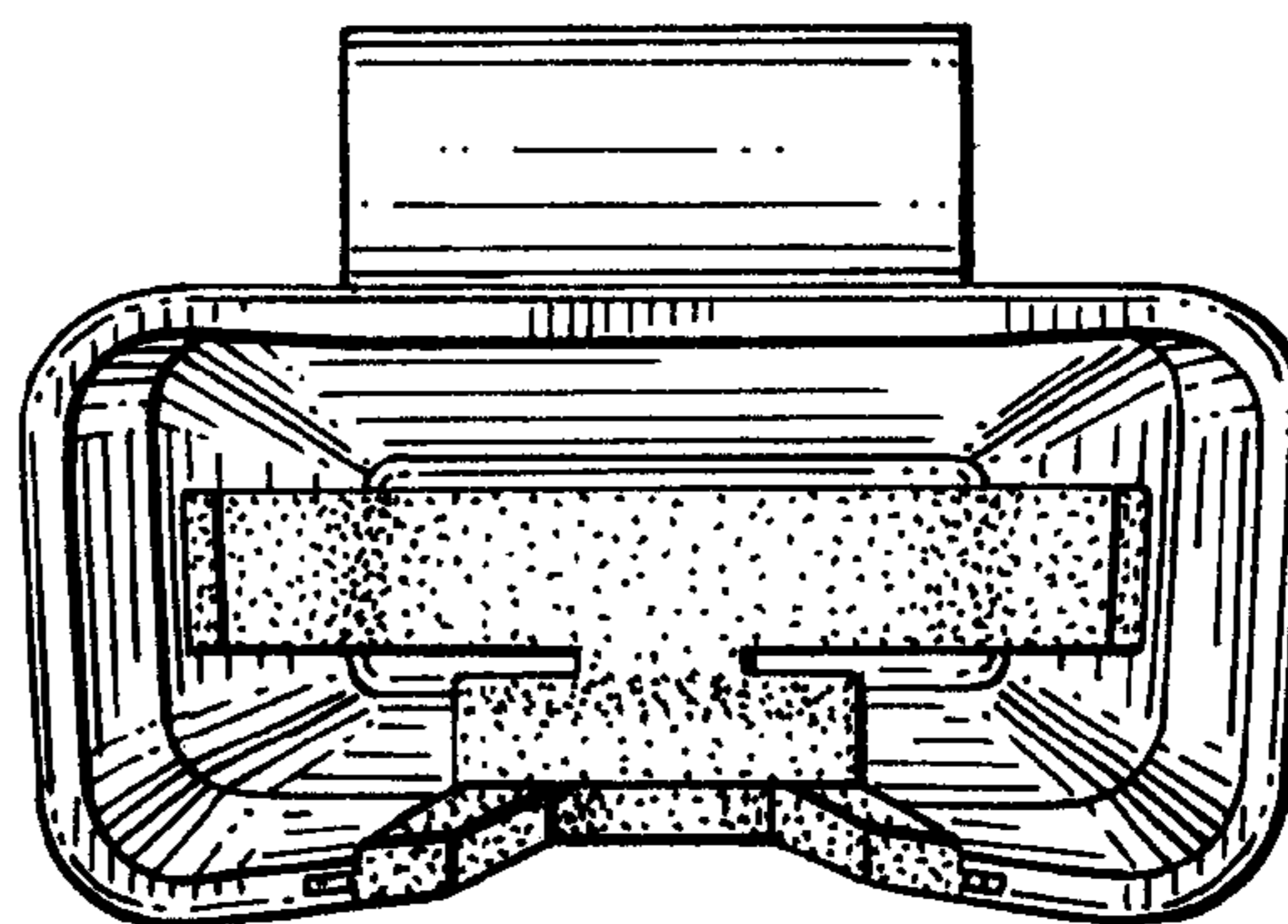

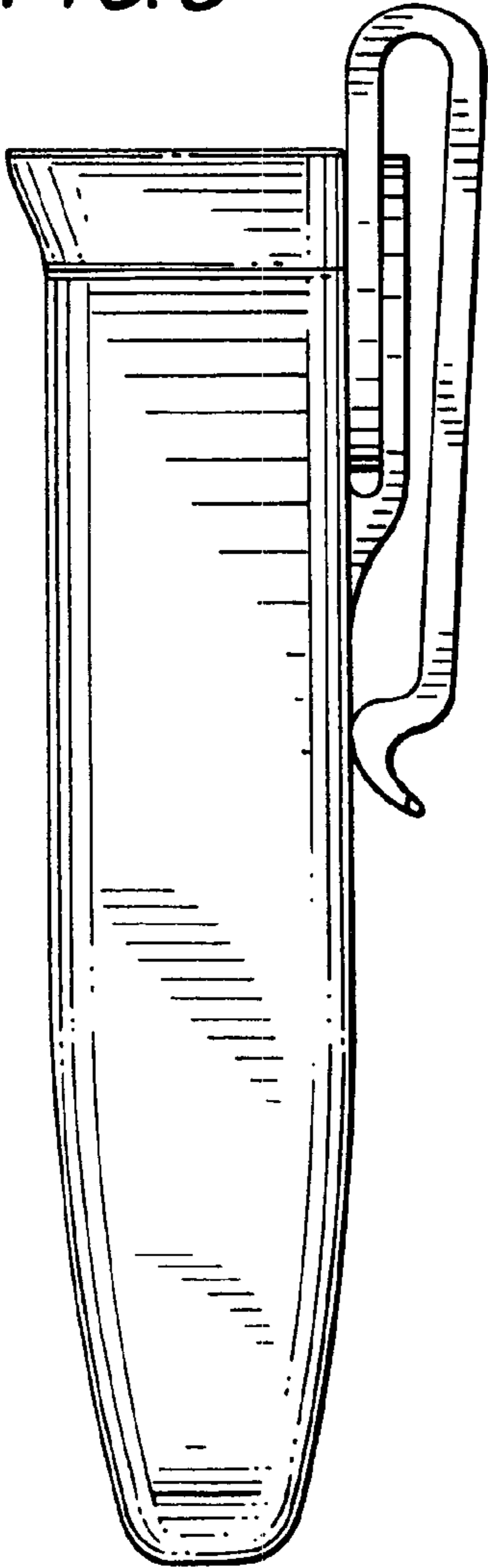

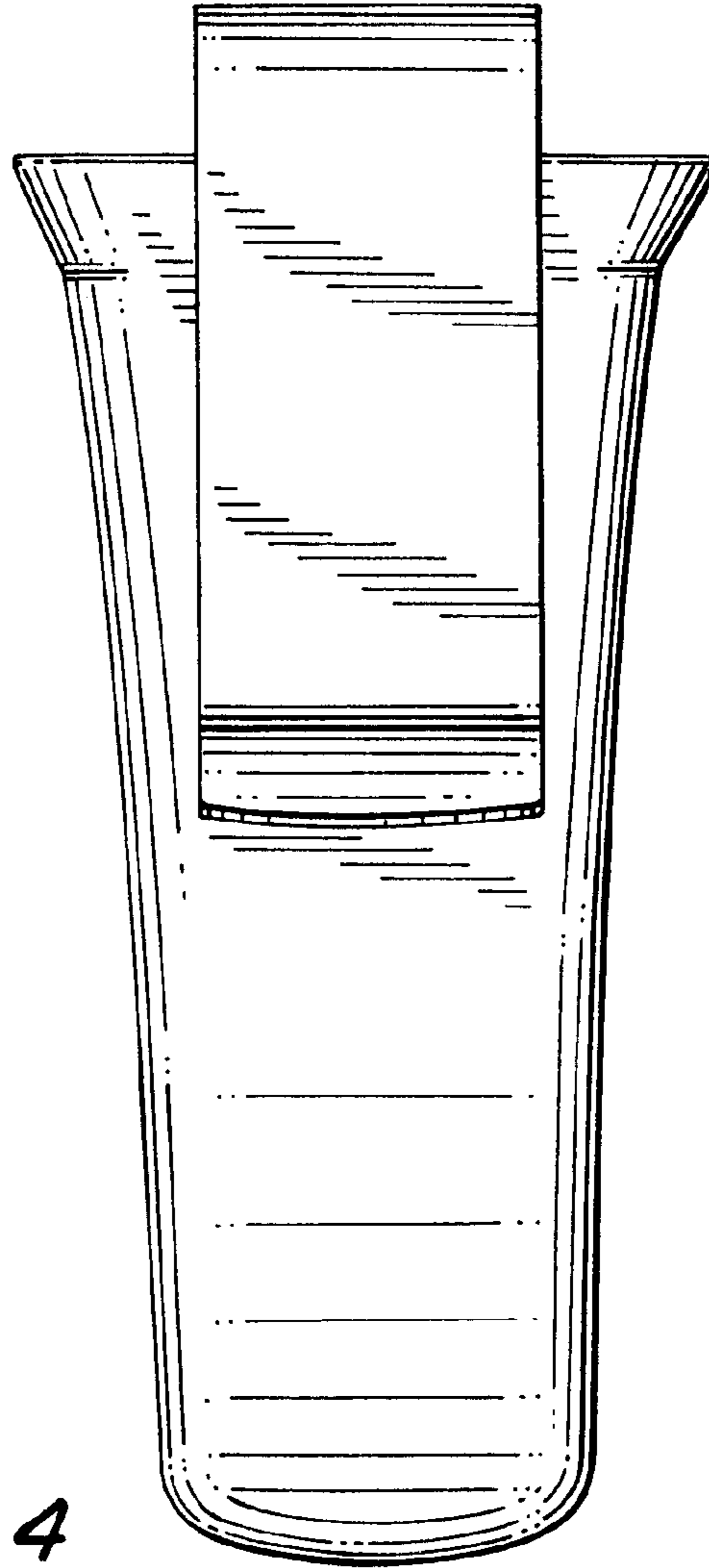

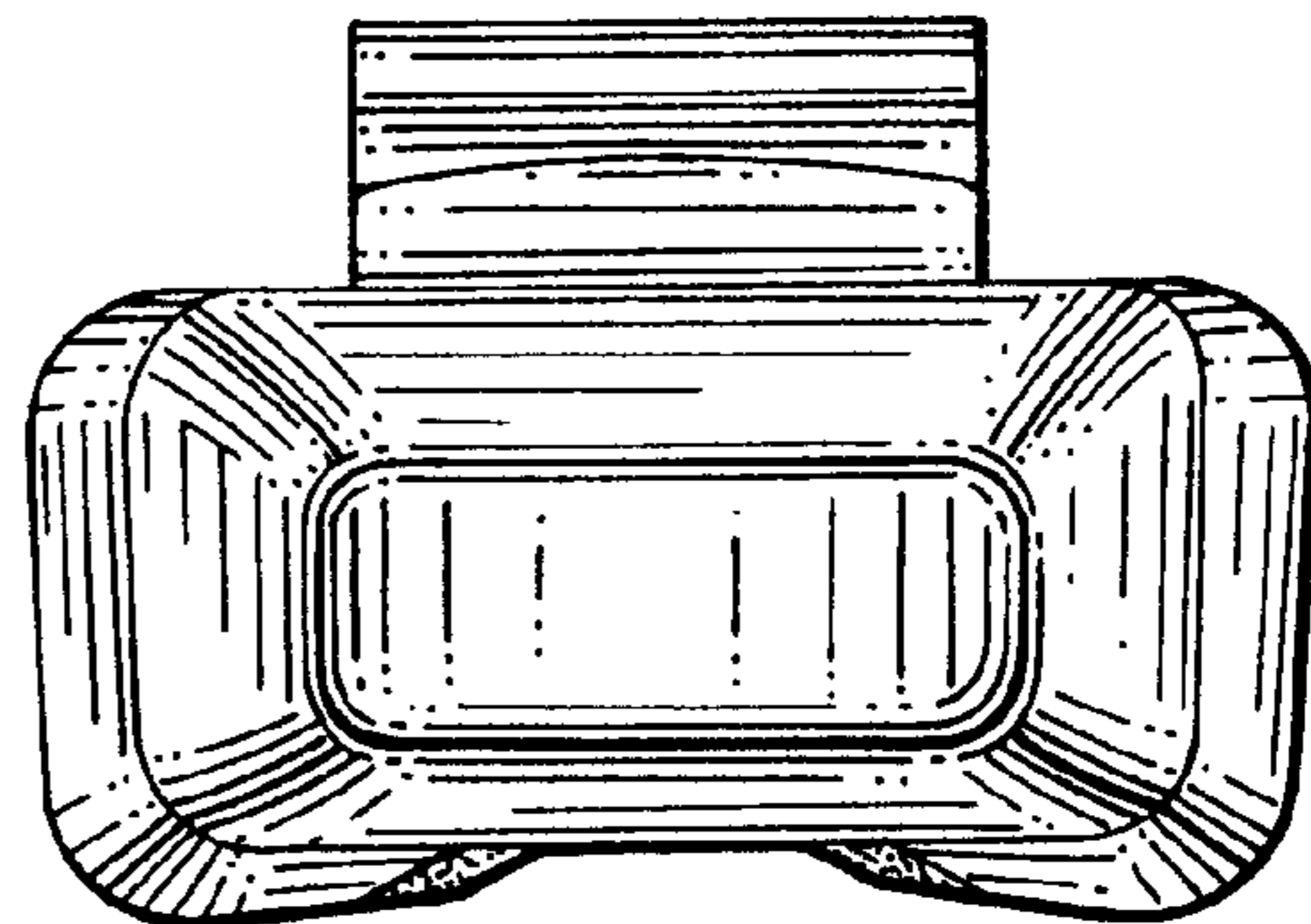

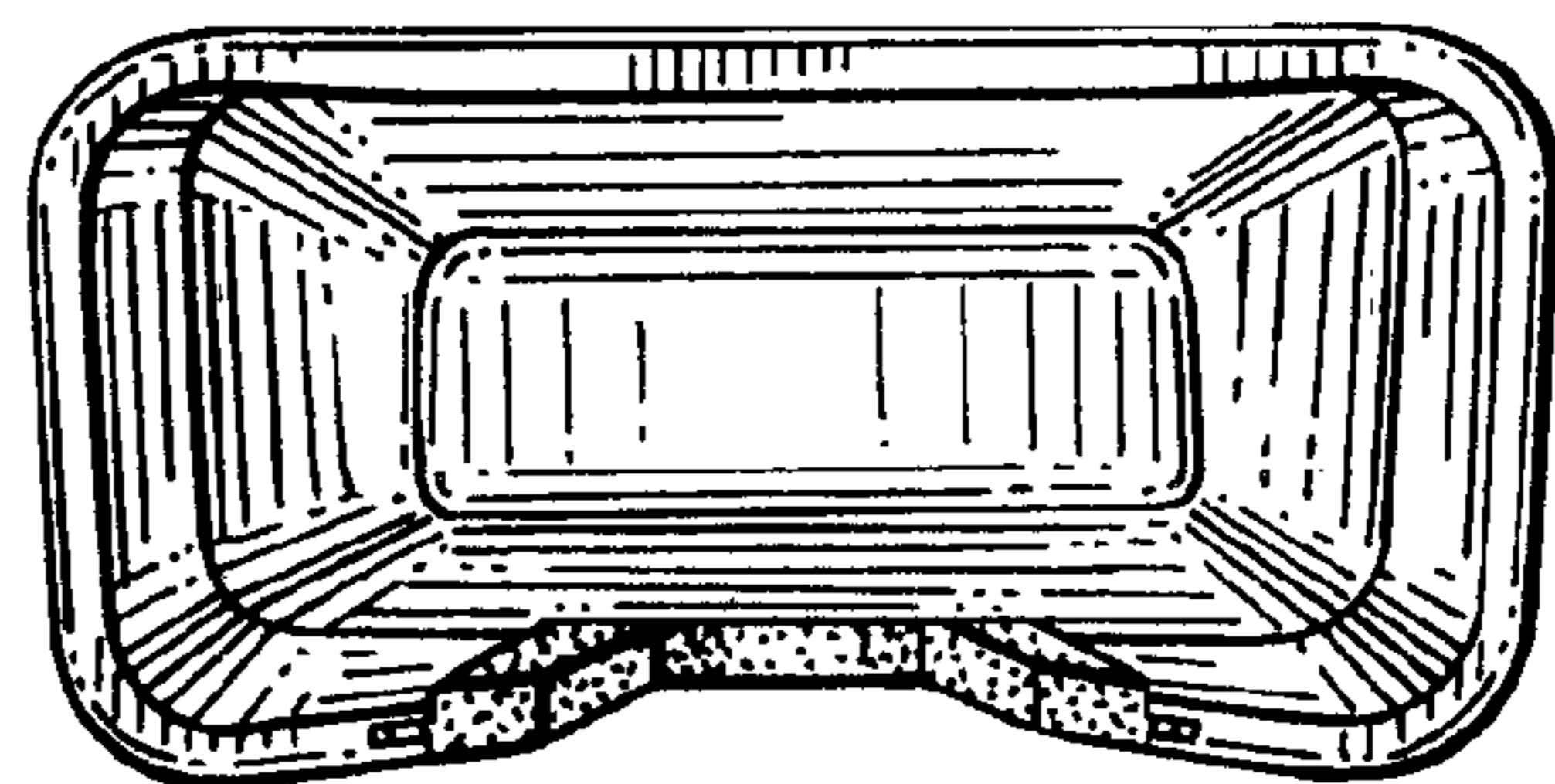
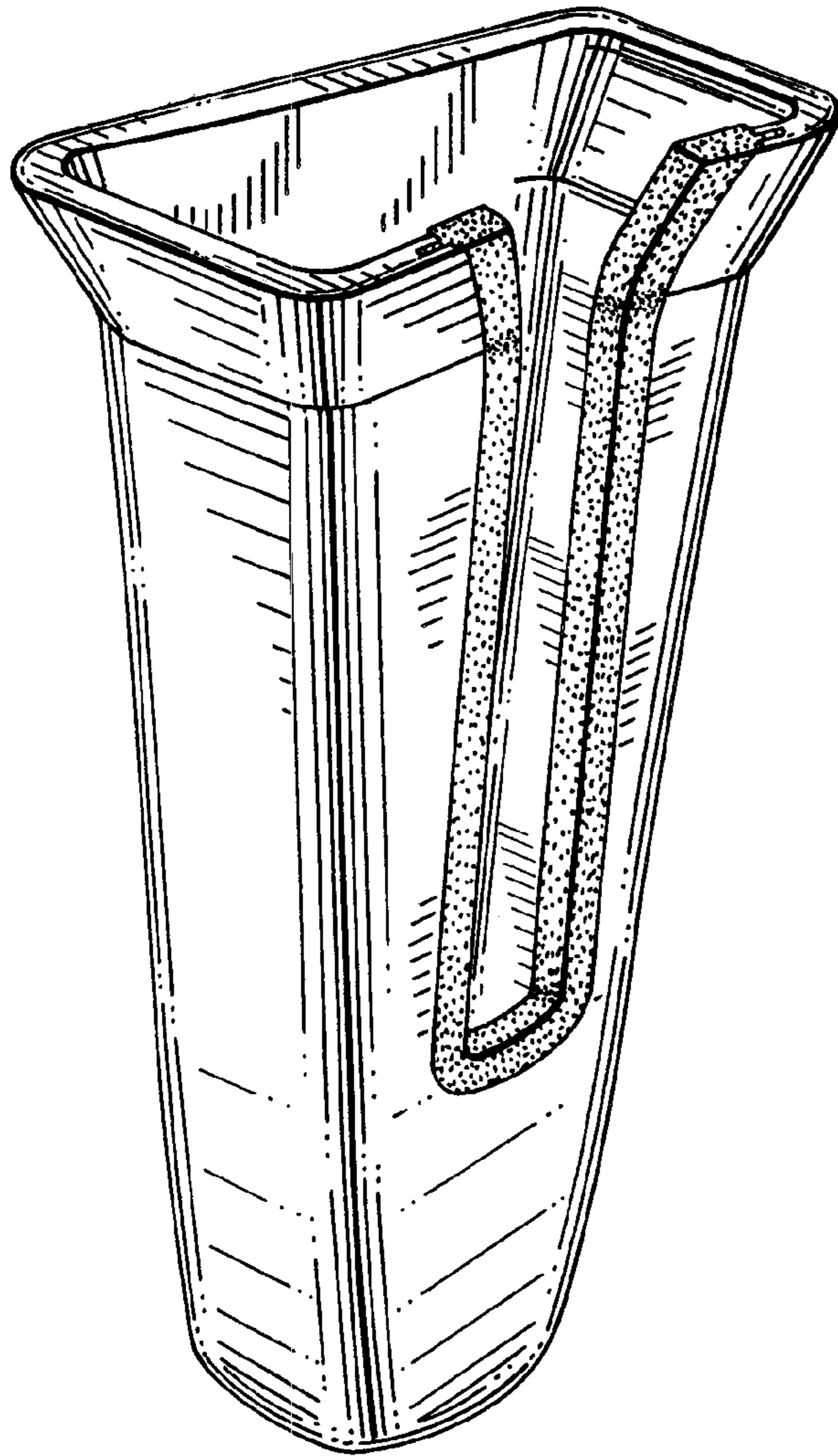

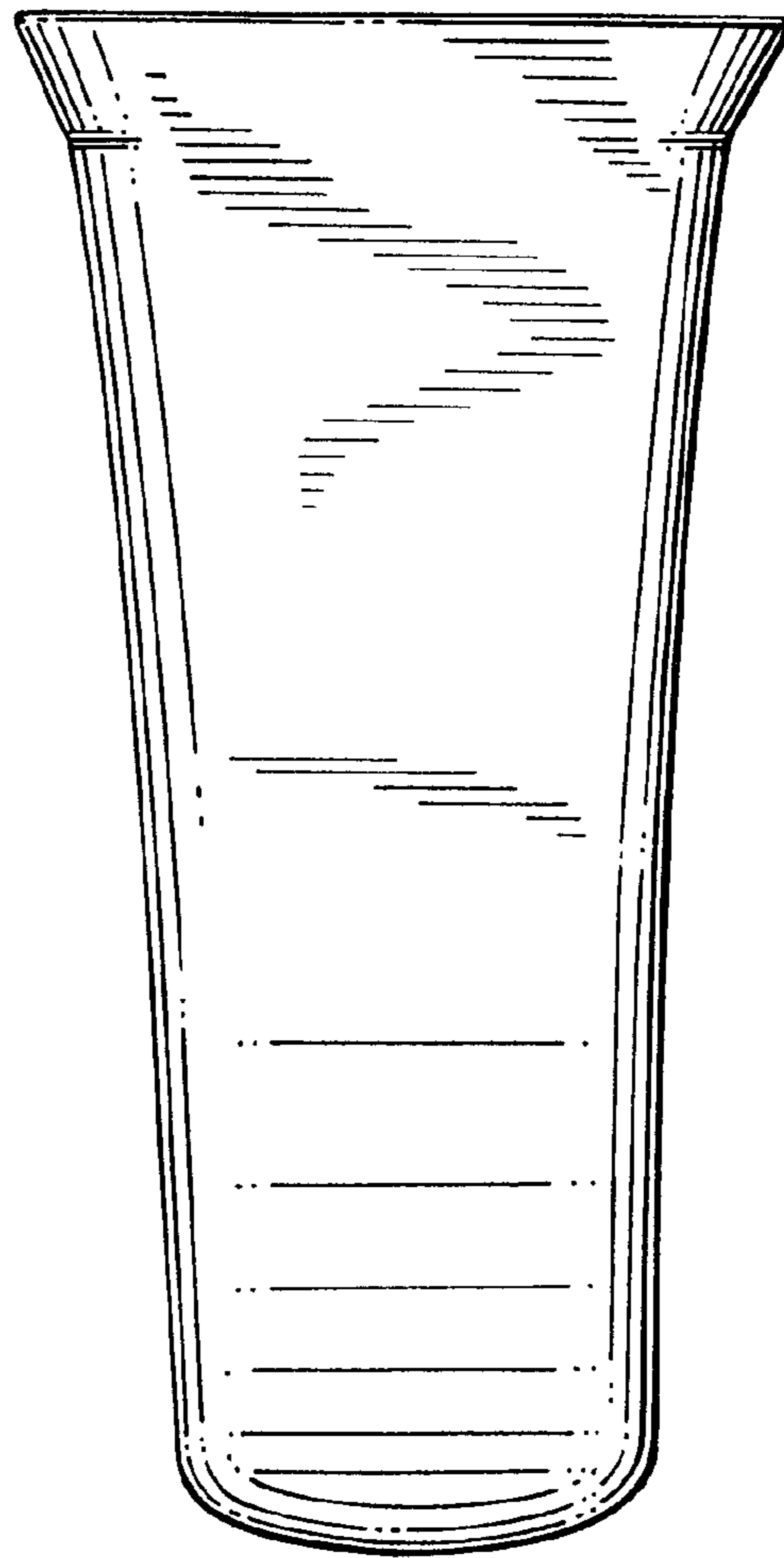
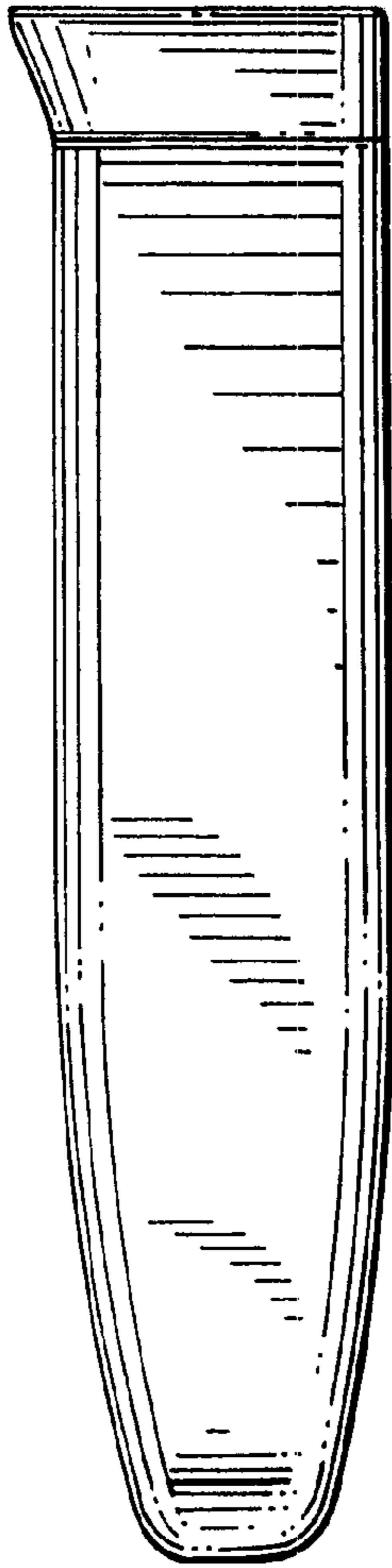

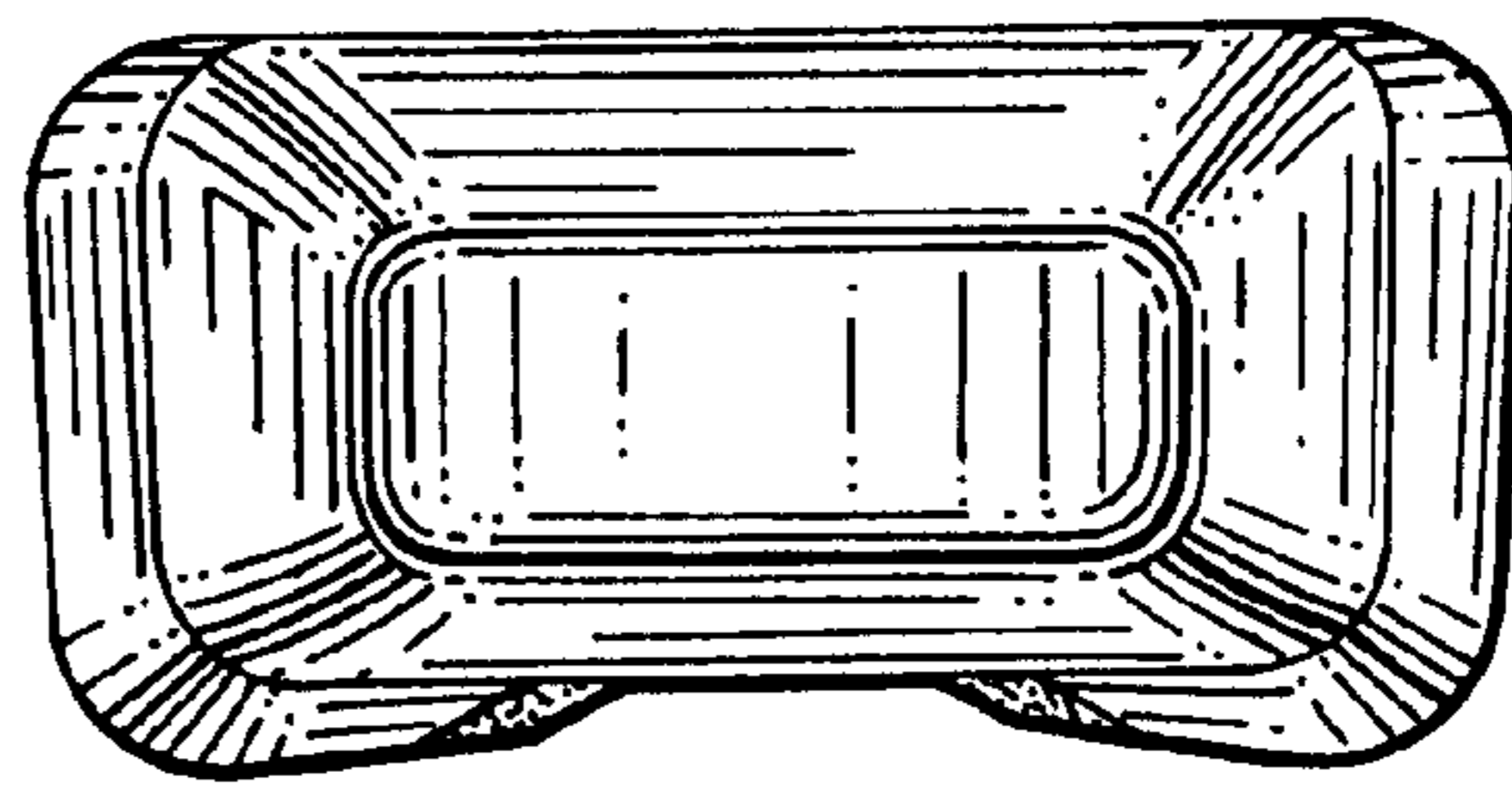

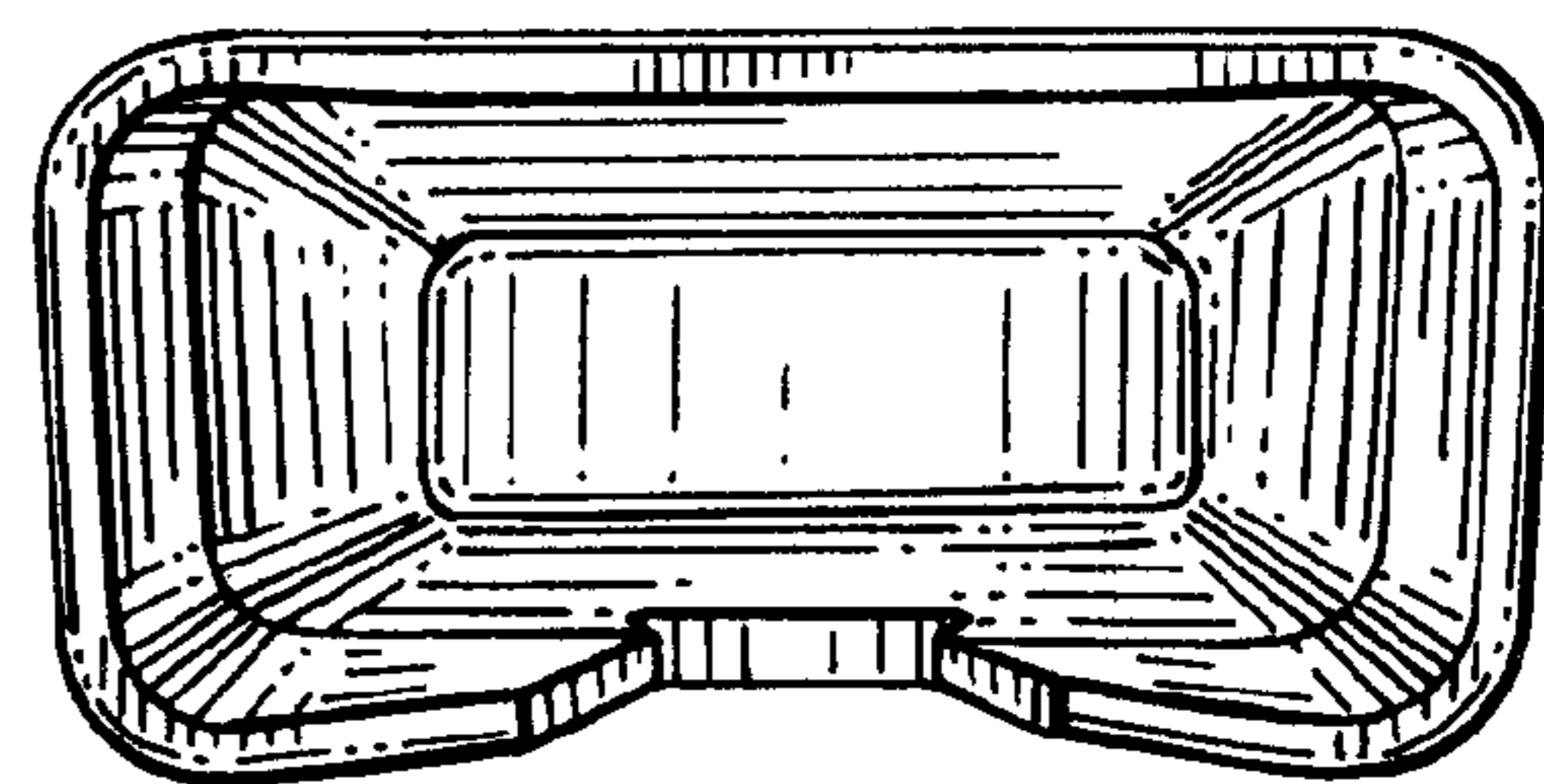
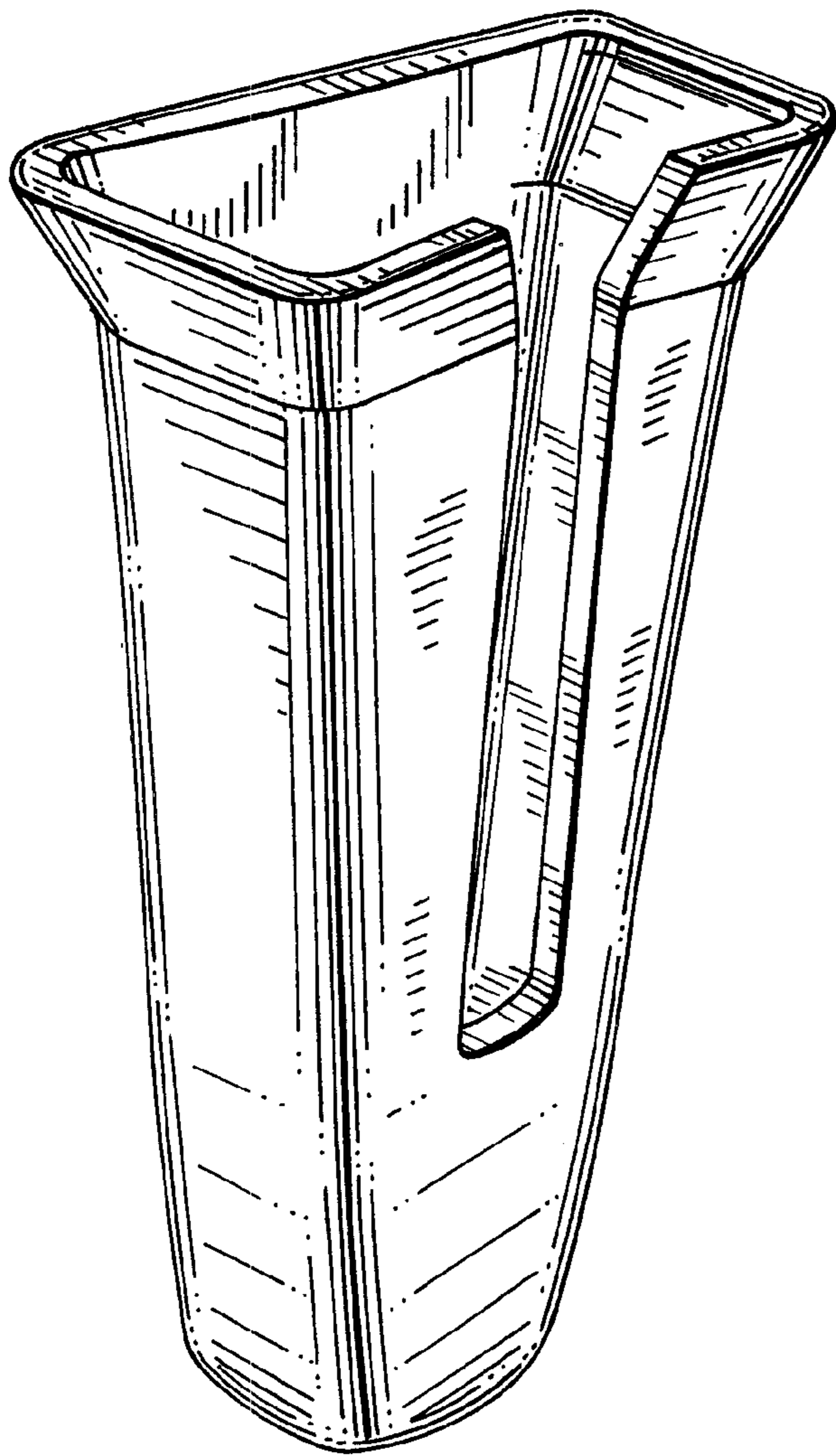

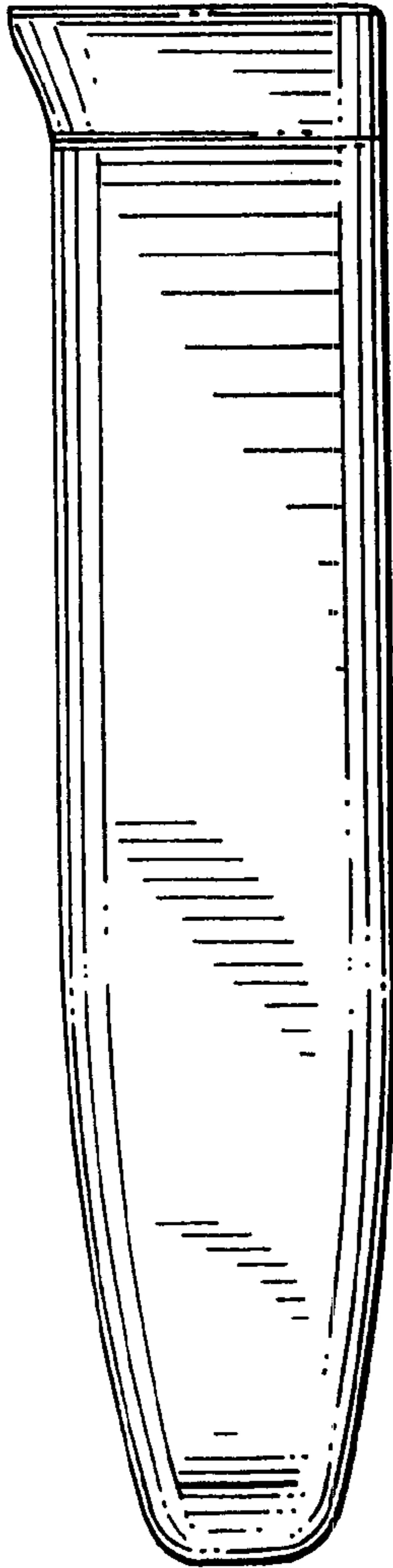

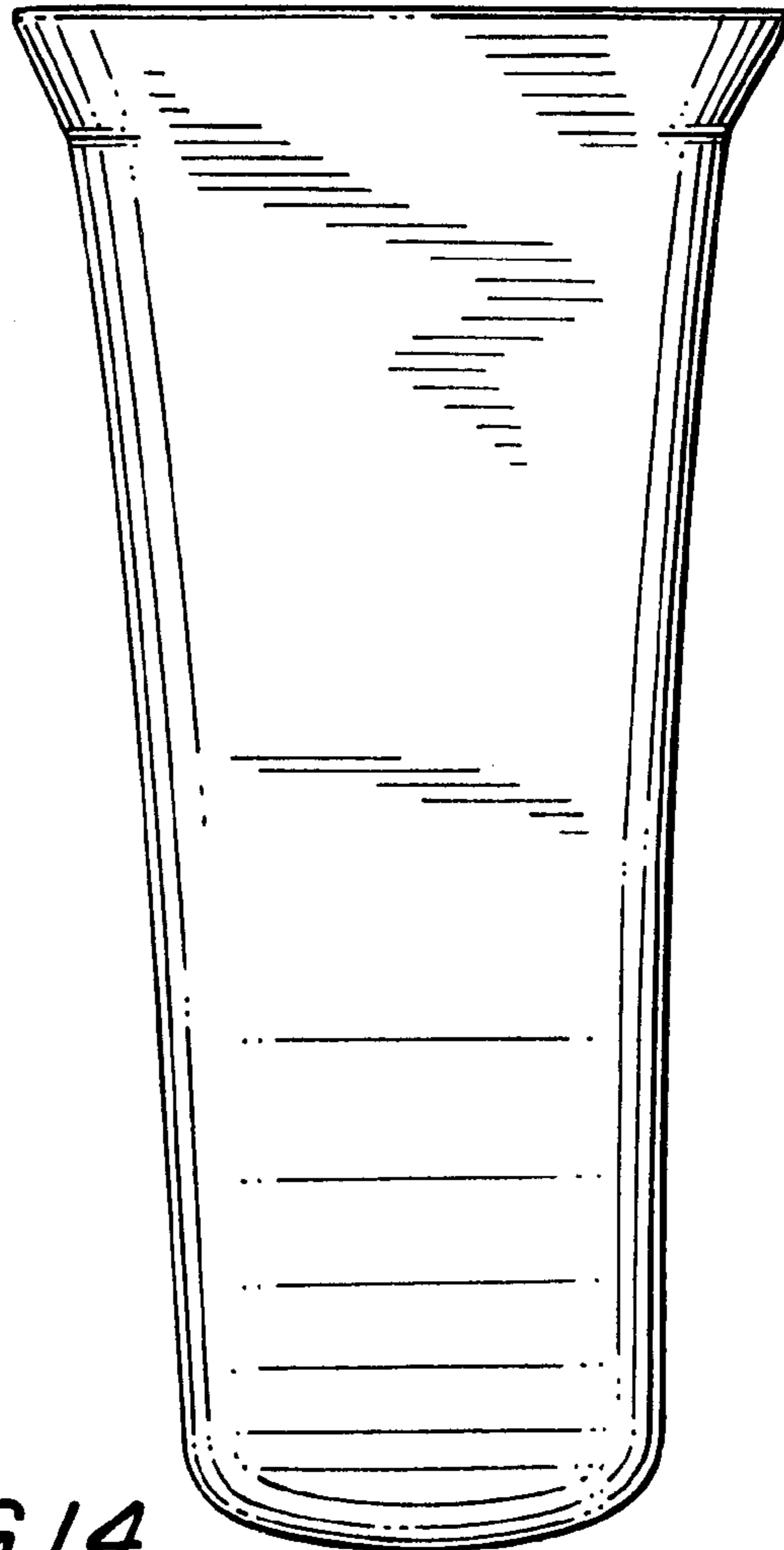
