showing my new design;

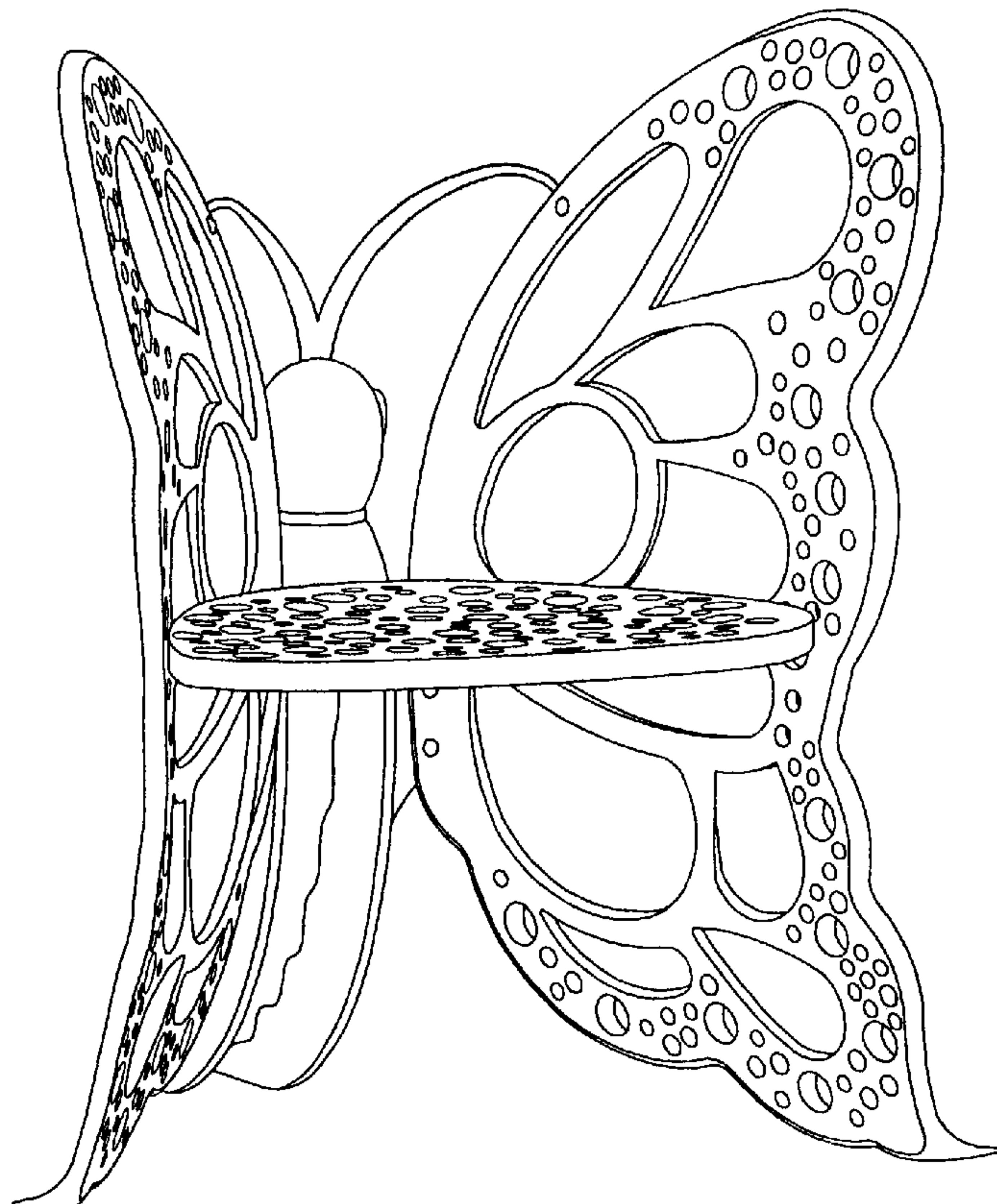
FIG. 2 is a rear perspective view of the butterfly chair of

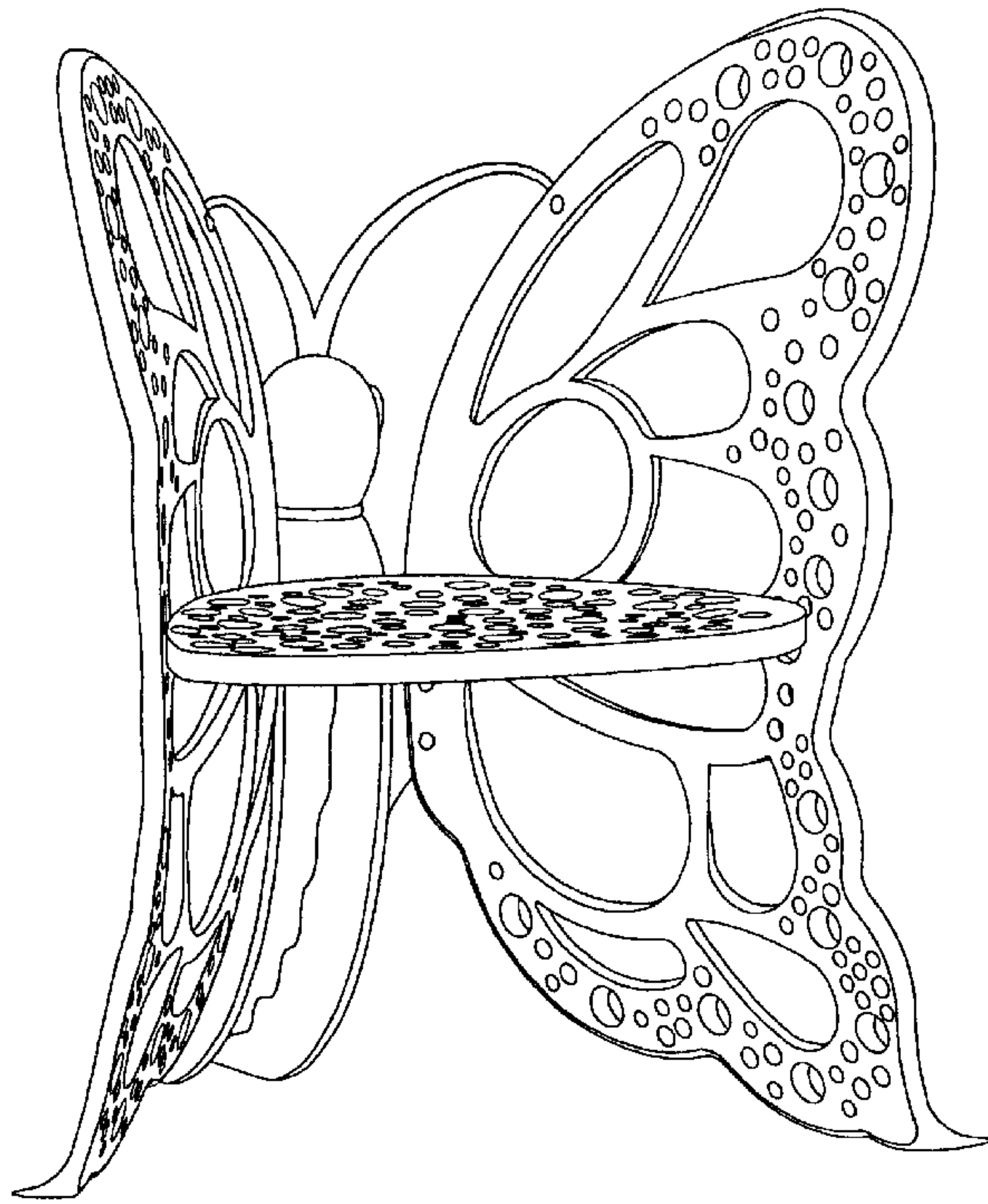

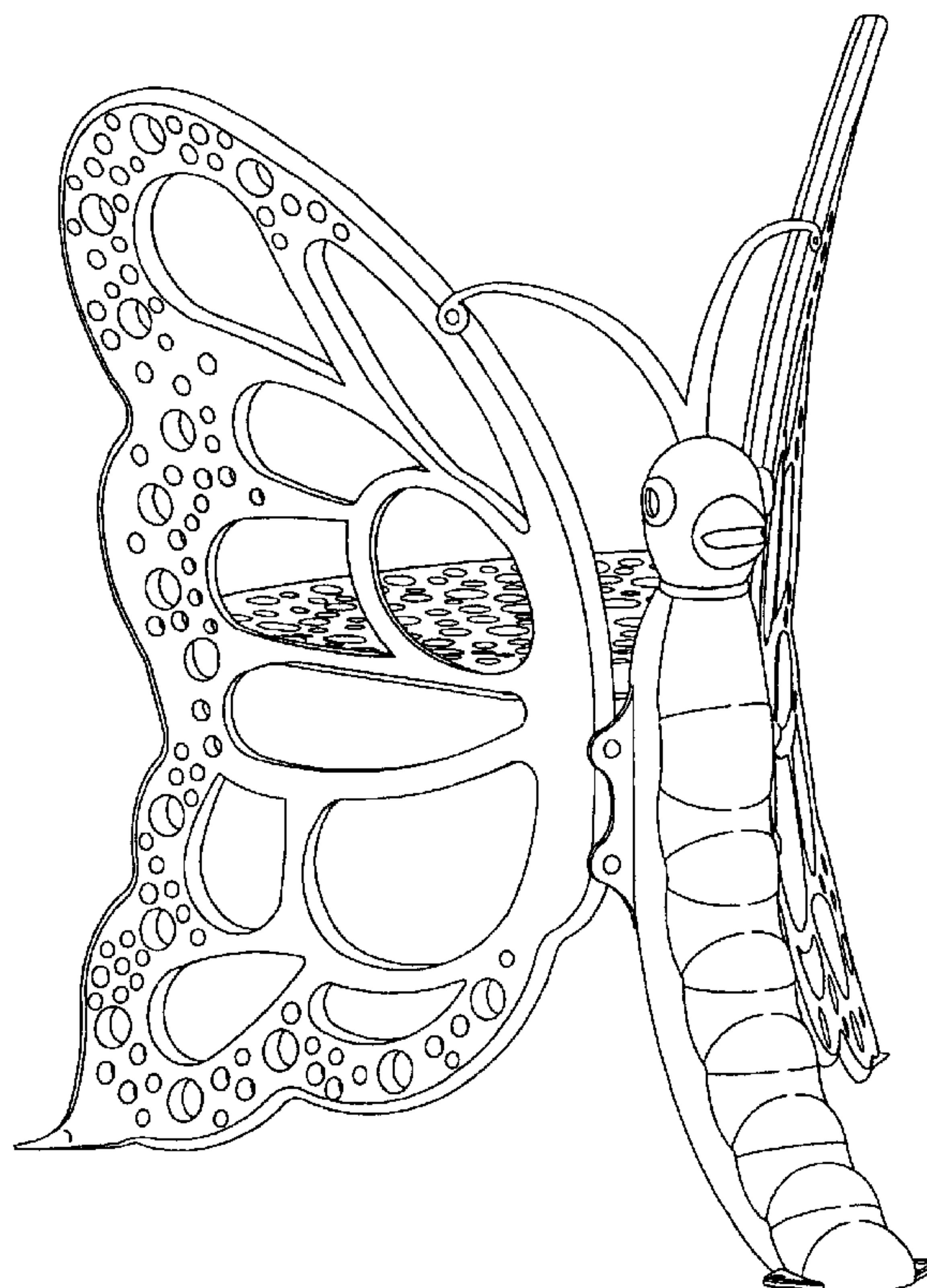

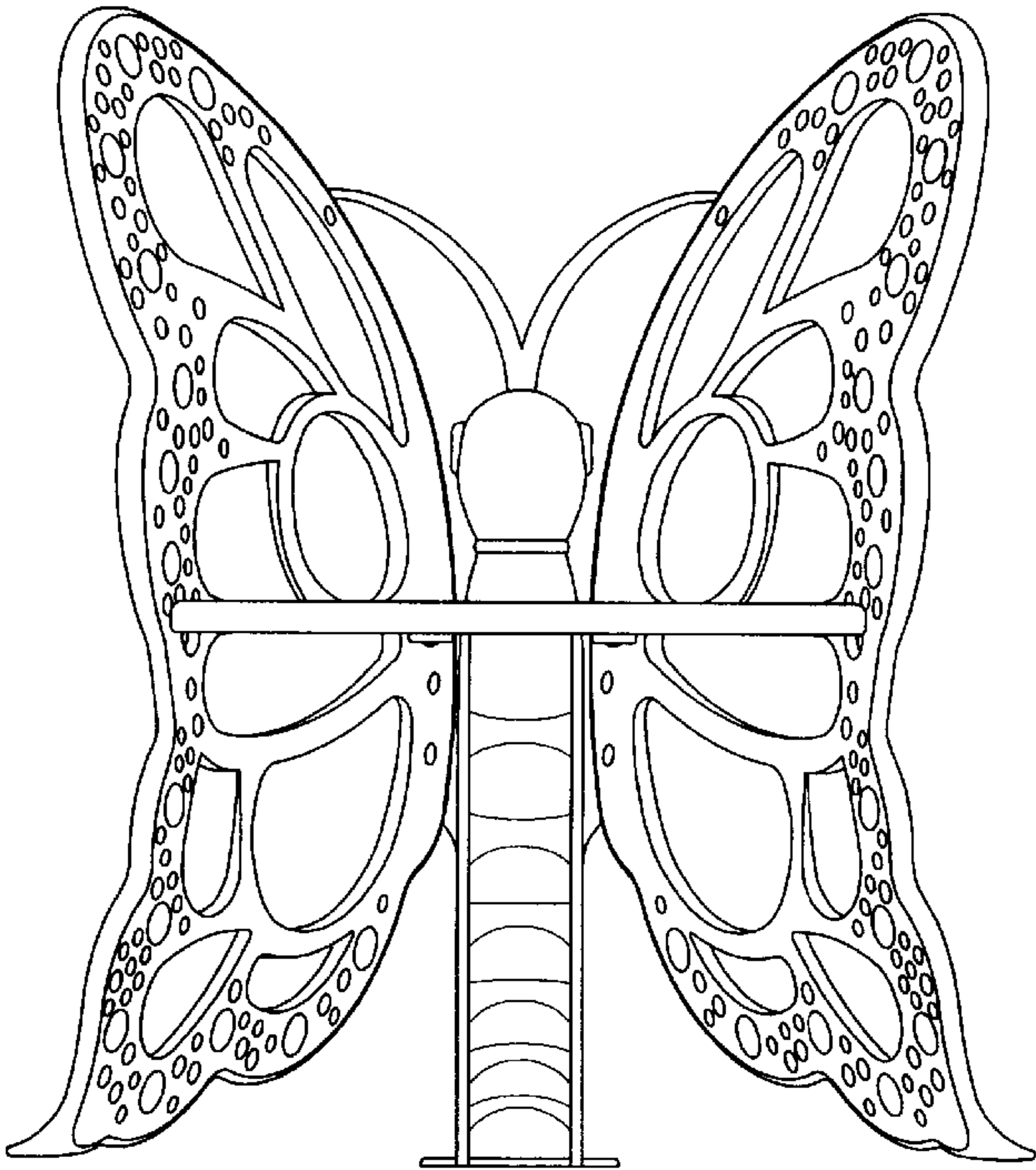

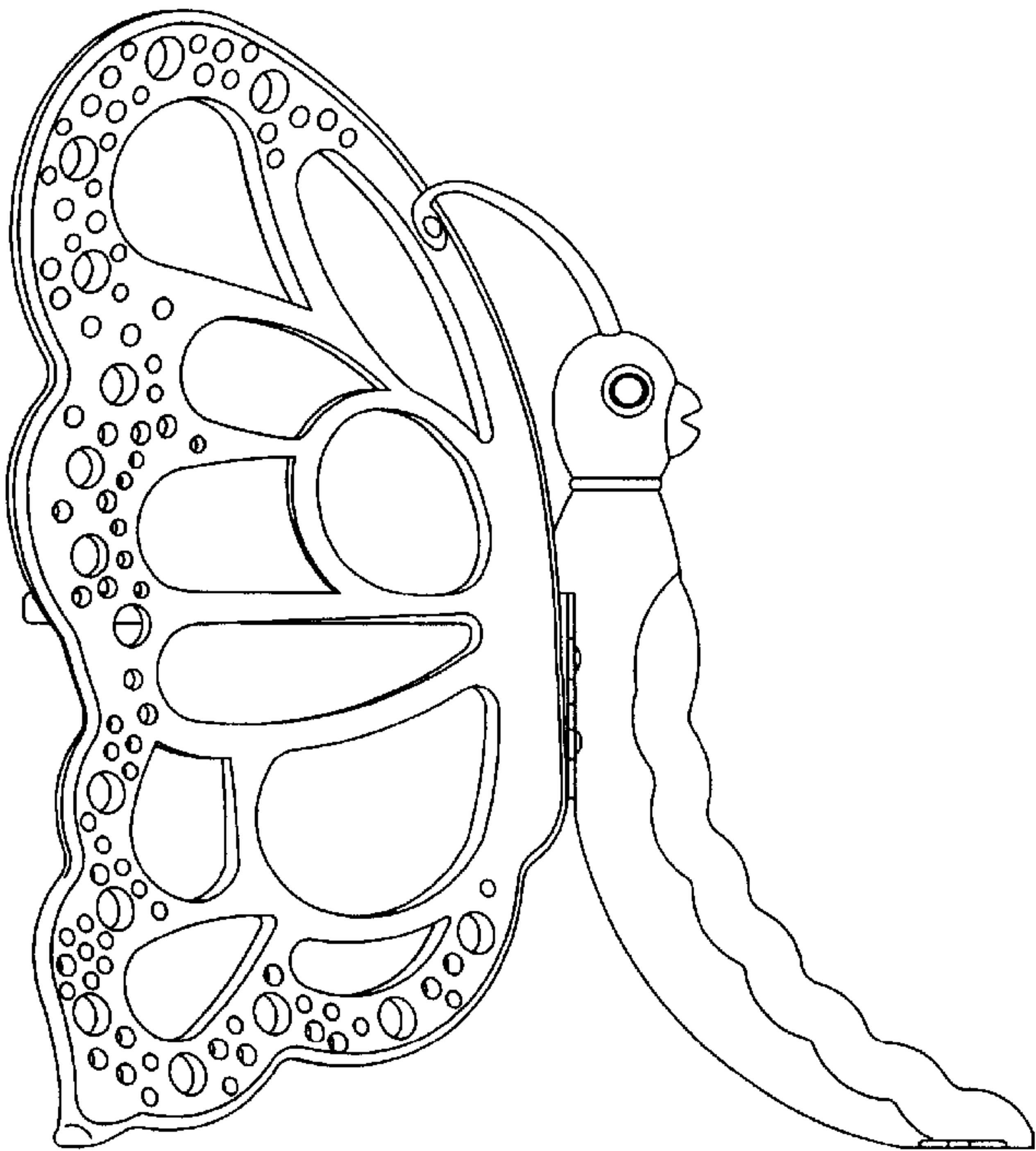

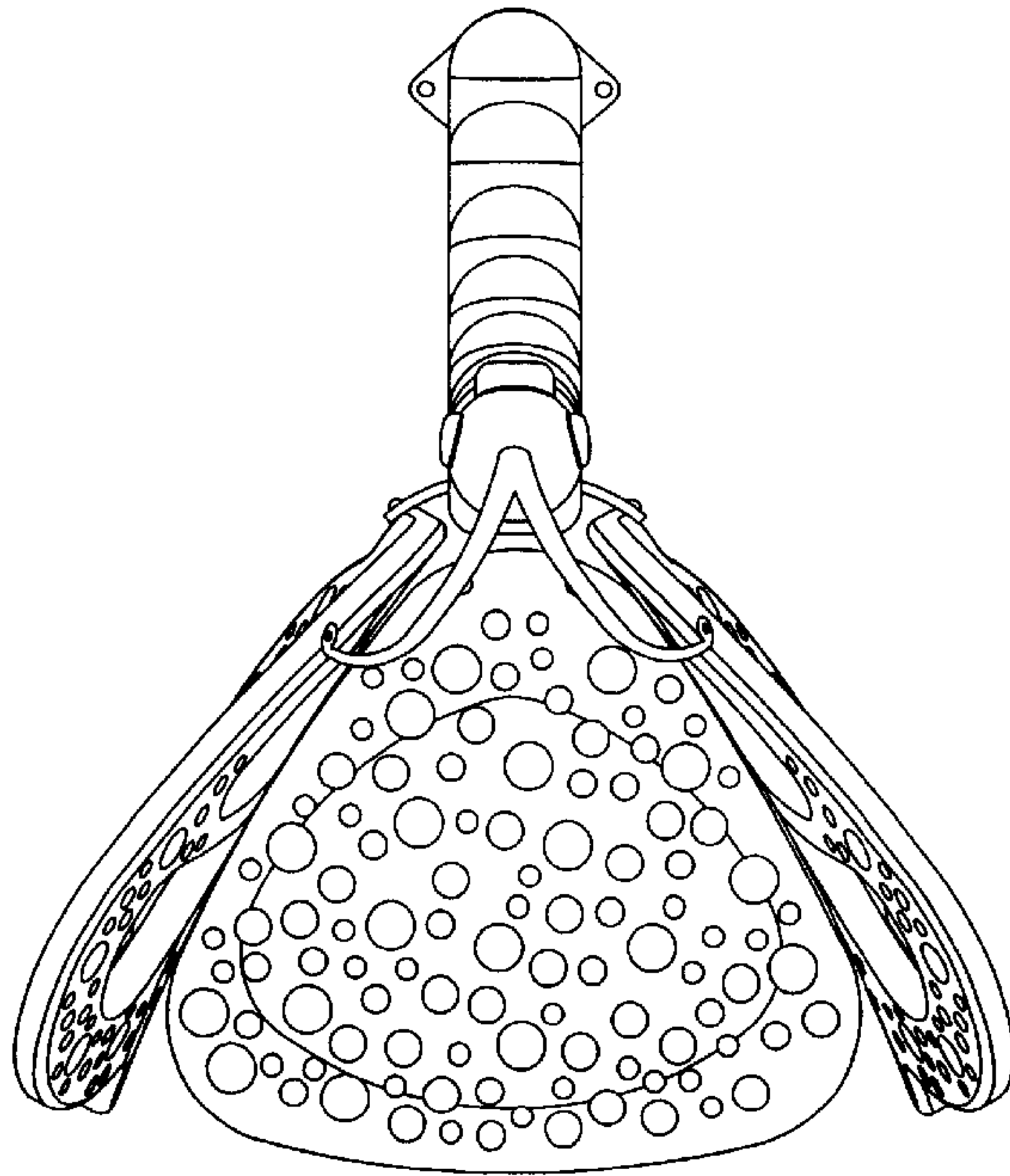

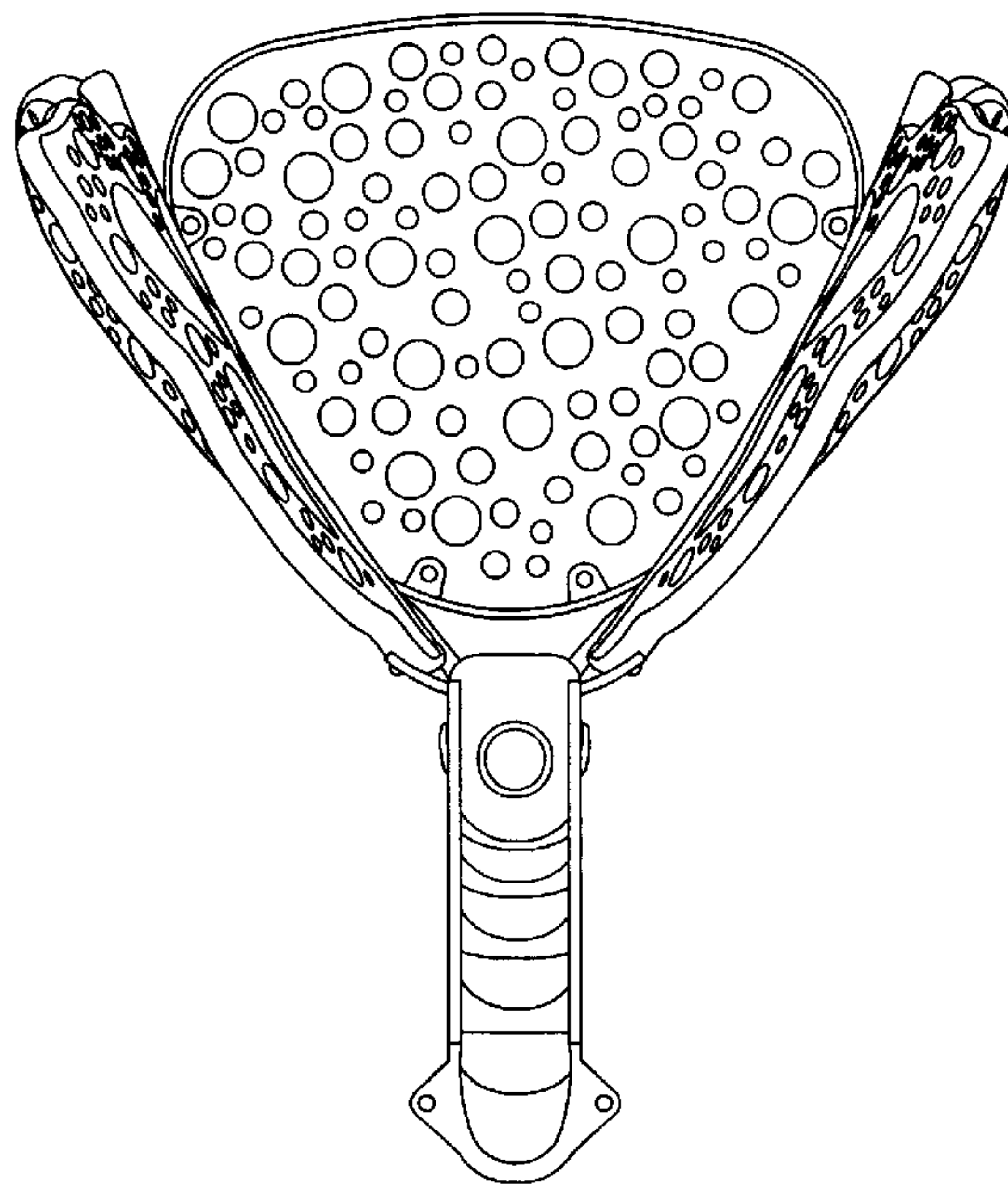
