FIG. 8 is a bottom view of the razor caddy.

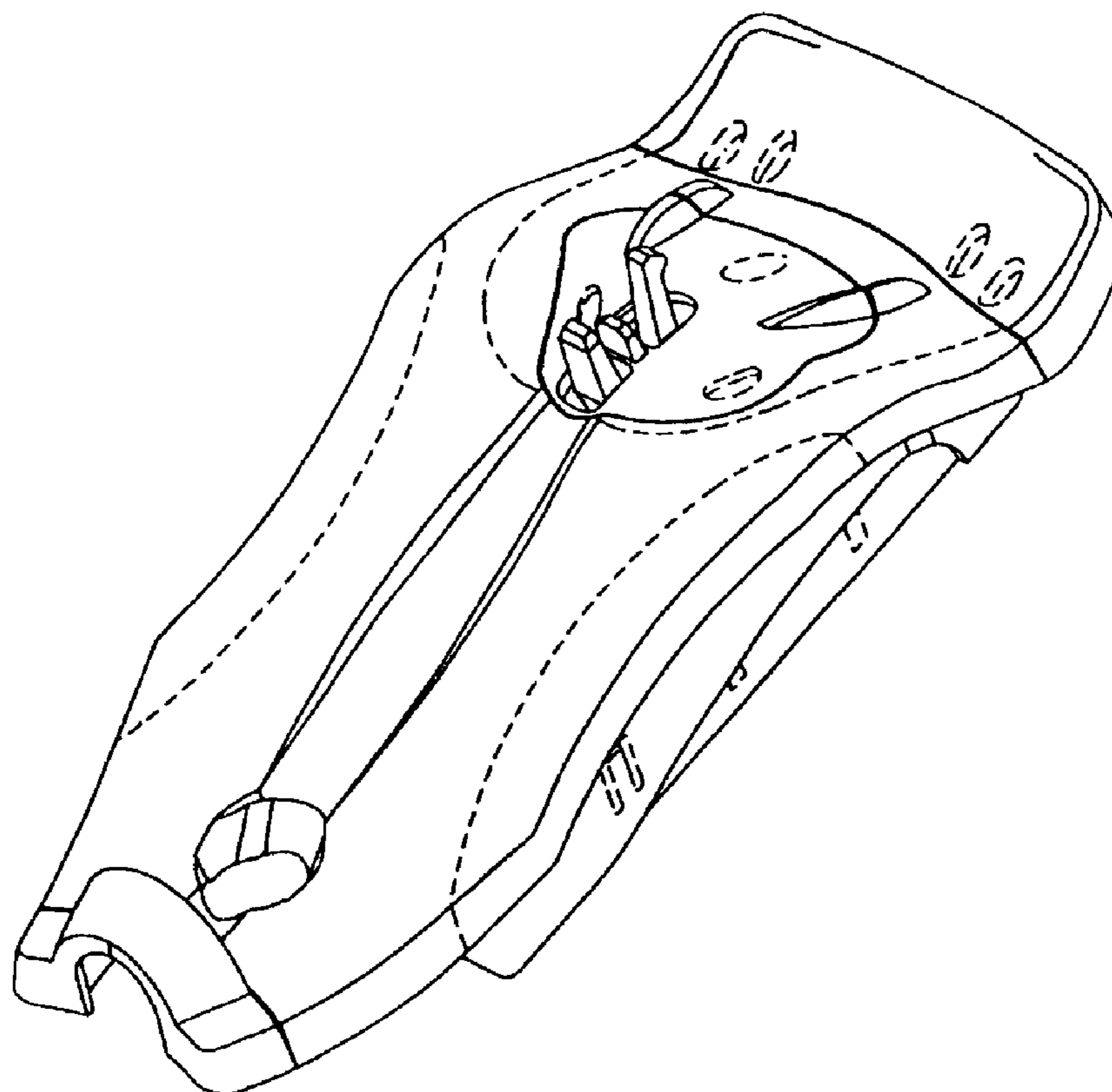

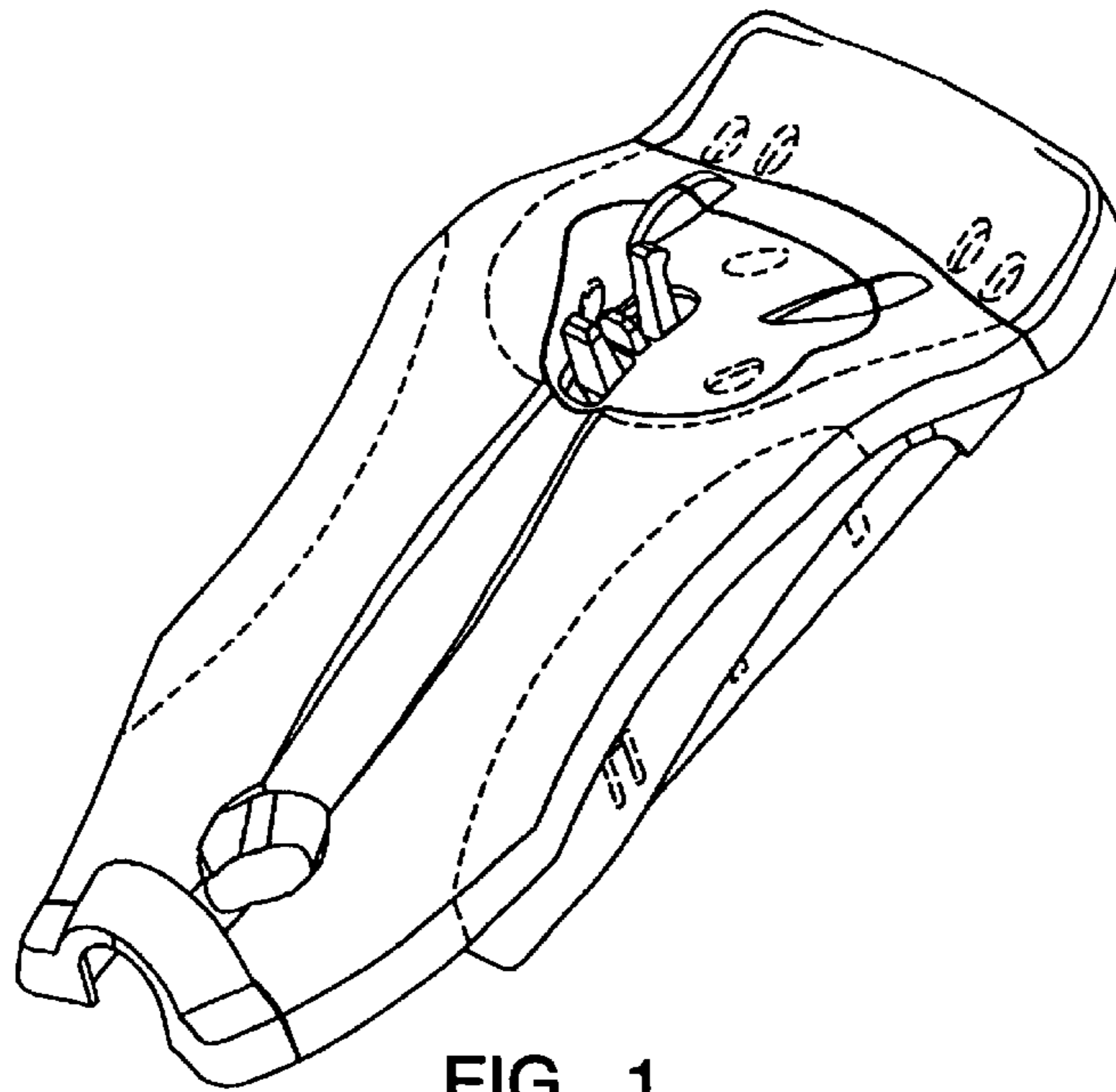

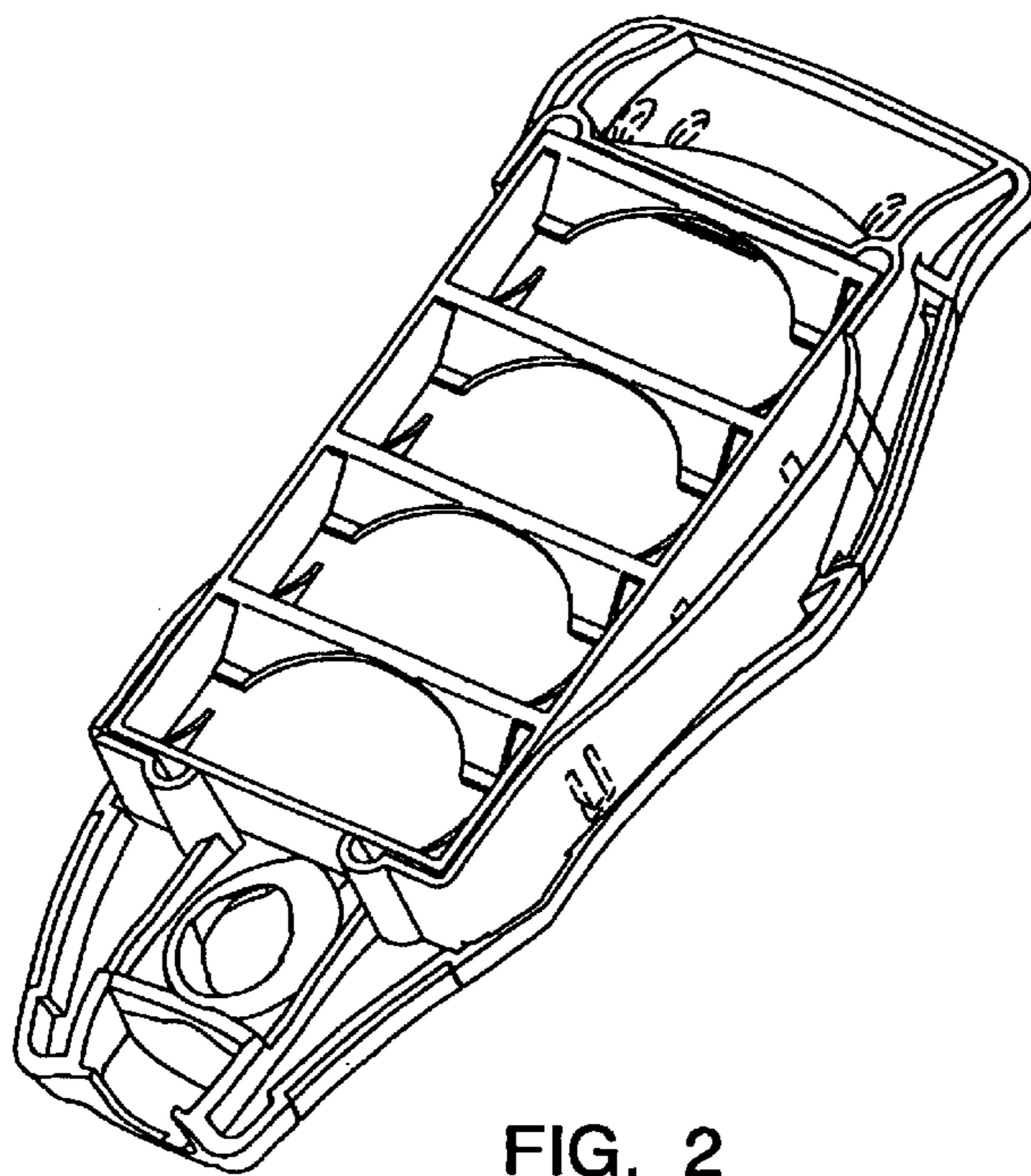

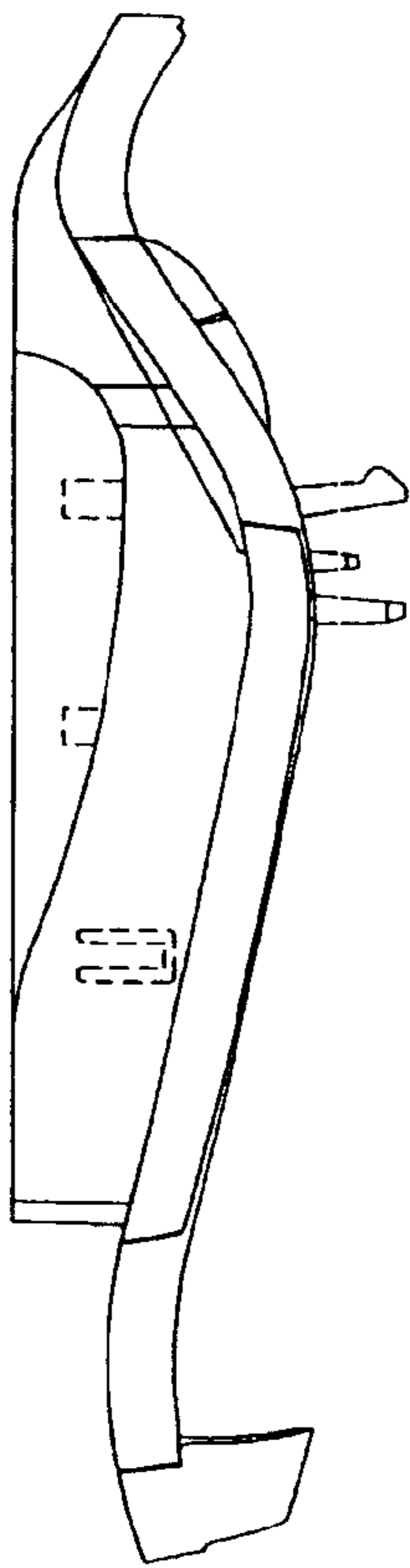

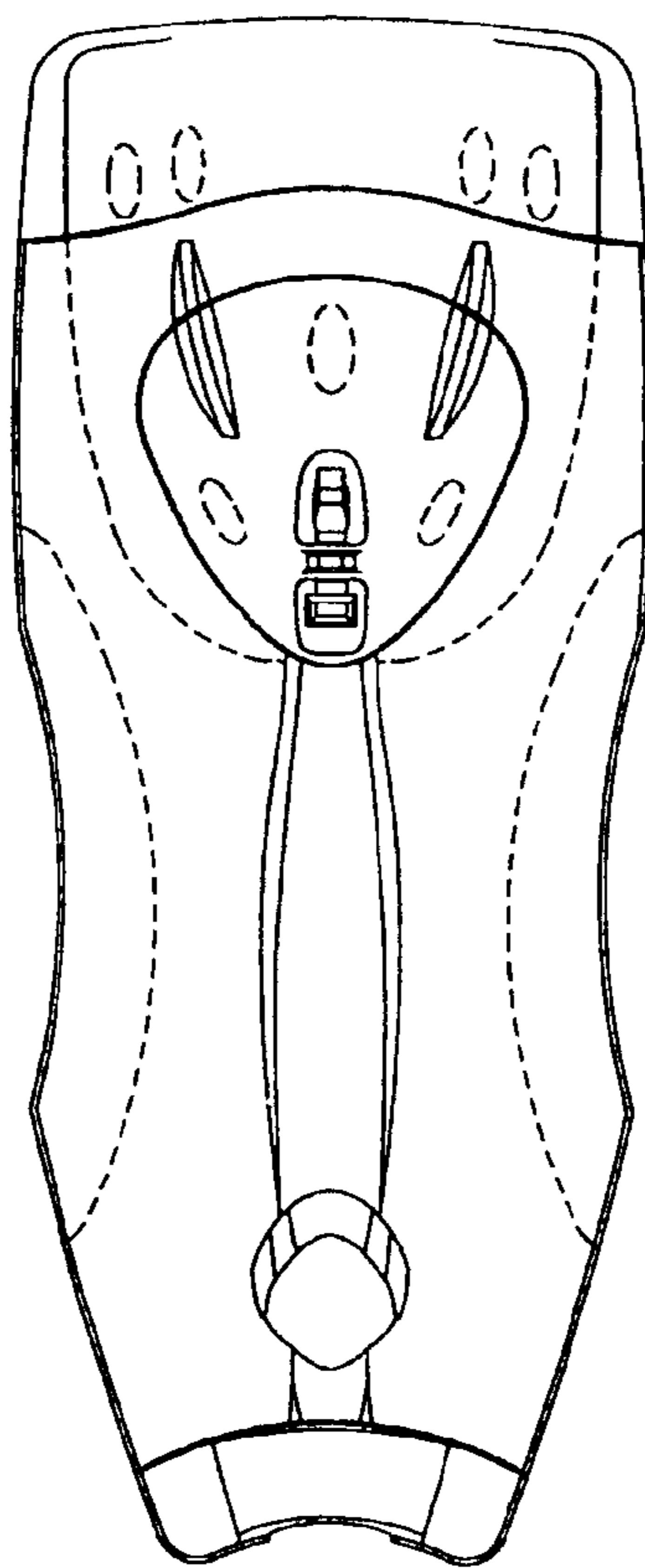

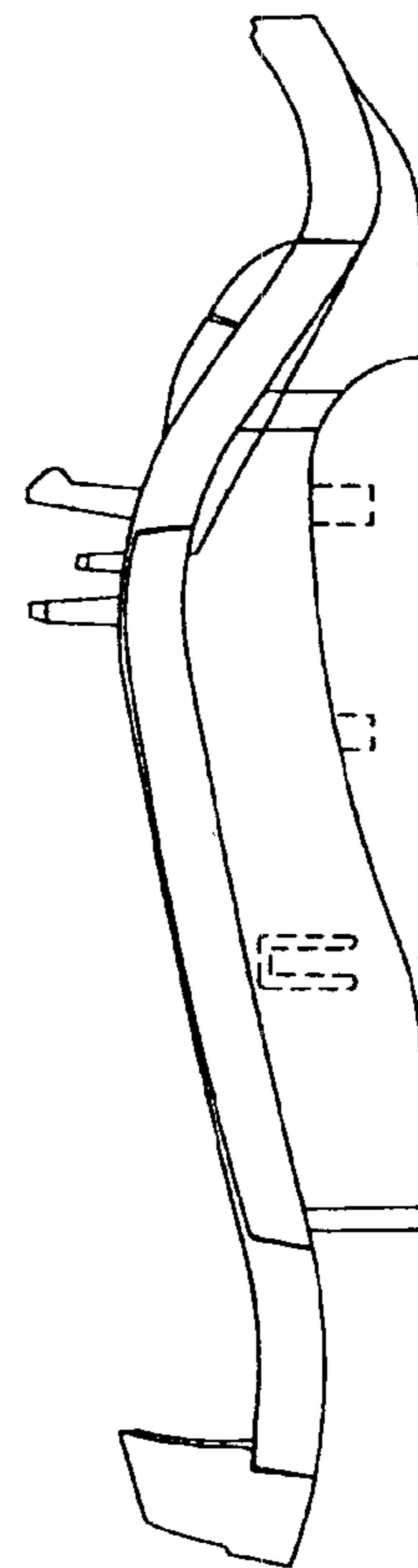

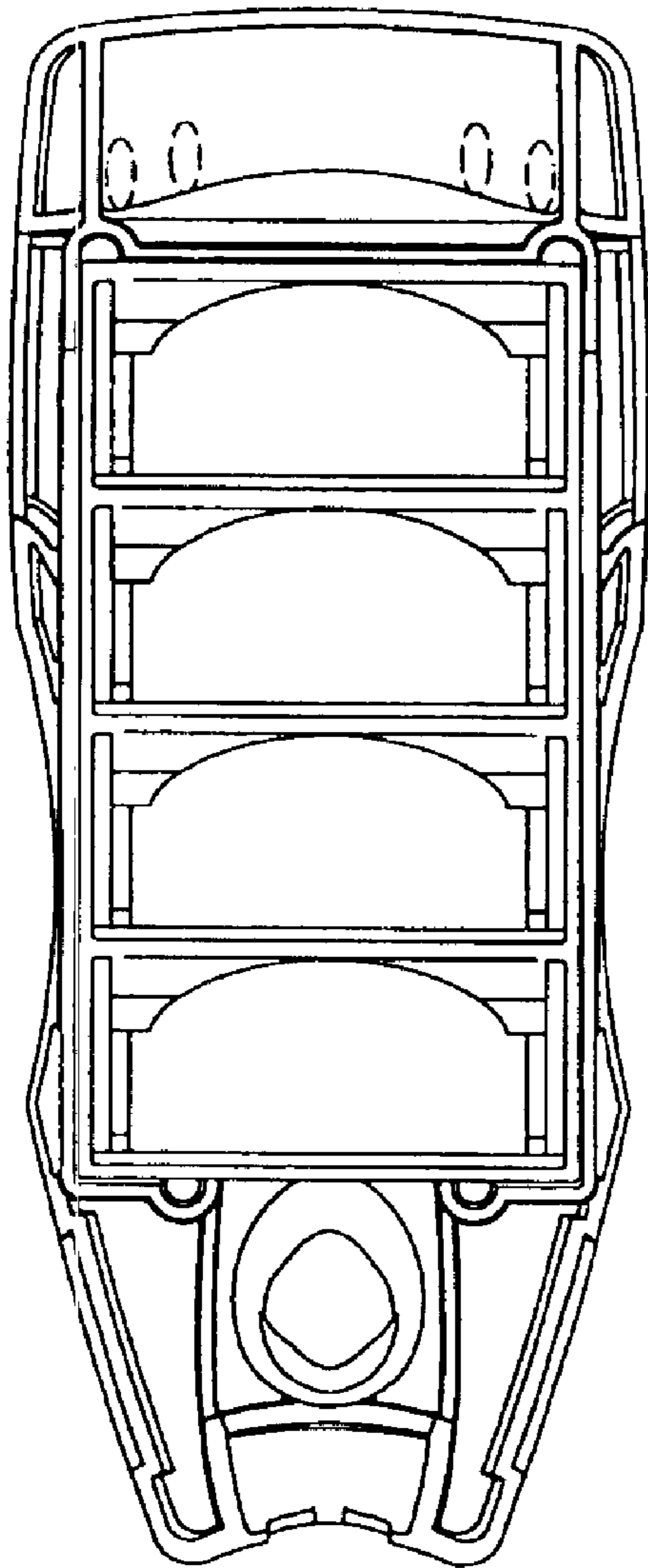

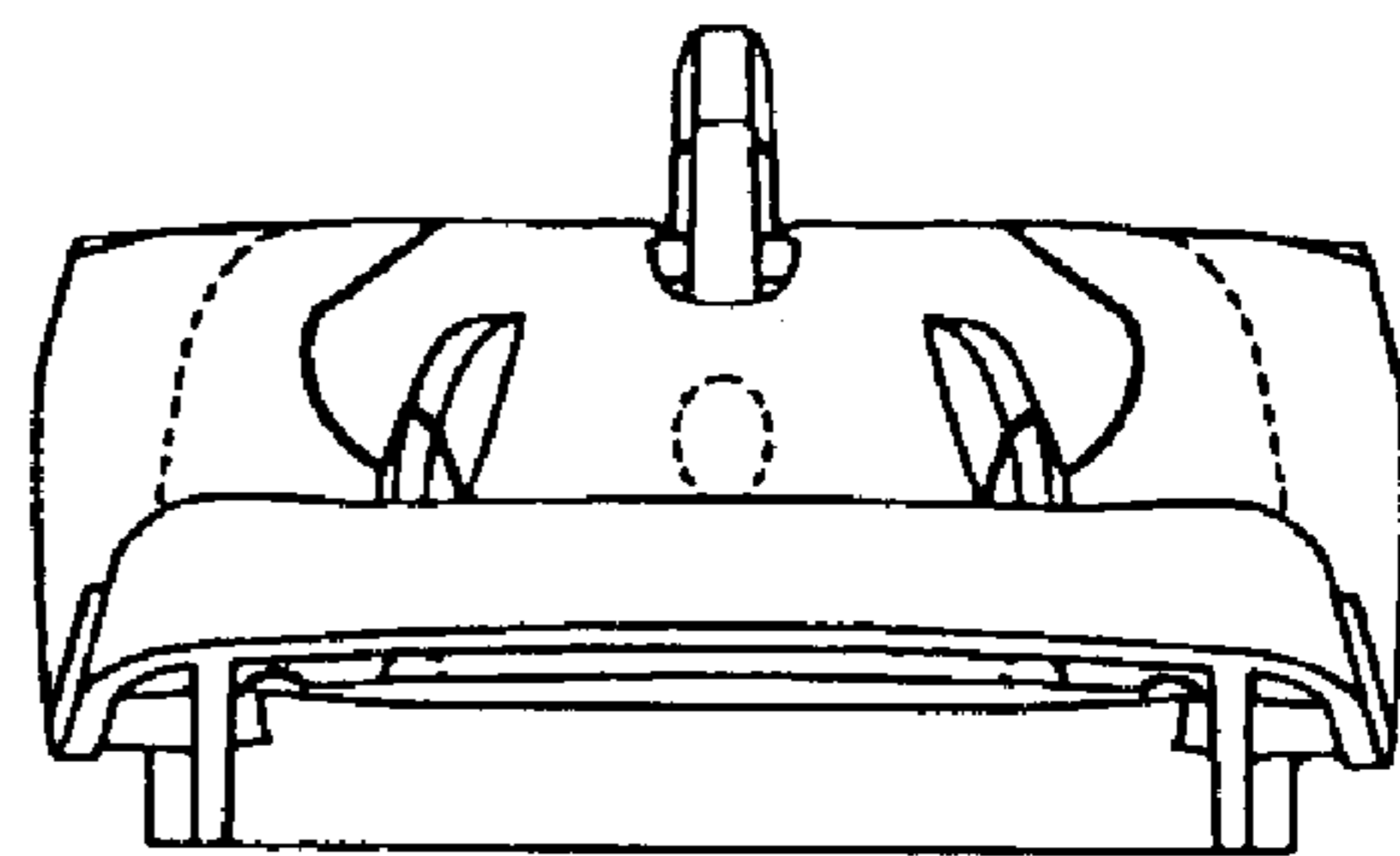

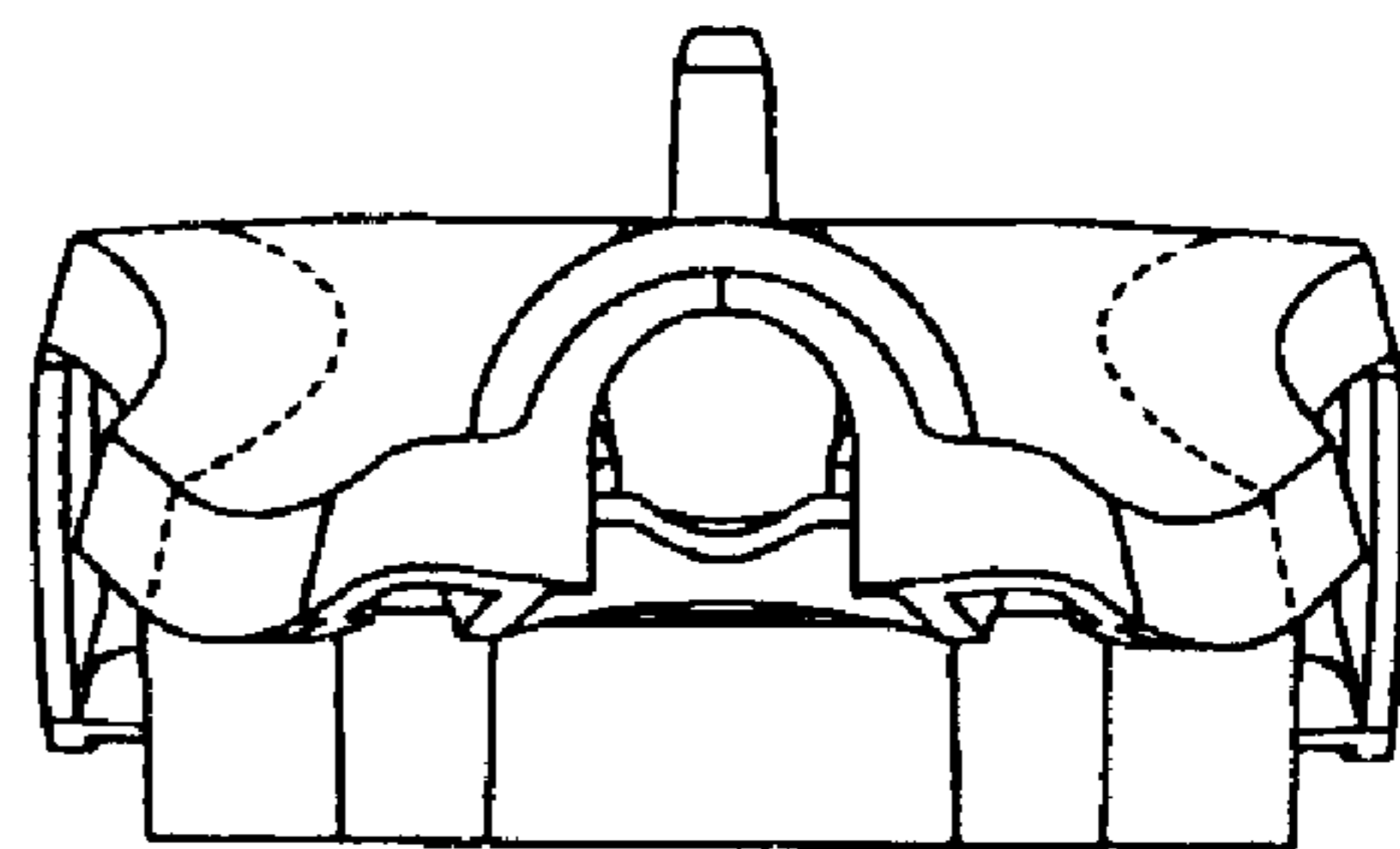
