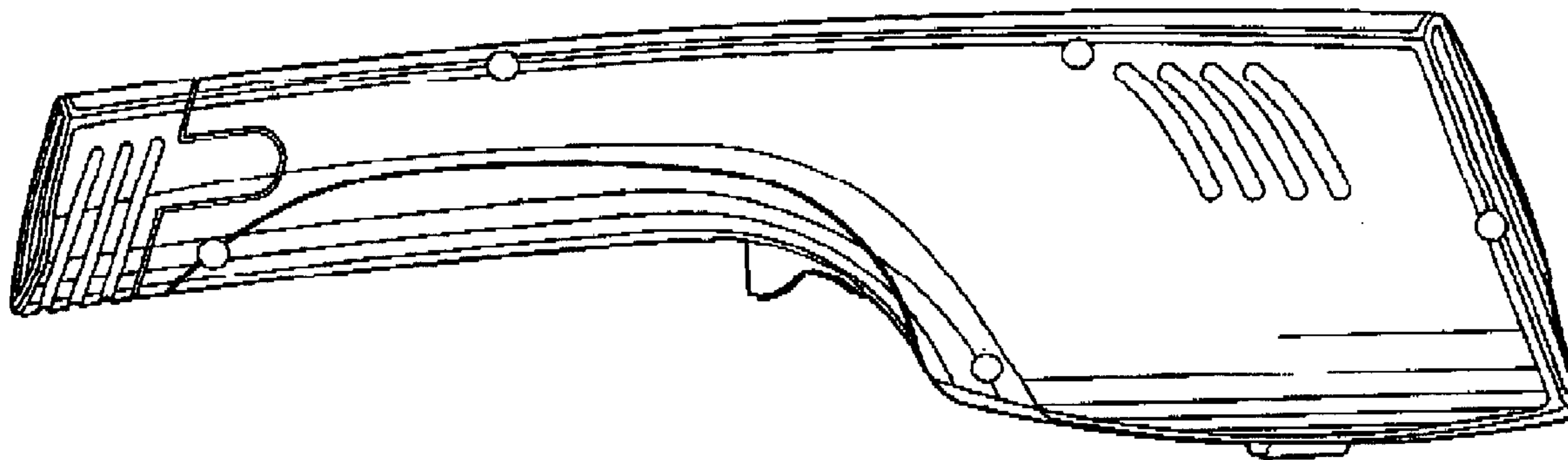
(57) **CLAIM**

The ornamental design for a rechargeable electric safety knife assembly, as shown.

DESCRIPTION

FIG. 1 is a side elevational view of the rechargeable electric safety knife assembly showing my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; and, FIG. 5 is a bottom plan view thereof.

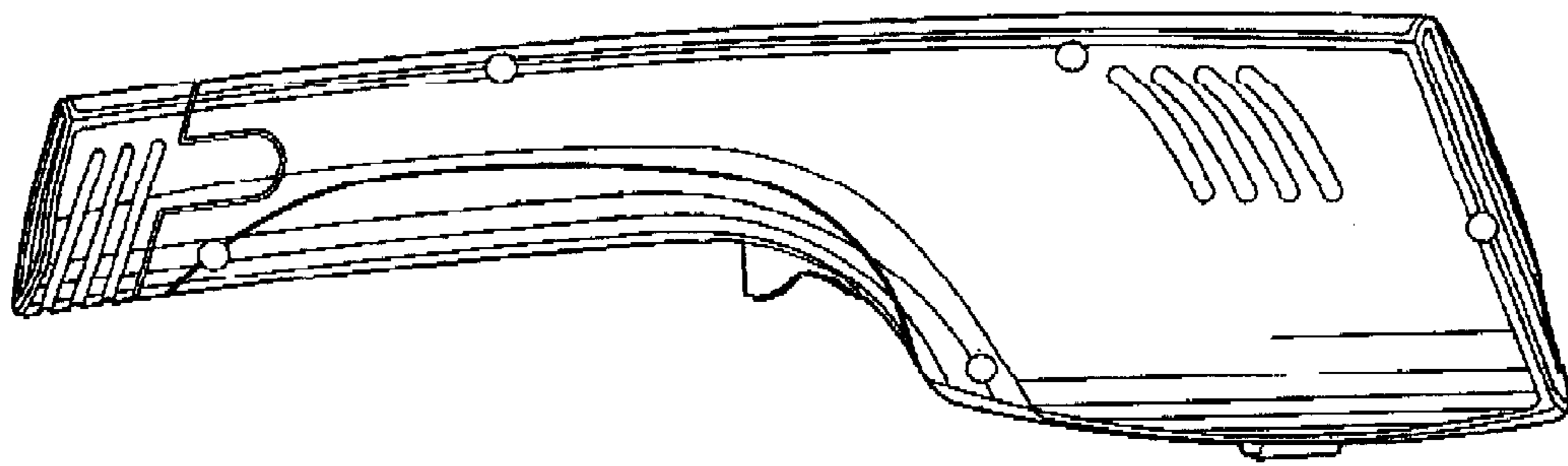

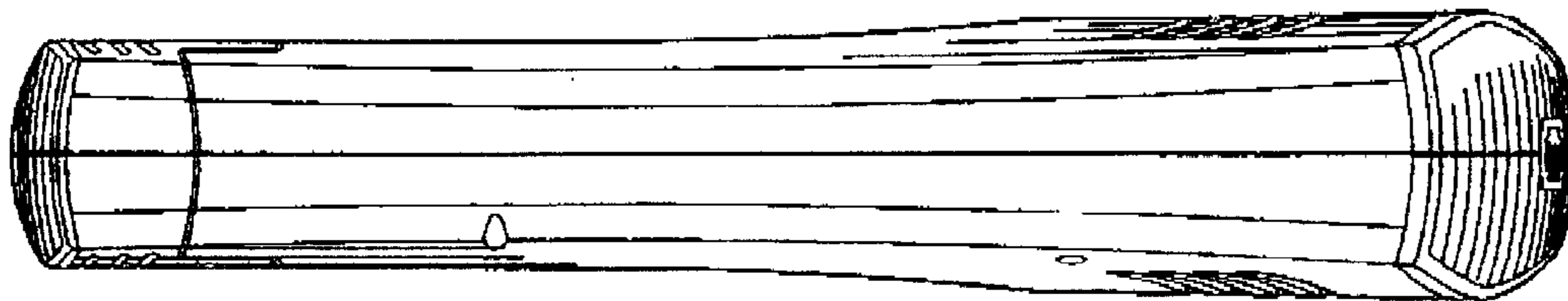

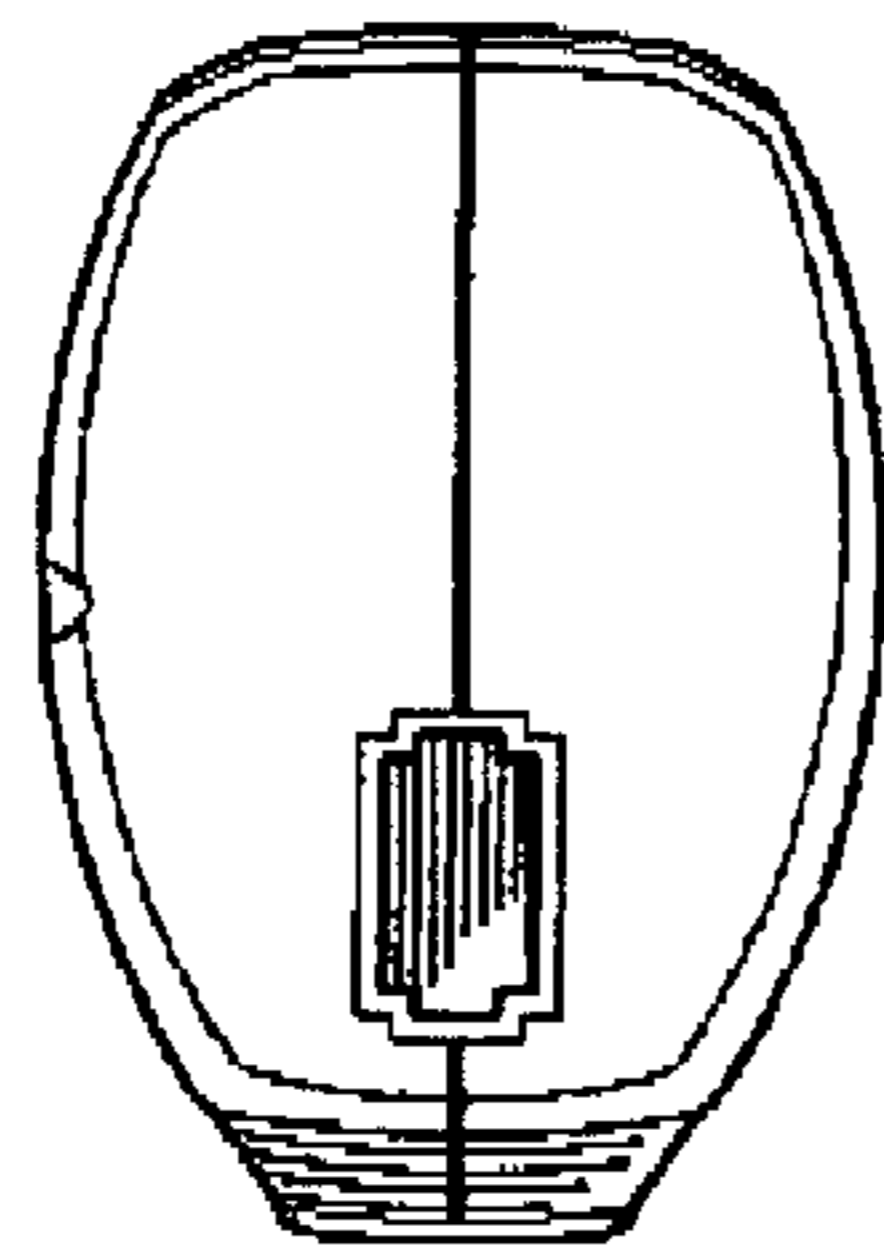

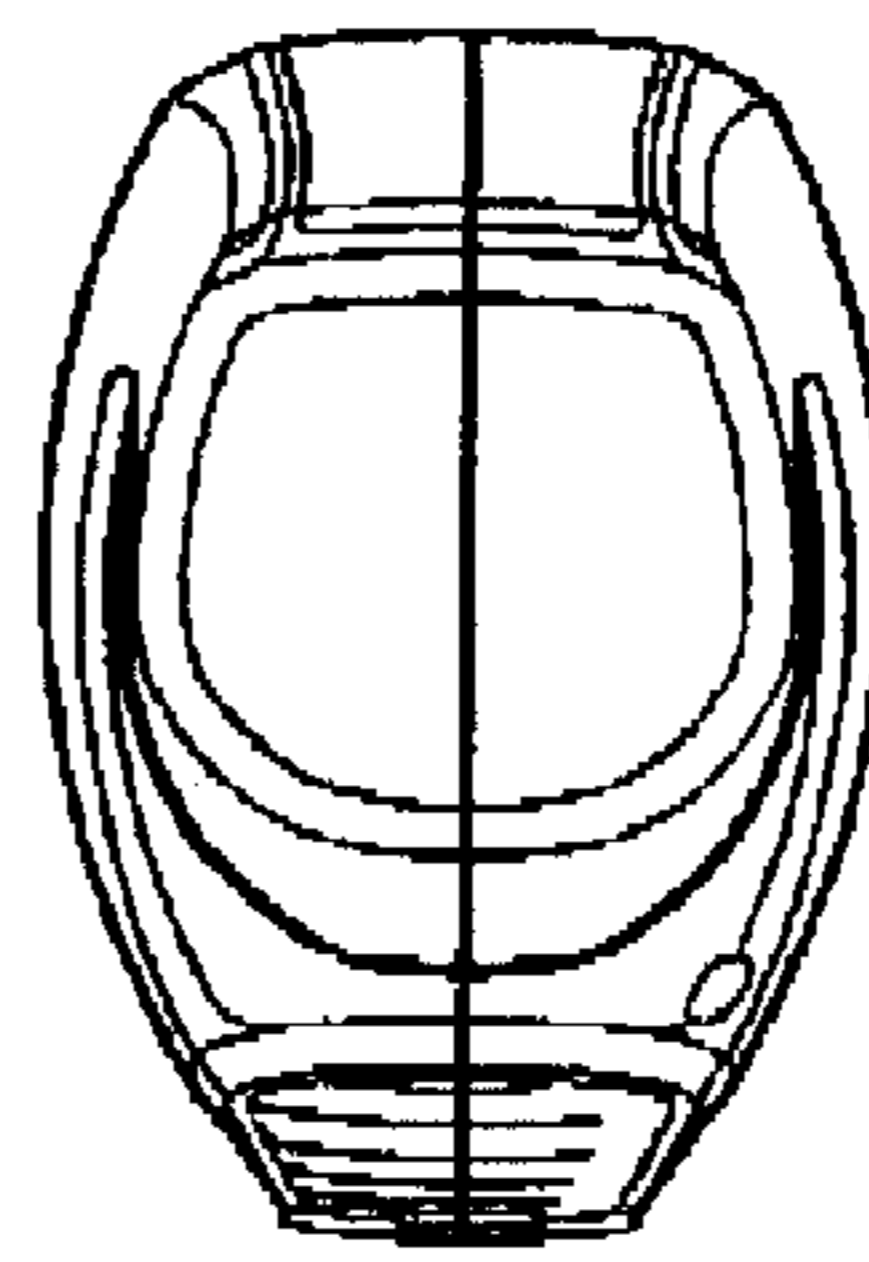

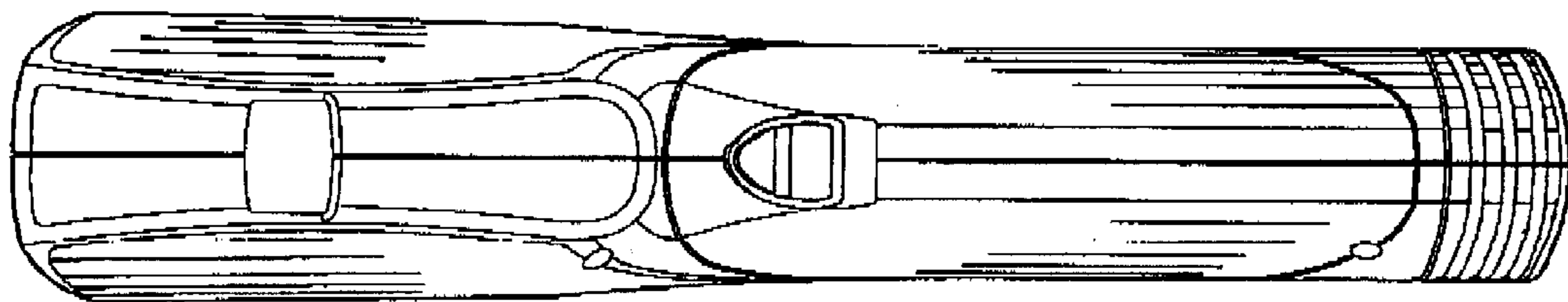
