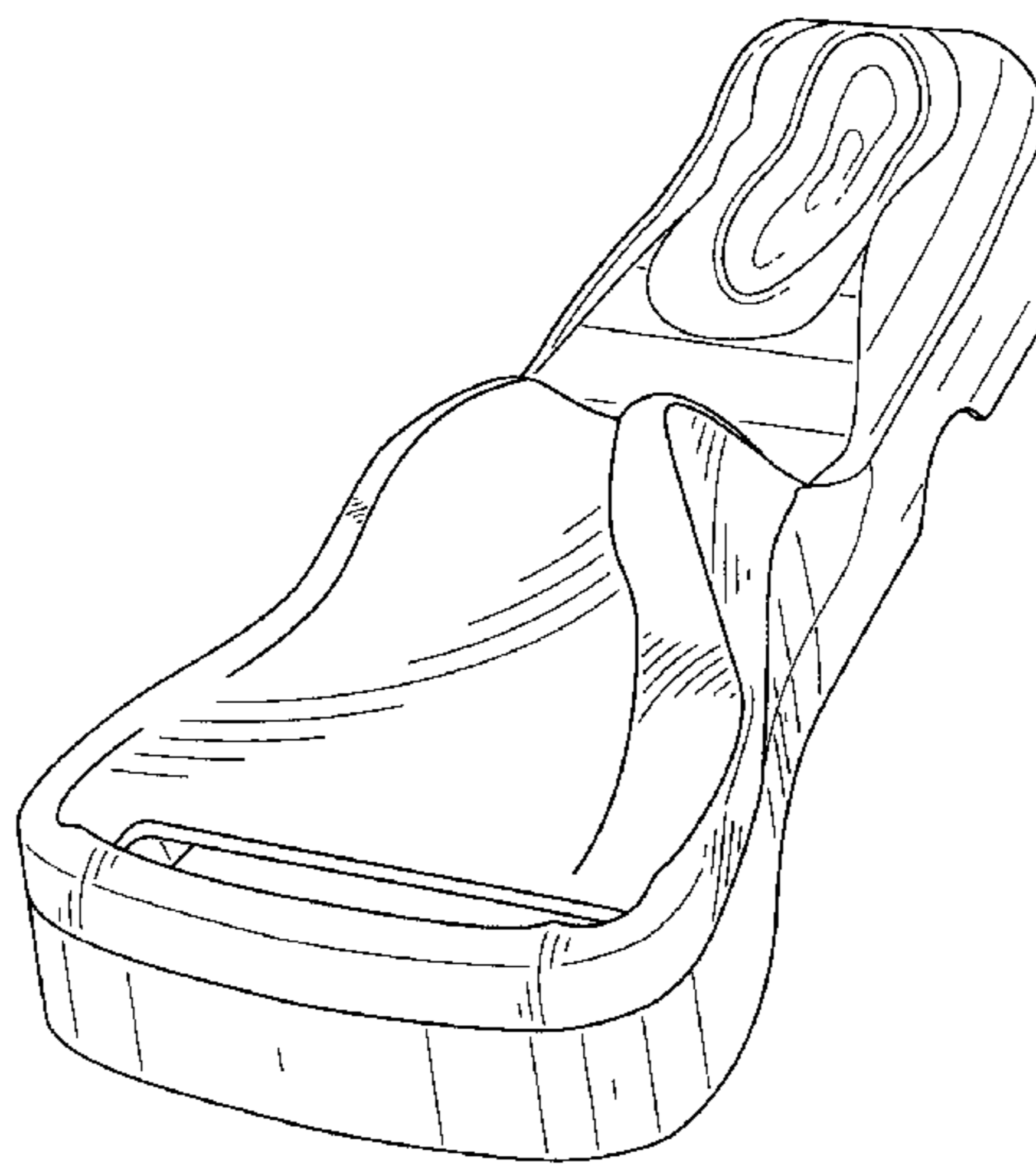
(57) **CLAIM**

The ornamental design for a shaving razor tray, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the shaving razor tray showing the new design;
 FIG. 2 is a front view of the shaving razor tray;
 FIG. 3 is a rear view of the shaving razor tray;
 FIG. 4 is a side view of the shaving razor tray;
 FIG. 5 is another side view of the shaving razor tray;
 FIG. 6 is a top view of the shaving razor tray;
 FIG. 7 is a bottom view of the shaving razor tray; and,
 FIG. 8 is a front perspective view of the shaving razor tray of FIGS. 1-7 with the broken line showing of a razor stored in the tray forming no part of the claimed design.

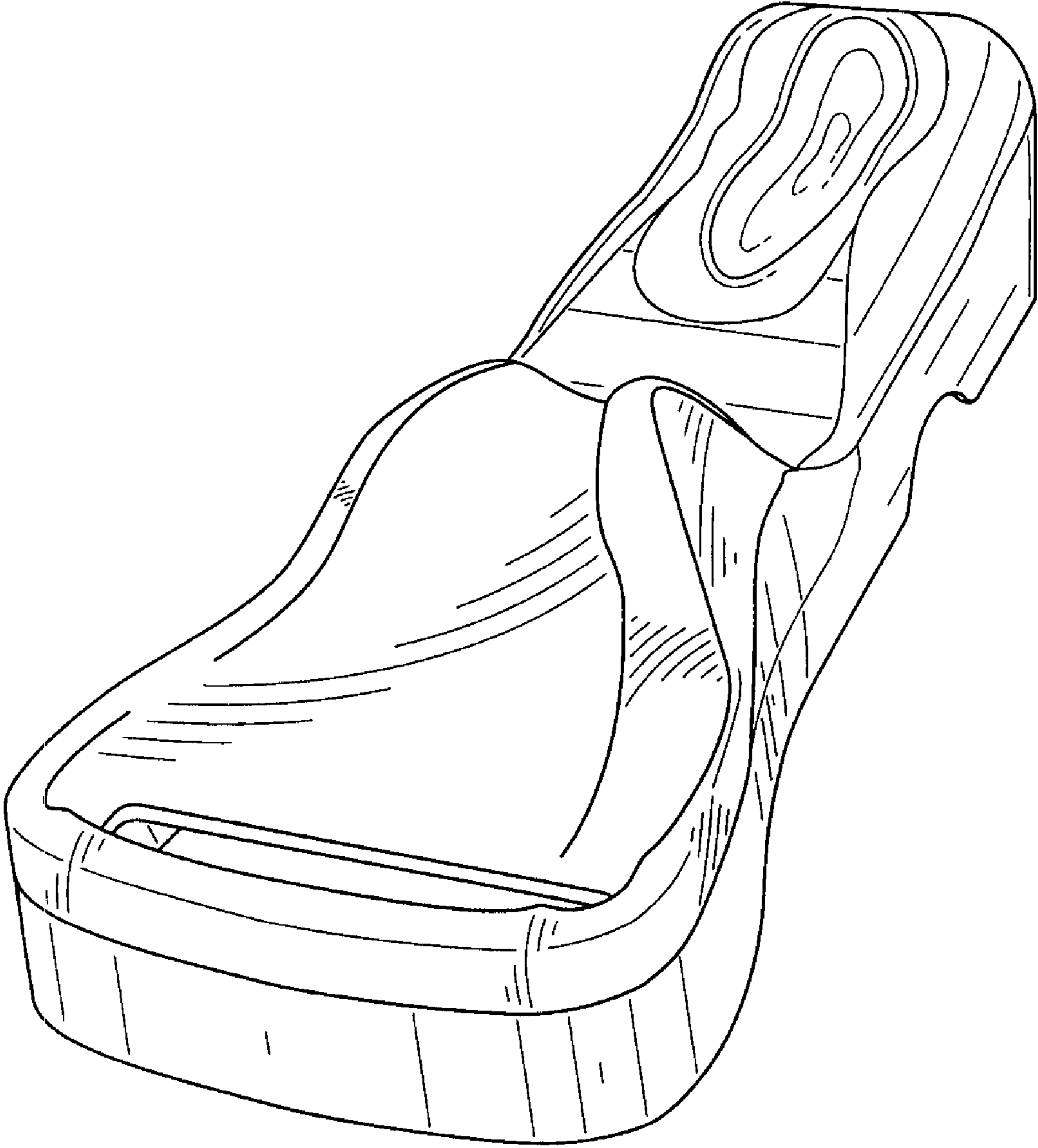

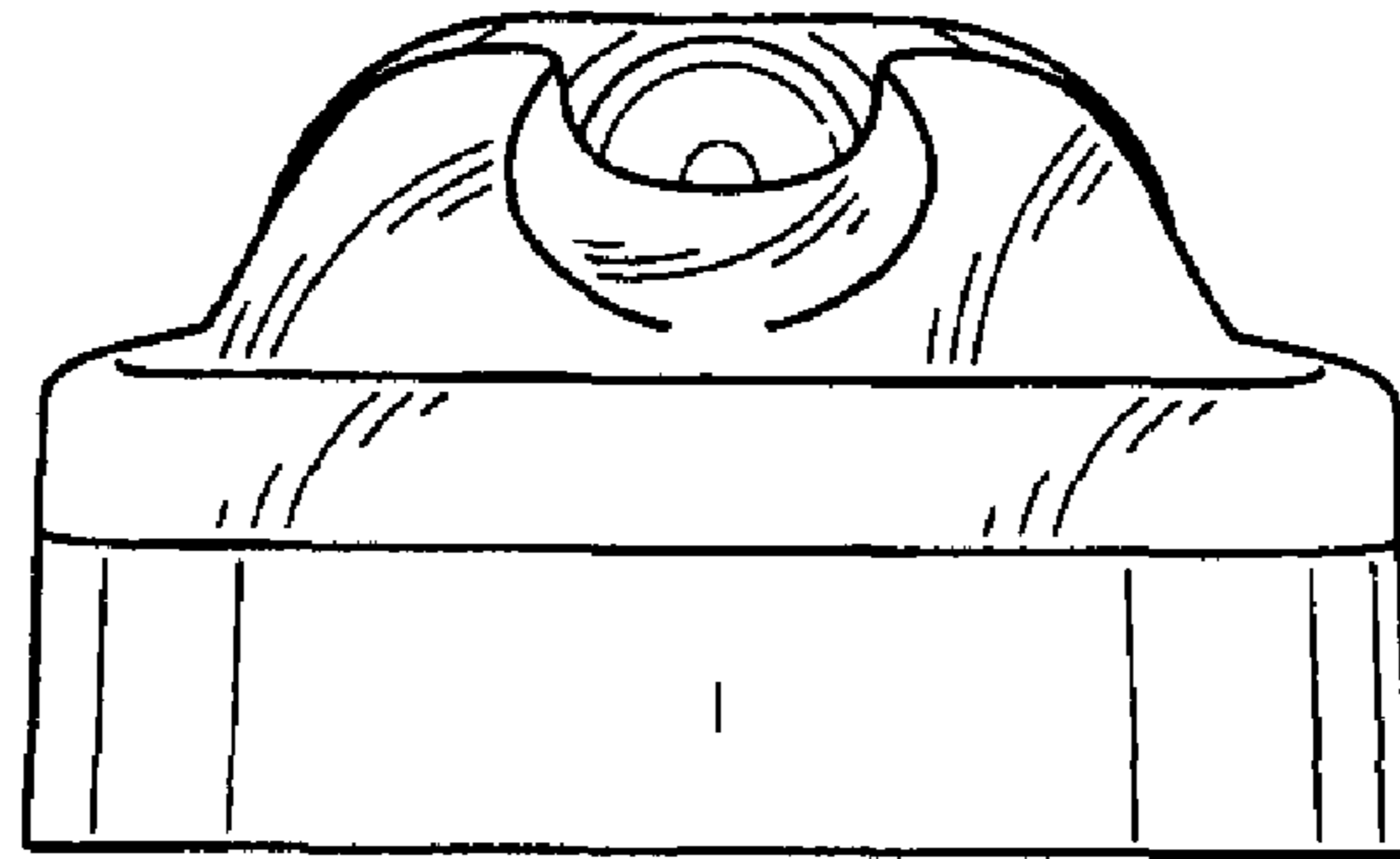

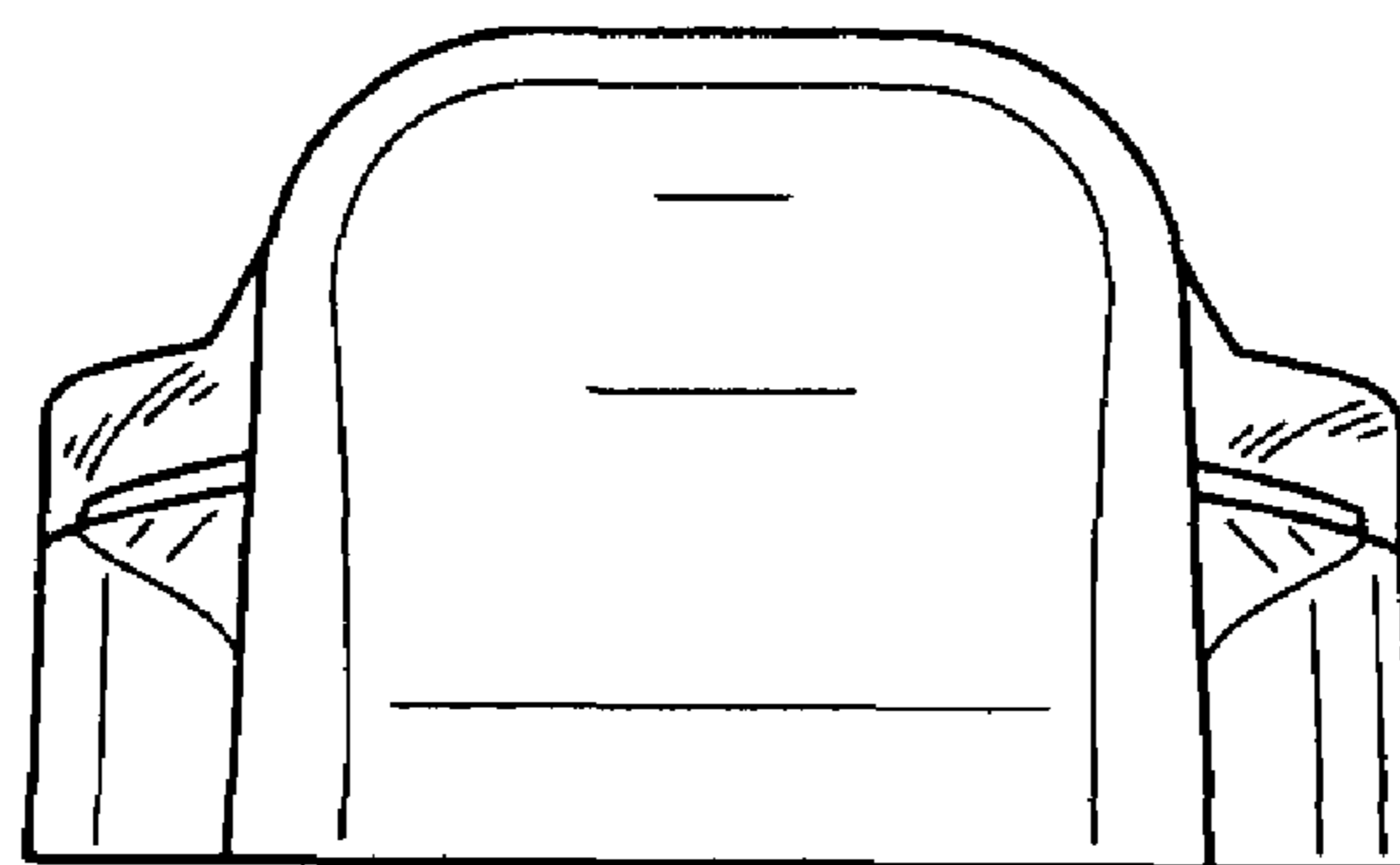

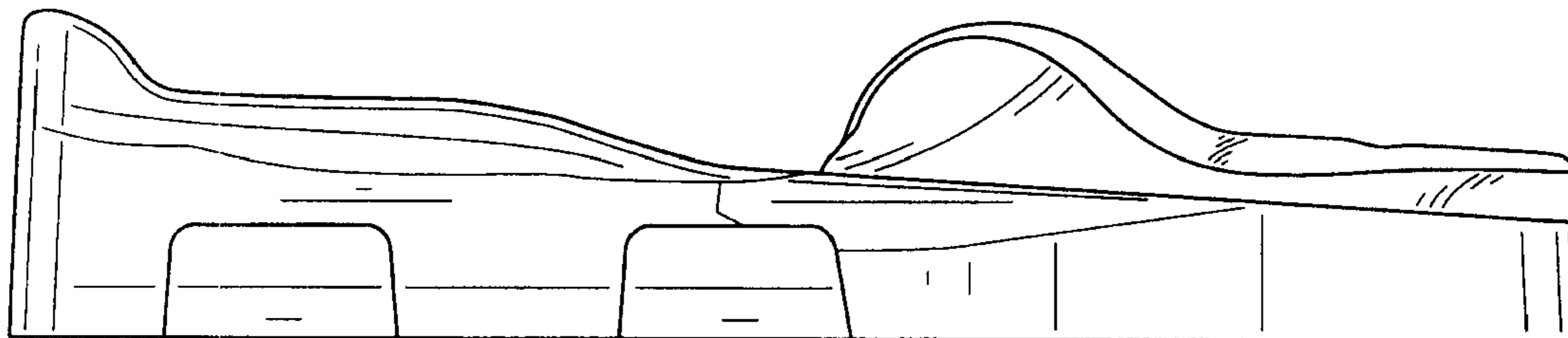

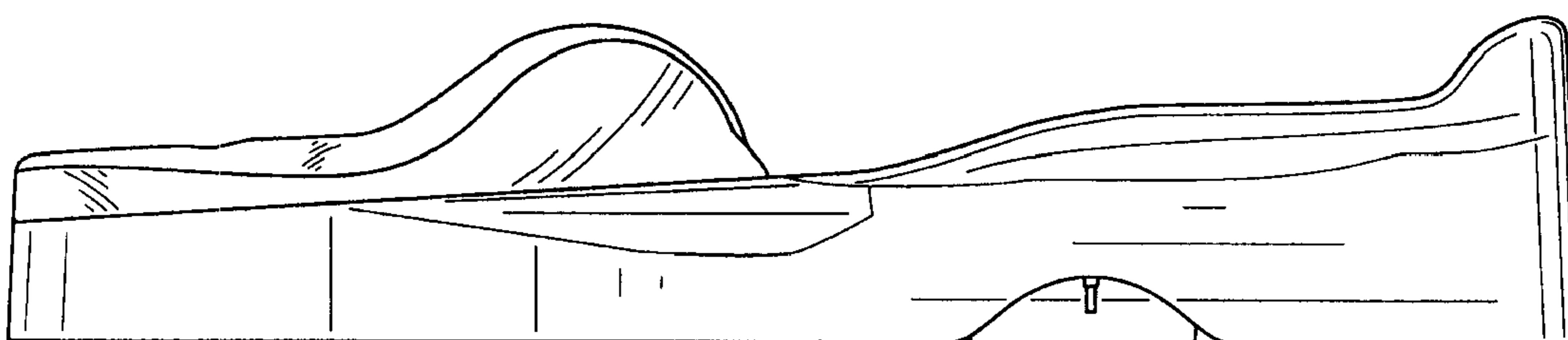

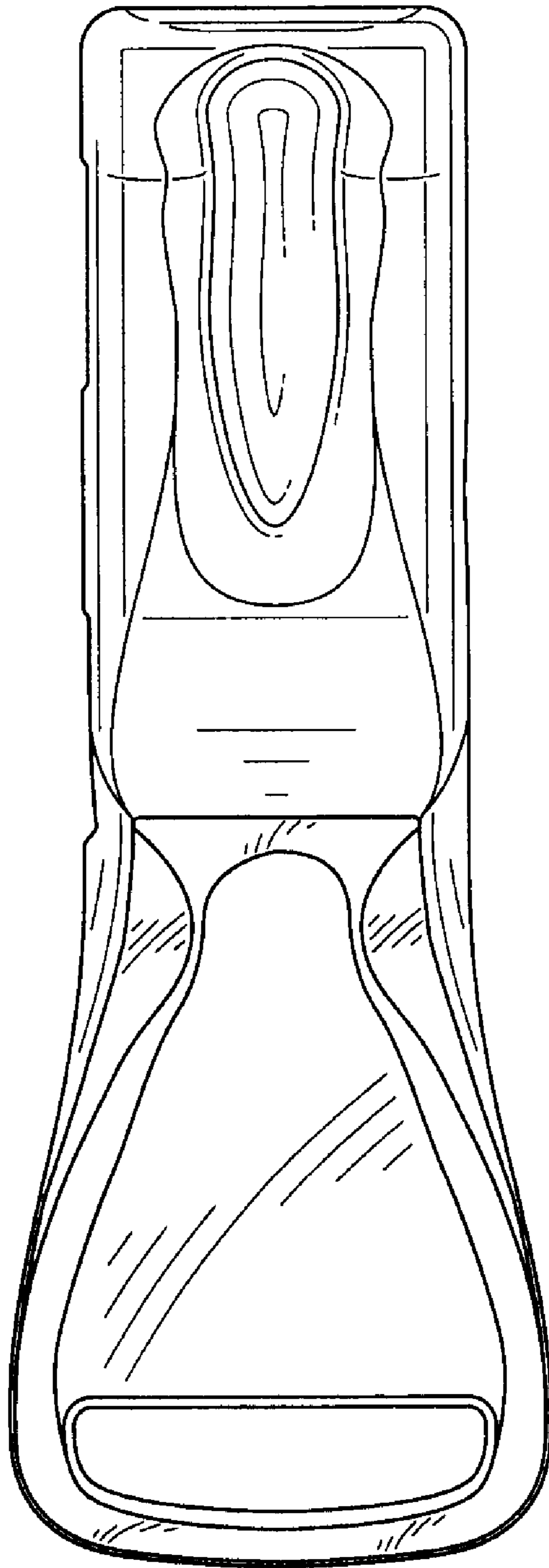

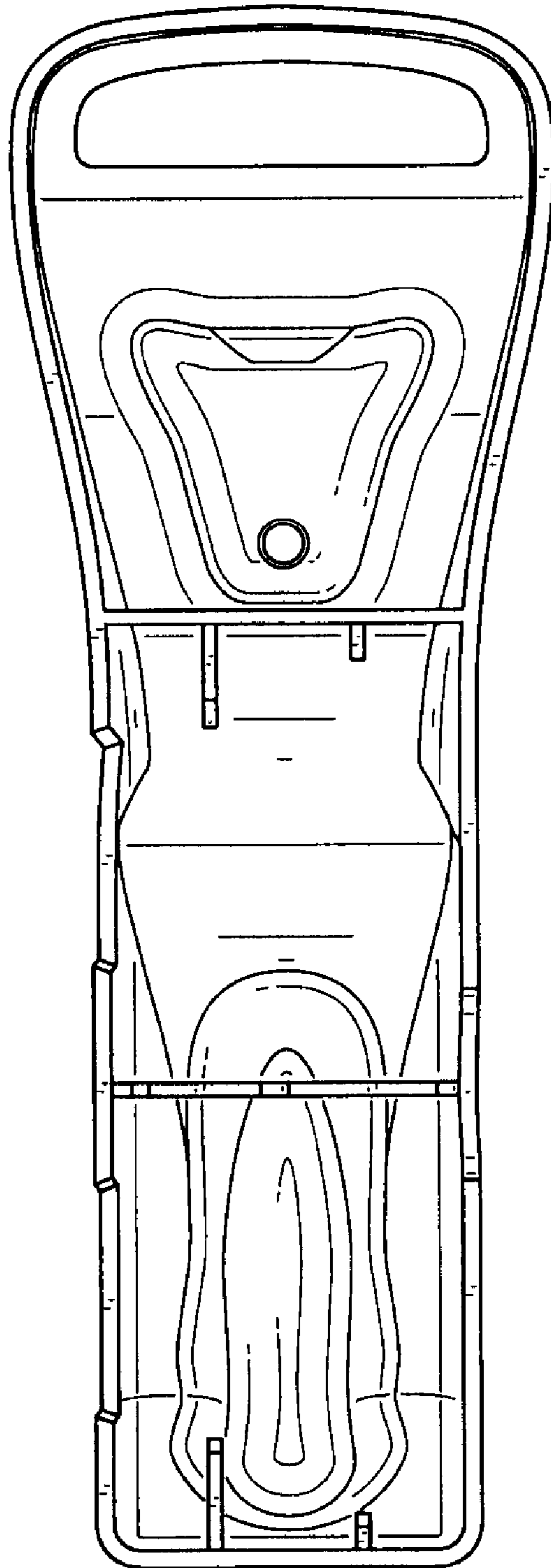

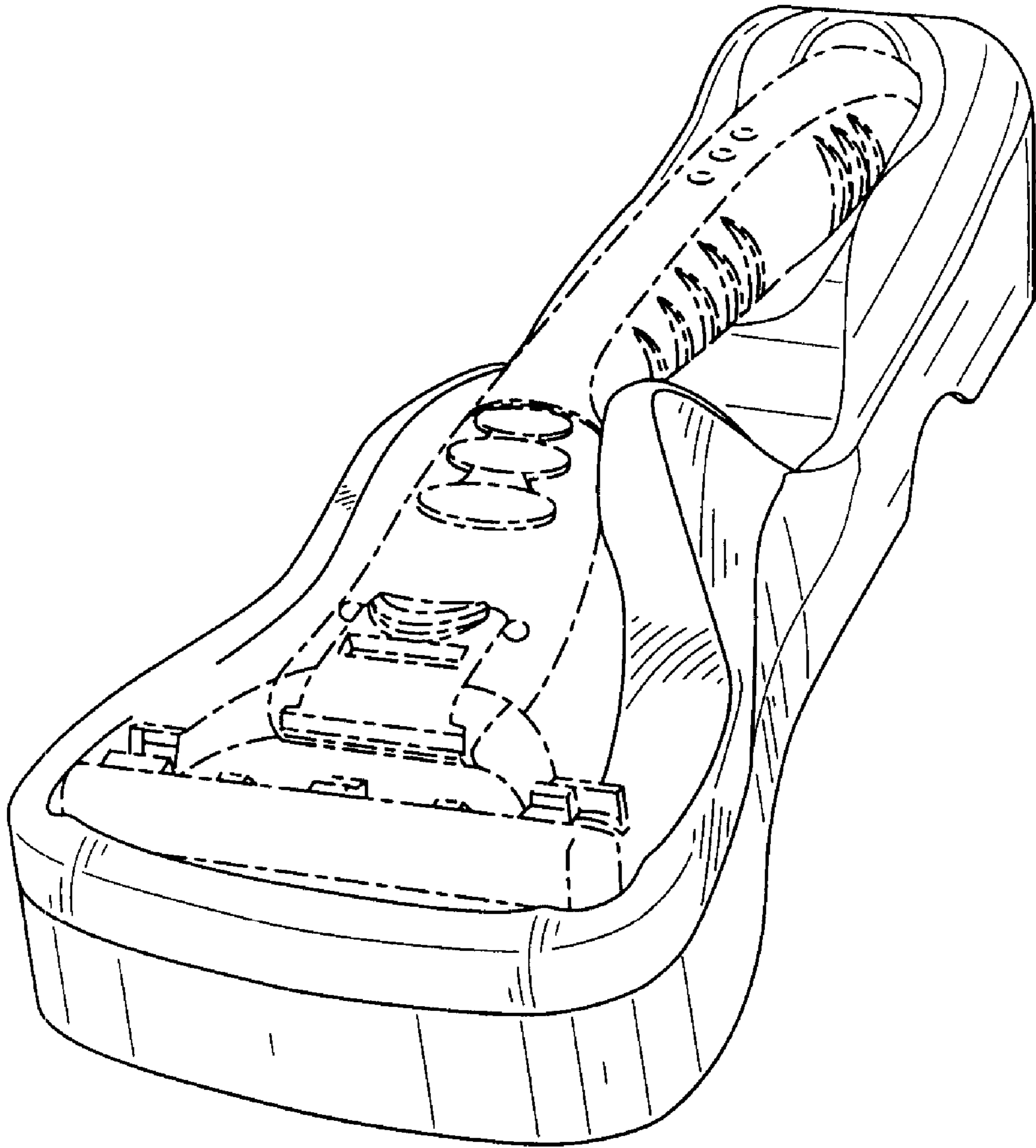
