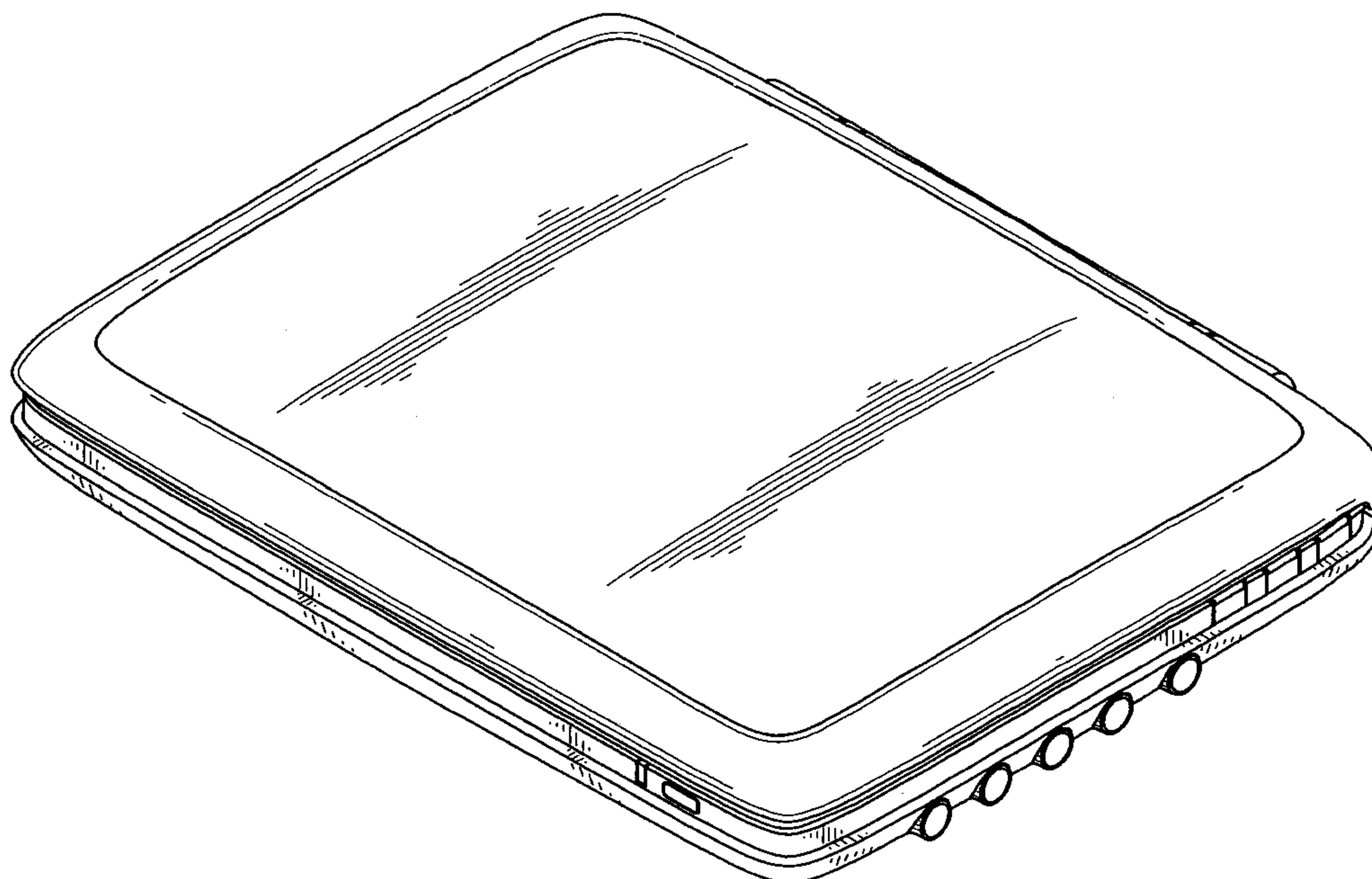
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a digital video disk player showing our new design;

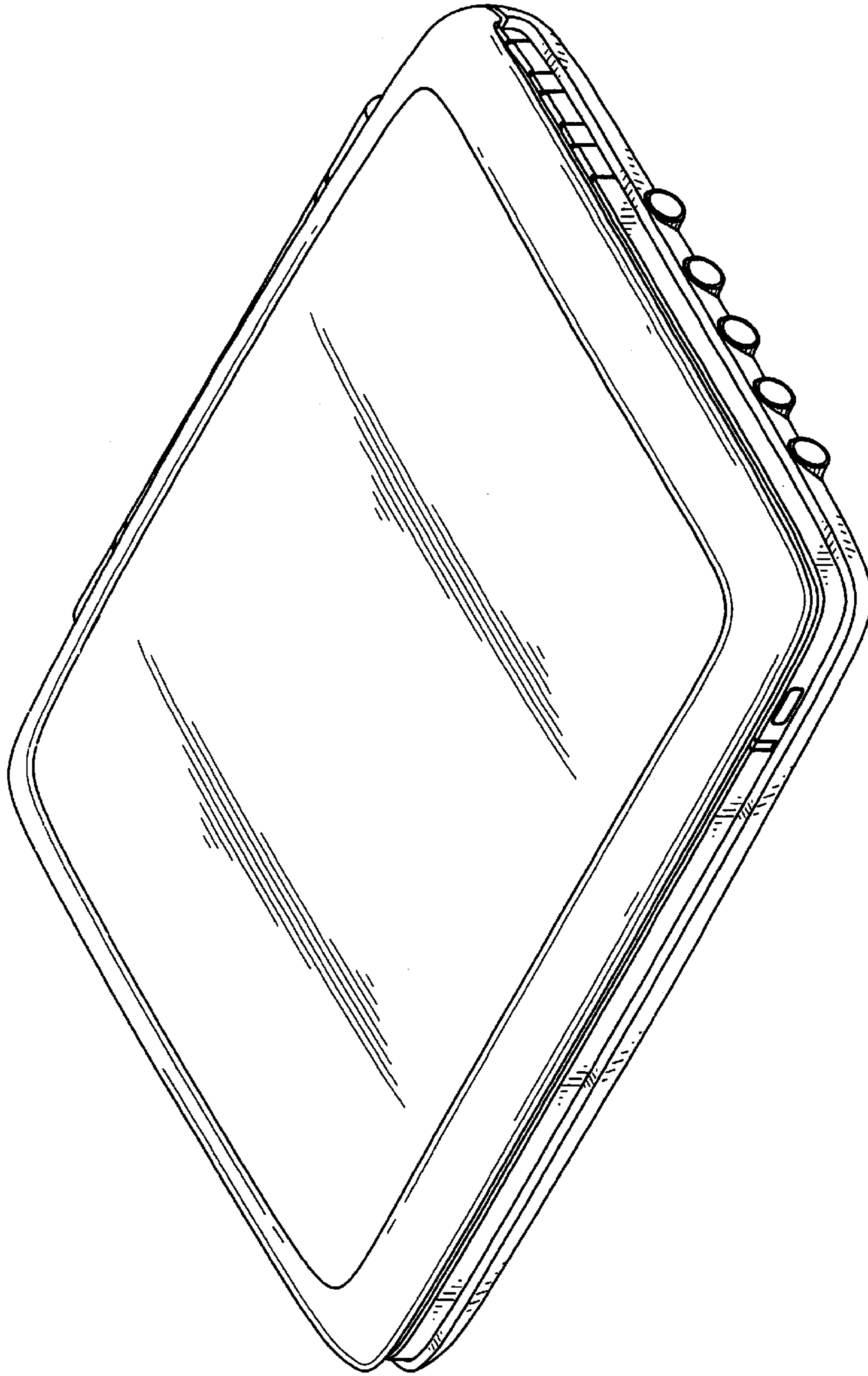

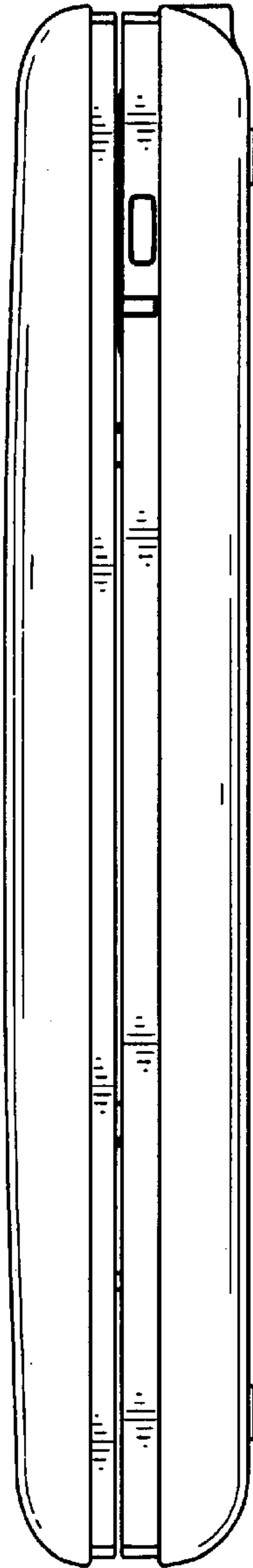

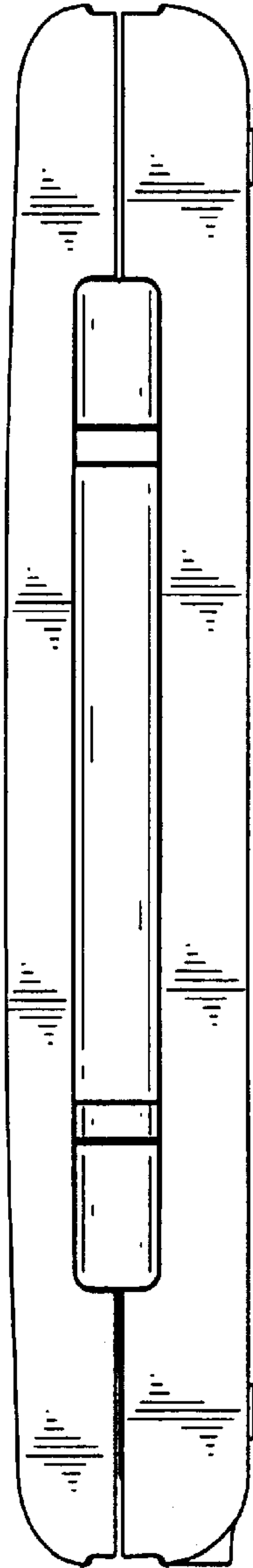

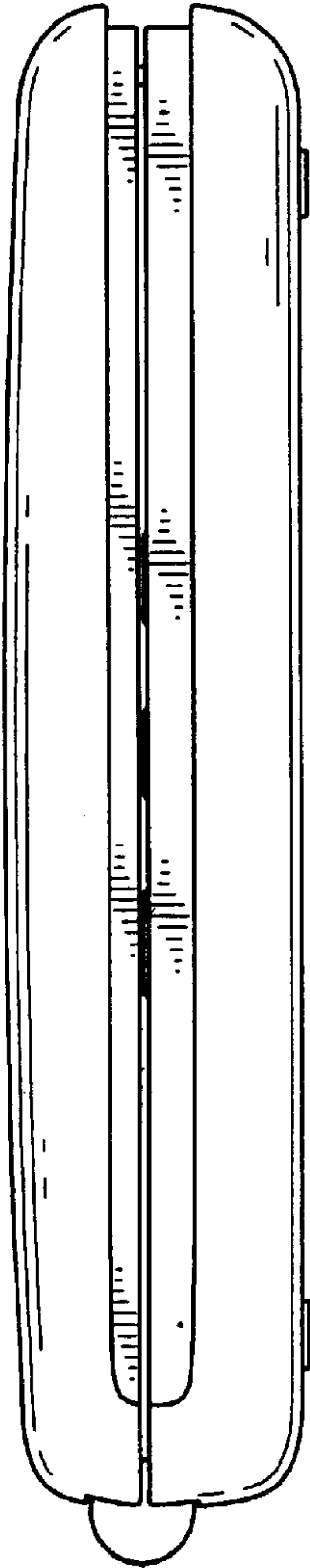

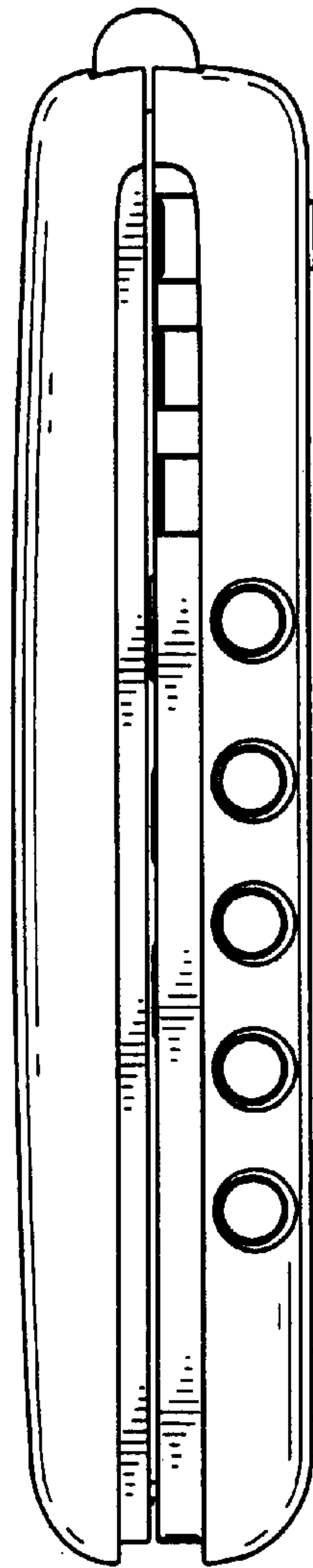

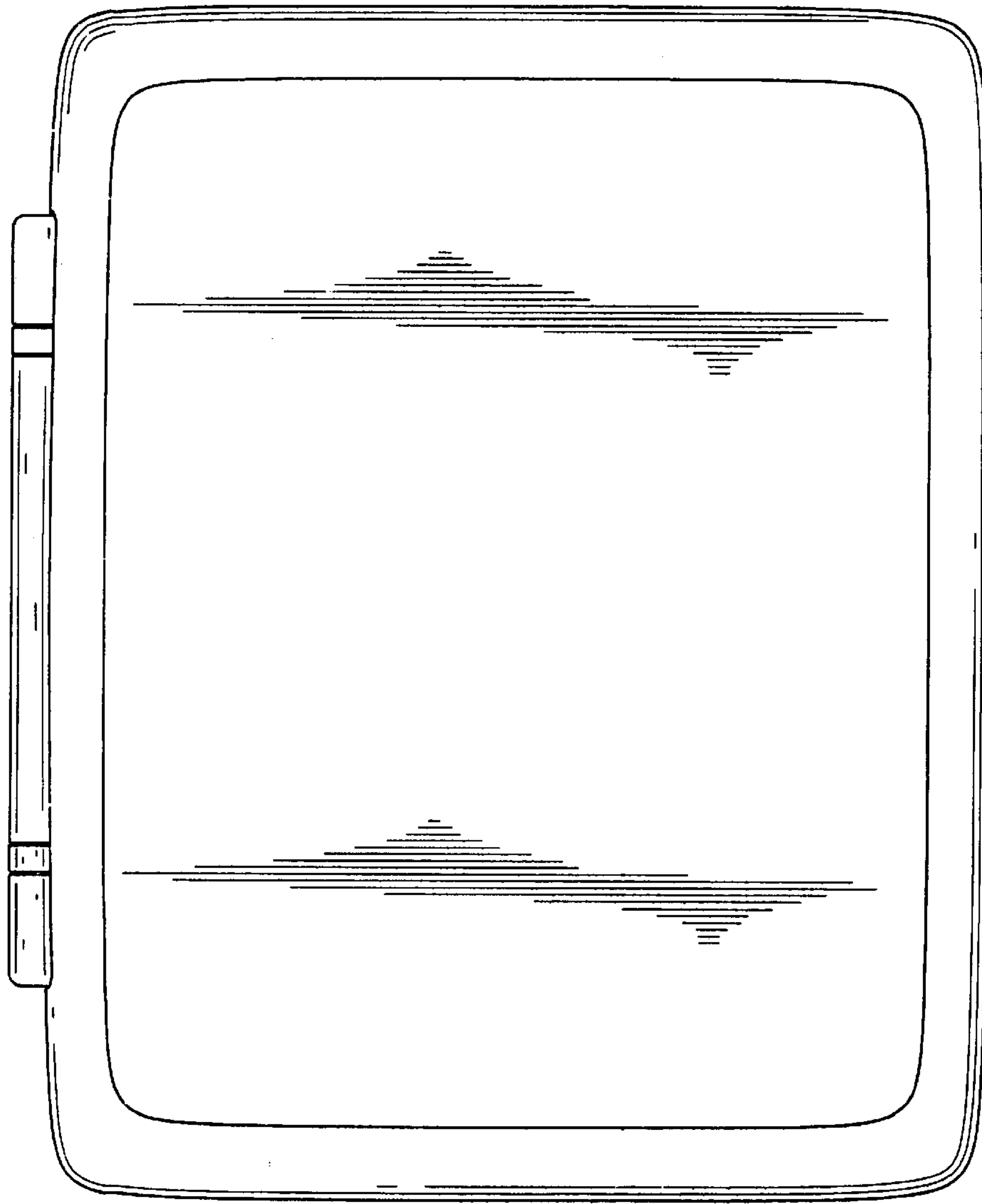

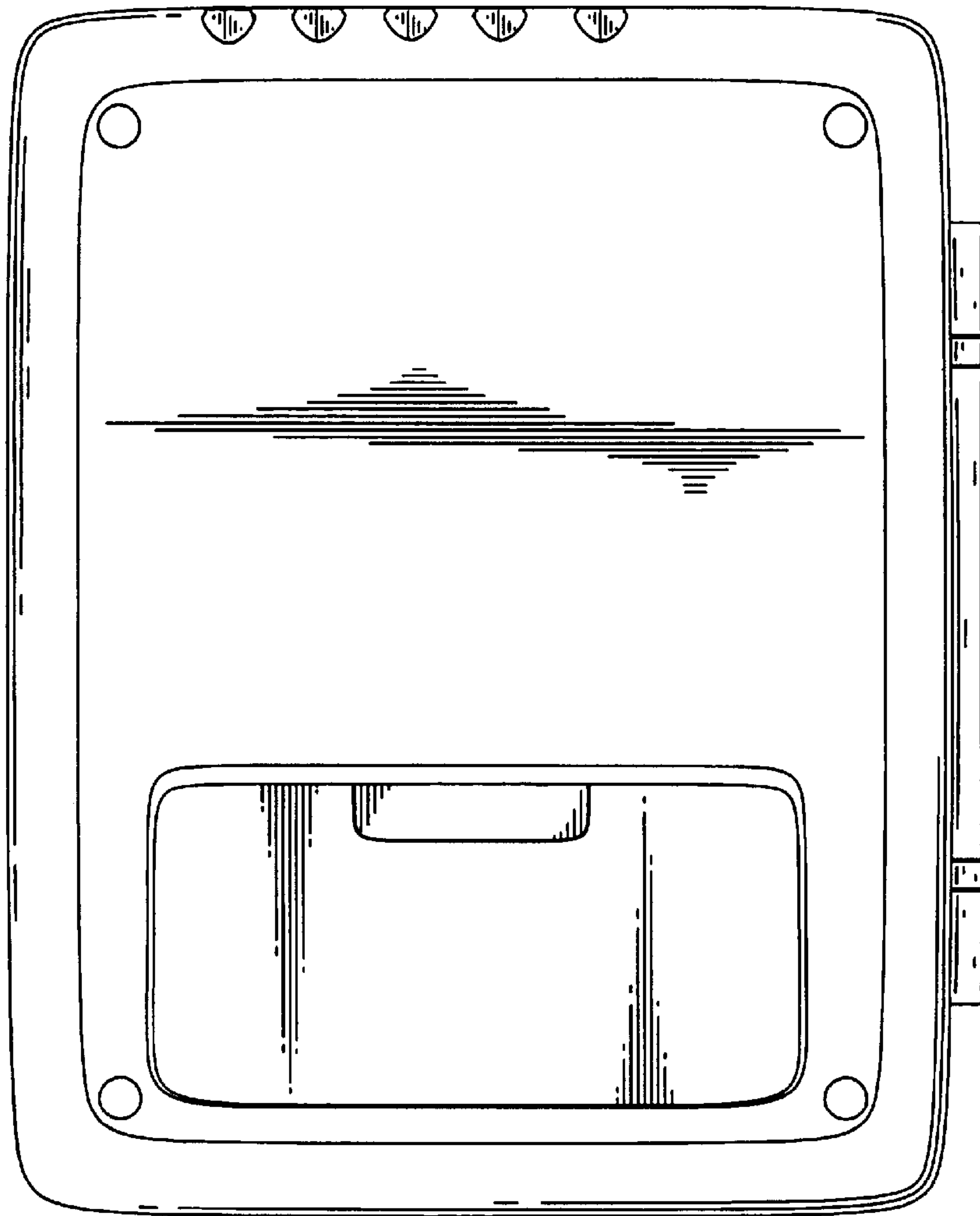

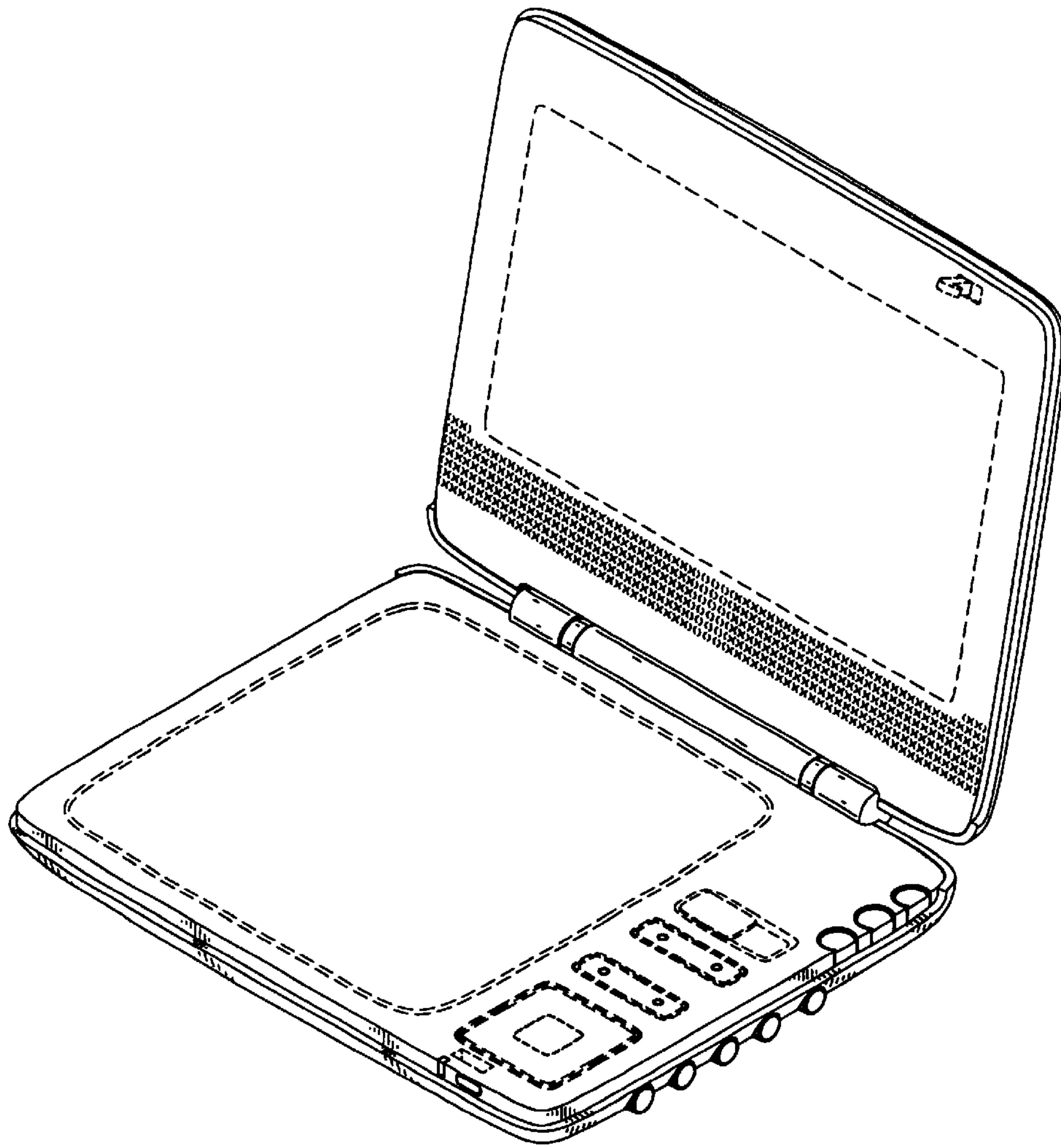
