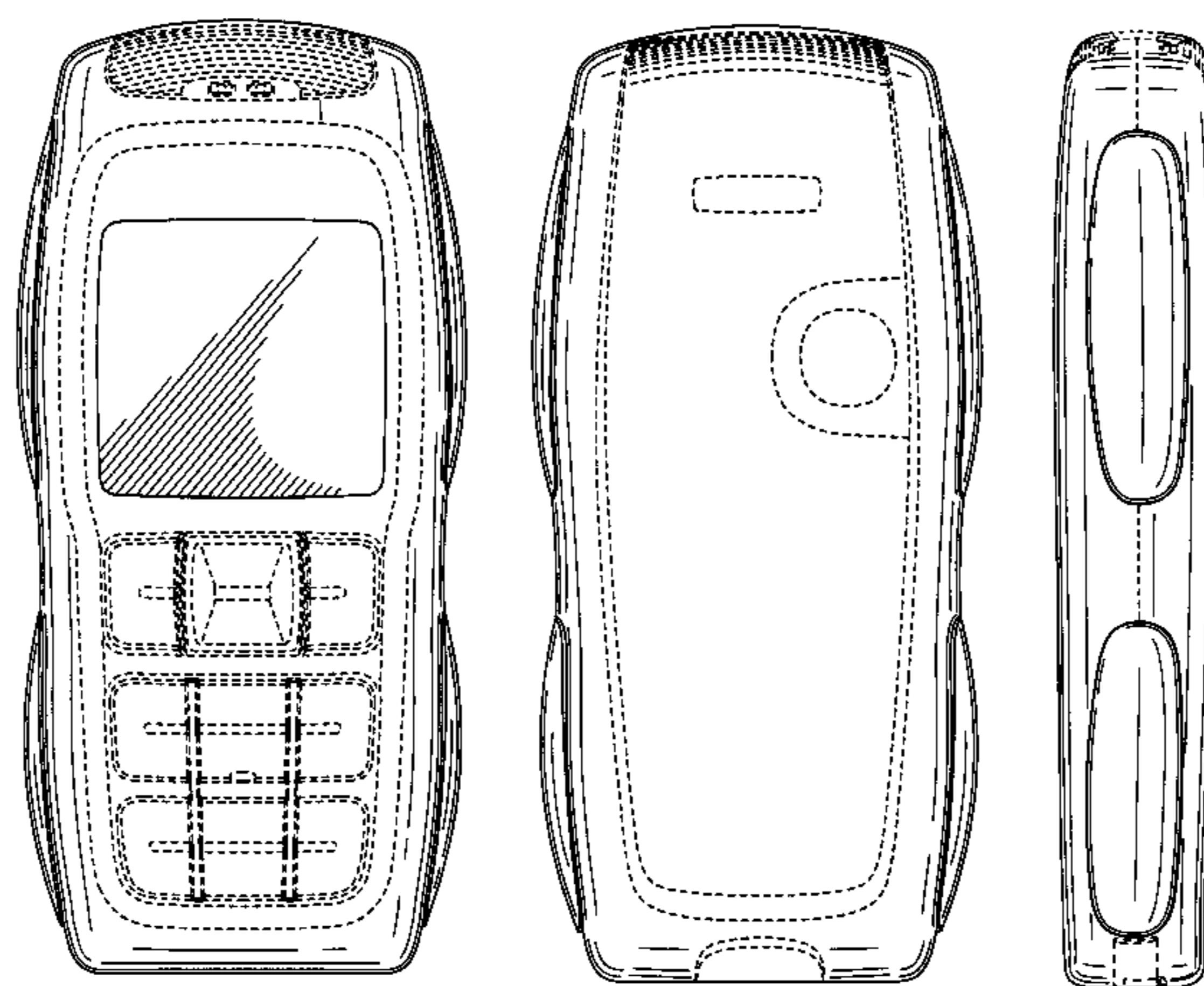
The ornamental design for a body shape of a handset, as shown and described.

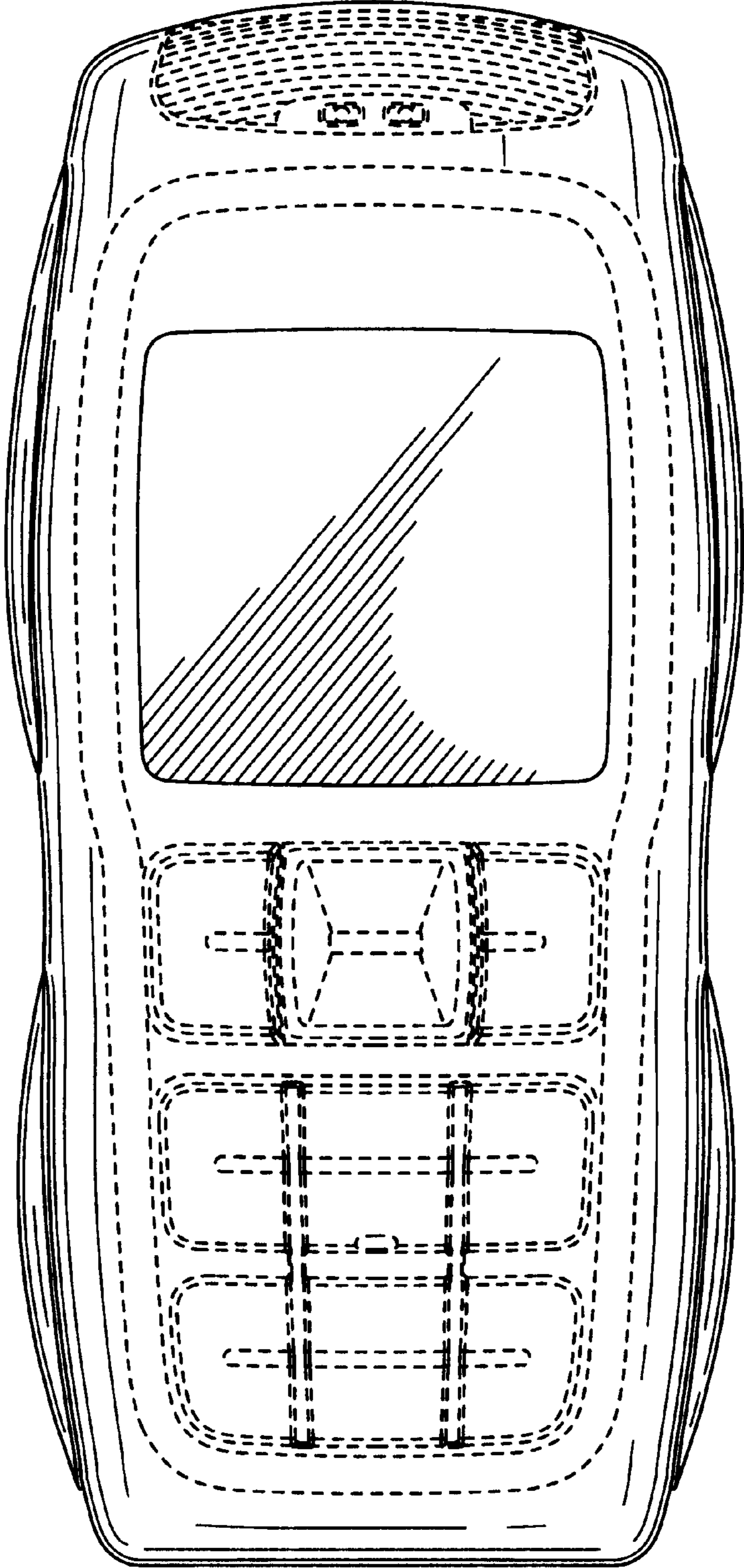

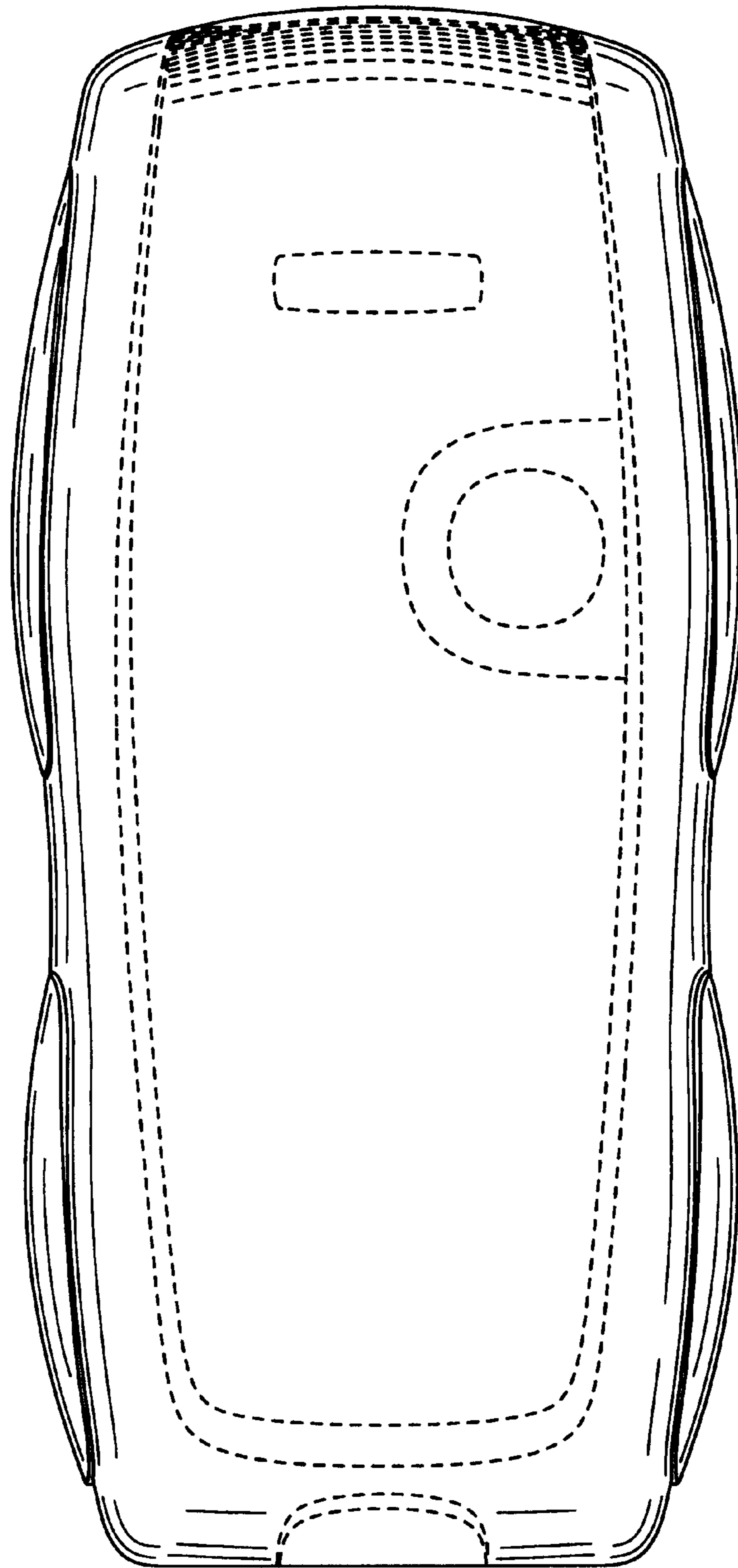

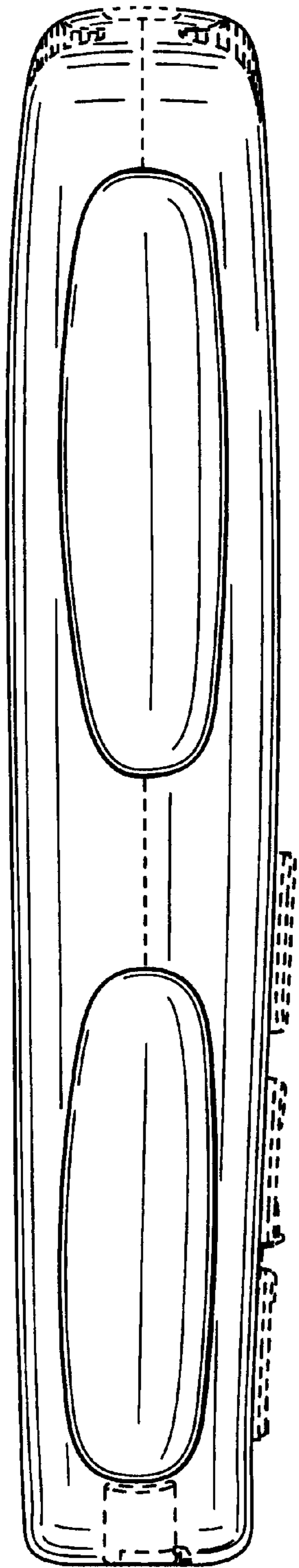

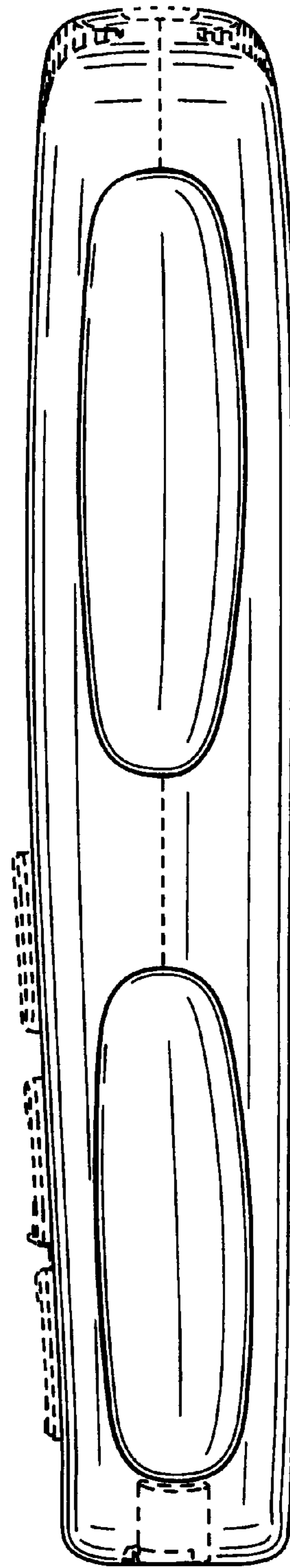

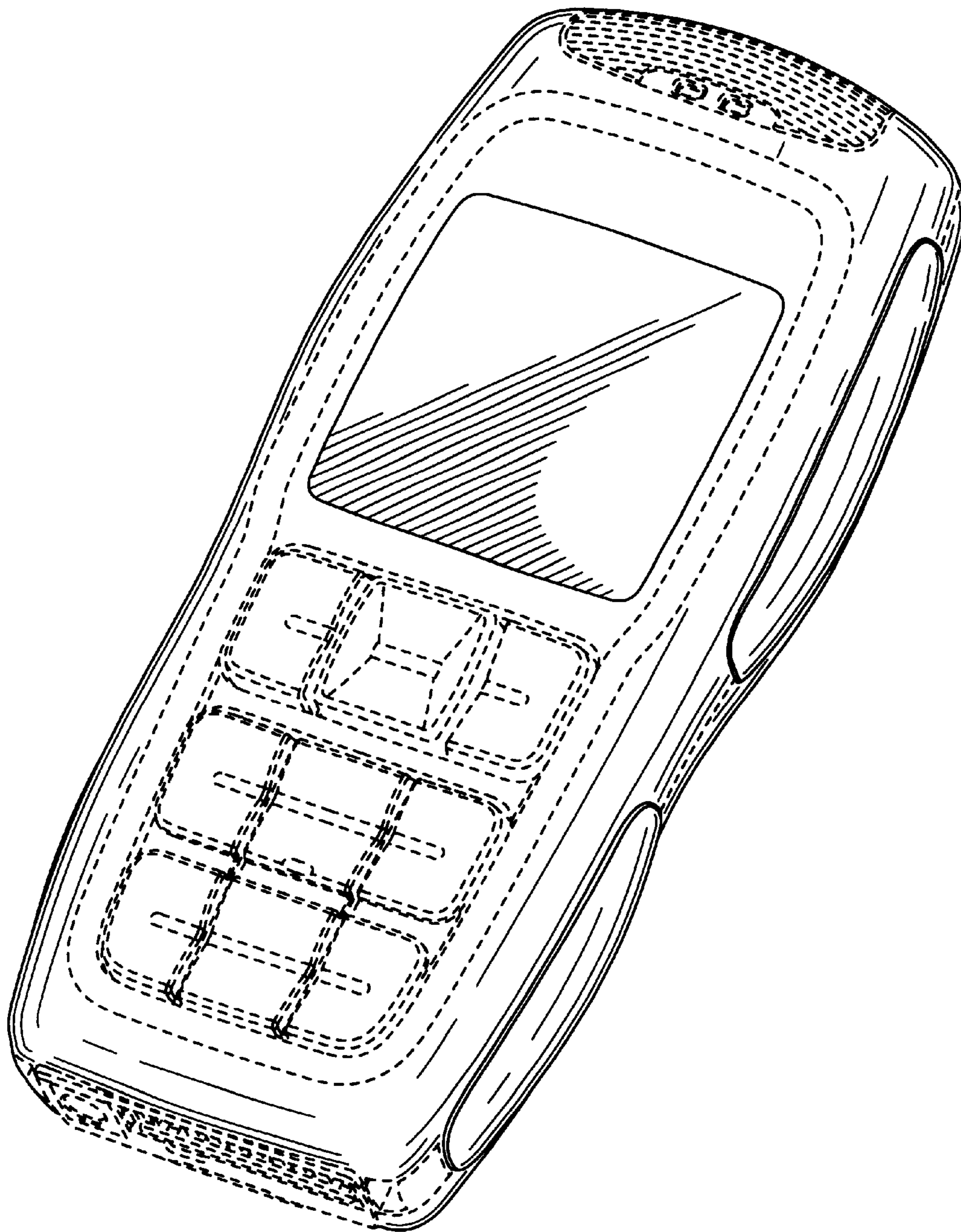

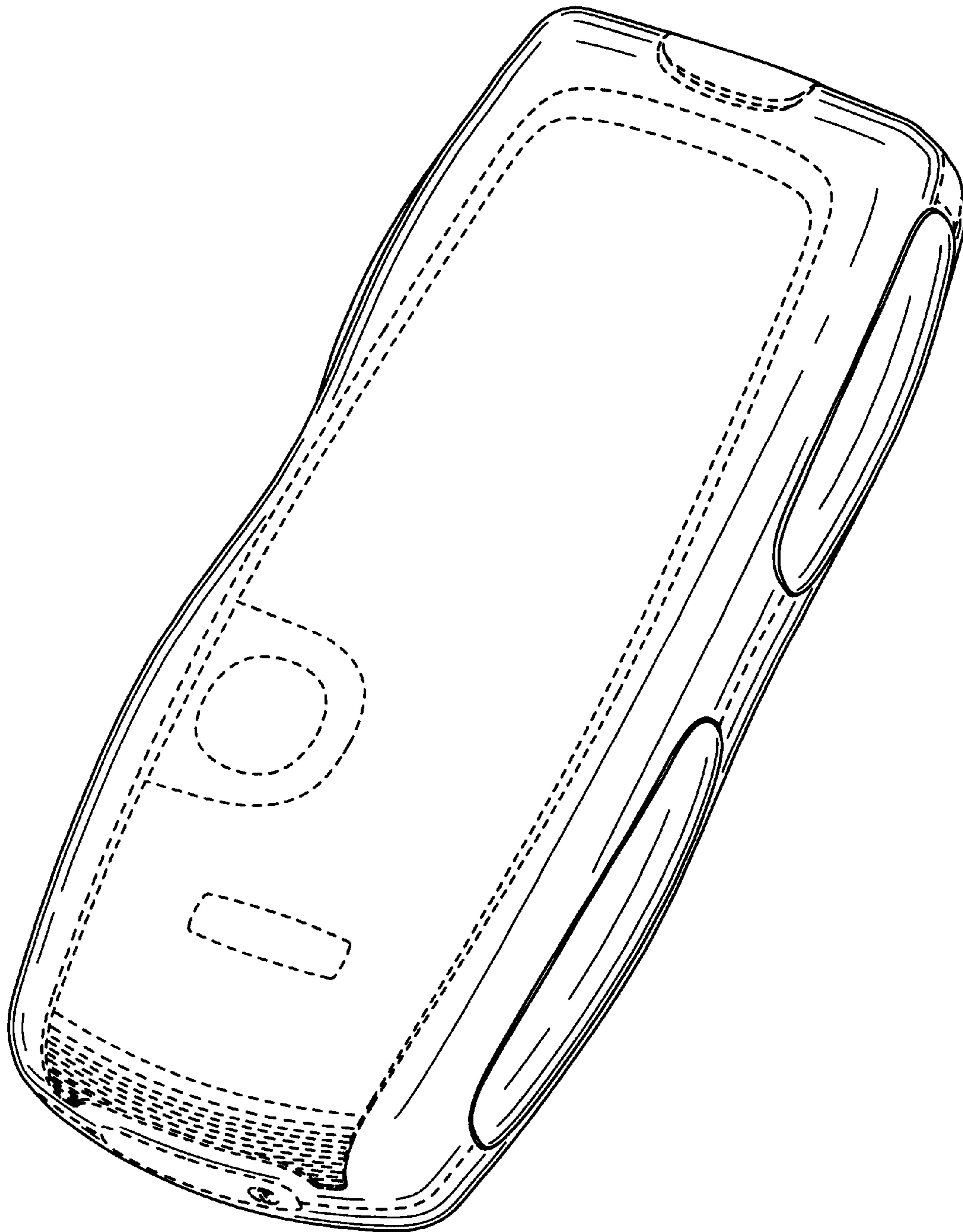
