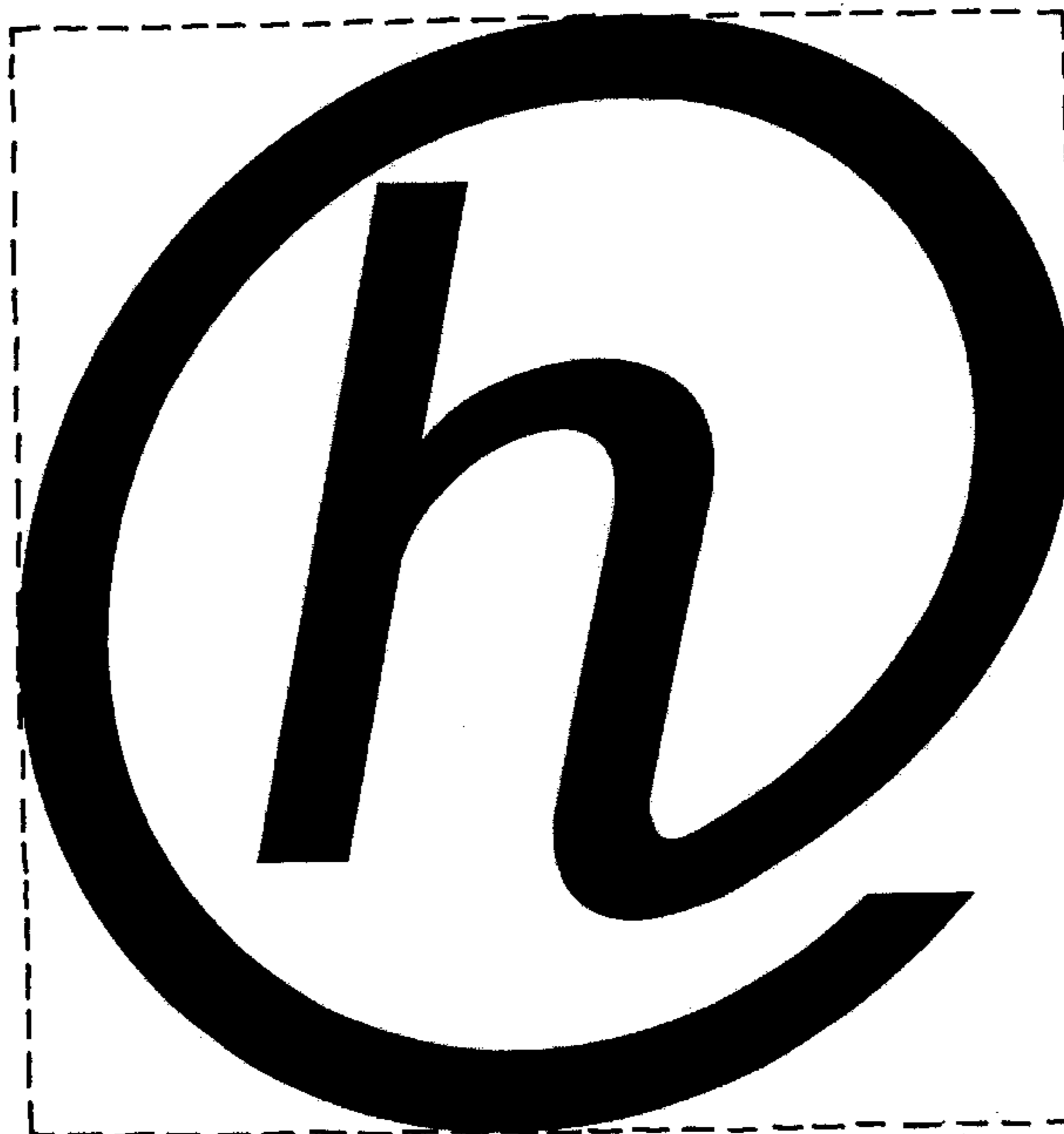

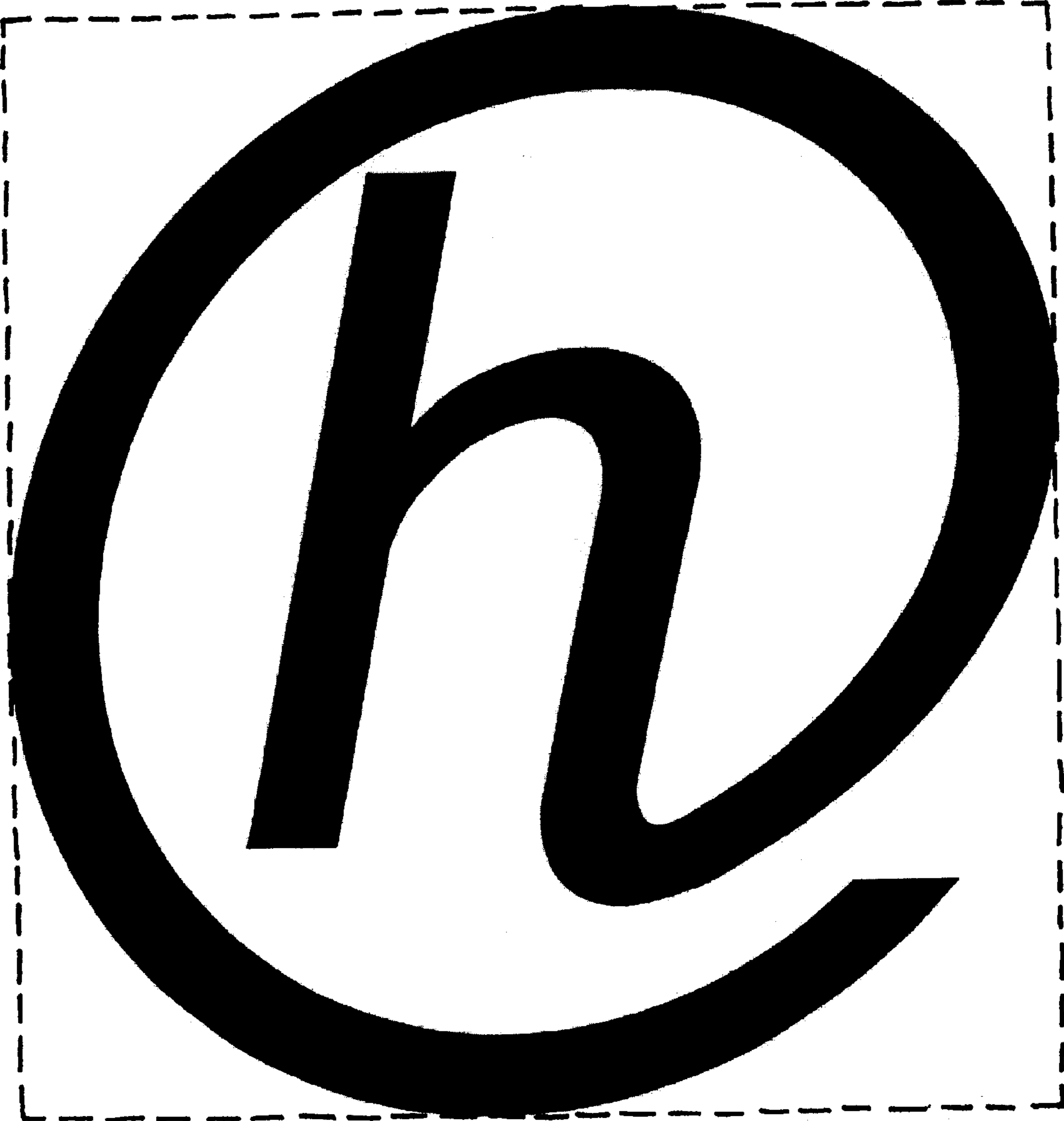
The ornamental design for a computer generated icon for a screen, as shown and described.
