FIG. 8 is a reduced side elevational view showing the X-shaped header for an internal combustion engine in use.

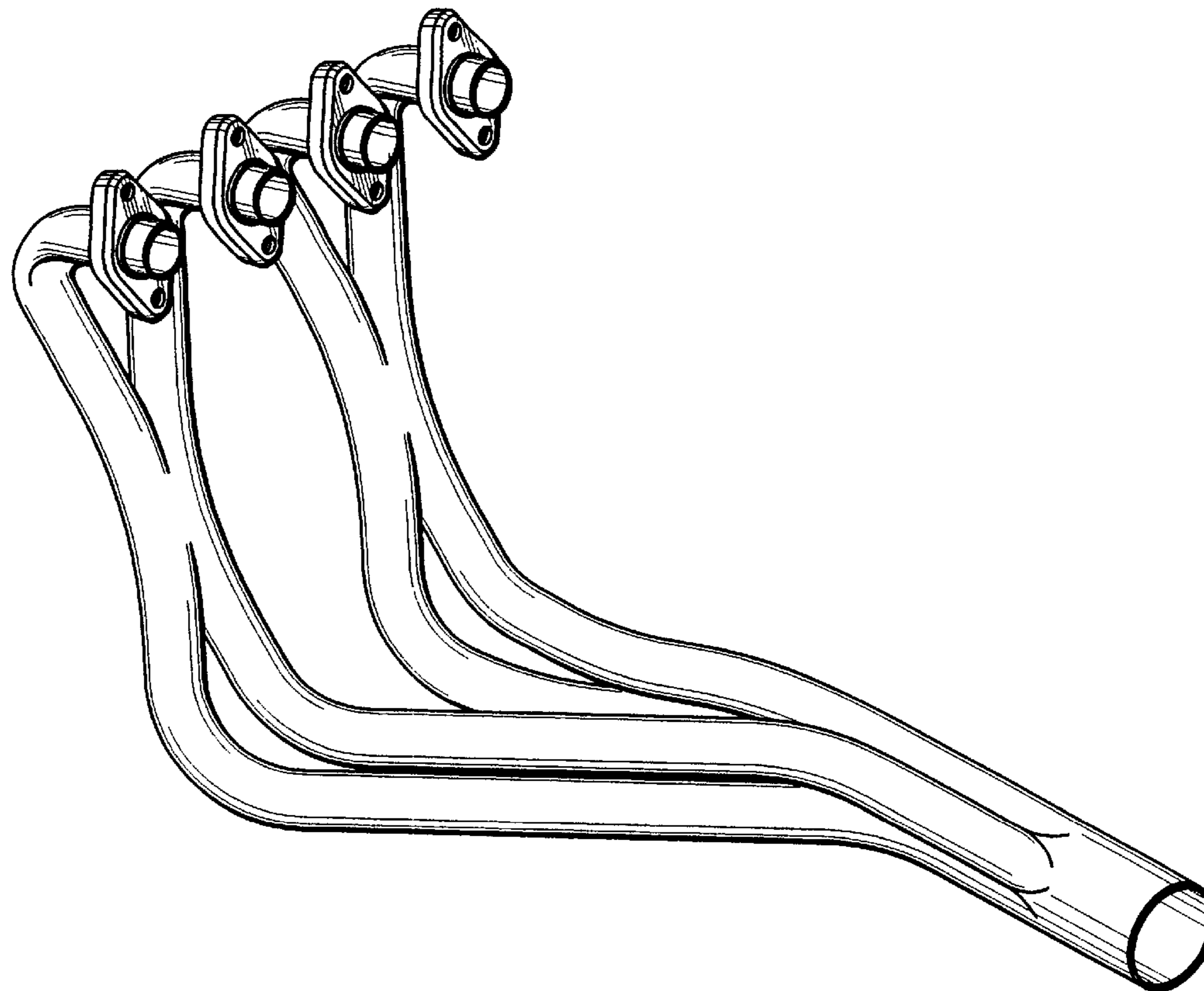
The broken line in FIG. 8 depicts environmental structure for illustrative purposes only and forms no part of the claimed design.

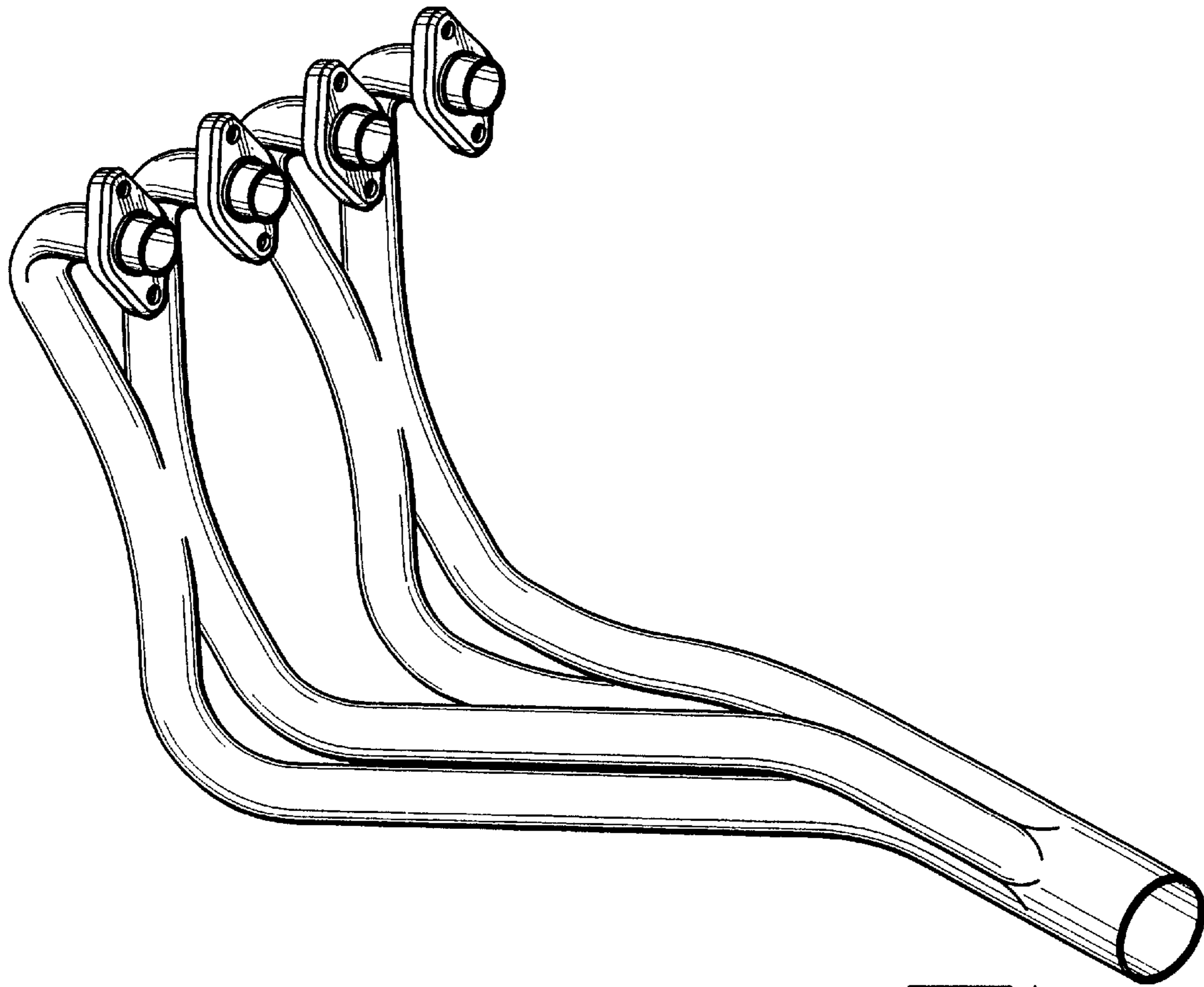

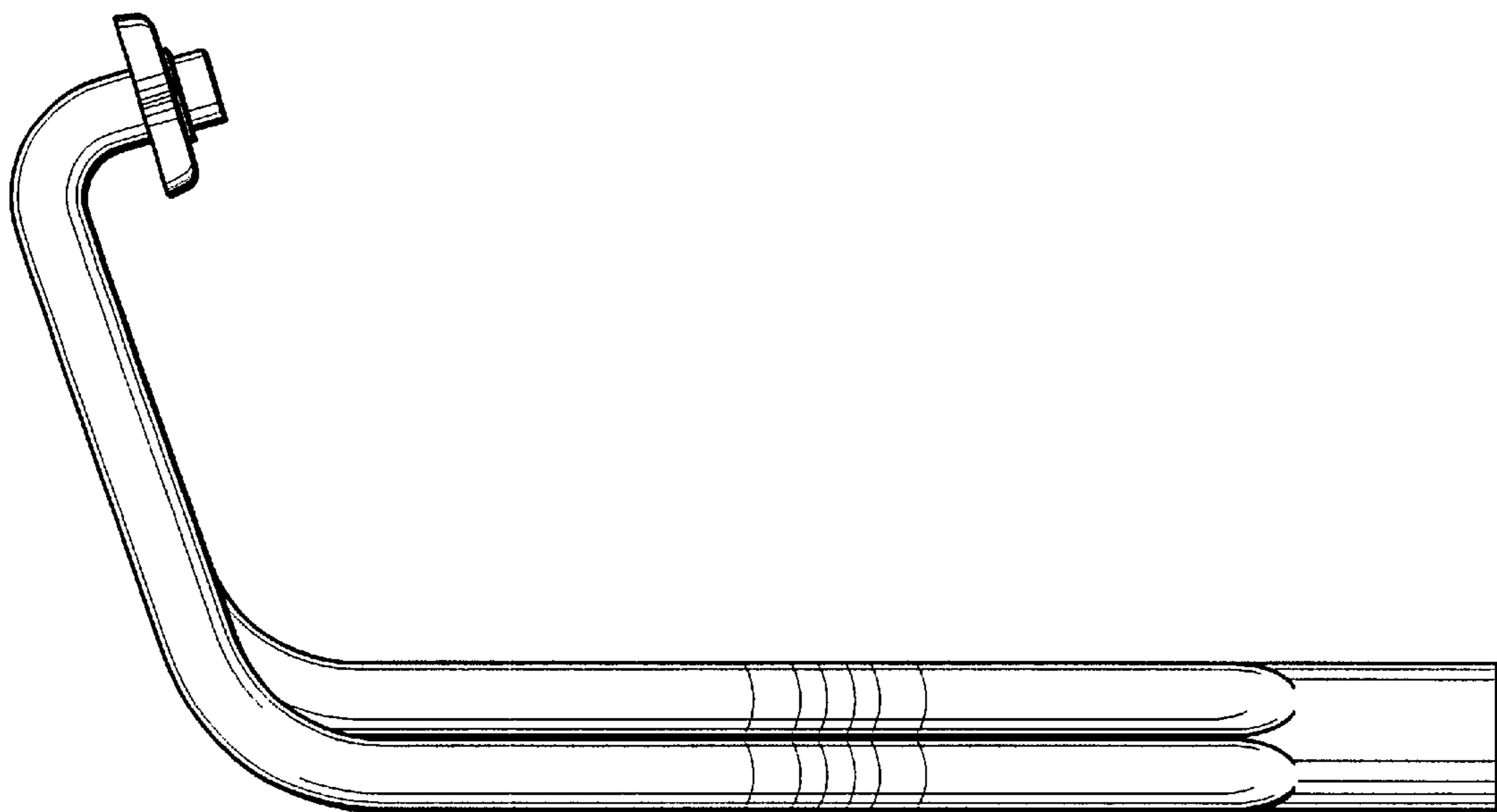

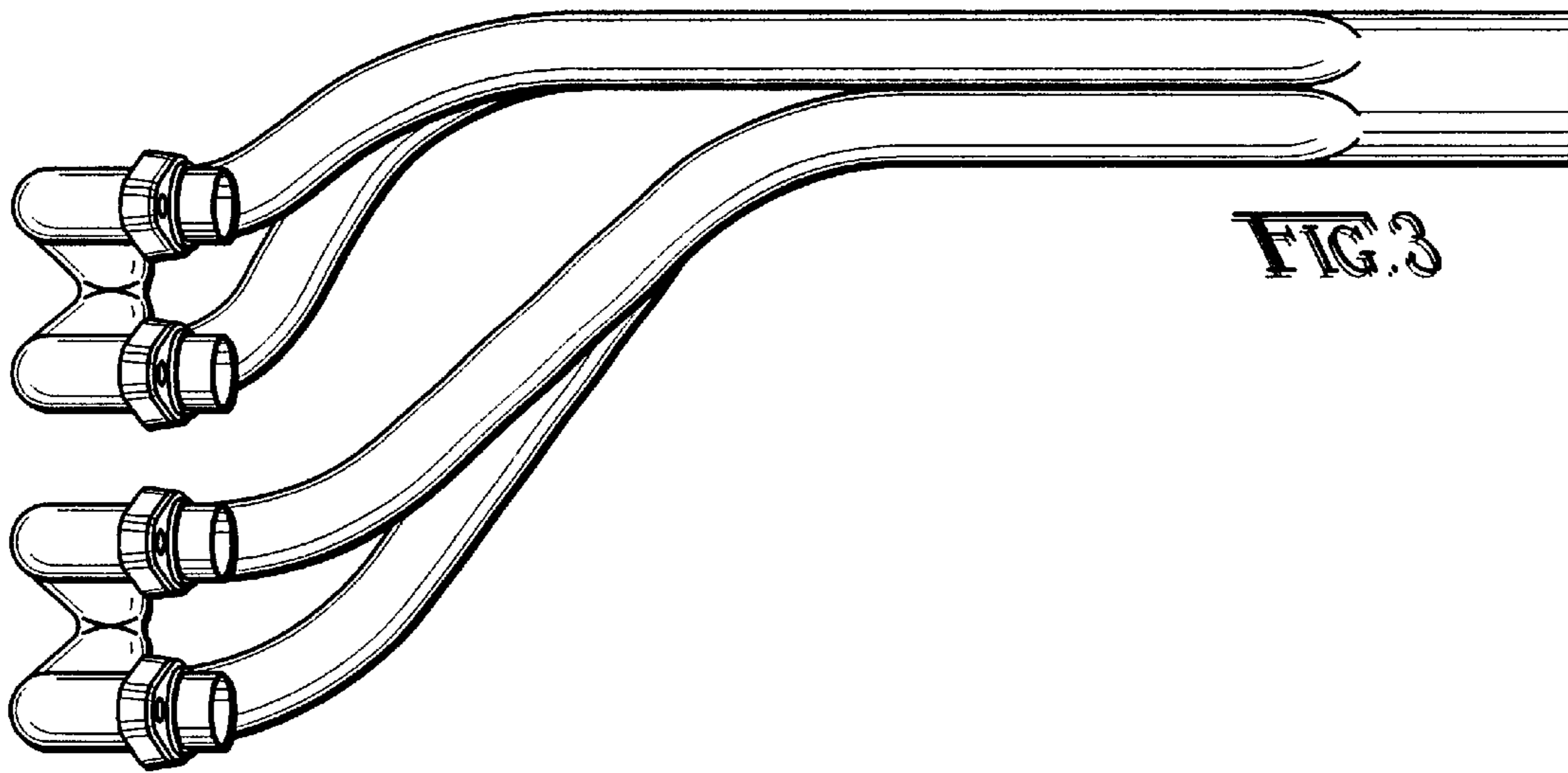

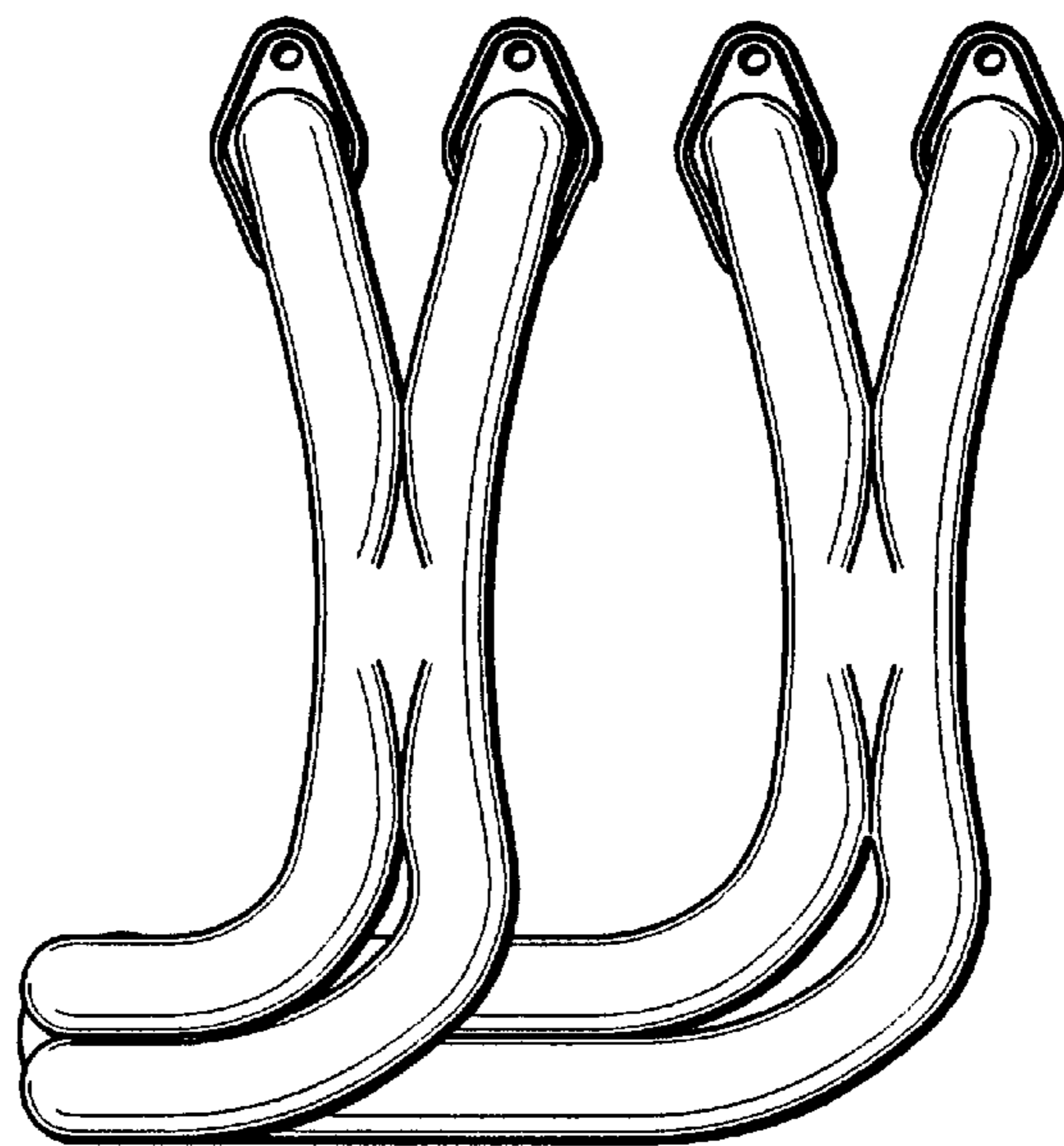

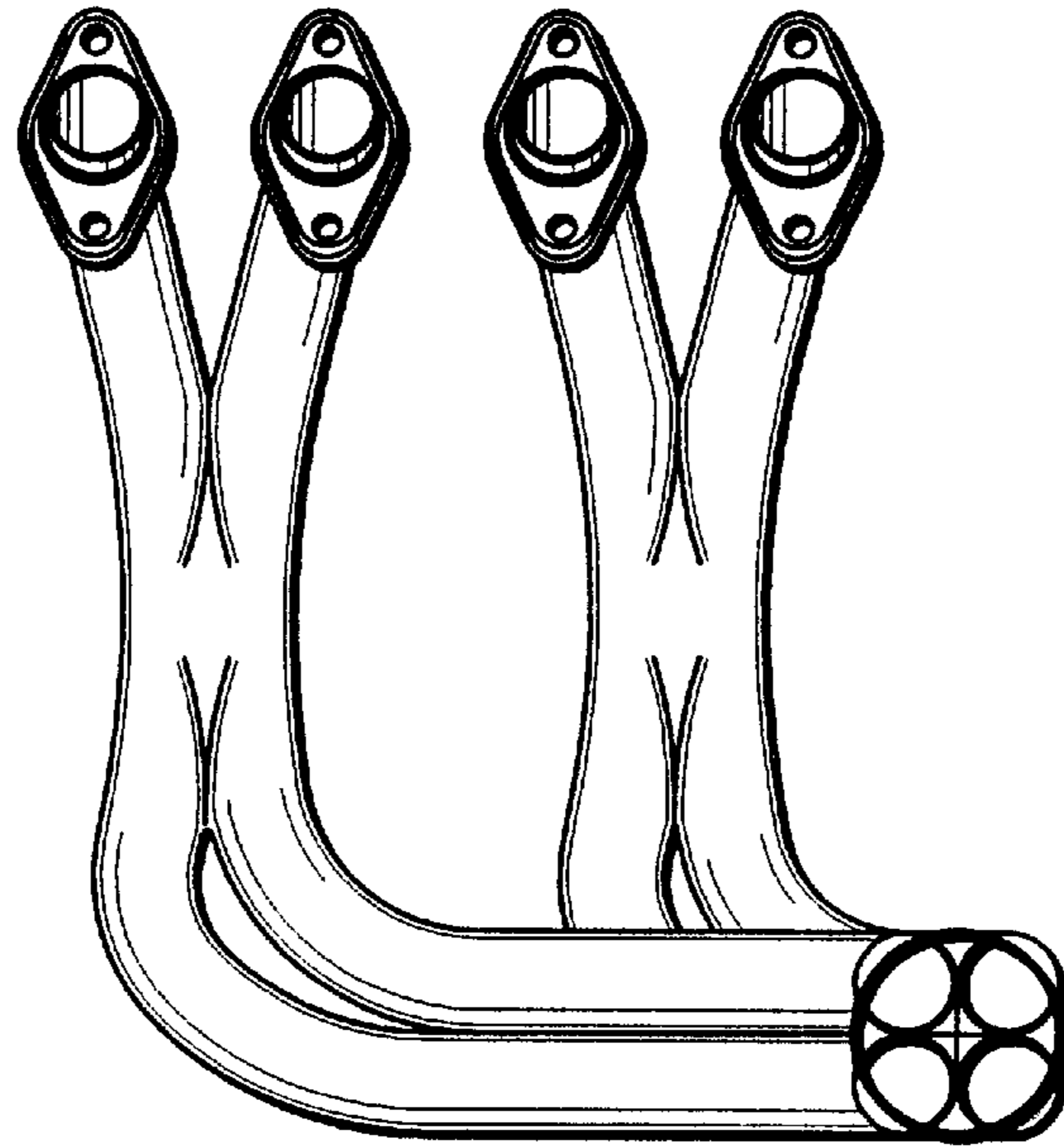

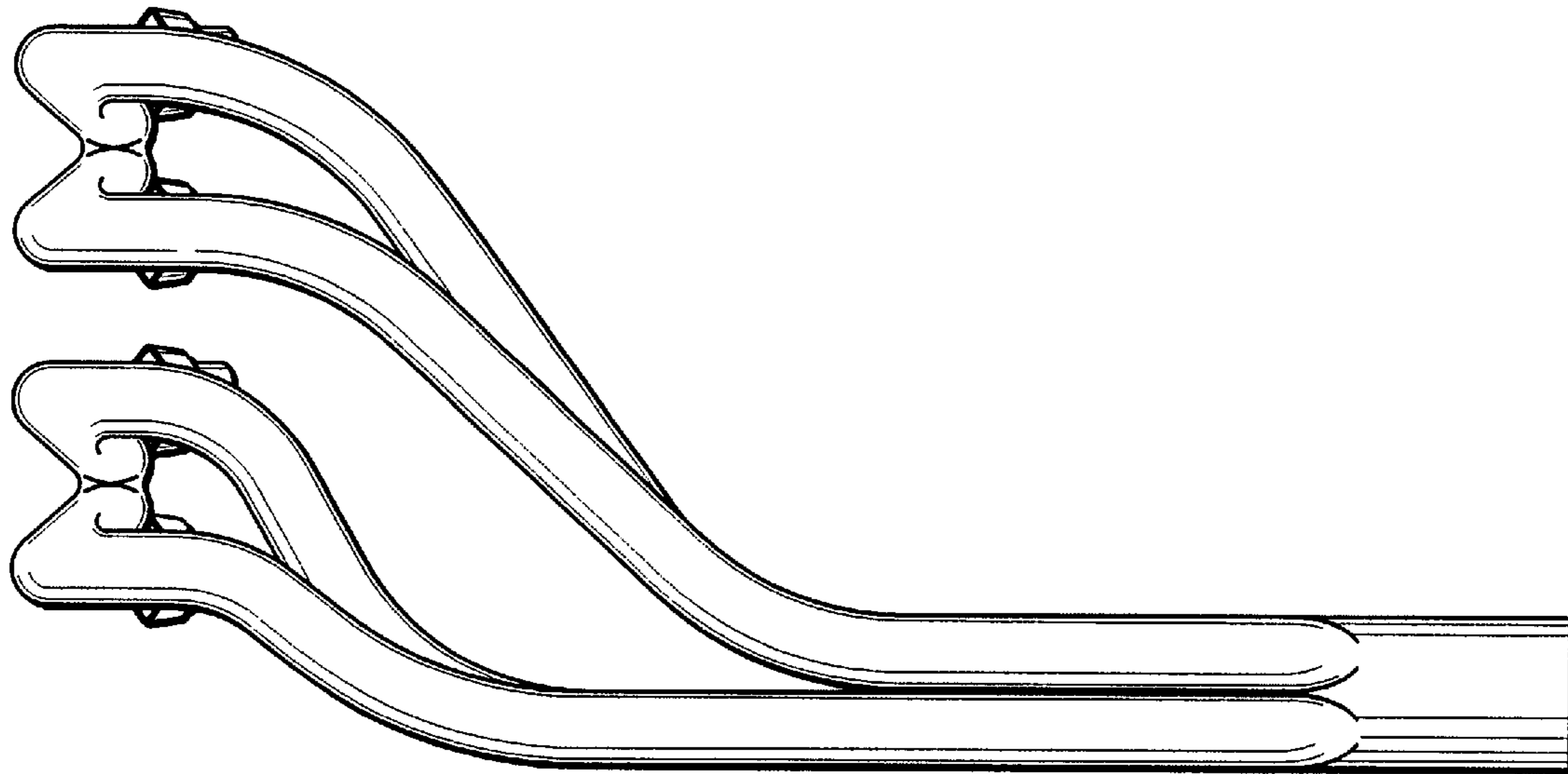

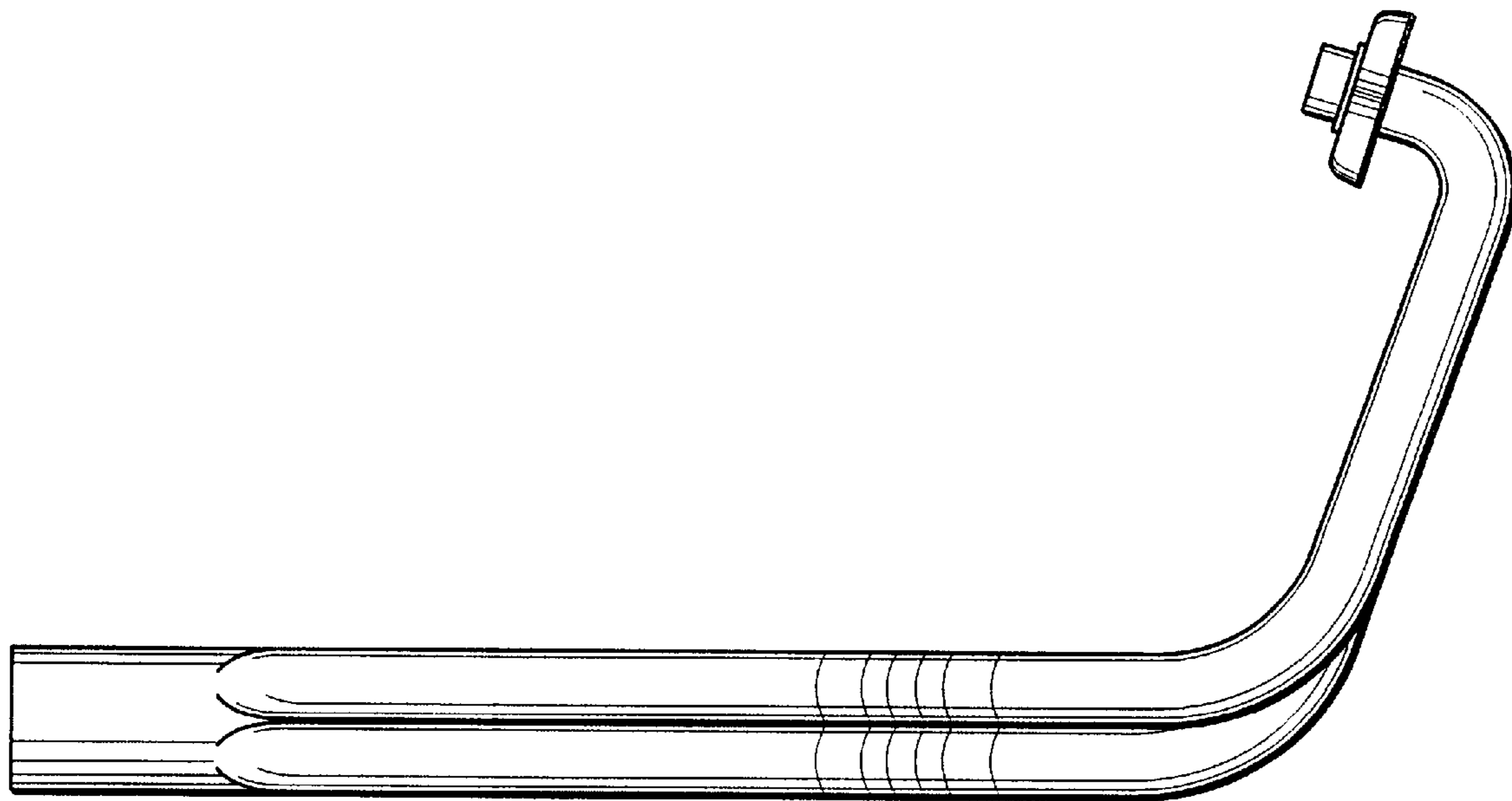

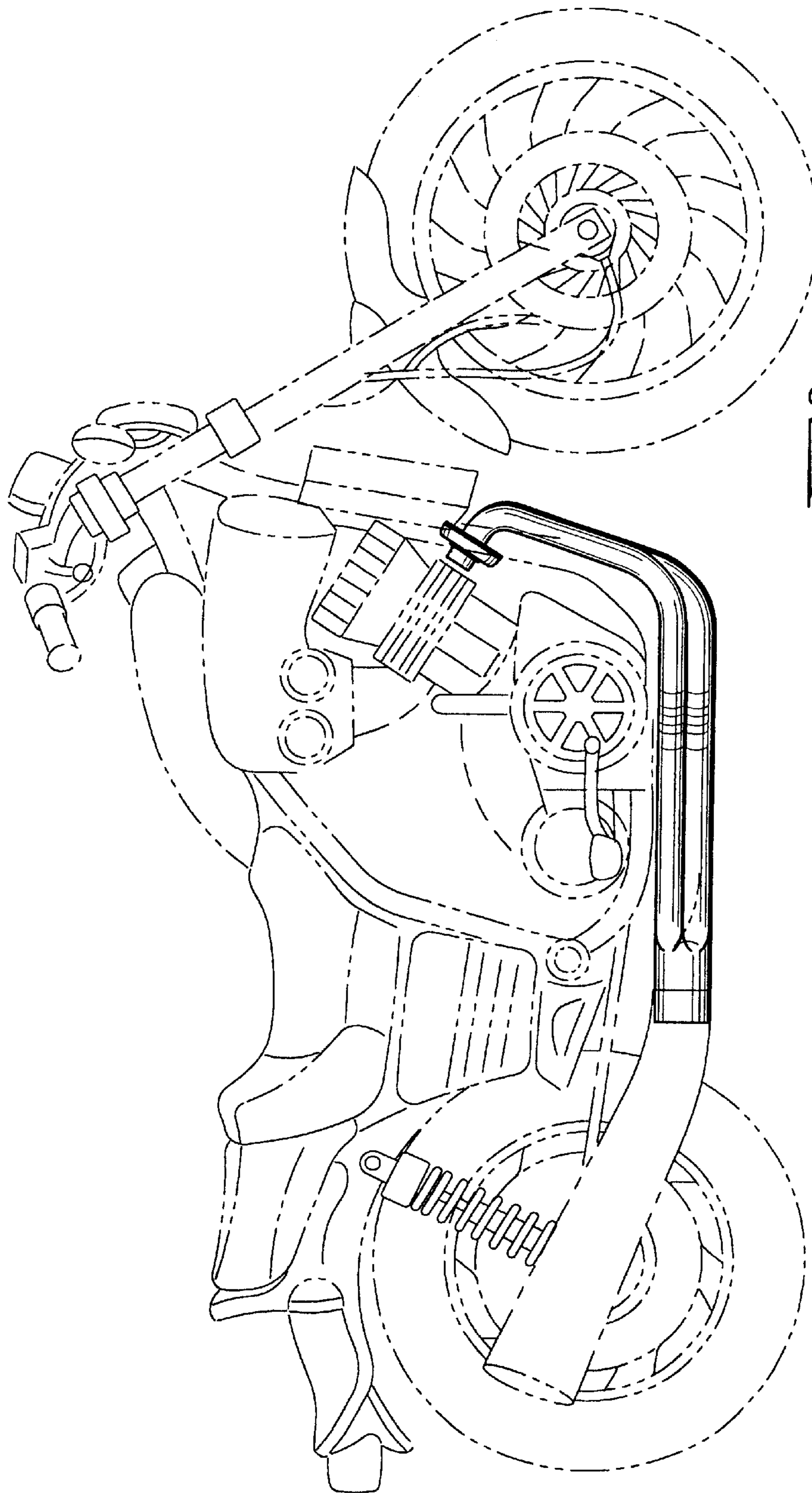
