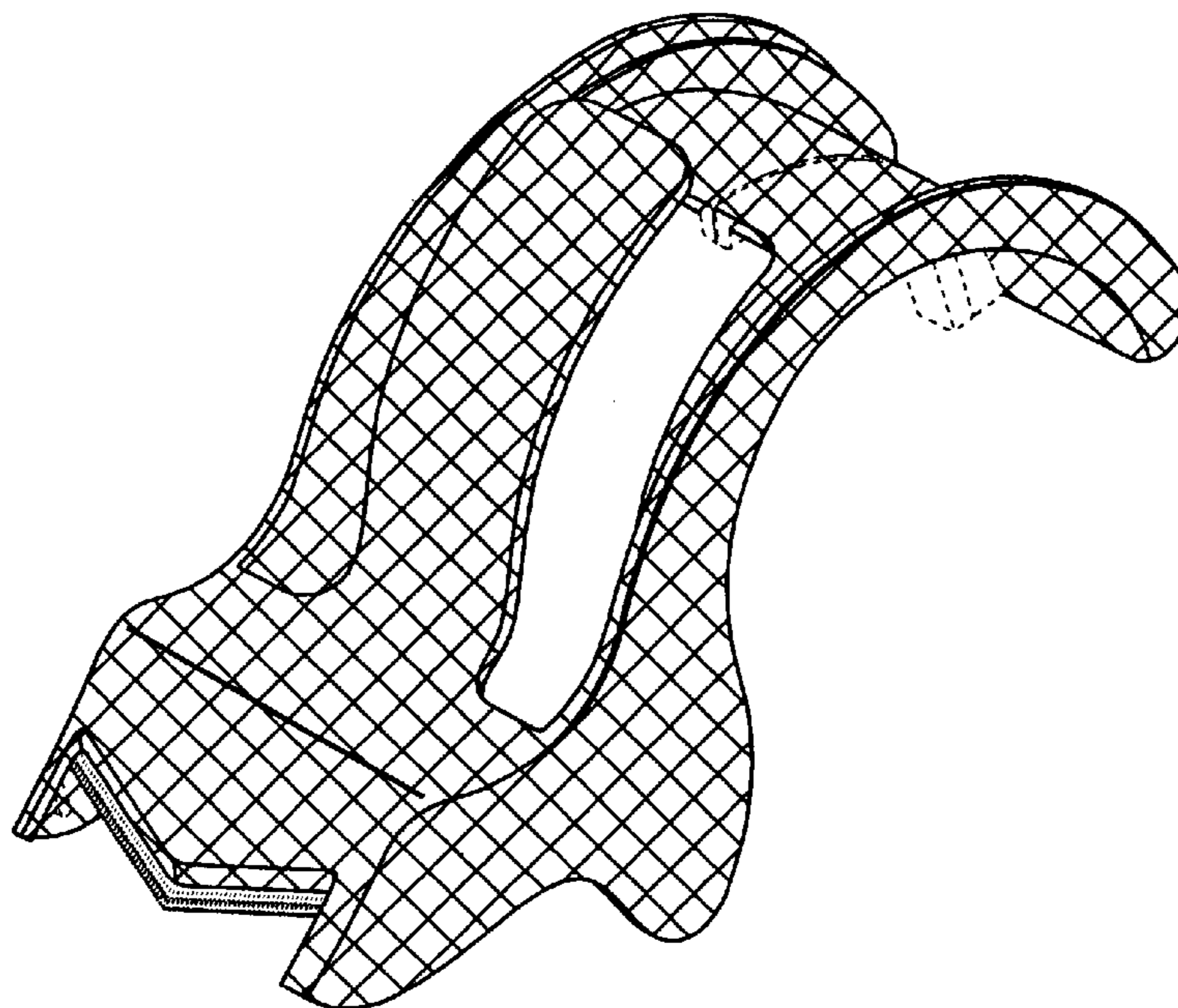
(57) **CLAIM**

The ornamental design for a tape dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tape dispenser according to the present invention; FIG. 2 is a right side view of the tape dispenser of FIG. 1, the left side view being a mirror image thereof; FIG. 3 is a top plan view of the tape dispenser of FIG. 1; FIG. 4 is a bottom plan view of the tape dispenser of FIG. 1; FIG. 5 is a front view of the tape dispenser of FIG. 1; and, FIG. 6 is a rear view of the tape dispenser of FIG. 1. The structure depicted by means of broken lines in the figures has been shown for illustrative purposes only and forms no part of the claimed design.

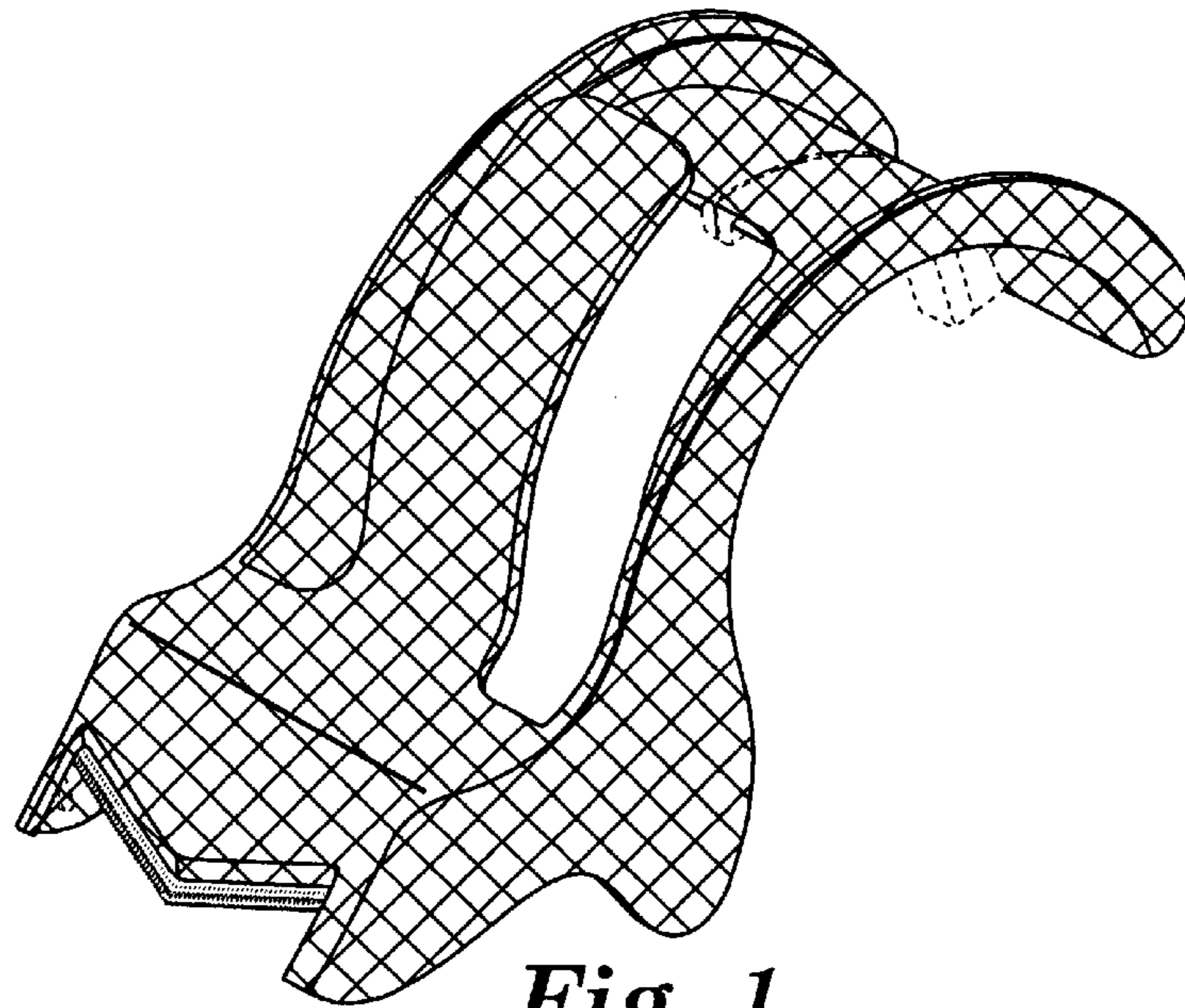

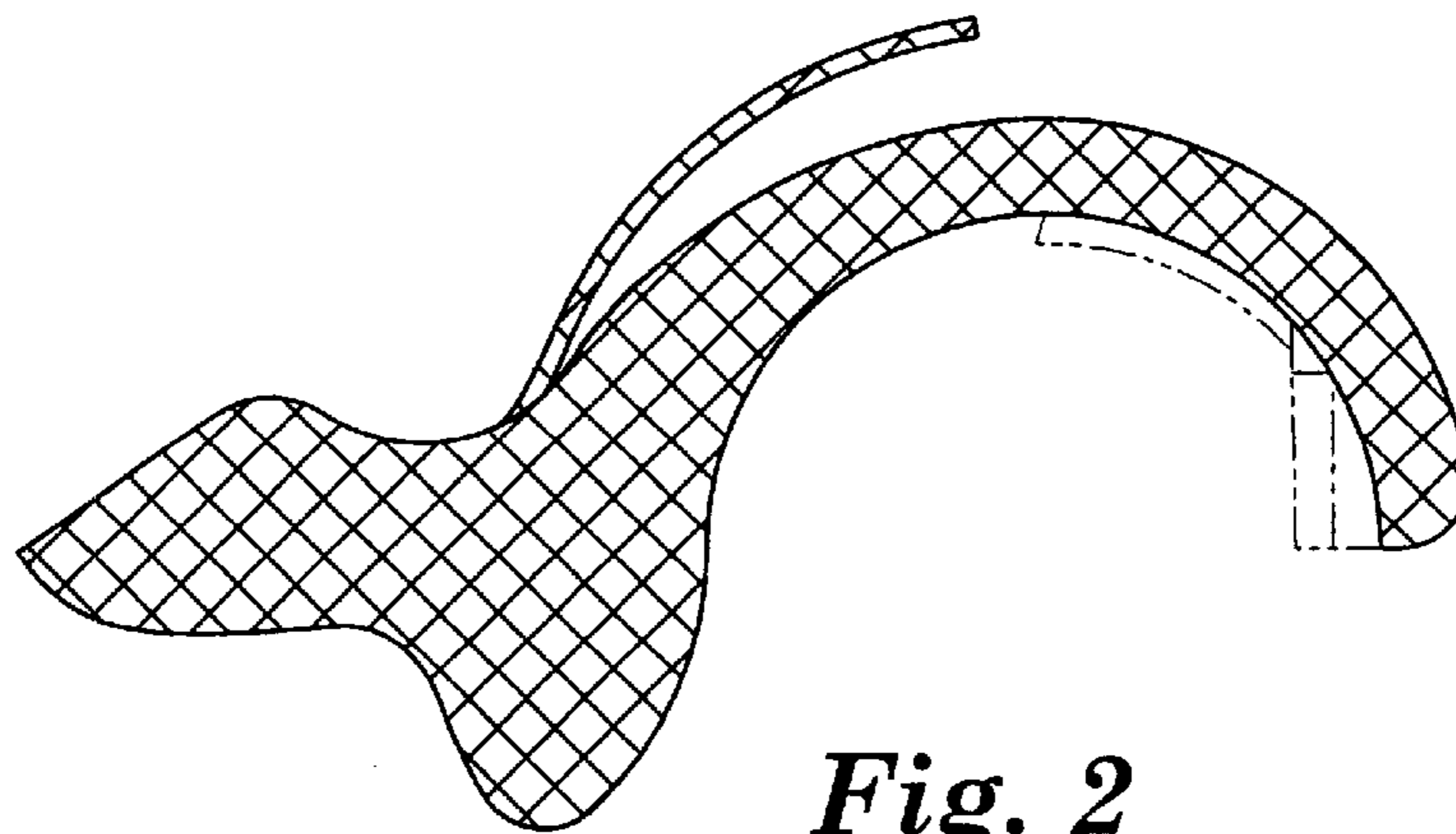

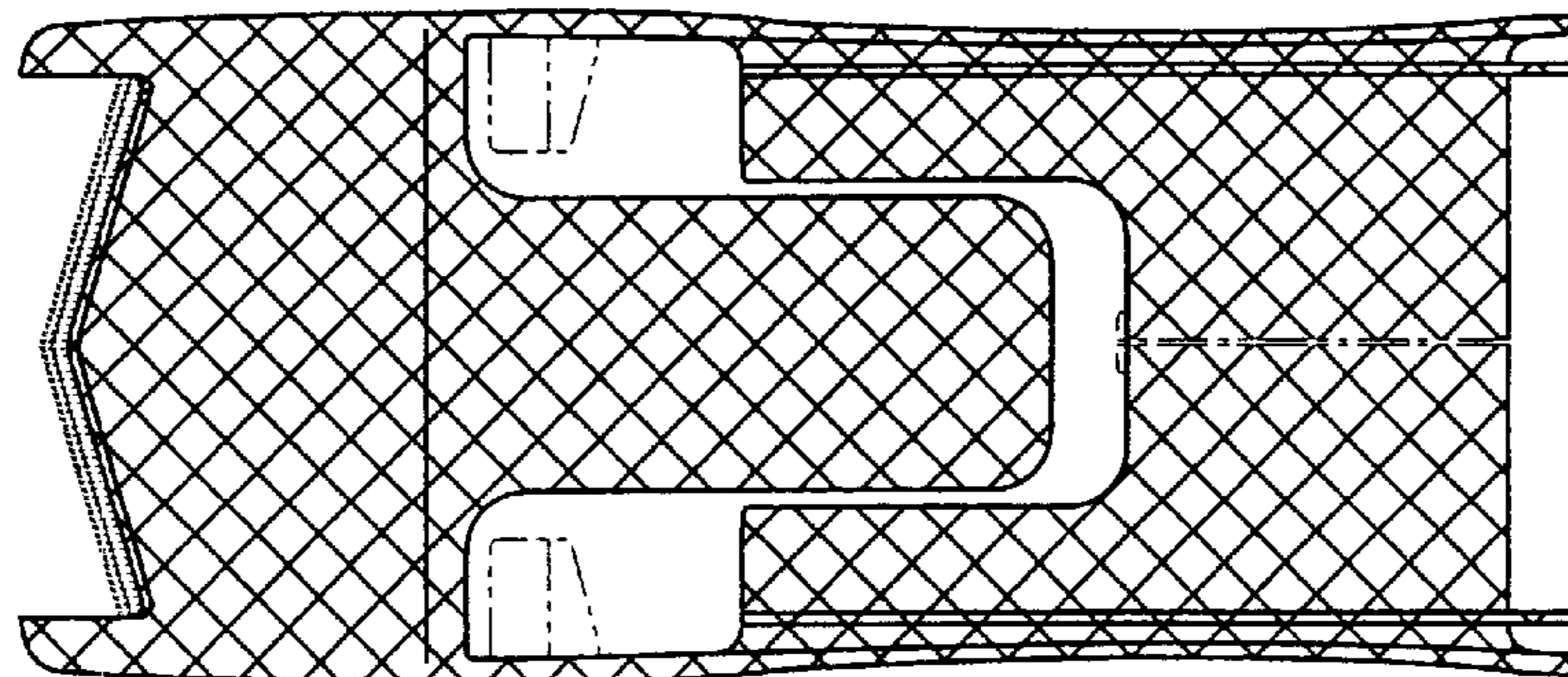

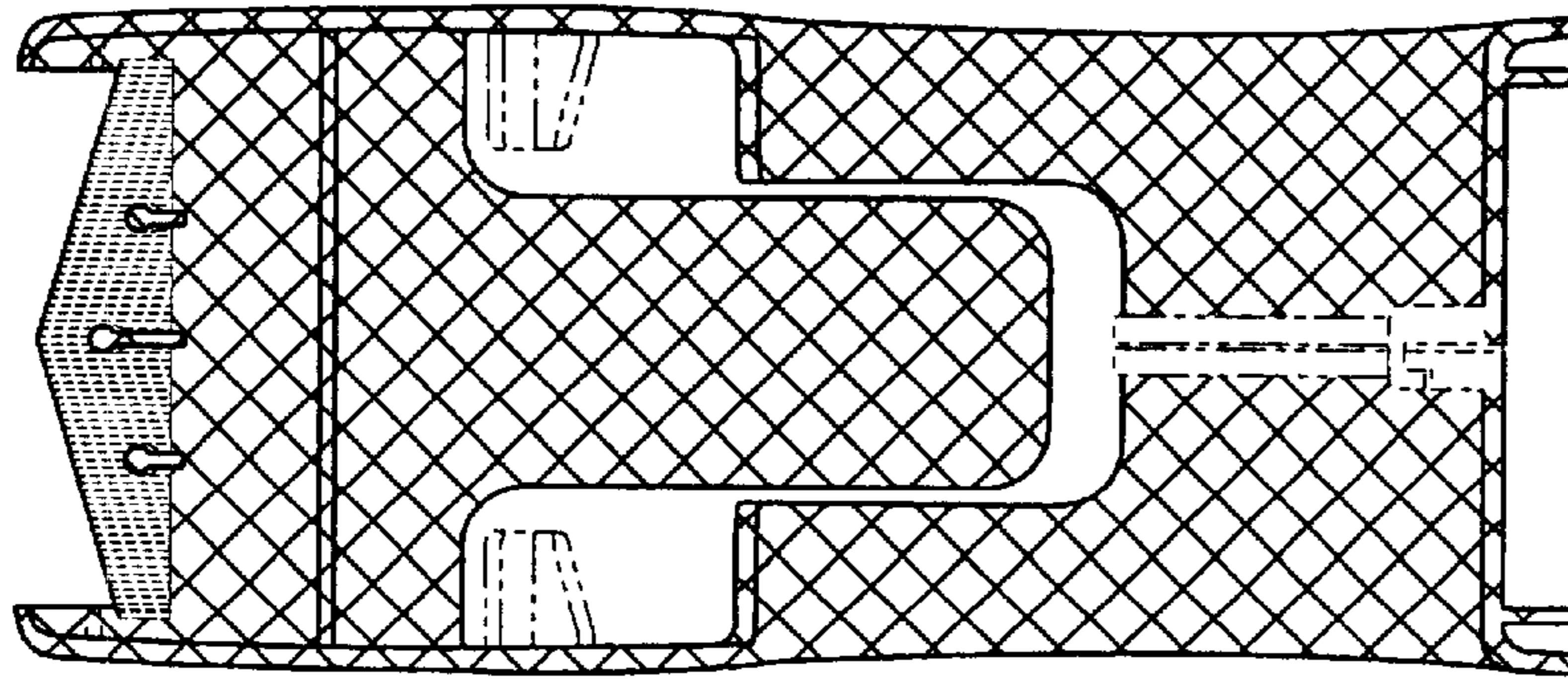

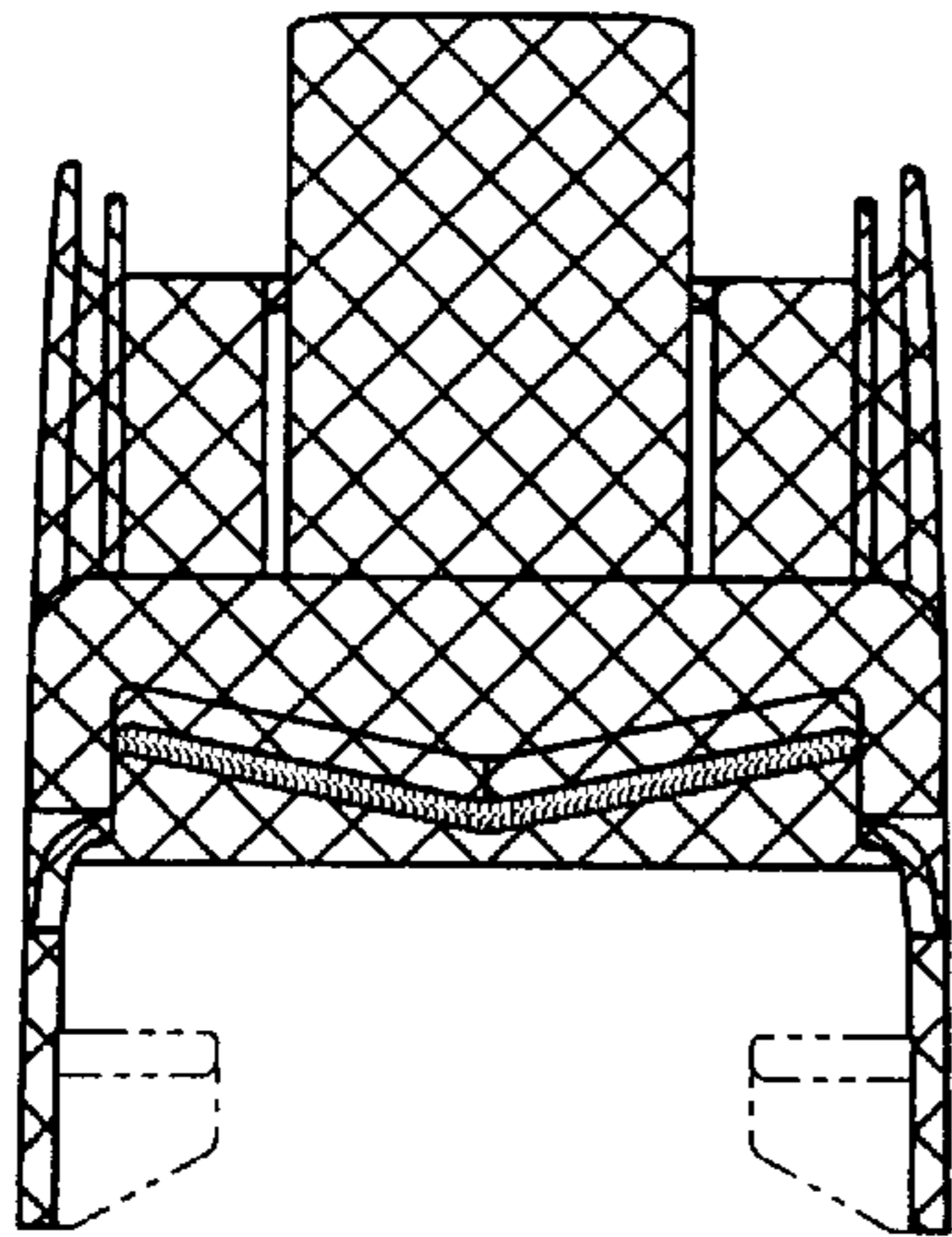

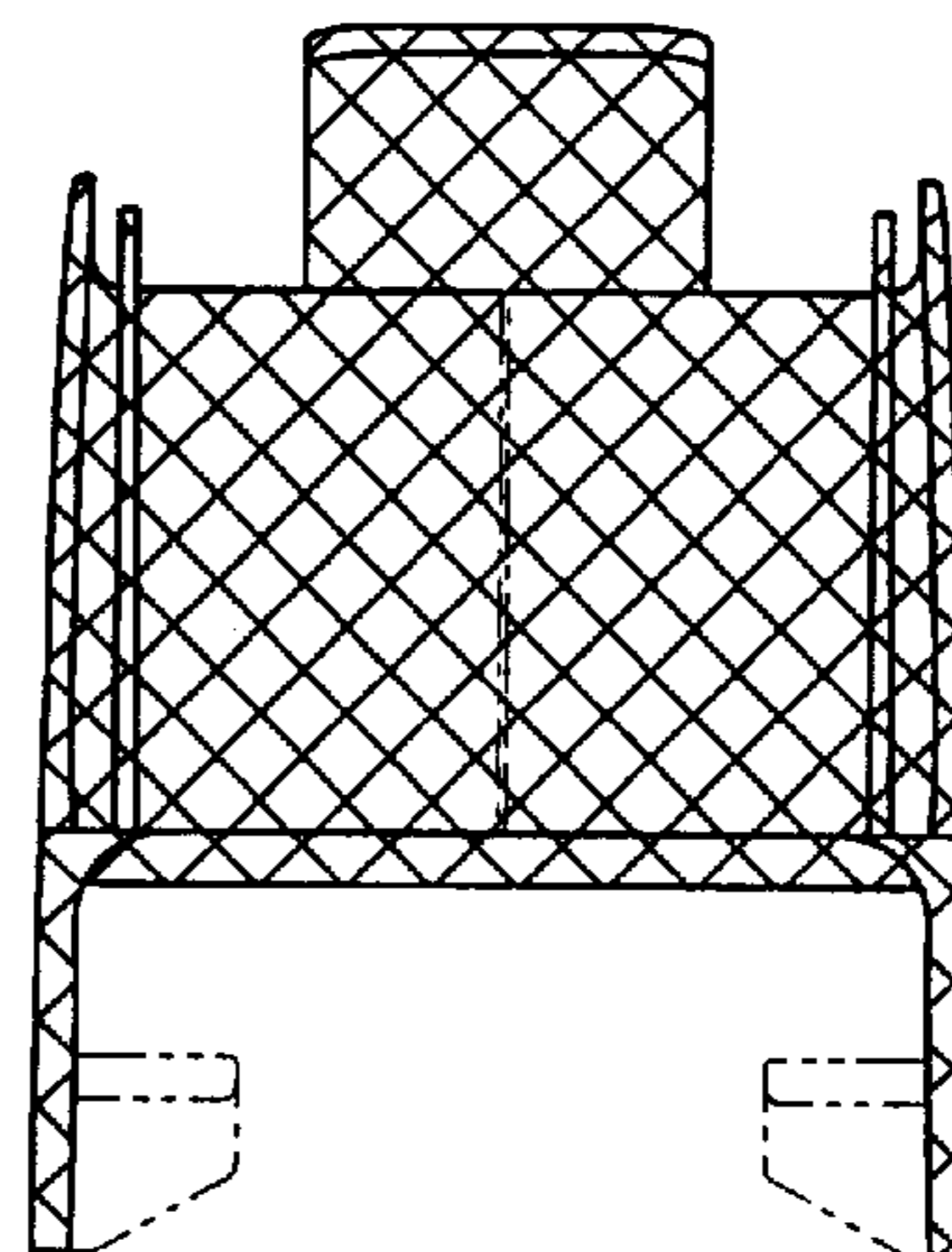
