(57) **CLAIM**

The ornamental design for a collapsible car, as shown and
described.

DESCRIPTION

FIG. 1 is a perspective view of the collapsible car with the
doors, hood, fenders, rear, and roof in closed position;

FIG. 2 is a top view of the collapsible car with the doors,
hood, fenders, rear, and roof in closed position;

FIG. 3 is a bottom view of the collapsible car with the doors,
hood, fenders, rear, and roof in closed position;

FIG. 4 is a left side view of the collapsible car with the
doors, hood, fenders, rear, and roof in closed position;

doors, hood, fenders, rear and roof in open position;

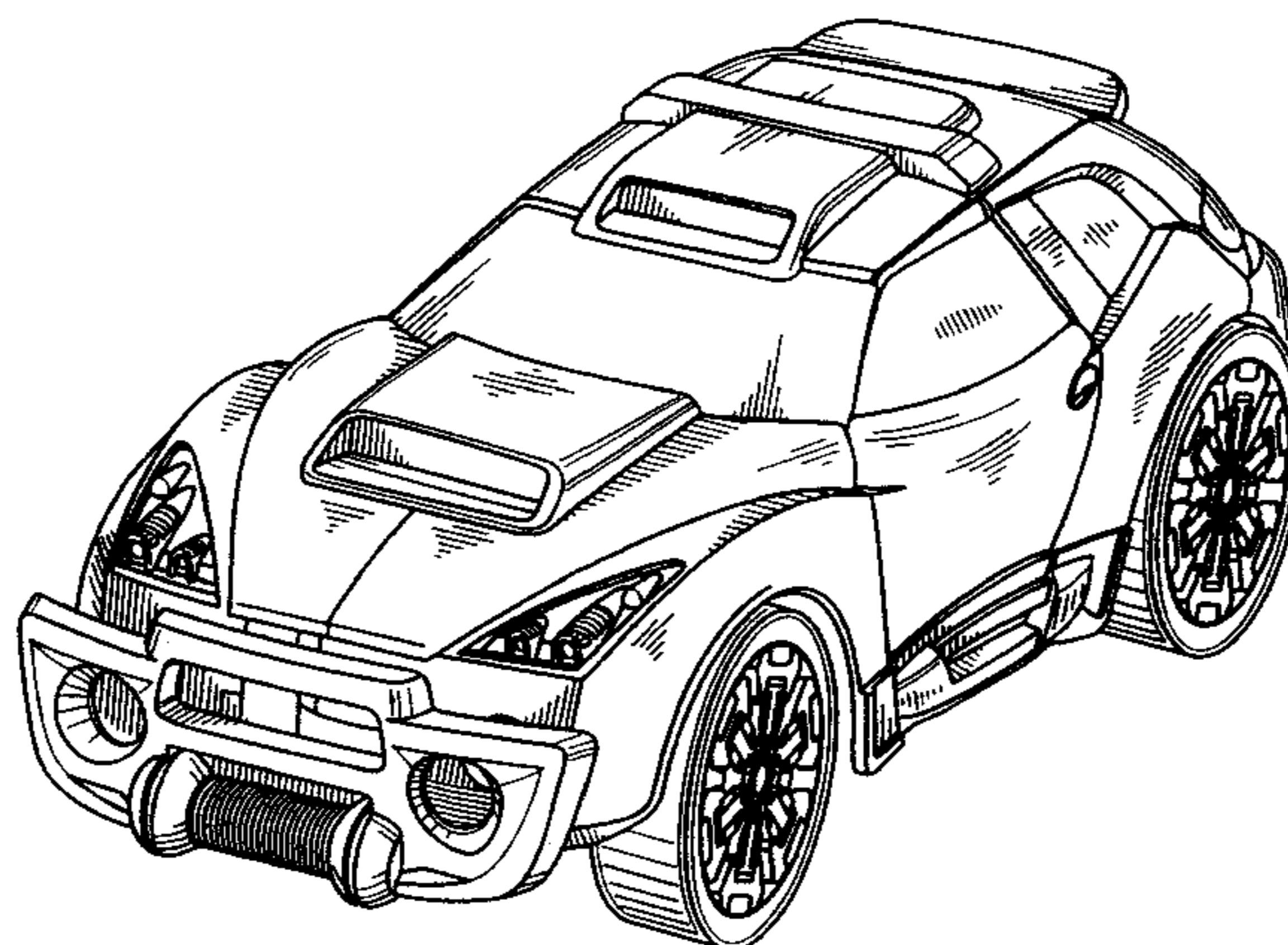
FIG. 11 is a left side view of the collapsible car with the

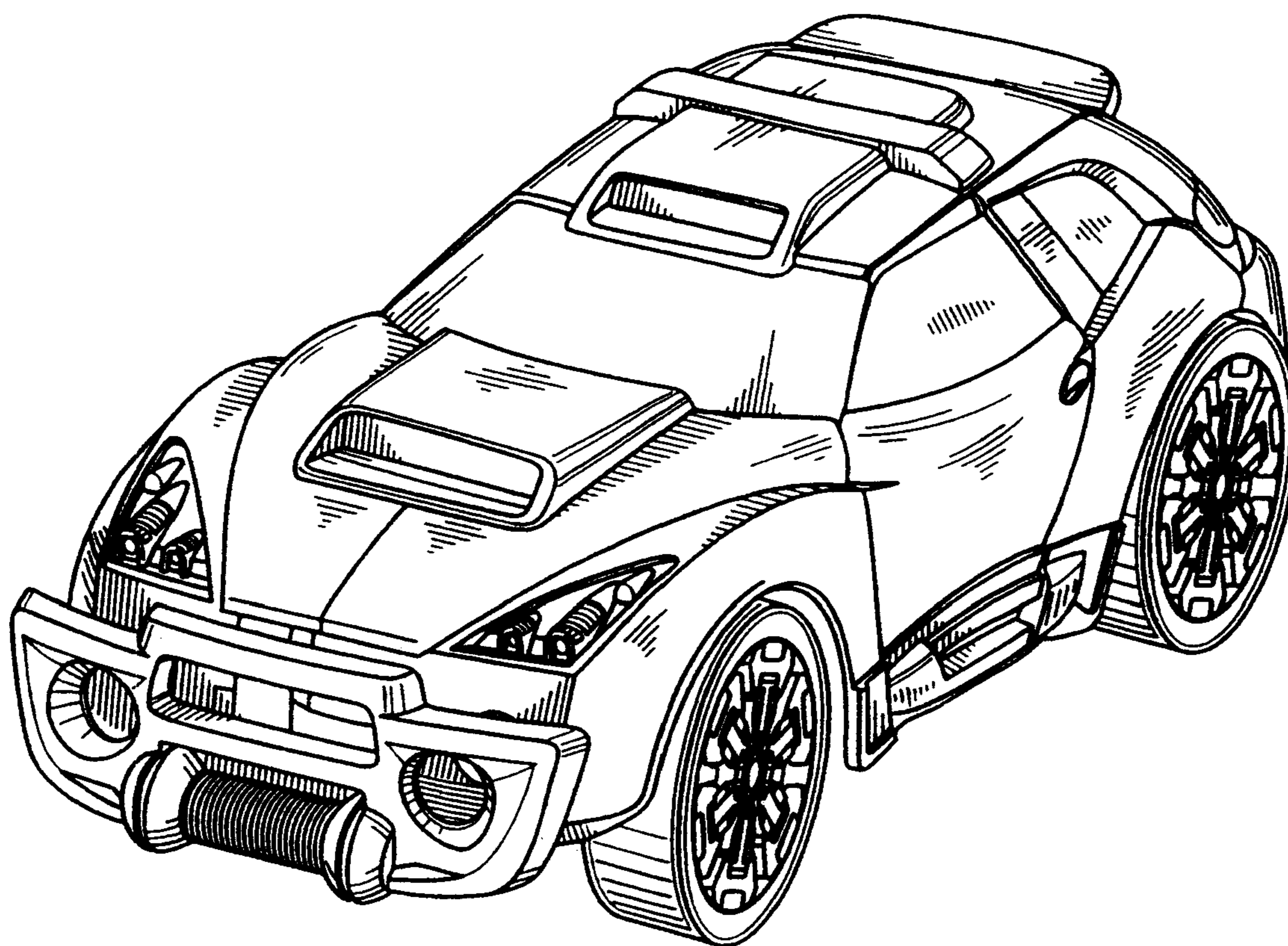

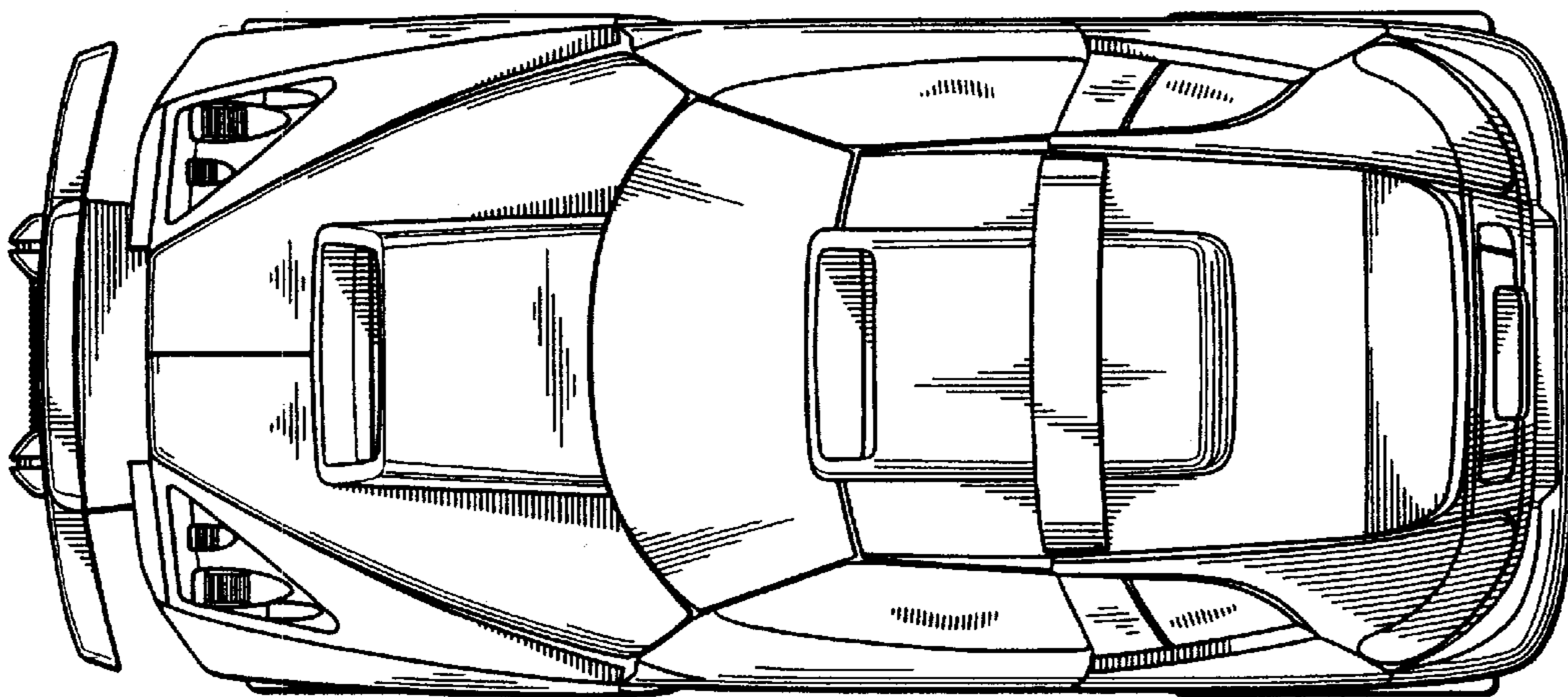

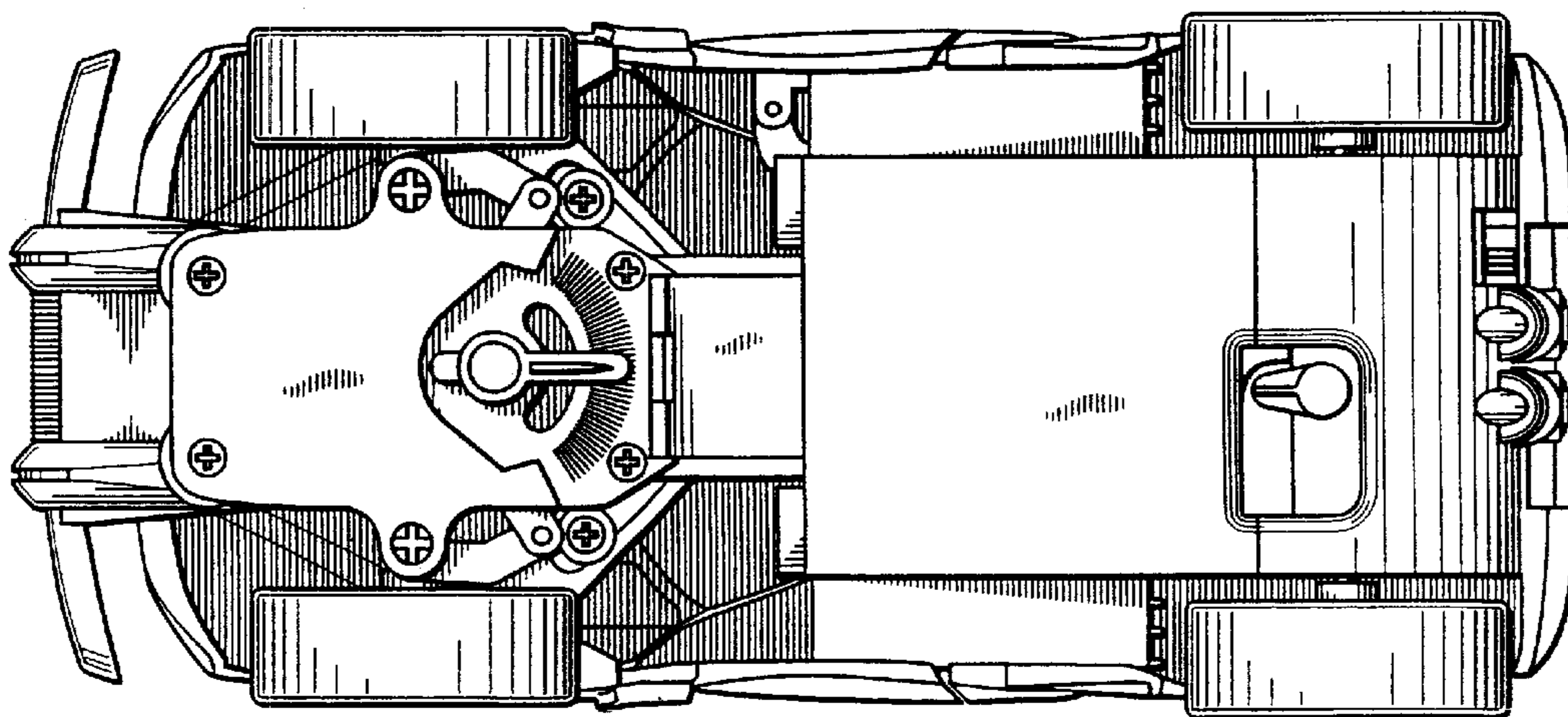

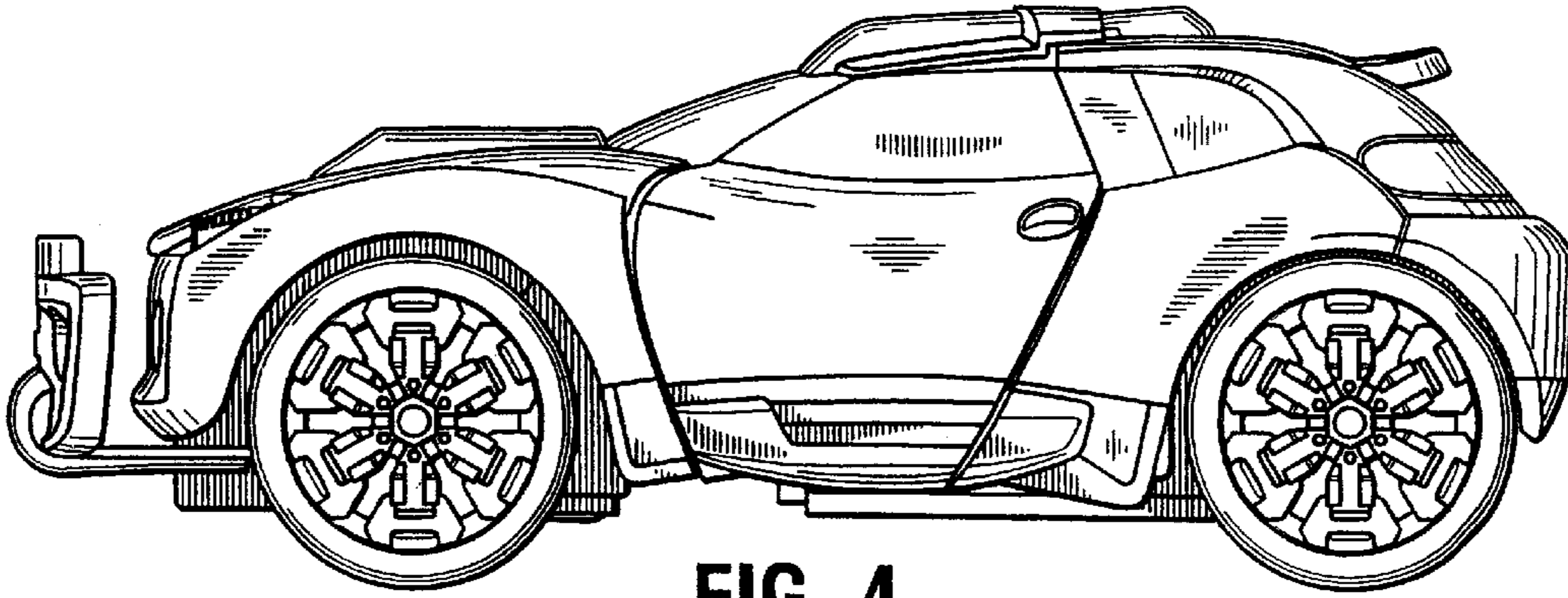

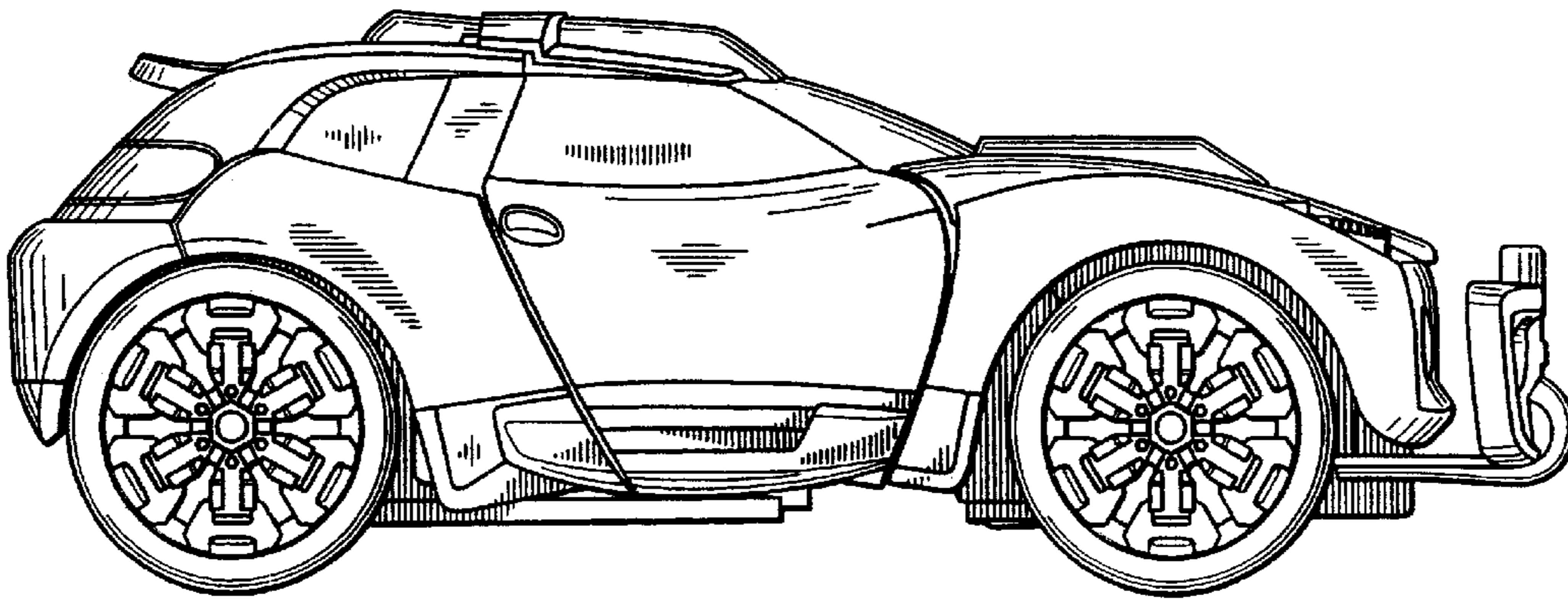

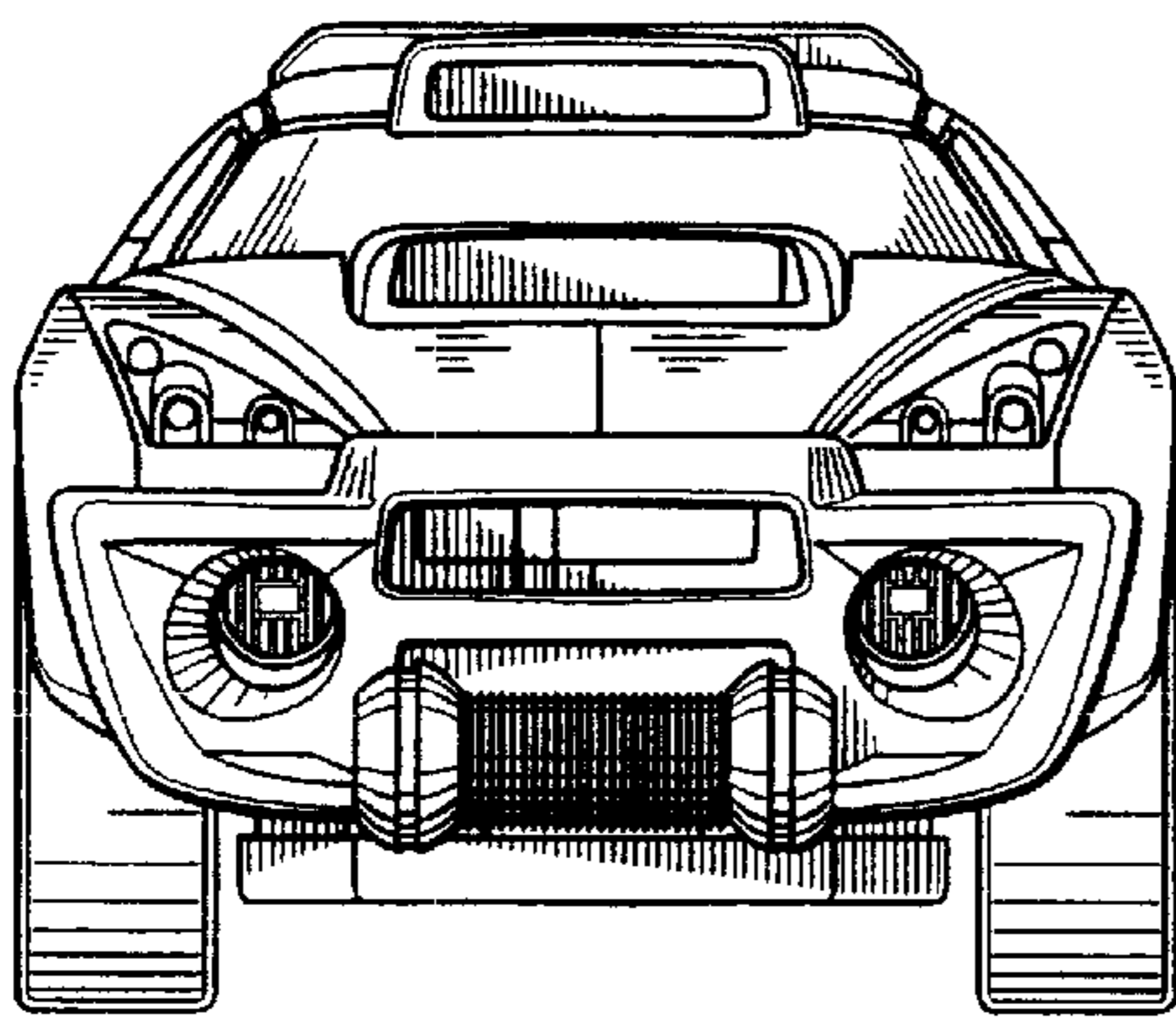

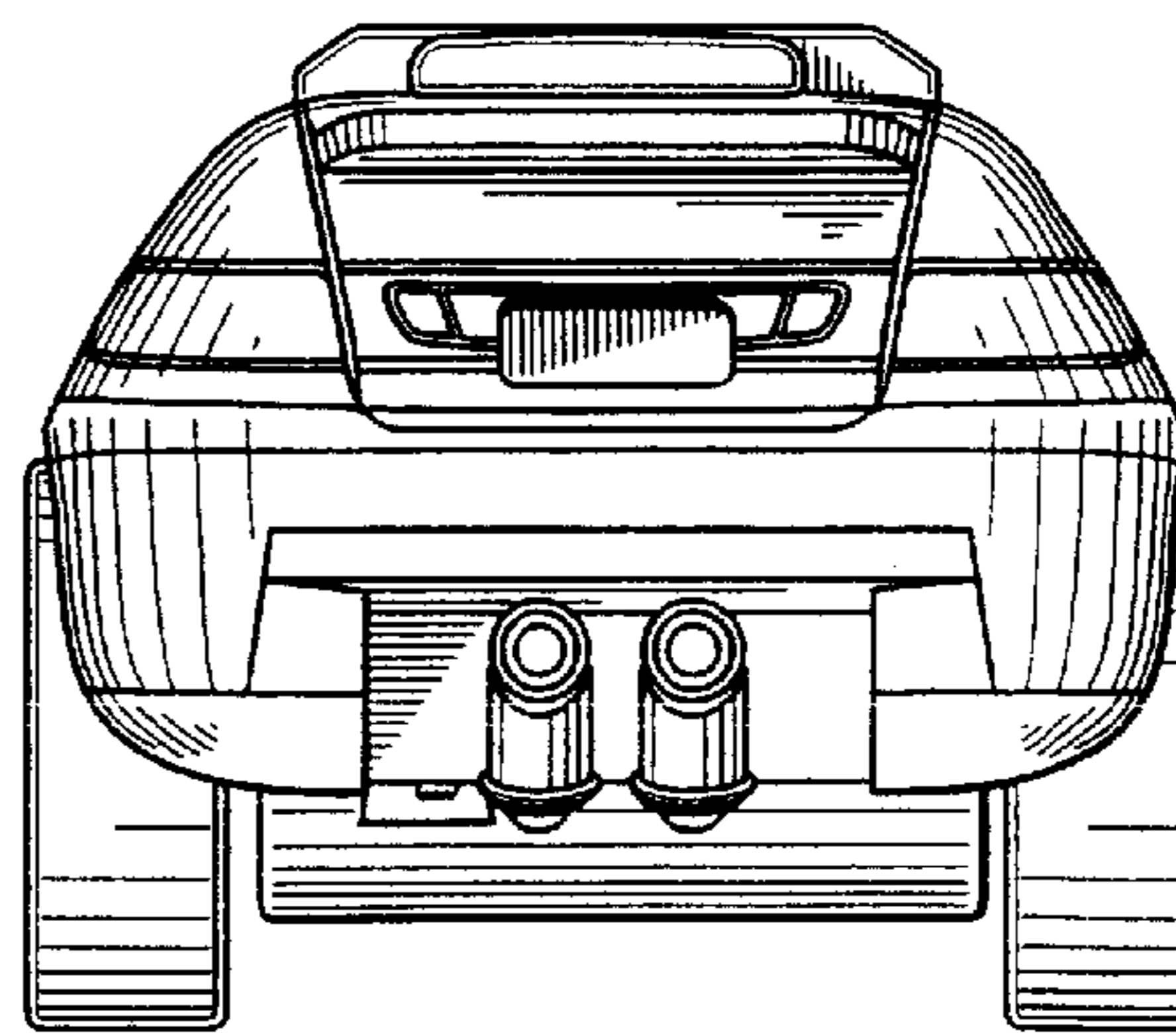

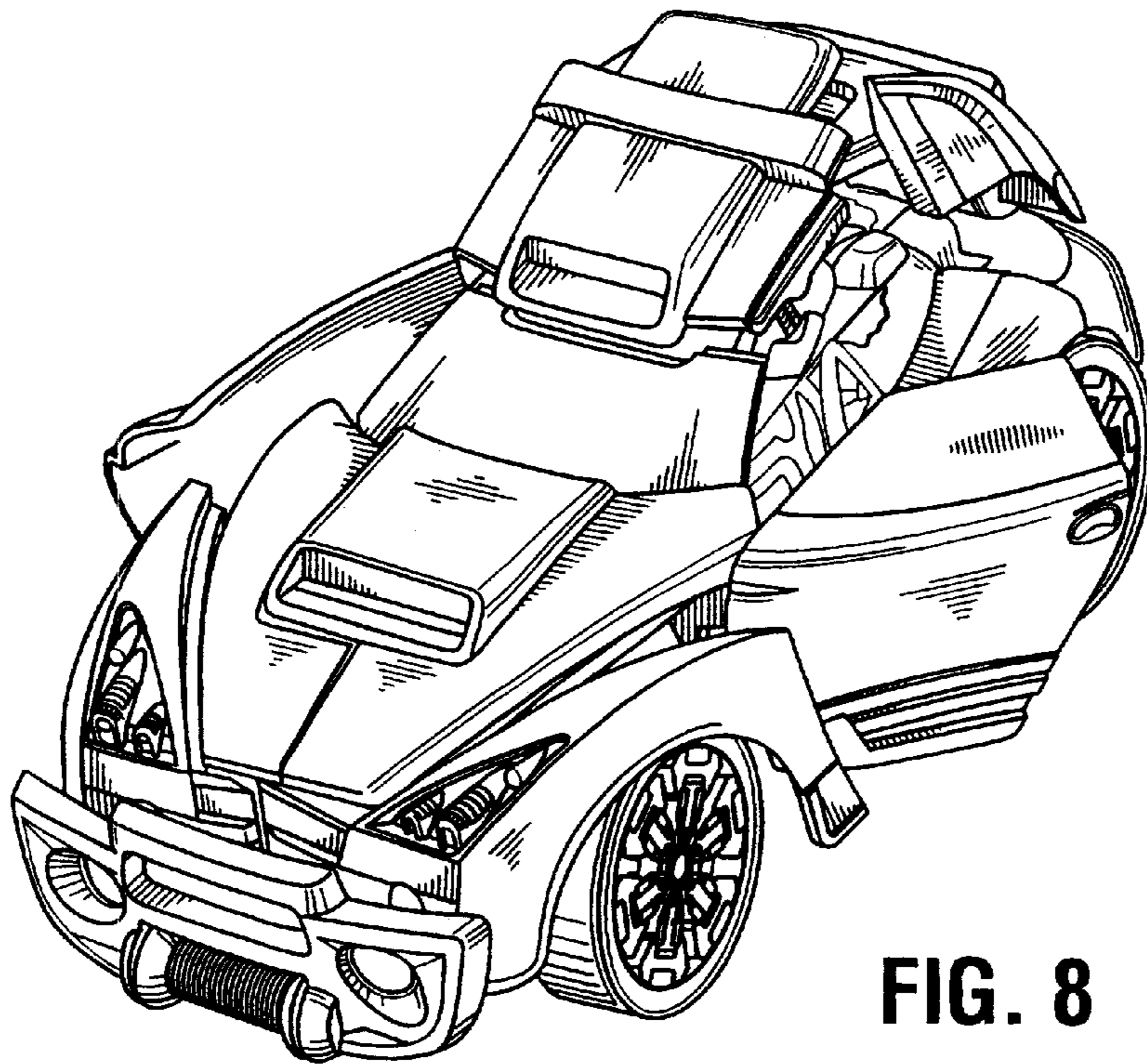

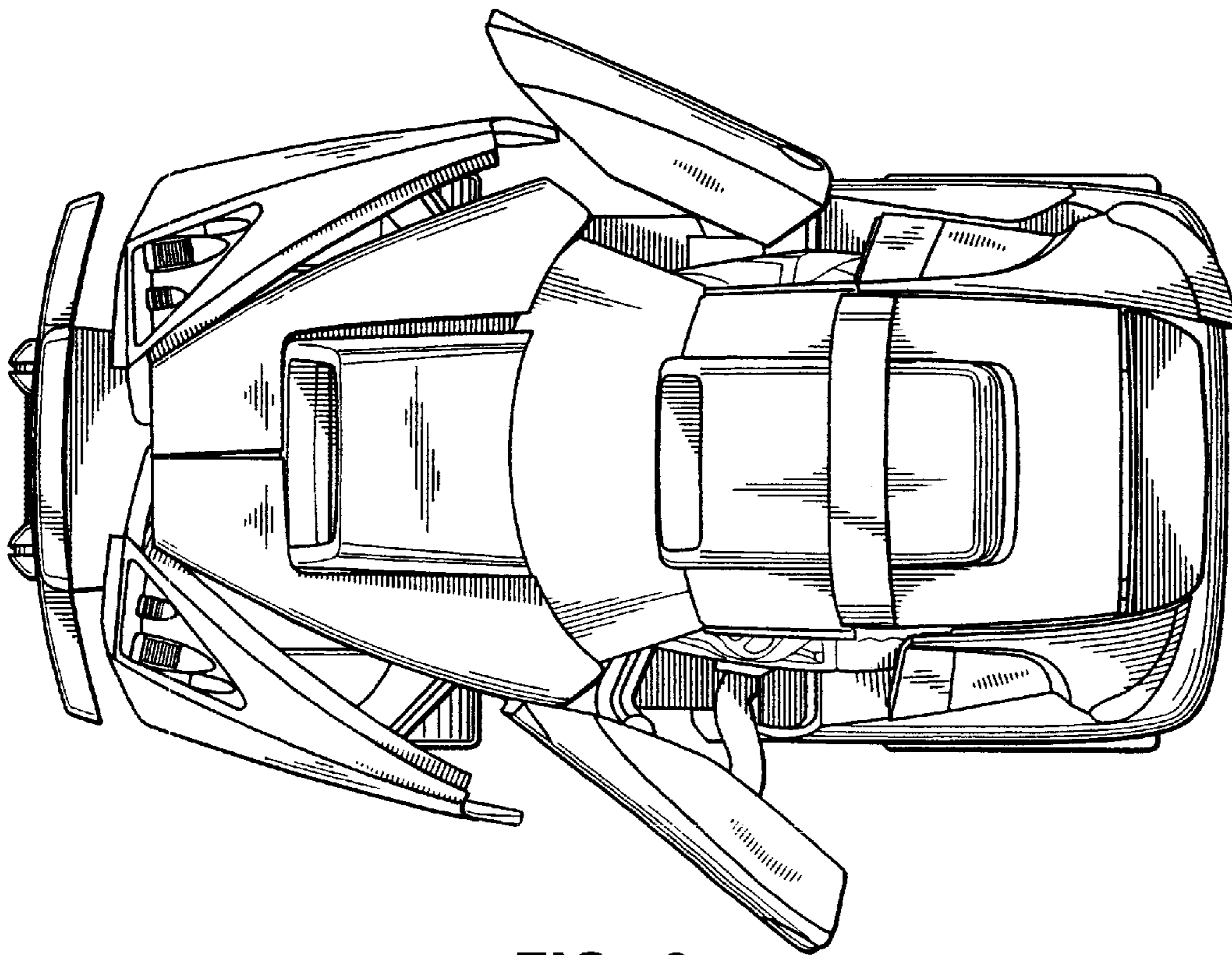

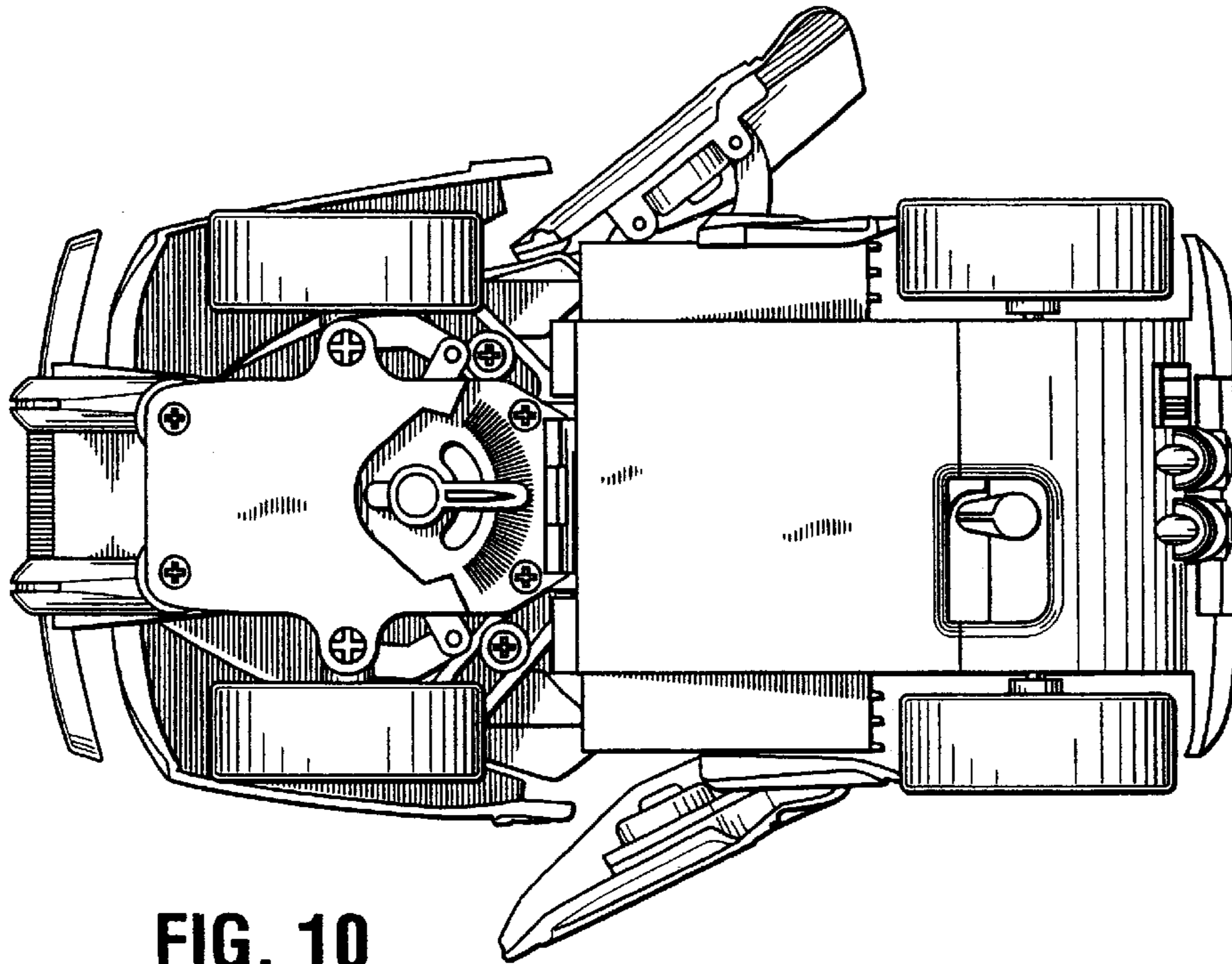

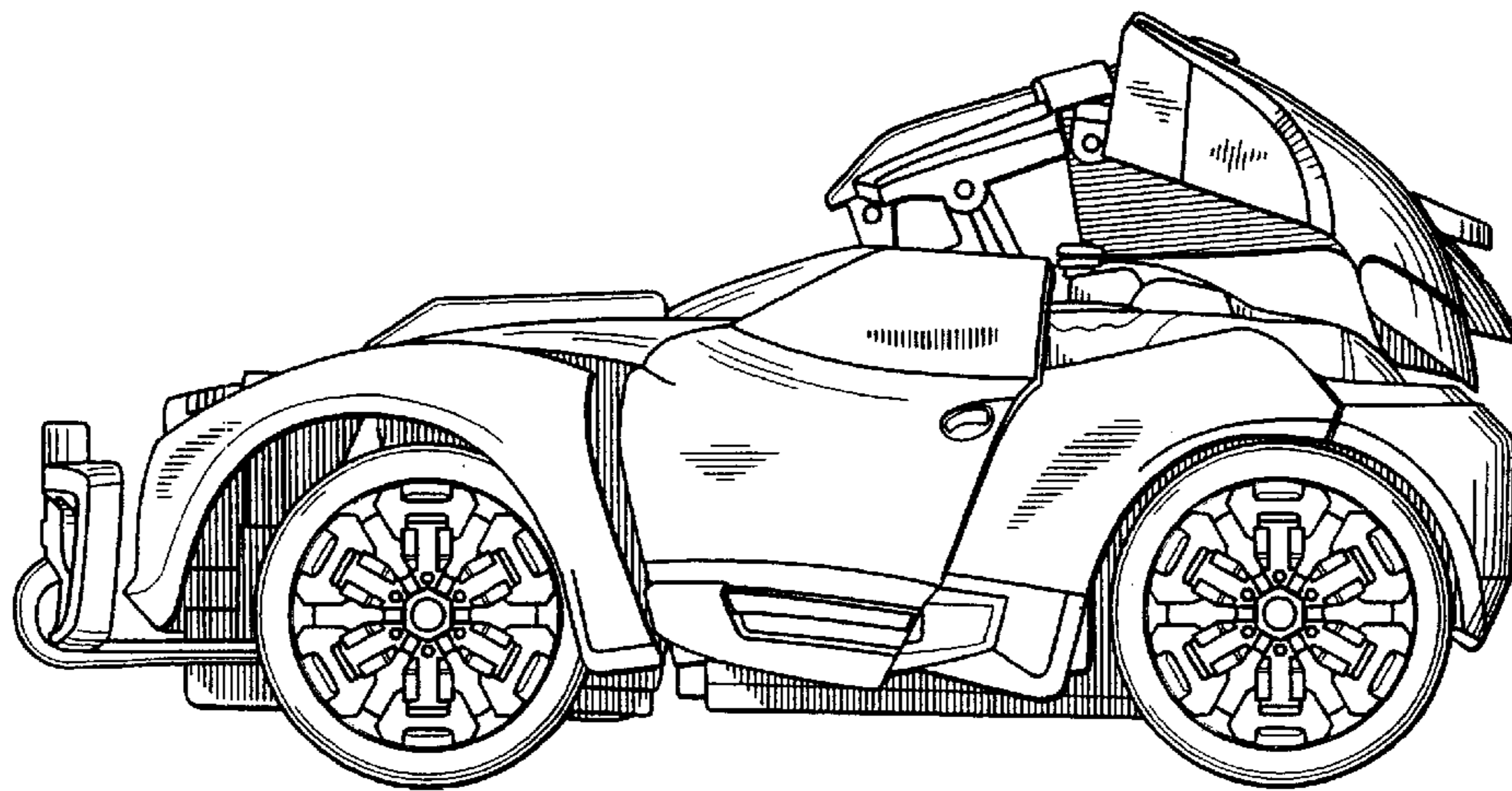

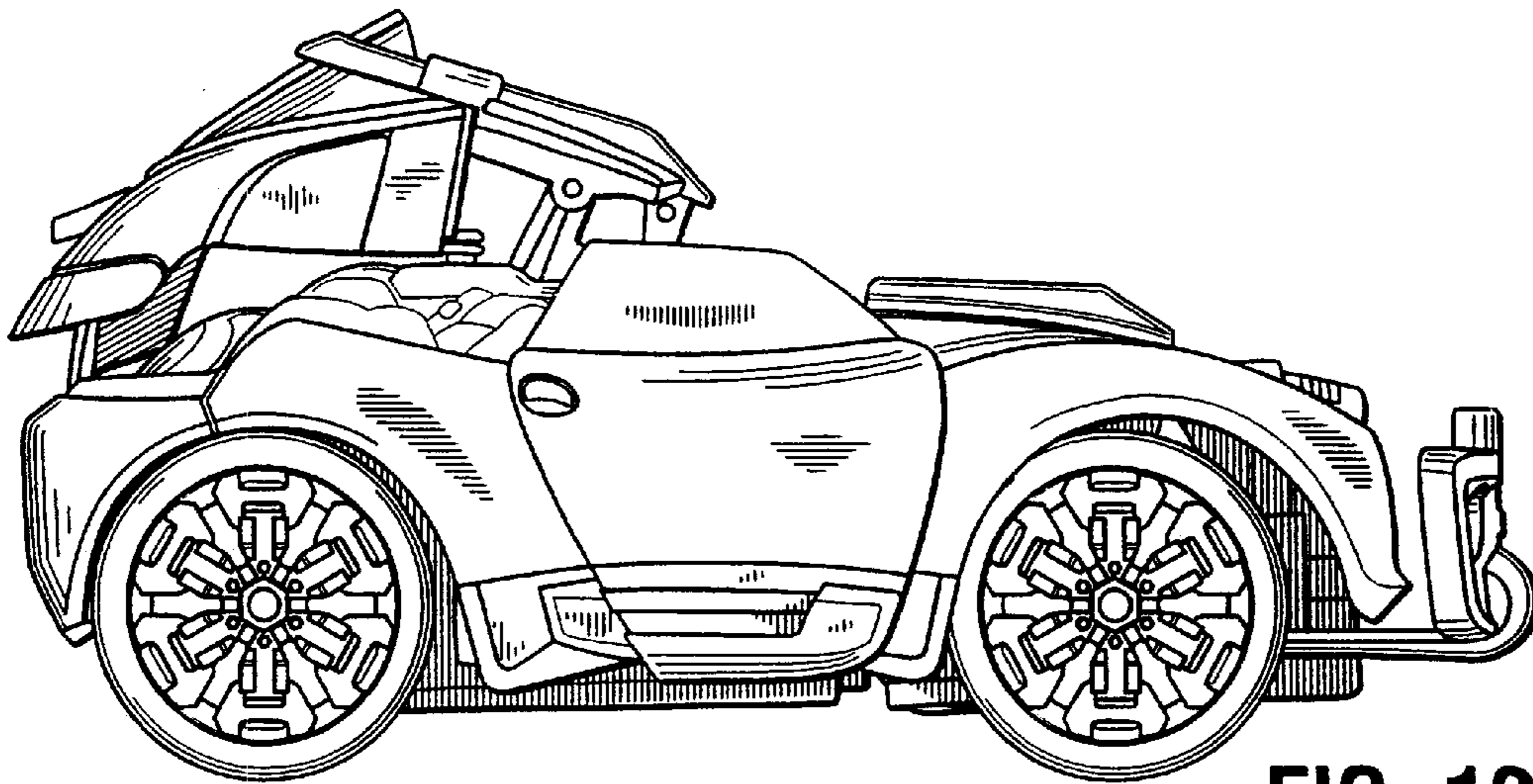

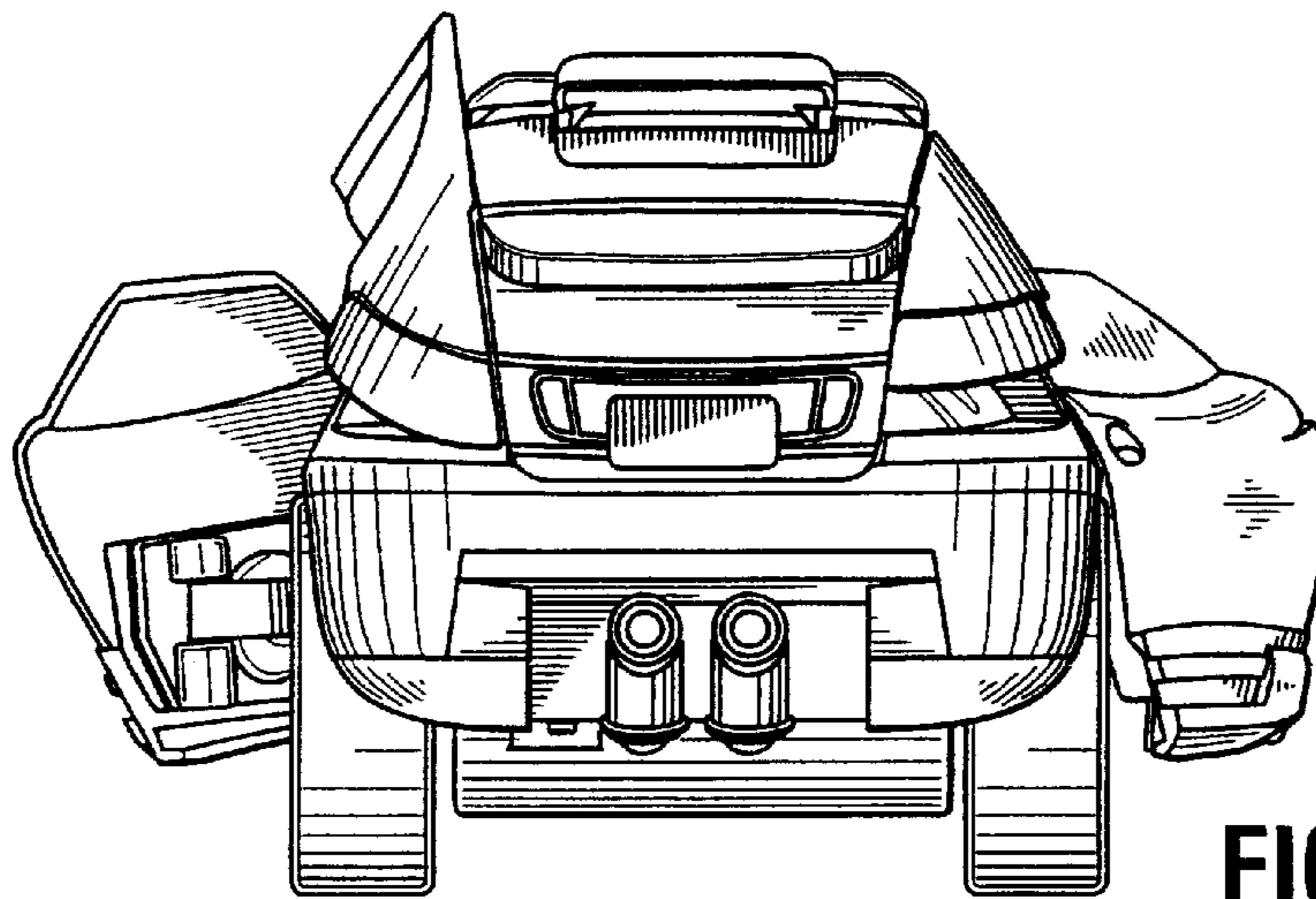

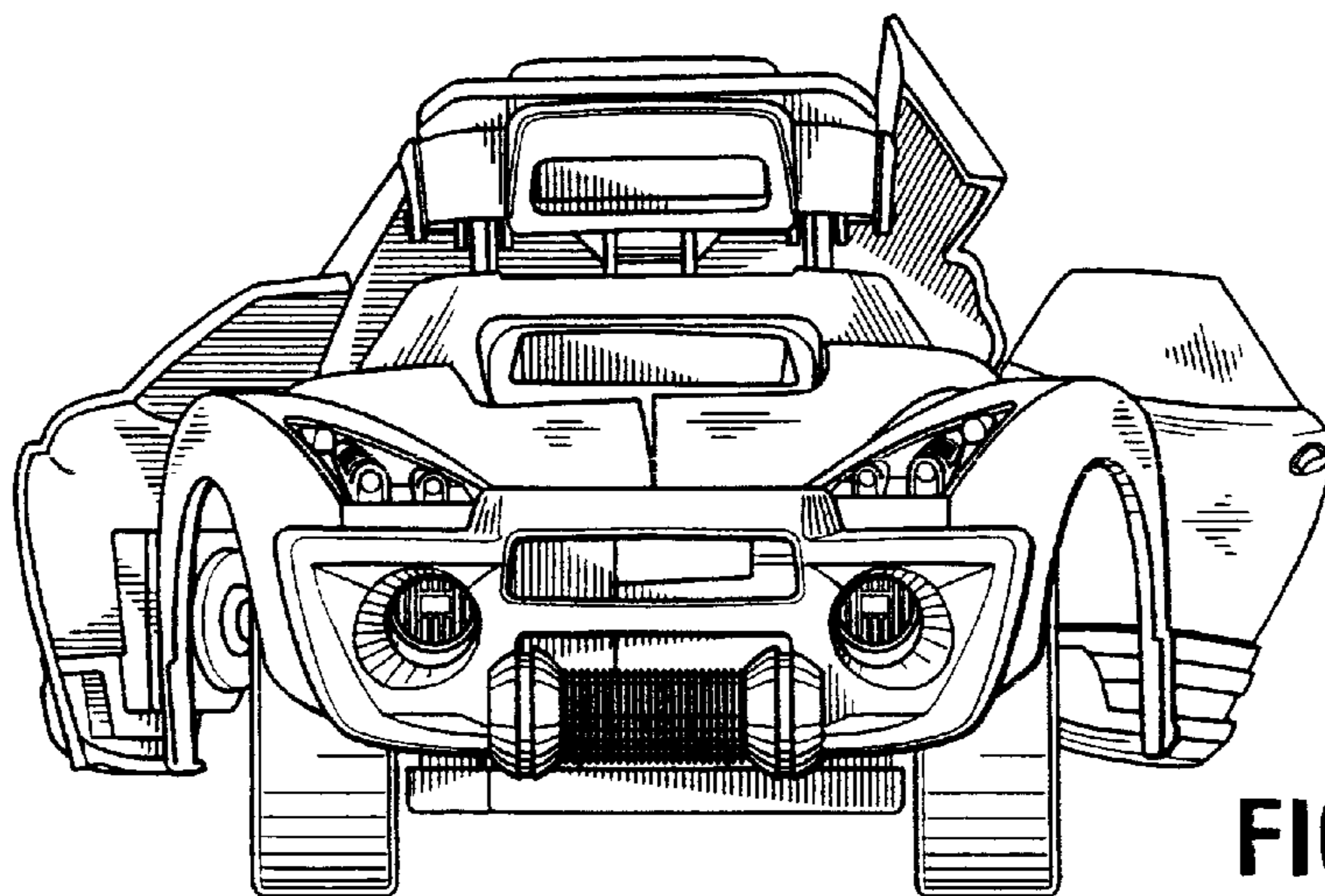
