The ornamental design for a wedge type golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a back view of the wedge type golf club head as claimed herein;

FIG. 3 is a front view thereof;

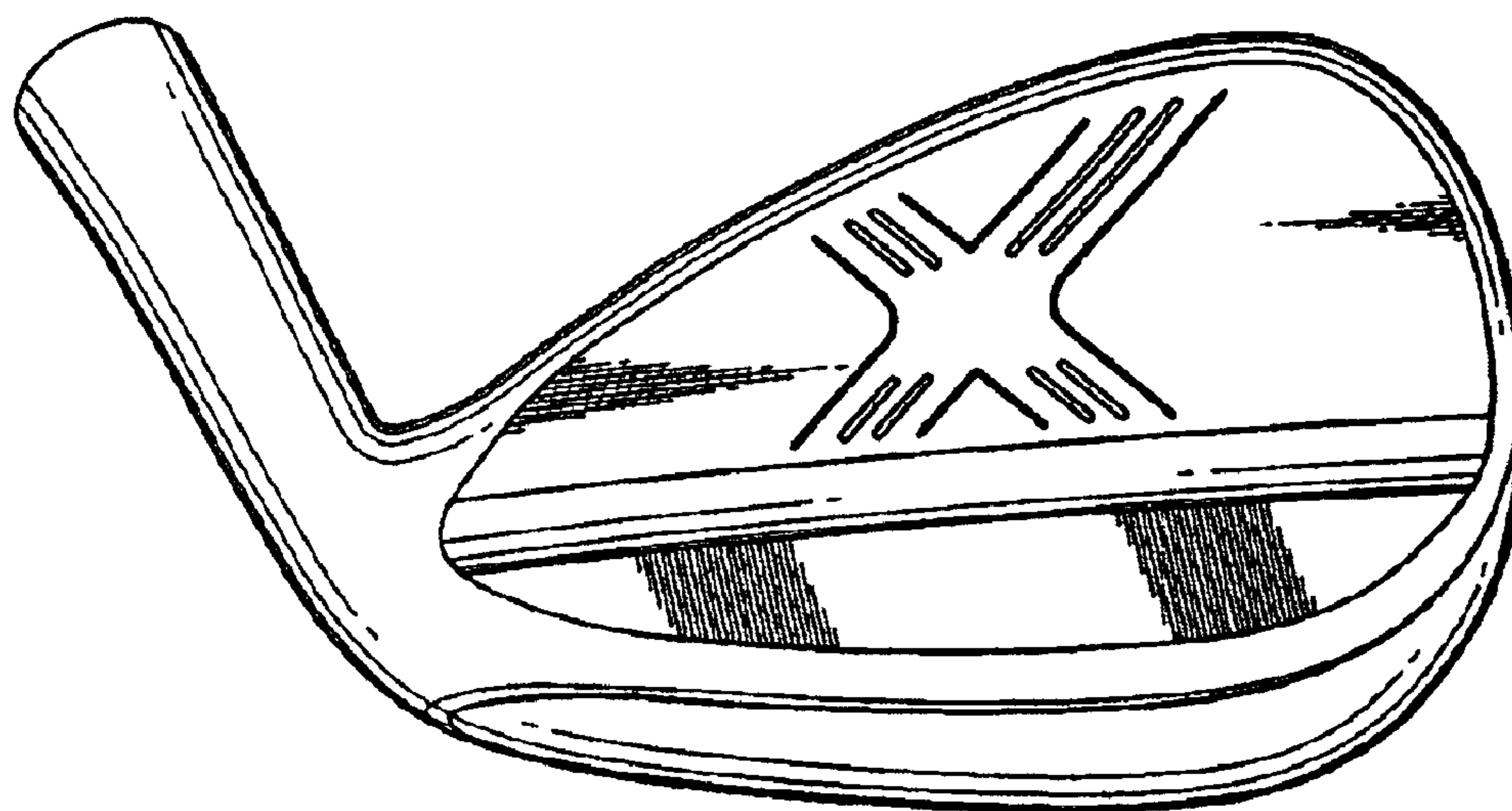
FIG. 4 is heel end view thereof;

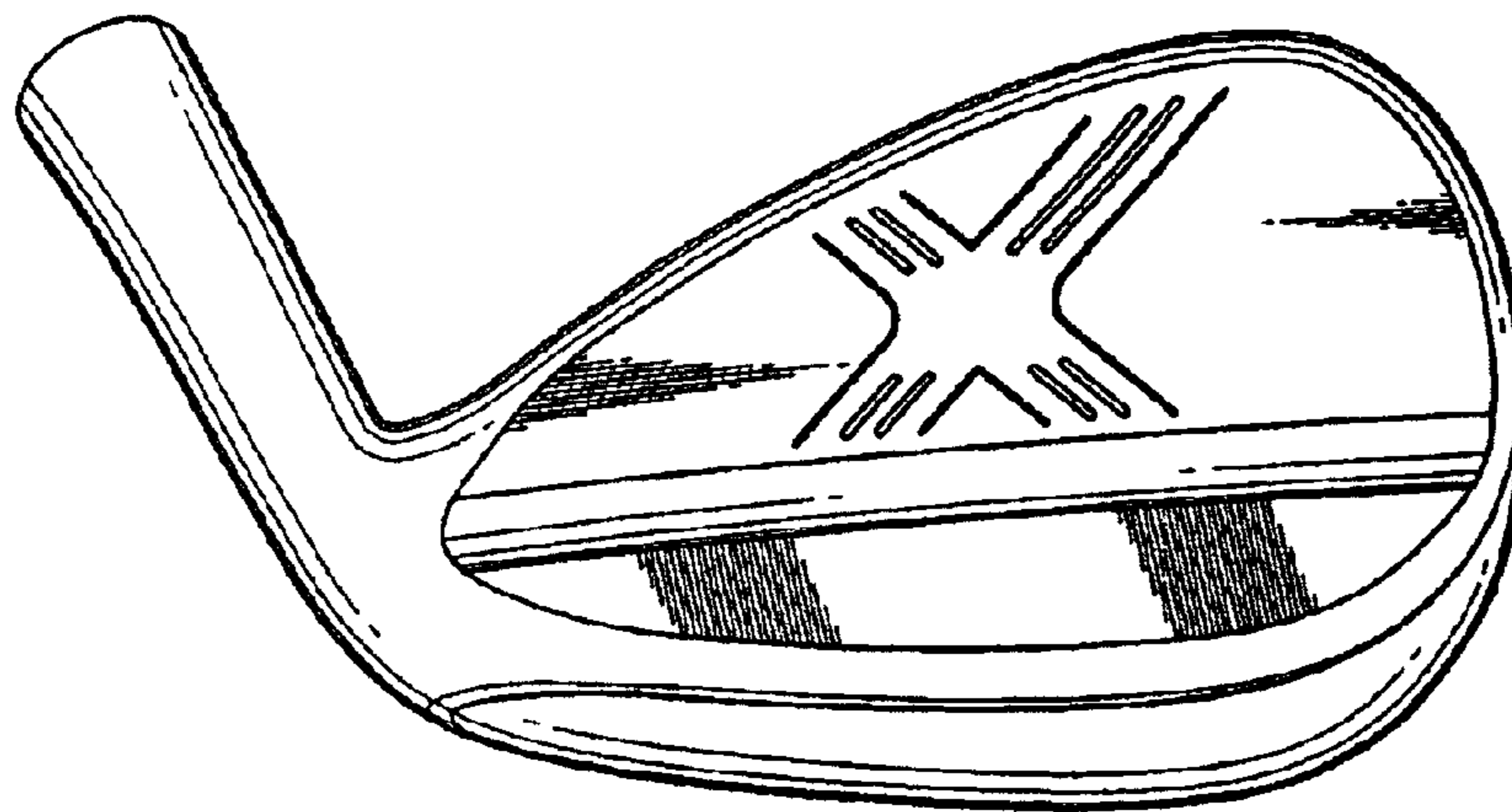

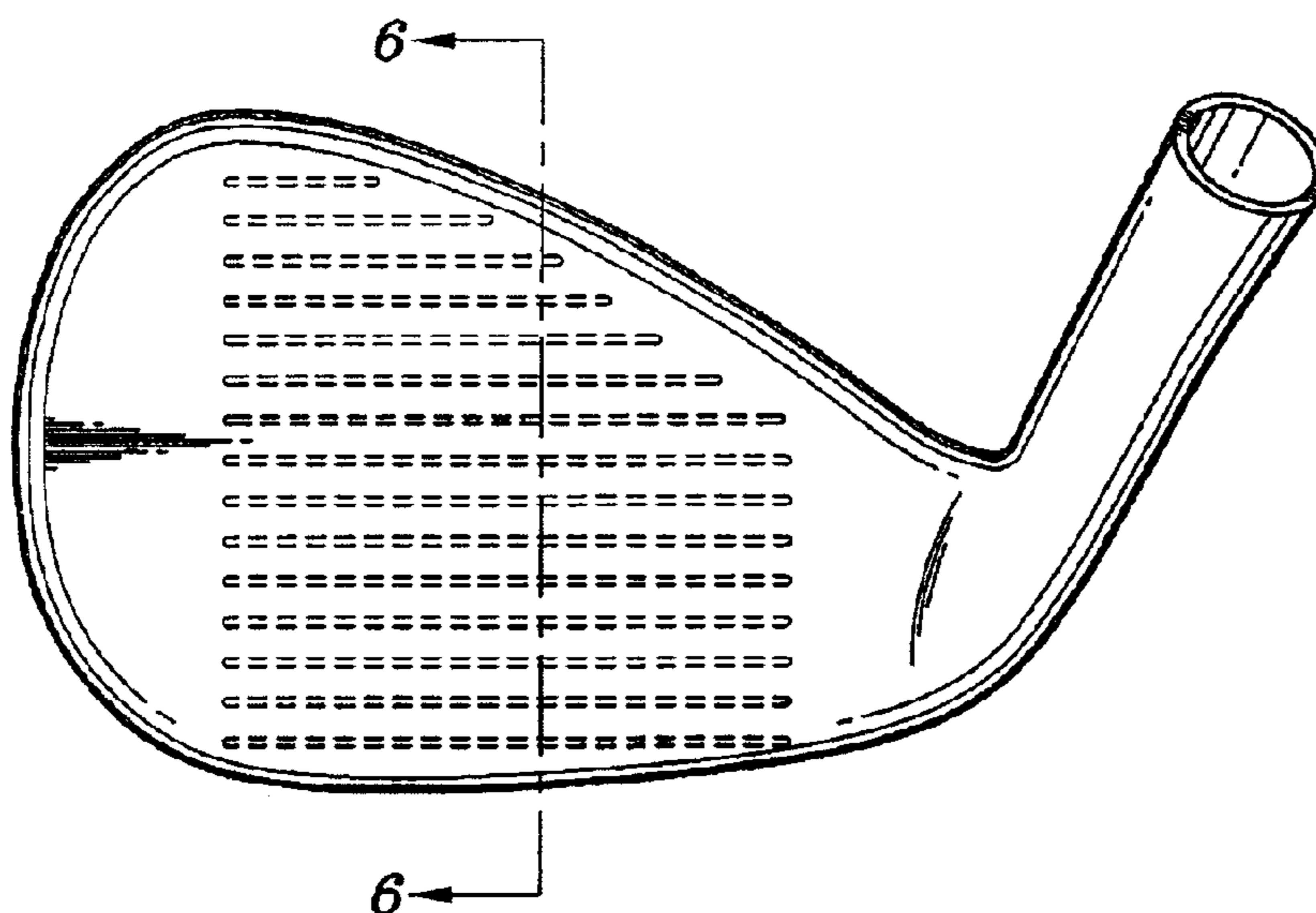
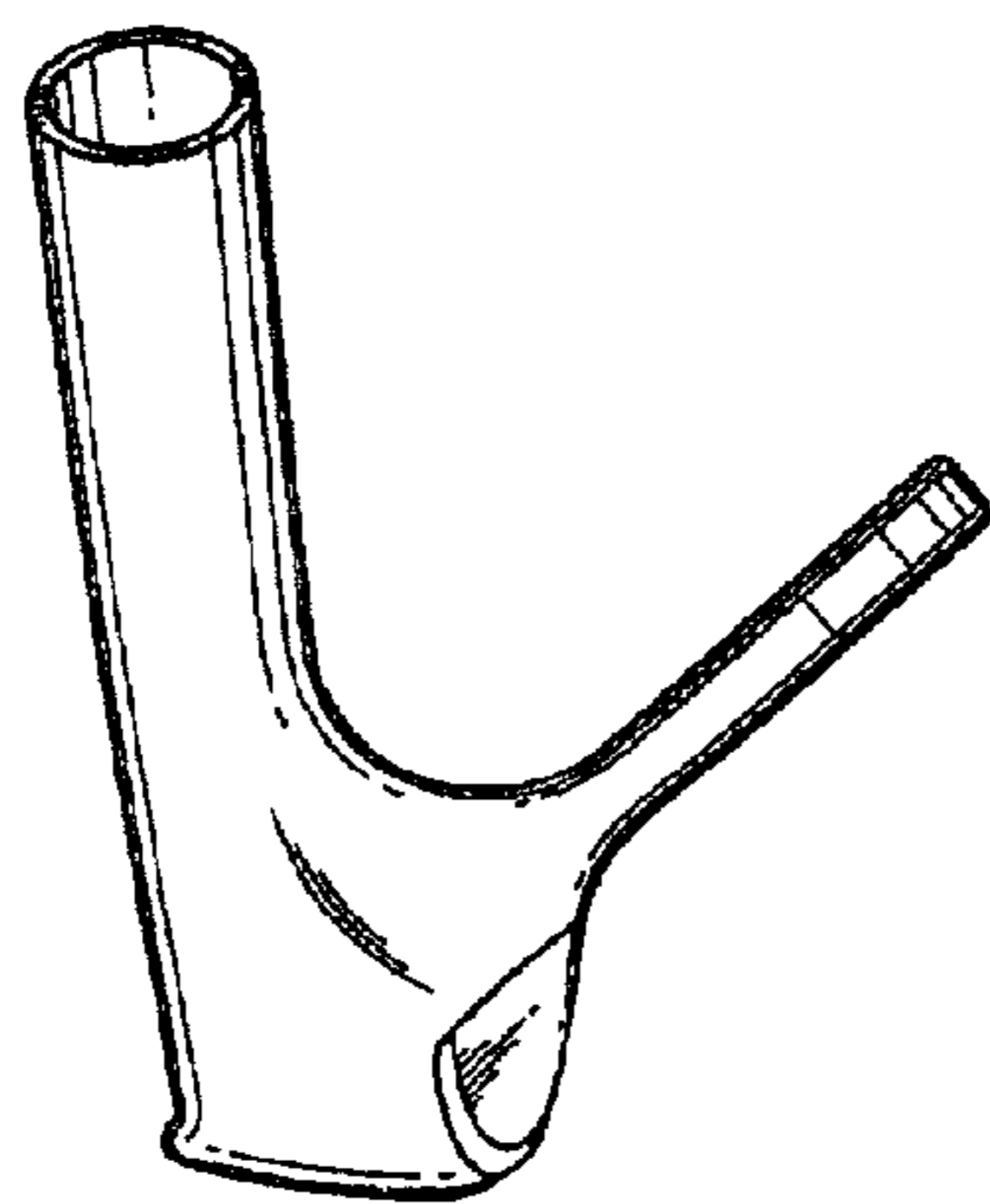
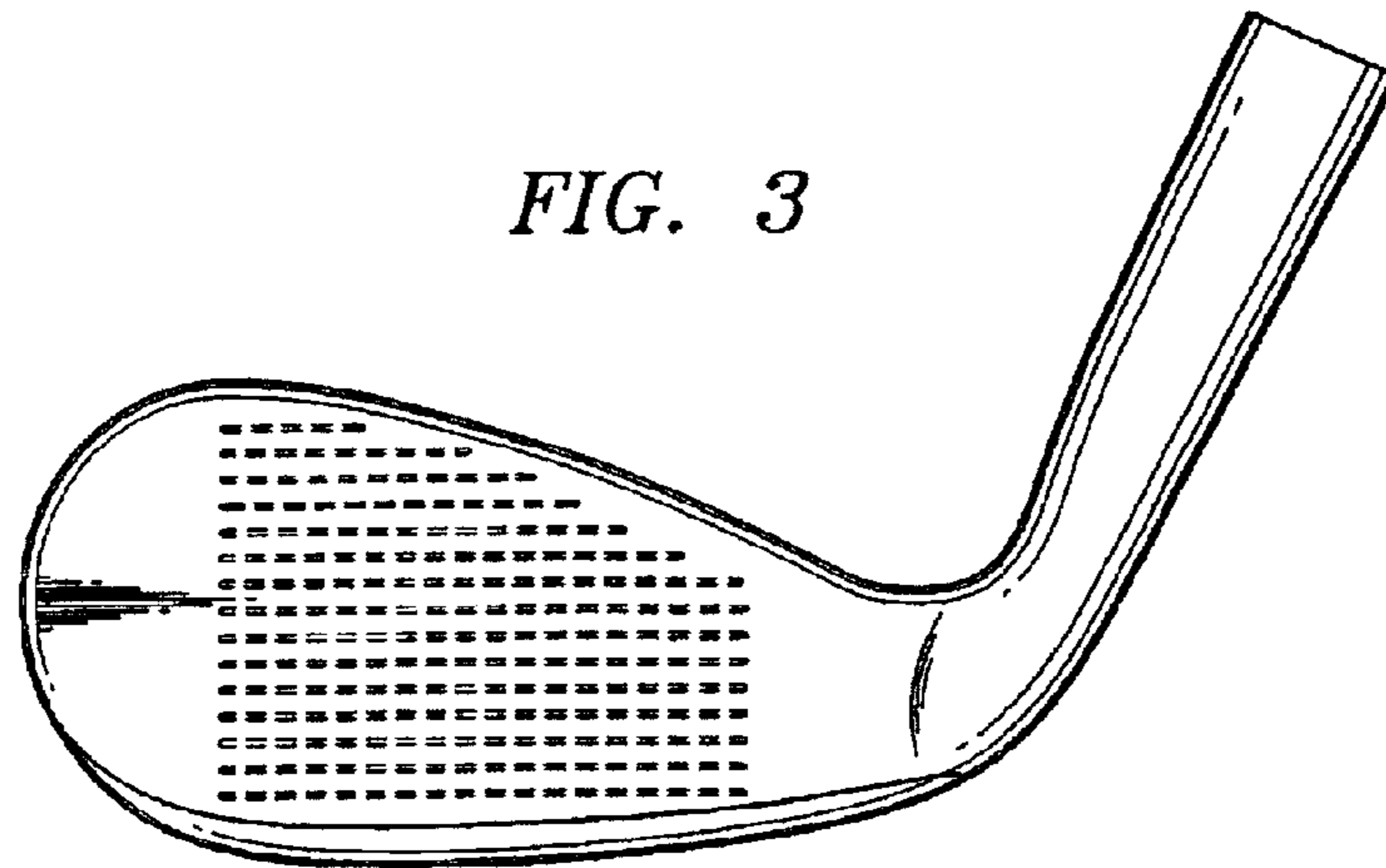
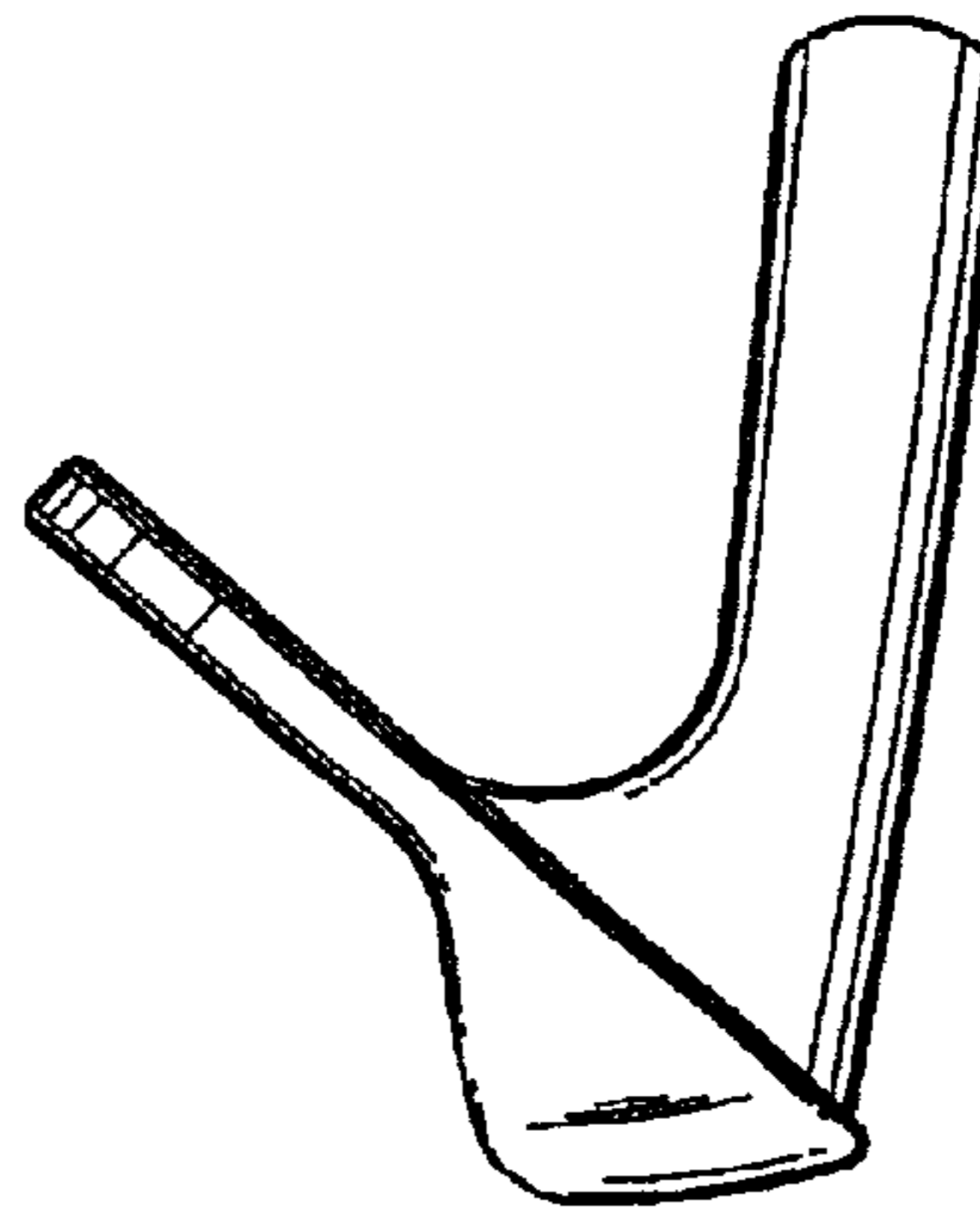


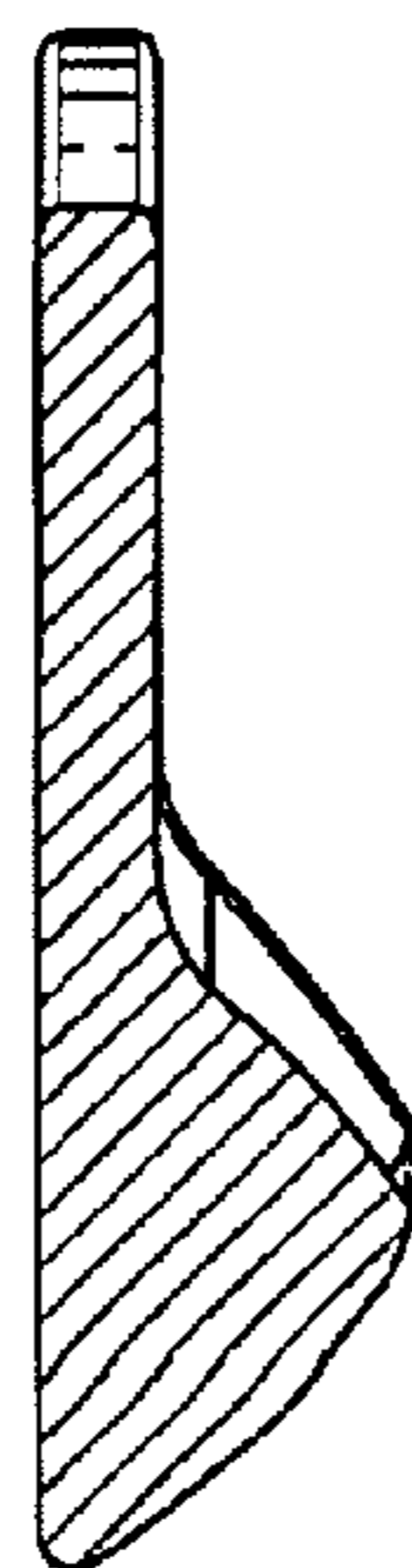
