The ornamental design for a head for golf club, as shown and described.

**DESCRIPTION**

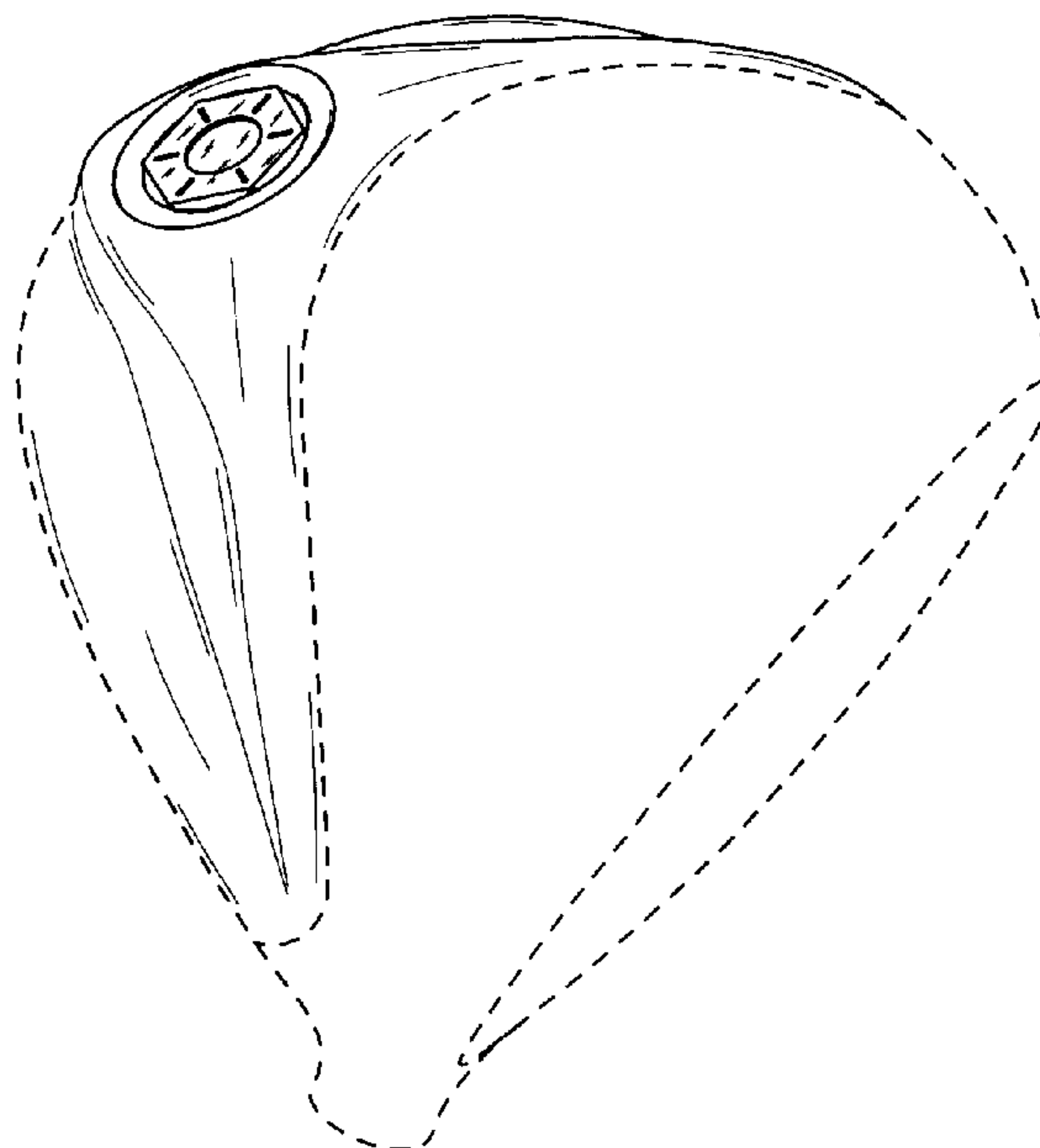

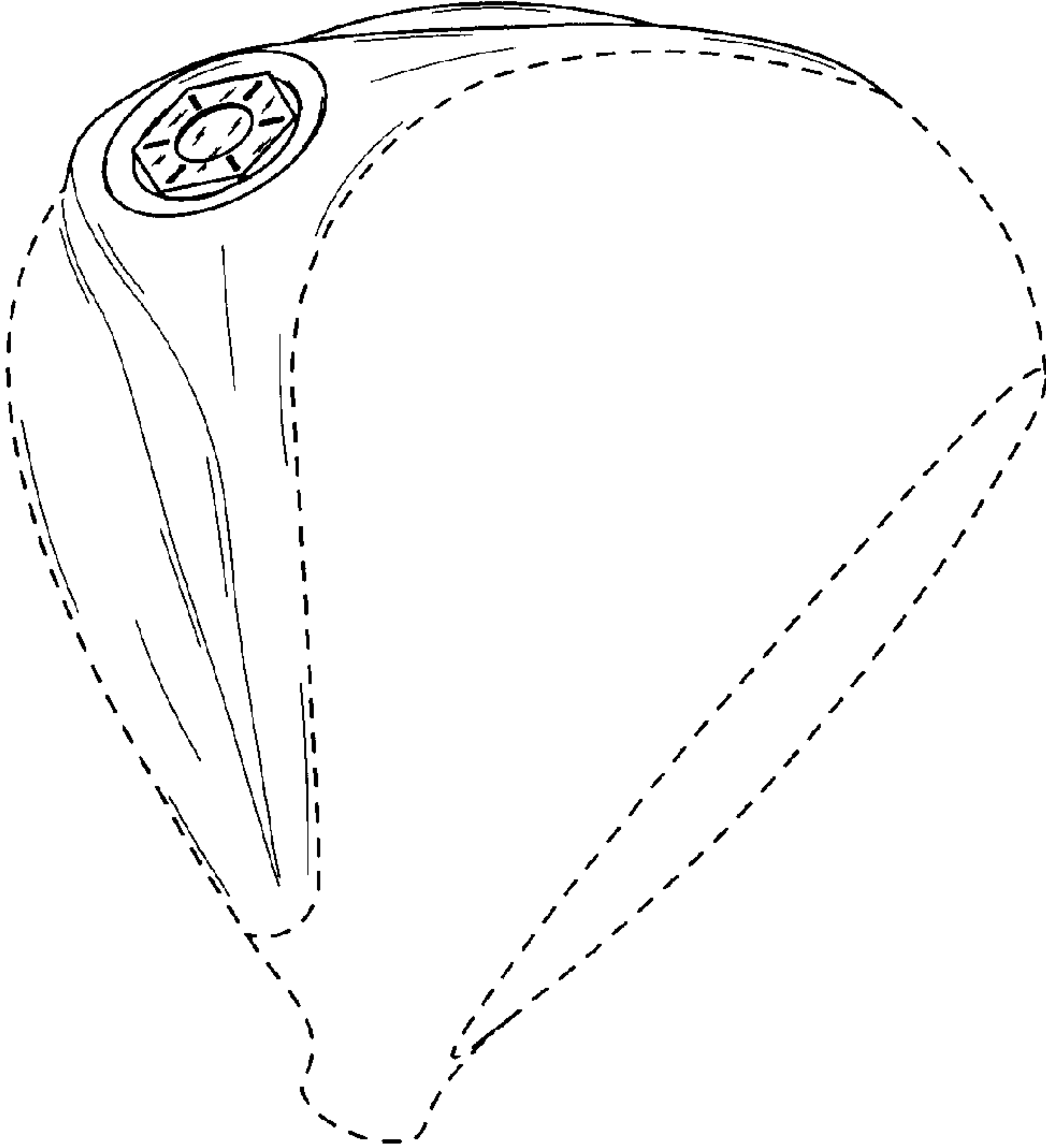

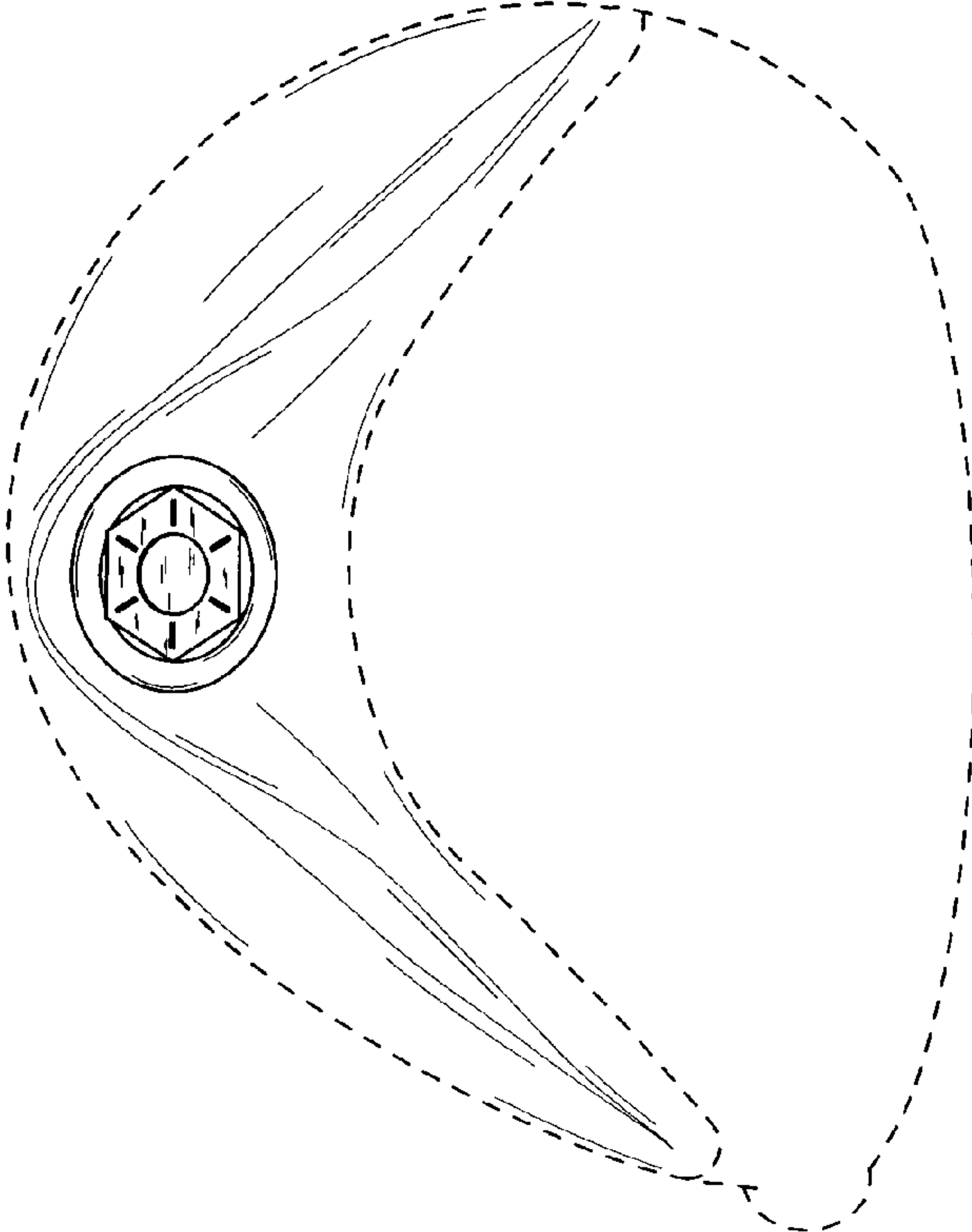

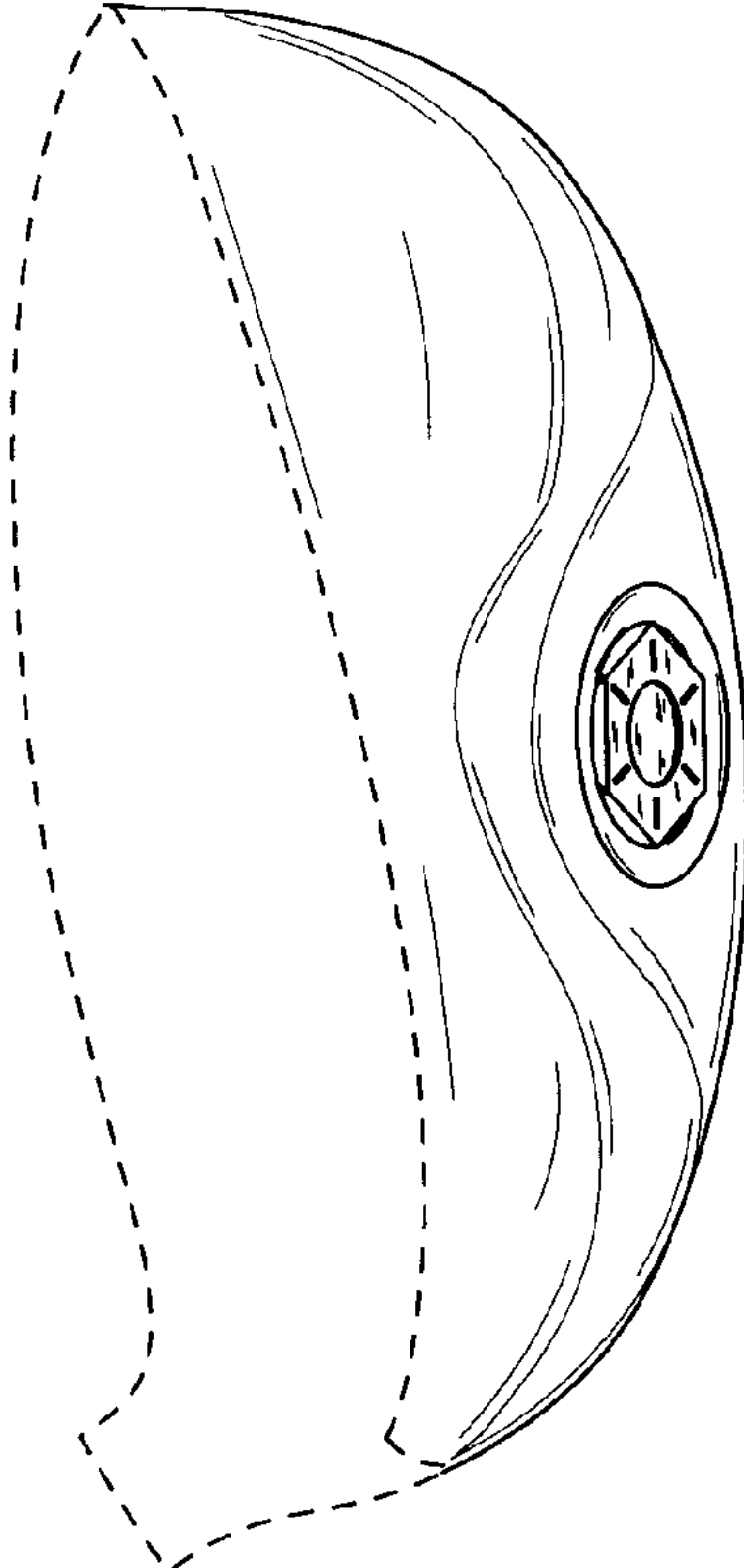

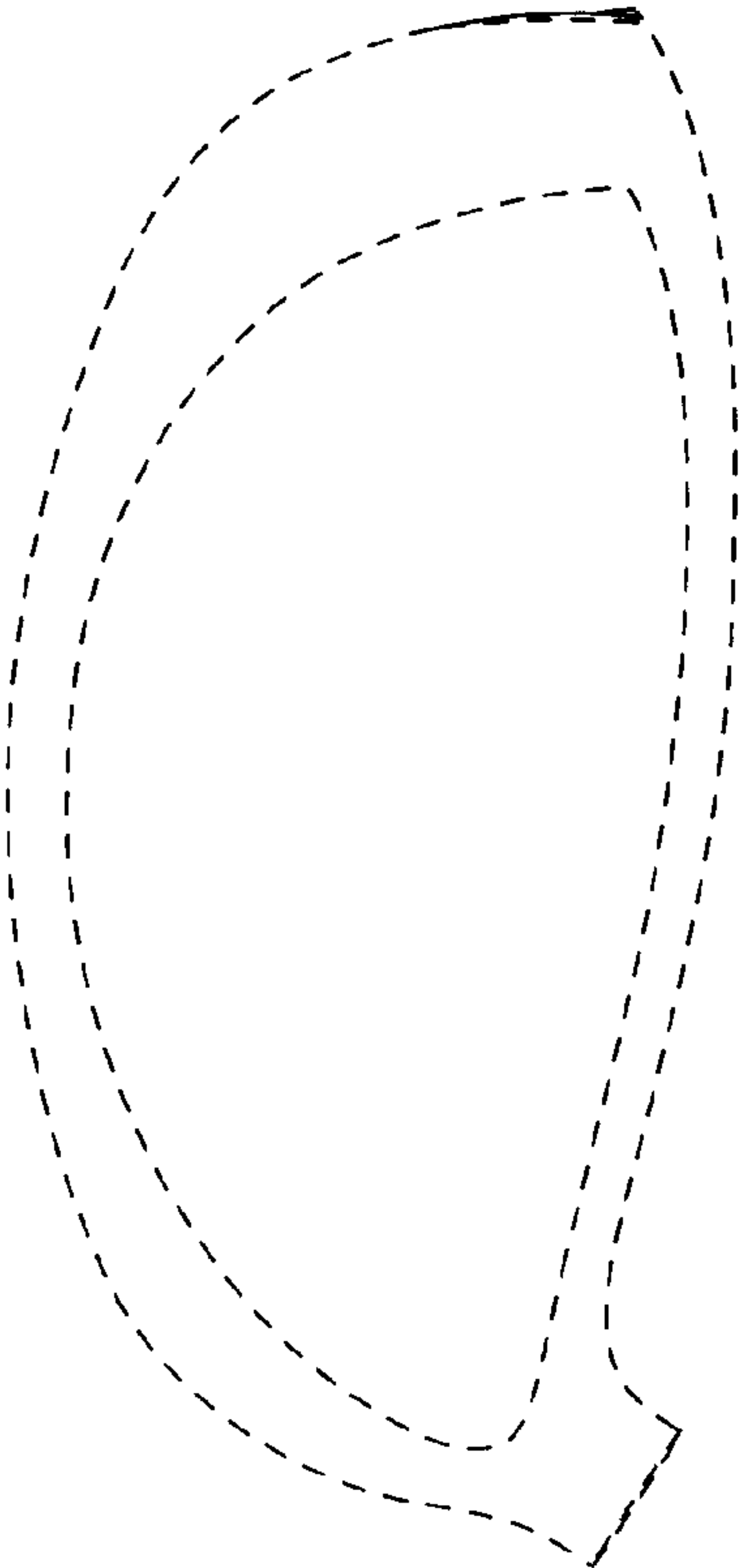

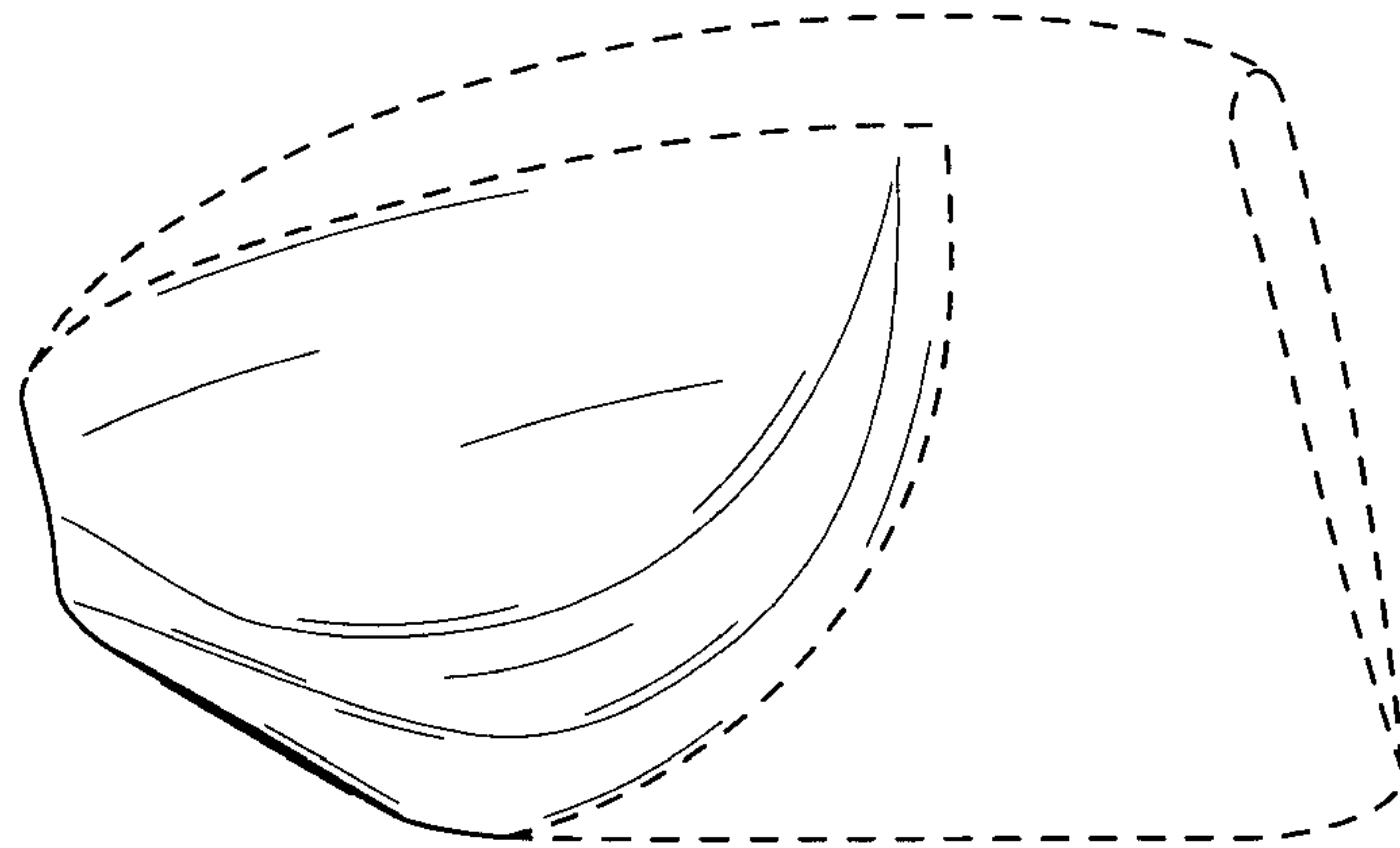
