FIG. 4 is a top plan view of the combination ceiling fan and light fixture in accordance with my design;

FIG. 5 is a bottom plan view of the combination ceiling fan and light fixture in accordance with my design;

FIG. 6 is a front elevation view of the combination ceiling fan and light fixture in accordance with my design, the opposite side being a mirror image of that shown; and,

FIG. 7 is a side elevation view of the combination ceiling fan and light fixture in accordance with my design, the opposite side being a mirror image of that shown.

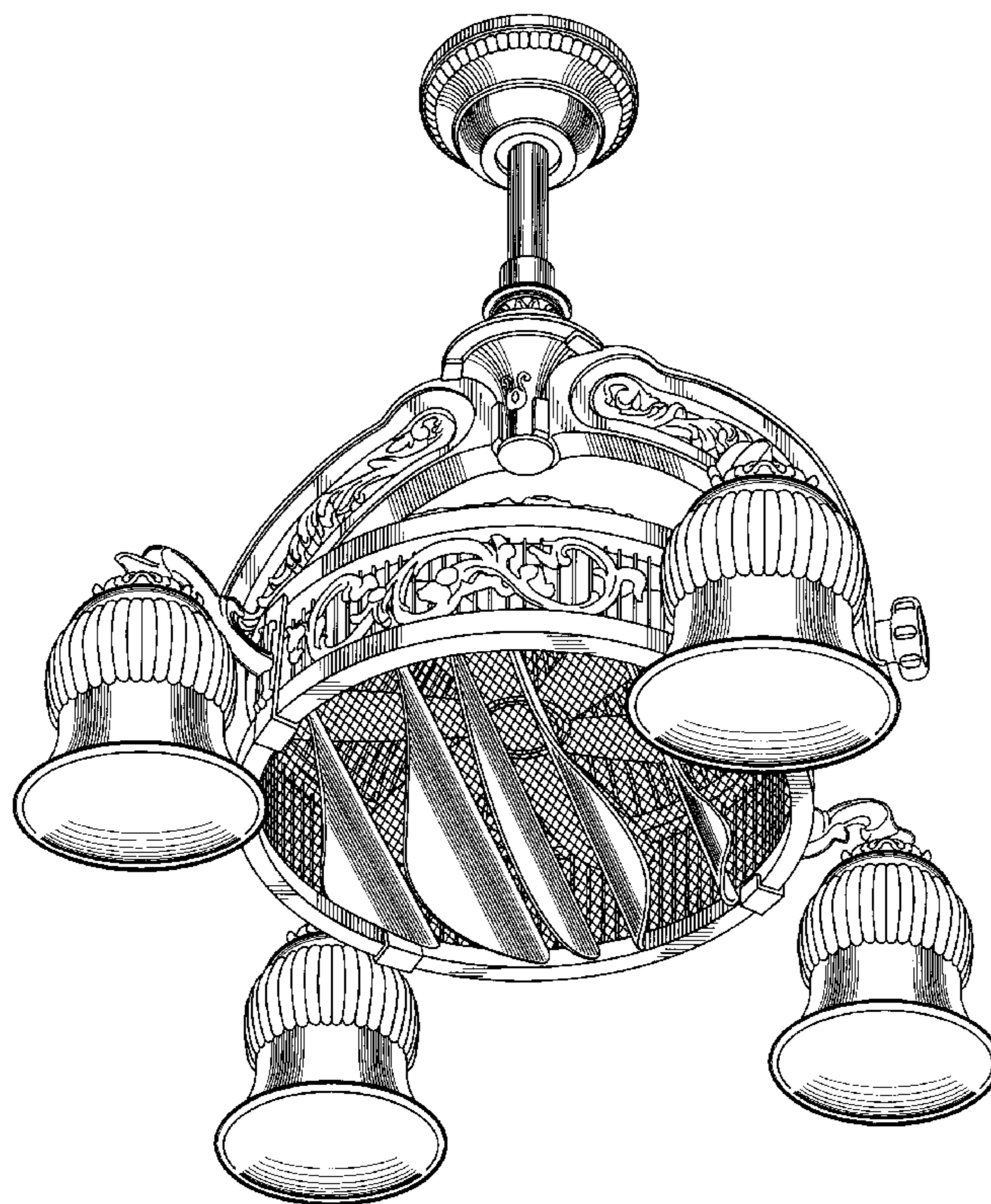

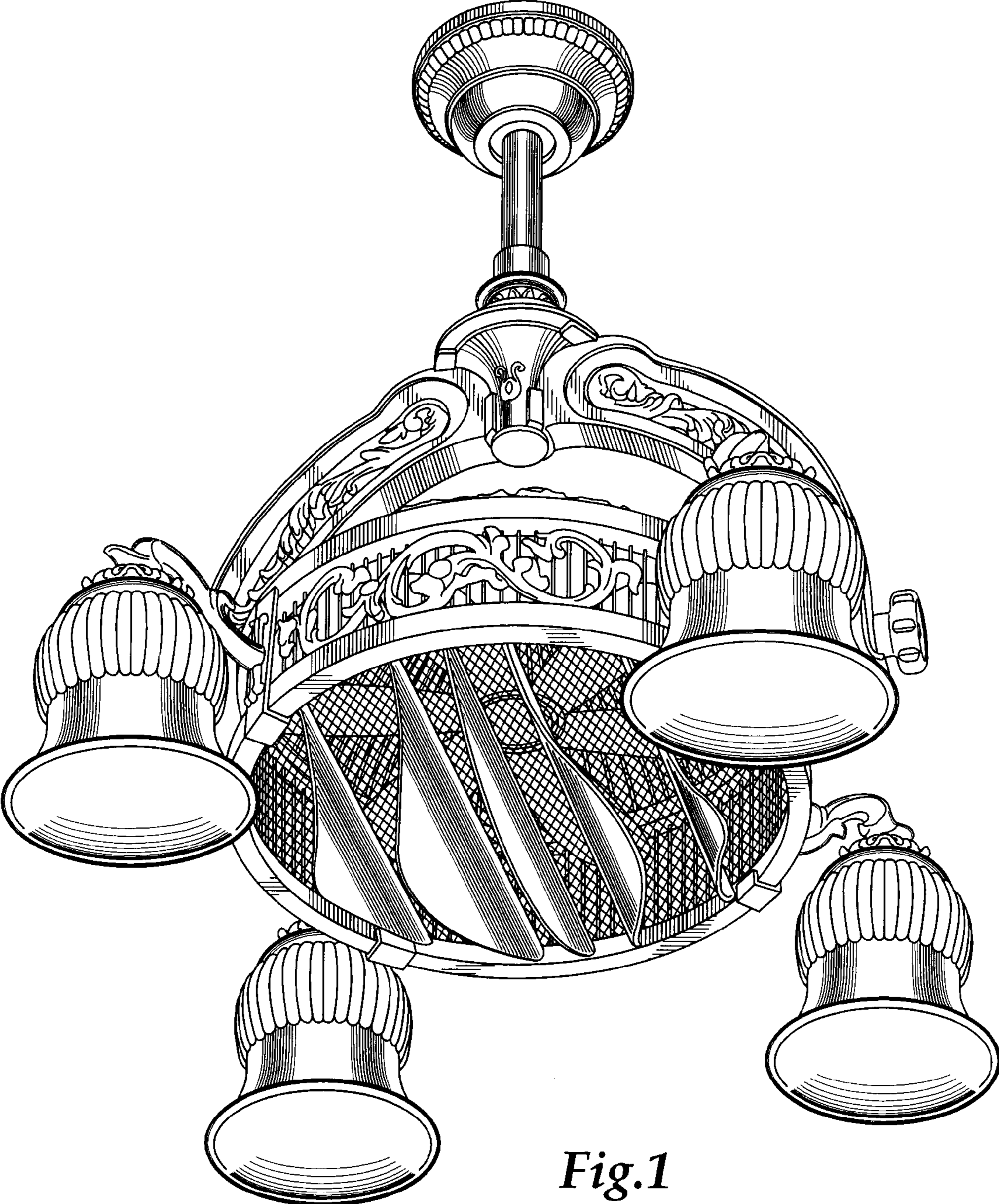

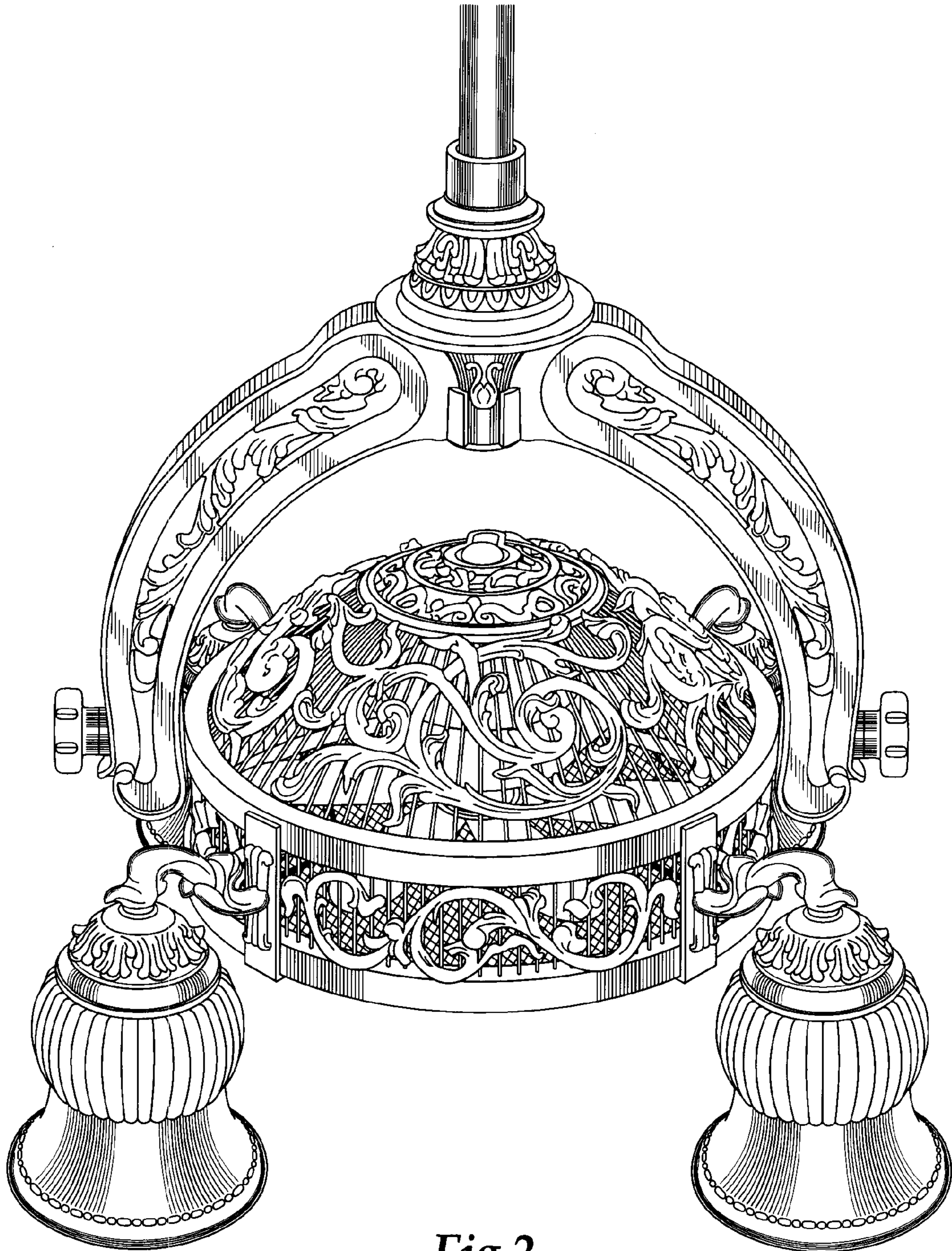

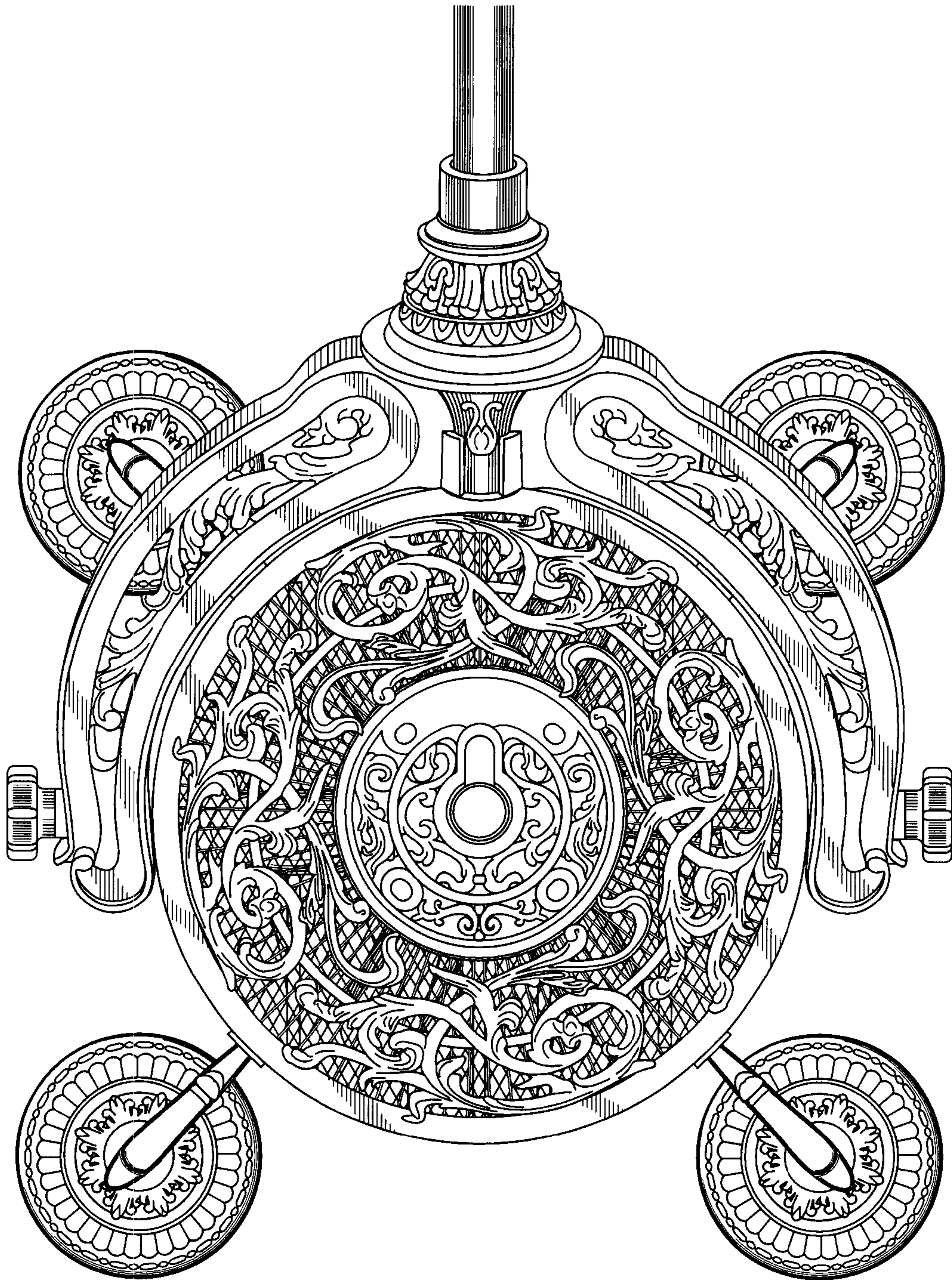

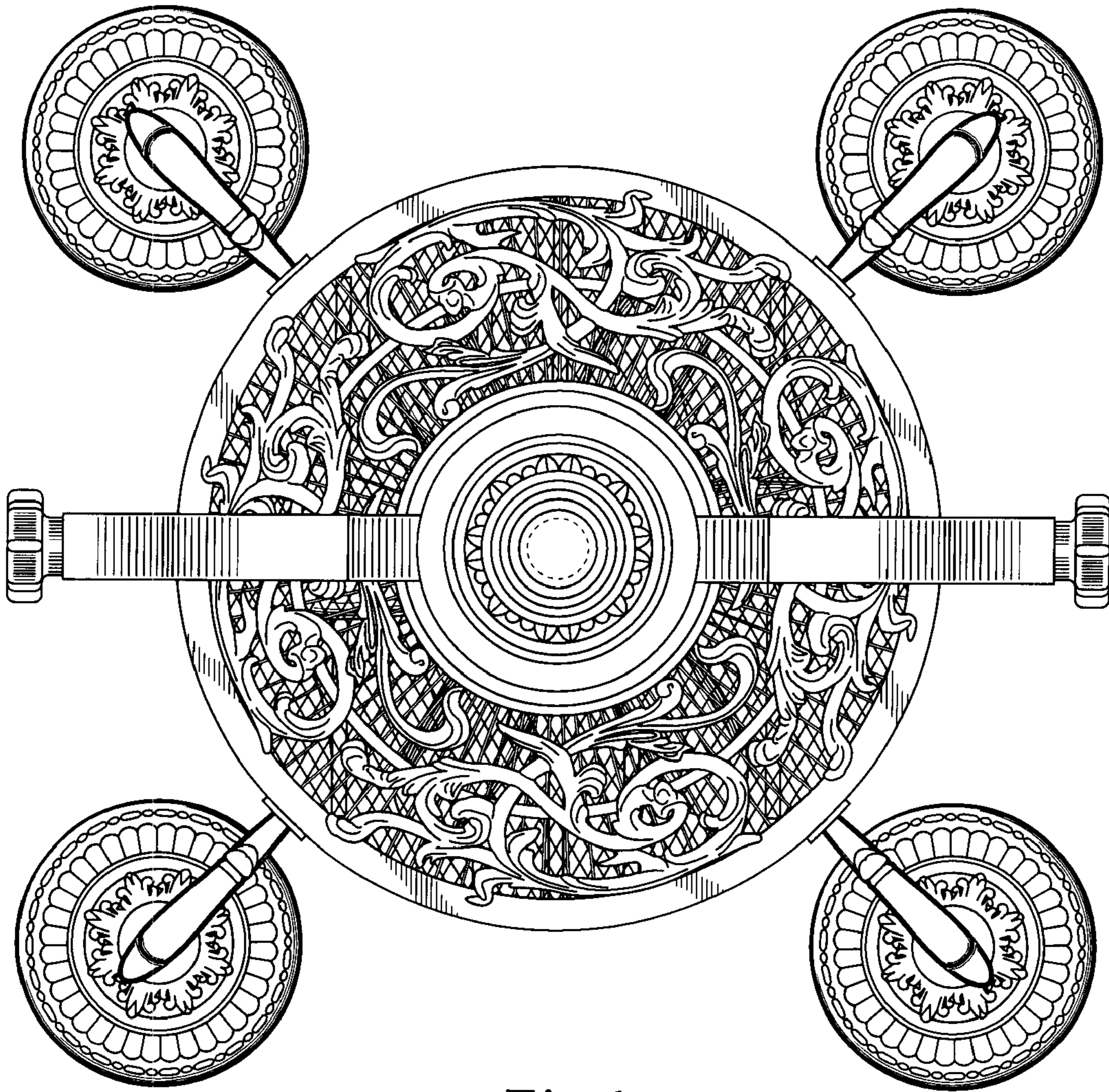

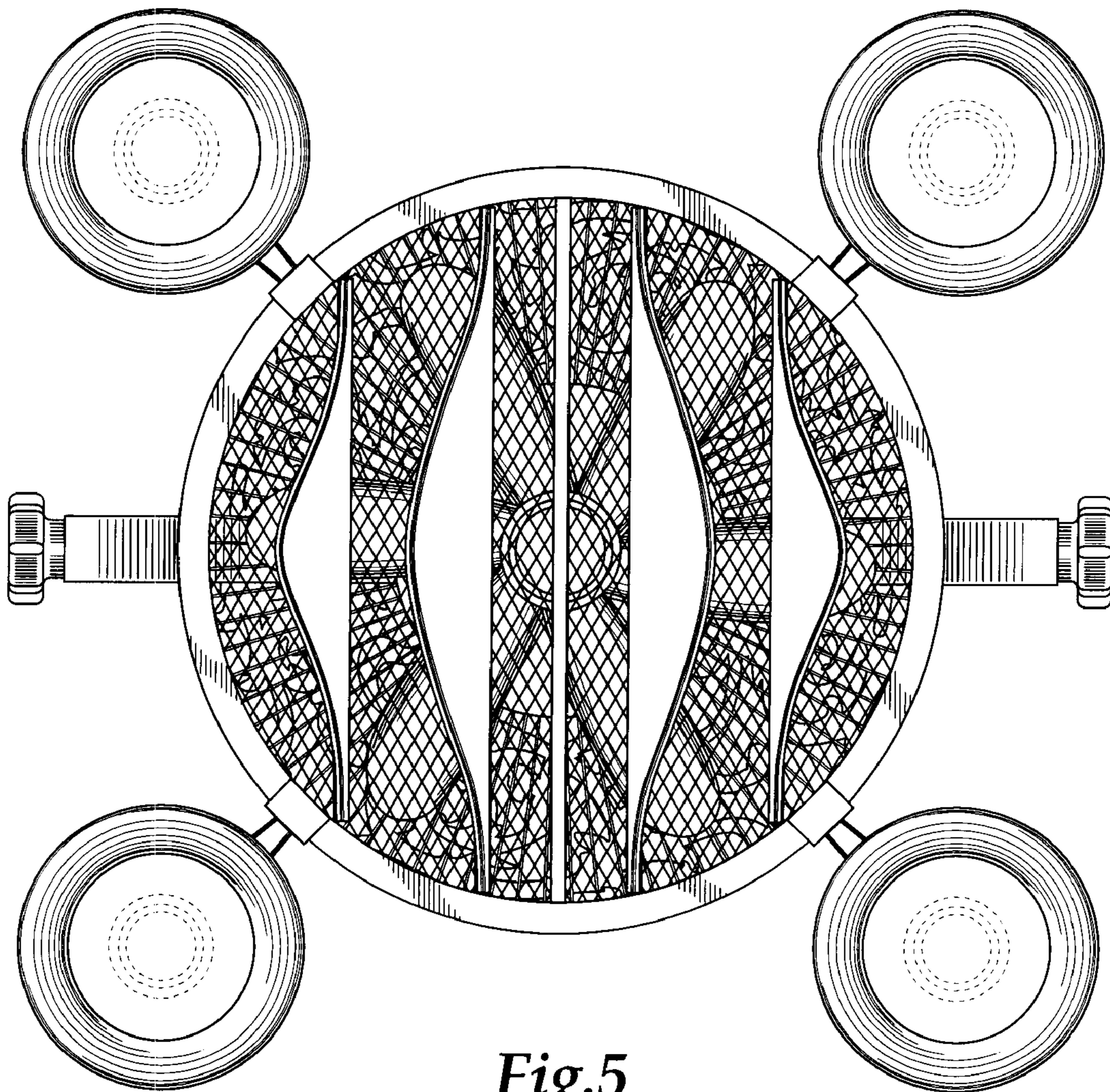

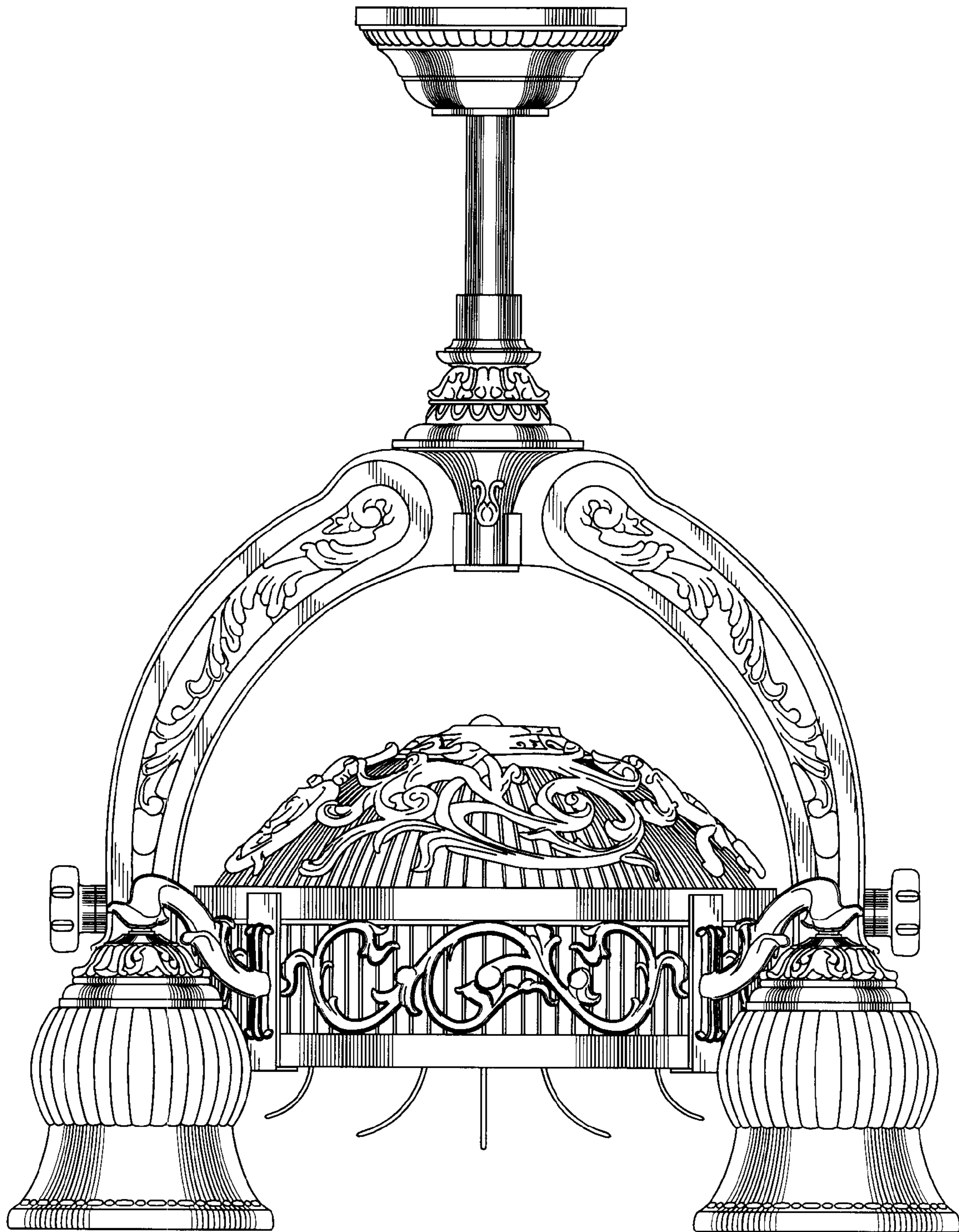

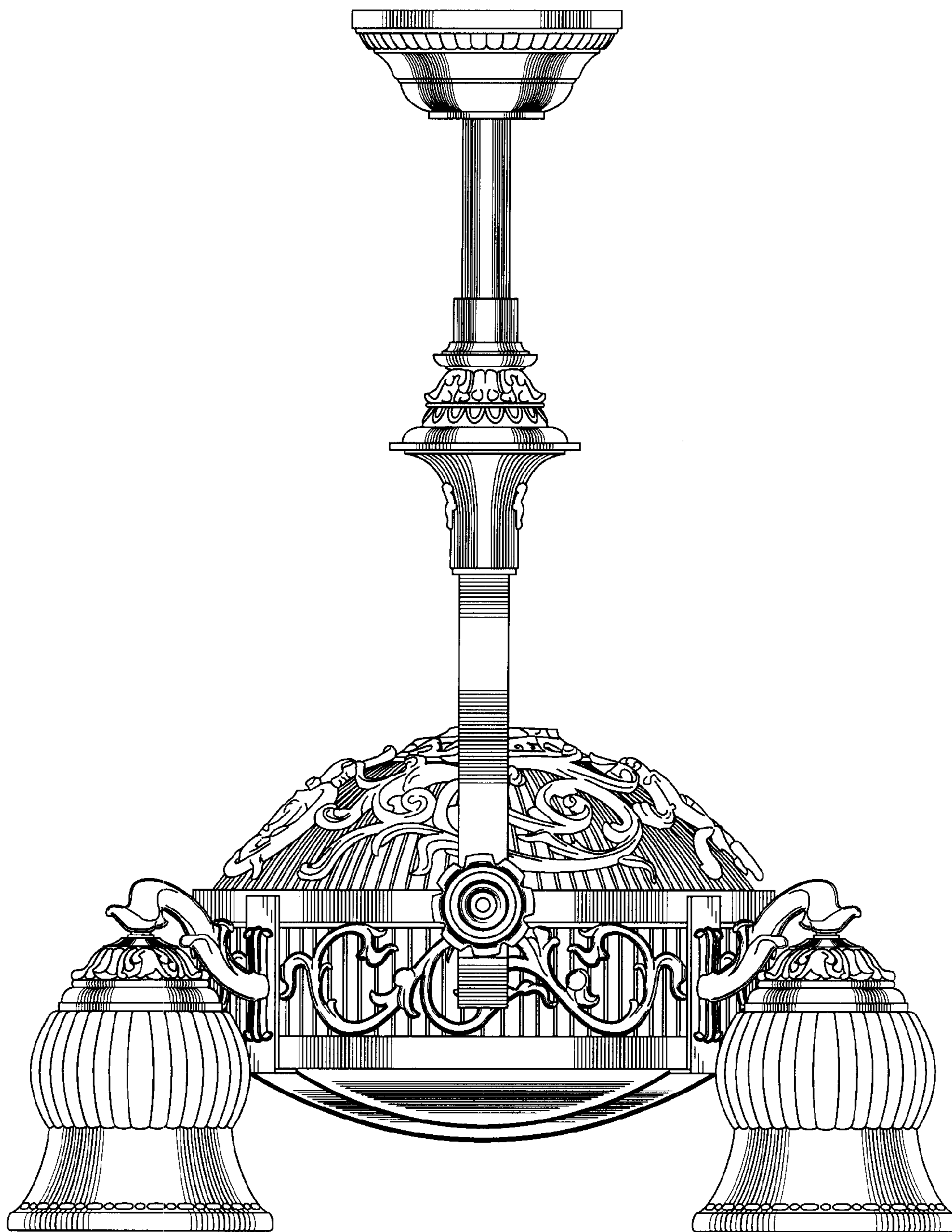
