(57) **CLAIM**

The ornamental design for a light fixture, as shown and described.

**DESCRIPTION**

This application is related to commonly owned concurrently filed U.S. design patent applications Ser. No. 29/197,587, Ser. No. 29/197,600, Ser. No. 29/197,613, Ser. No. 29/197,608, and Ser. No. 29/197,619.

FIG. 1 is a front elevational view of the light fixture of the present design, a rear elevational view being a mirror image thereof;

FIG. 2 is a left side elevational view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a top plan view of an alternative embodiment of the light fixture shown in FIG. 4;

FIG. 7 is a front elevational view of an alternative embodiment of a light fixture of the present design, a rear elevational view being a mirror image thereof;

FIG. 8 is a left side elevational view thereof;

FIG. 9 is a right side elevational view thereof;

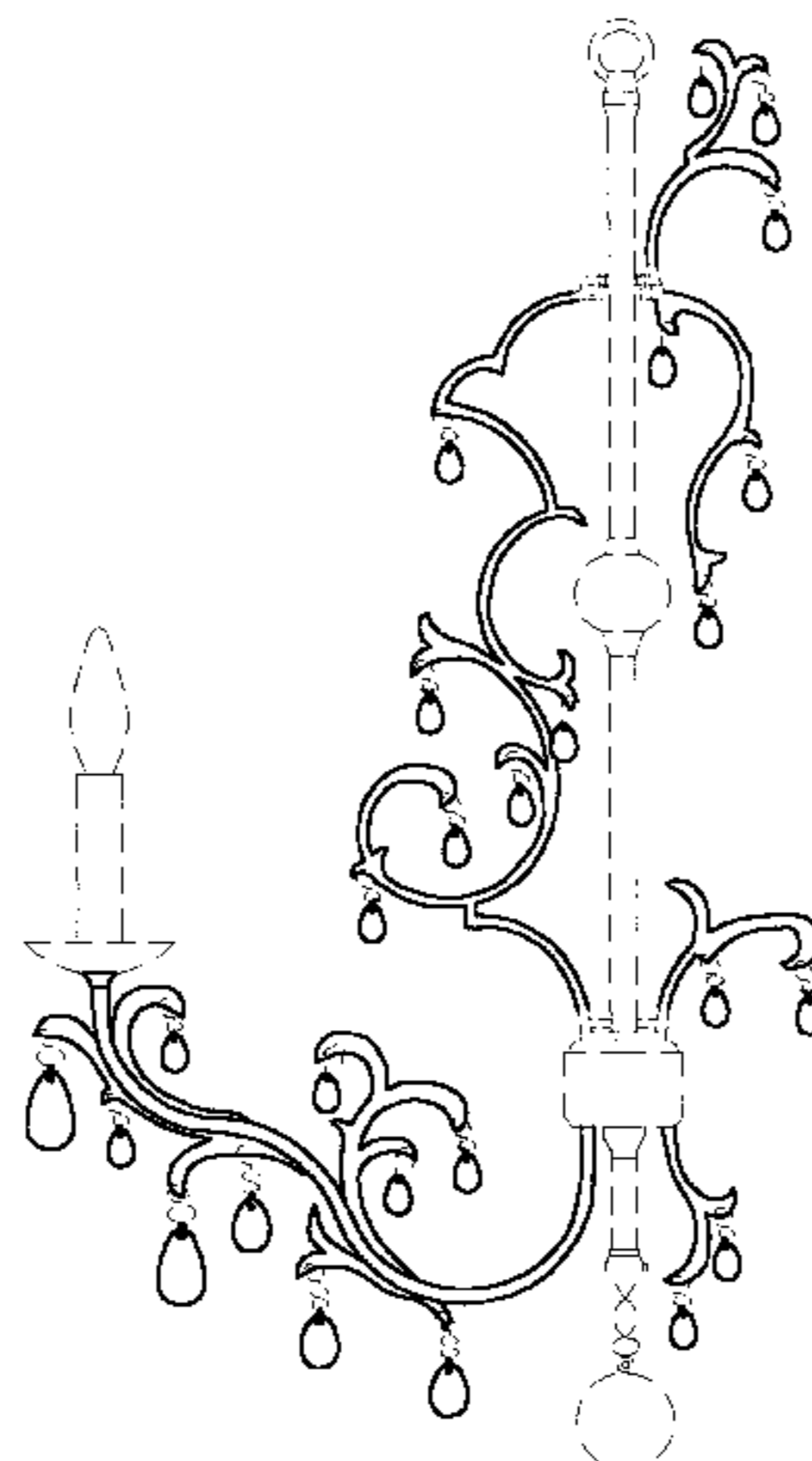
FIG. 10 is a top plan view thereof;

FIG. 11 is a bottom plan view thereof; and,

FIG. 12 is a top plan view of an alternative embodiment of the light fixture shown in FIG. 10.

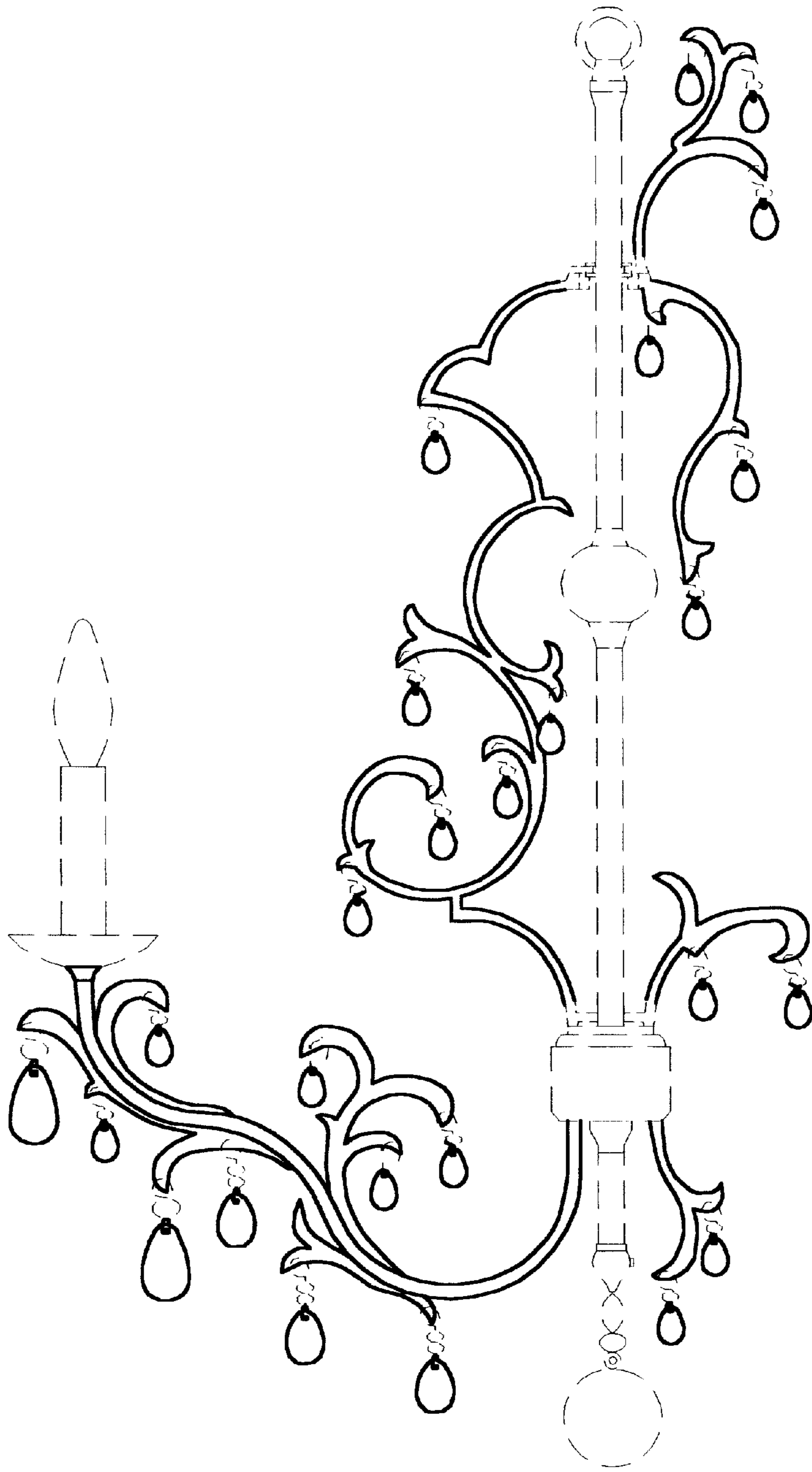

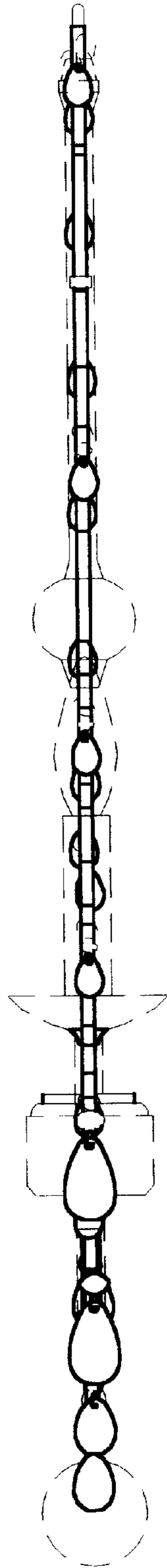

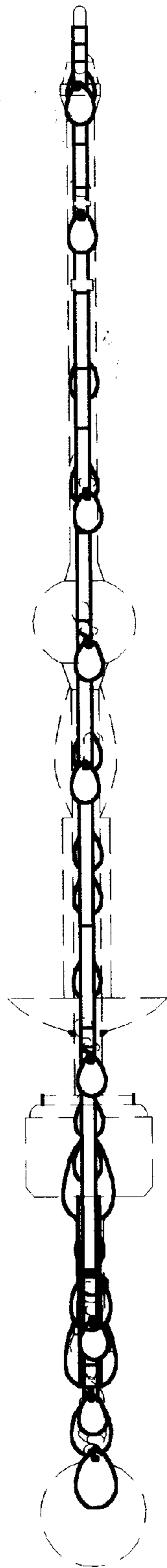

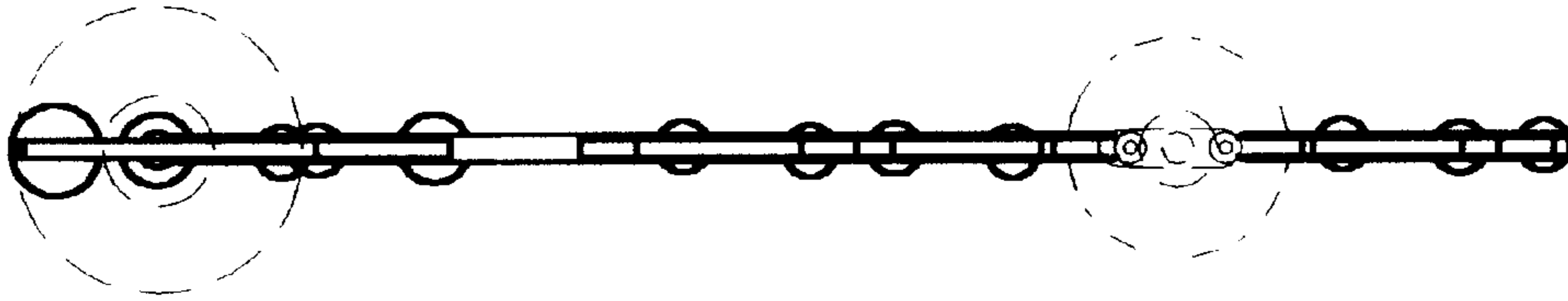

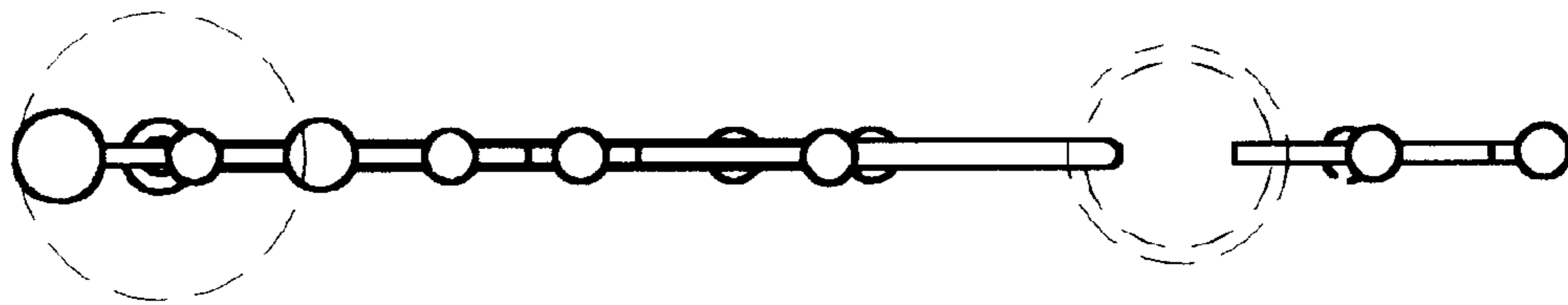

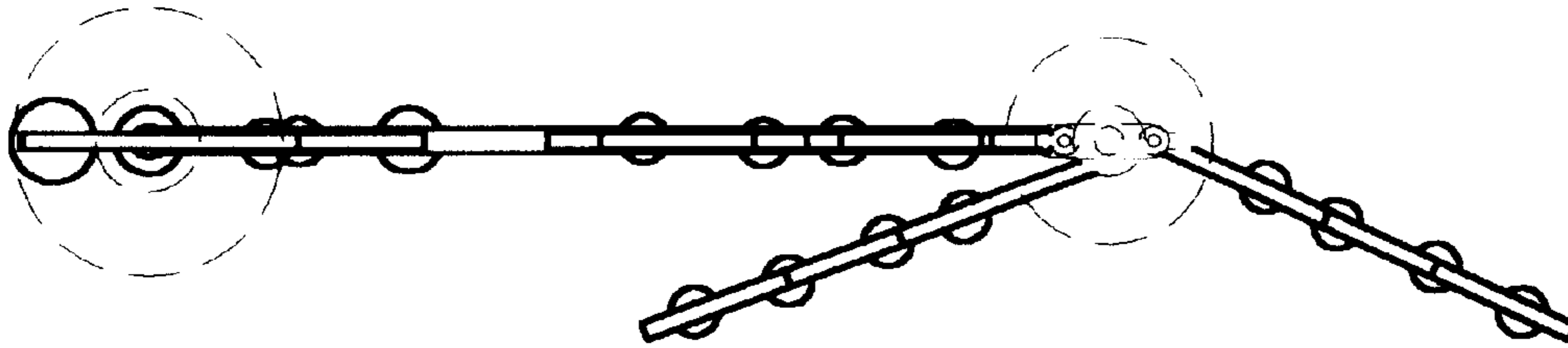

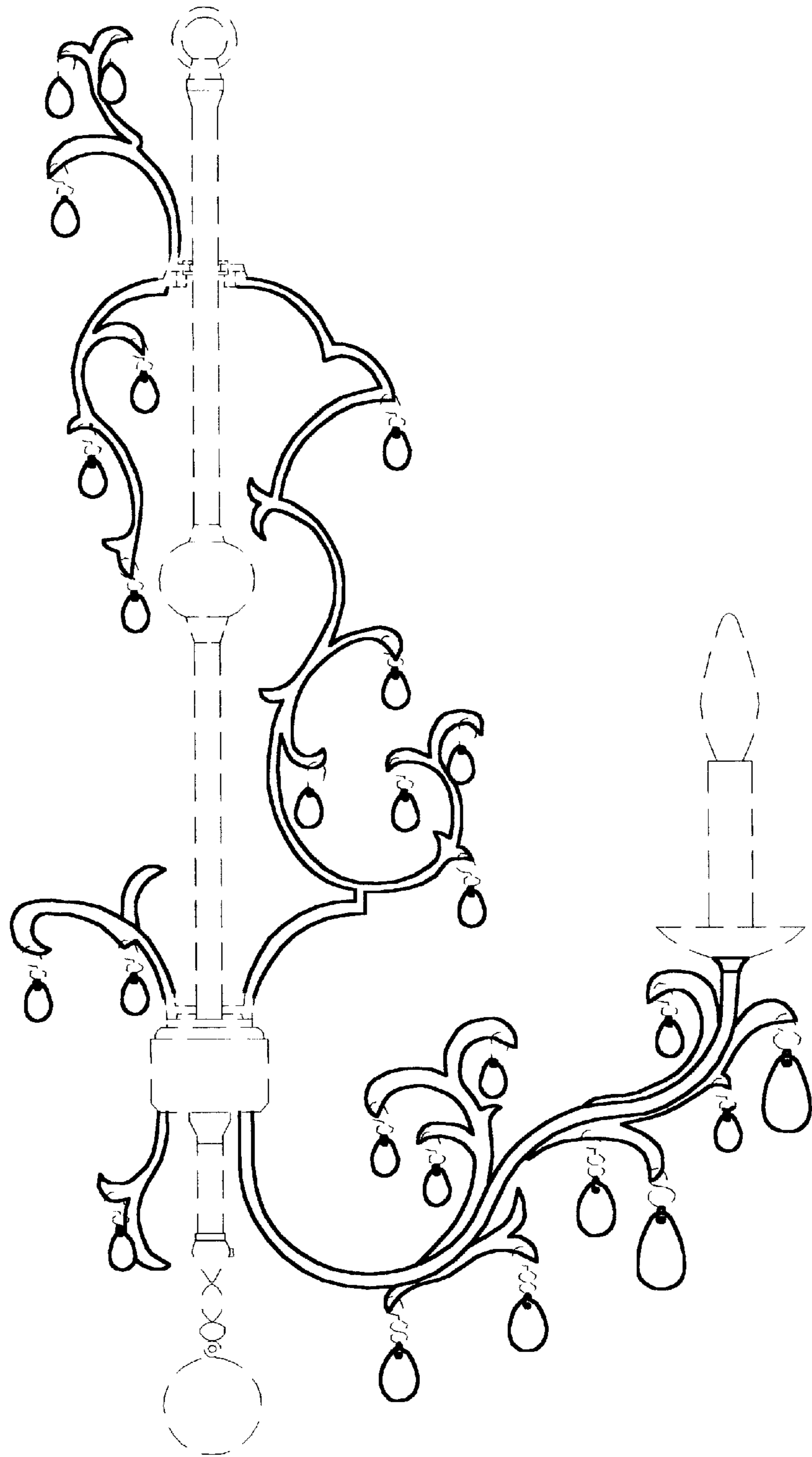

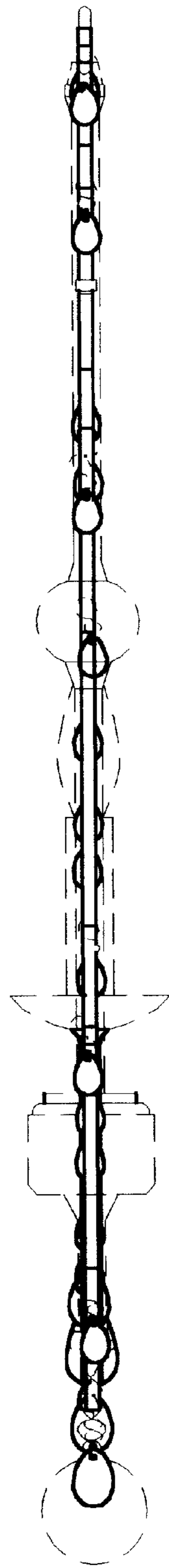

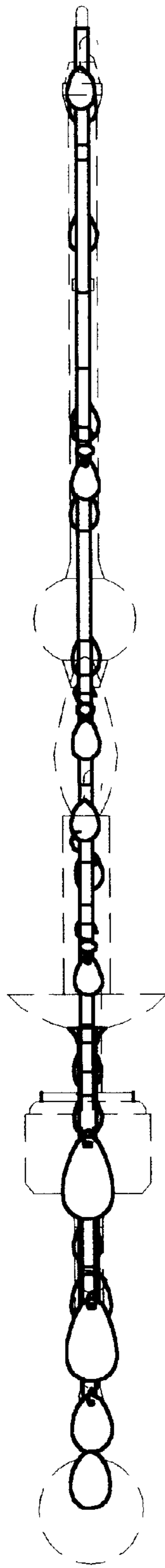

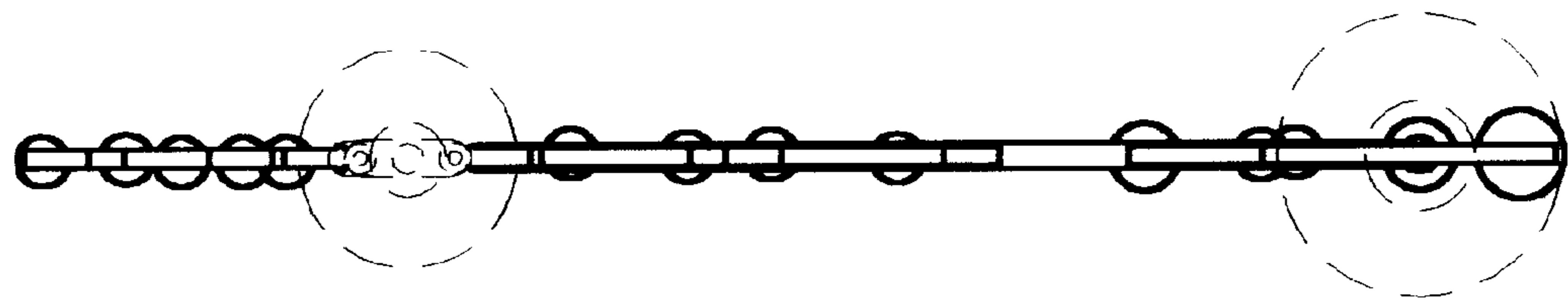

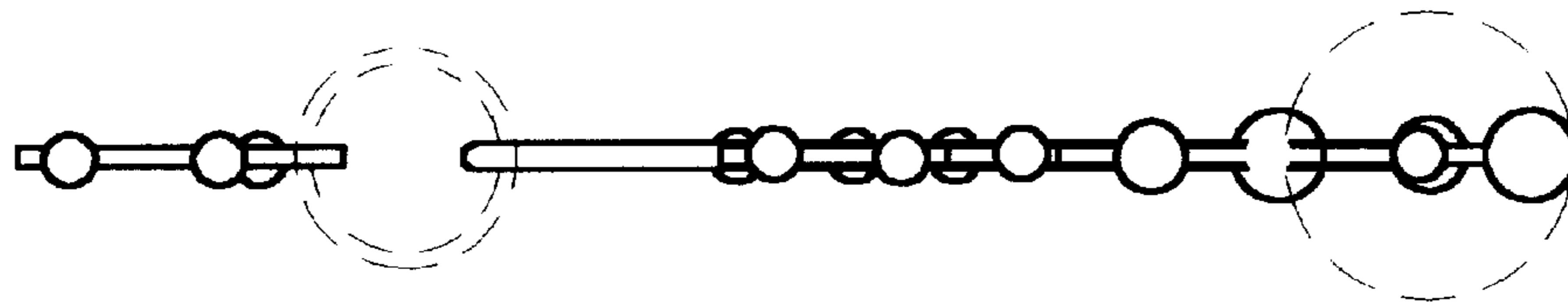

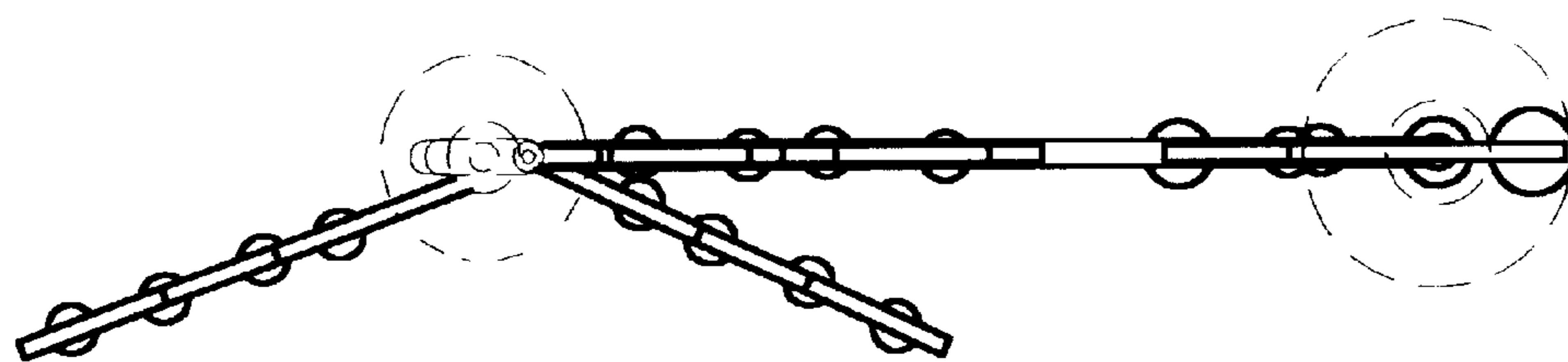
