(57) **CLAIM**

The ornamental design for a portion of a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of a portion of a shoe upper showing my new design;

FIG. 2 is a side view thereof;

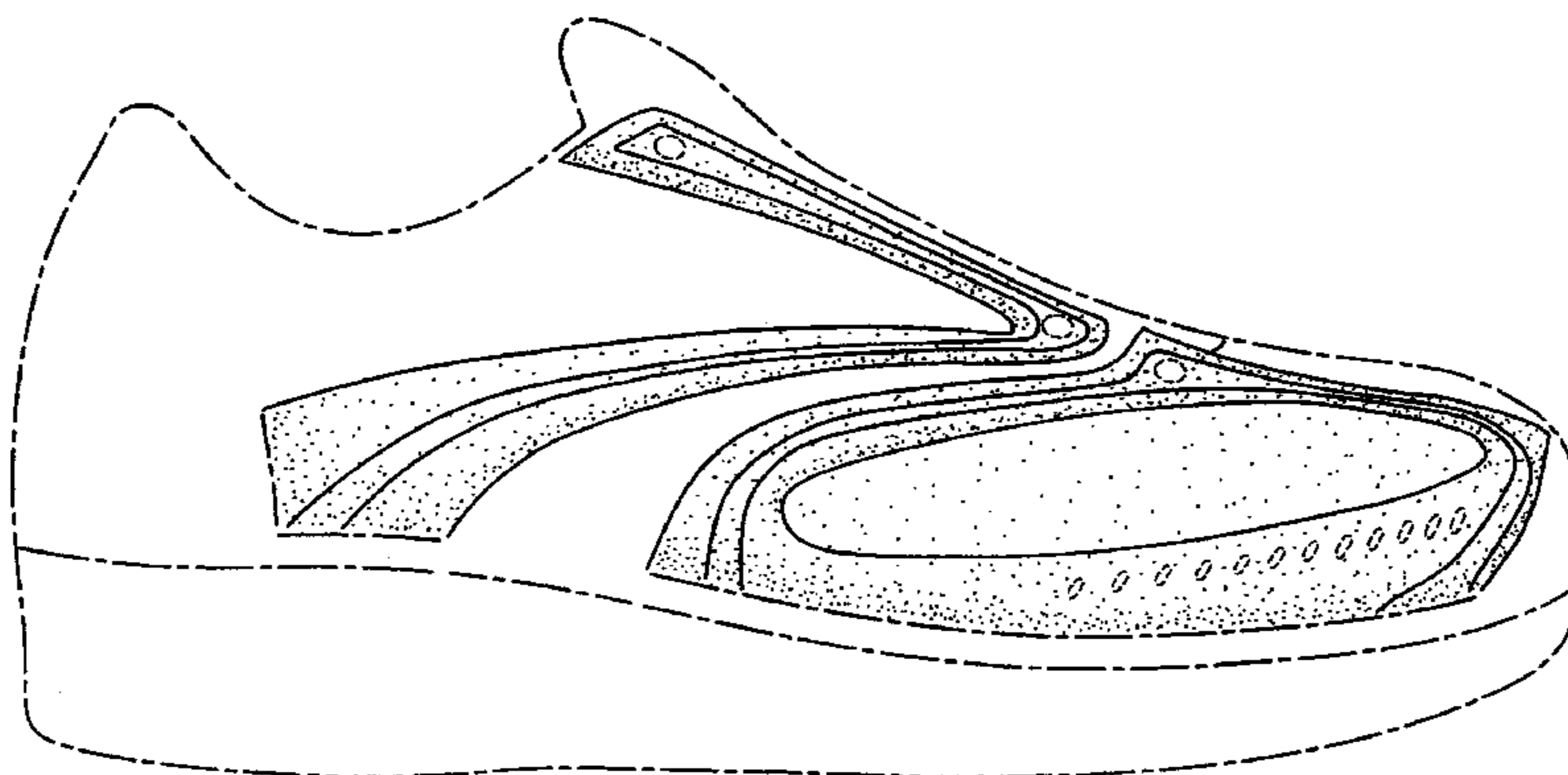
FIG. 3 is a front view thereof;

FIG. 4 is a top view thereof; and,

FIG. 5 is a second perspective view thereof.

The uneven broken line showing of the three generally circular features and the series of generally oval features in the shaded area form no part of the claimed design. The uneven broken line showing of the remainder of the shoe is for illustrative purposes only and forms no part of the claimed design.

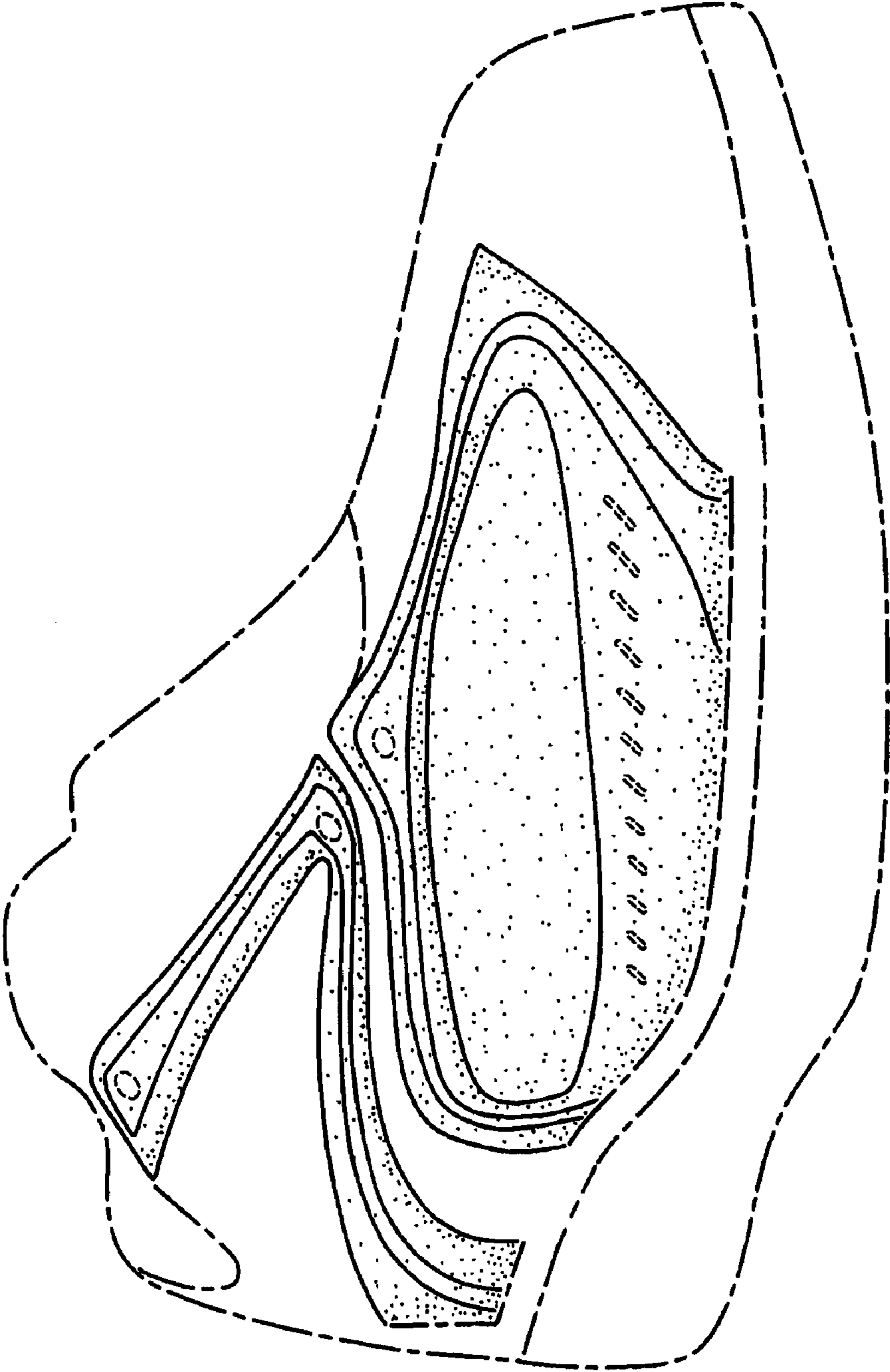

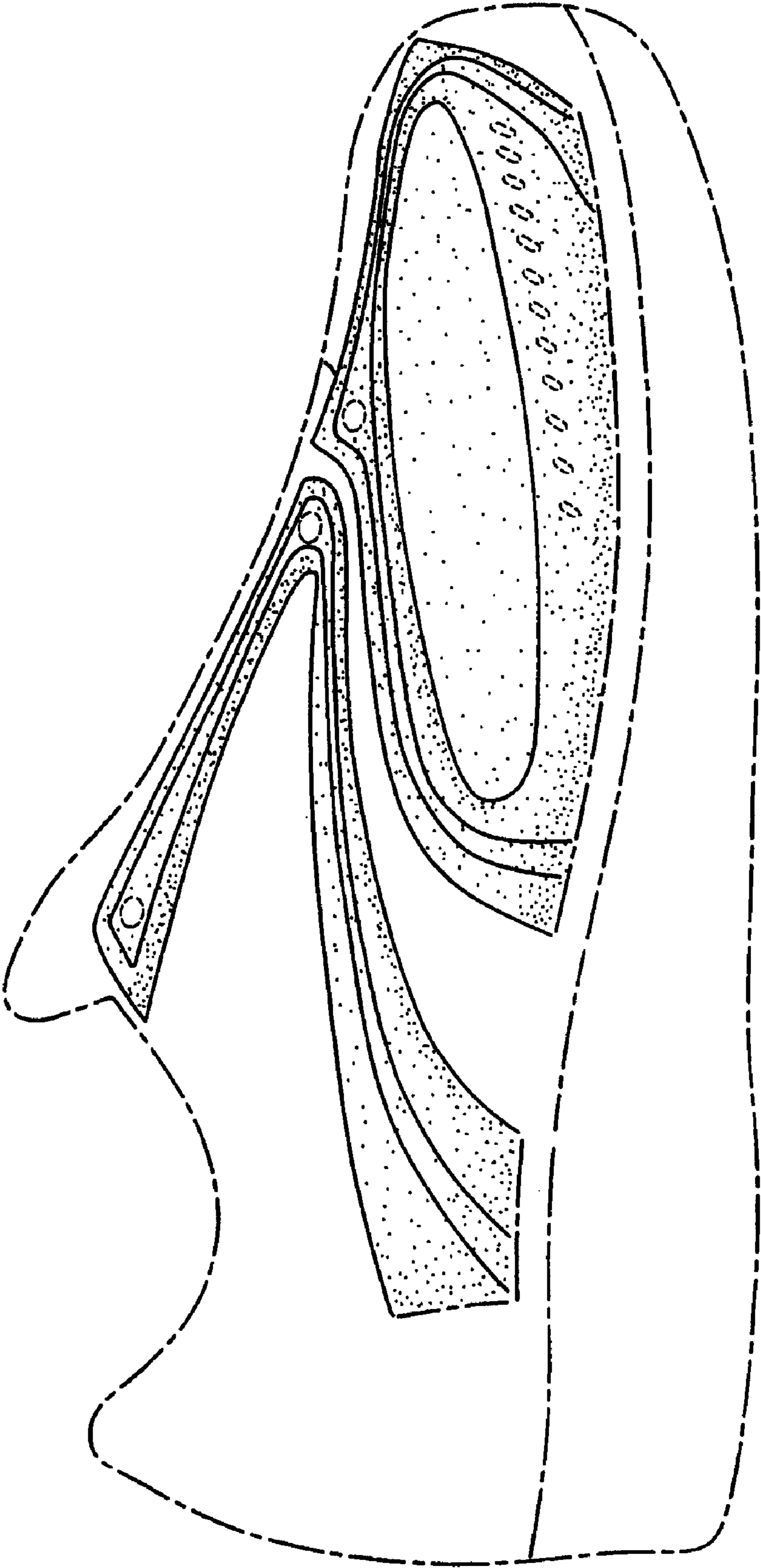

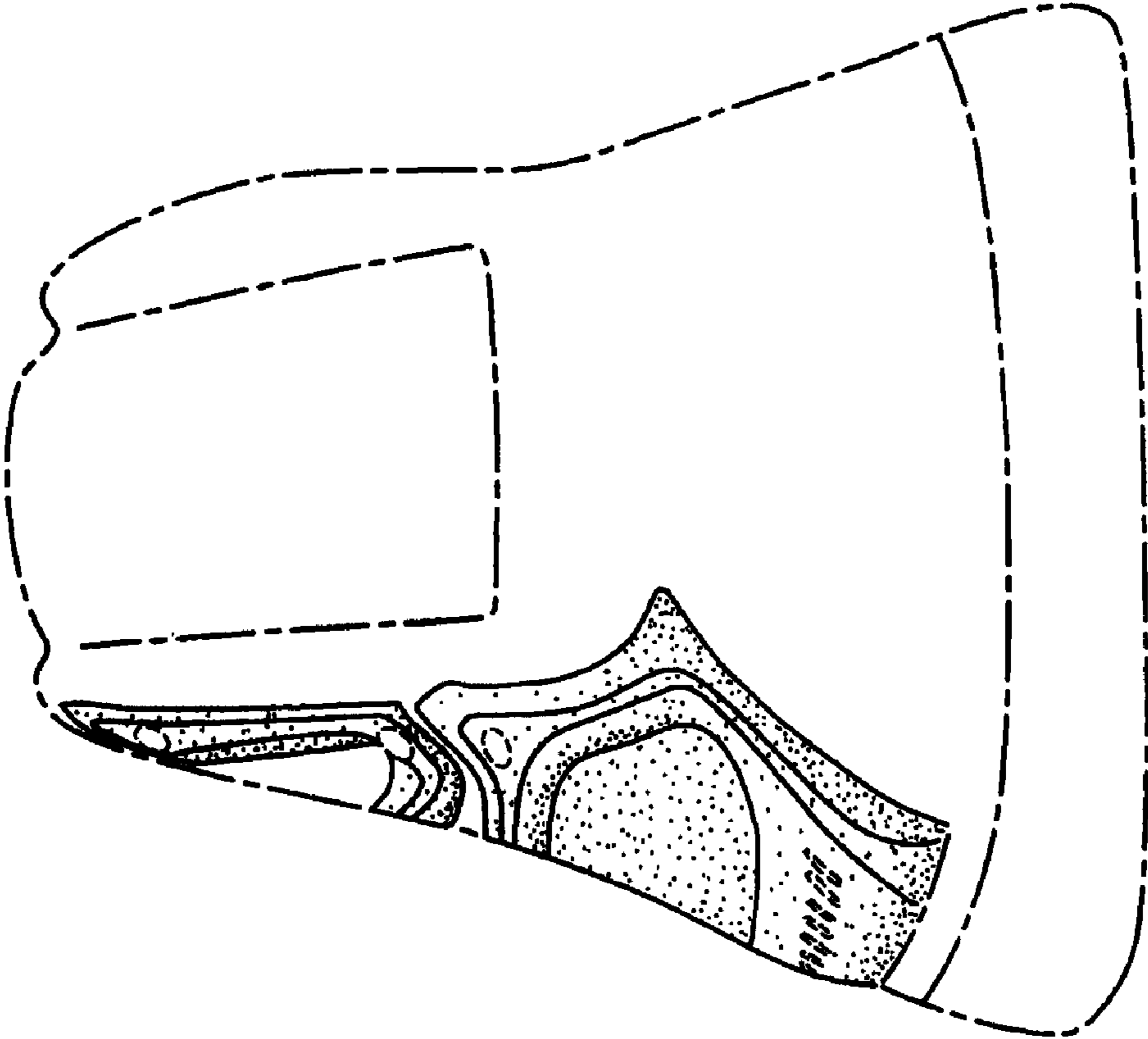

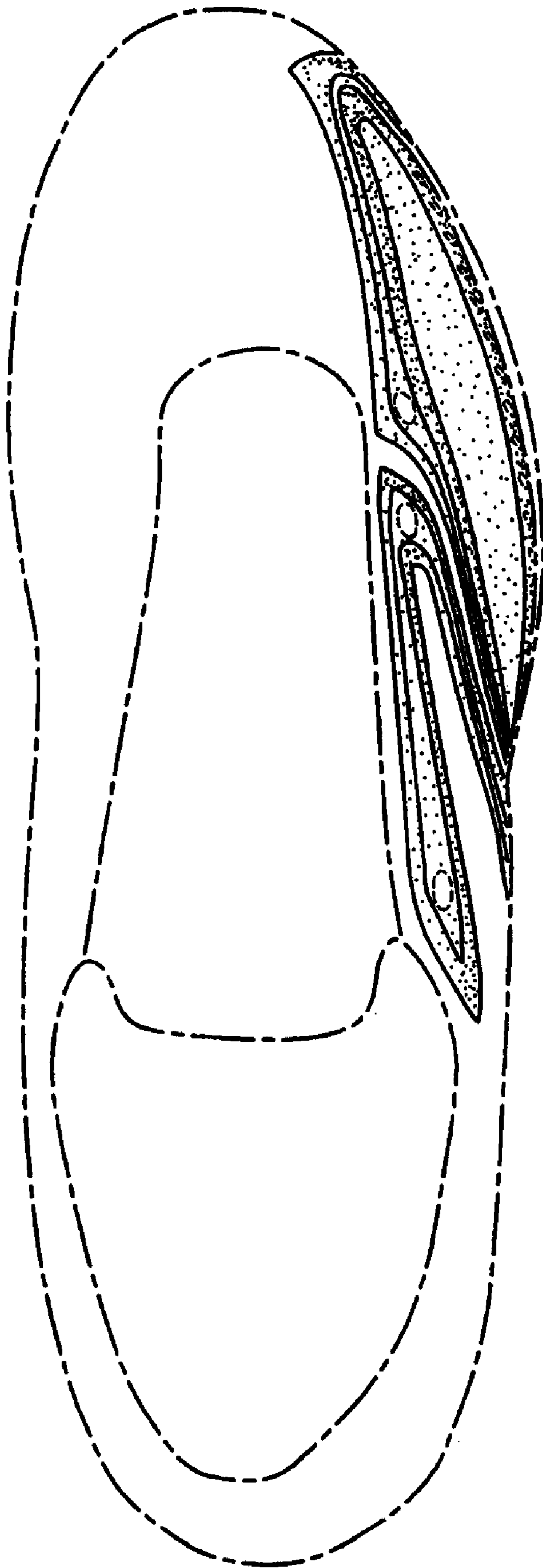
