(57) **CLAIM**

We claim the ornamental design for display portion, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a display portion according to a first embodiment of the invention.

FIG. 2 is a back view of a display portion according to a first embodiment of the invention.

FIG. 3 is a side view of a display portion according to a first embodiment of the invention.

FIG. 4 is a front perspective view of a display portion according to a second embodiment of the invention having a panel attached thereto.

FIG. 5 is a back view of a display portion according to a second embodiment of the invention having a panel attached thereto.

FIG. 6 is a side view of a display portion according to a second embodiment of the invention having a panel attached thereto.

FIG. 7 is a front perspective view of a display portion according to a third embodiment of the invention.

FIG. 8 is a back view of a display portion according to a third embodiment of the invention.

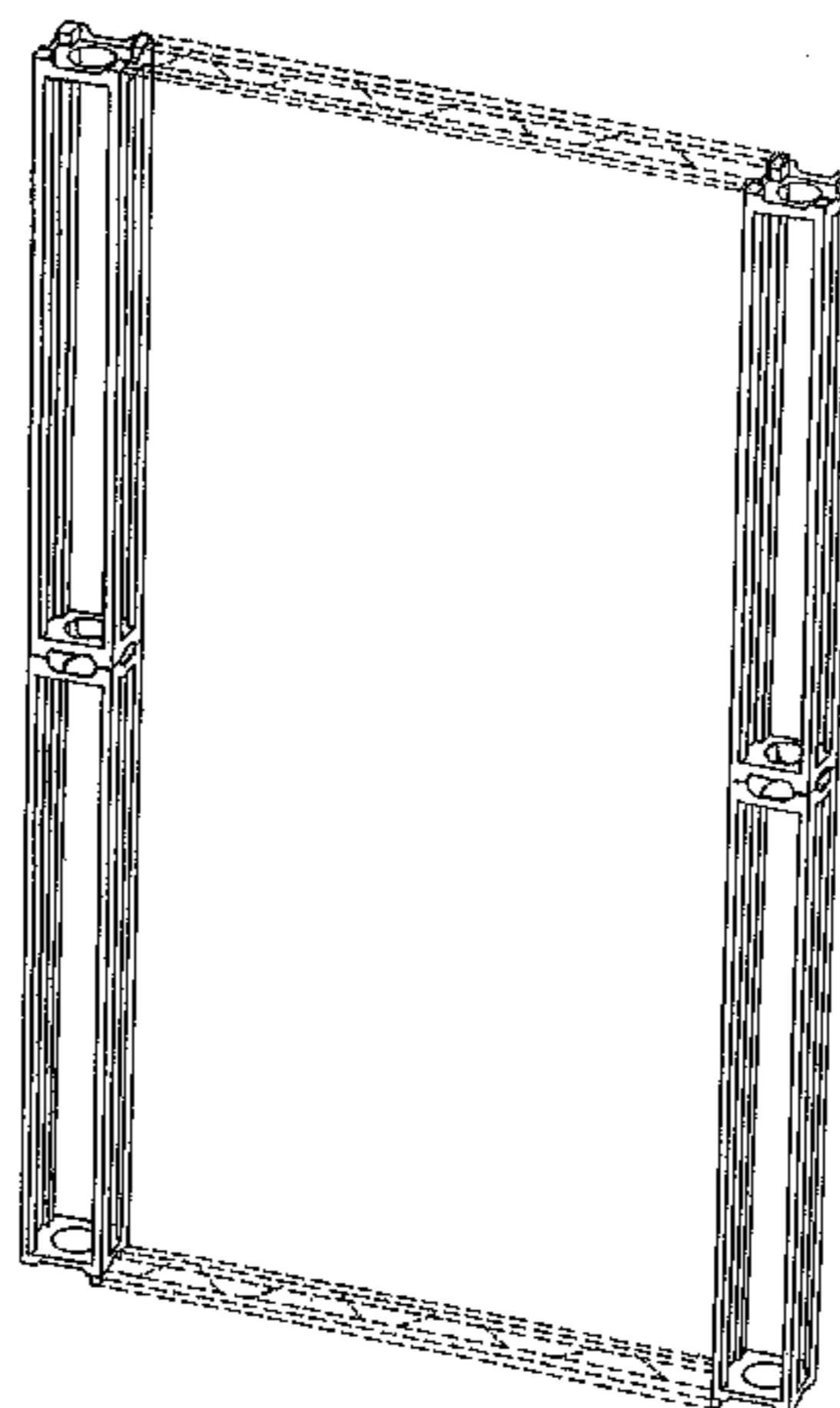
FIG. 9 is a side view of a display portion according to a third embodiment of the invention.

FIG. 10 is a front perspective view of a display portion according to a fourth embodiment of the invention having panels attached thereto; and,

FIG. 11 is a back view of a display portion according to a fourth embodiment of the invention having panels attached thereto.

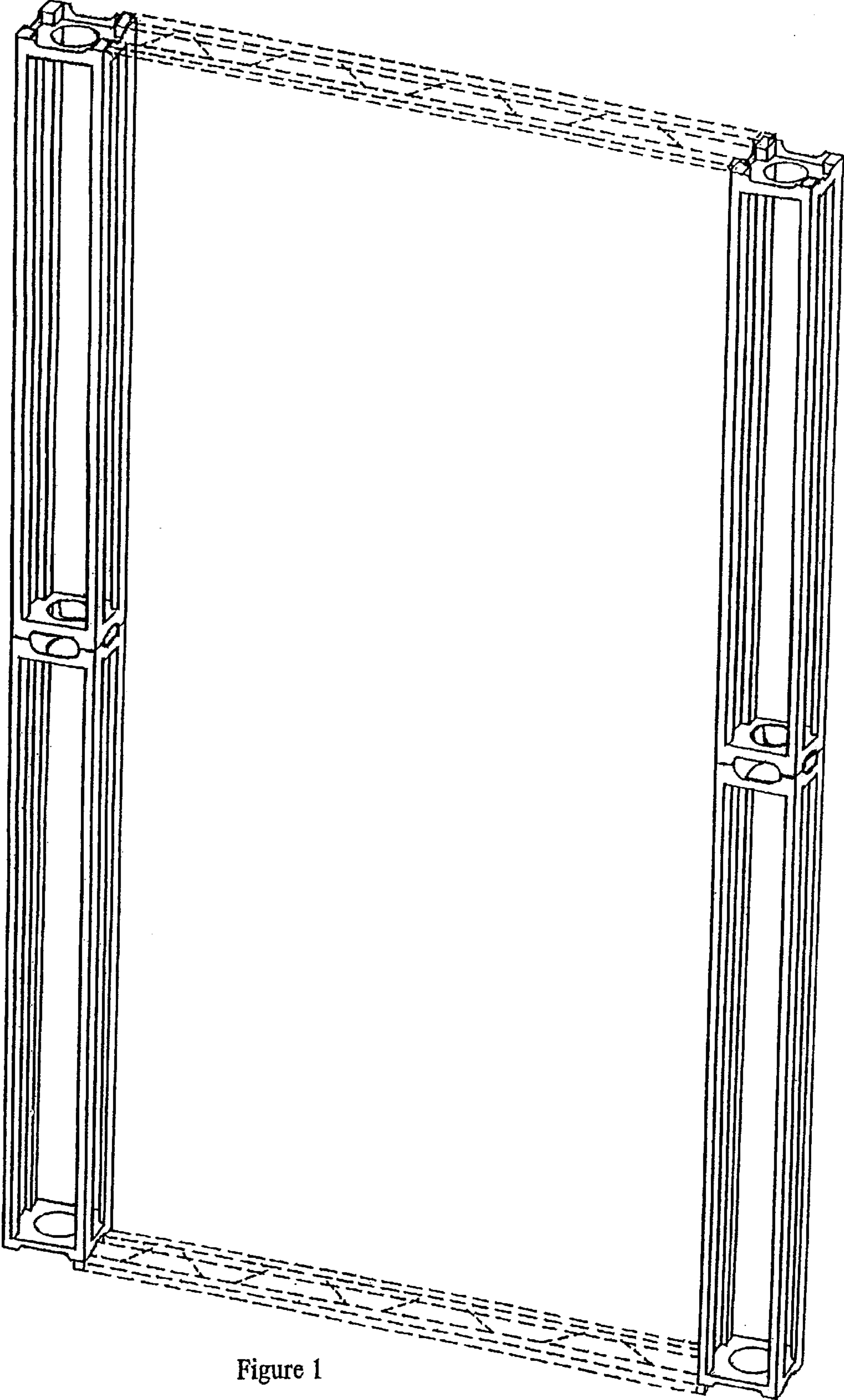

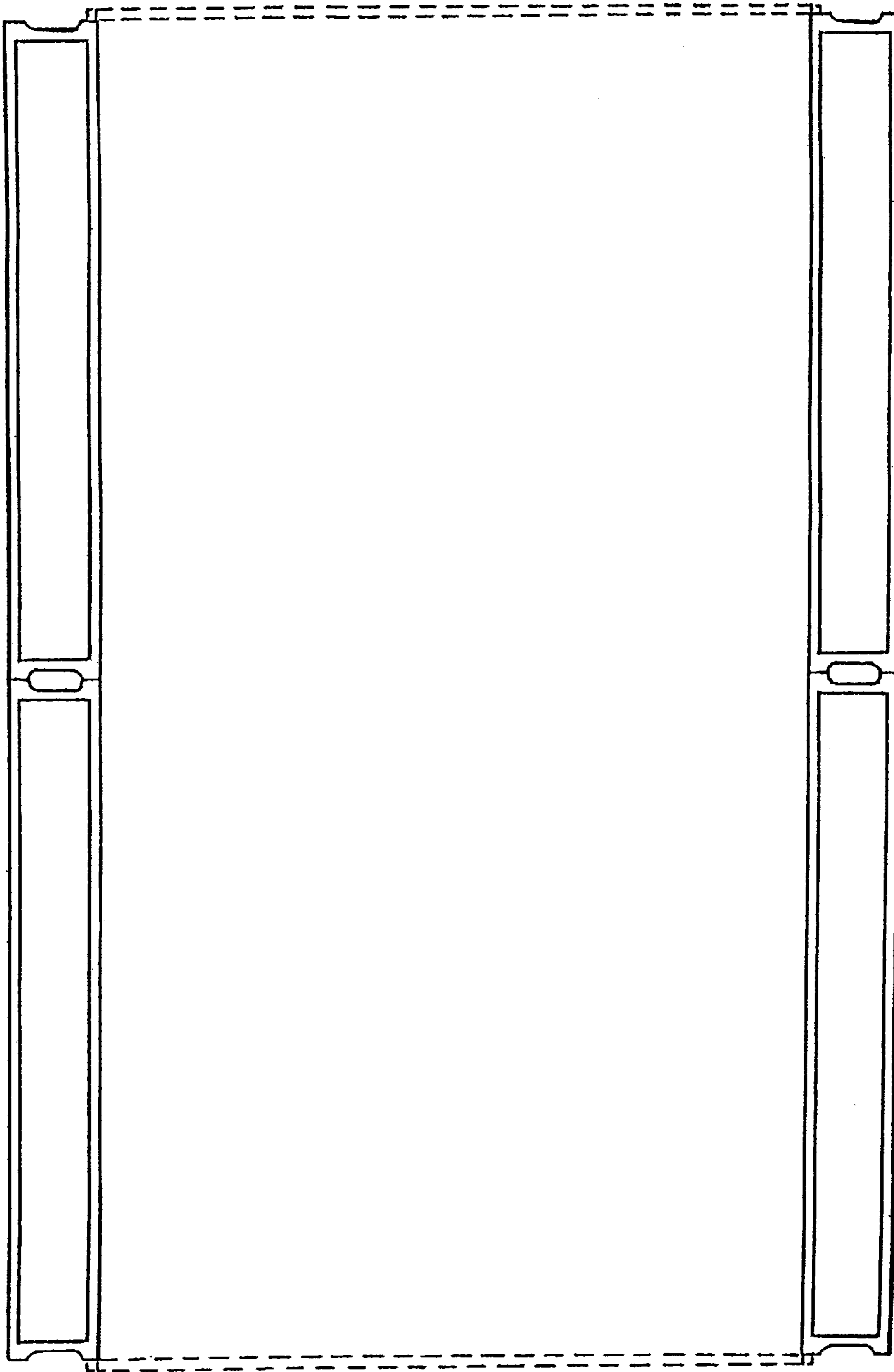

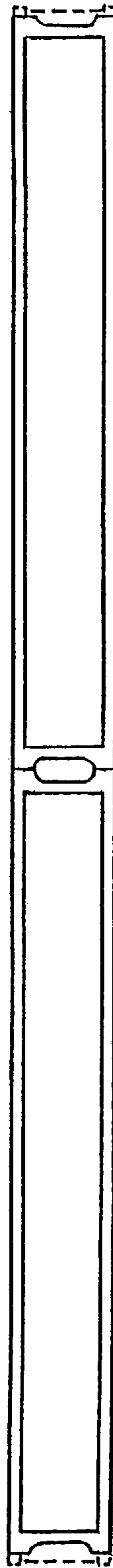

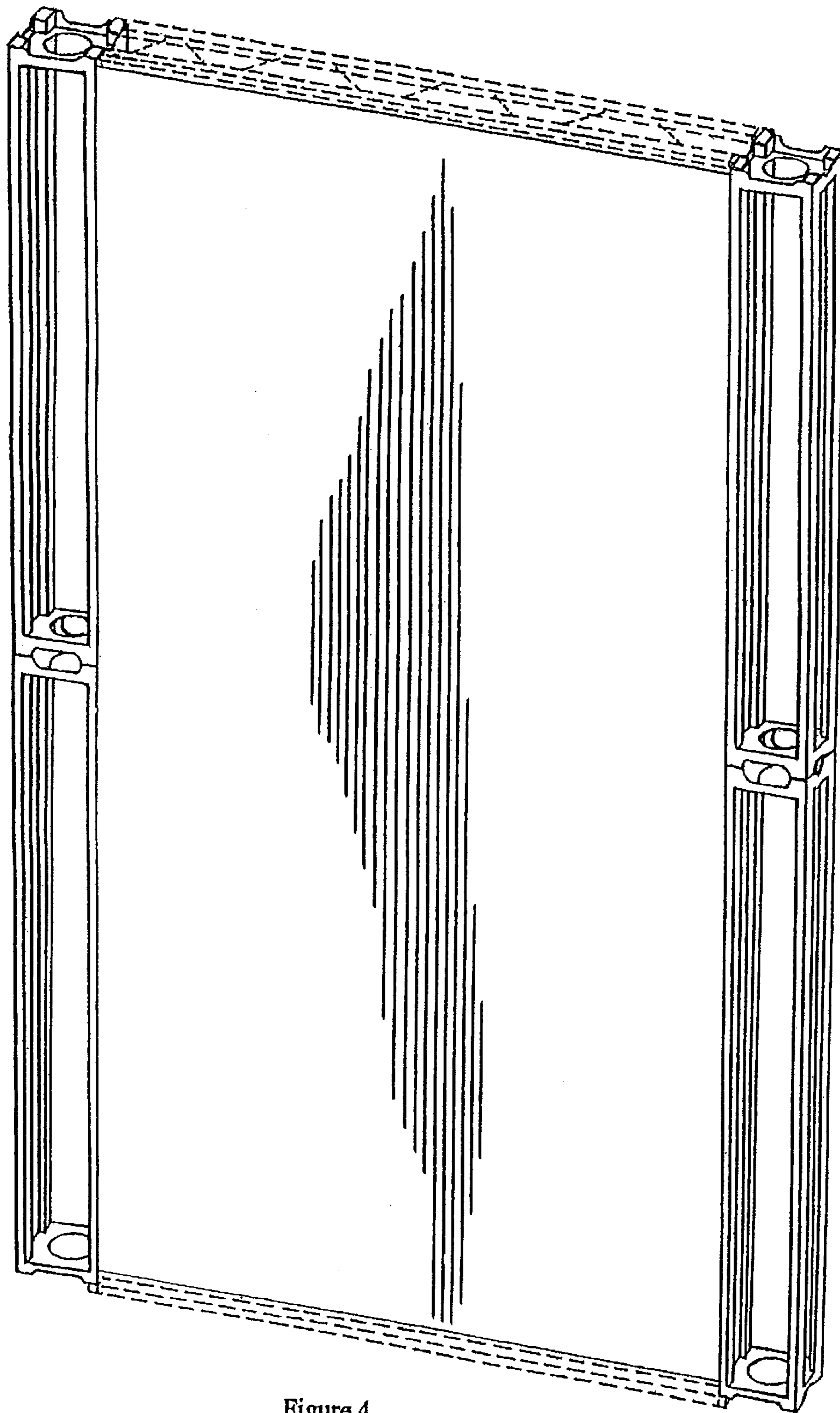

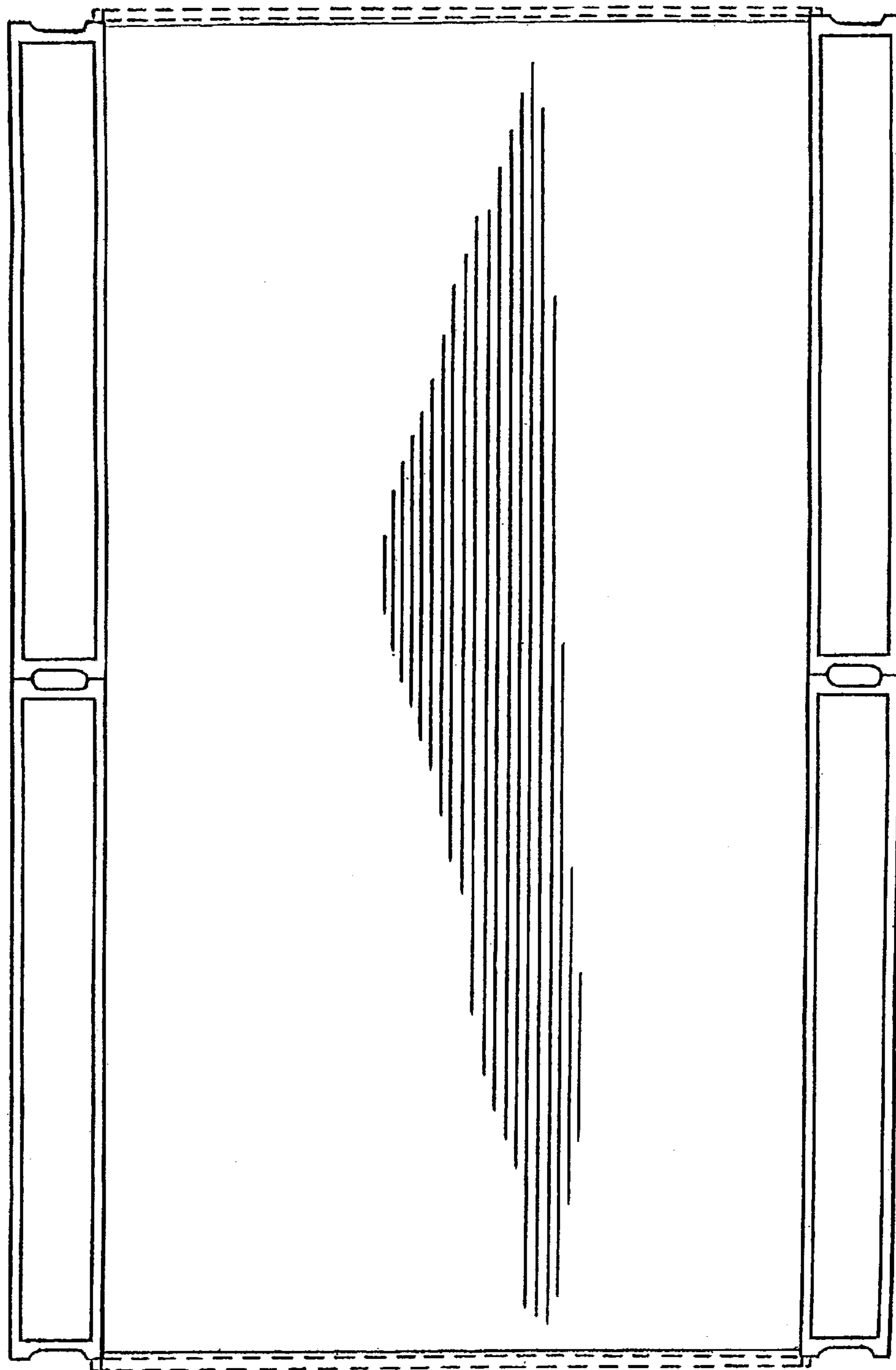

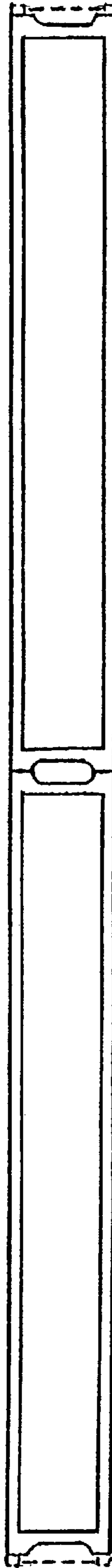

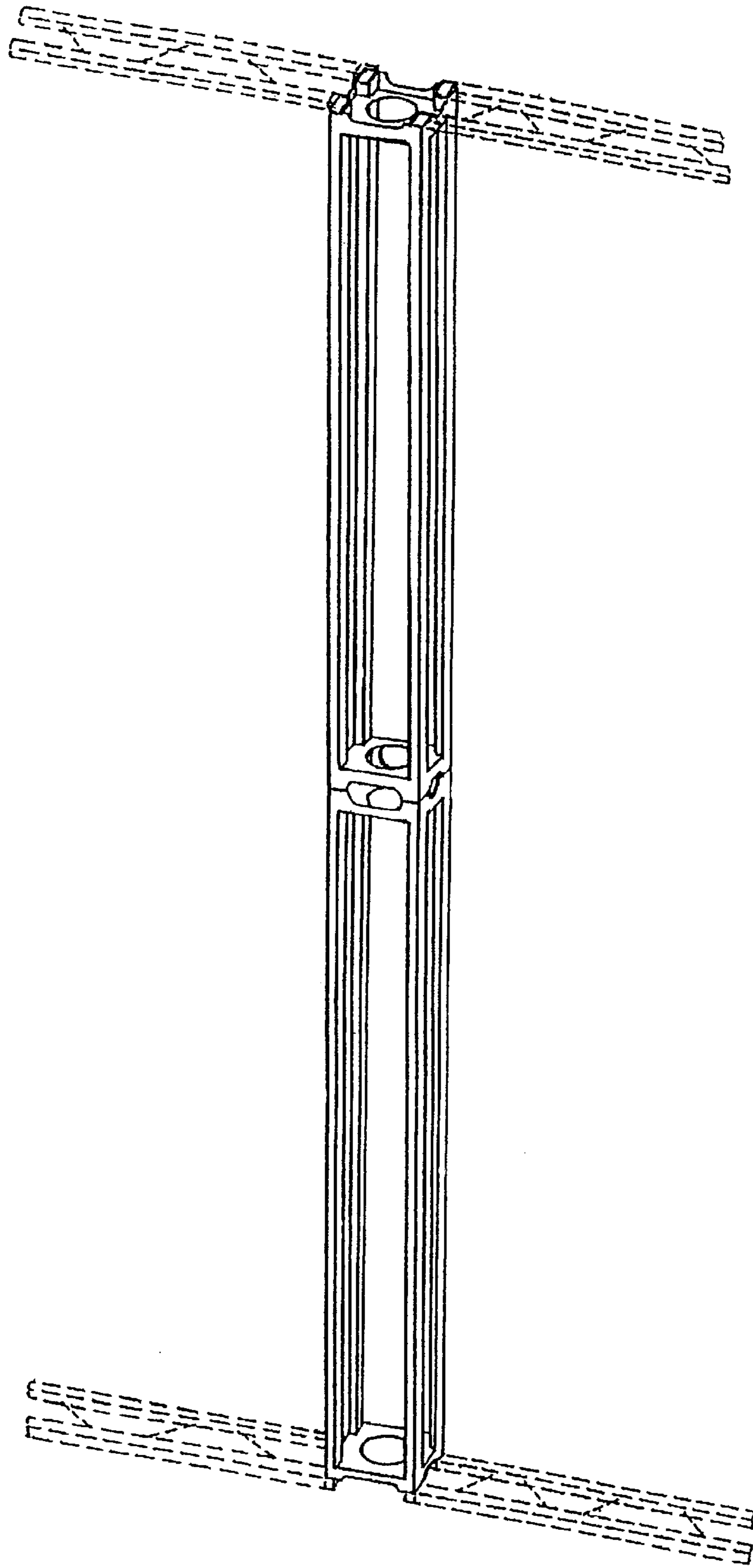

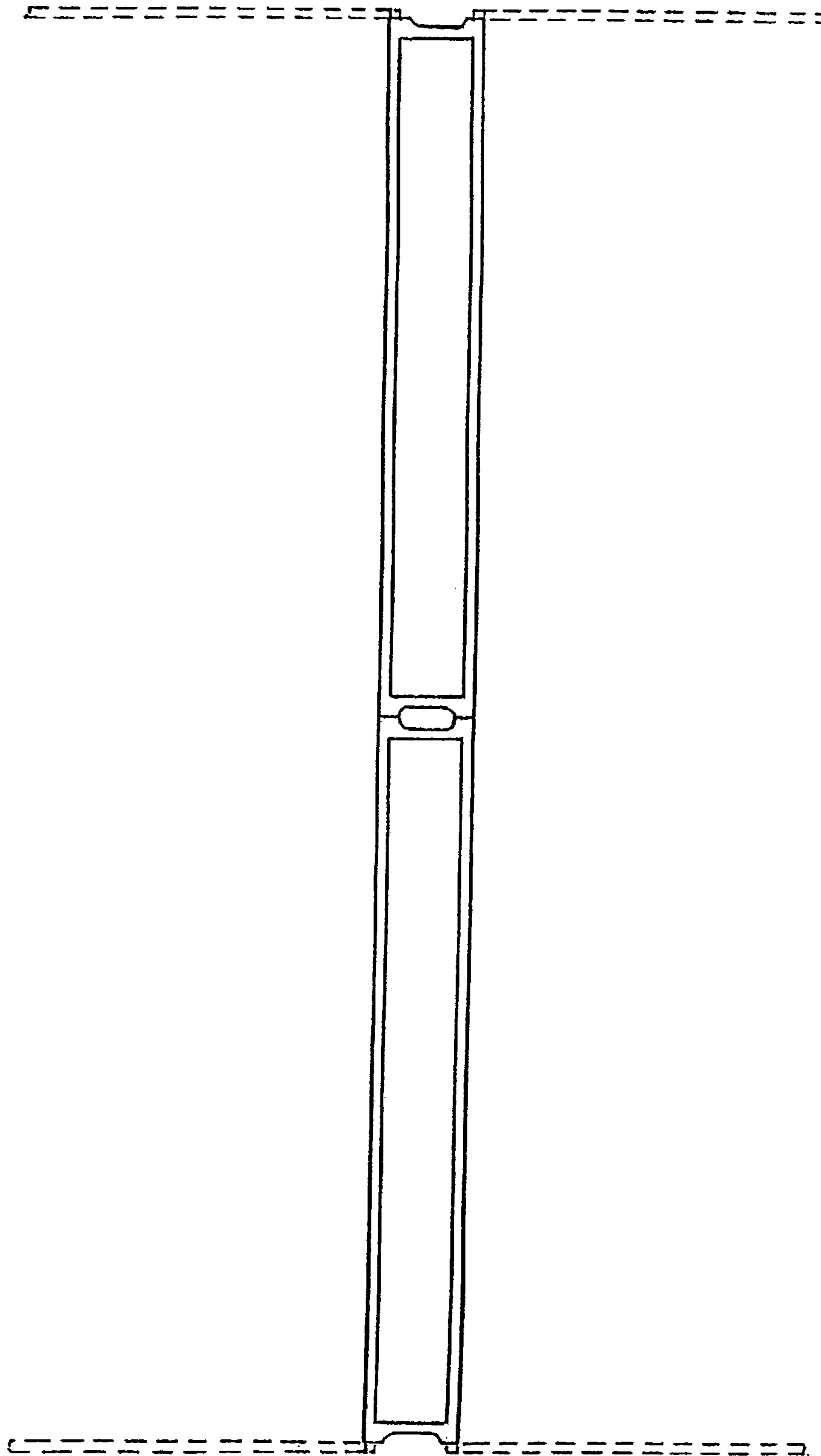

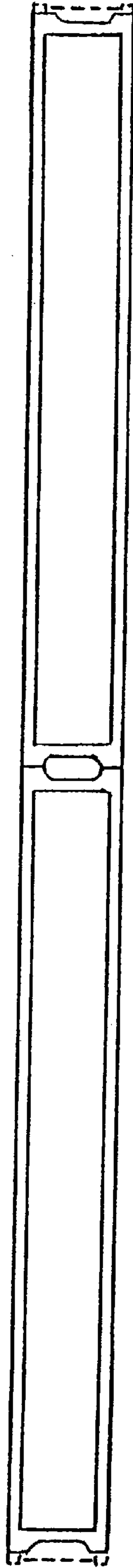

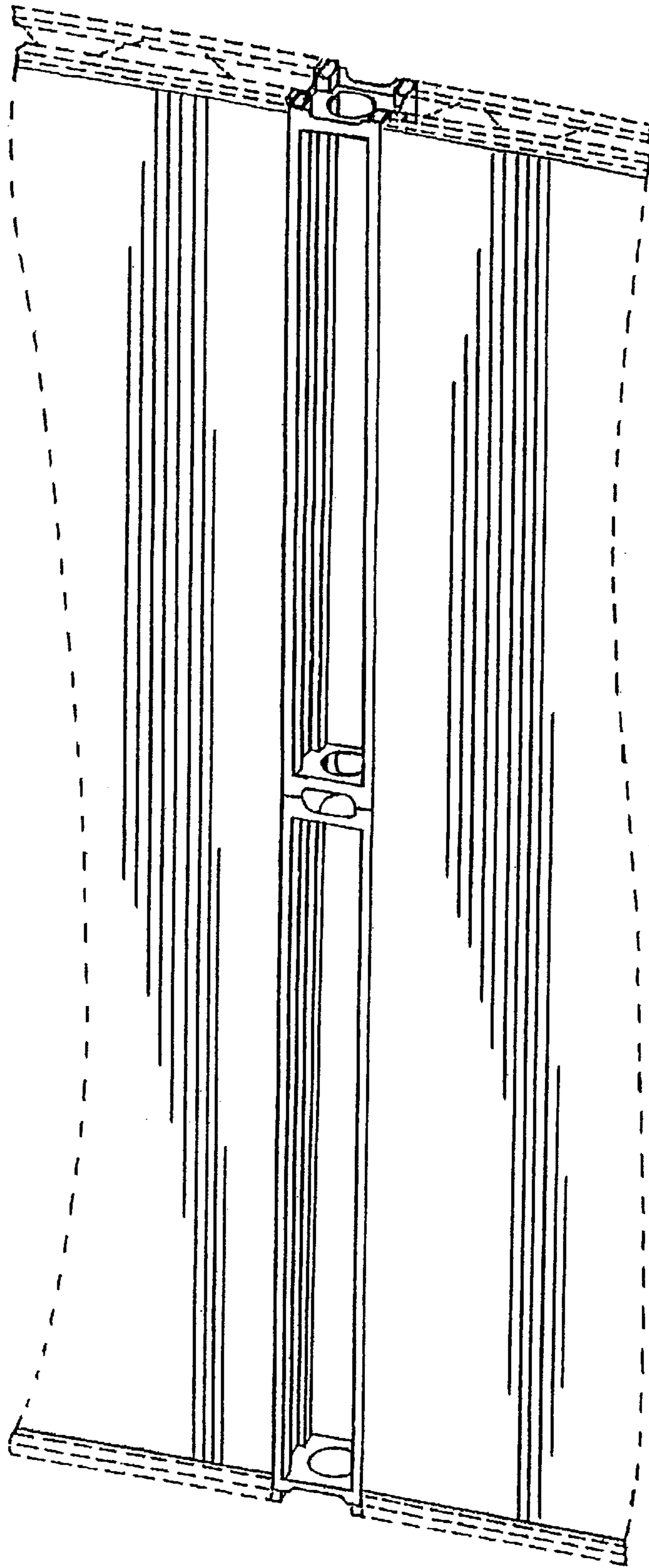

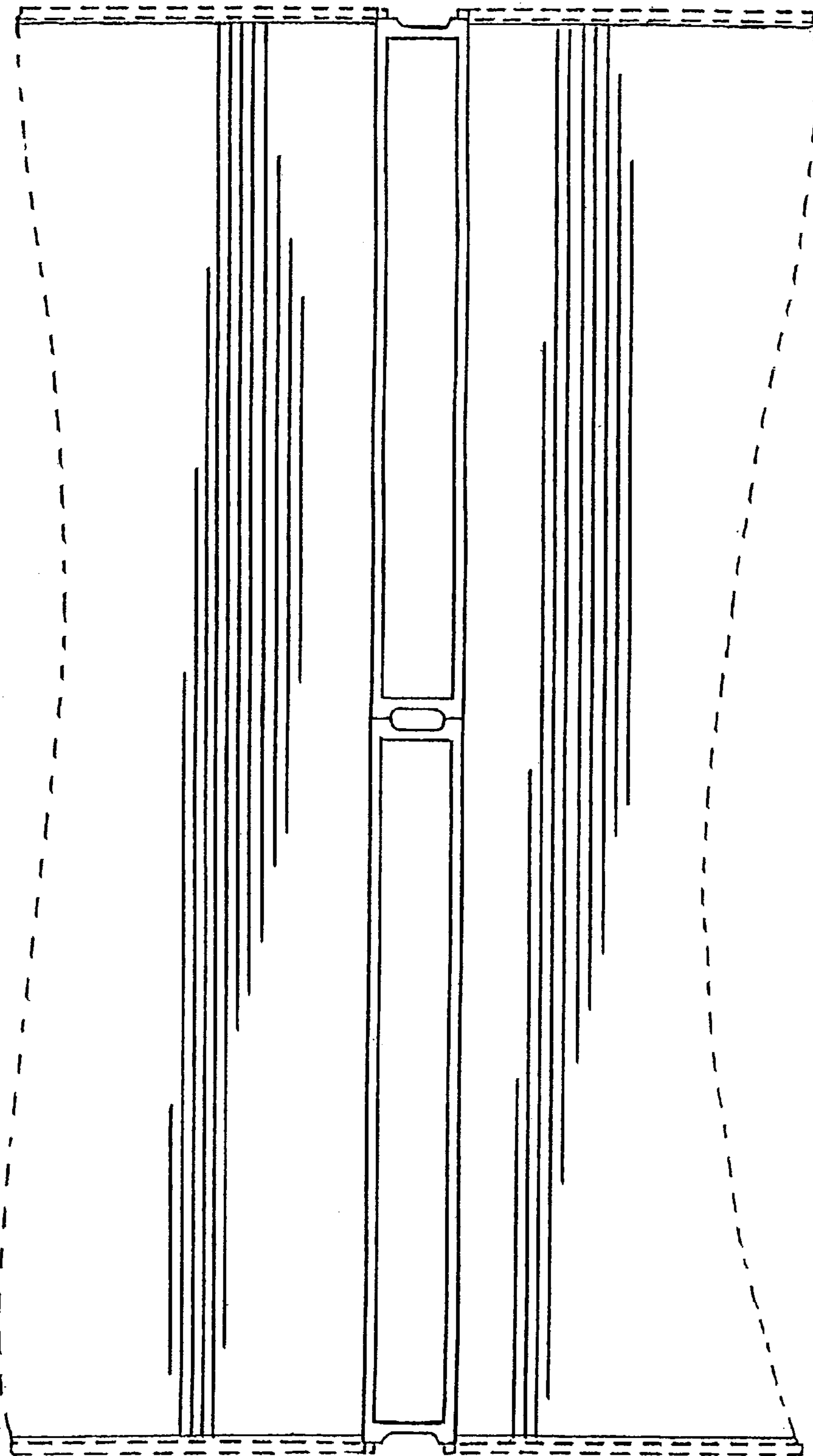
