FIG. 4 is a rear elevational view thereof;

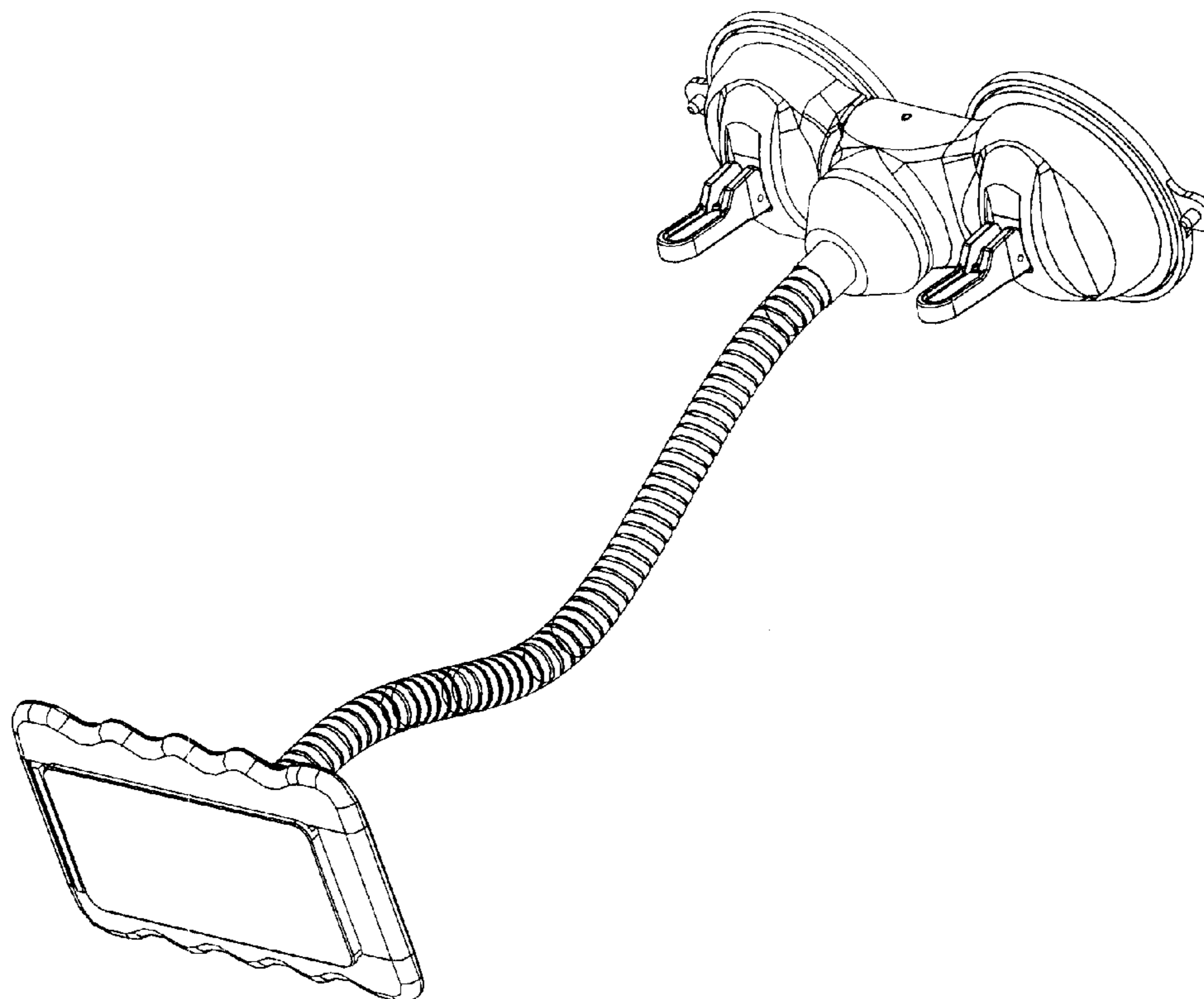
FIG. 5 is a left side elevational view thereof;

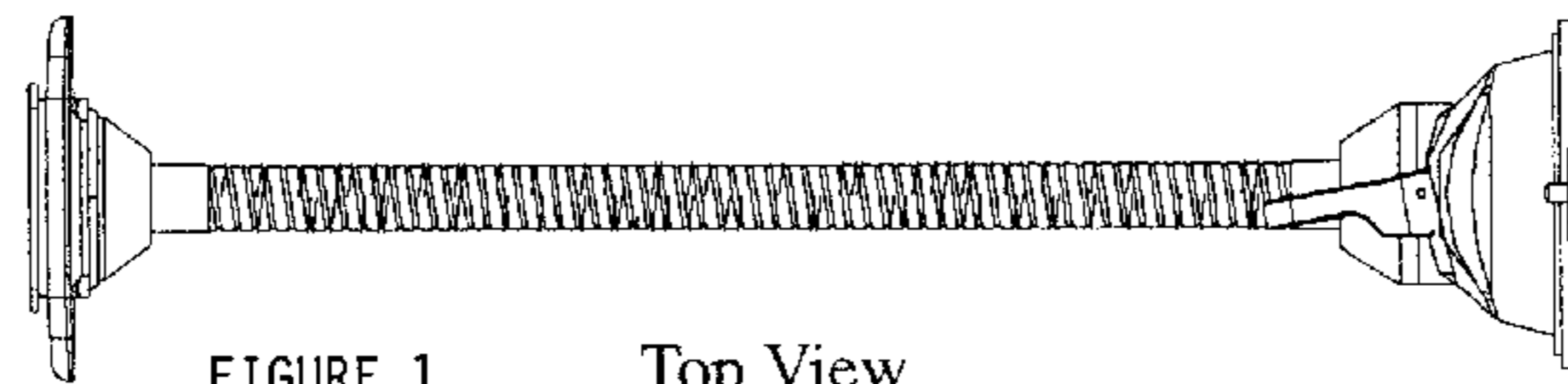
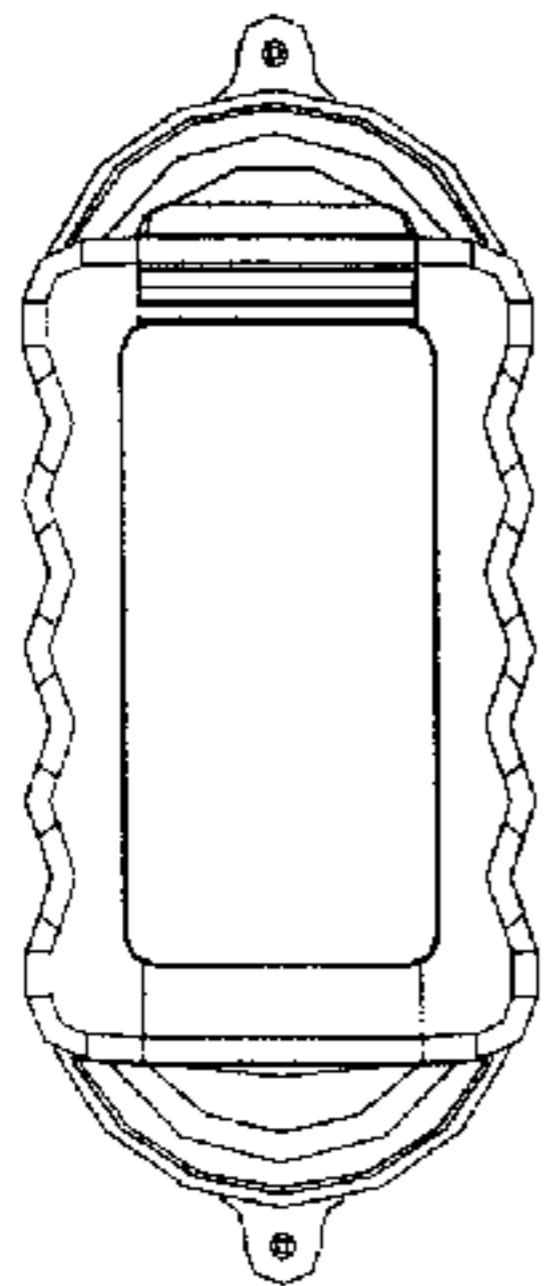


FIGURE 1 Top View

Left Side View

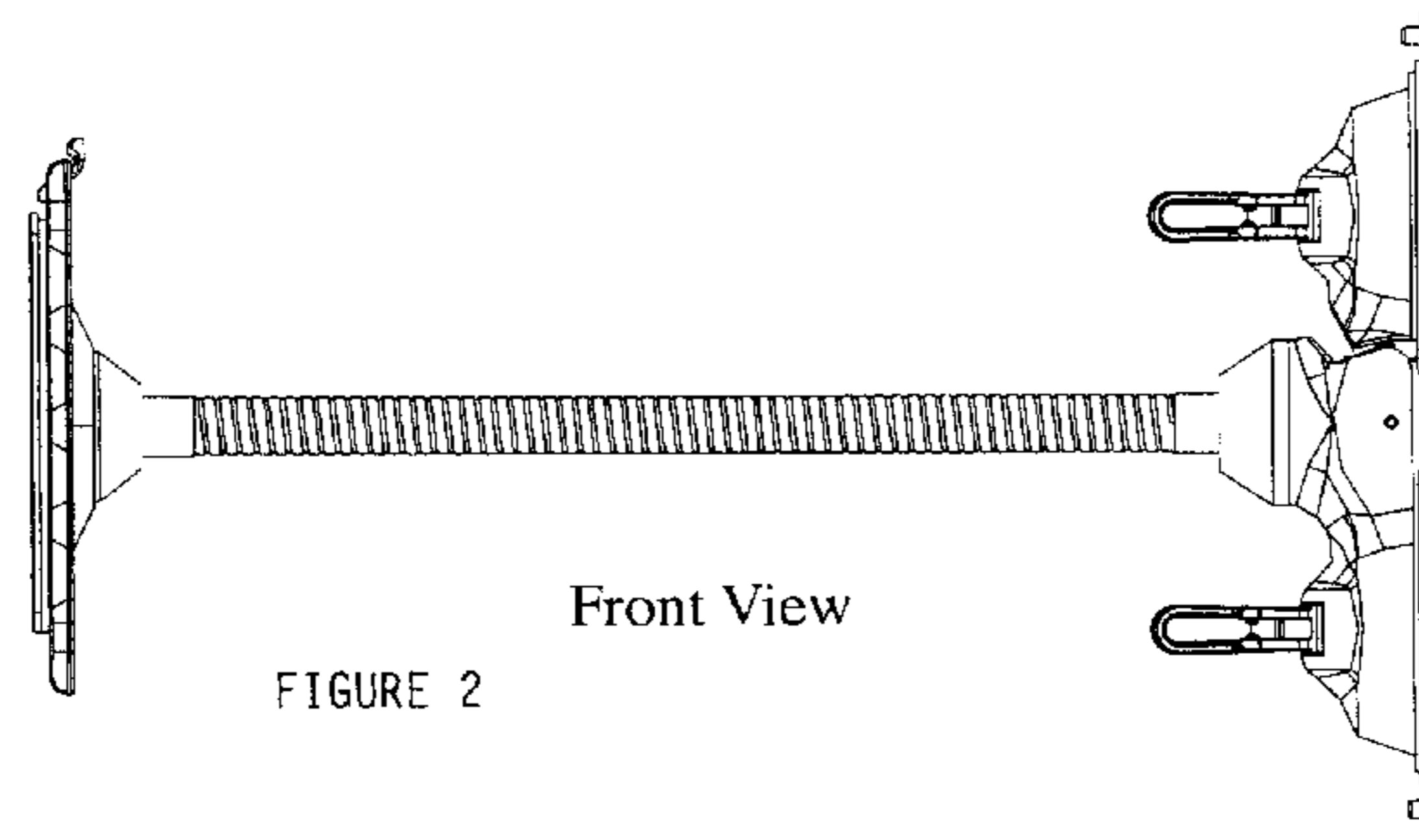


FIGURE 2 Front View

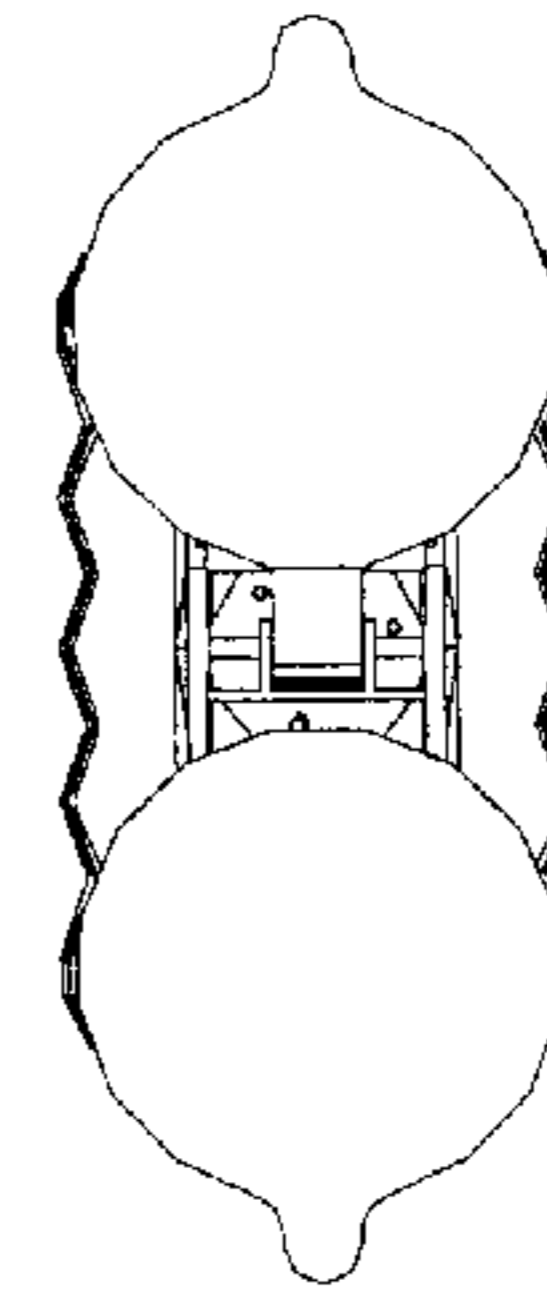

Right Side View

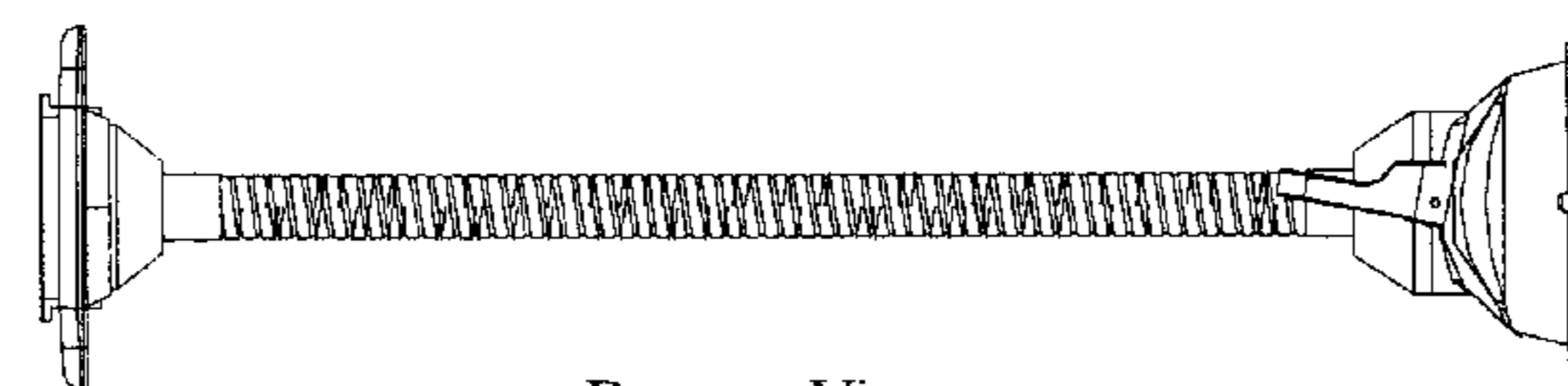


FIGURE 3 Bottom View

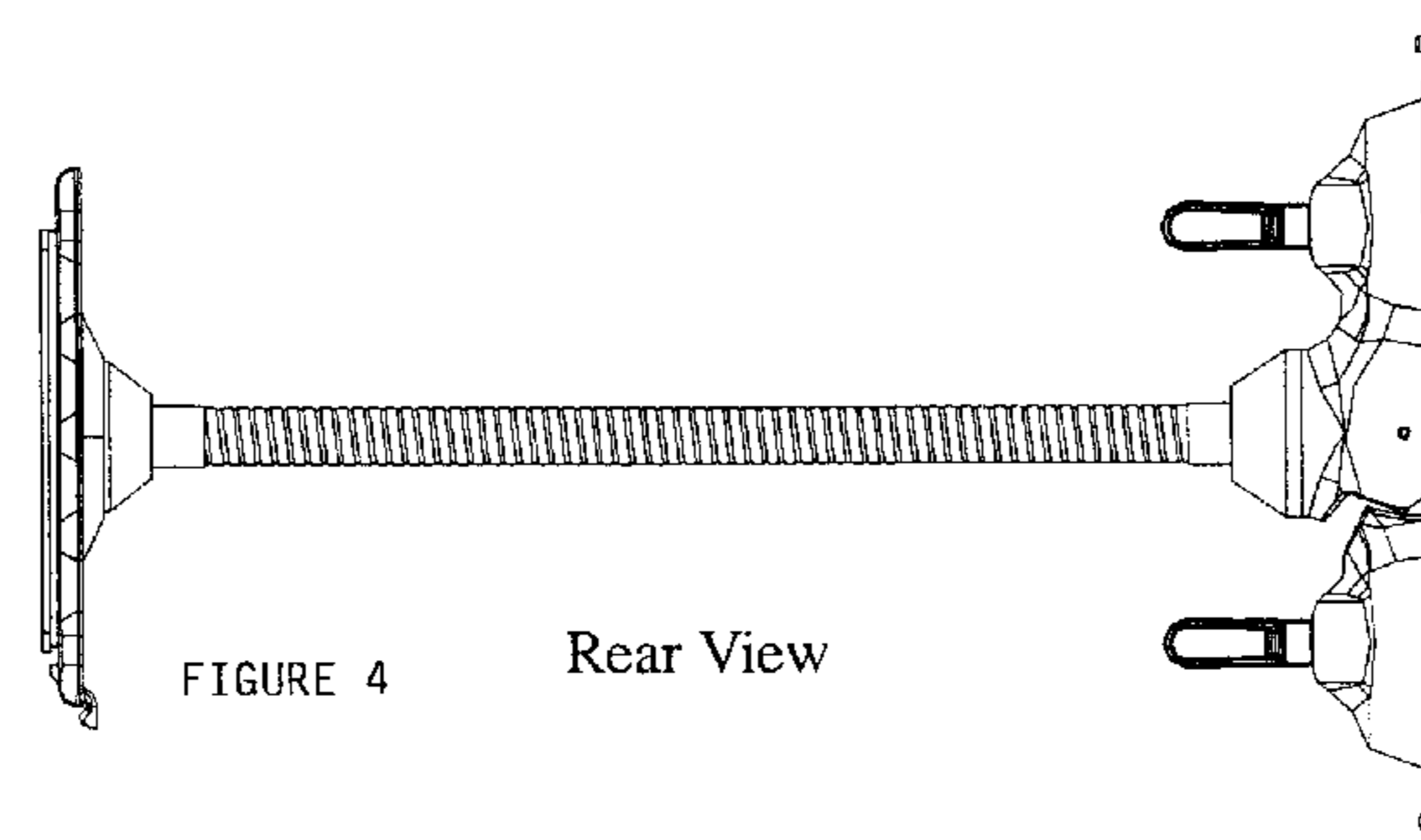


FIGURE 4 Rear View

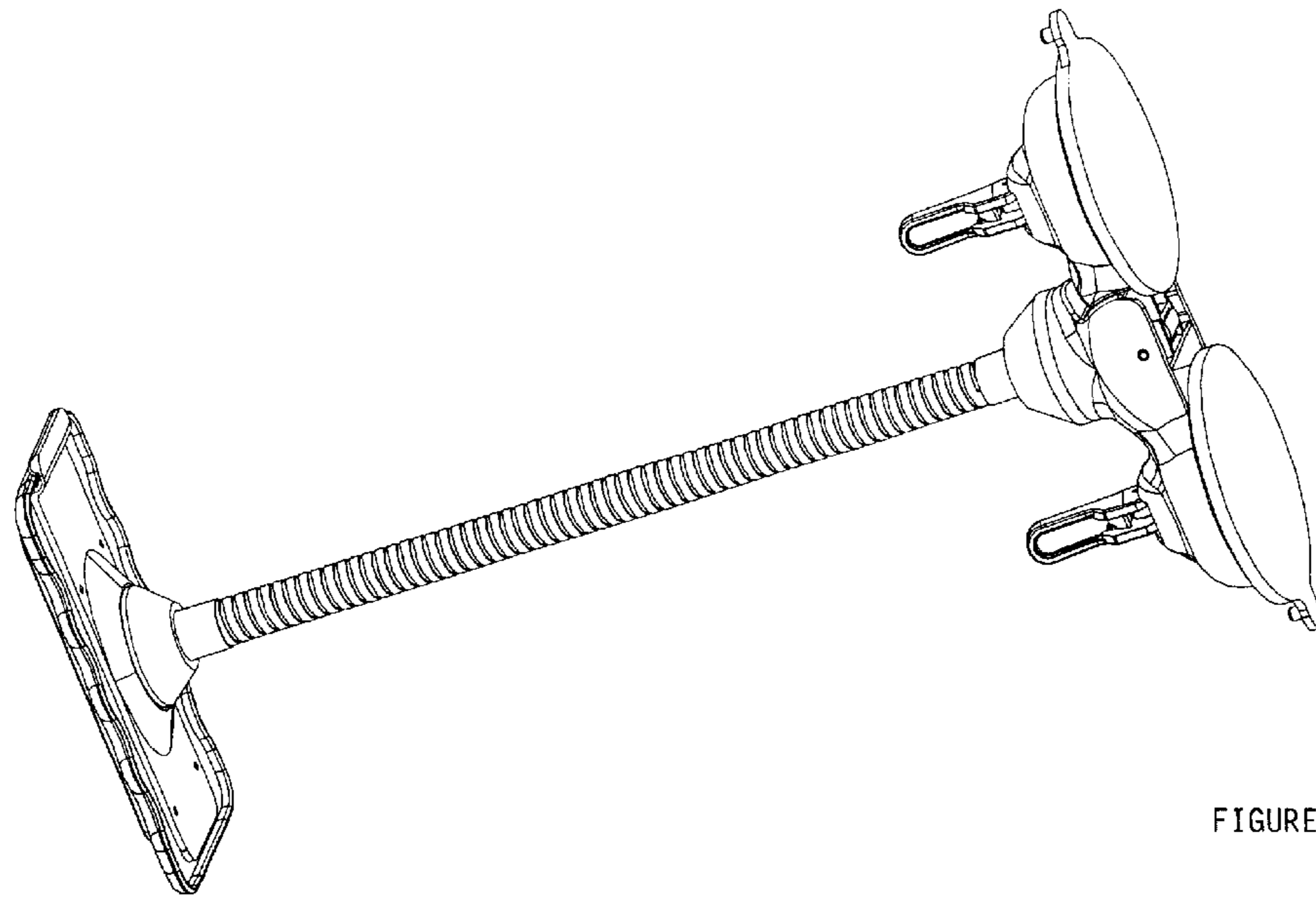

Perspective View

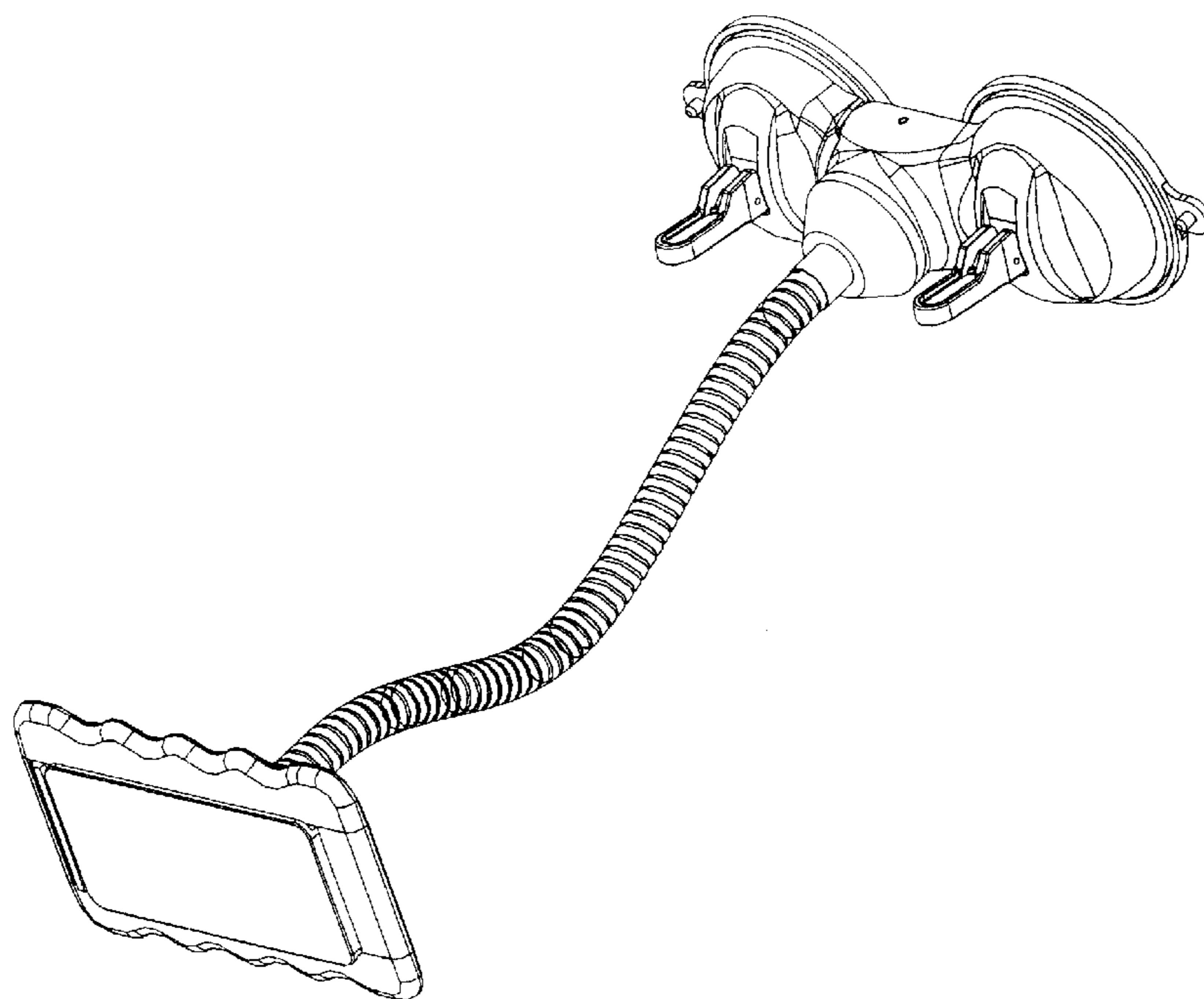
