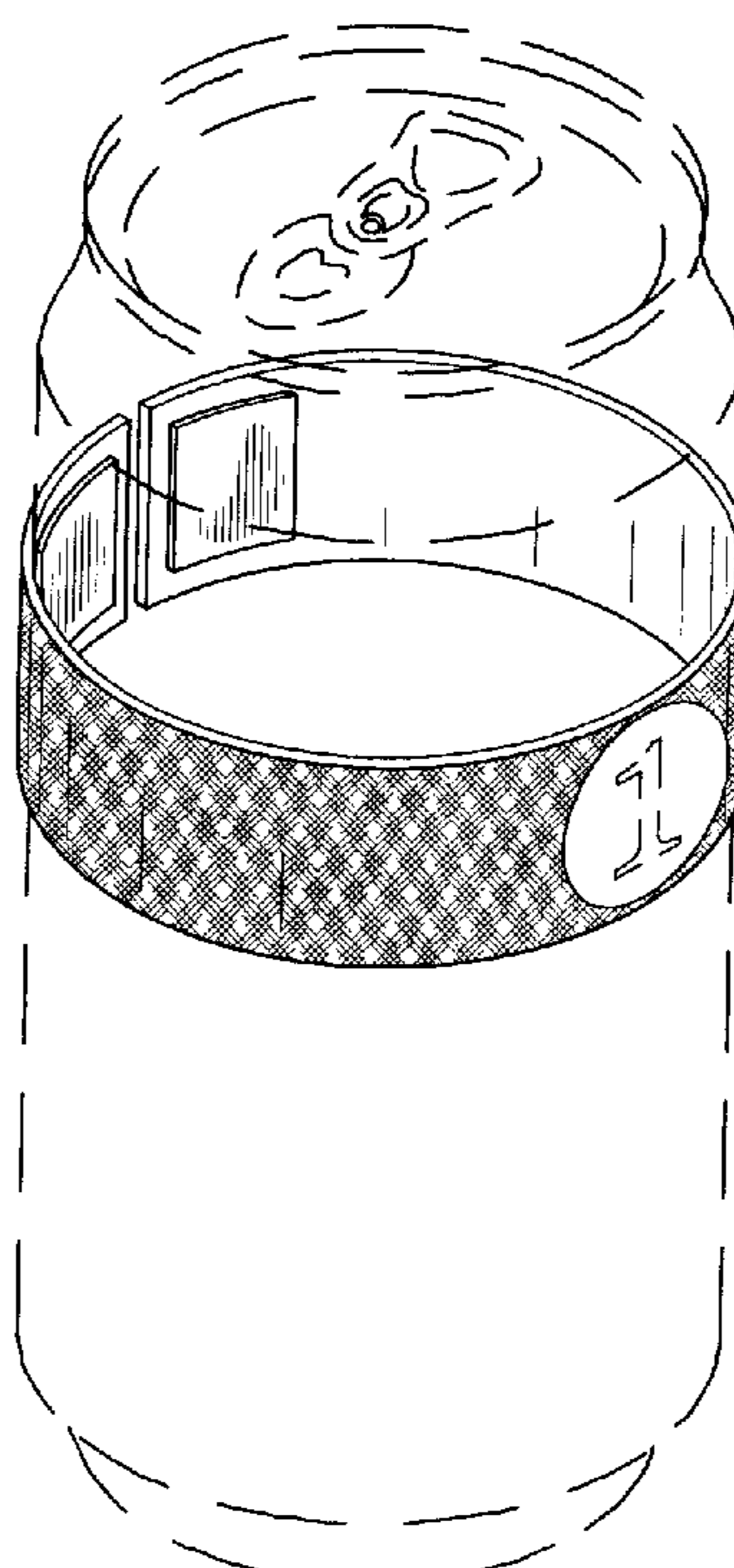
(57) **CLAIM**

The ornamental design for a beverage can identification strap, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a beverage can identification strap showing my new design;  
FIG. 2 is a bottom plan view thereof;  
FIG. 3 is a side elevational view thereof;  
FIG. 4 is a front elevational view thereof;  
FIG. 5 is a perspective view thereof; and,  
FIG. 6 is a perspective view showing the present invention in a preferred environment.

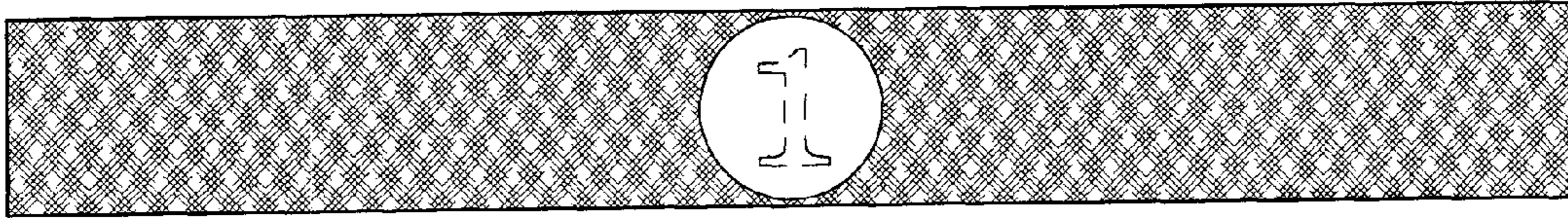

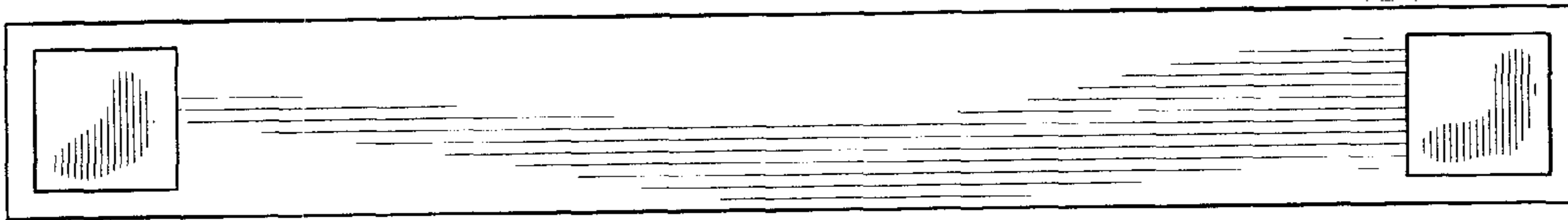

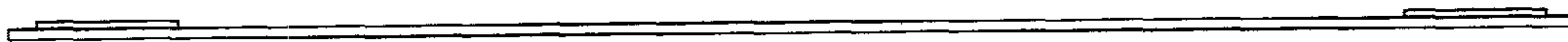

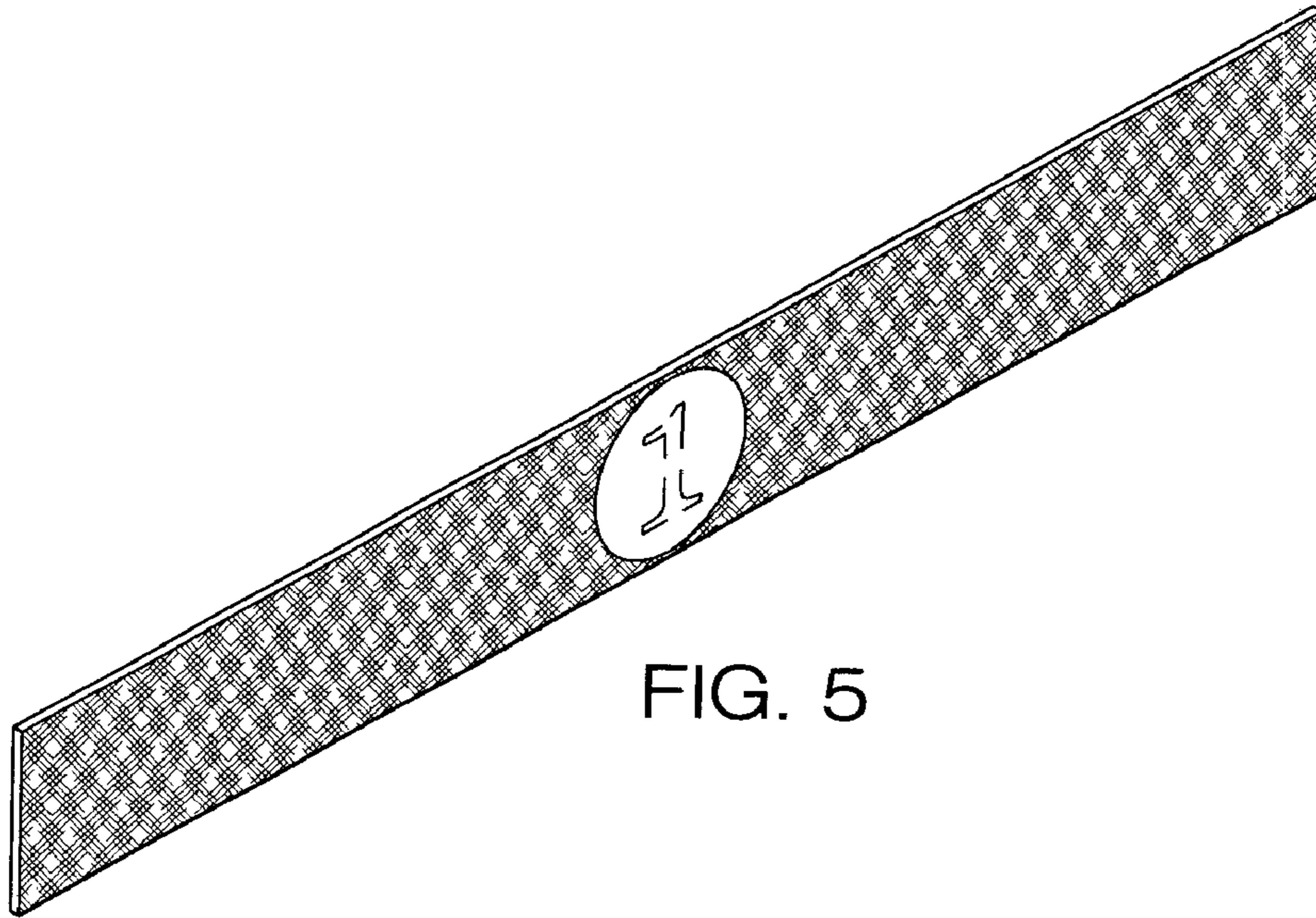

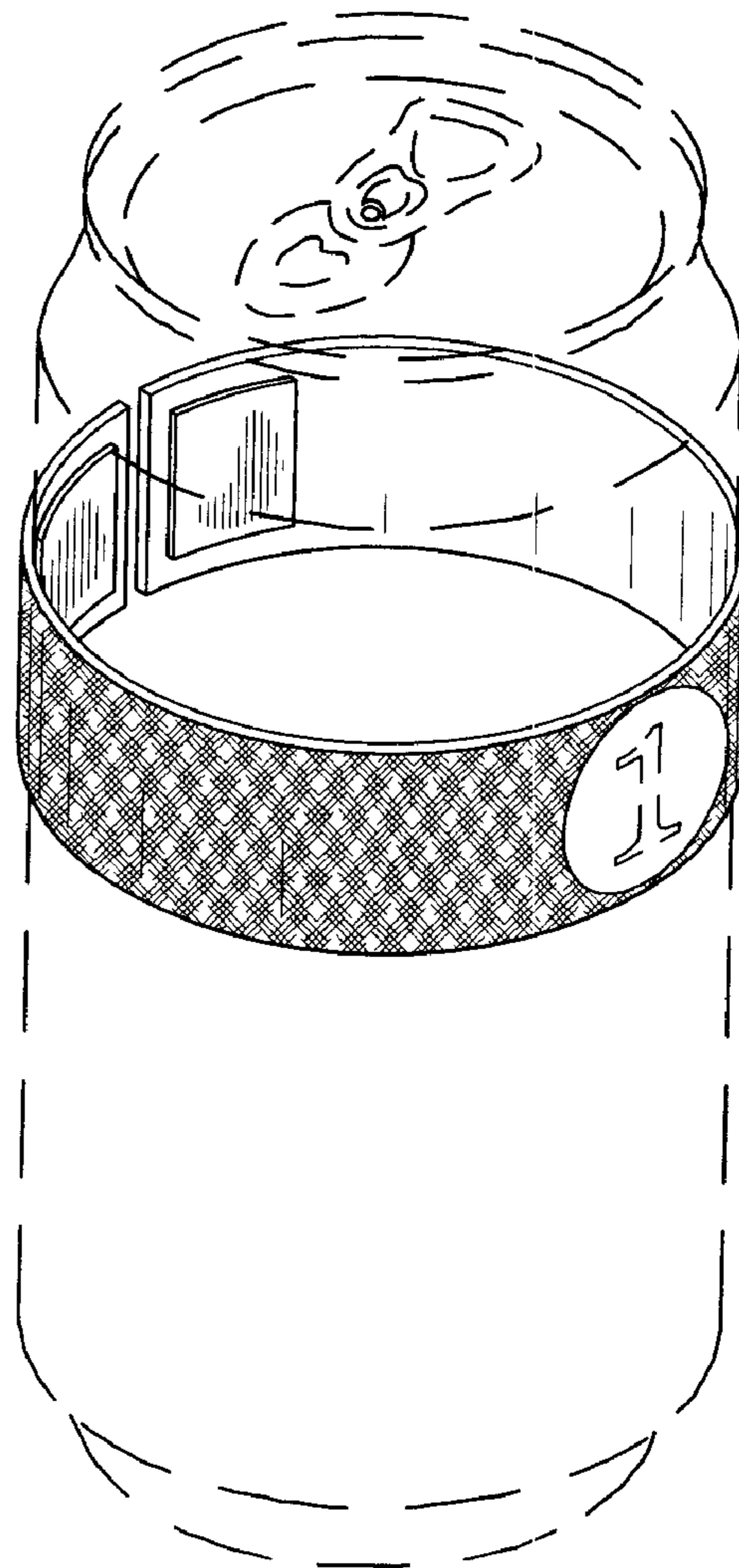
