FIG. 5 is a top end view of a beverage can tab, with stylized bull design cutout in dark blue color, showing our new design, and lined for the color blue; and,

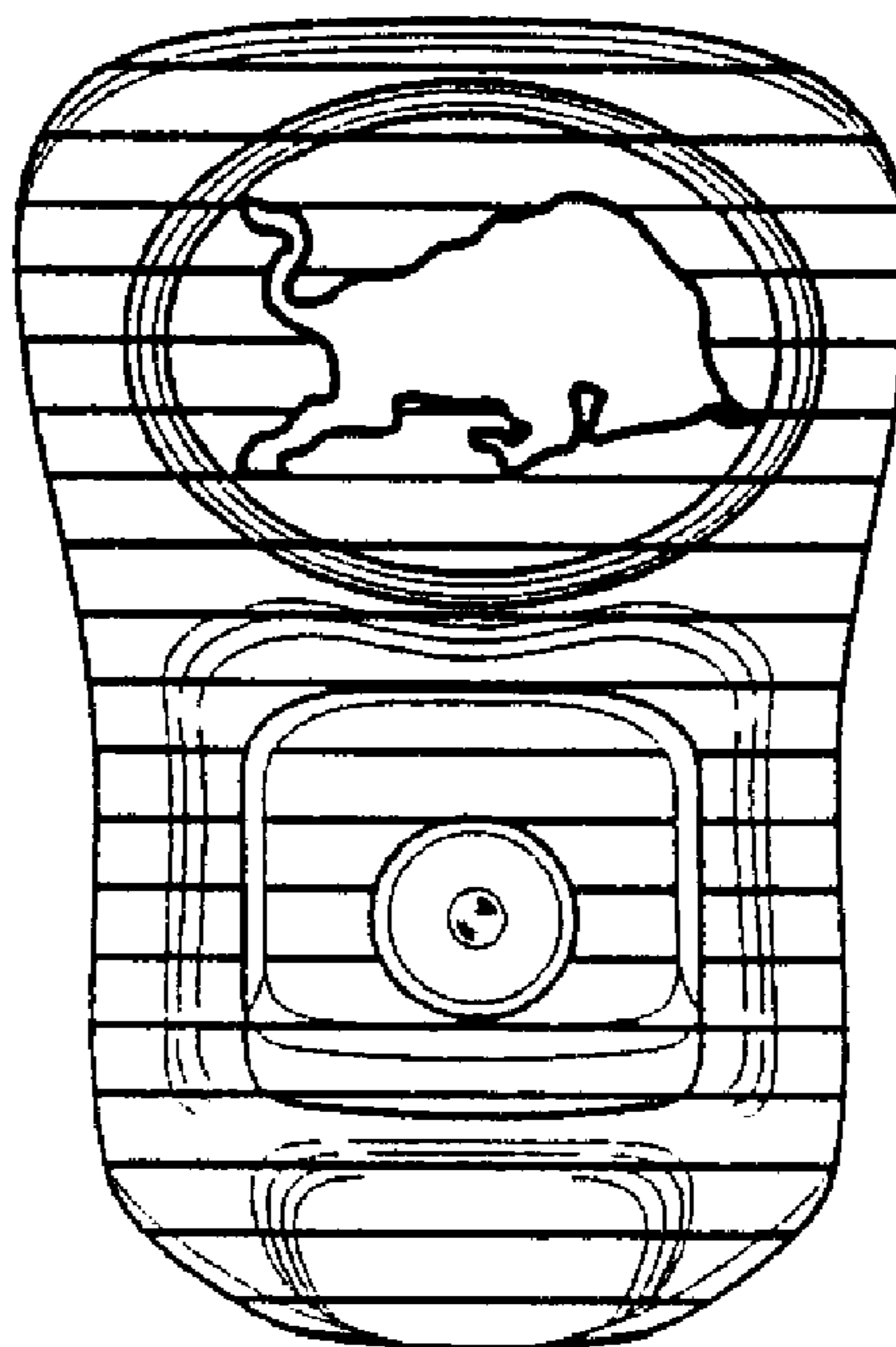
FIG. 6 is a bottom end view of a beverage can tab, with stylized bull design cutout in dark blue color, showing our new design, and lined for the color blue.

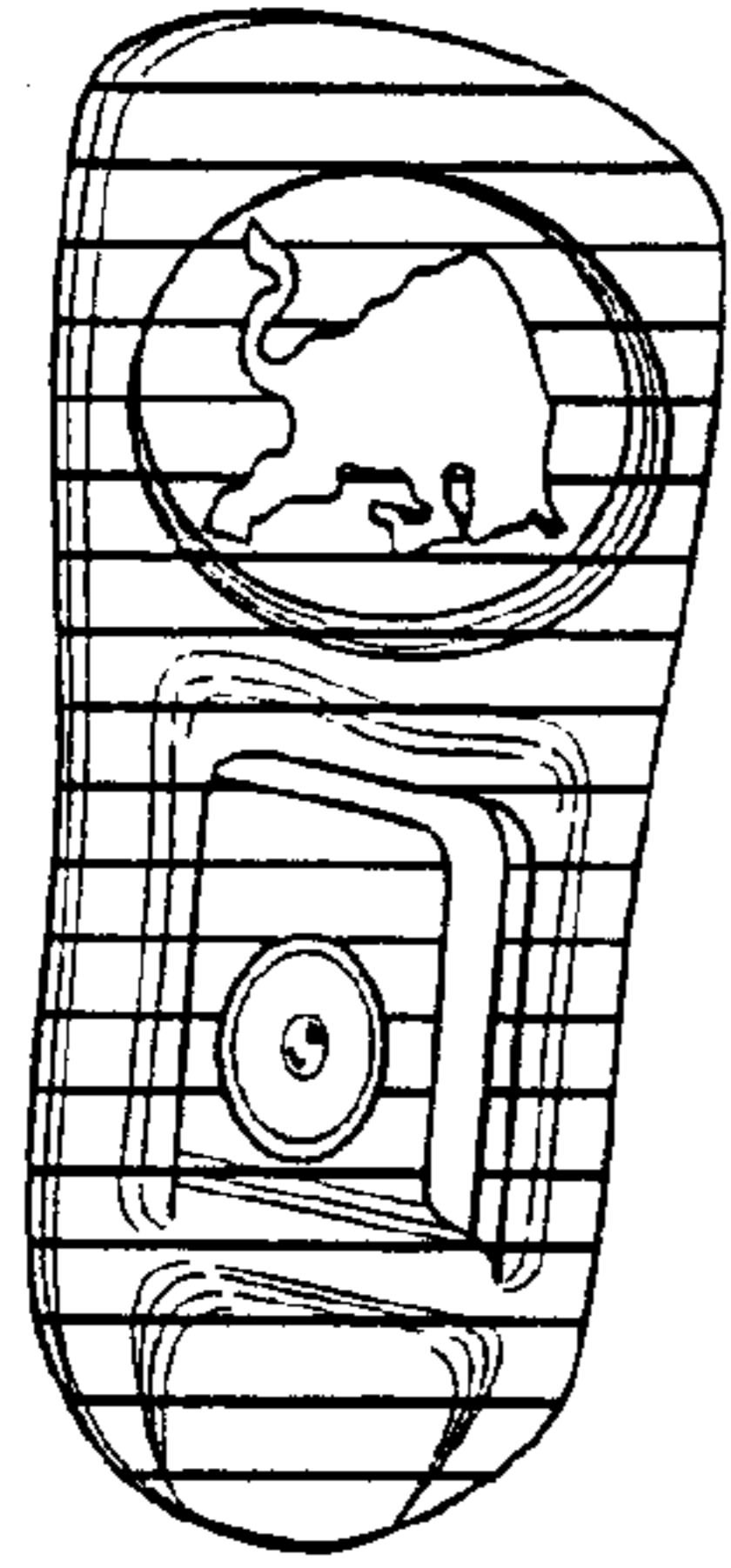

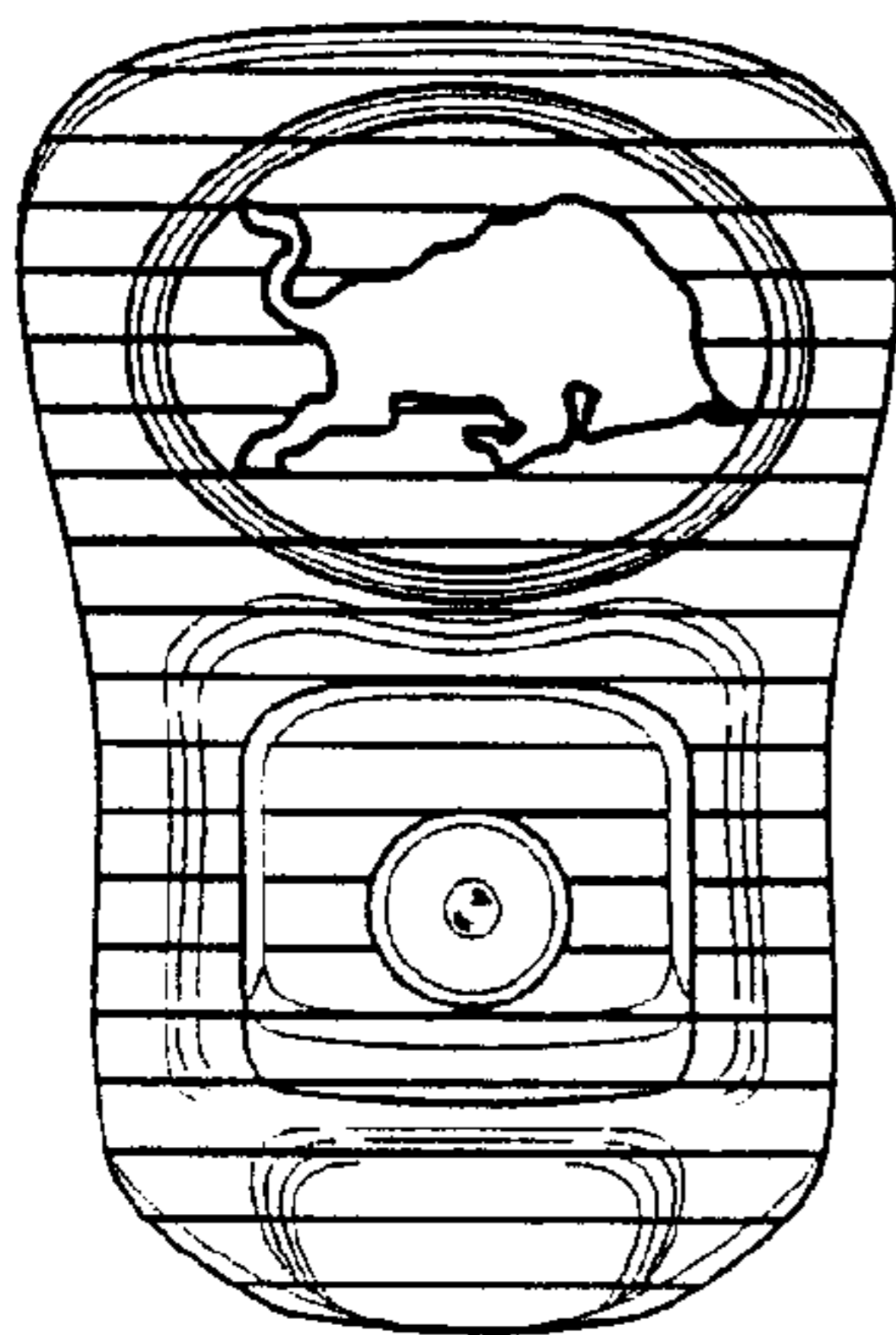

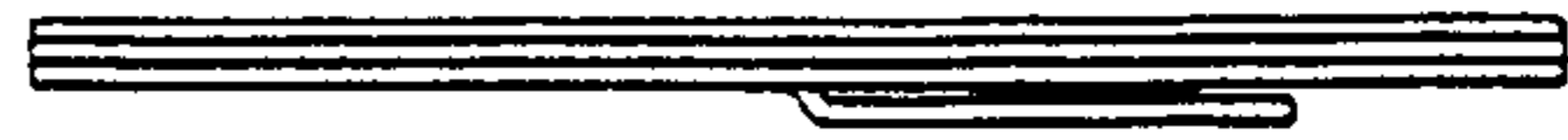

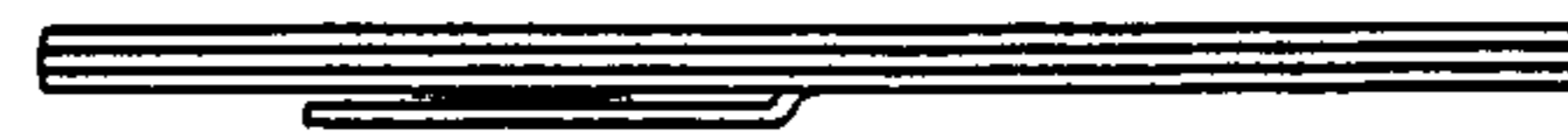

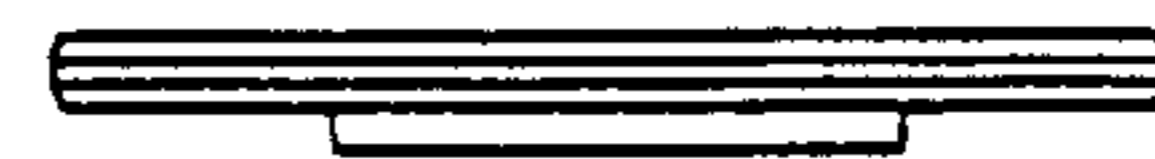
