FIG. 2 is a side view of the tape measure of FIG. 1;

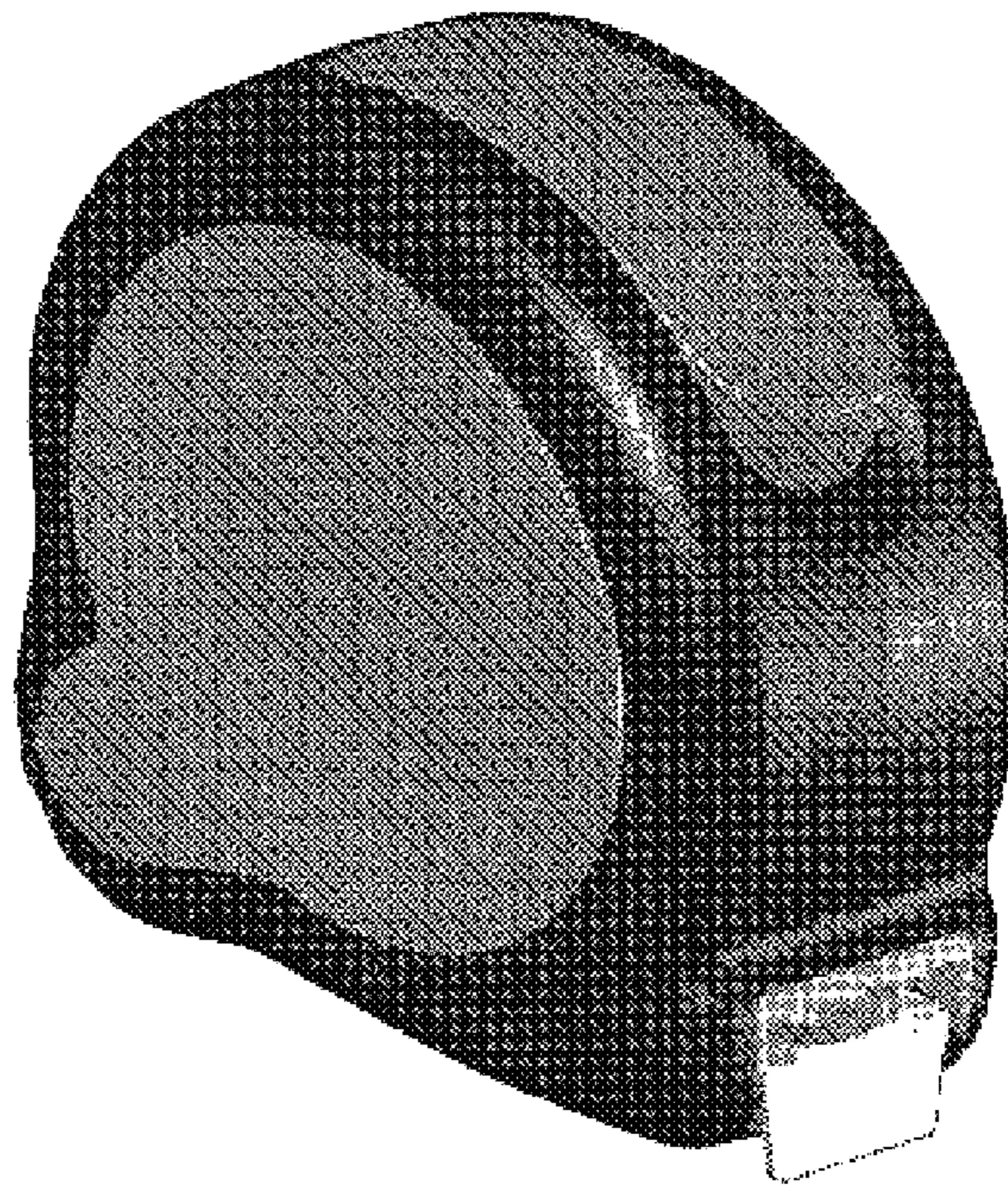
FIG. 3 is another side view of the tape measure of FIG. 1;

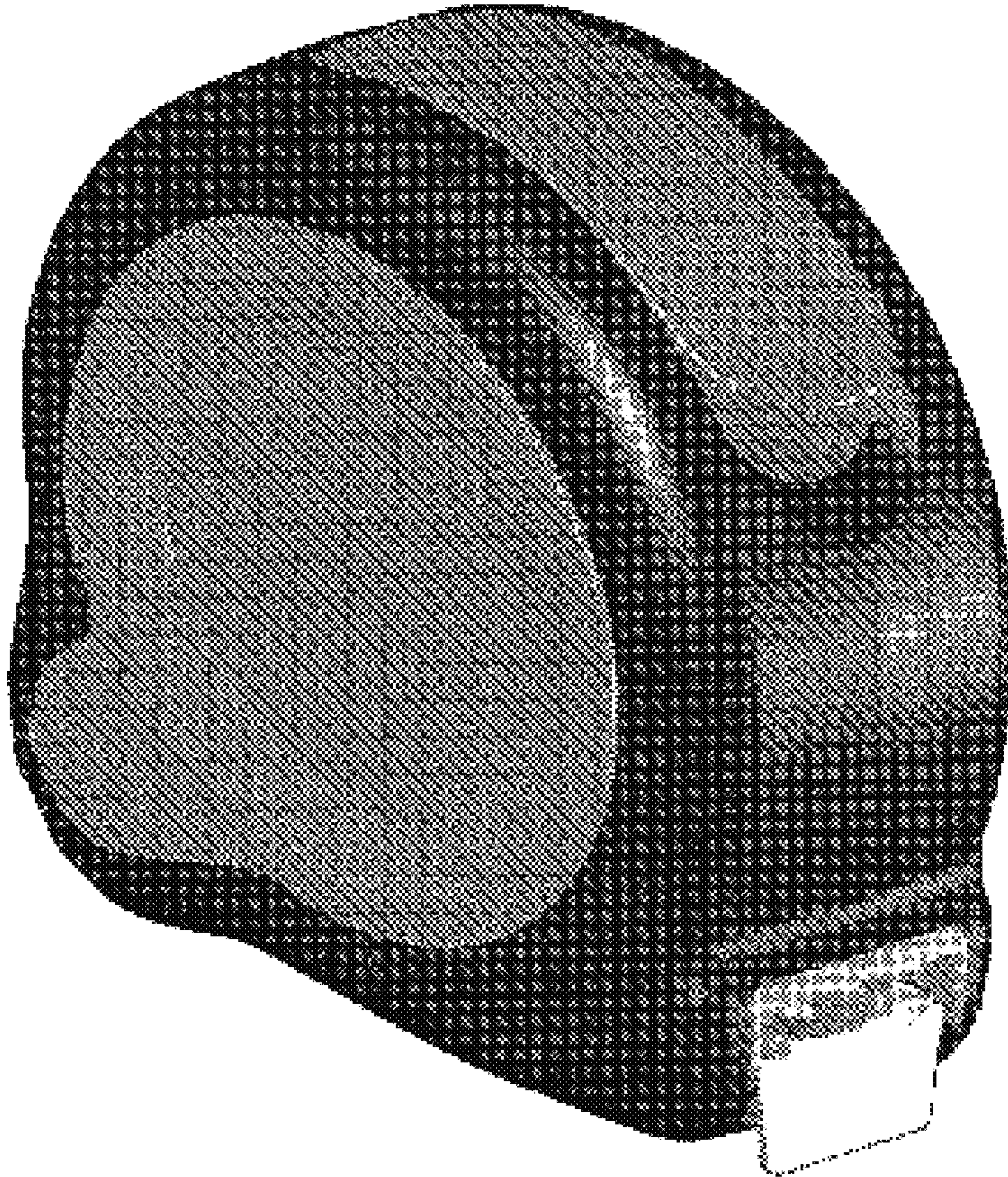

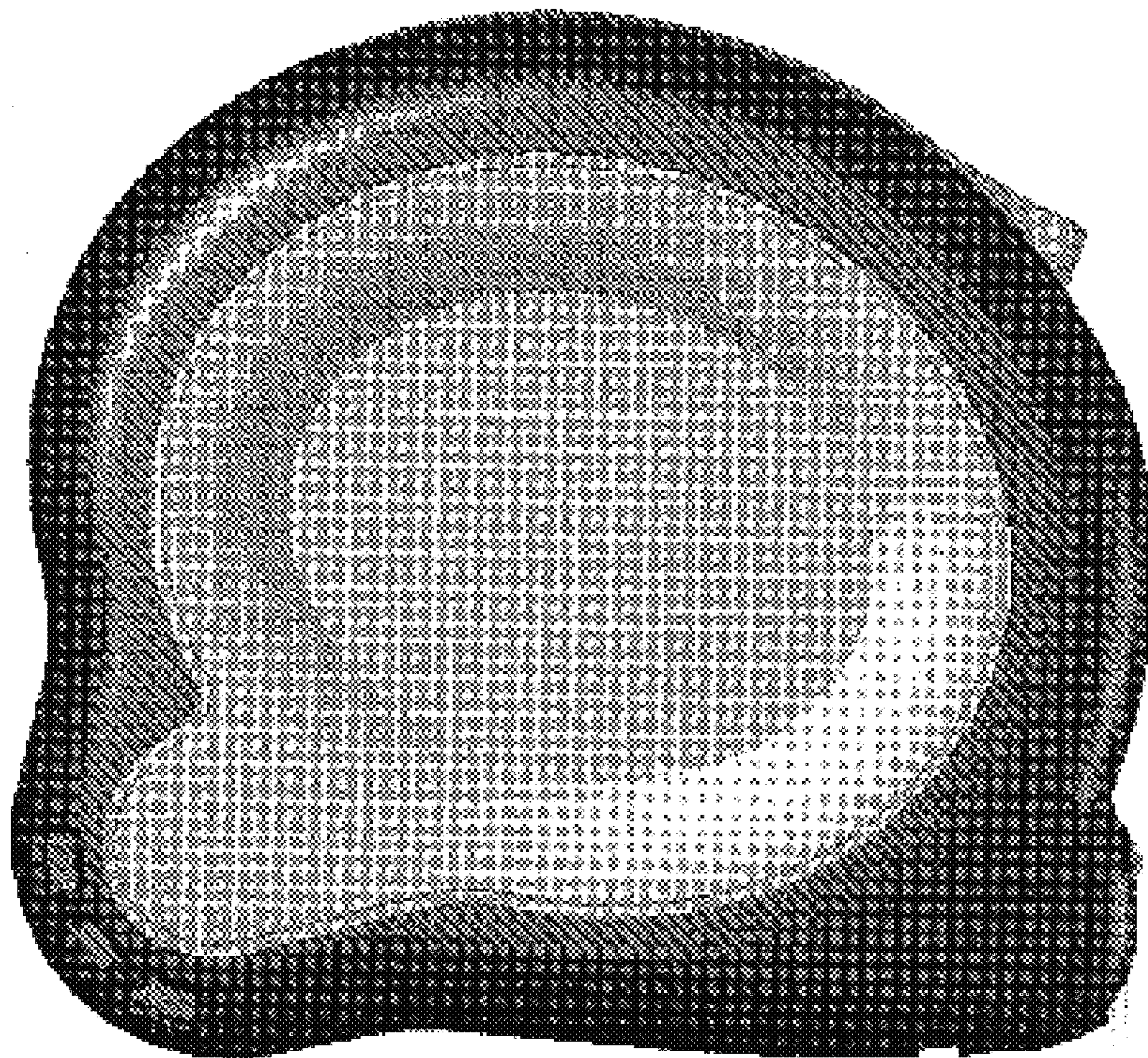

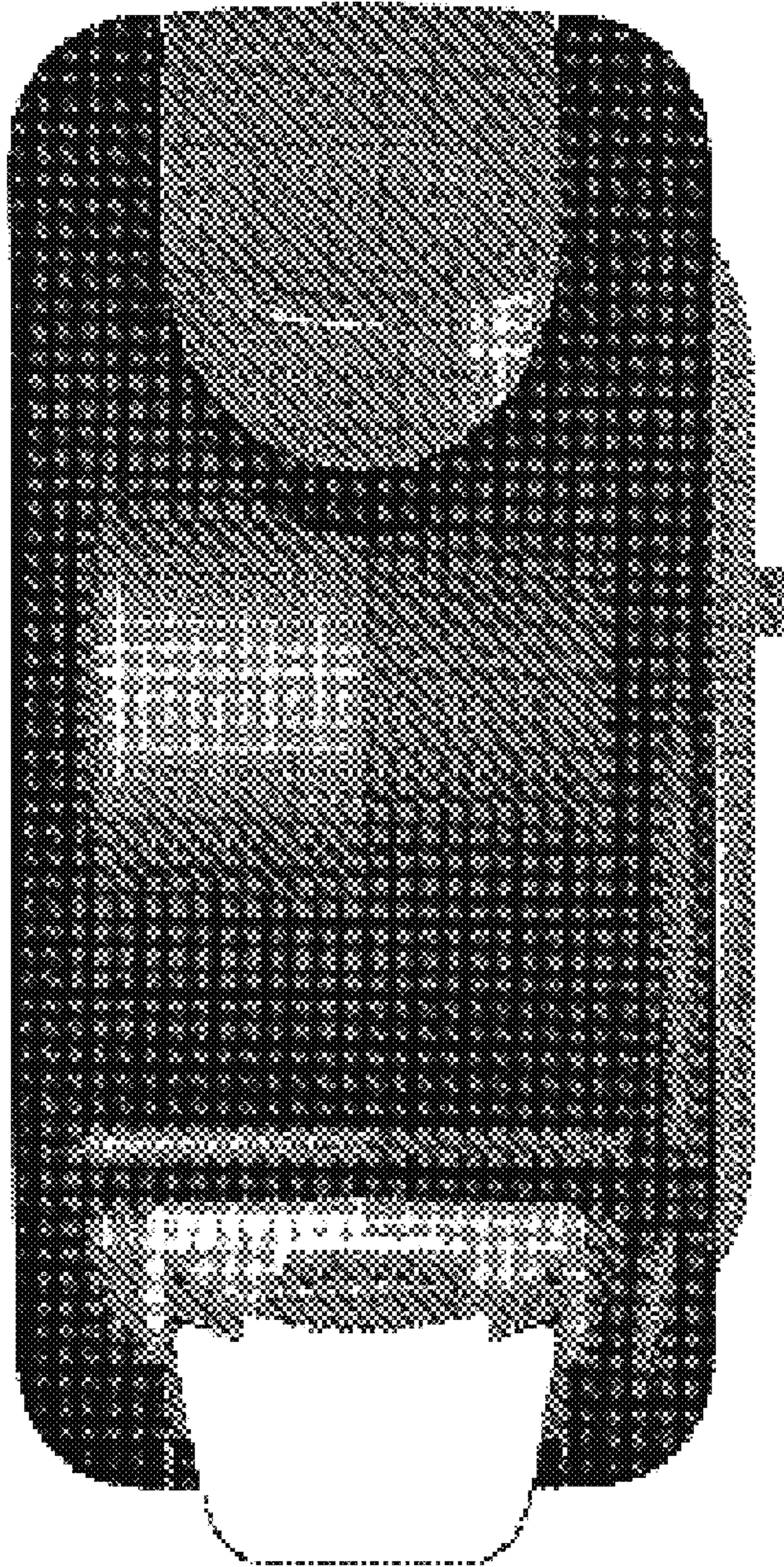

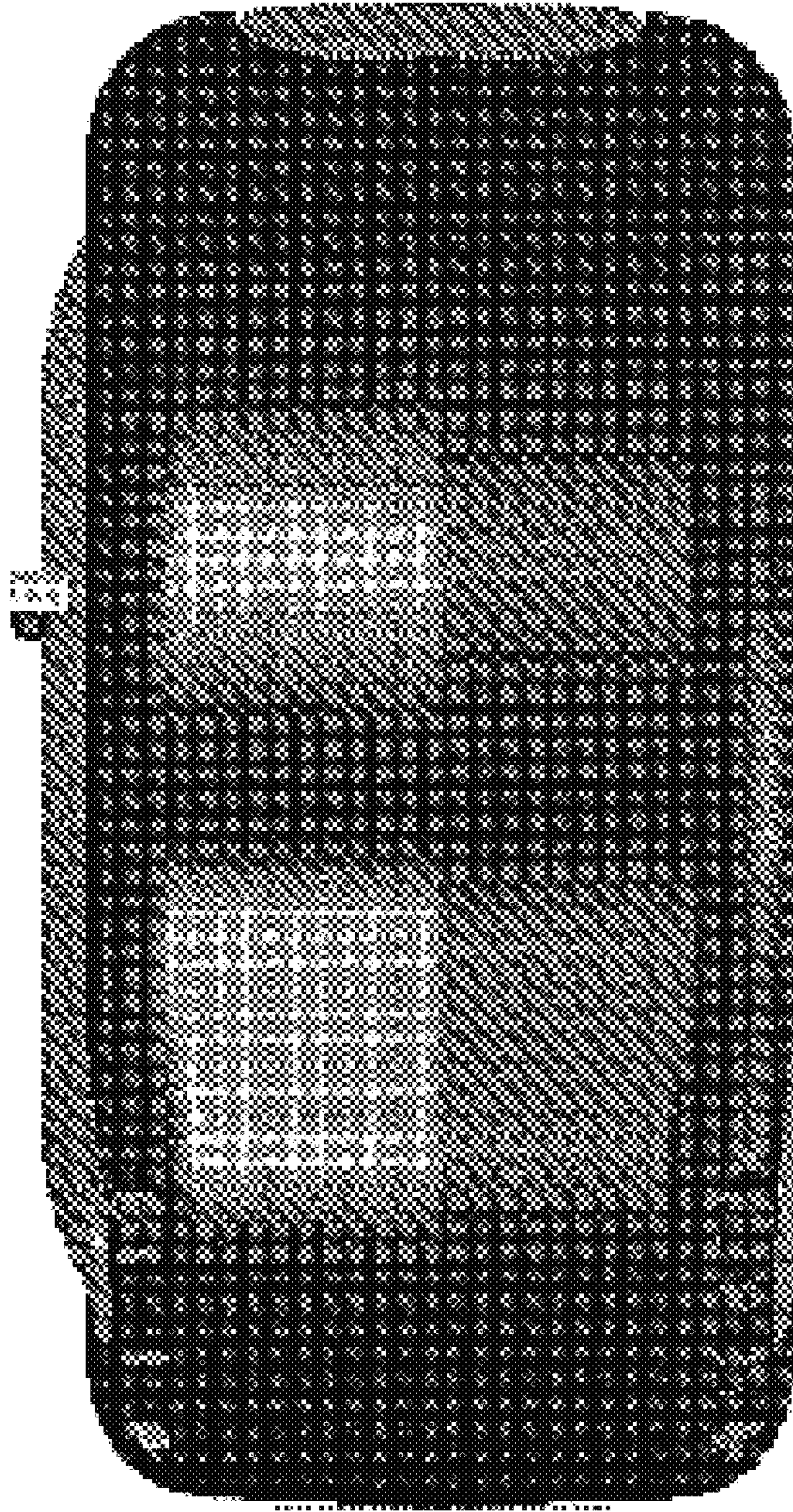

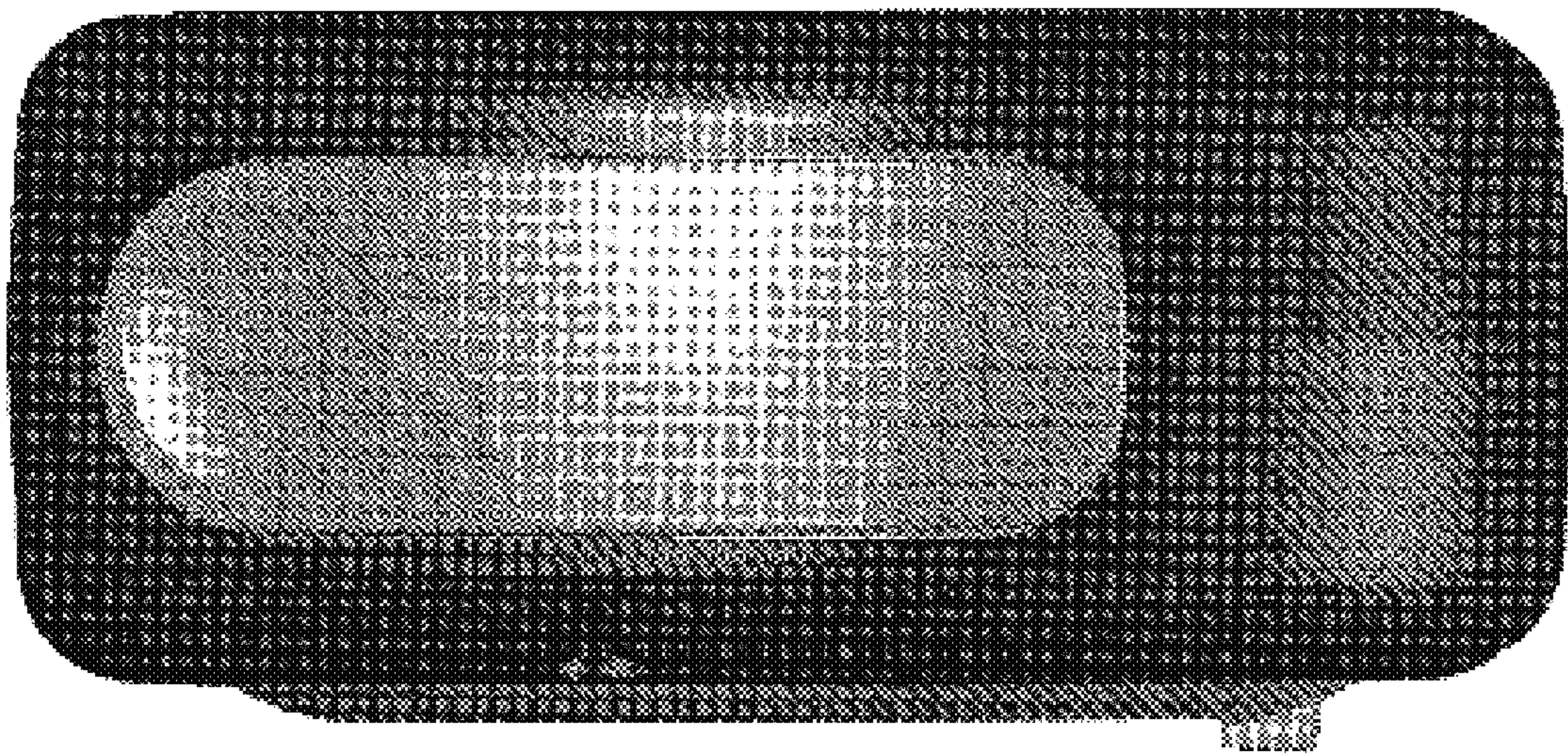

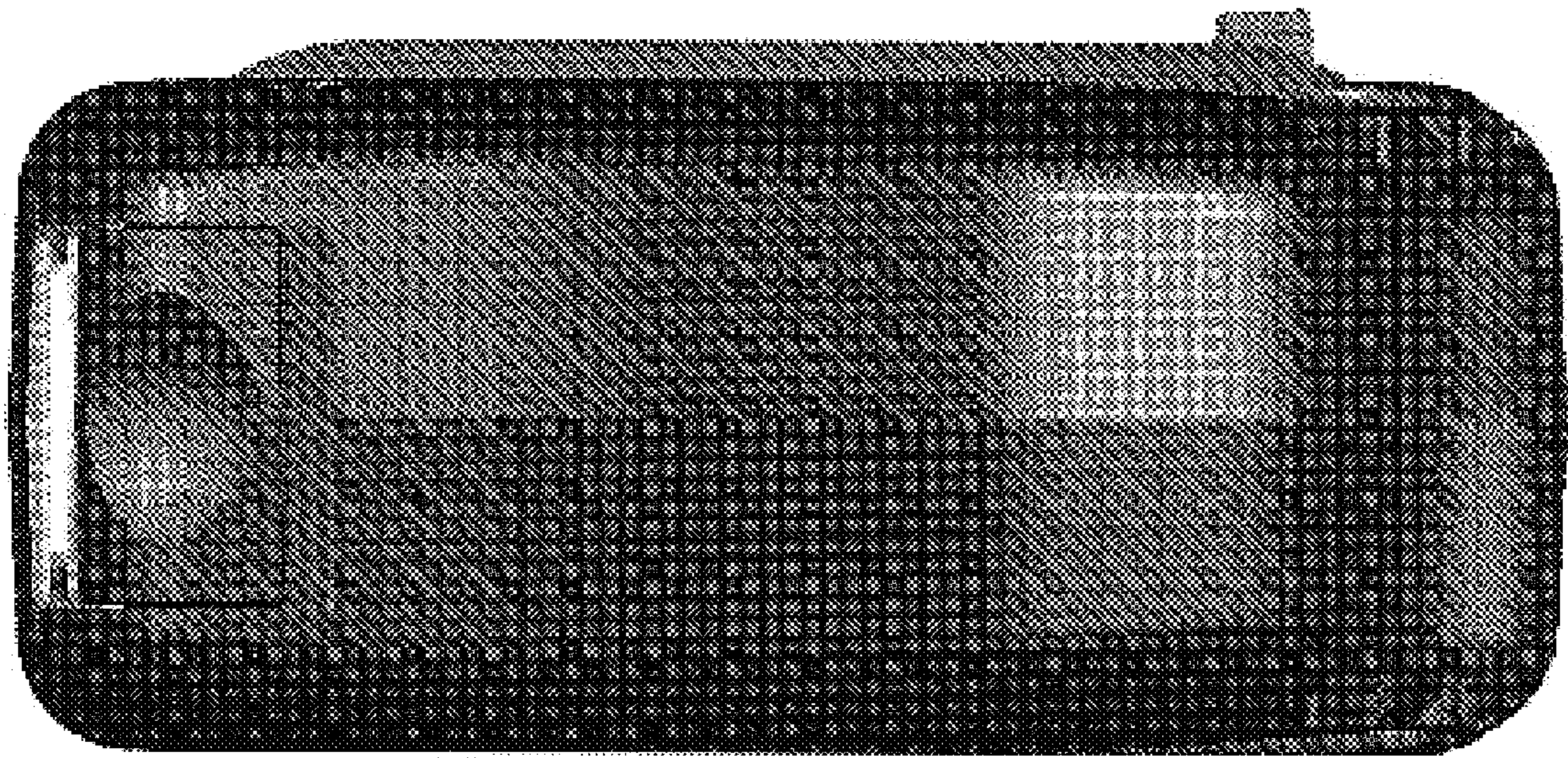
