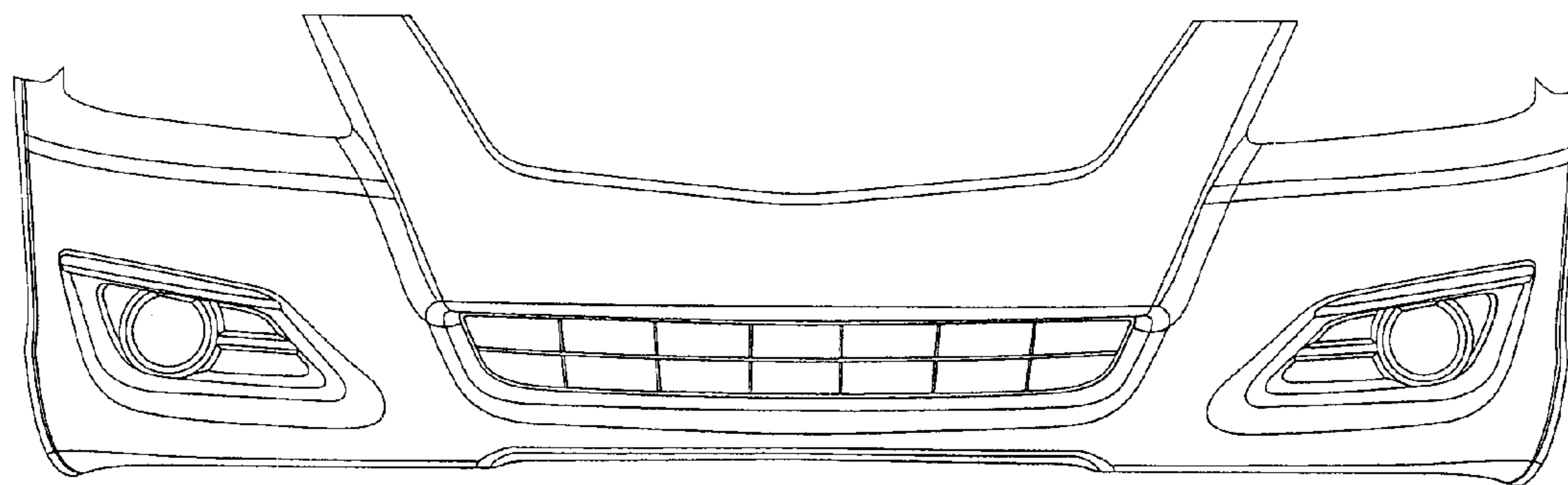

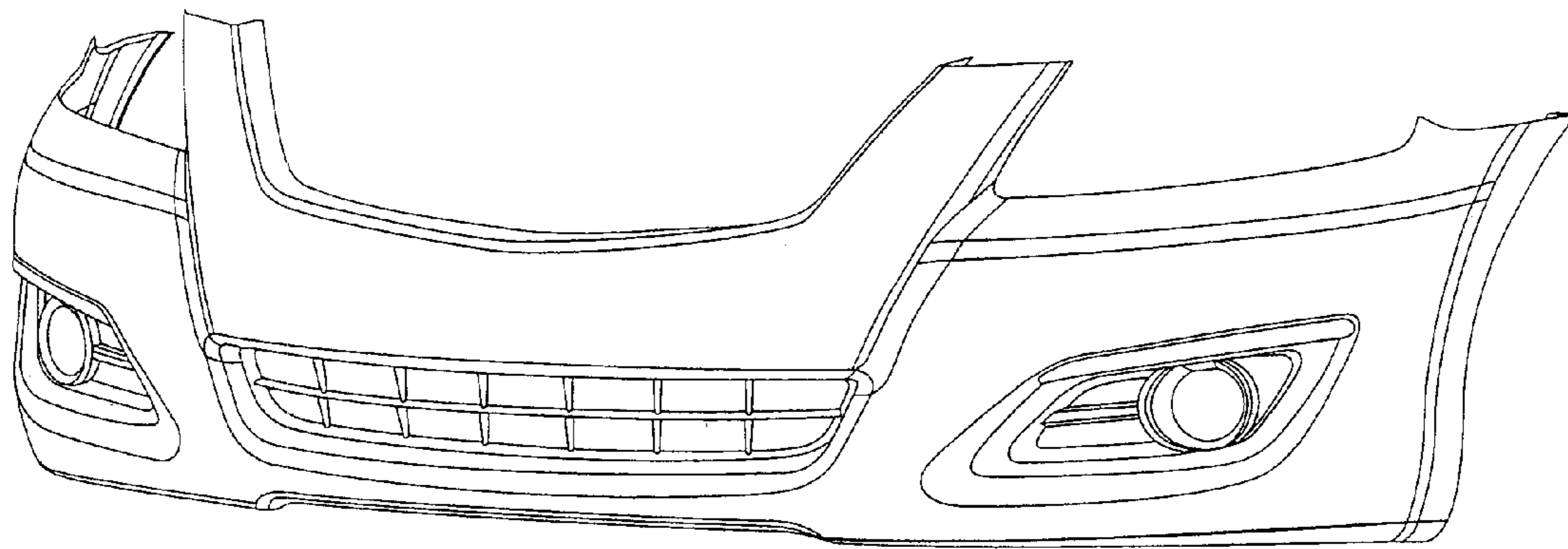
The ornamental design for a front bumper for an automobile, as shown and described.

**DESCRIPTION**

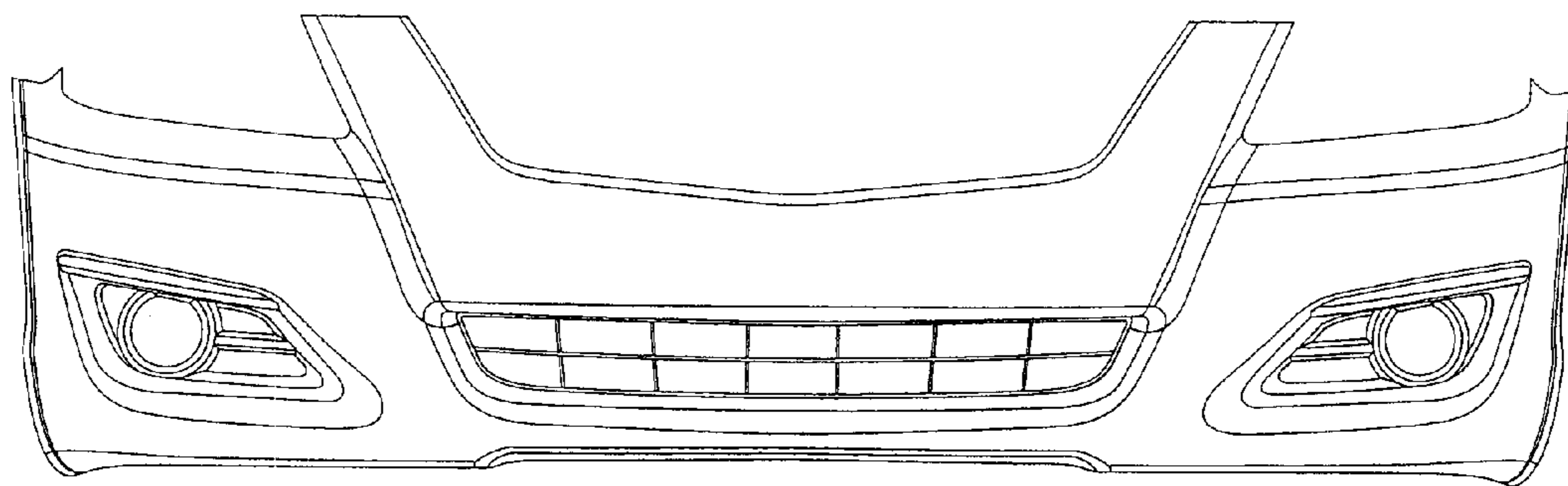
FIG. 1 is a front perspective view of a front bumper for an automobile showing my new design;

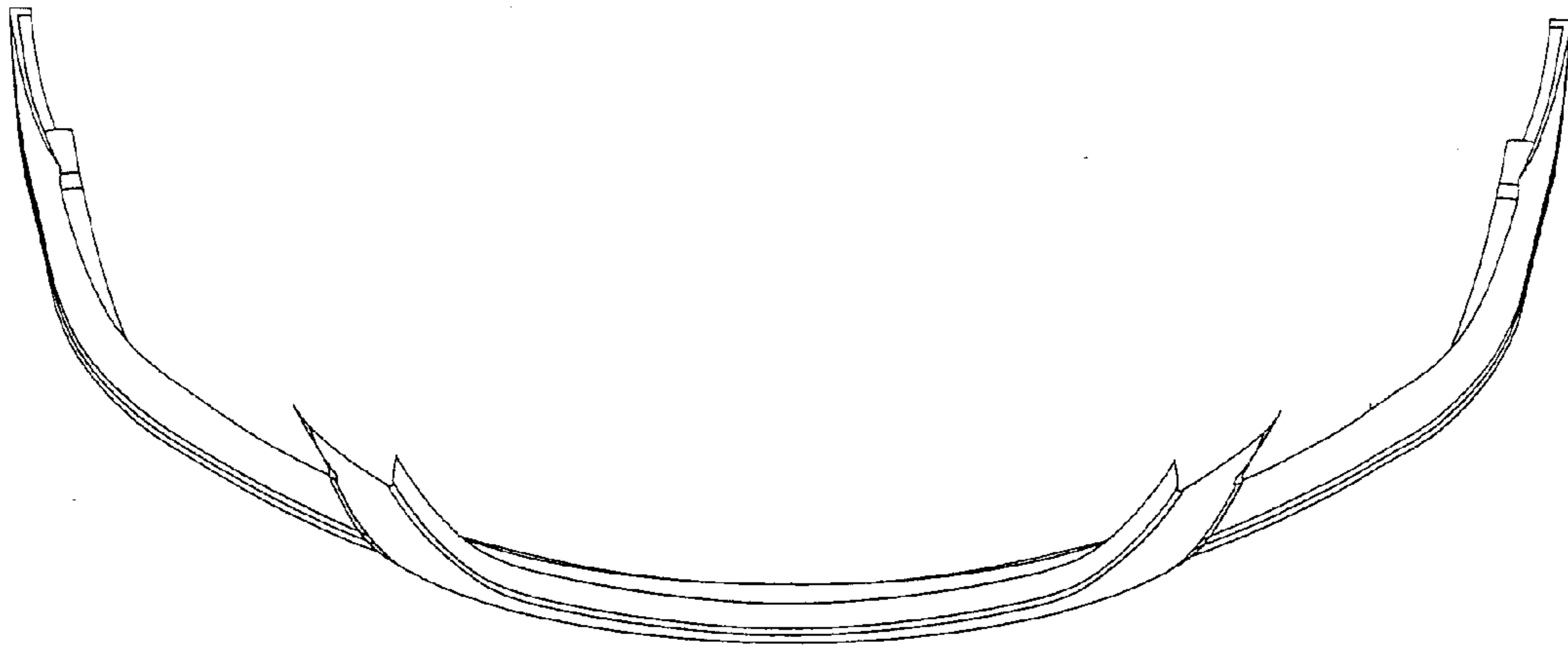




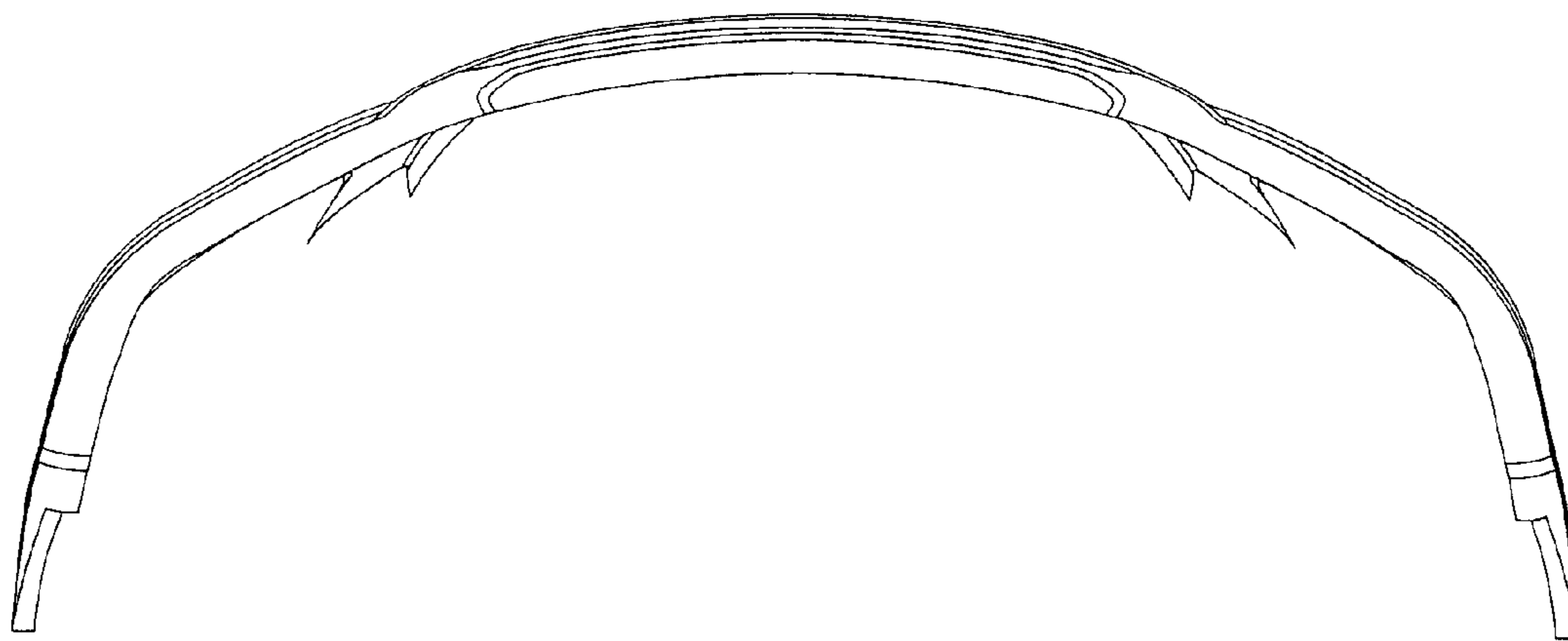

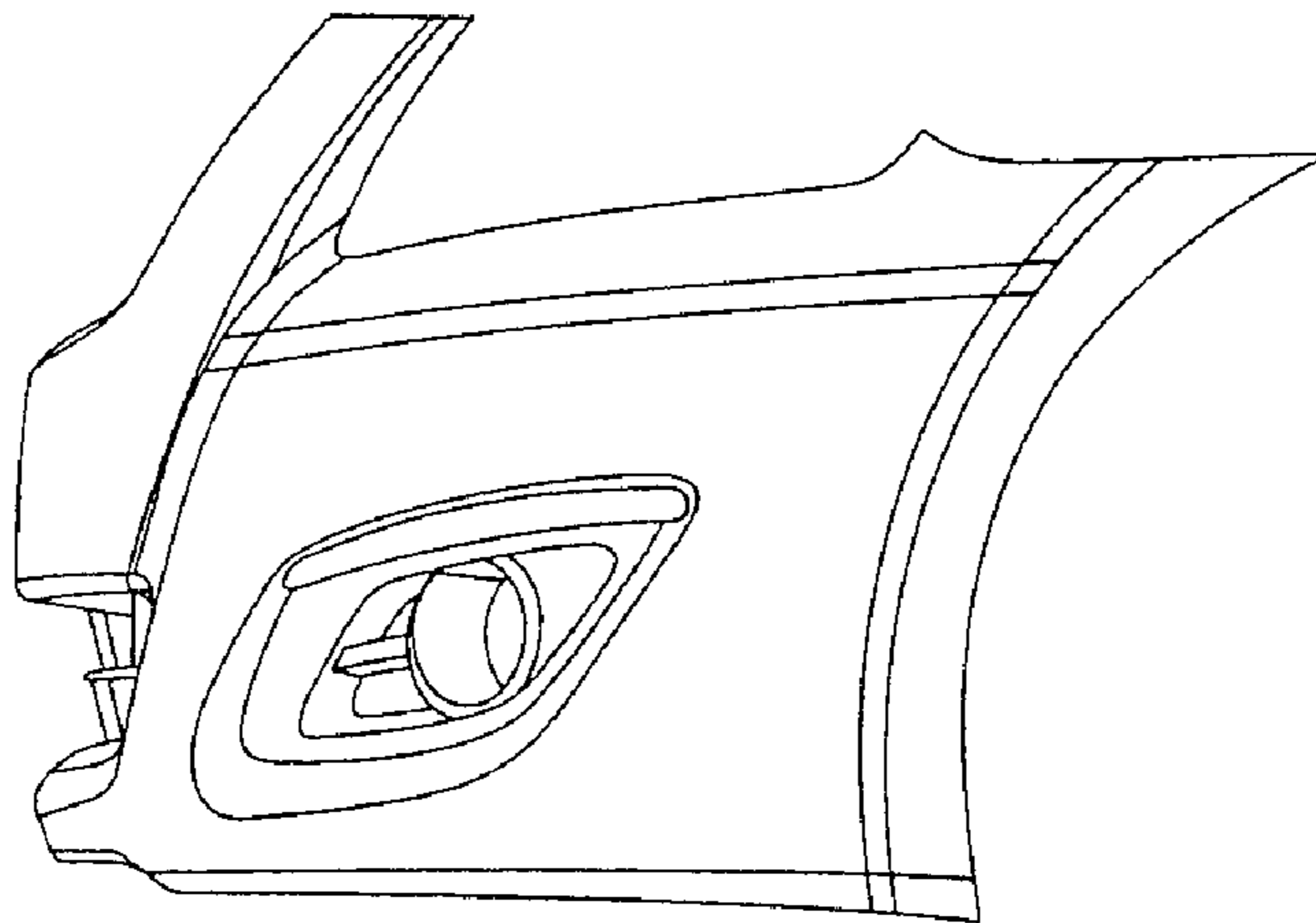
