(57) **CLAIM**

We claim the ornamental design for plasma display panel television receiver, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of plasma display panel television receiver showing the new design:

FIG. 4 is a left-side elevation view thereof;

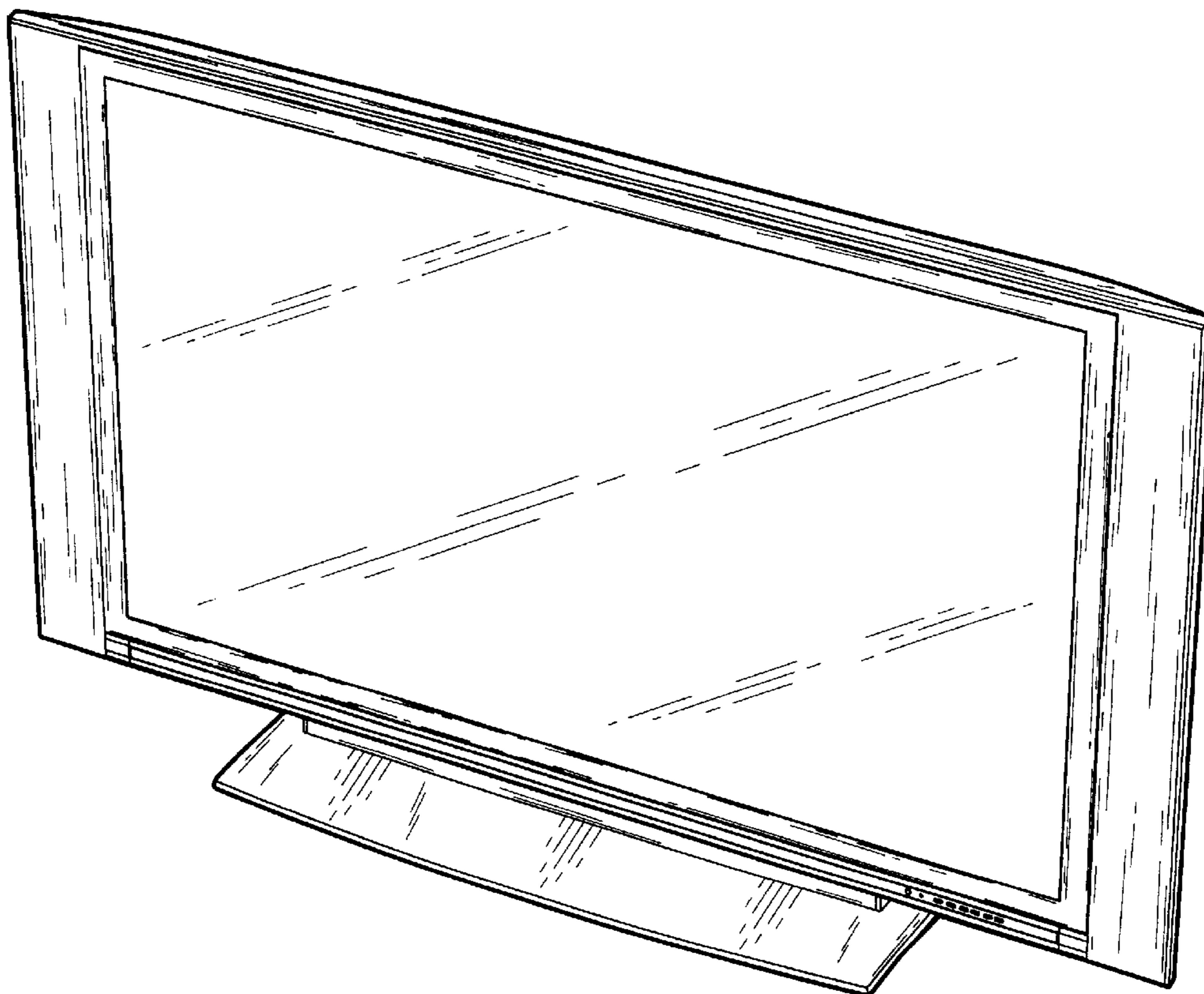

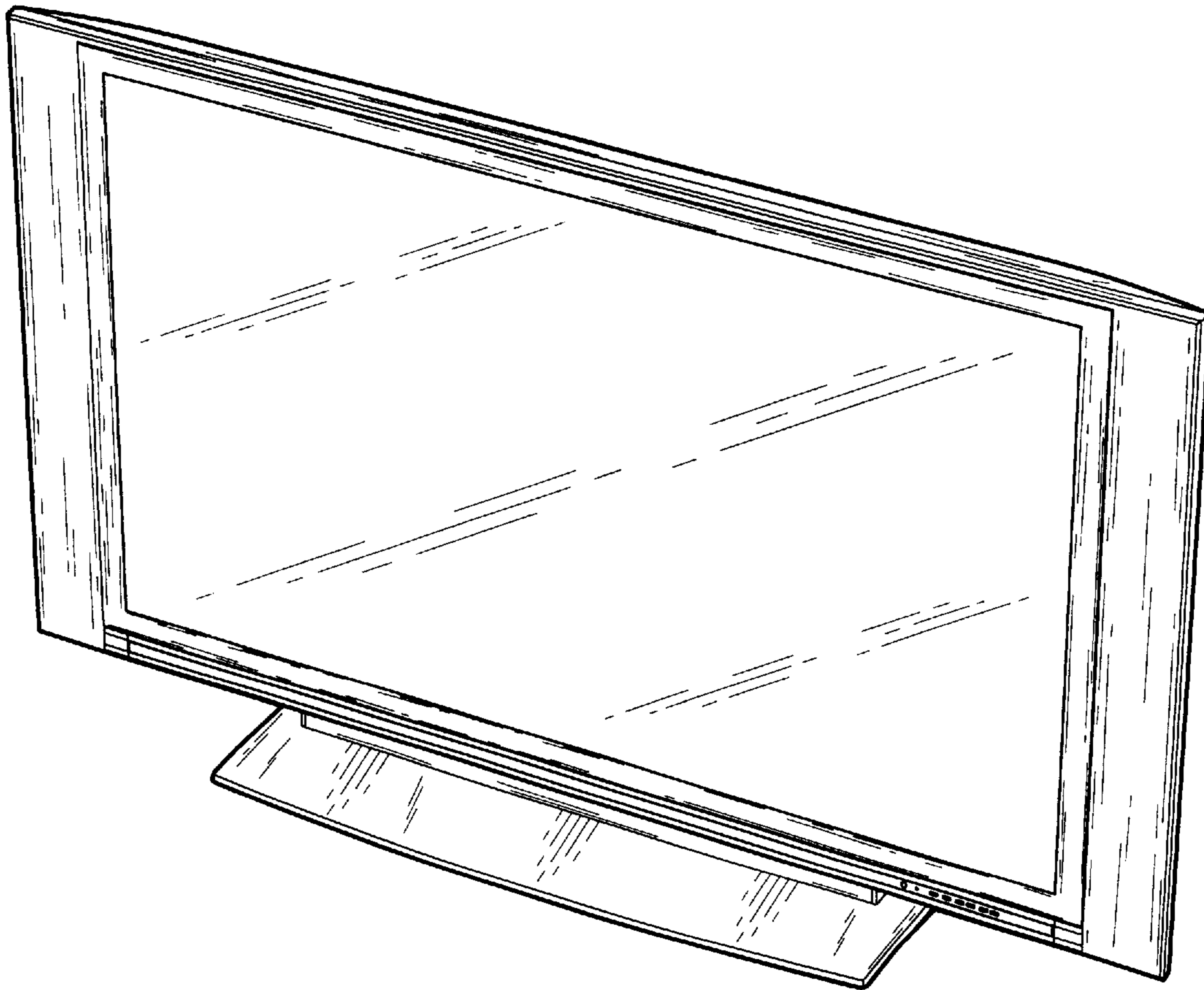

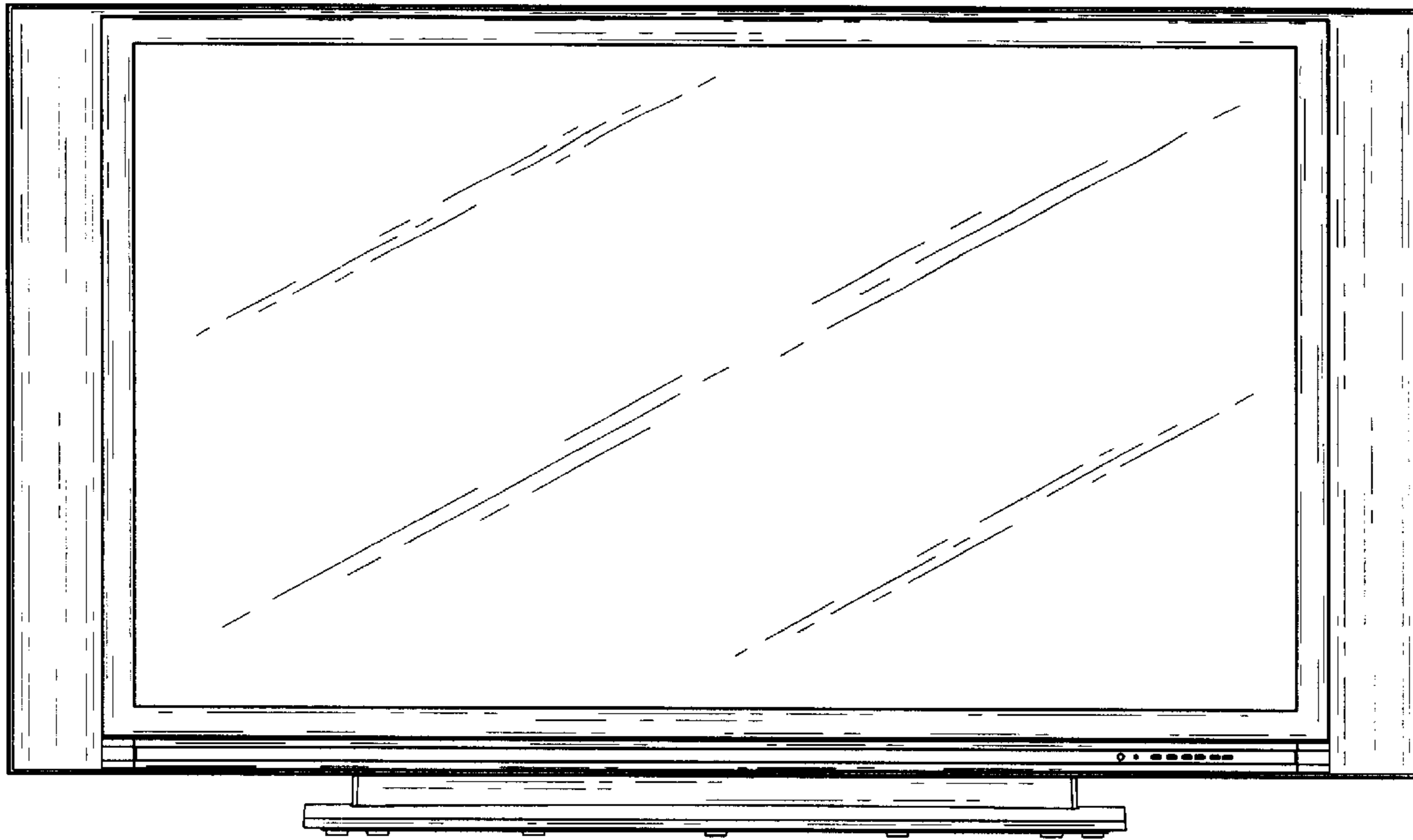

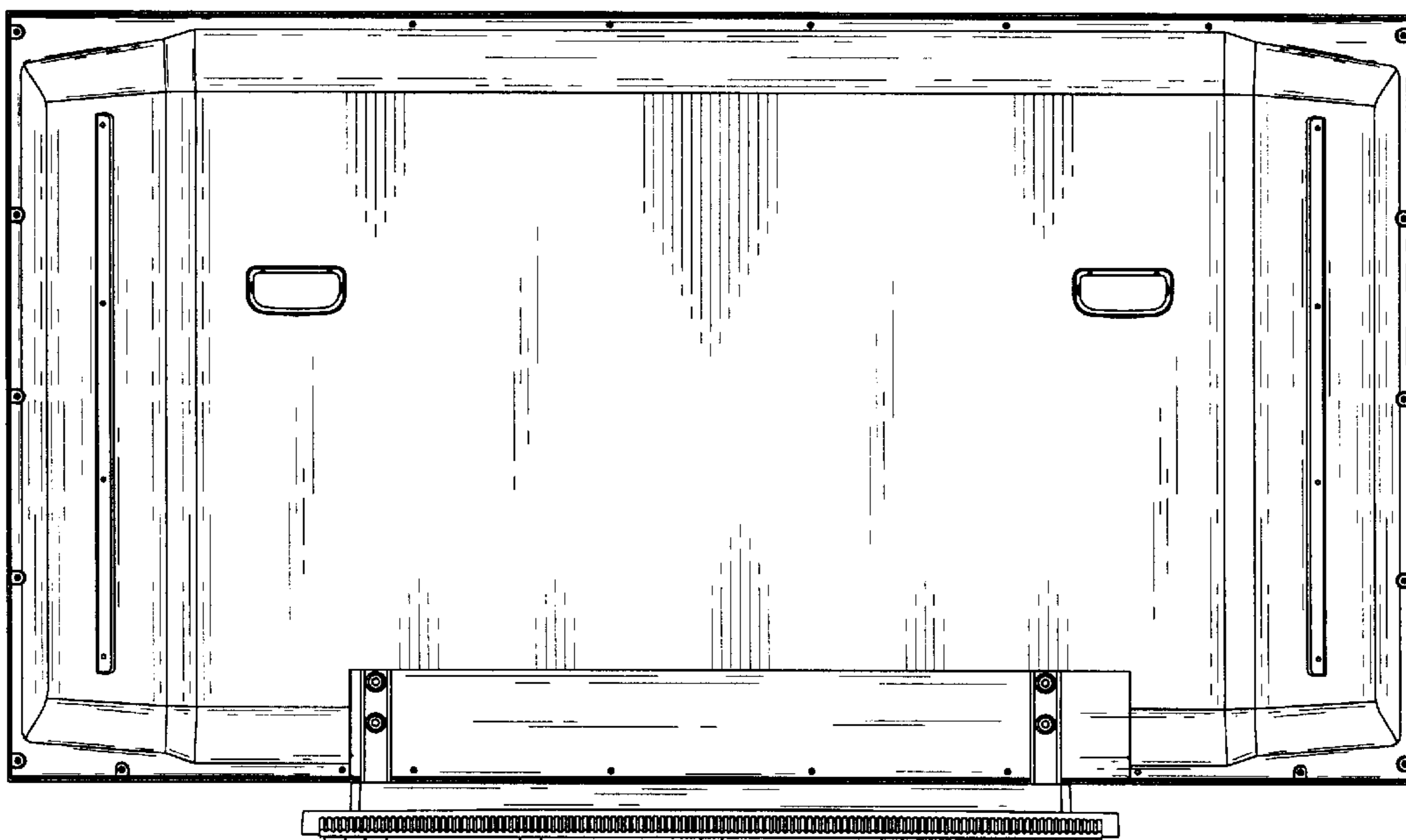

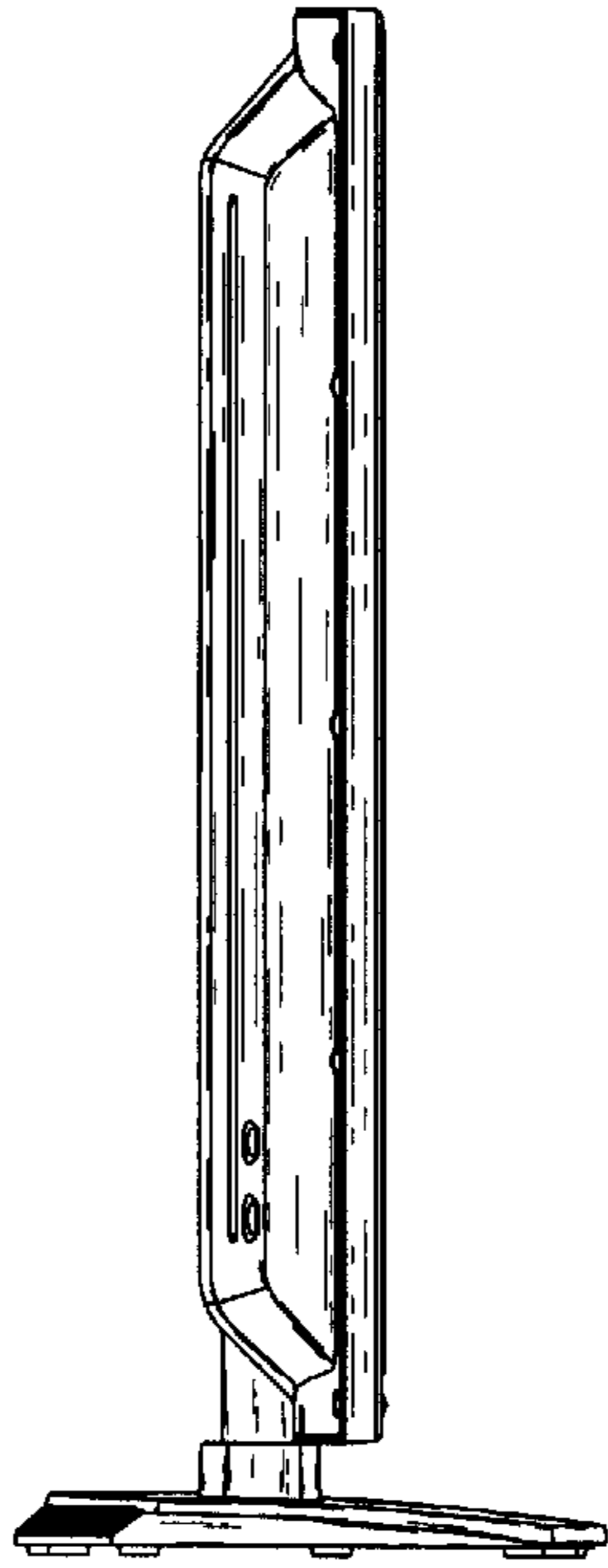

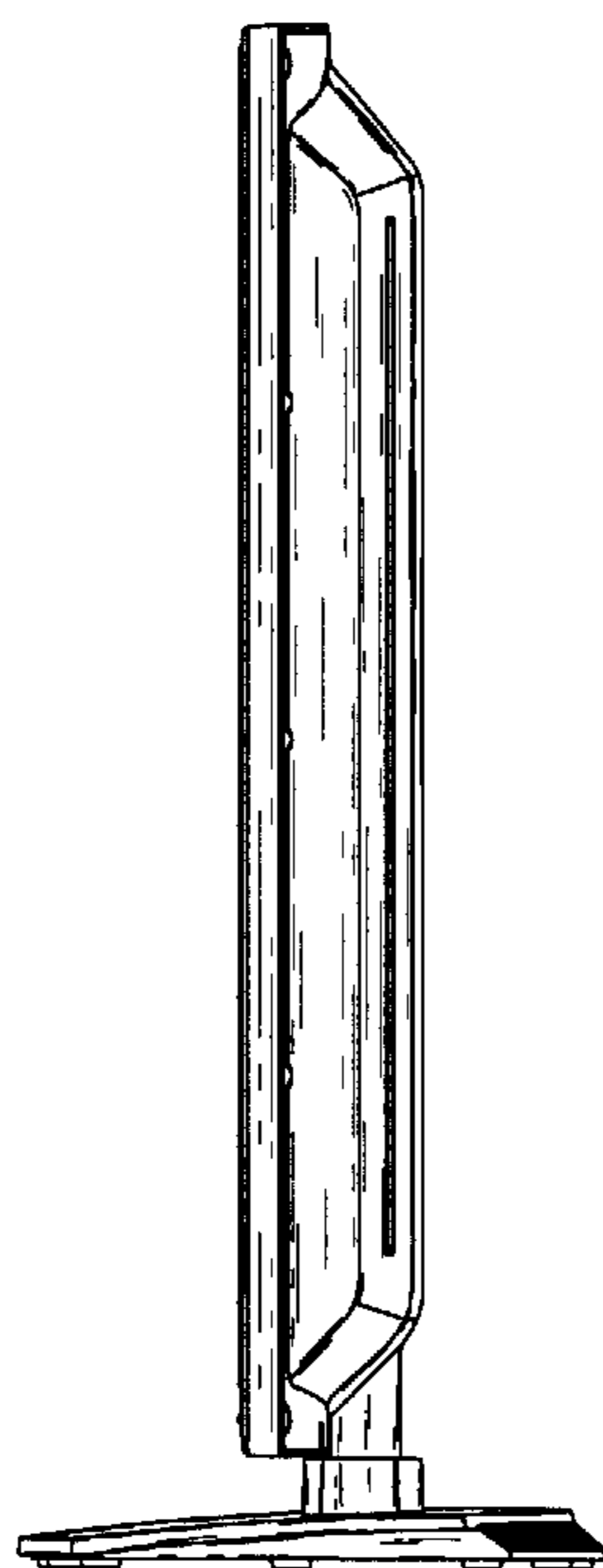

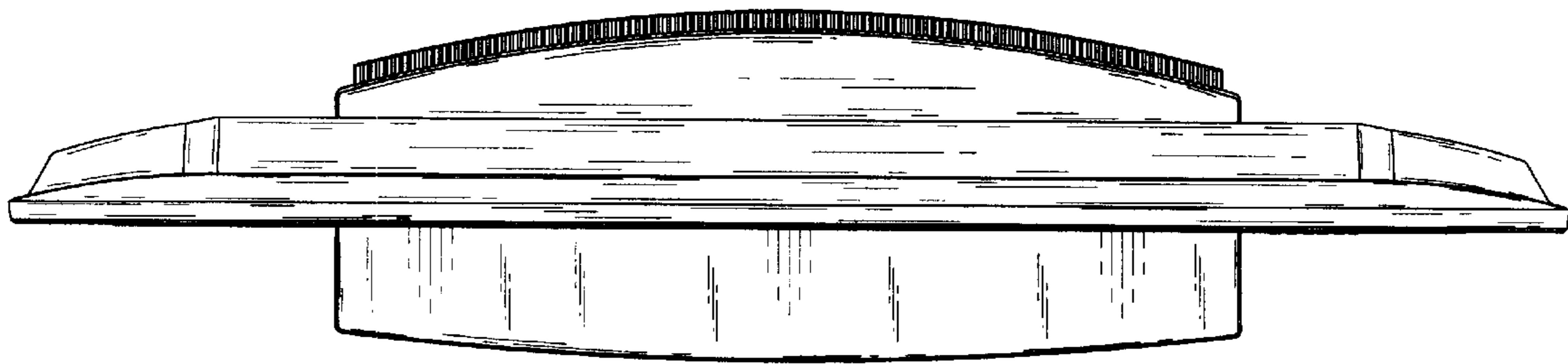
