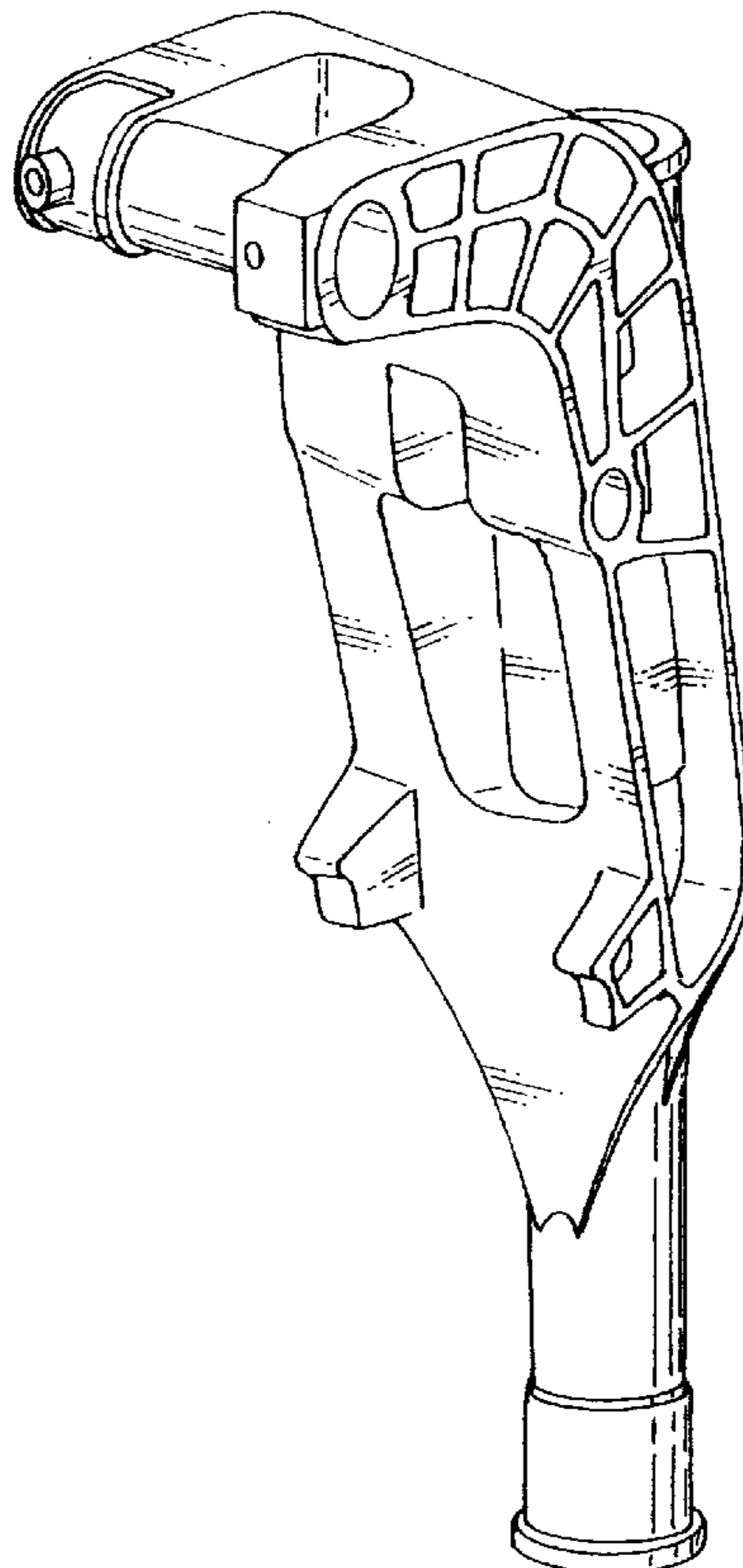
The ornamental design for a bracket of outboard motor, as shown and described.

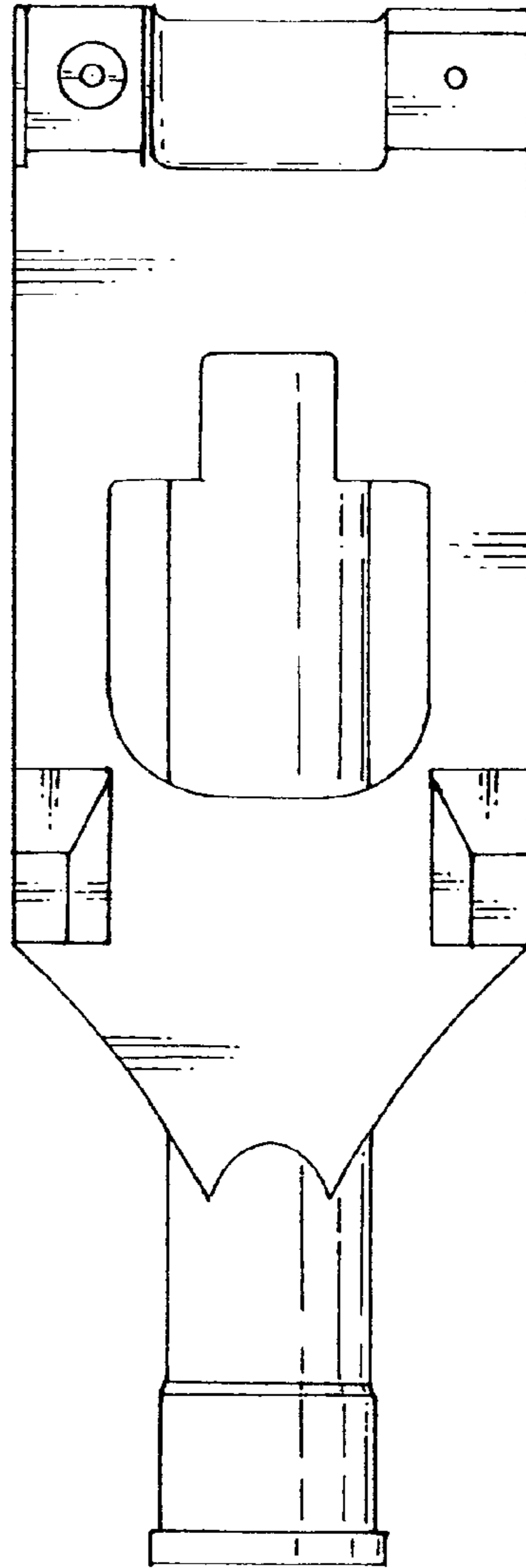

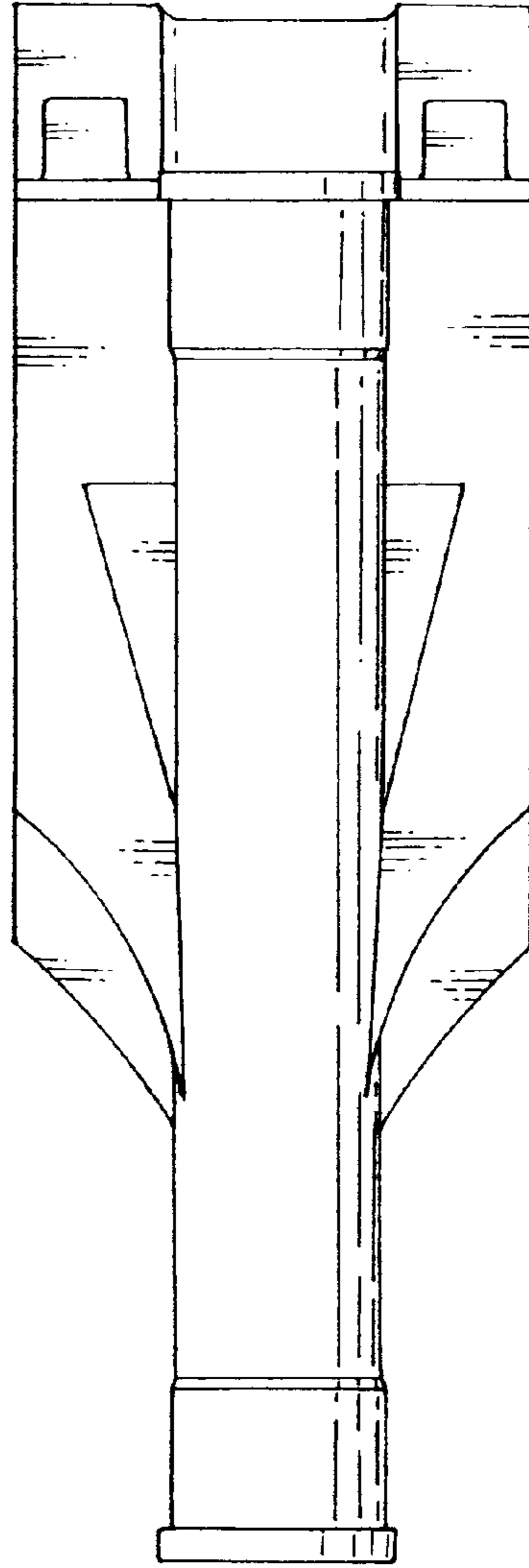

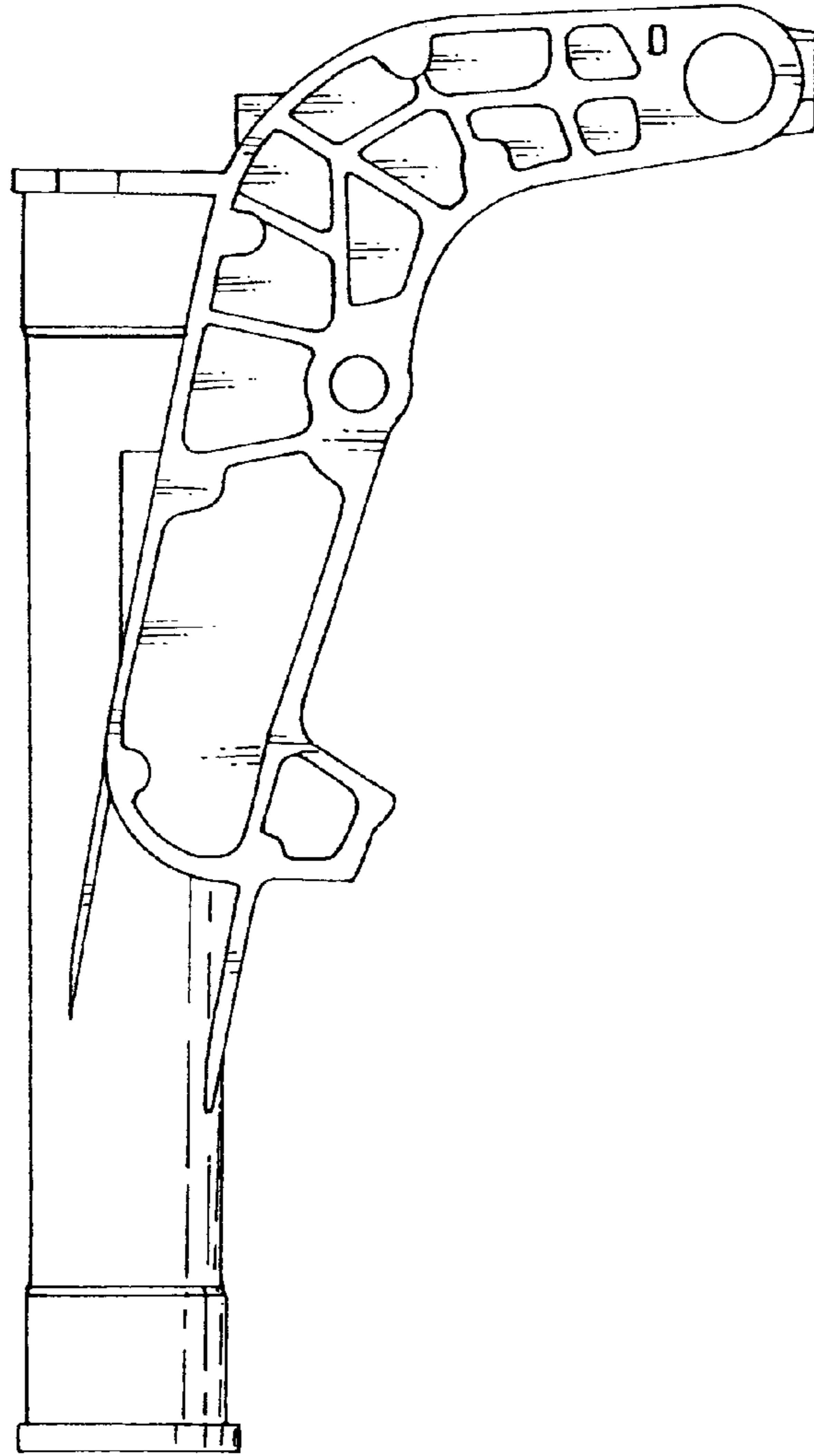

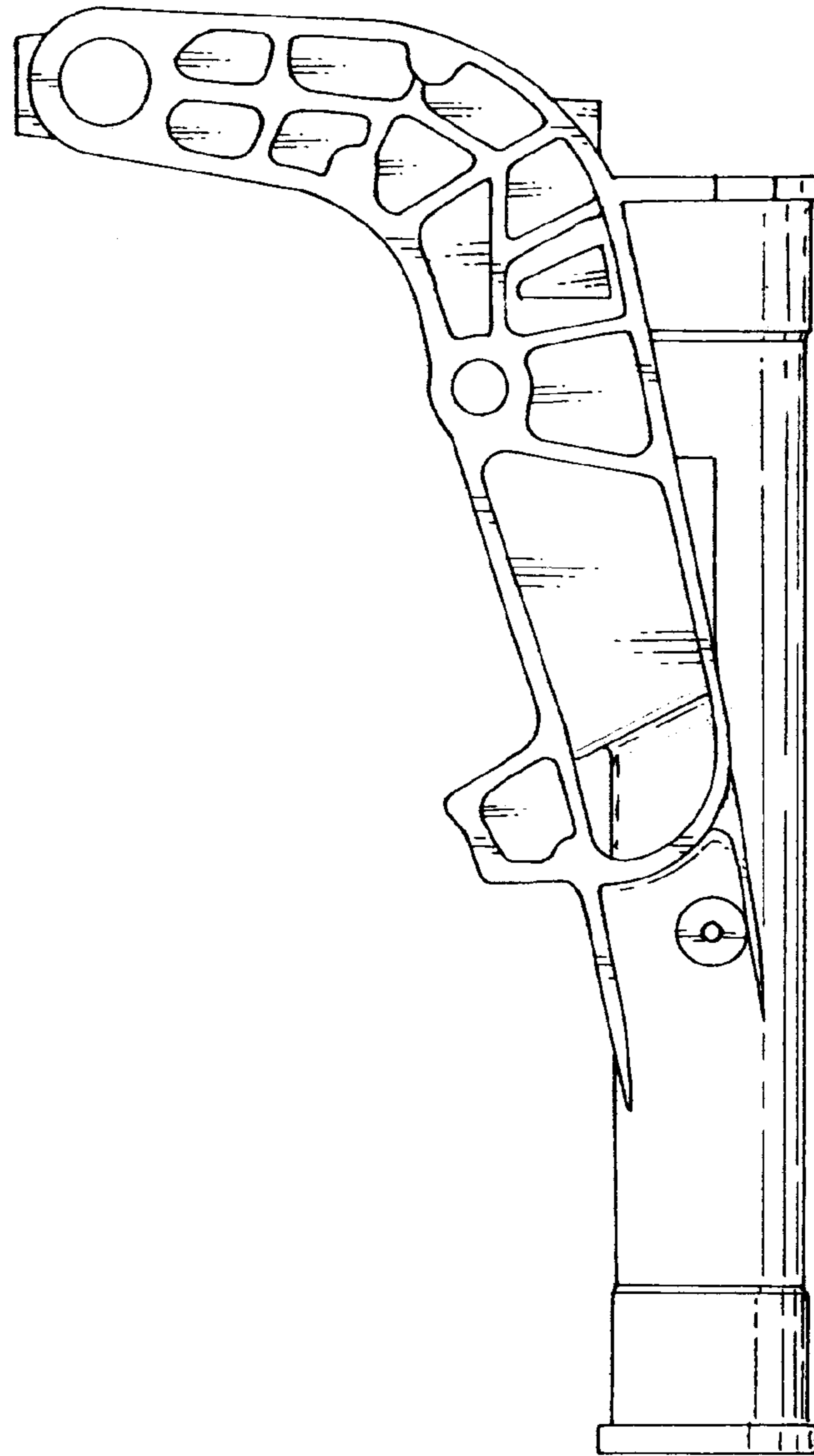

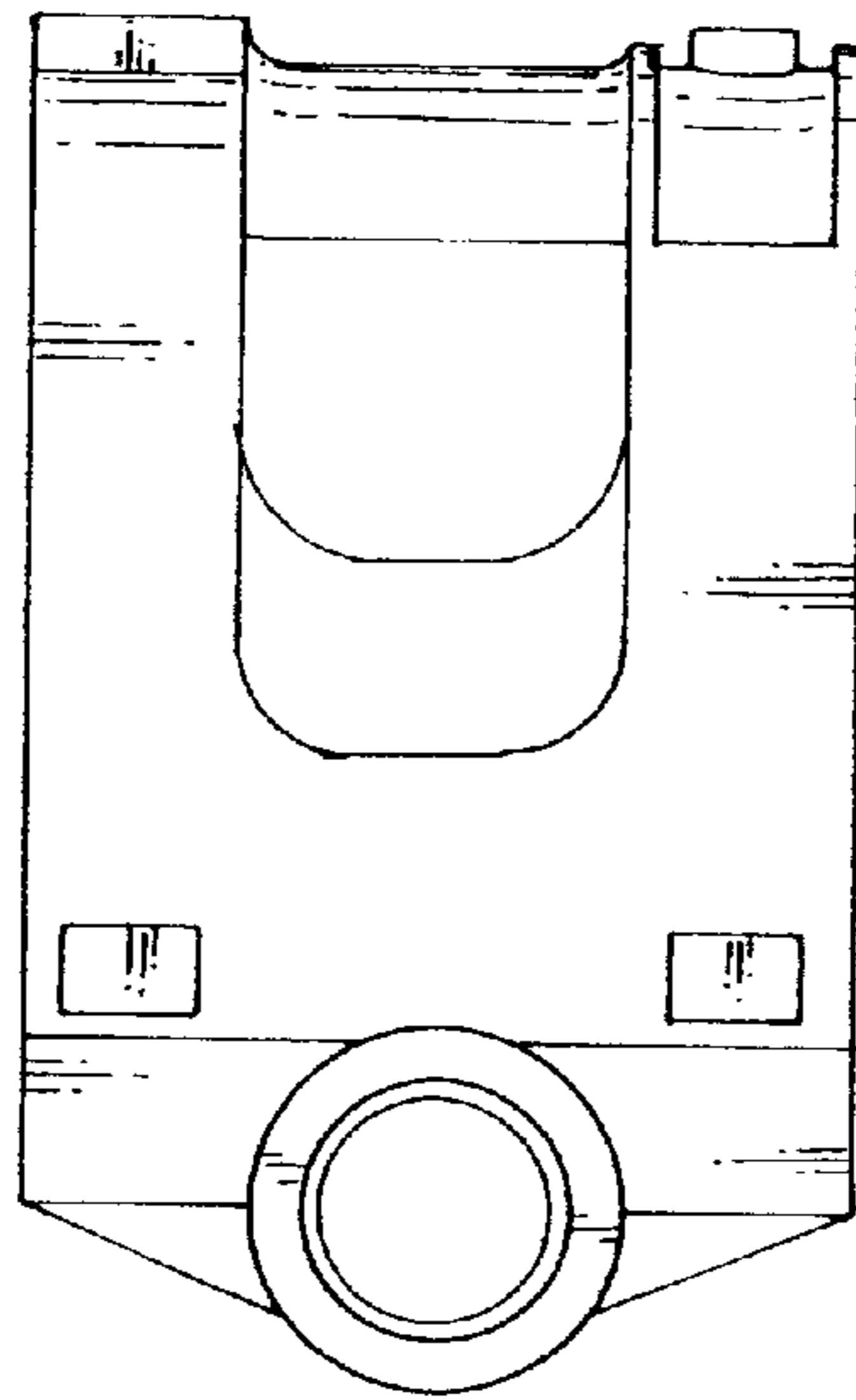

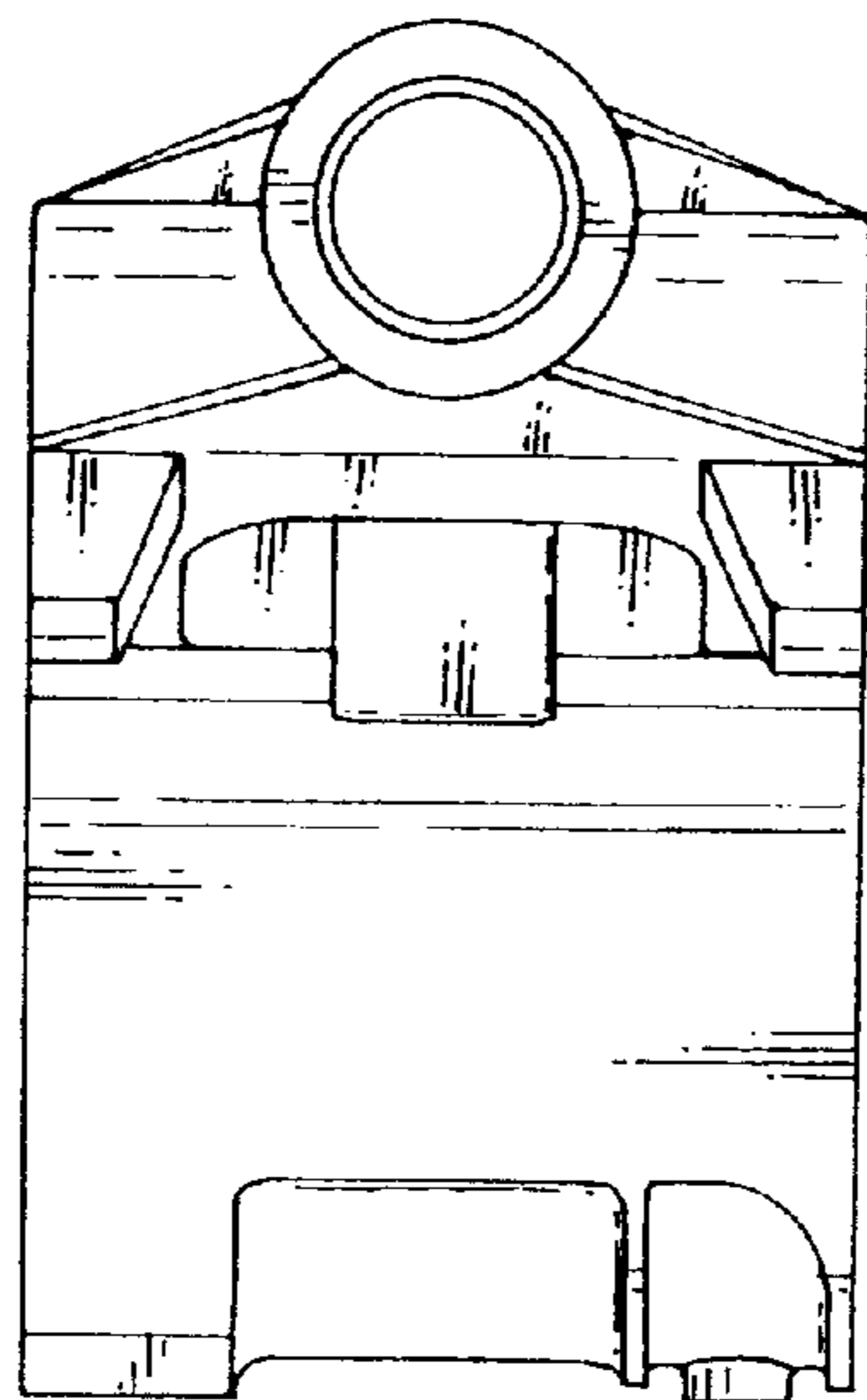

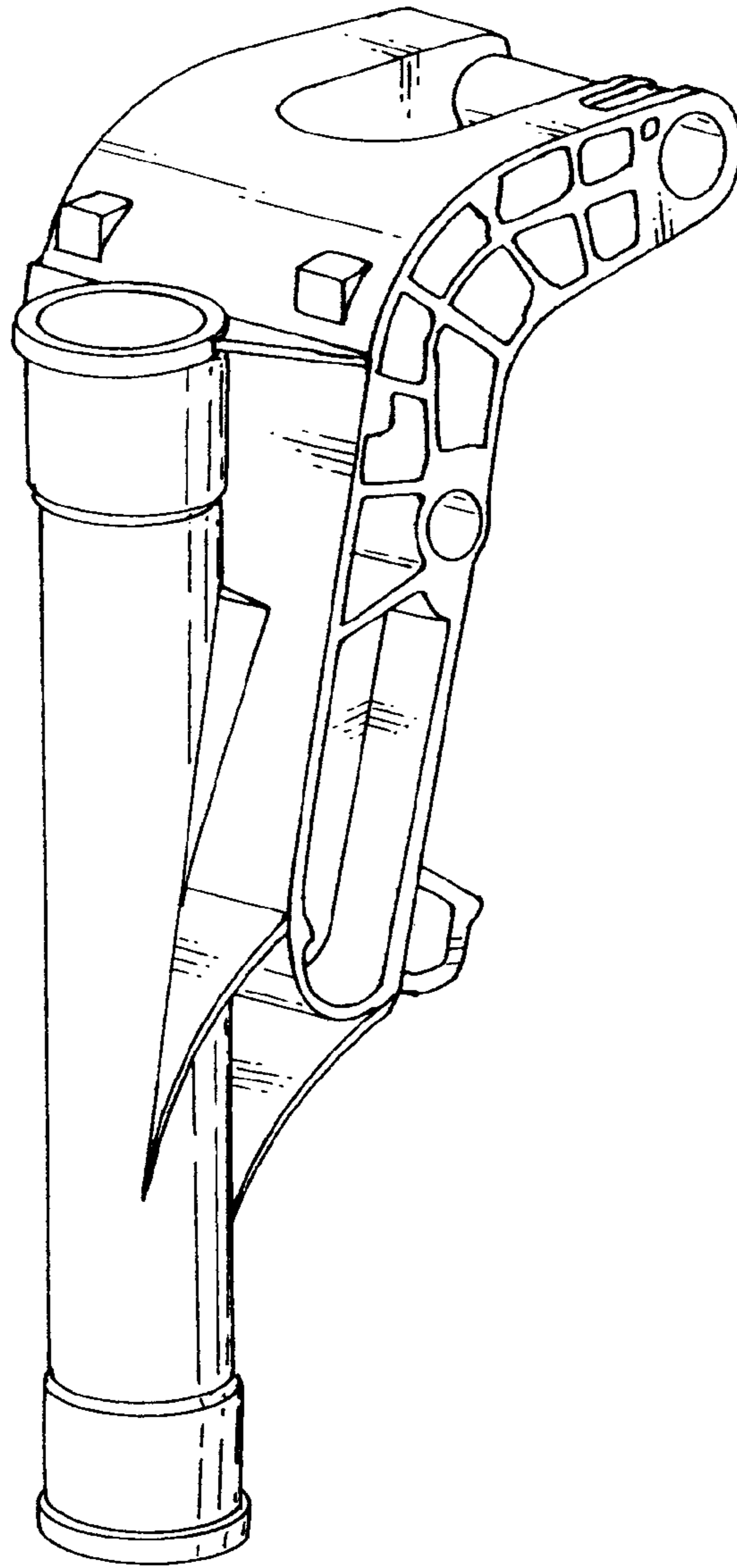

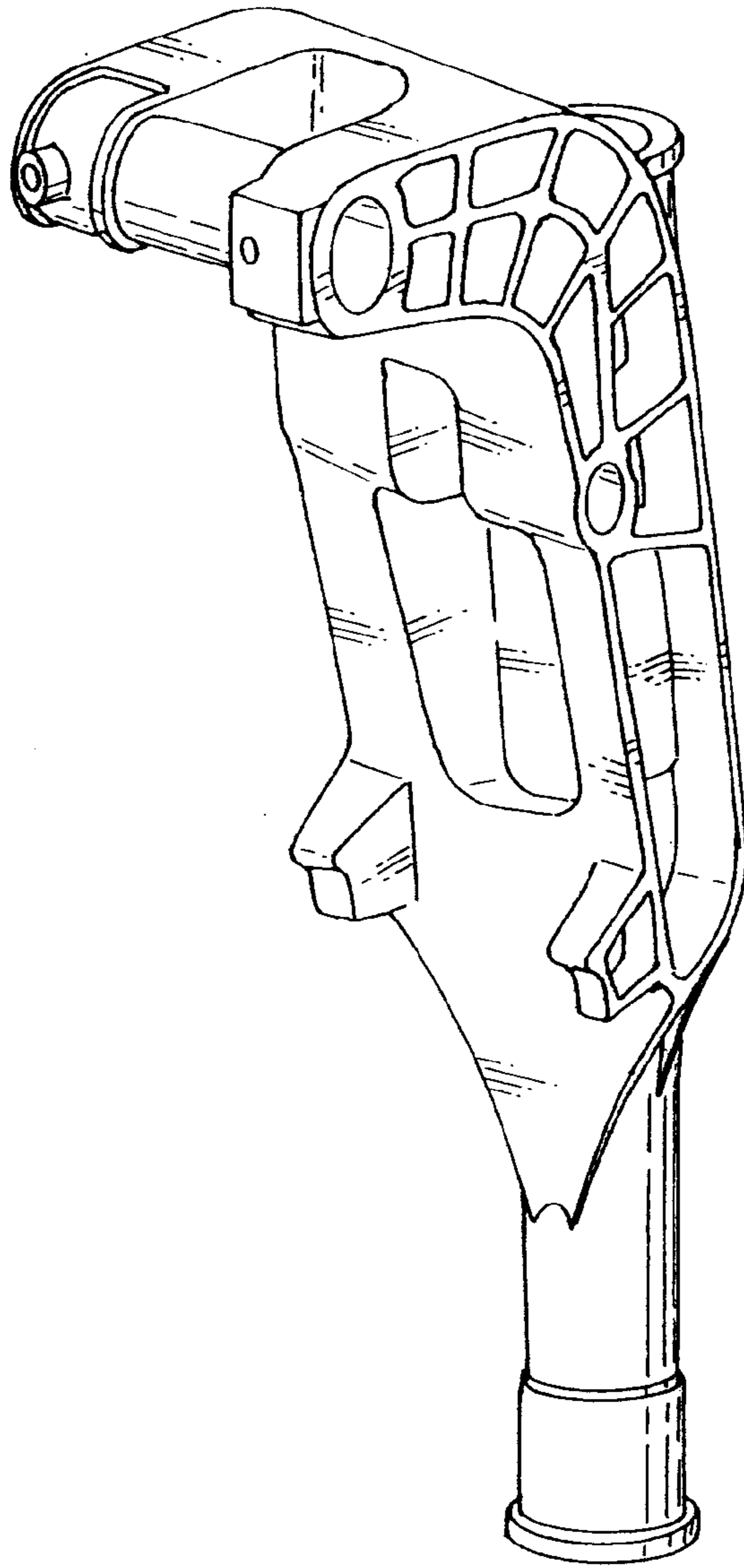

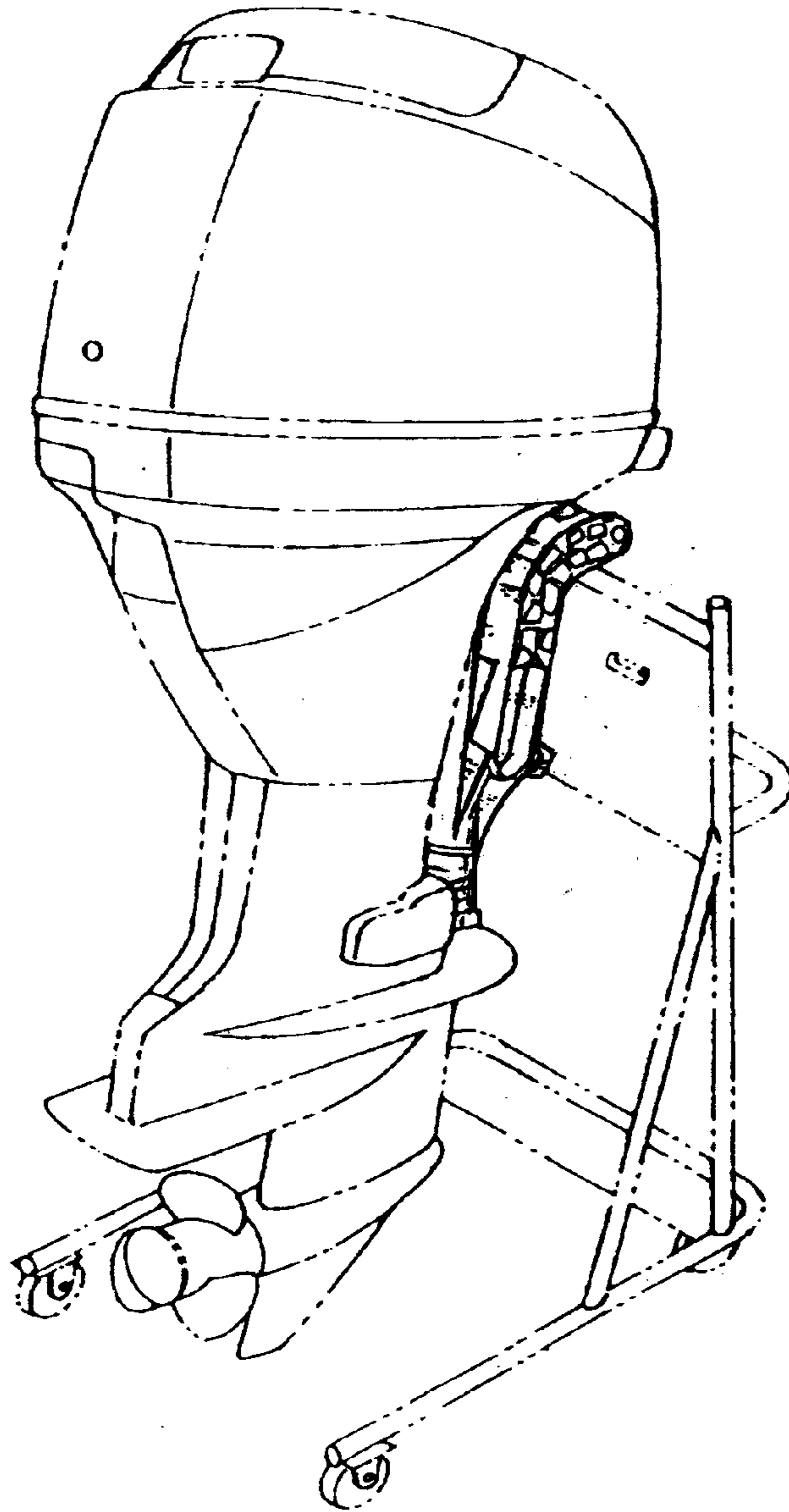
