FIG. 9 is a left side view of the embodiment of the dispensing cabinet shown in FIG. 1, but omitting the hinges.

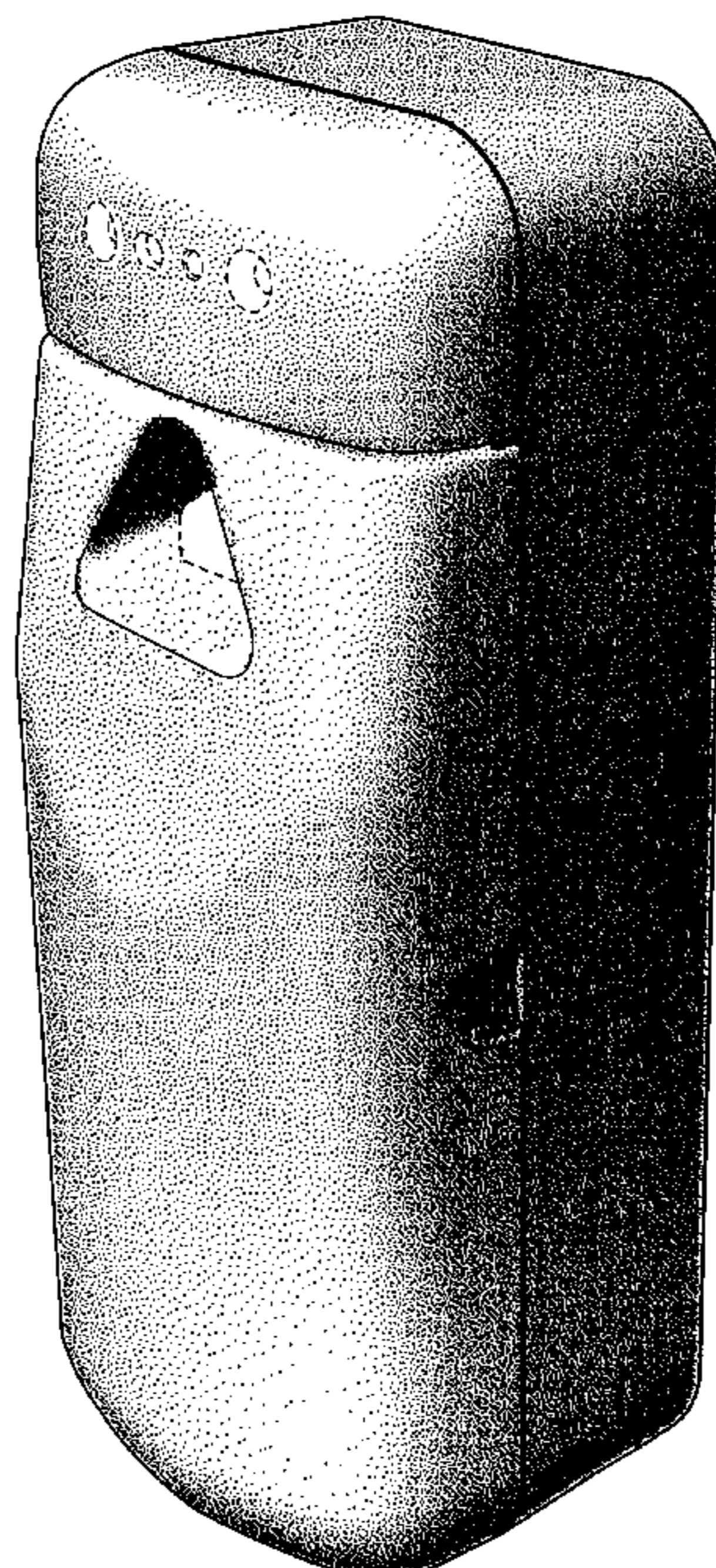

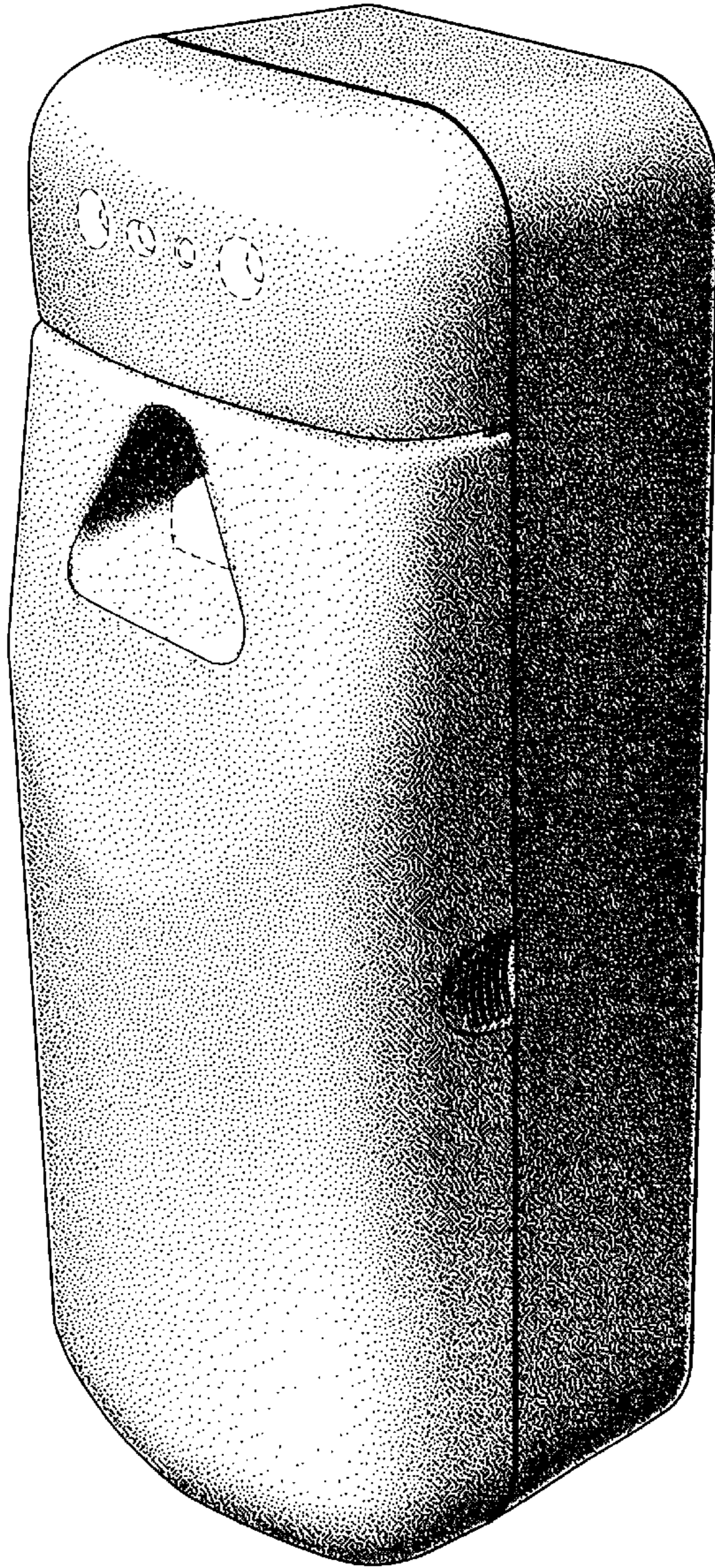
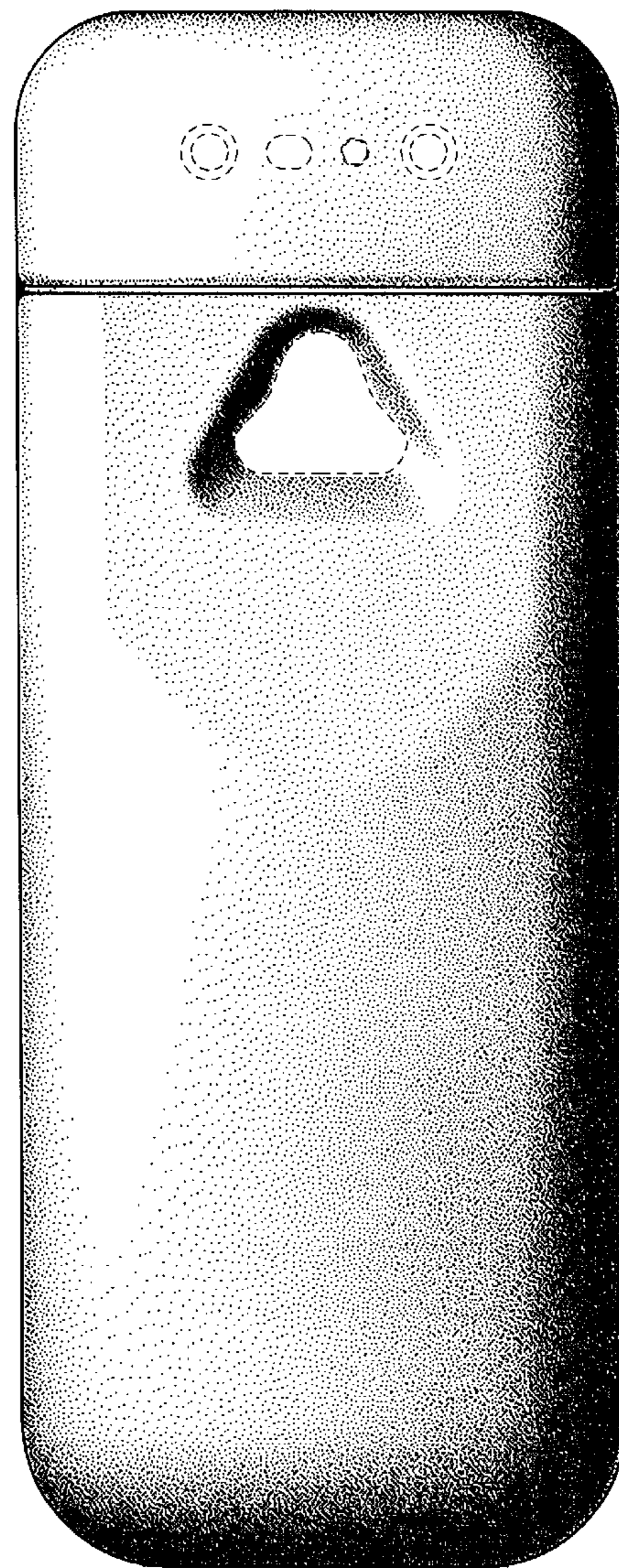

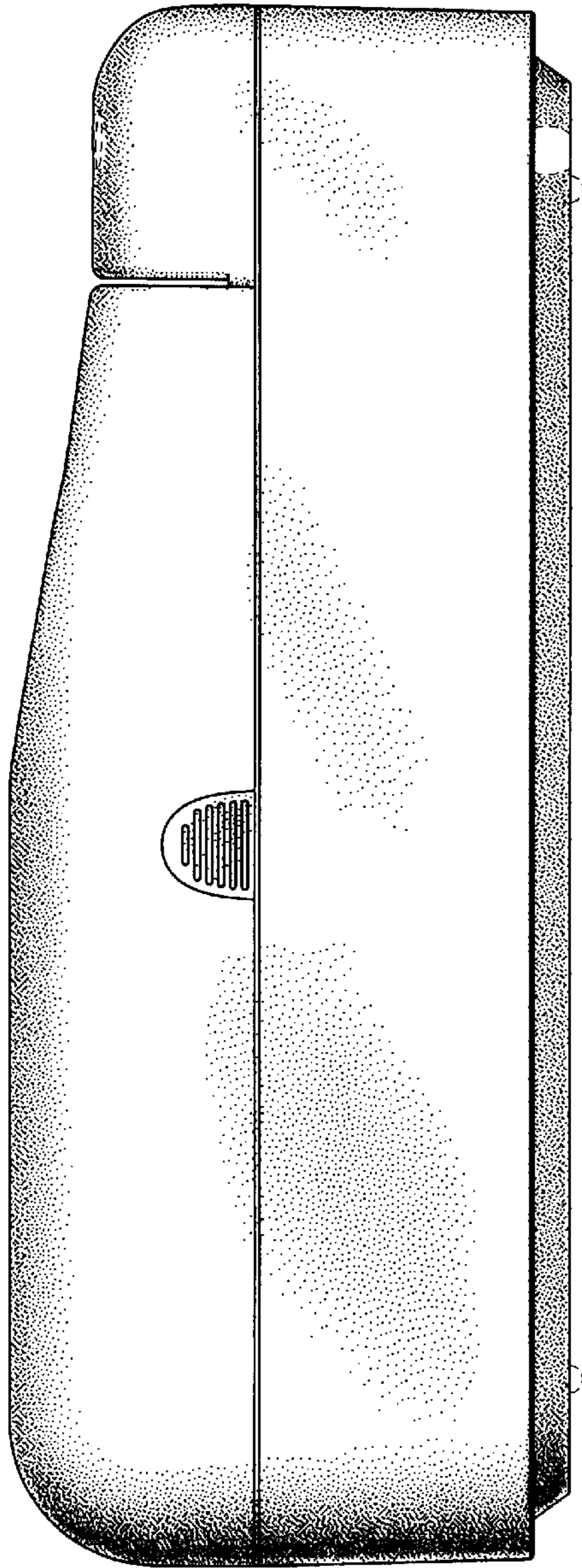

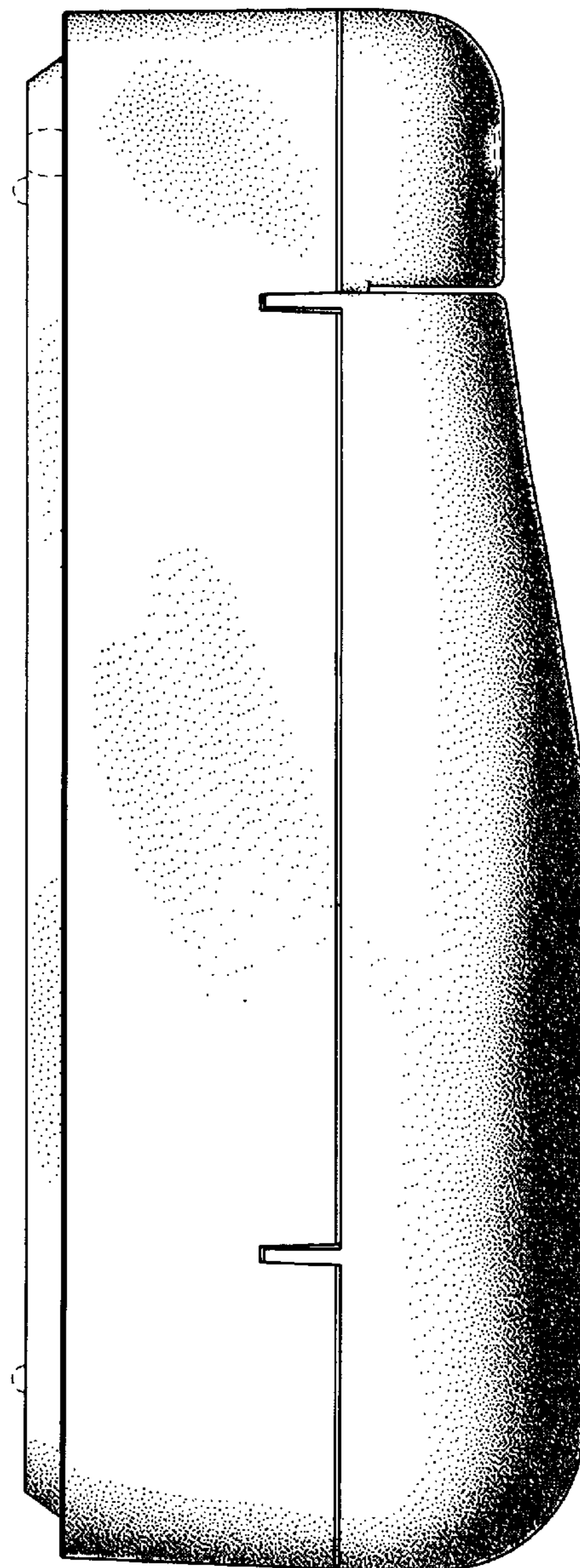

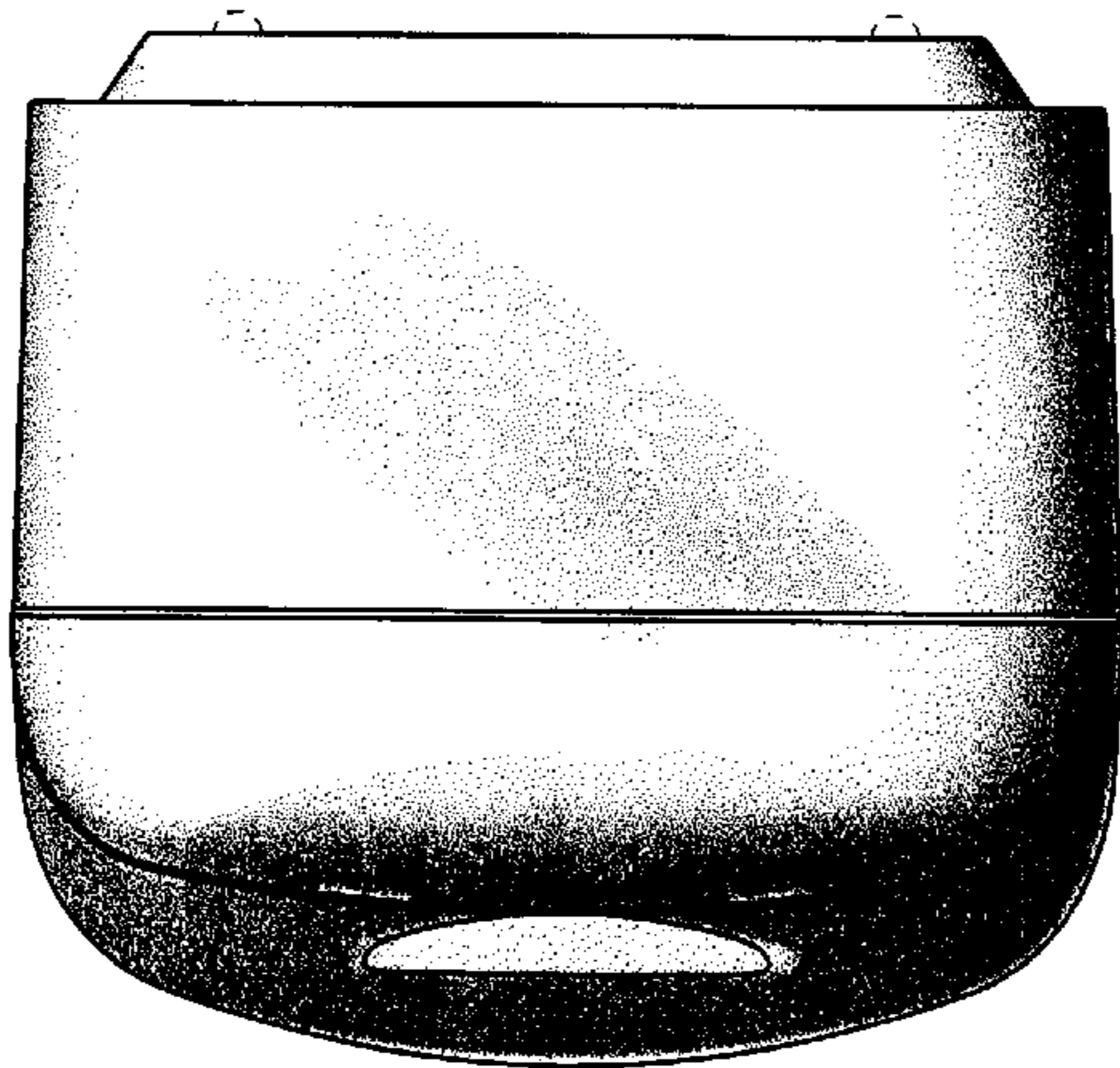

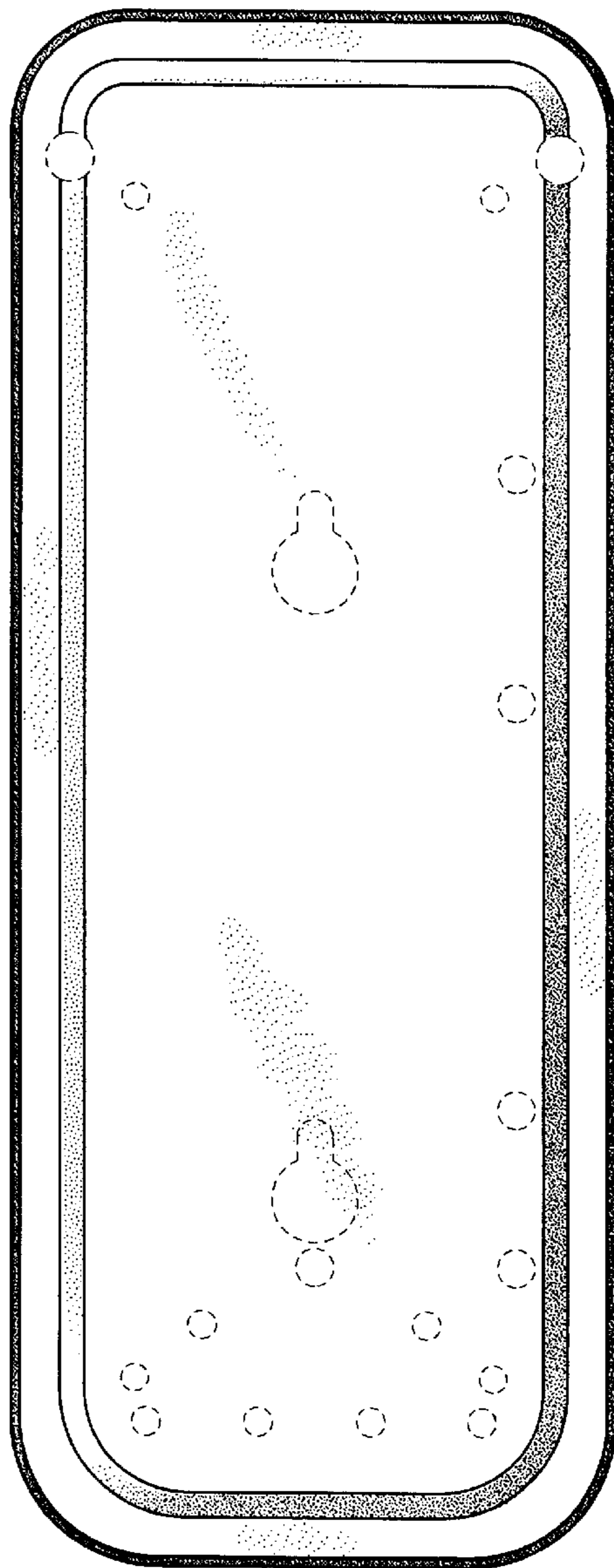
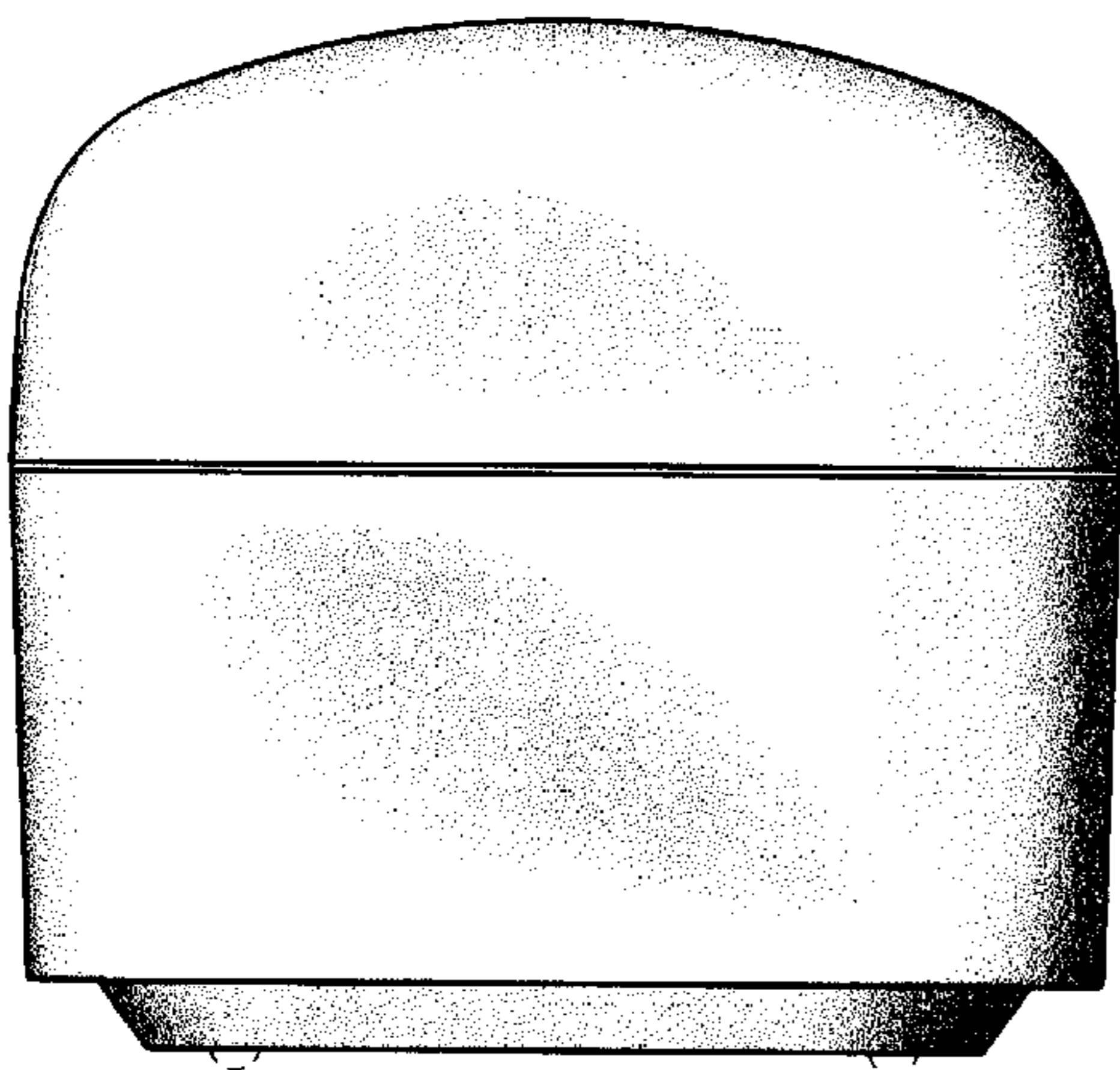

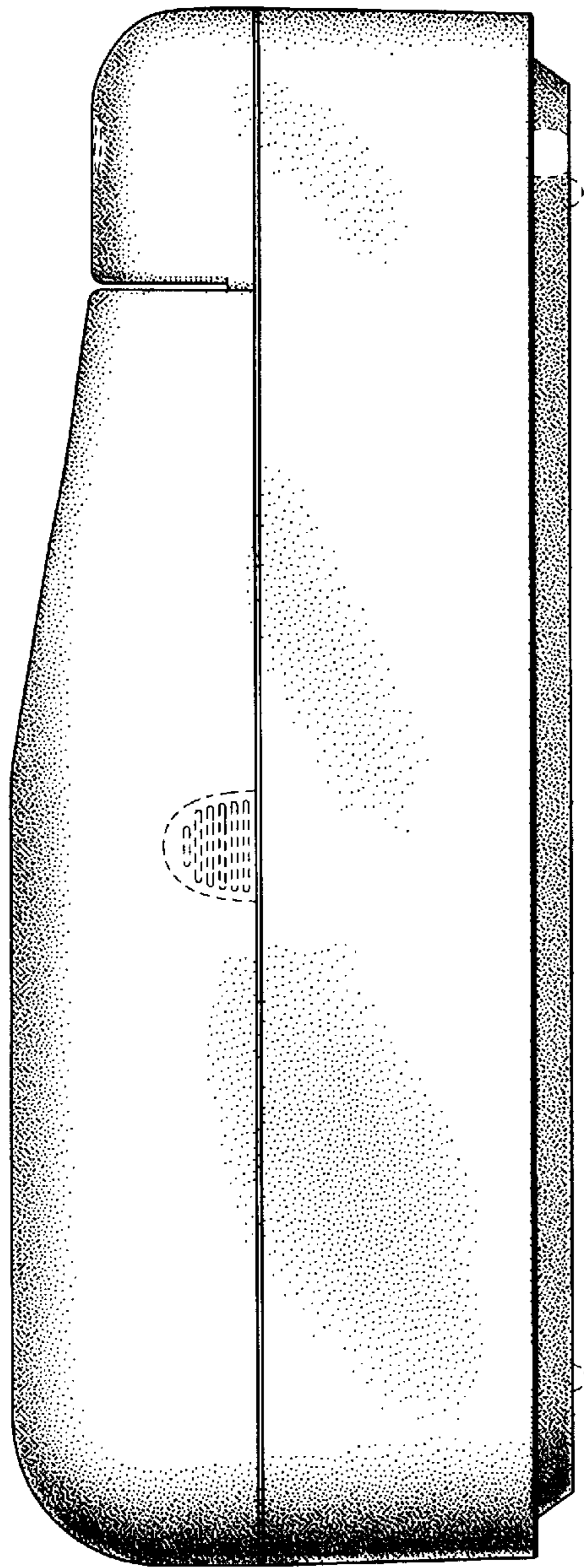
