FIG. 1 illustrates a side view of the replaceable component for a liquid and lotion applicator showing my new and ornamental design;

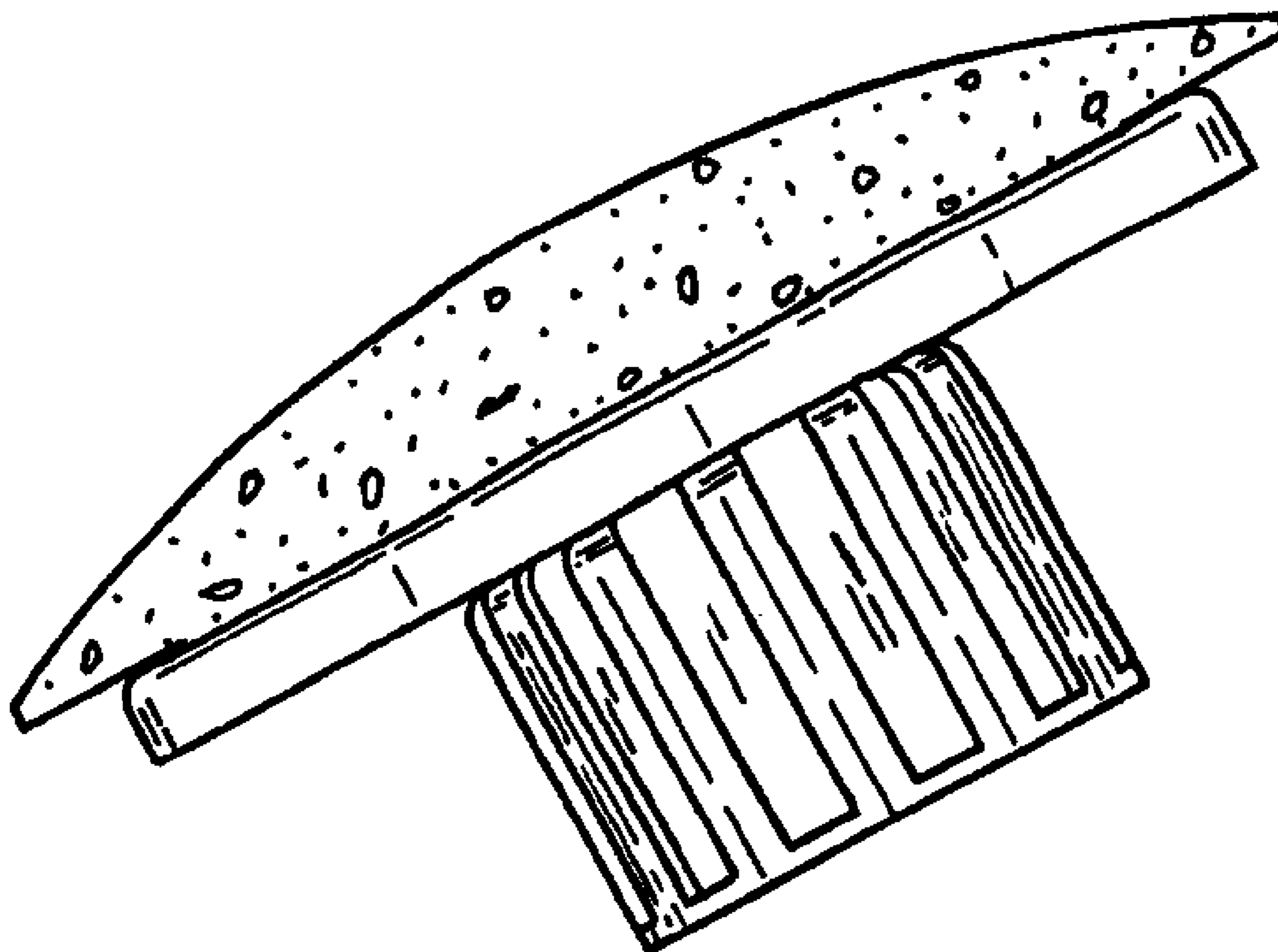
FIG. 2 illustrates a bottom plan view thereof;

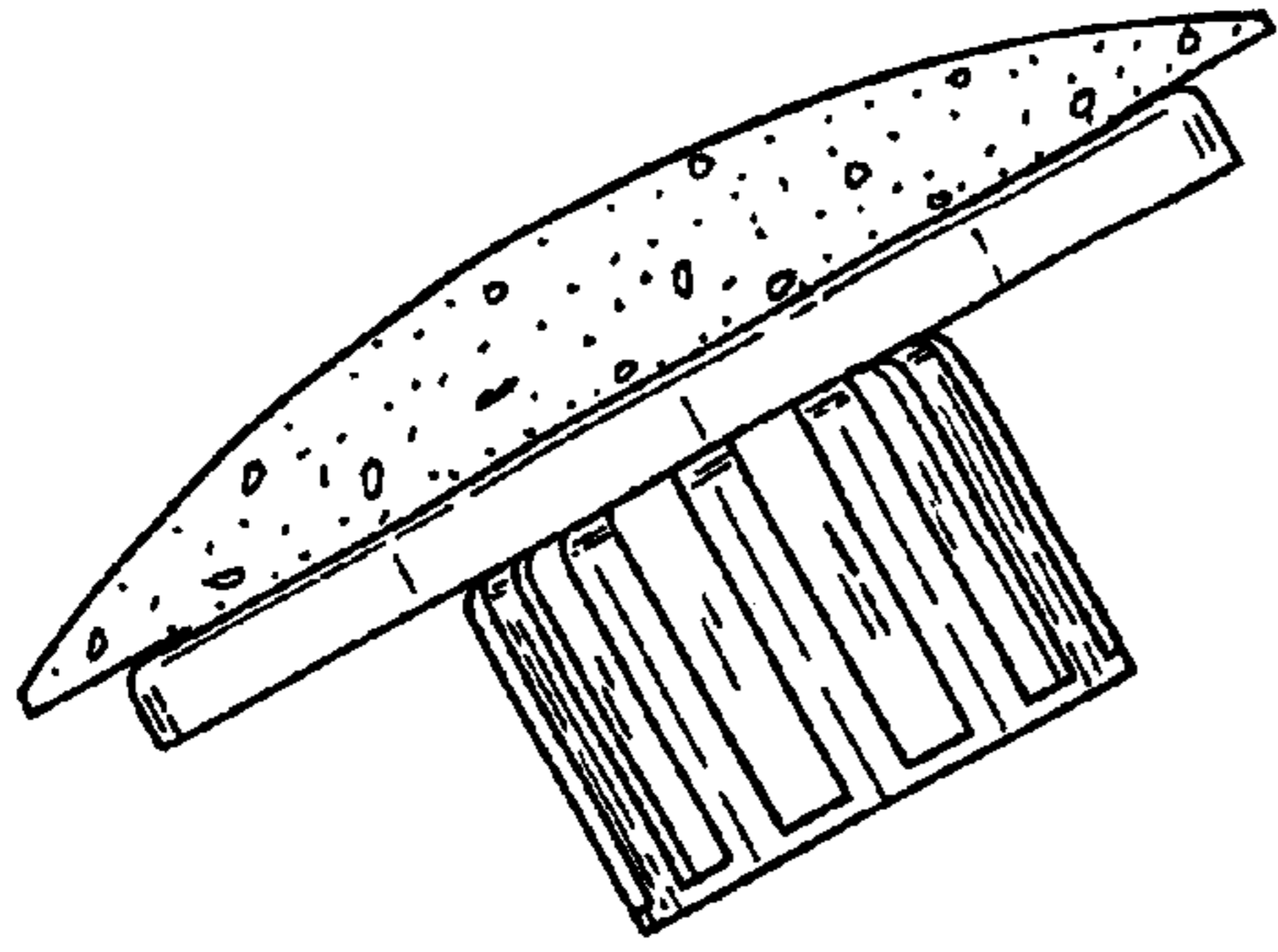

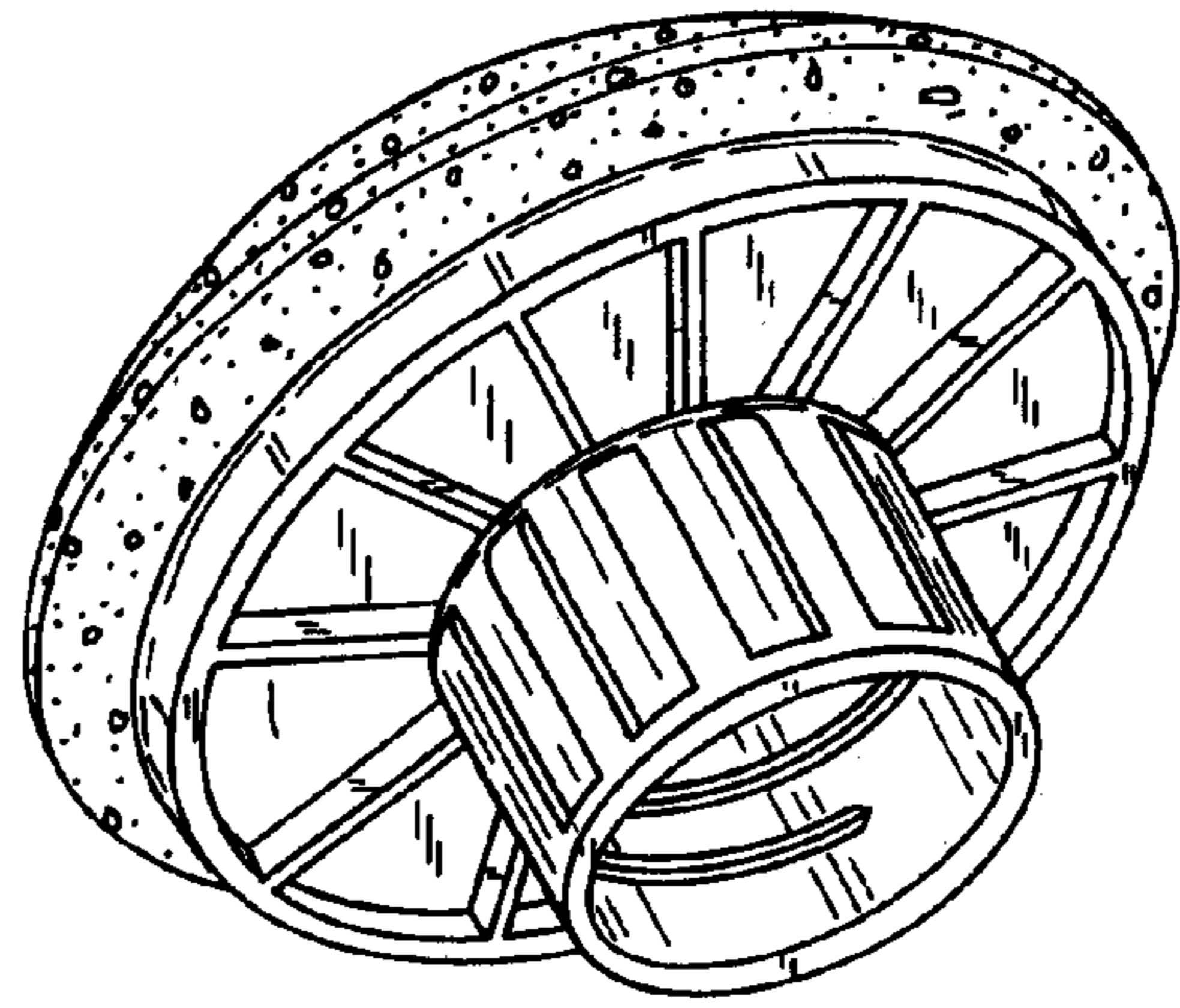

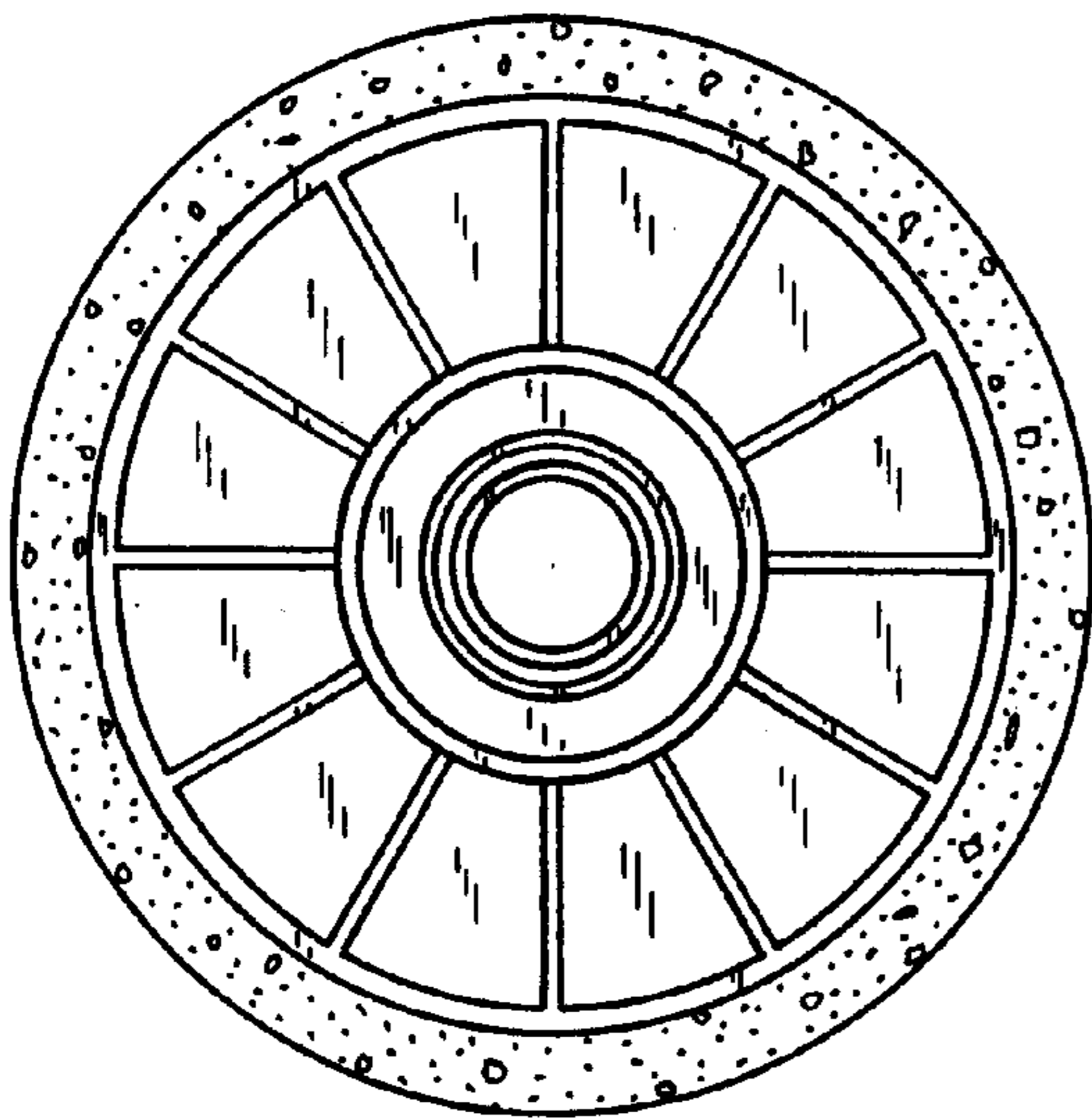

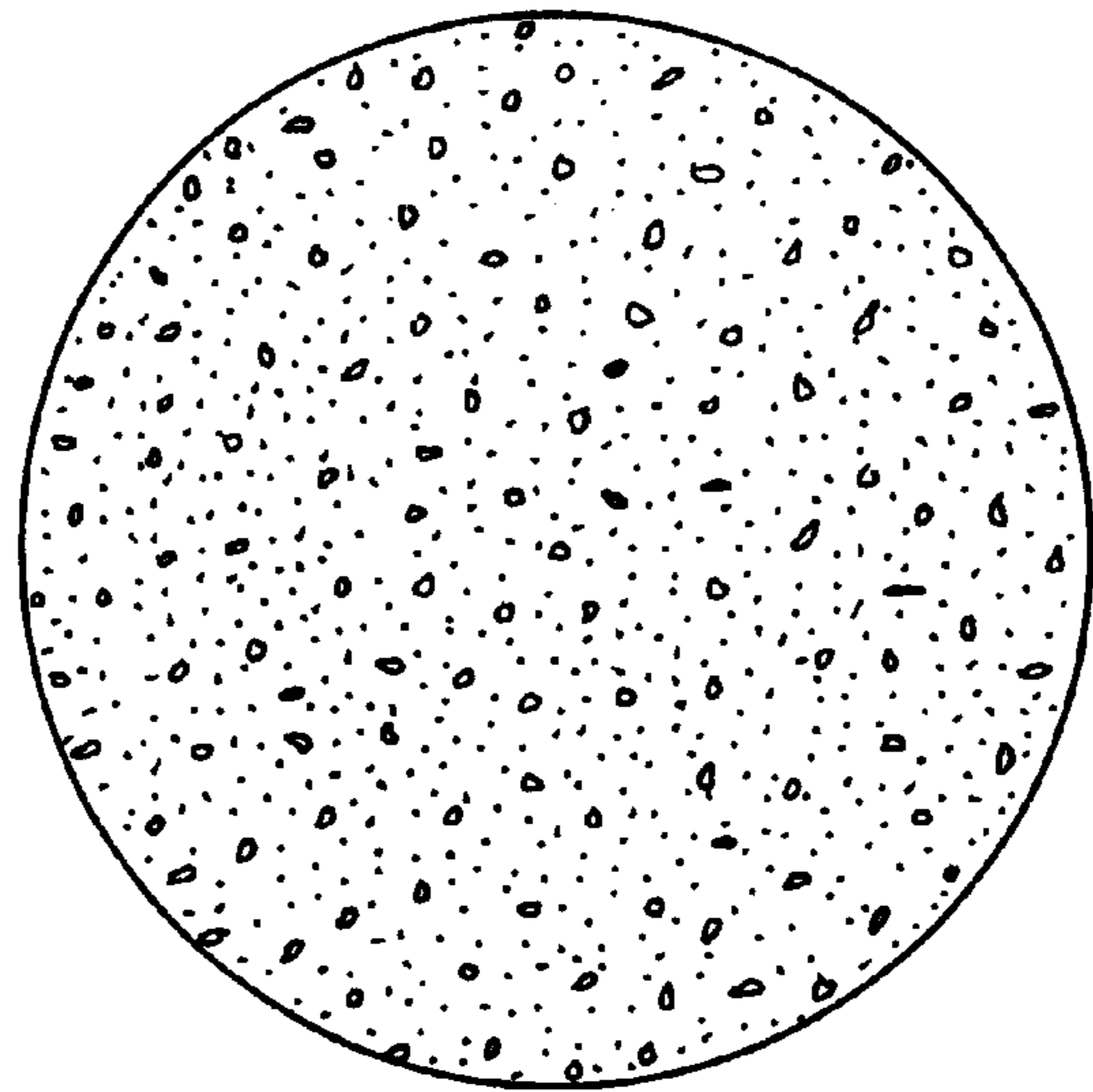

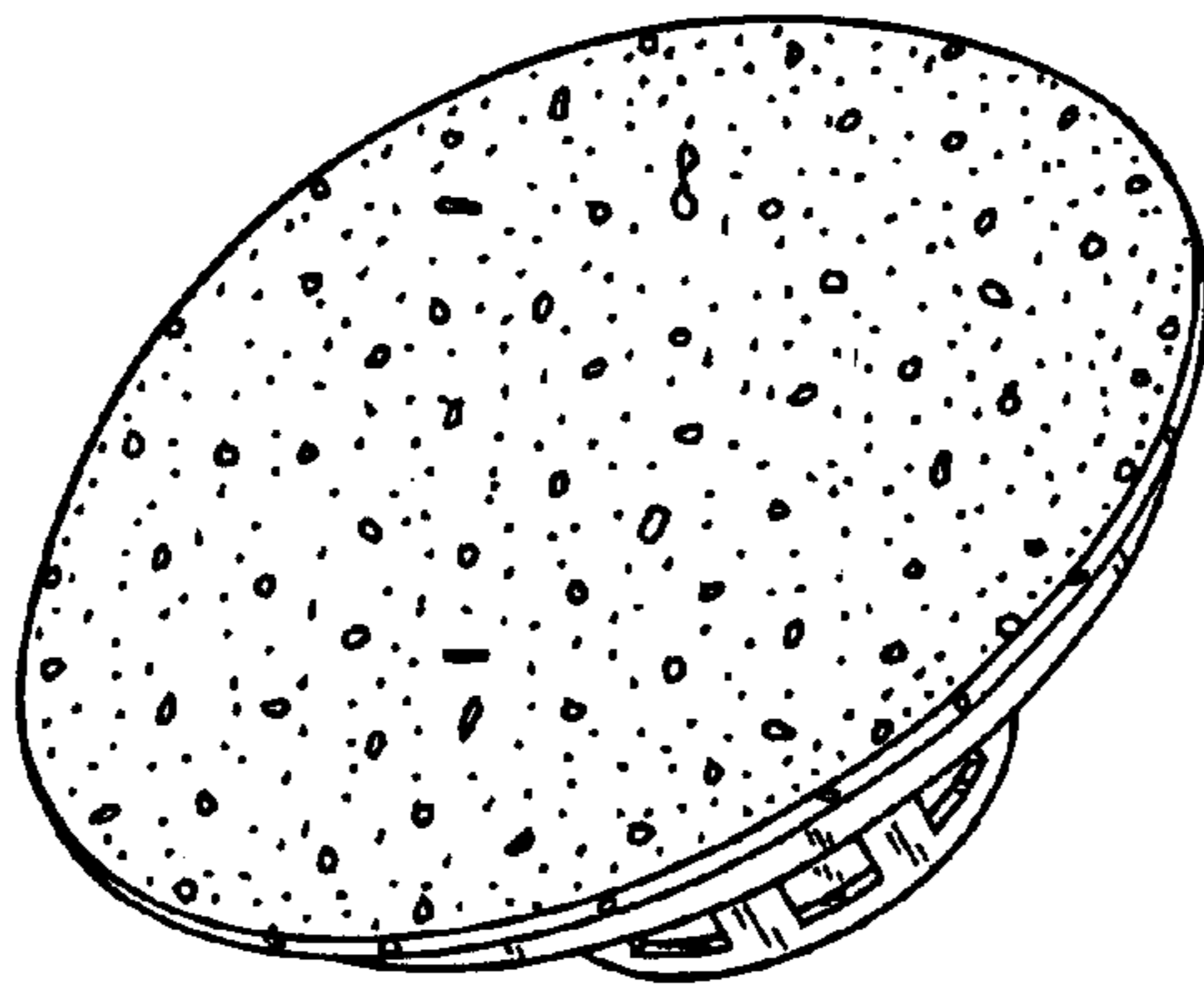
