(57) **CLAIM**

The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a container according to the novel design;

FIG. 2 is a bottom plan view thereof;

FIG. 3 is a back elevational view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a left side elevational view thereof;

FIG. 7 is a right side elevational view thereof;

FIG. 8 is a side elevational view with one of the doors shown removed for convenience of illustration; and,

FIG. 9 is a back elevational view with one of the doors shown removed for convenience of illustration.

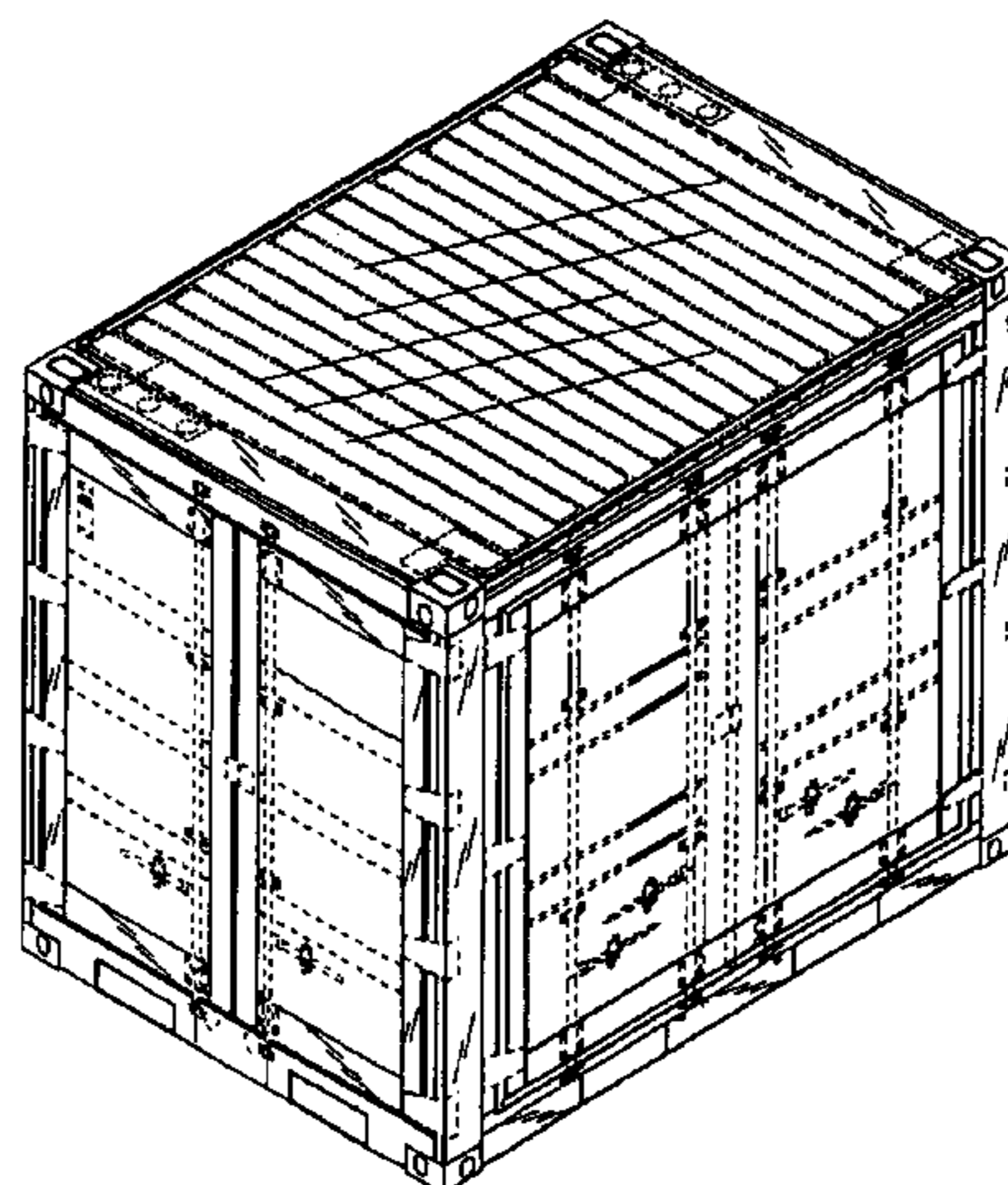

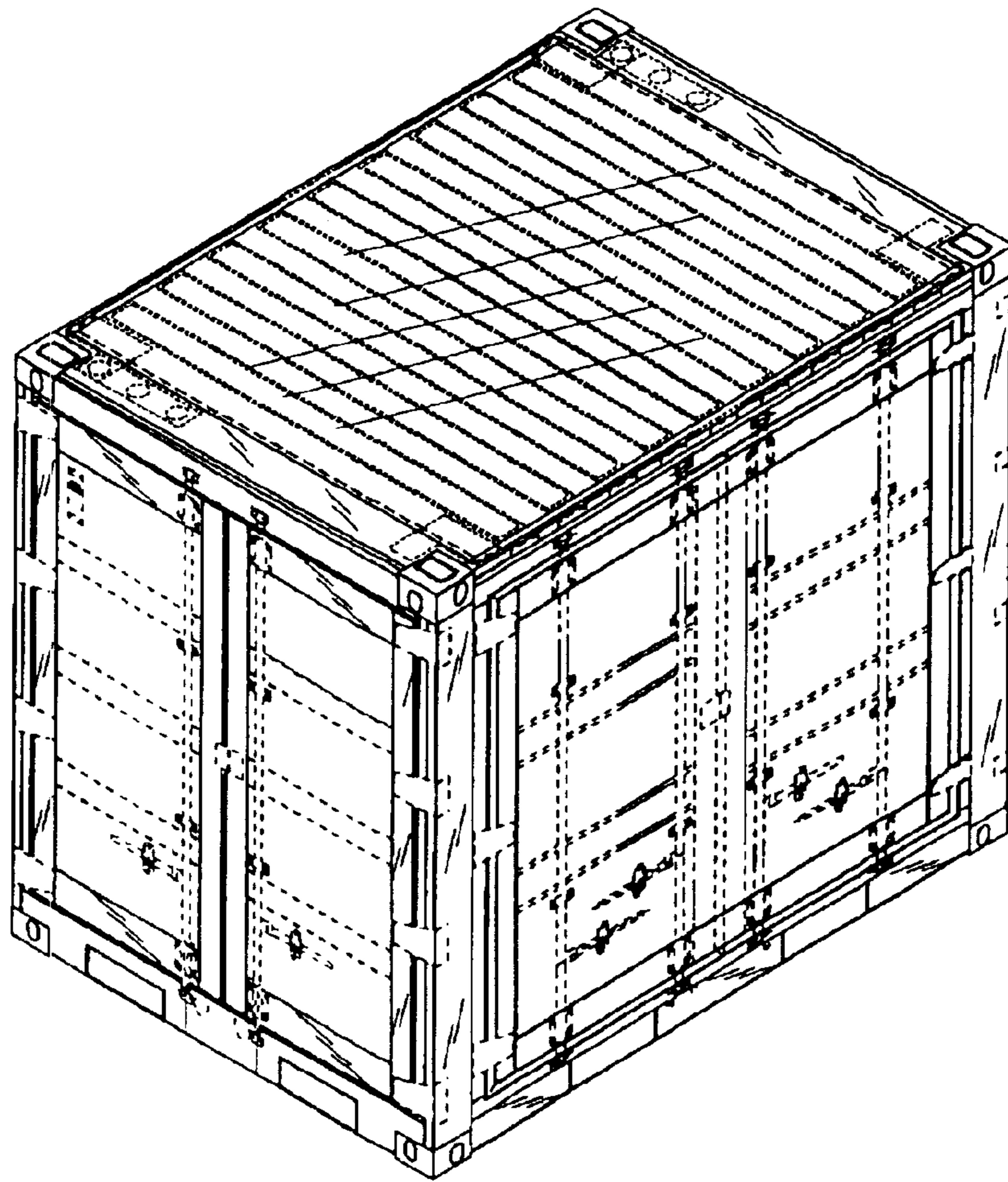

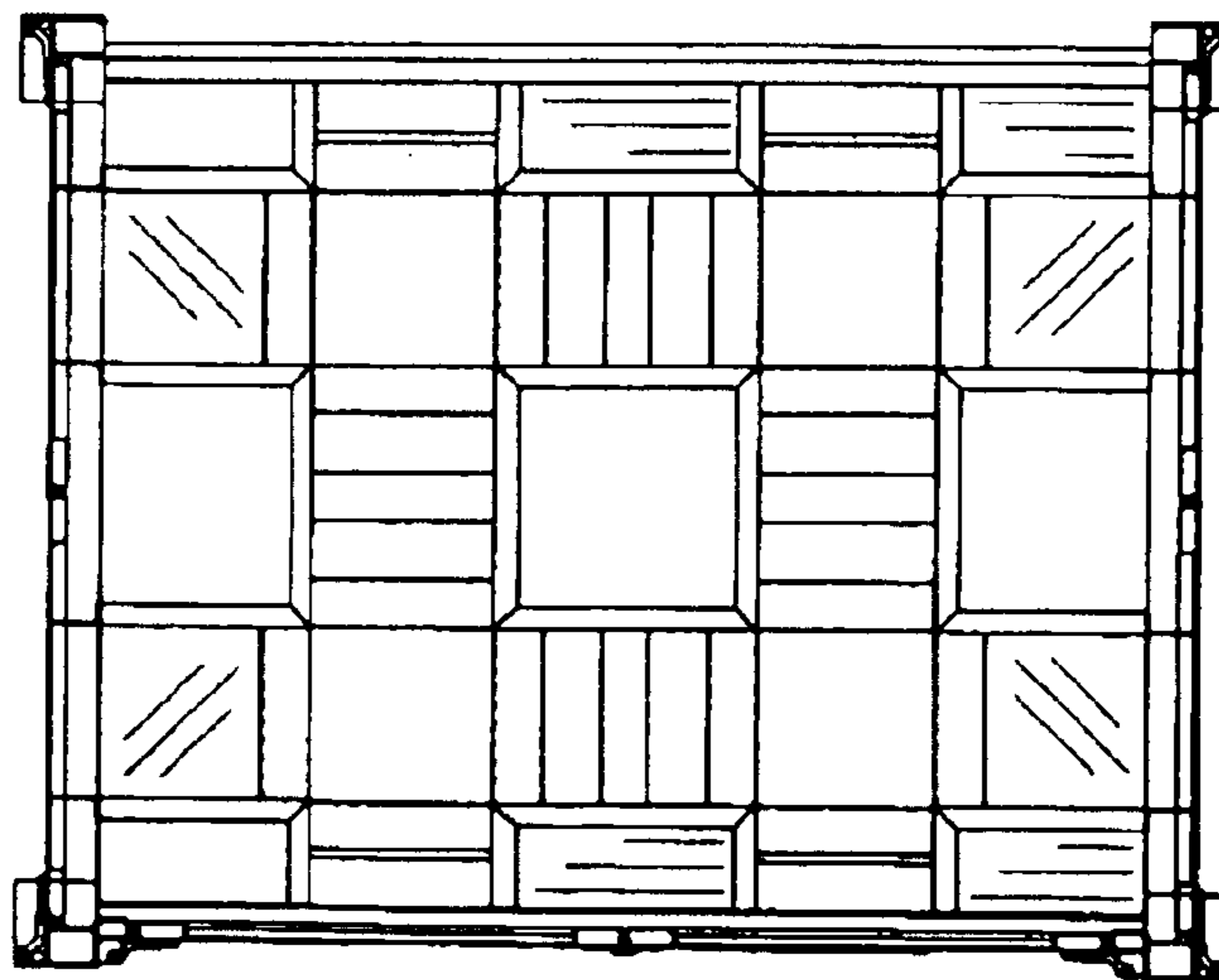

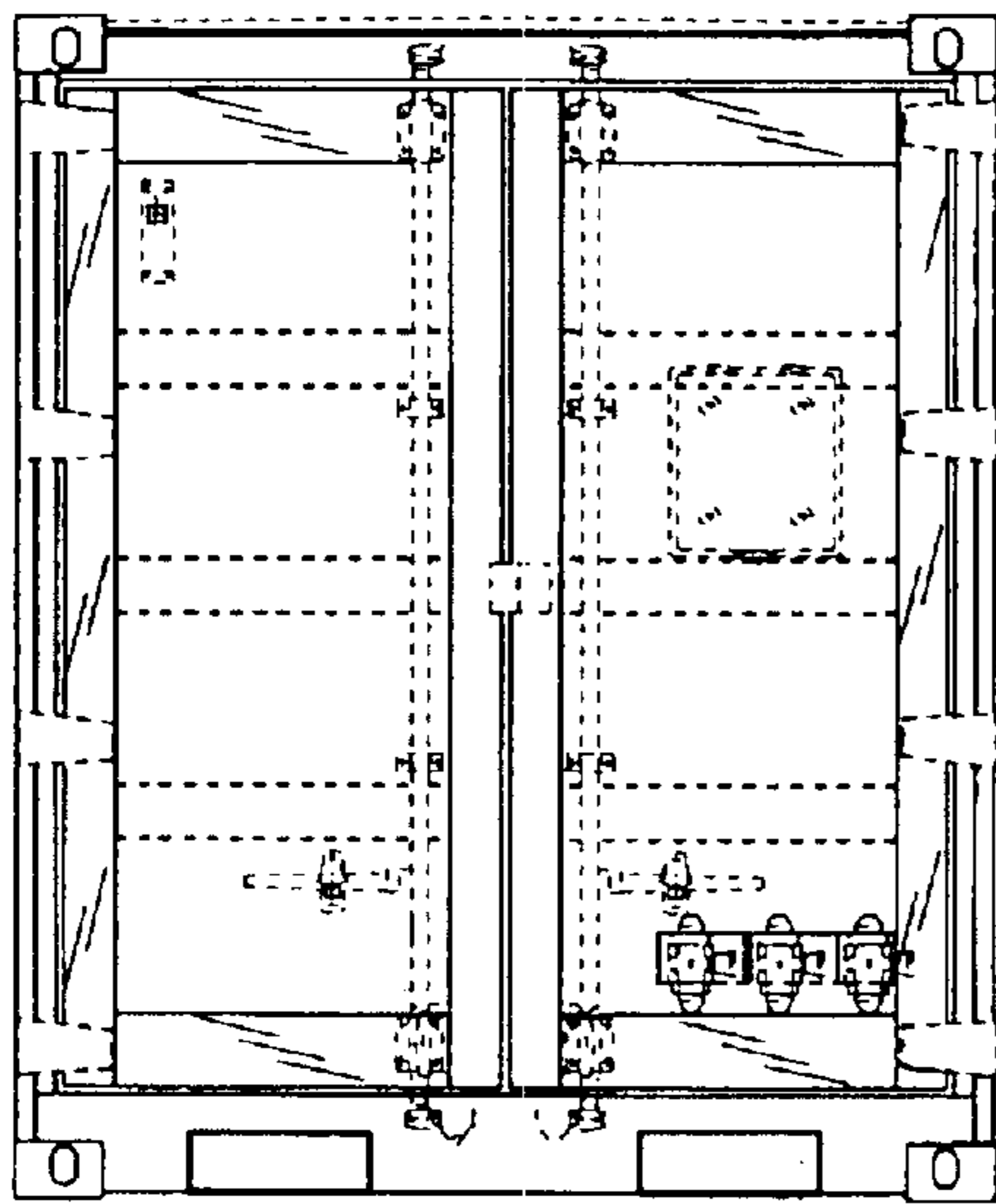

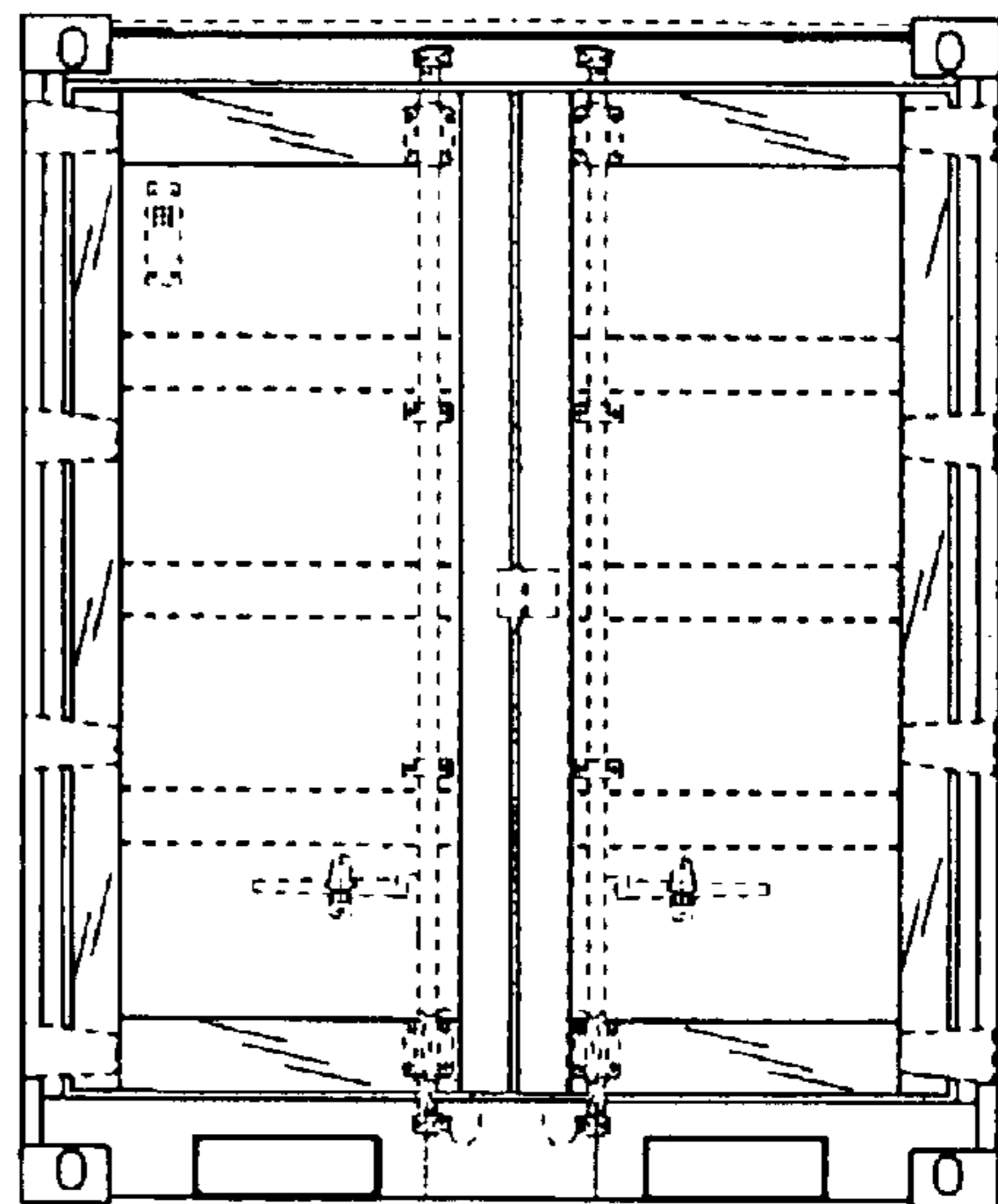

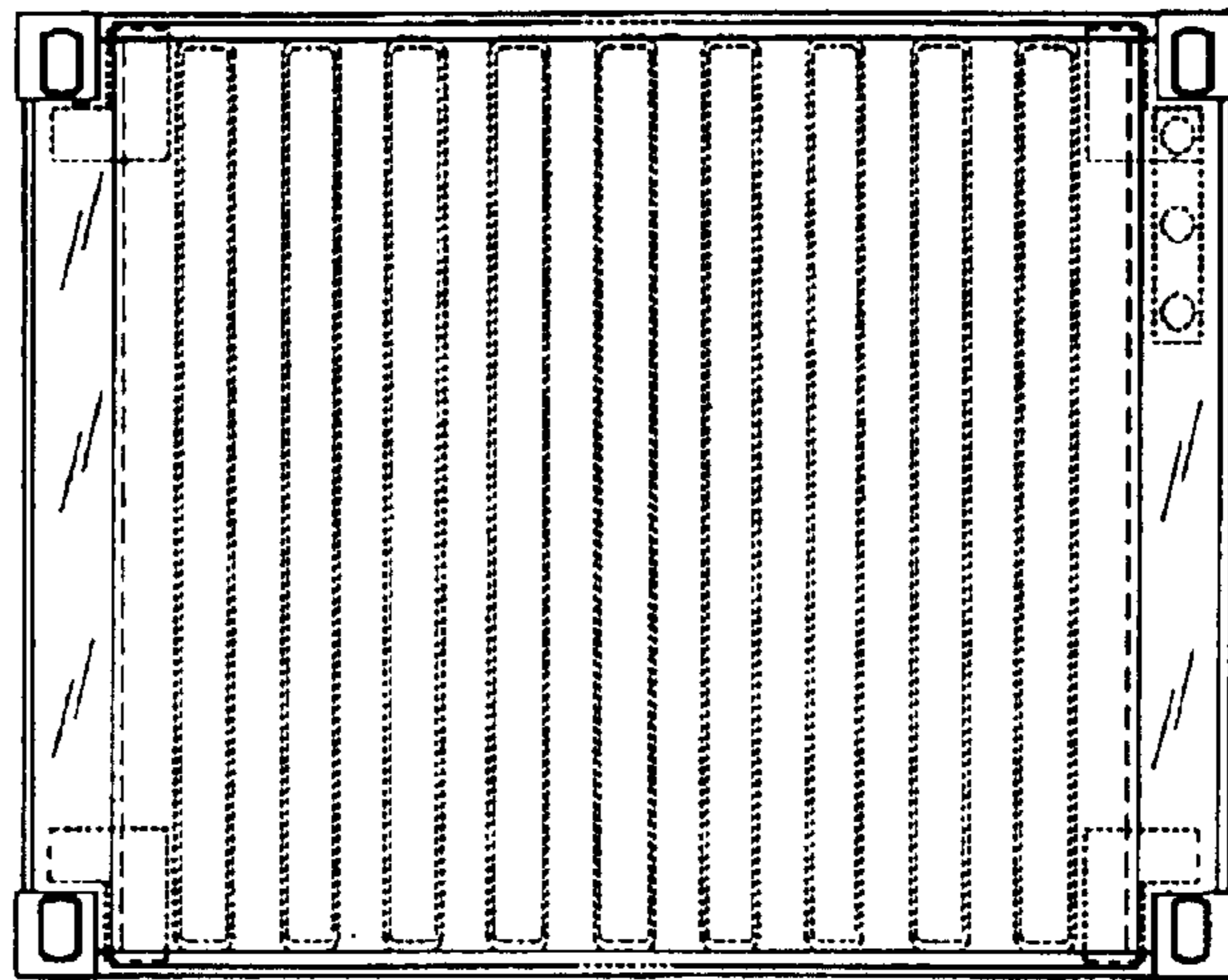

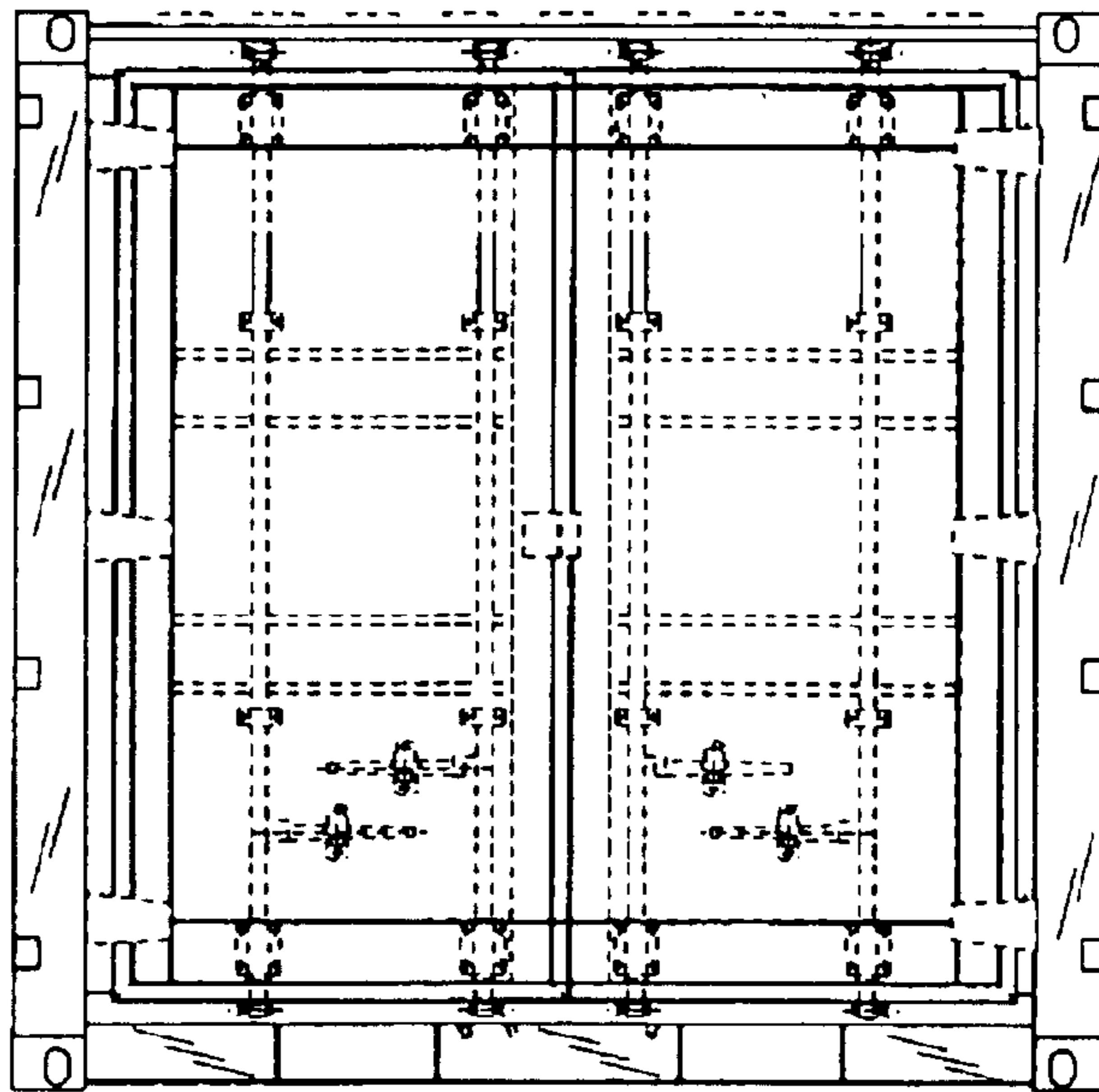

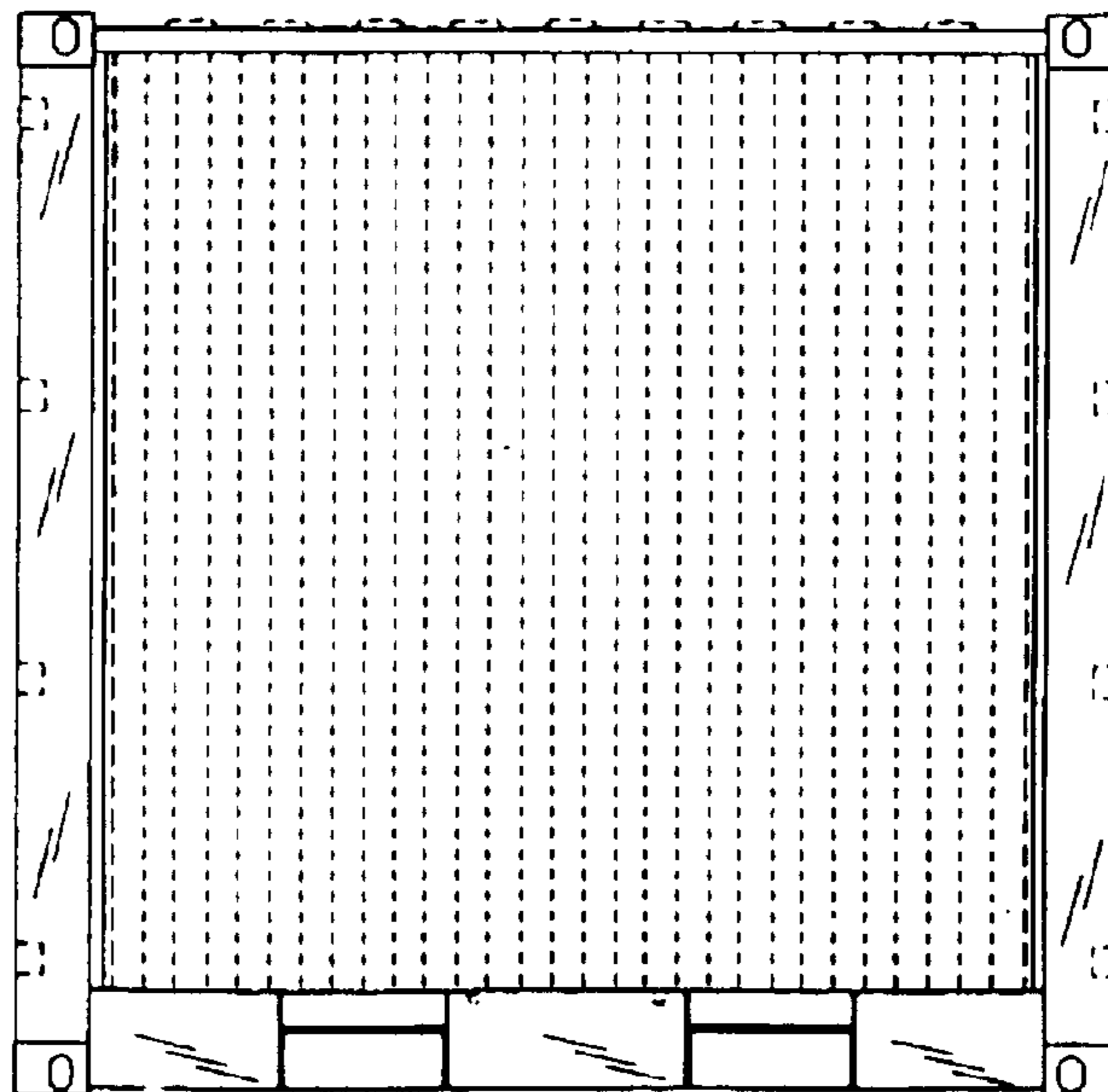

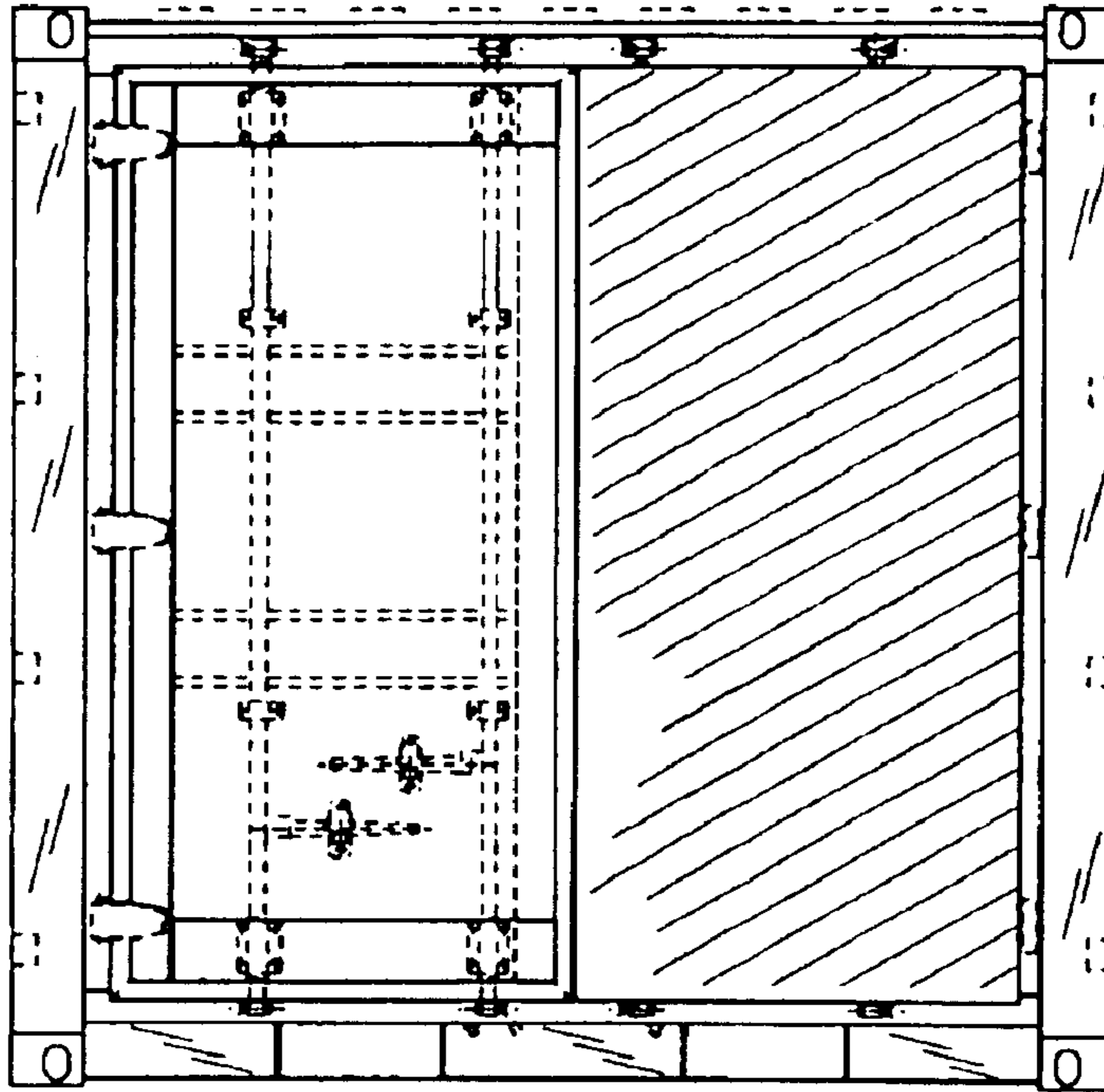
