The ornamental design for a pizza, as shown and described.

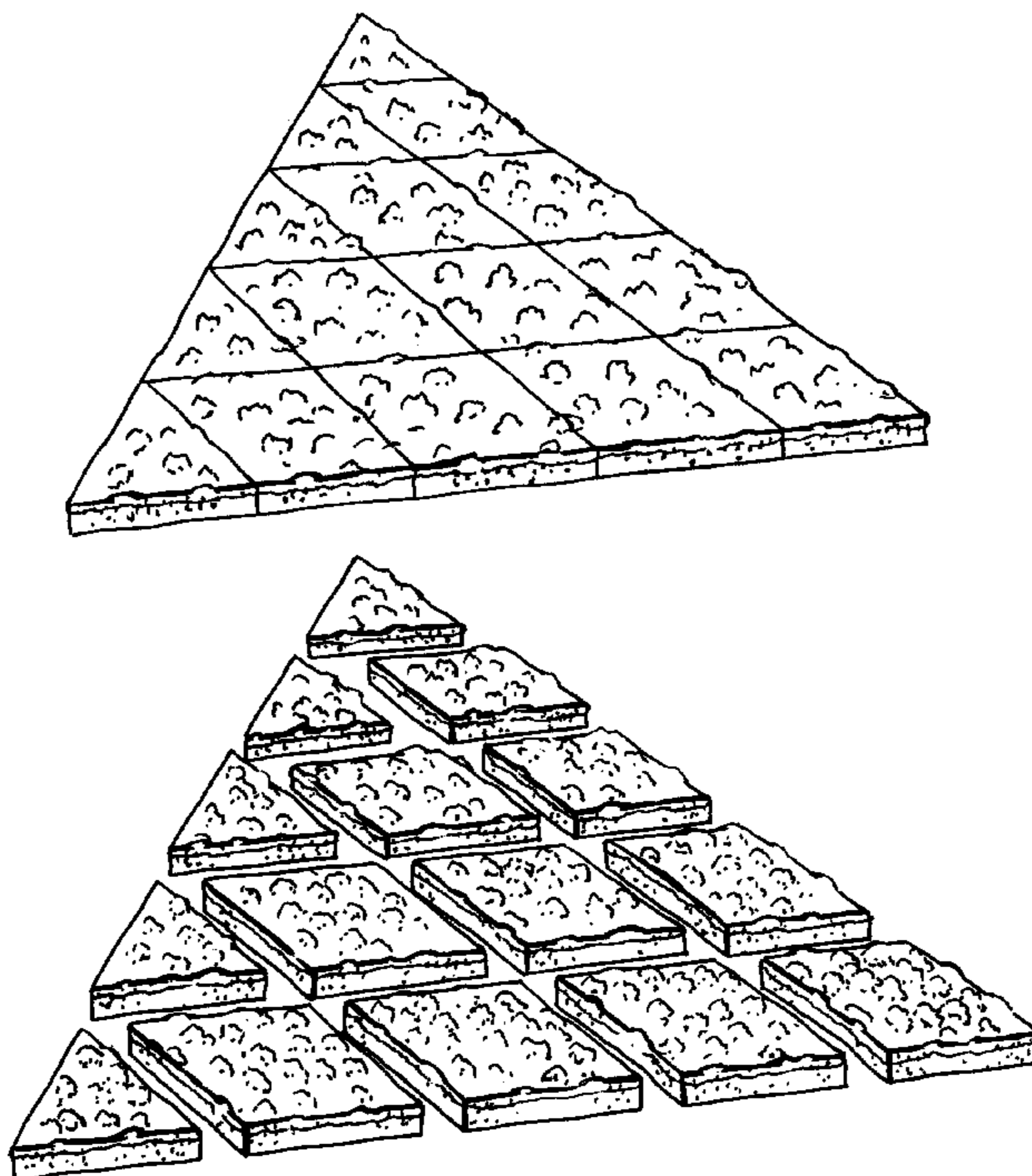
DESCRIPTION

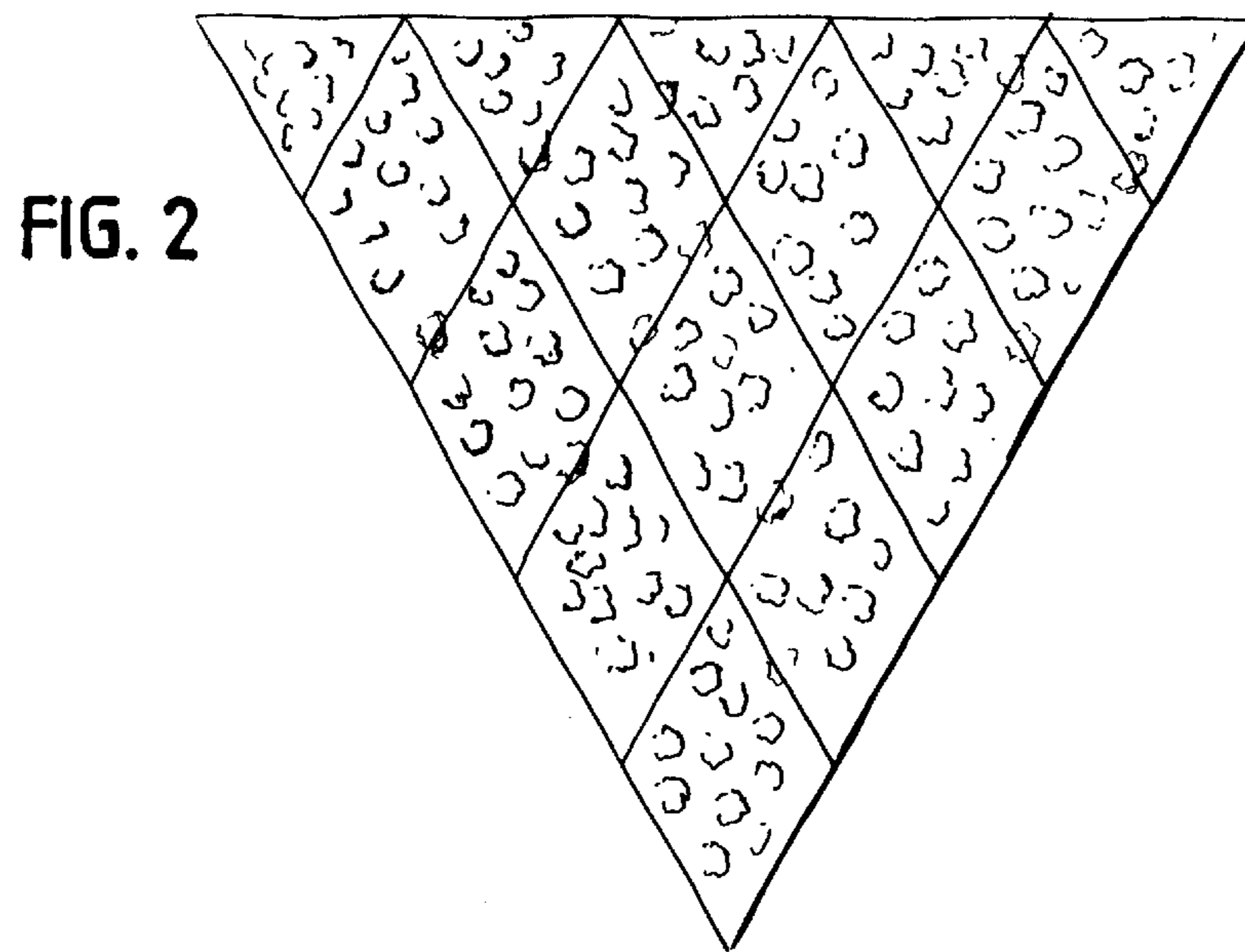
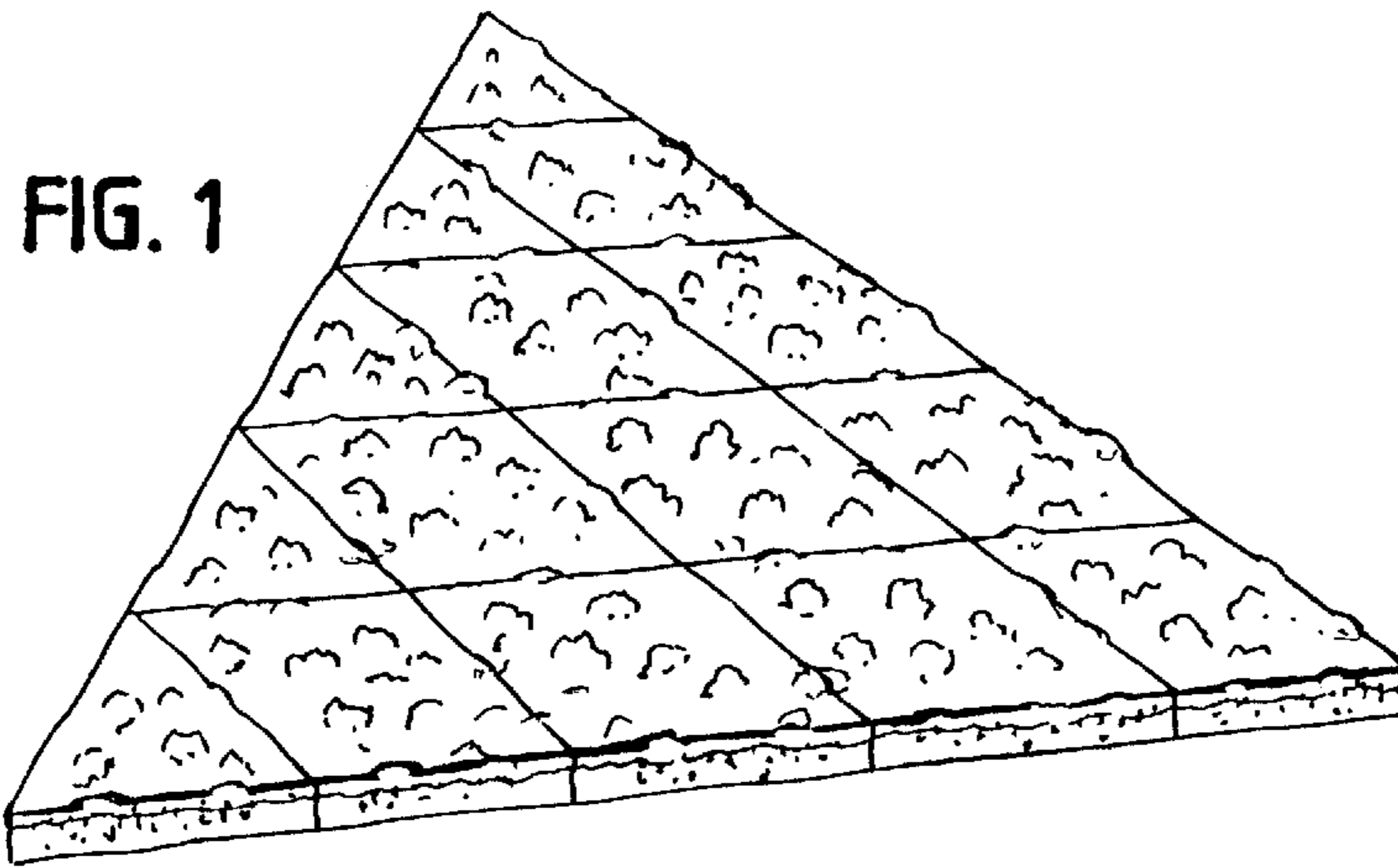

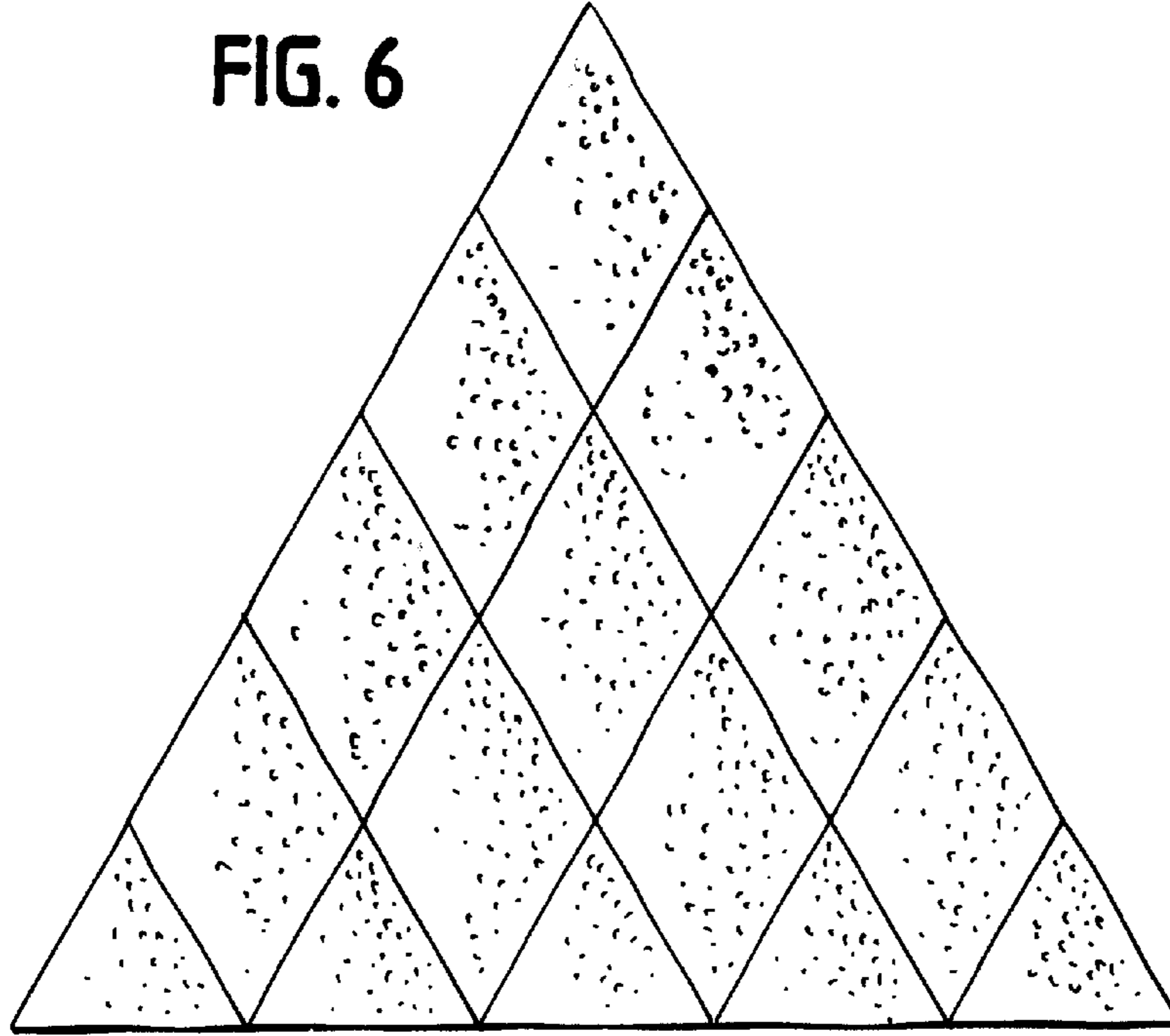
