The ornamental design for a purse with the appearance of a puppy, as shown and described.

DESCRIPTION

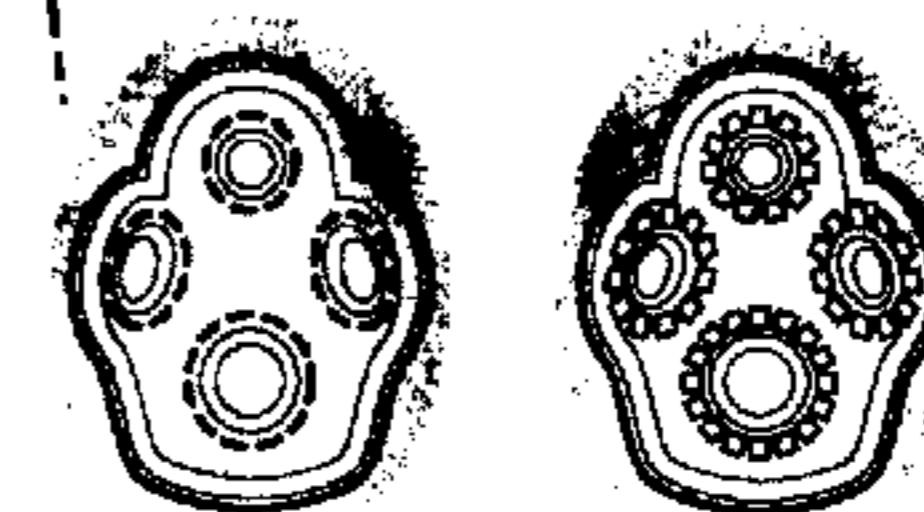
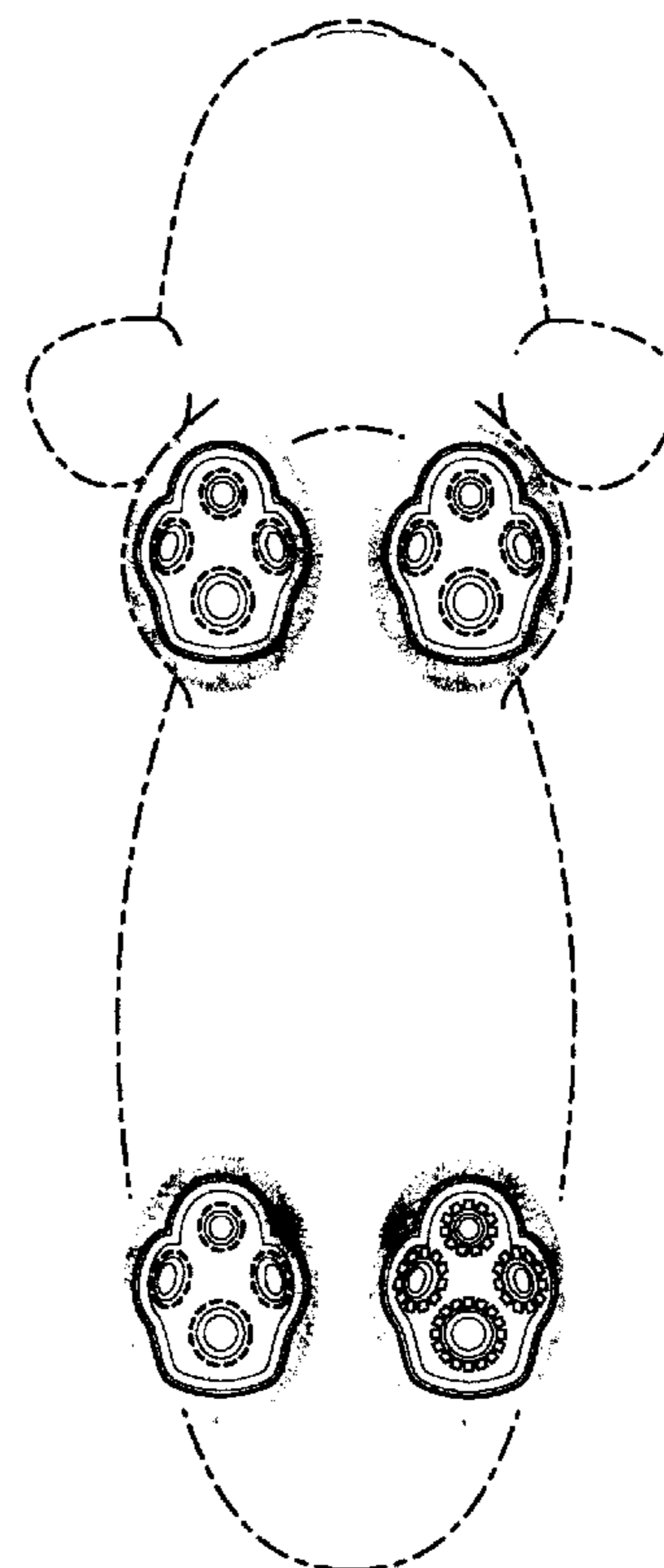
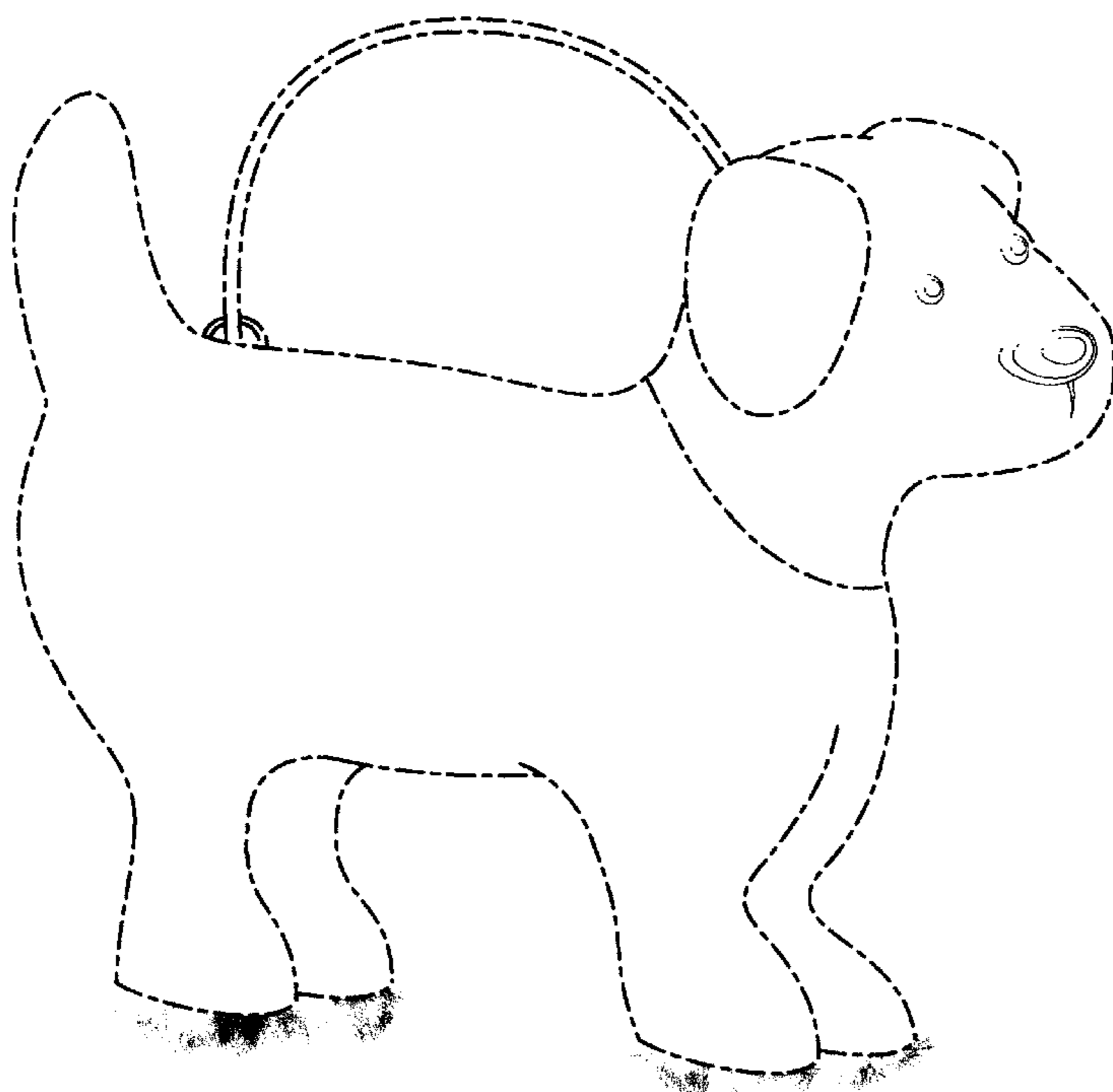
FIG. 1 is a right front perspective view of a purse according to the present design with details of the body and head of the puppy in broken lines as environmental structure associated with the design;

FIG. 2 is a front view of the purse of FIG. 1; and, FIG. 3 is a bottom view of the purse of FIG. 1 showing the details of the paw design.

An ornamental design for a purse with the appearance of a puppy is provided in the drawings and as claimed herein. The stitched details representing paw on the feet with the pads on one foot outlined in rhinestones or jewels.

The broken line showing is for illustrative purposes only and forms no part of the claimed design.

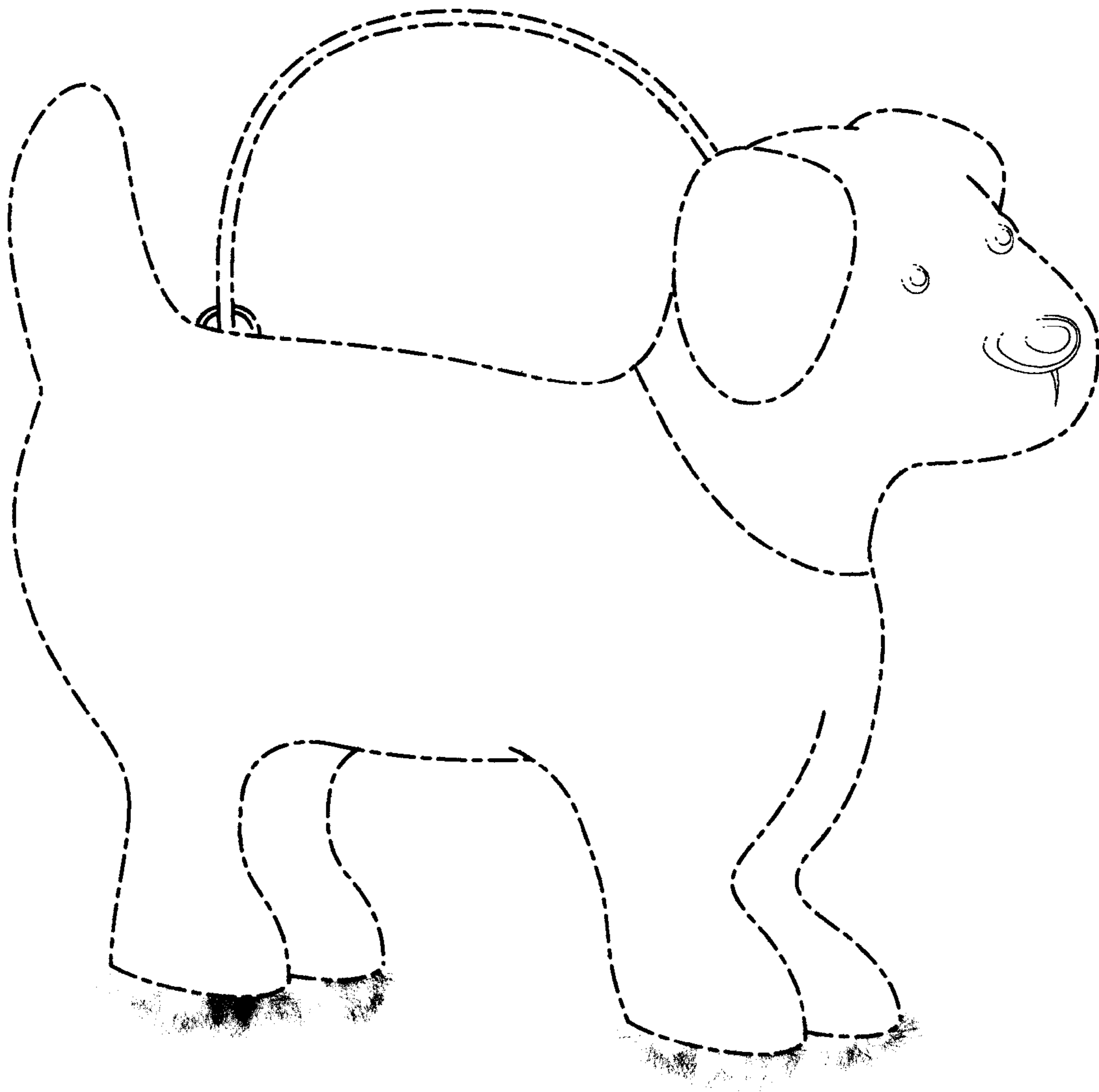

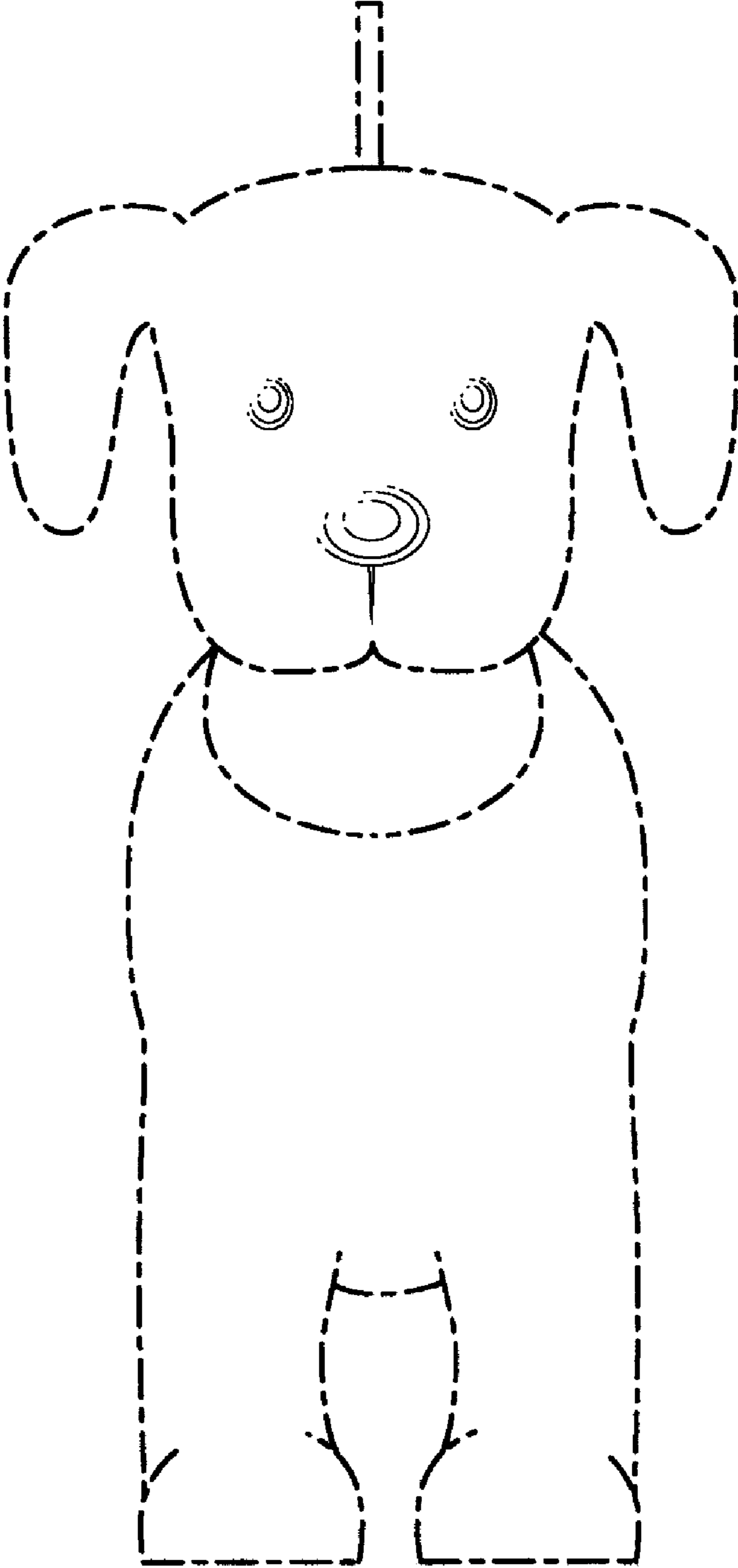

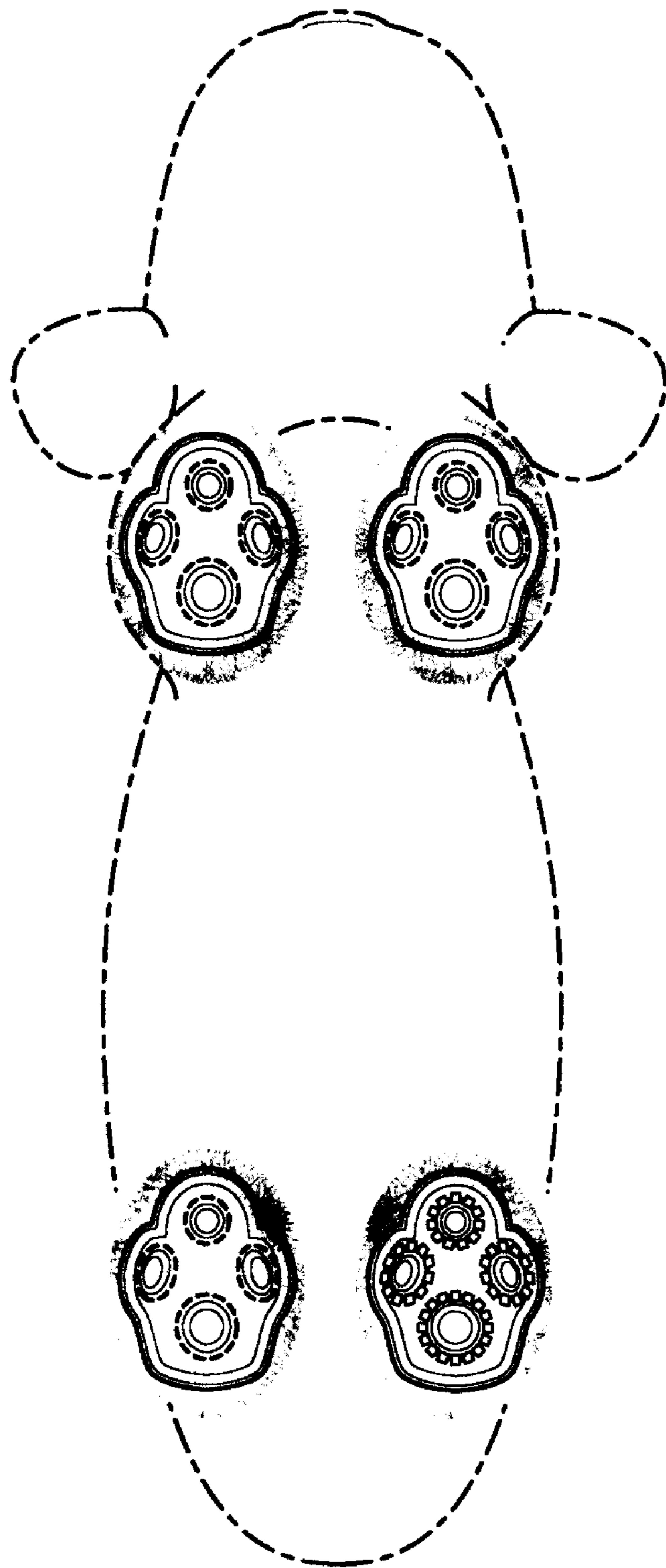
