showing a second embodiment of my new design.

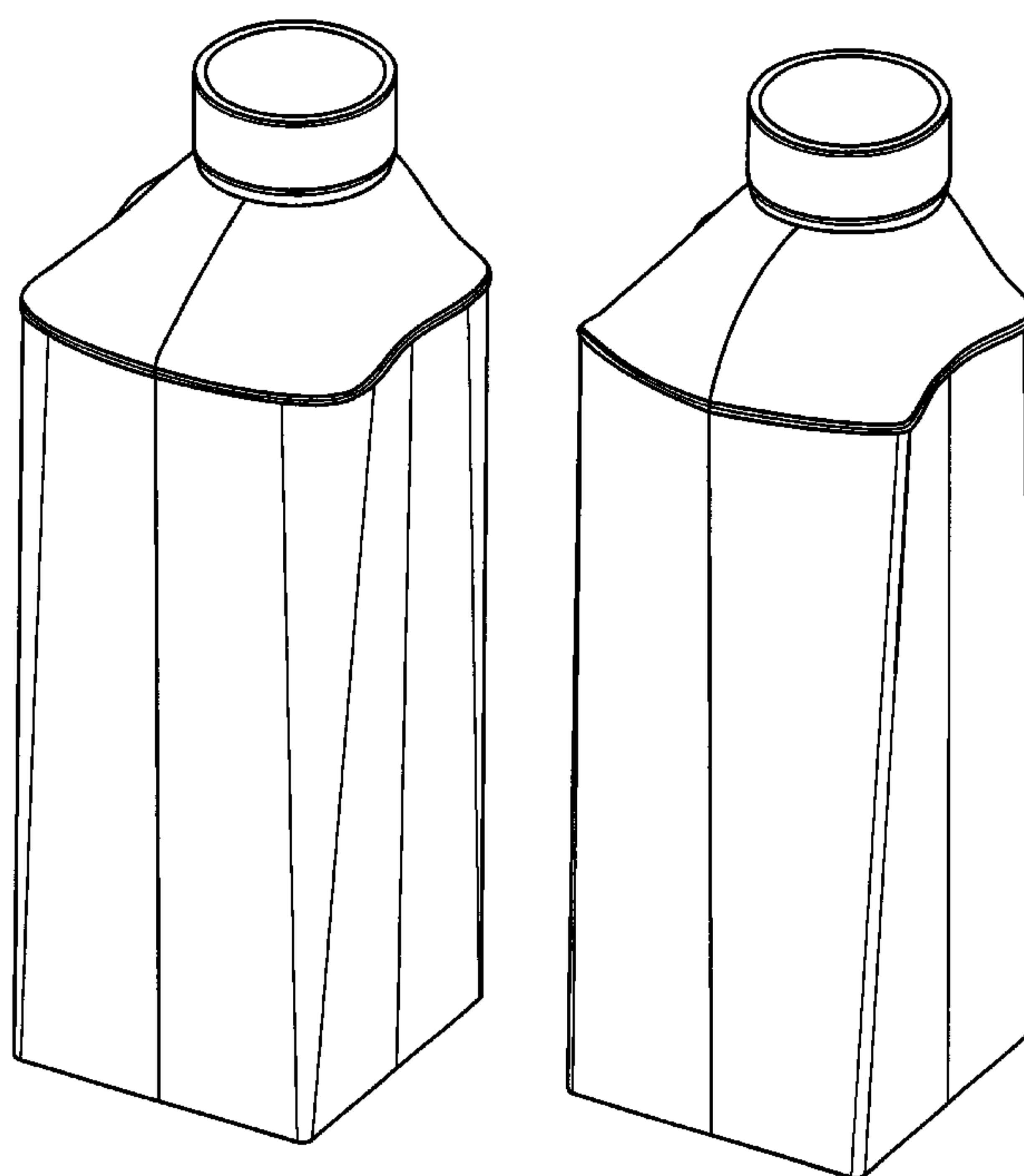
FIG. 7 is a front elevational view thereof.

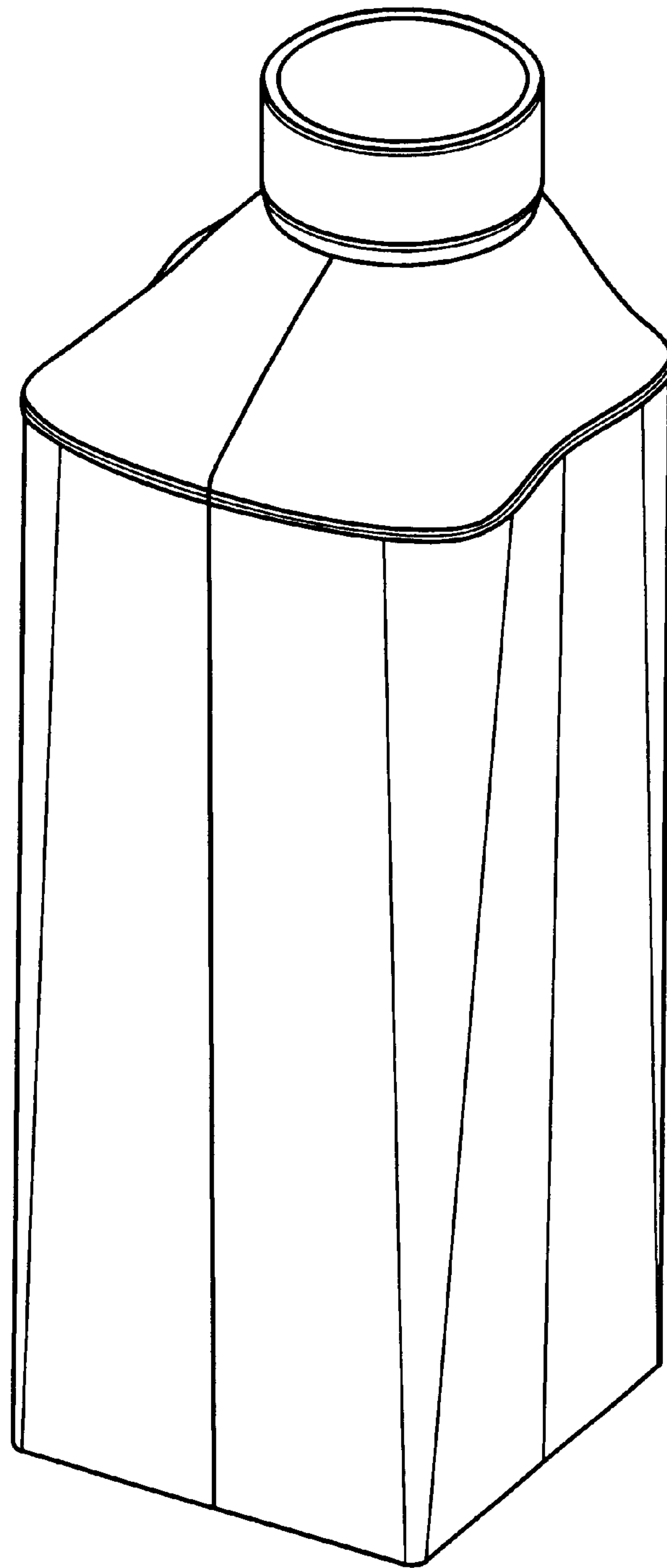

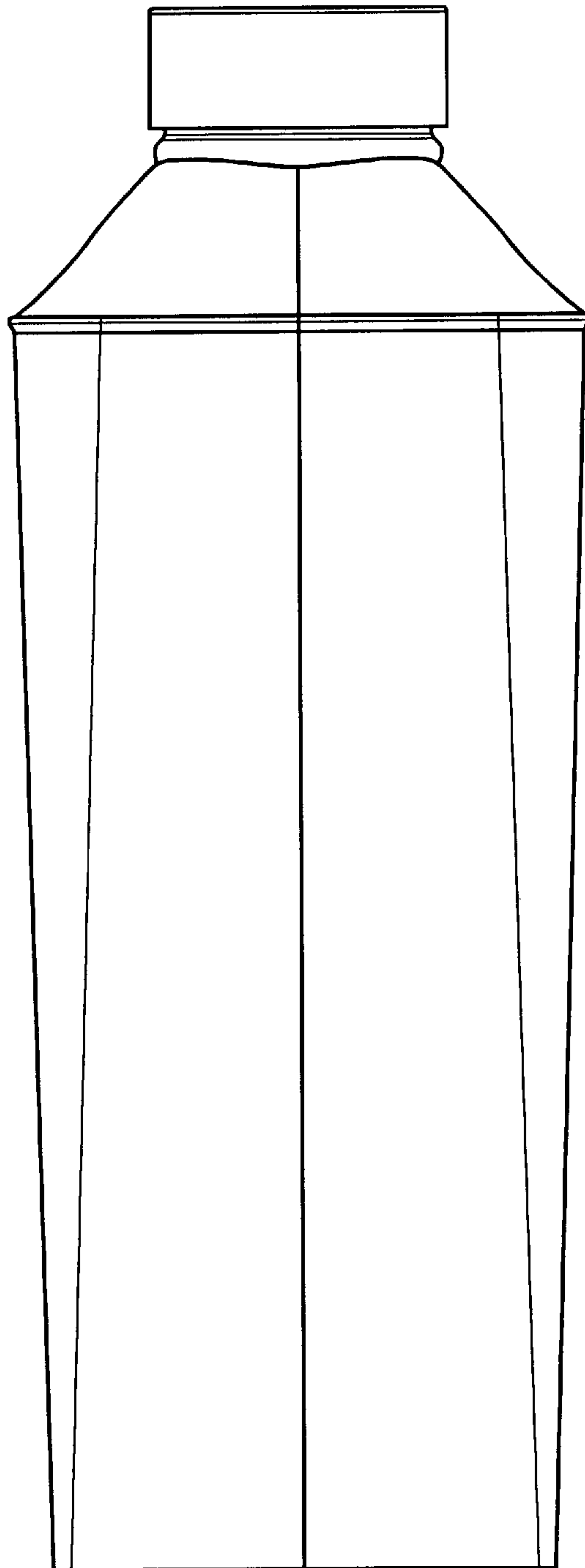

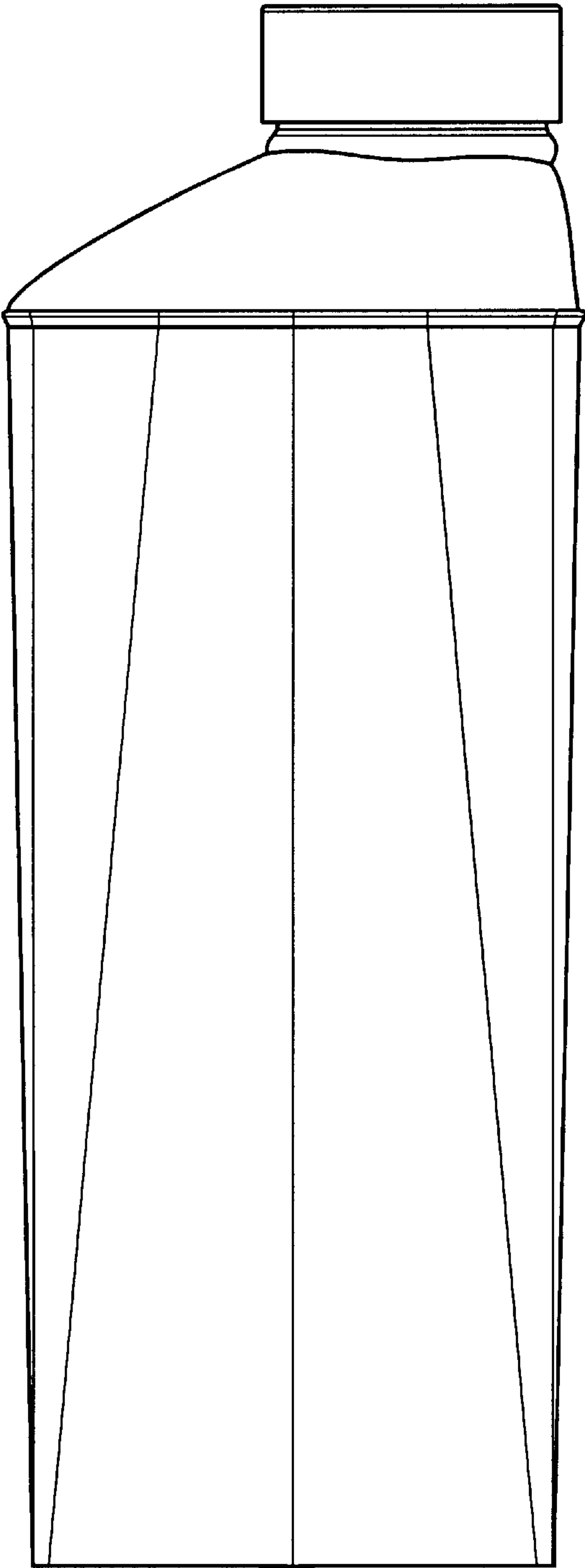

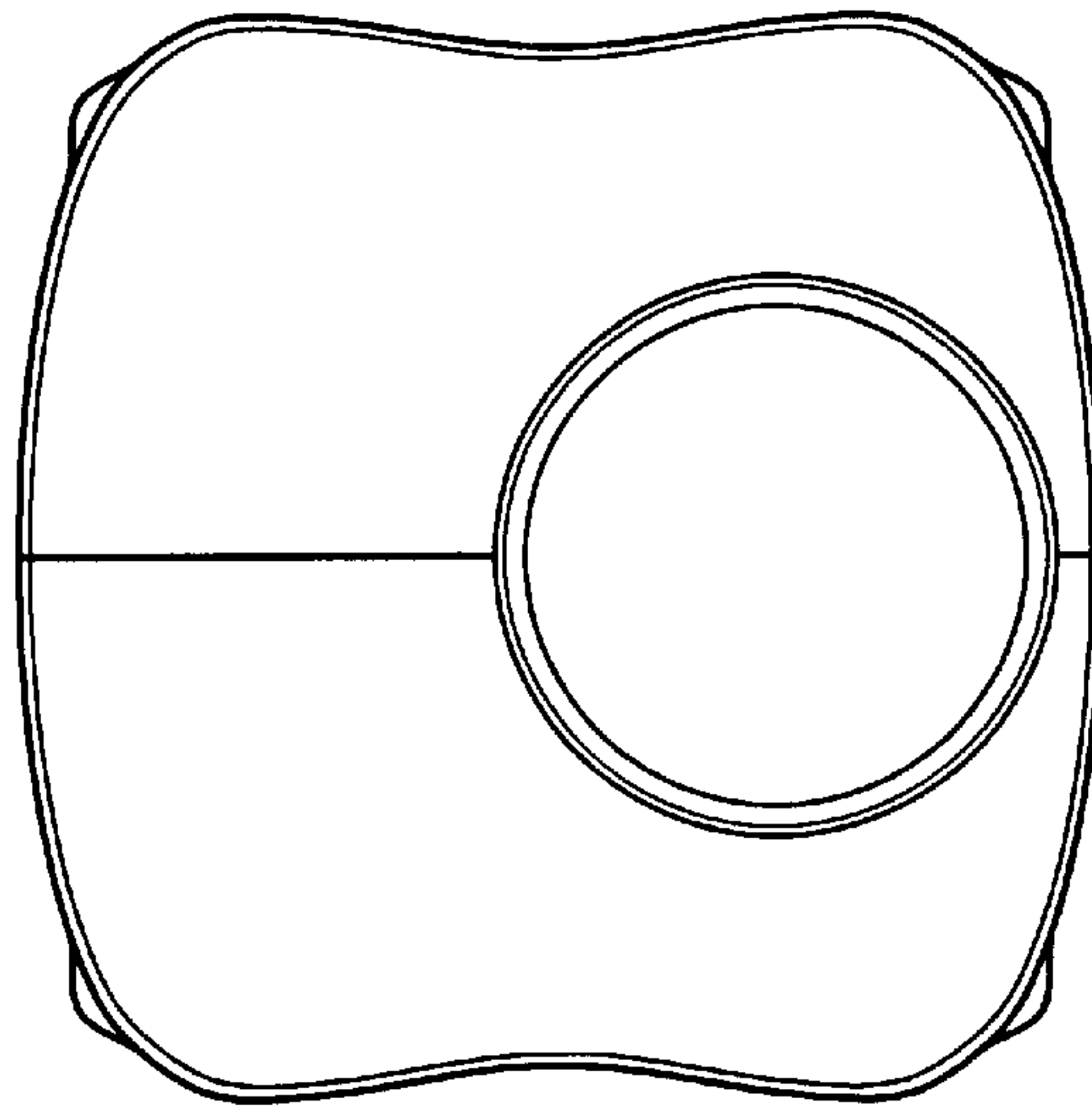

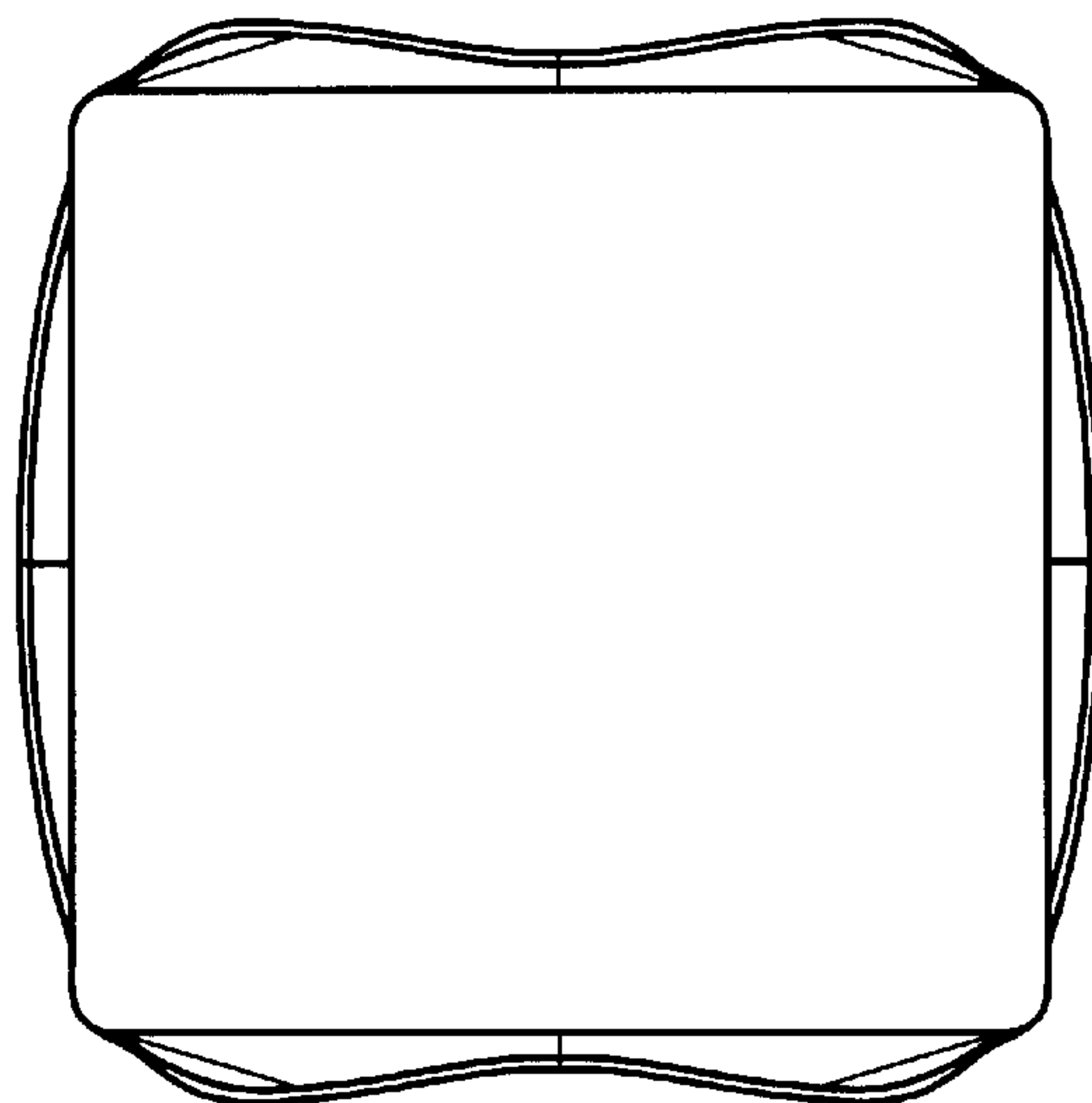

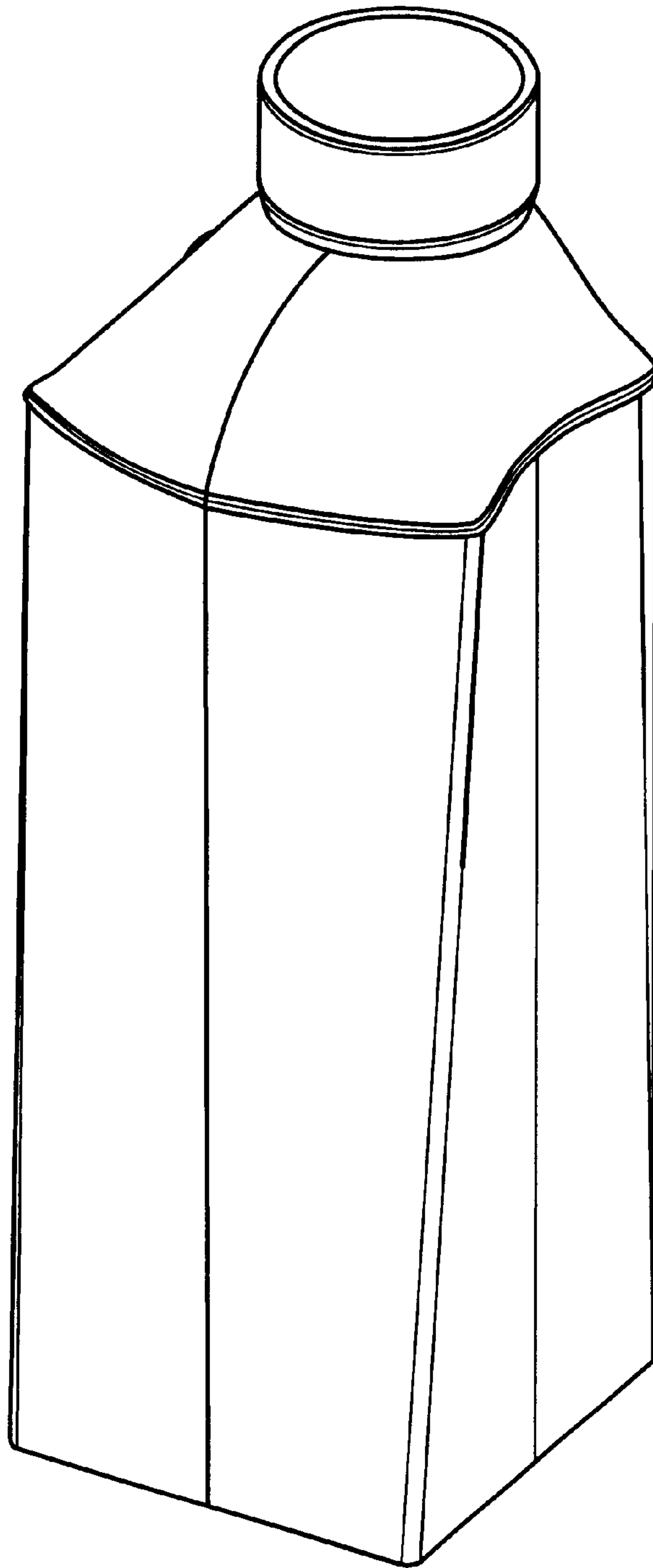

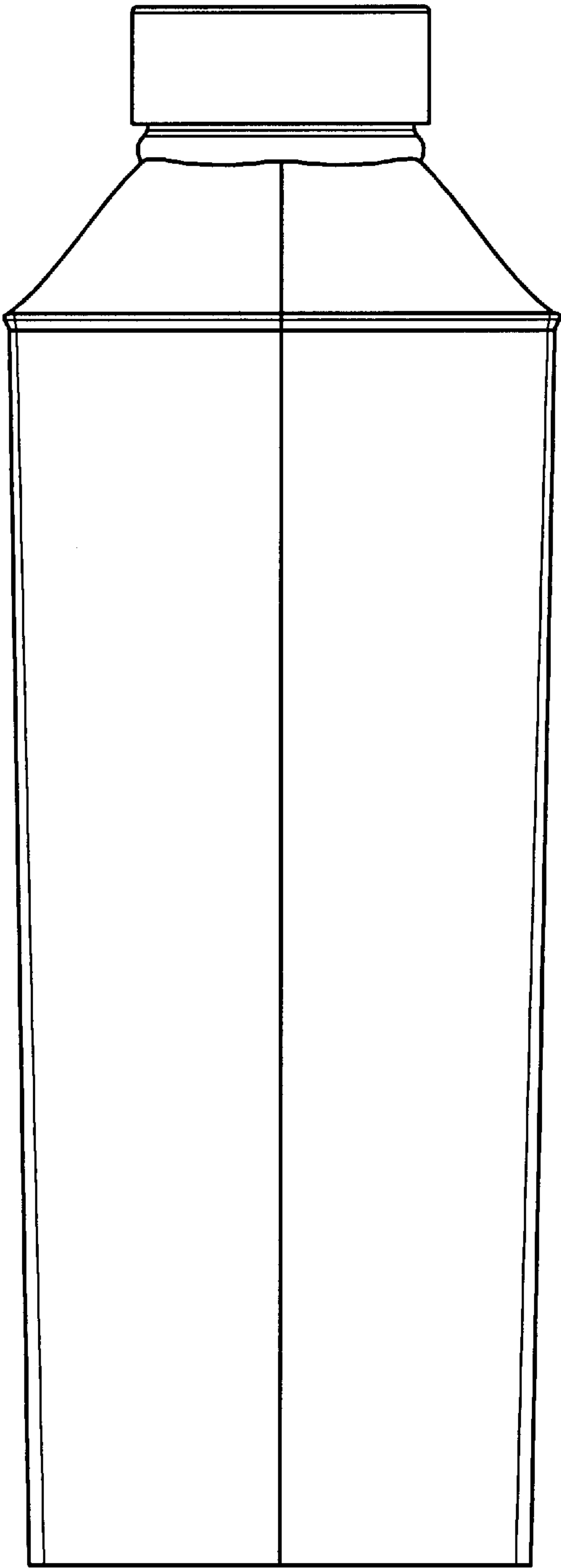

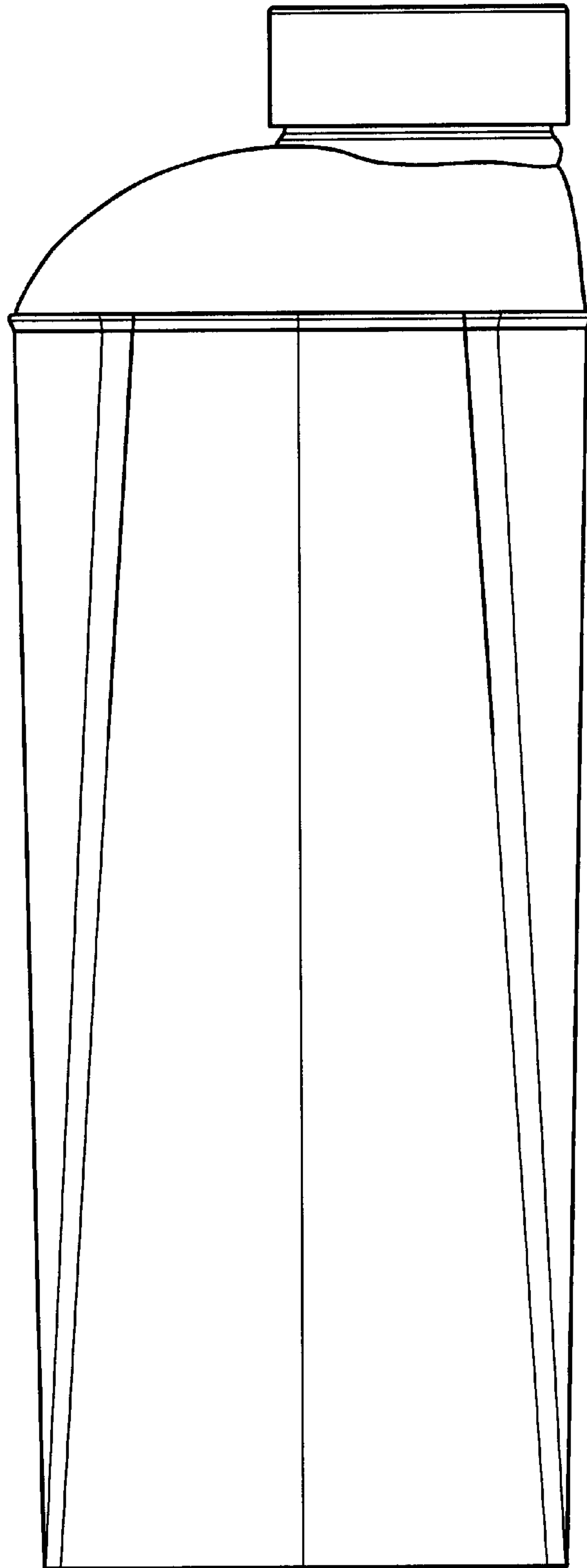

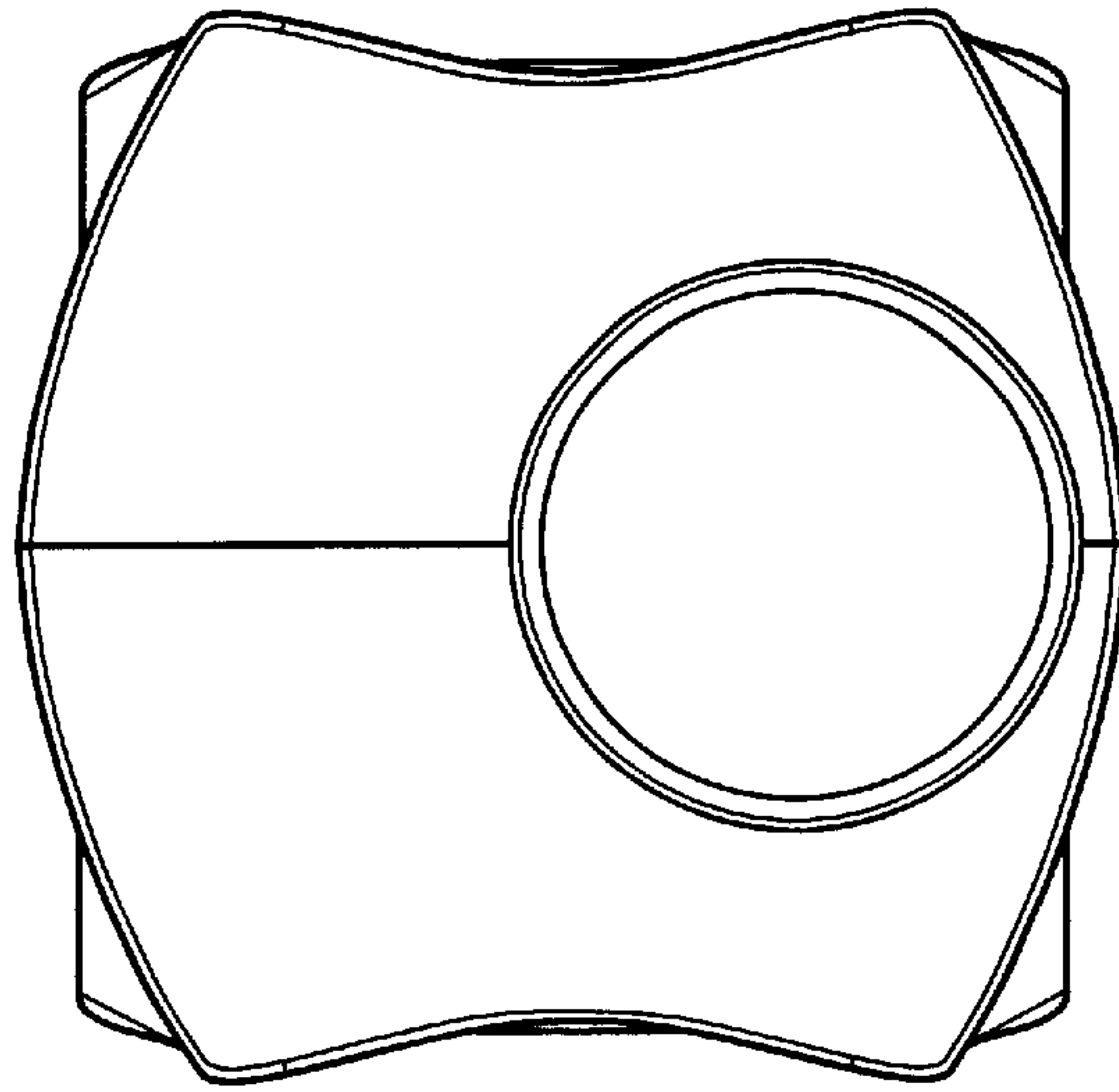

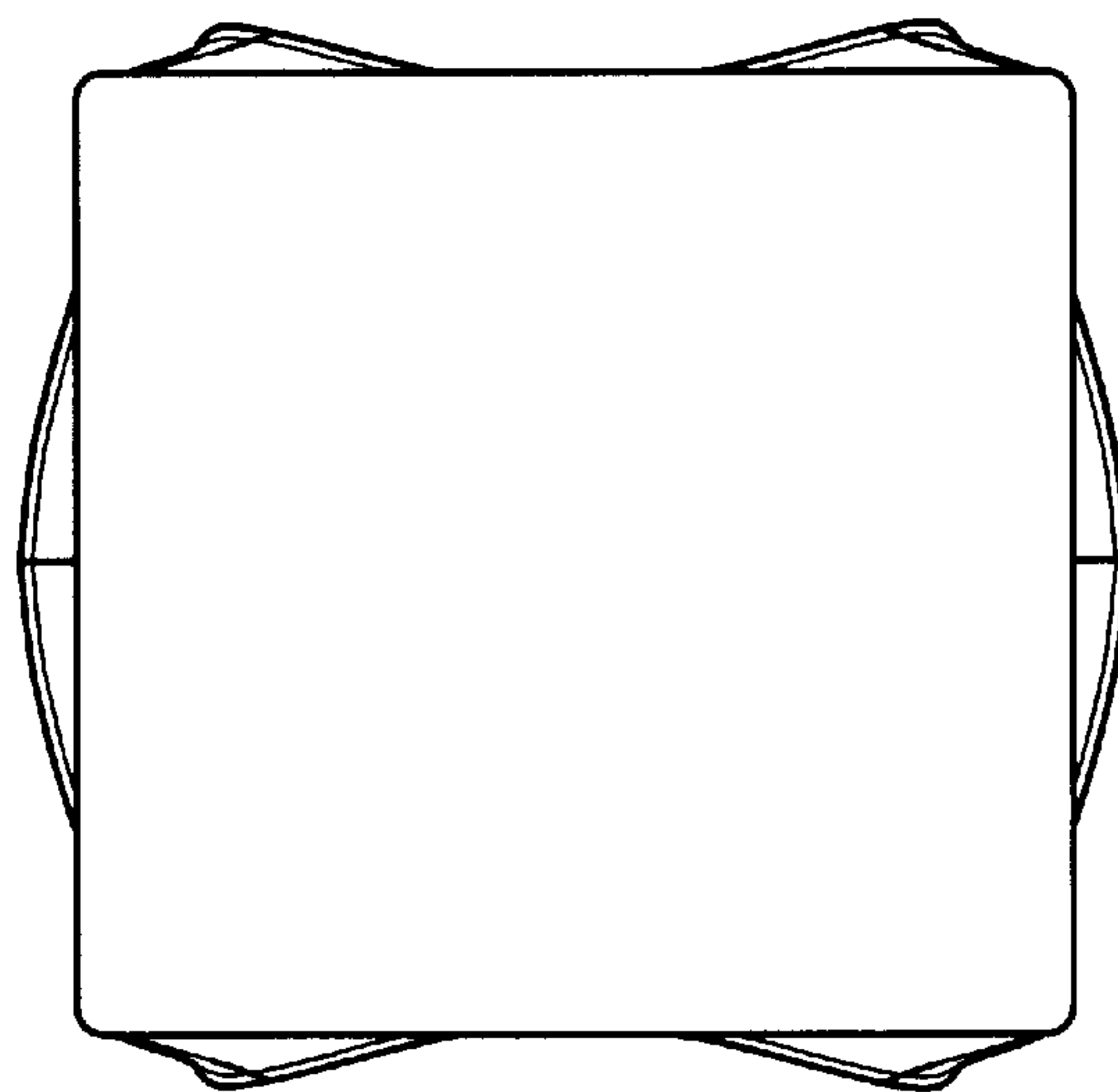
