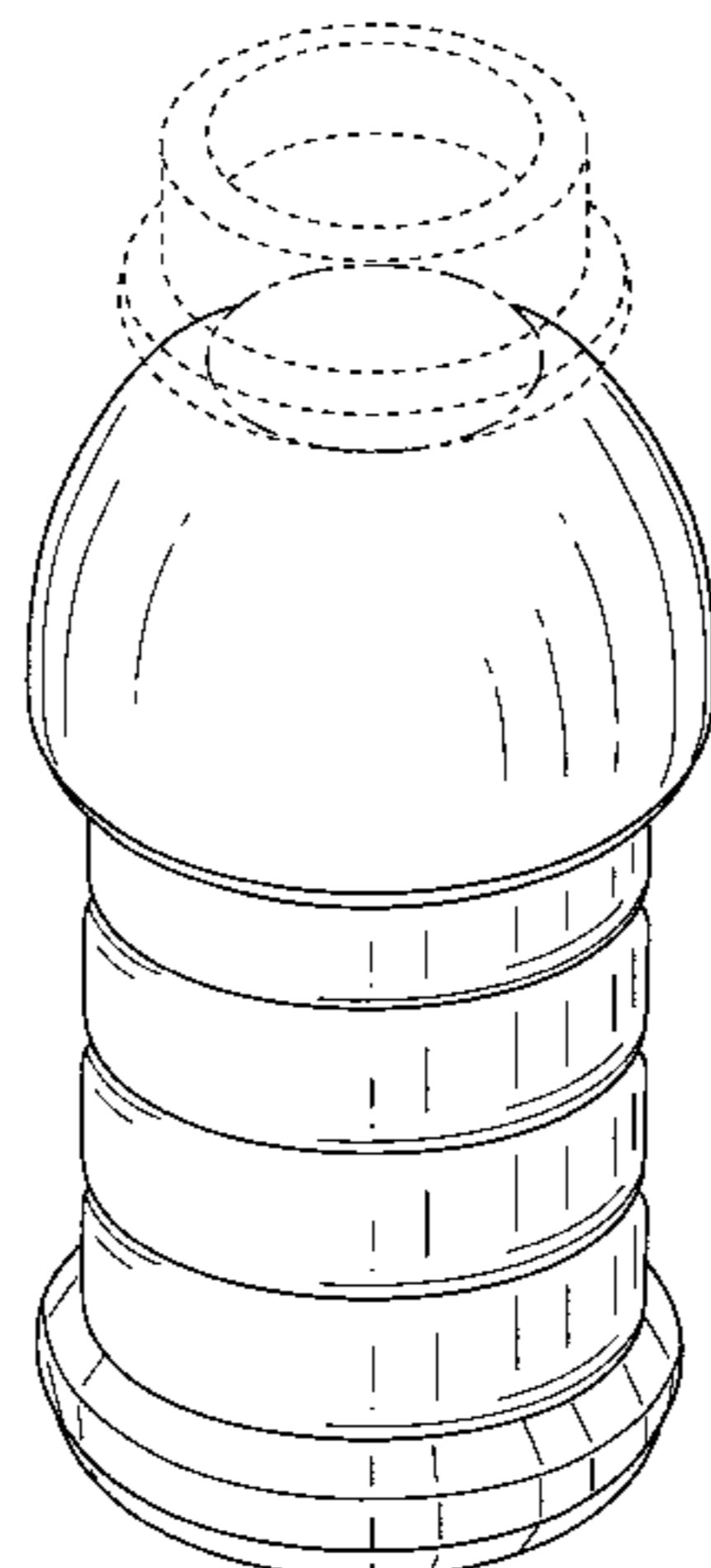
(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a bottle in accordance with the present invention;  
FIG. 2 is a right side elevational view thereof, shown at a reduced scale, the front, rear, and left side elevational views being identical;  
FIG. 3 is a top plan view thereof; and,  
FIG. 4 is a bottom plan view thereof.  
The dash-dash-dash-dash lines shown in the drawings are for environmental purposes only and form no part of the claimed design.  
The dot-dash-dot-dash broken line in the drawing forms the top boundary of the claim.  
The broken lines shown in FIGS. 1-3 of the neck are for illustrative purposes only and form no part of the claimed design.

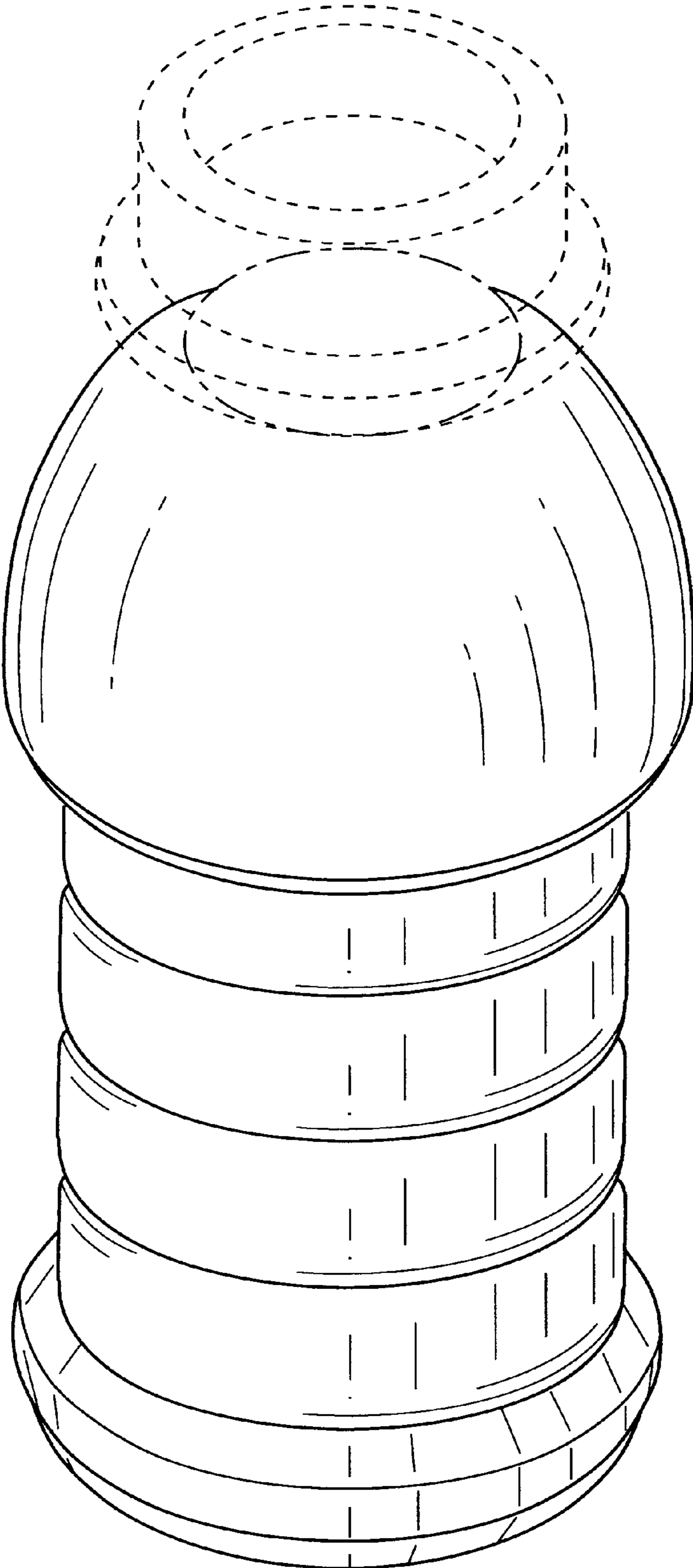

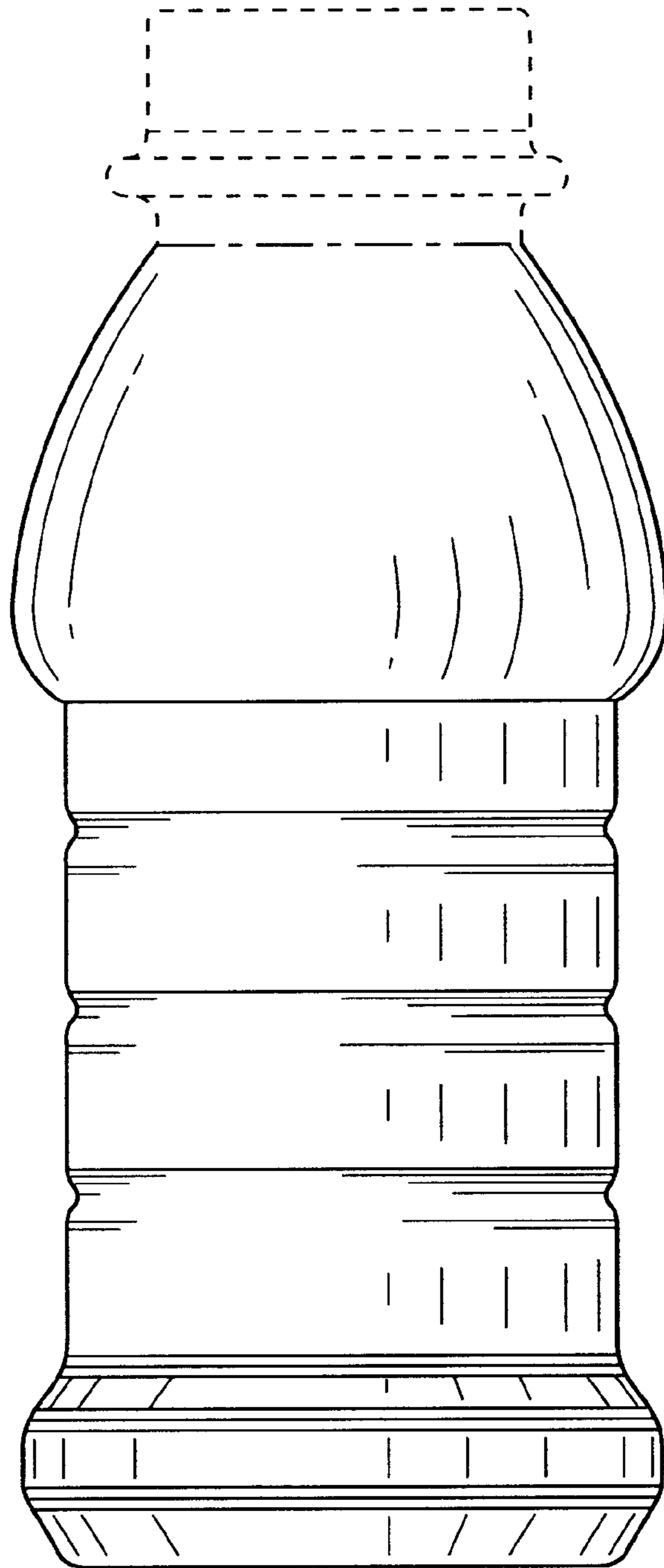

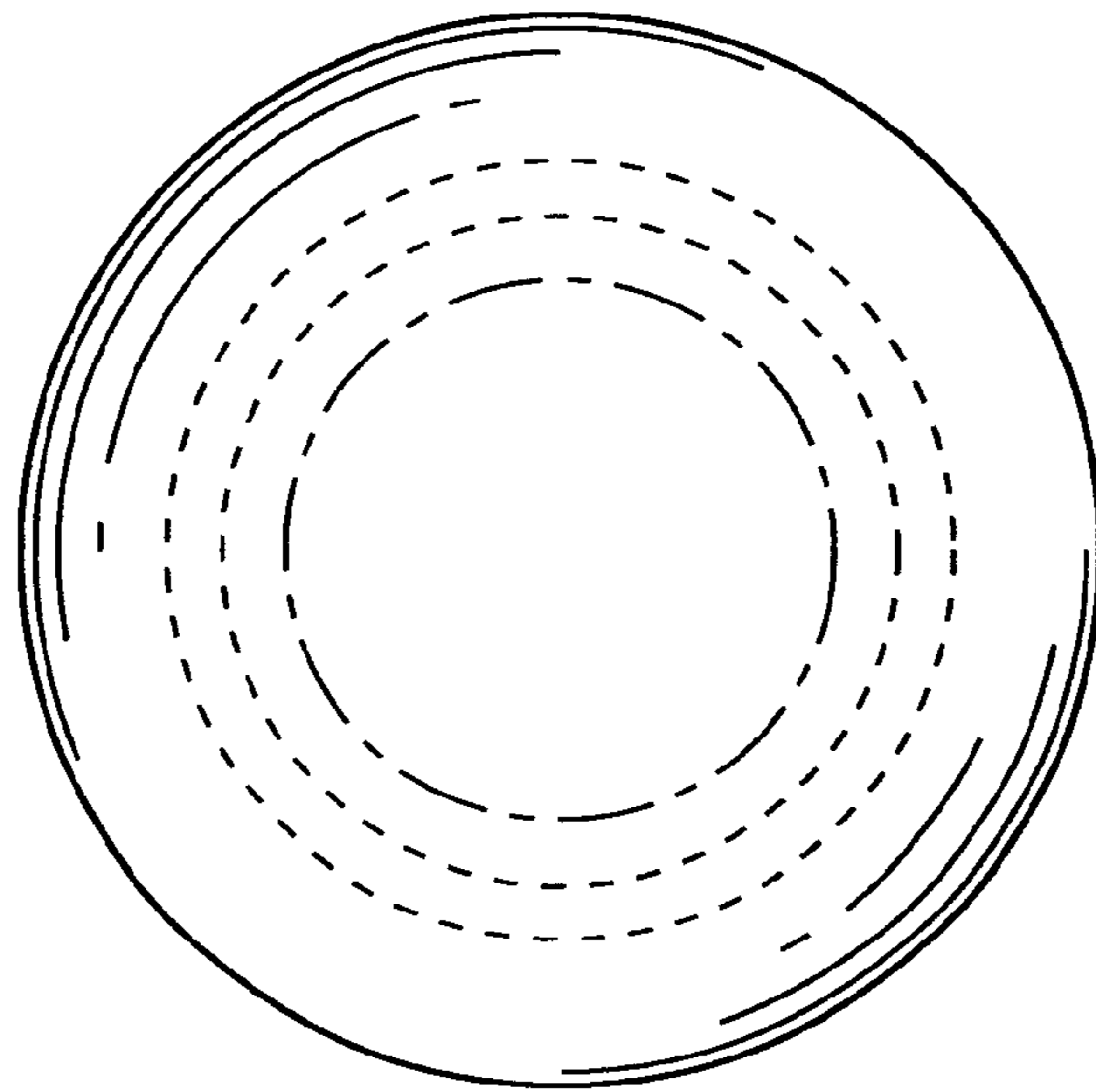

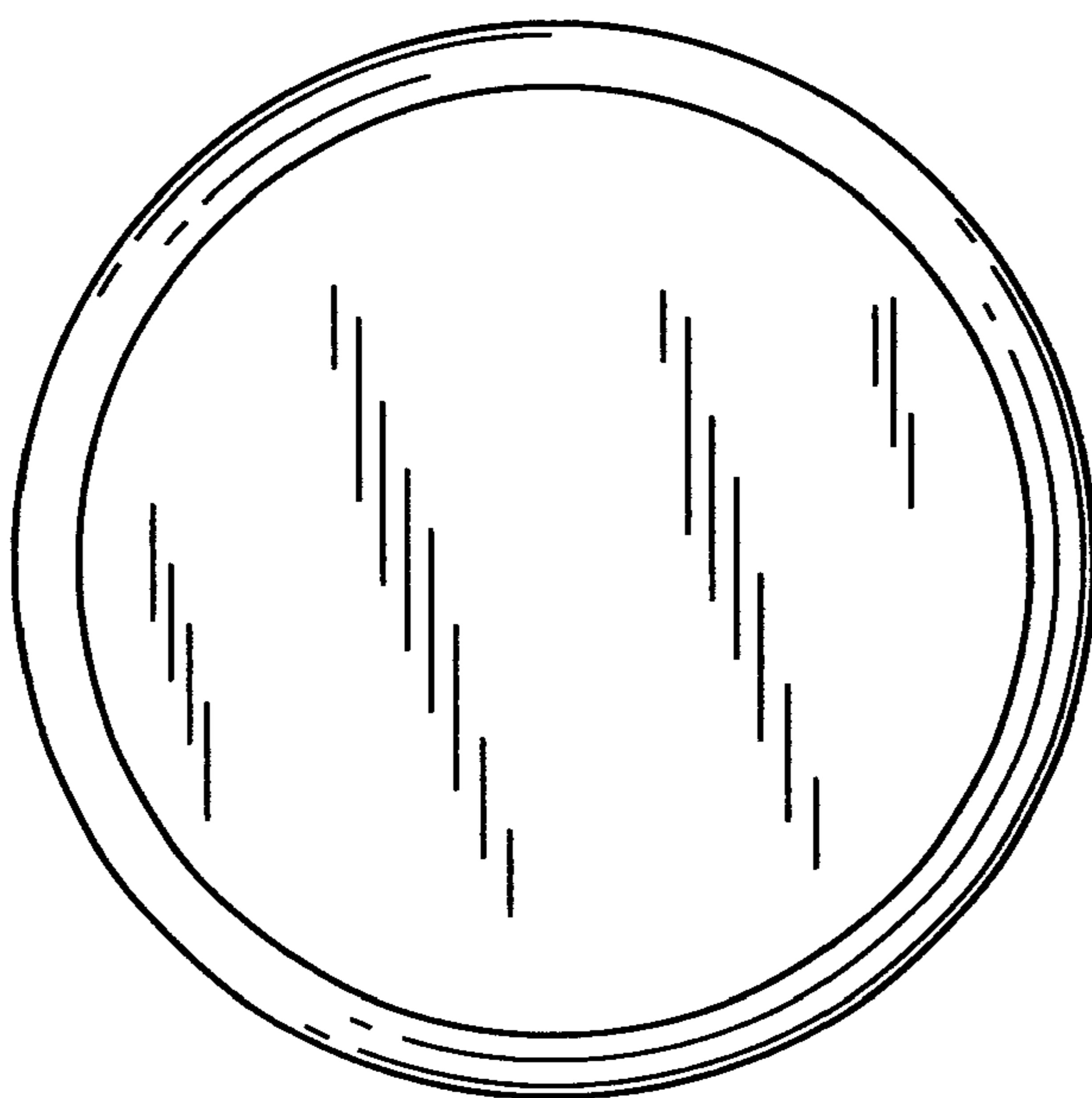
