(57) **CLAIM**

The ornamental design for a propel/repel dispensing container, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the first embodiment of a propel/repel dispensing container showing my new design, wherein the back and side views are the same;

FIG. 2 is a top view thereof;

FIG. 3 is a bottom view thereof;

FIG. 4 is a perspective view thereof;

FIG. 5 is a front view of the second embodiment of a propel/repel dispensing container, wherein the back and side views are the same; and,

FIG. 6 is a top view thereof, wherein the bottom view is the same as FIG. 3.

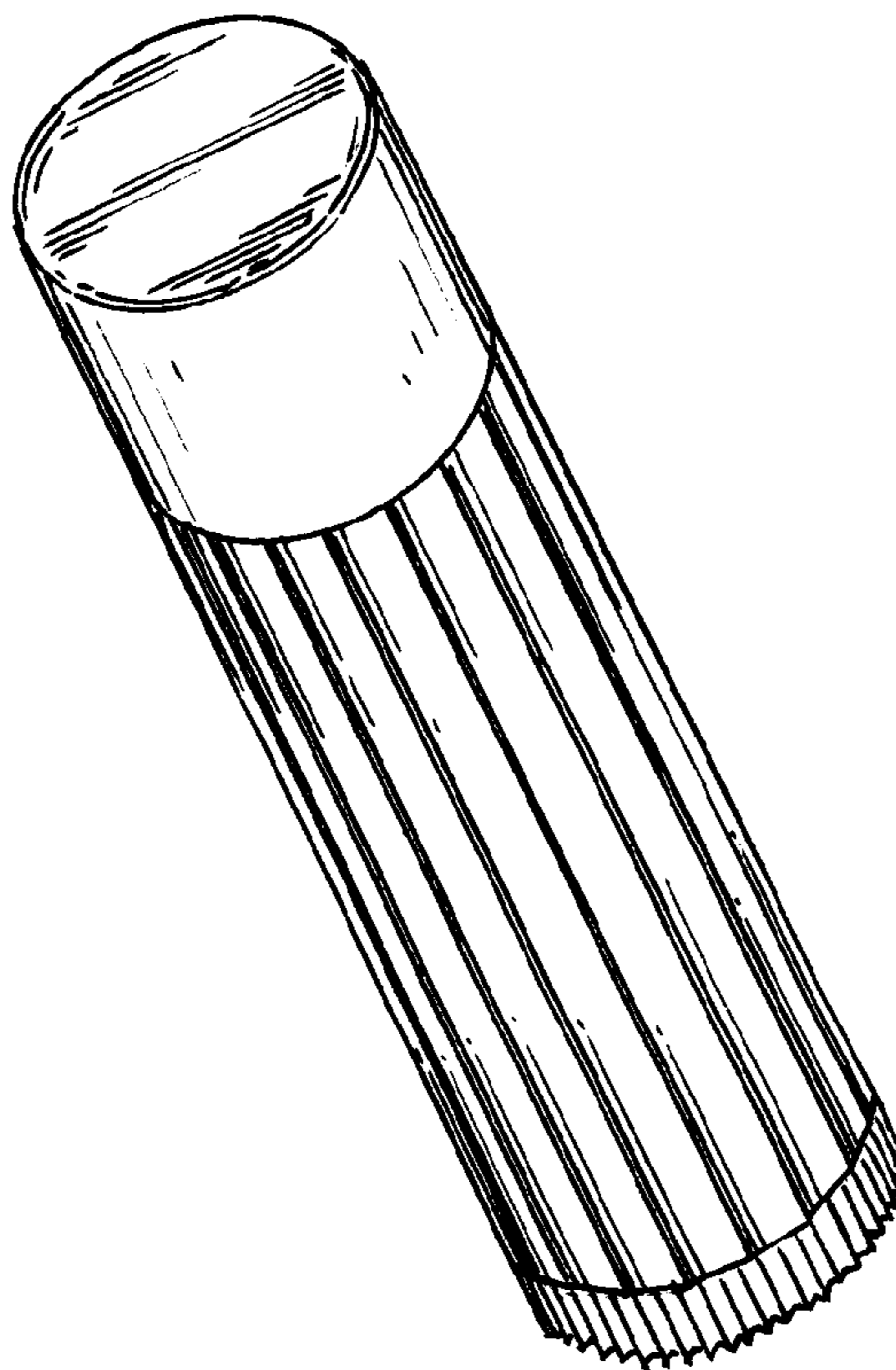

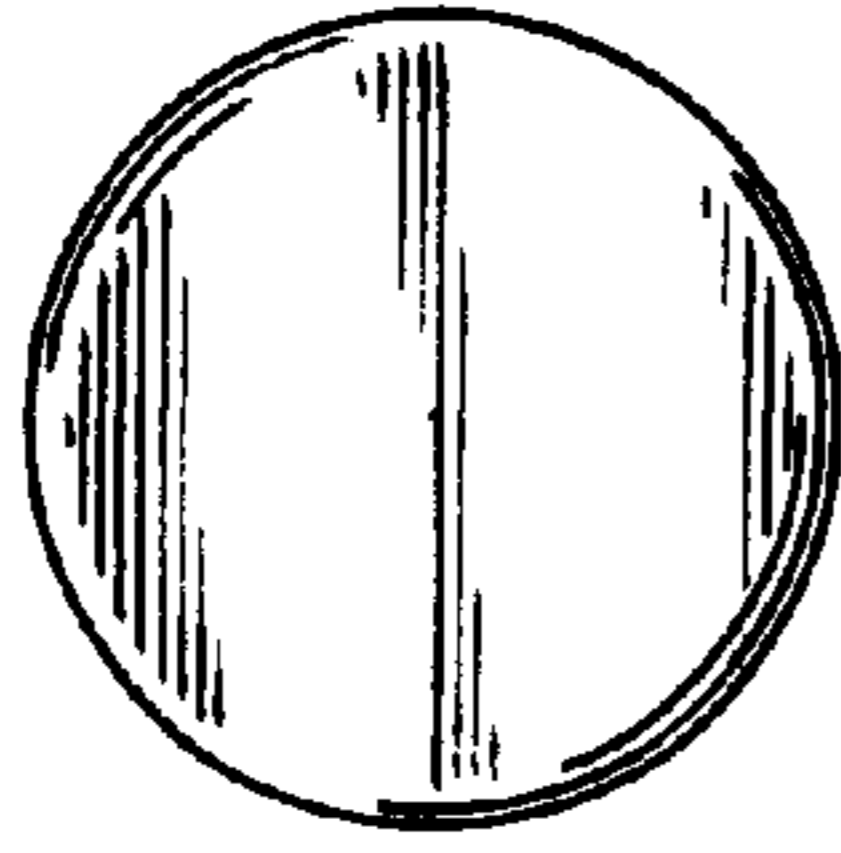

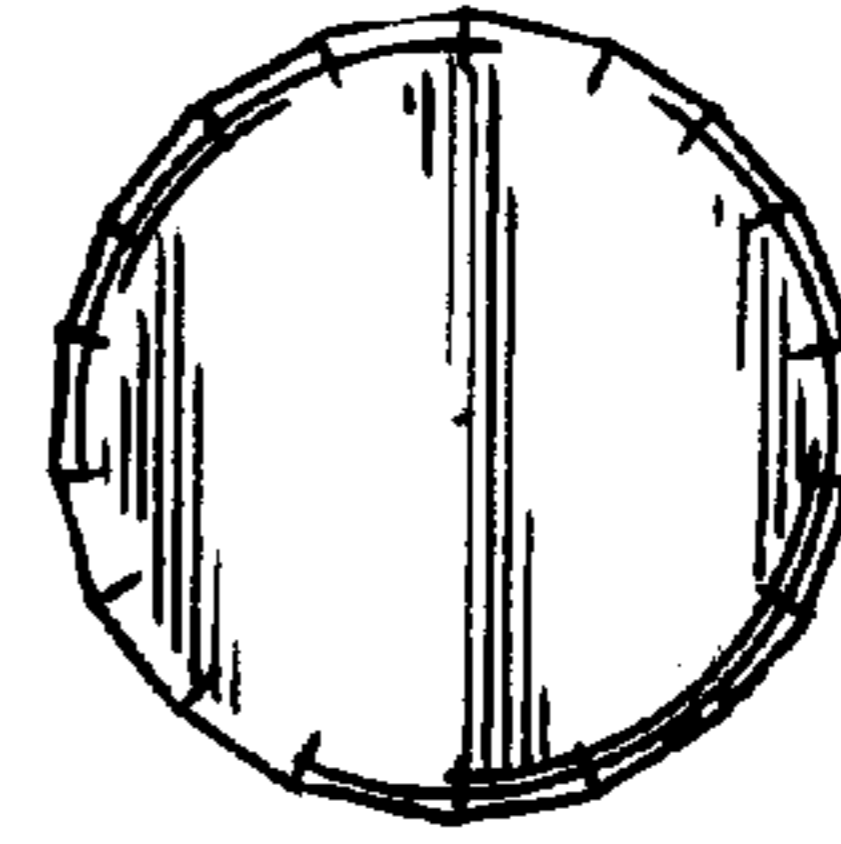

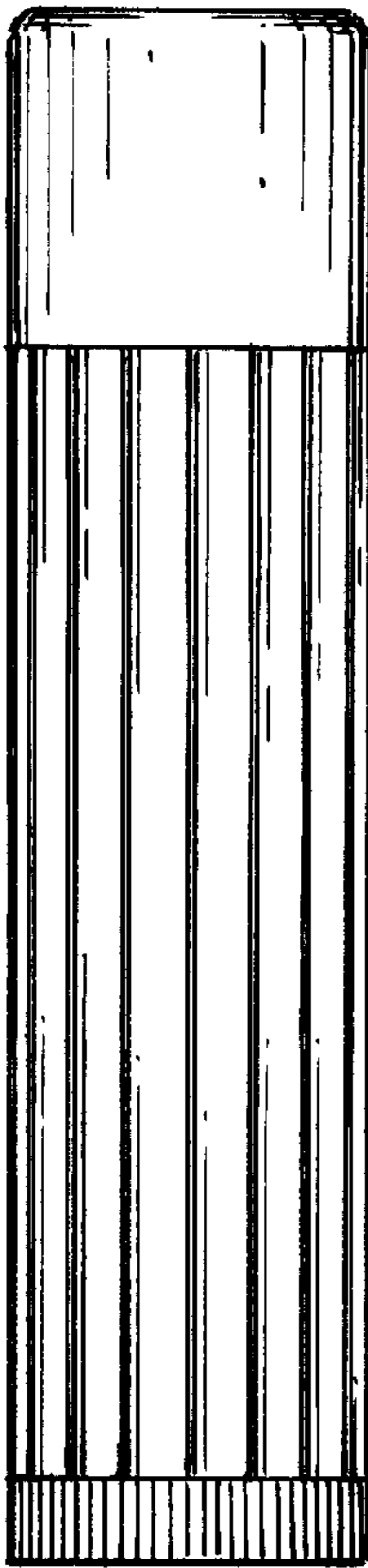

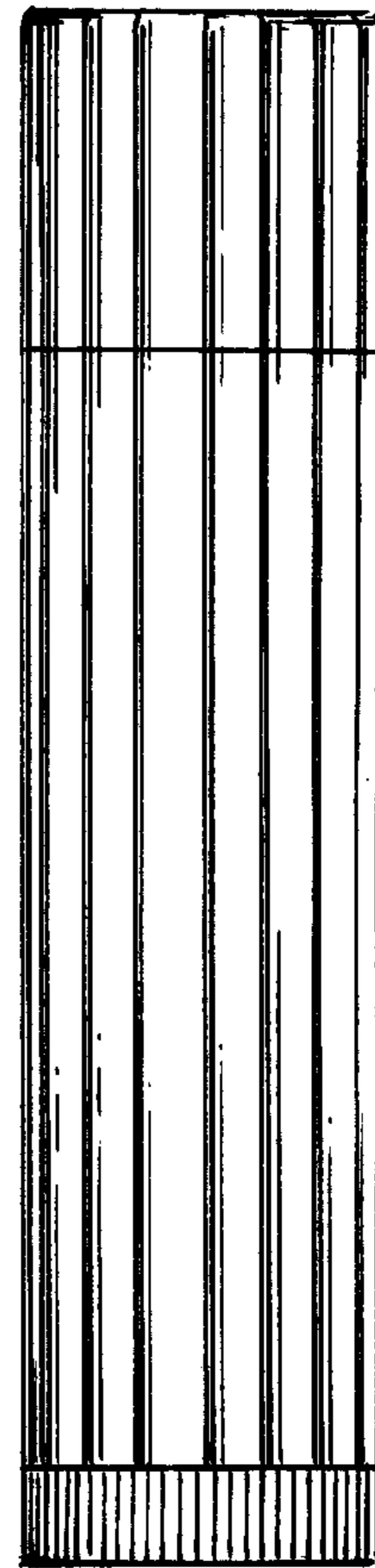

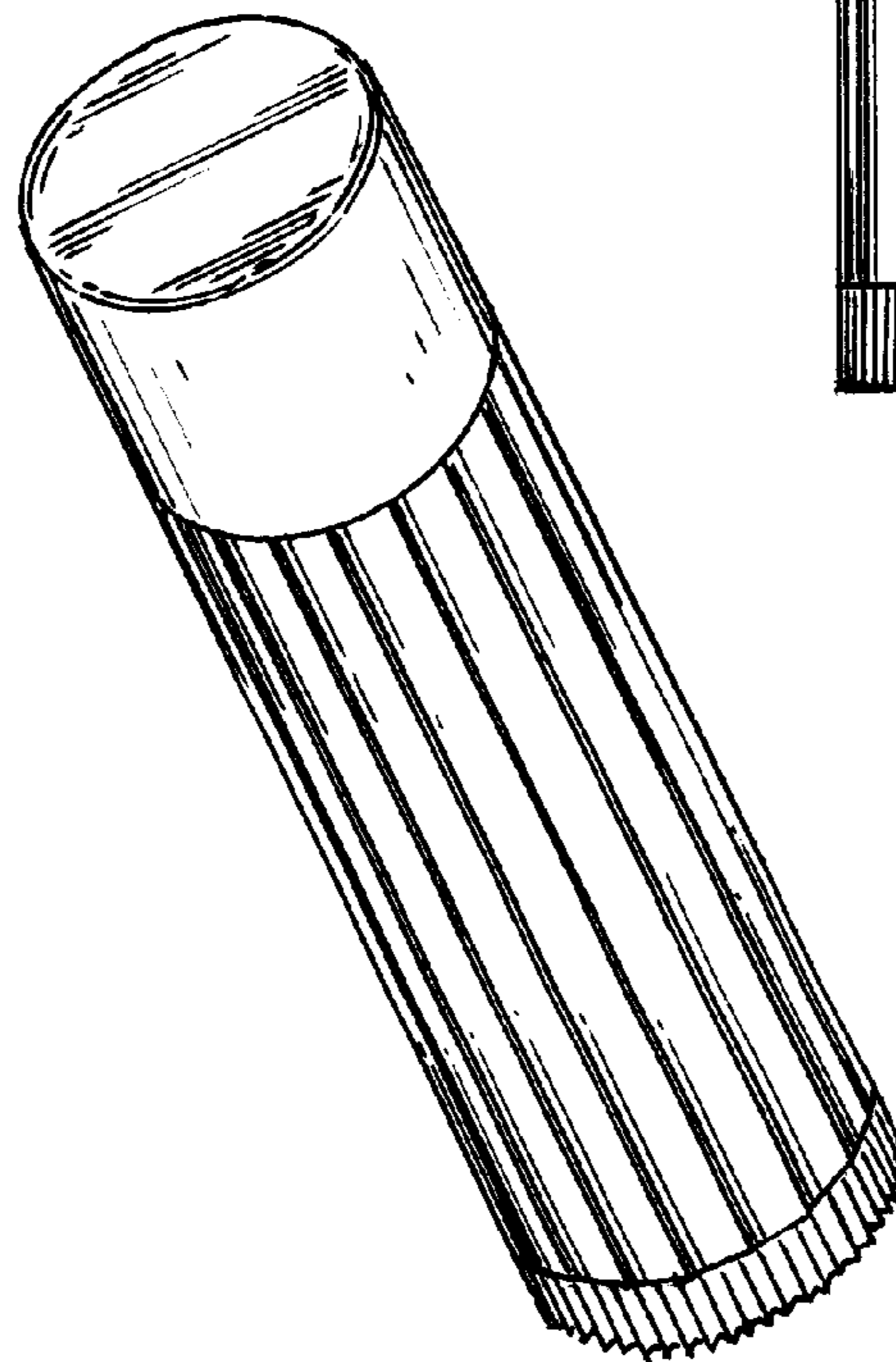
