(57) **CLAIM**

The new and ornamental design for a peaceful heart pendant, as shown.

**DESCRIPTION**

FIG. 1 is a front elevational view of a peaceful heart pendant;  
FIG. 2 is a rear elevational view thereof;  
FIG. 3 is a top view thereof;  
FIG. 4 is a side view thereof, both sides being identical;  
FIG. 5 is a bottom view thereof;  
FIG. 6 is a perspective view; and,  
FIG. 7 is a perspective view of a peaceful heart pendant in a state rotated from that shown in FIG. 1.

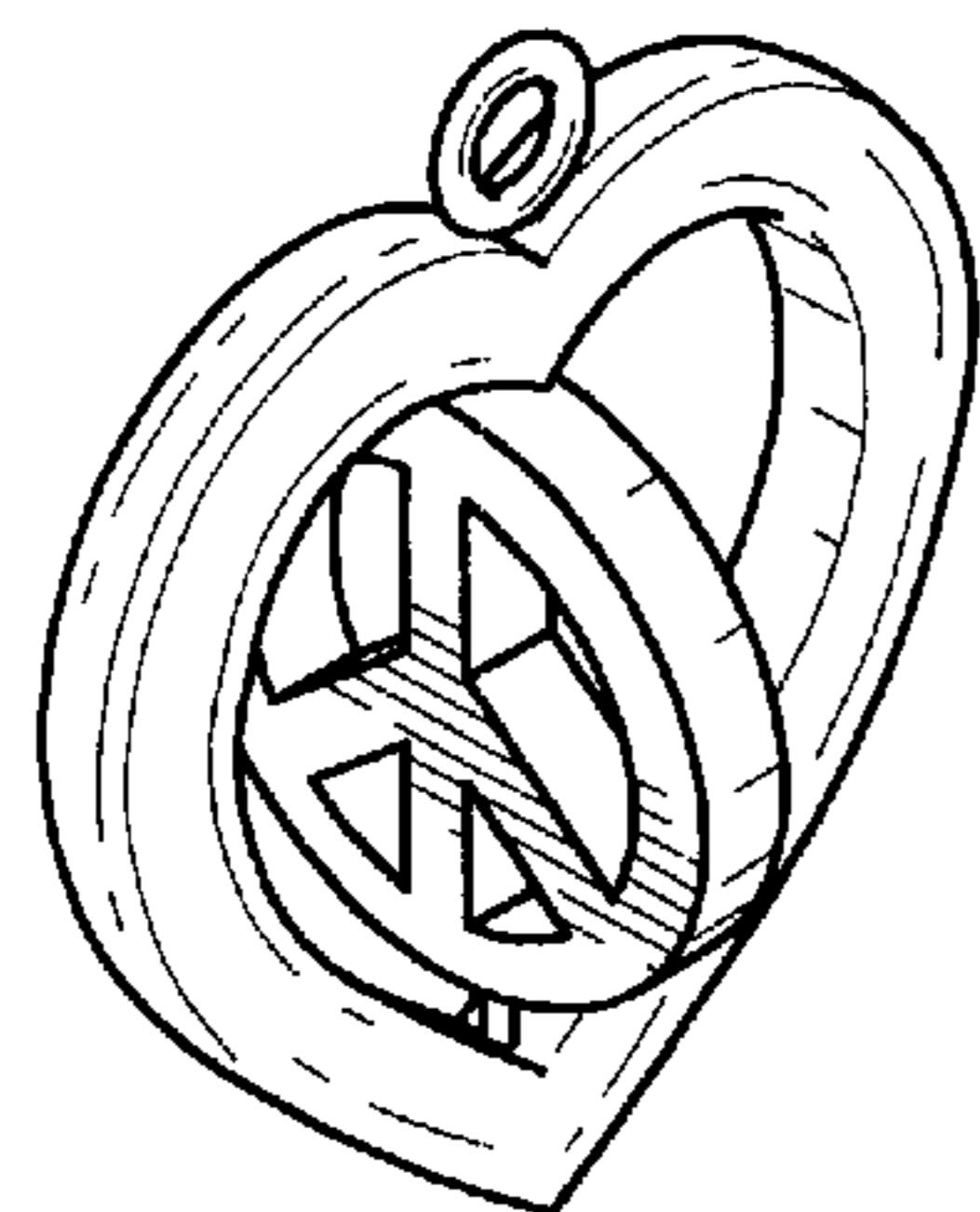

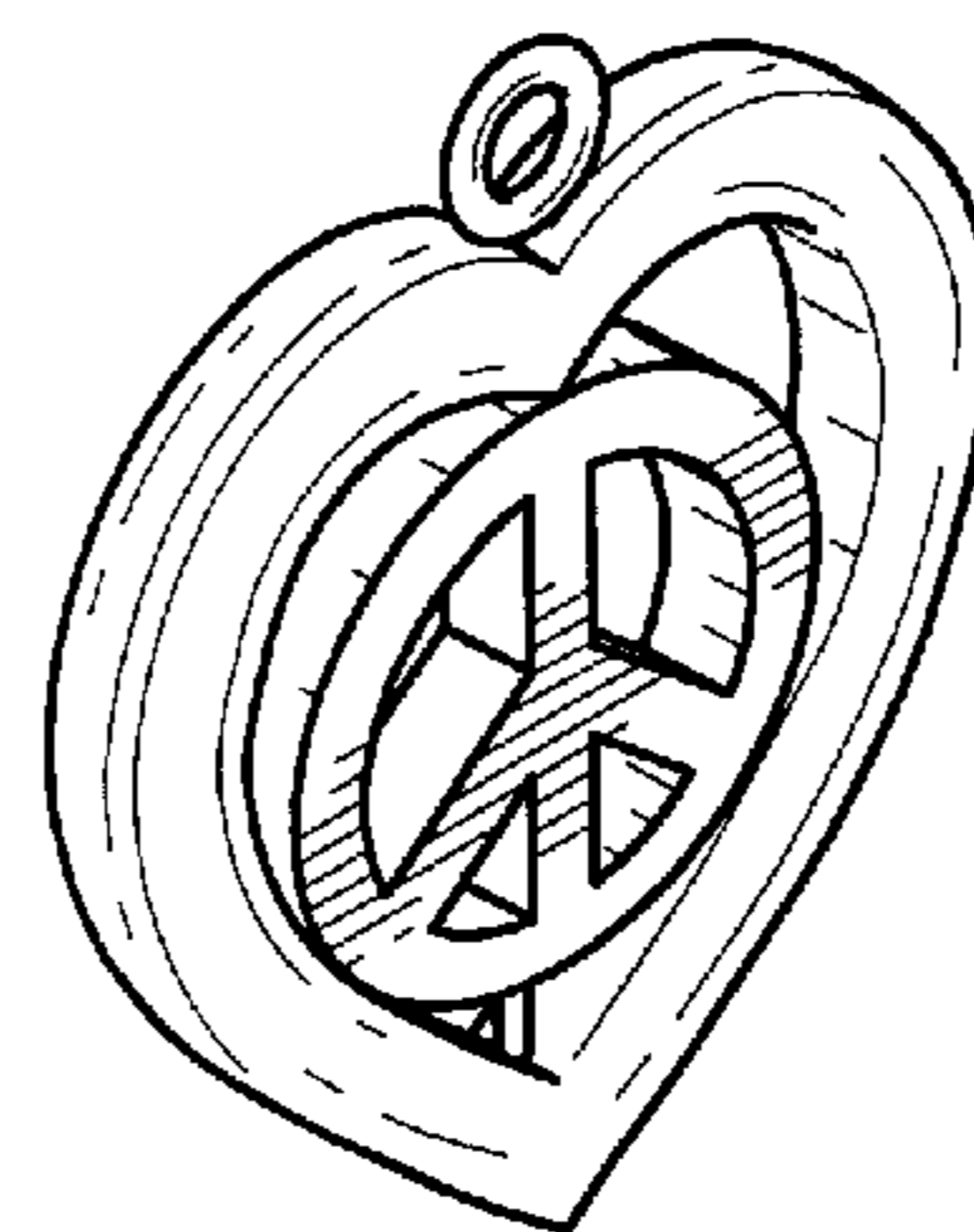
