We claim the ornamental design for plasma display panel television receiver, as shown and described.

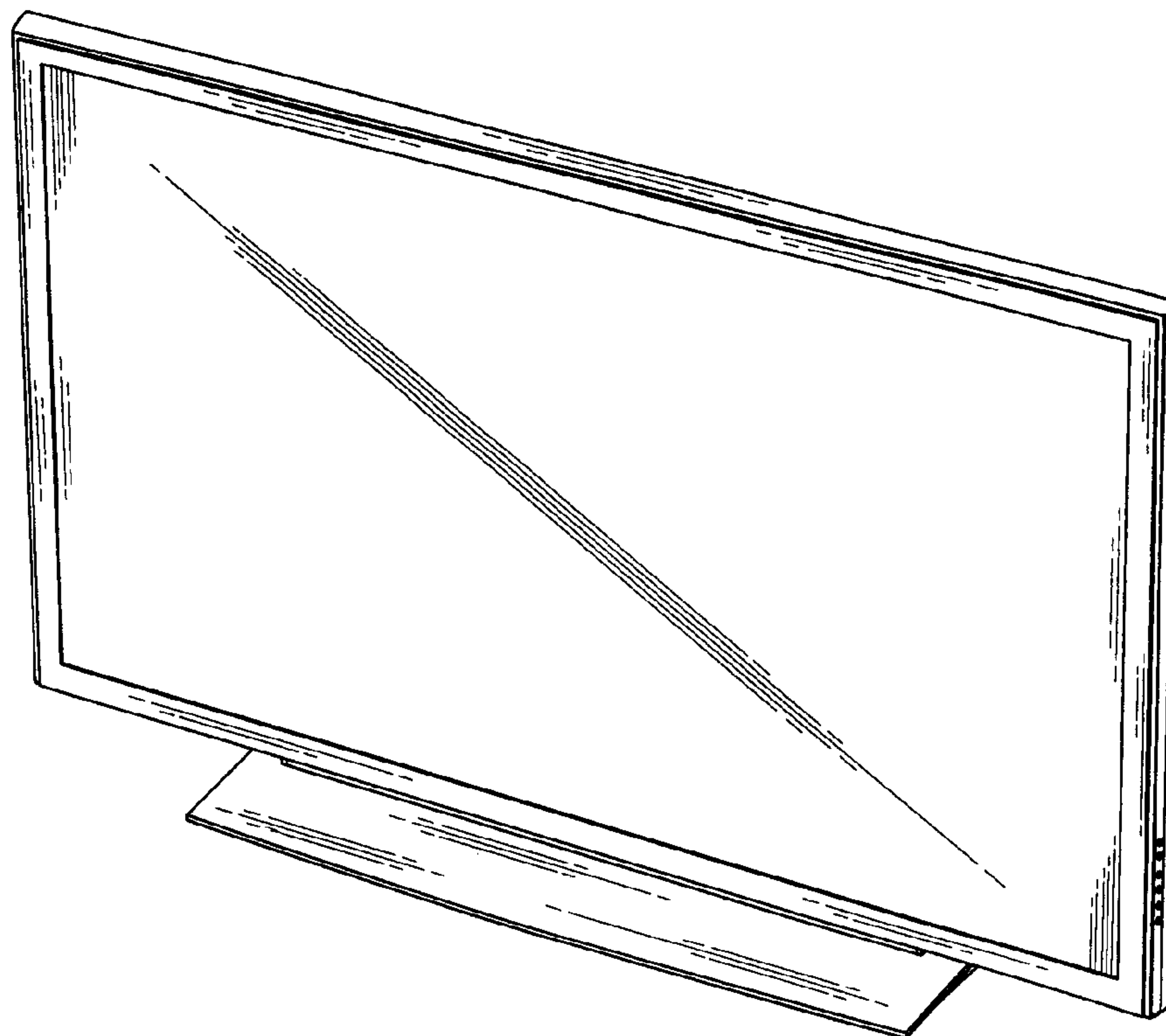

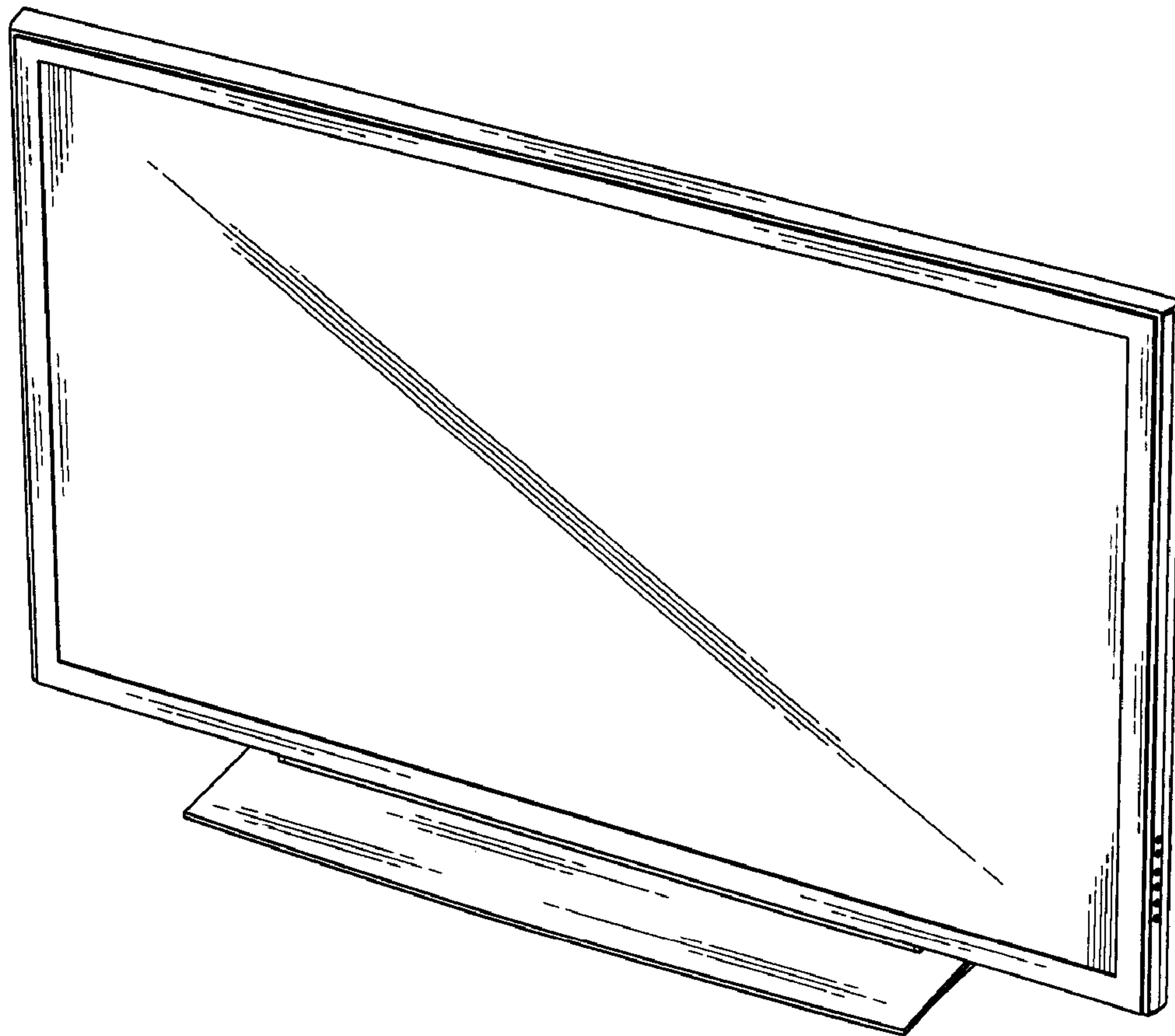

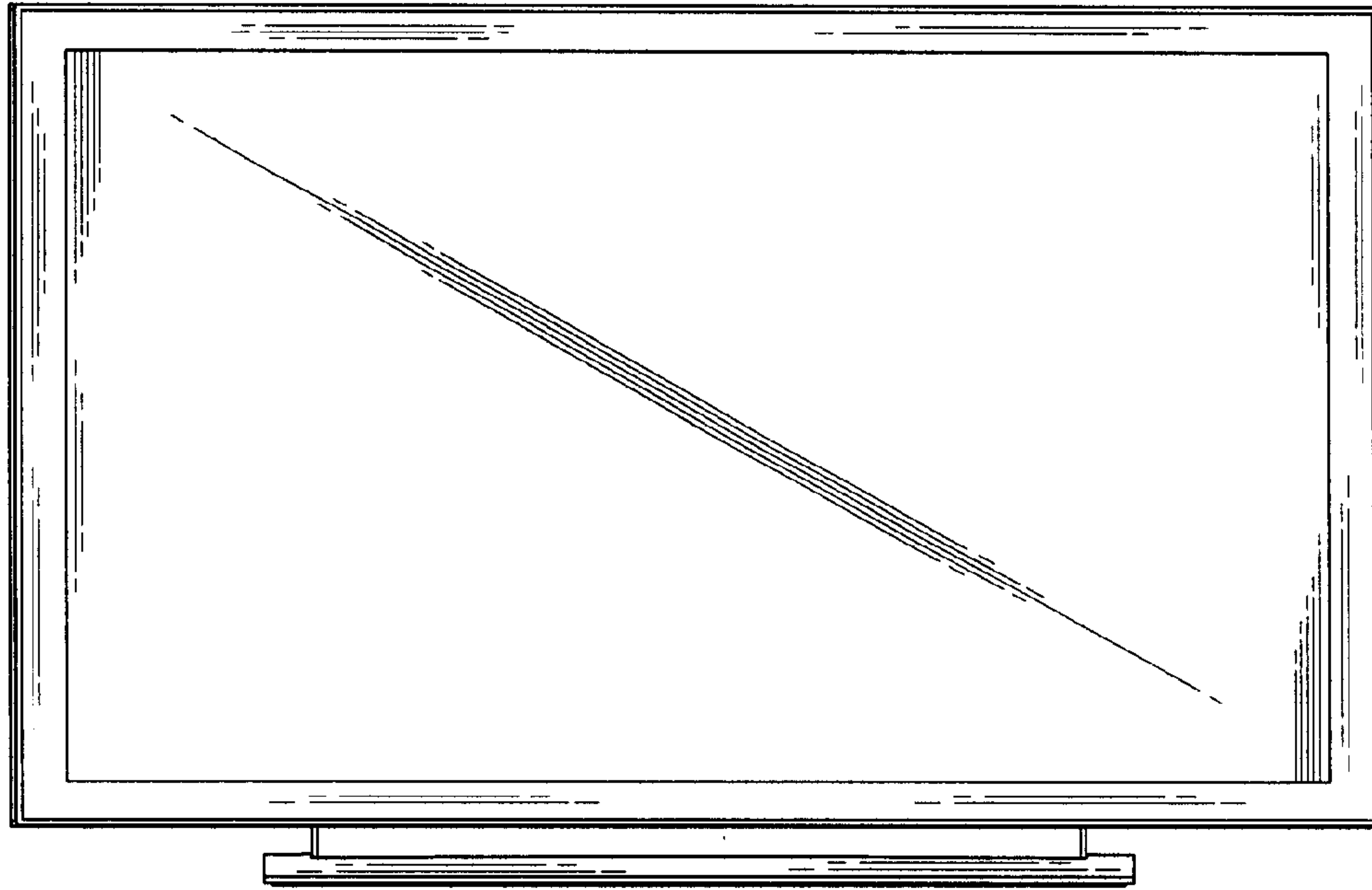

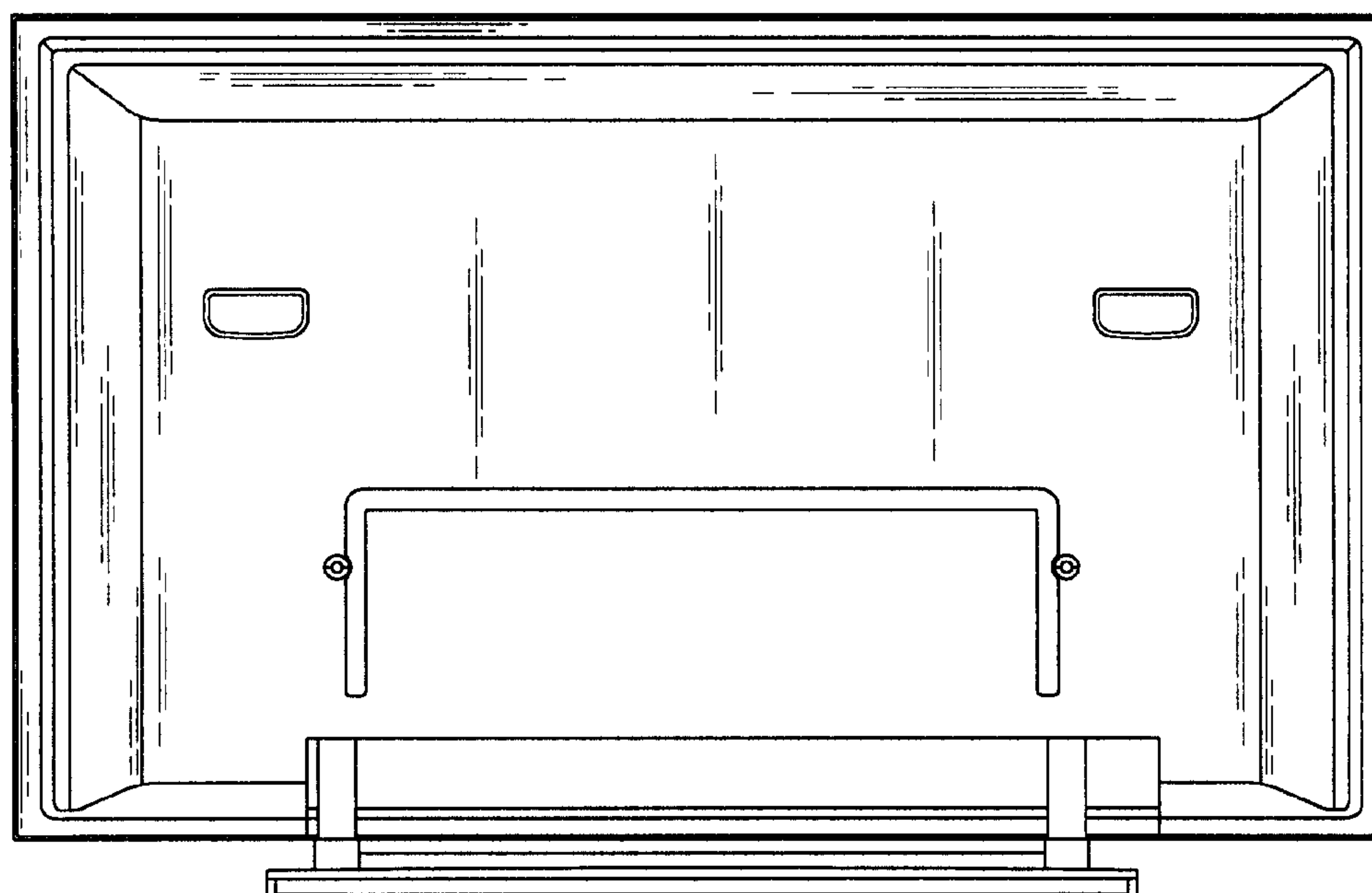

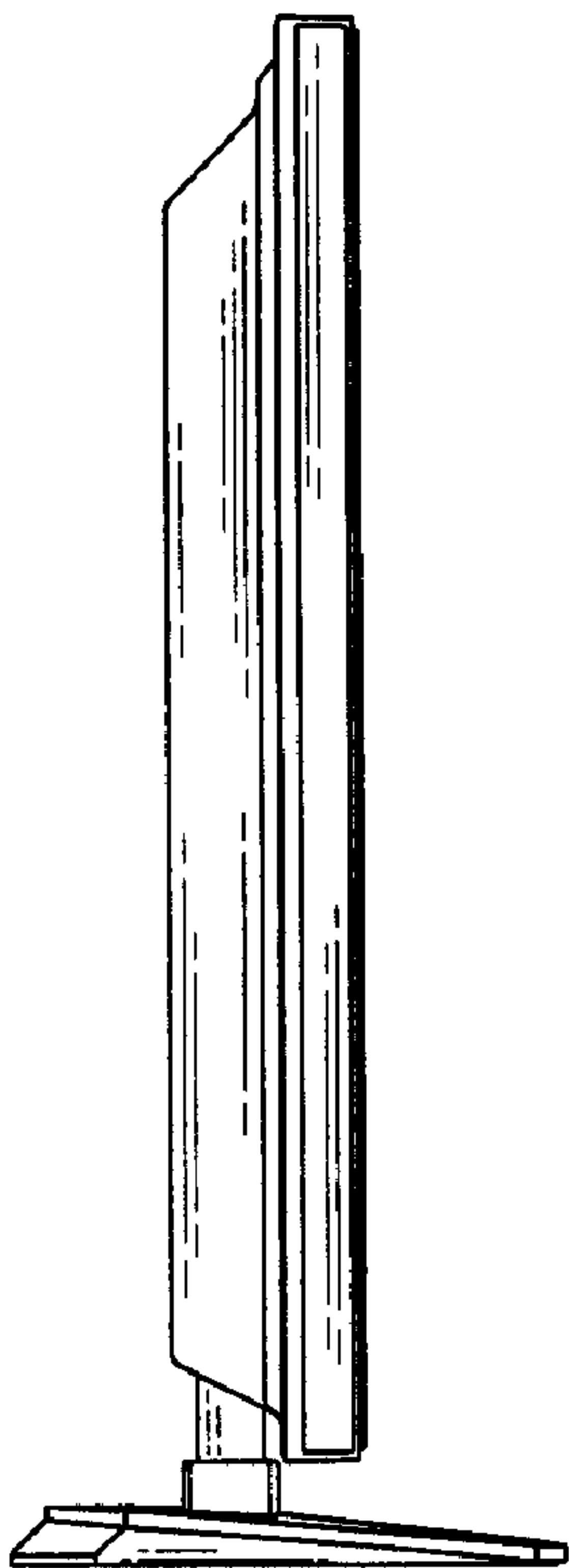

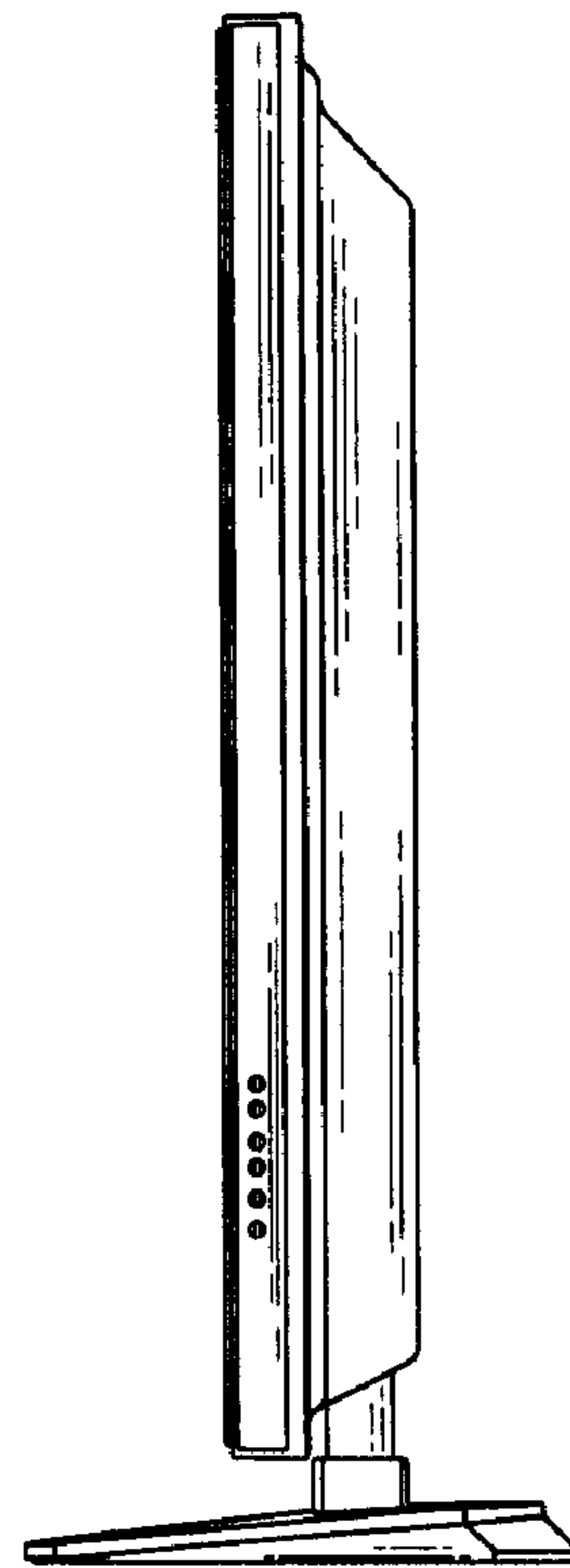

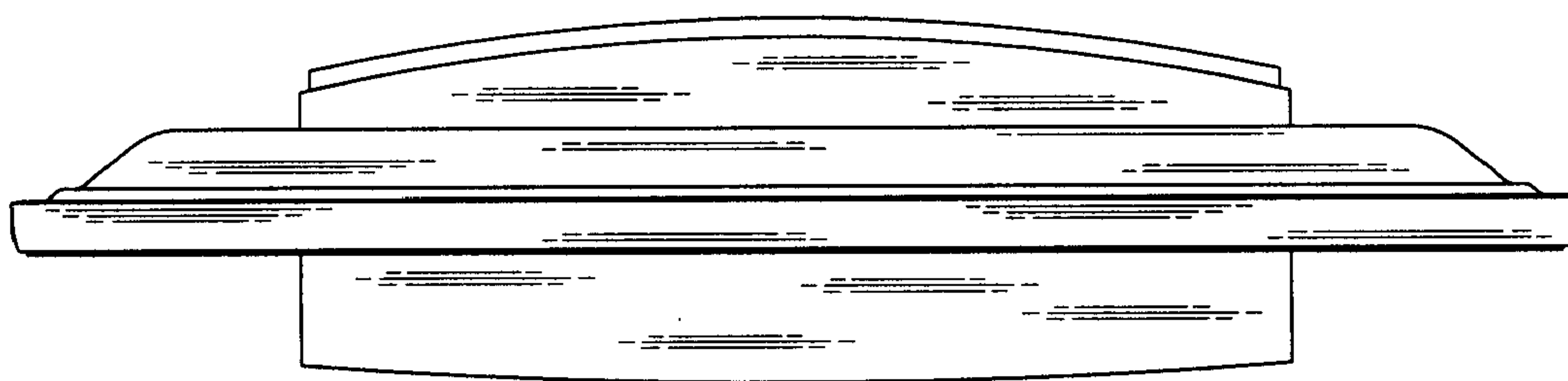
