DESCRIPTION

FIG. 1 is a front, top and left side perspective view of a portable digital information recording/reproduction unit, showing my new design;

FIG. 3 is a front elevational view thereof;

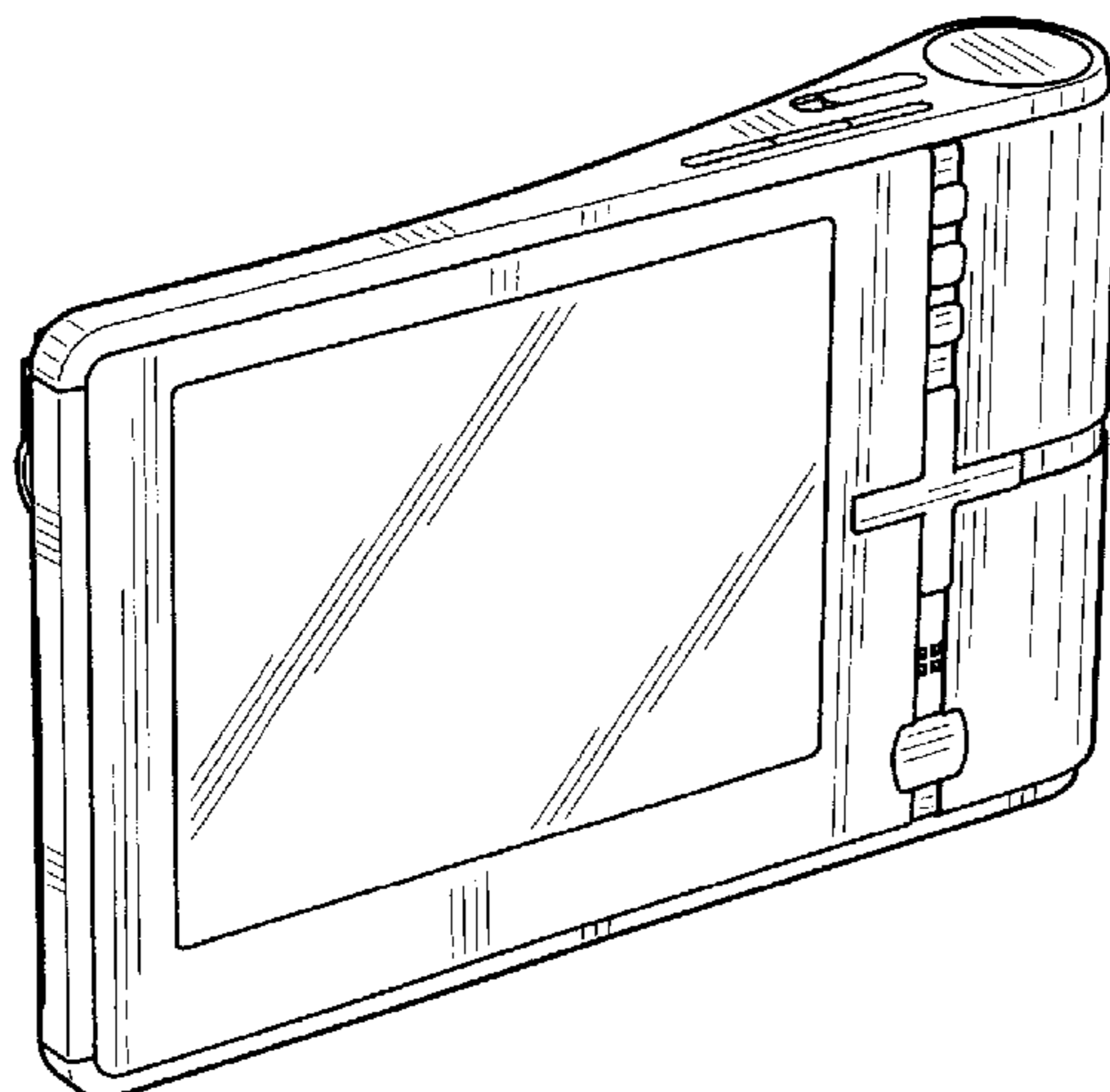
FIG. 4 is a bottom plan view thereof;

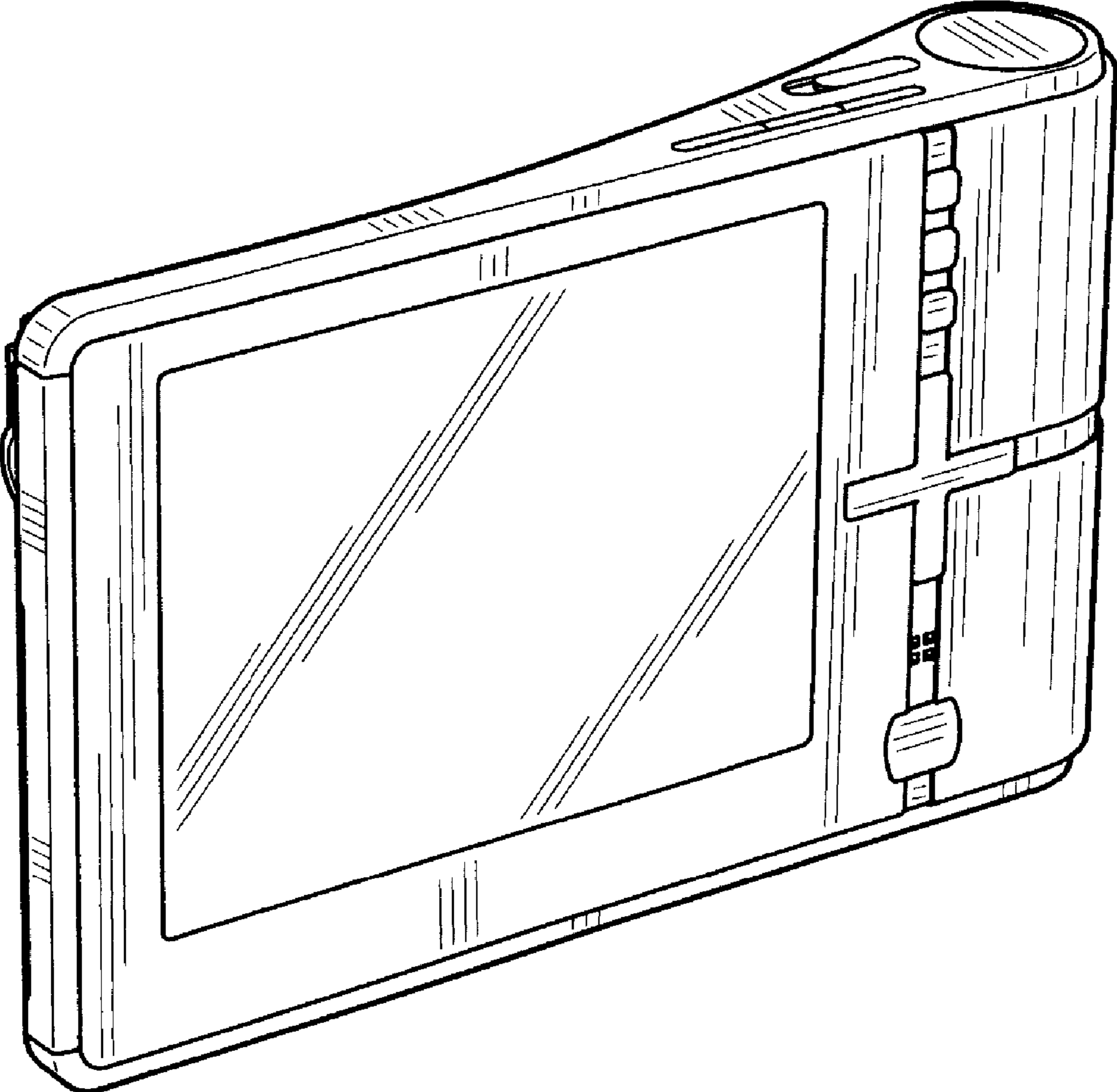

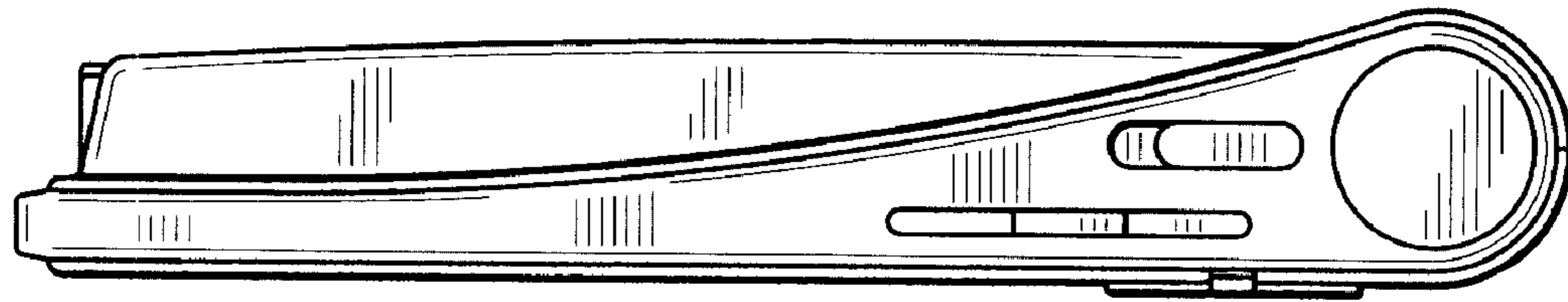

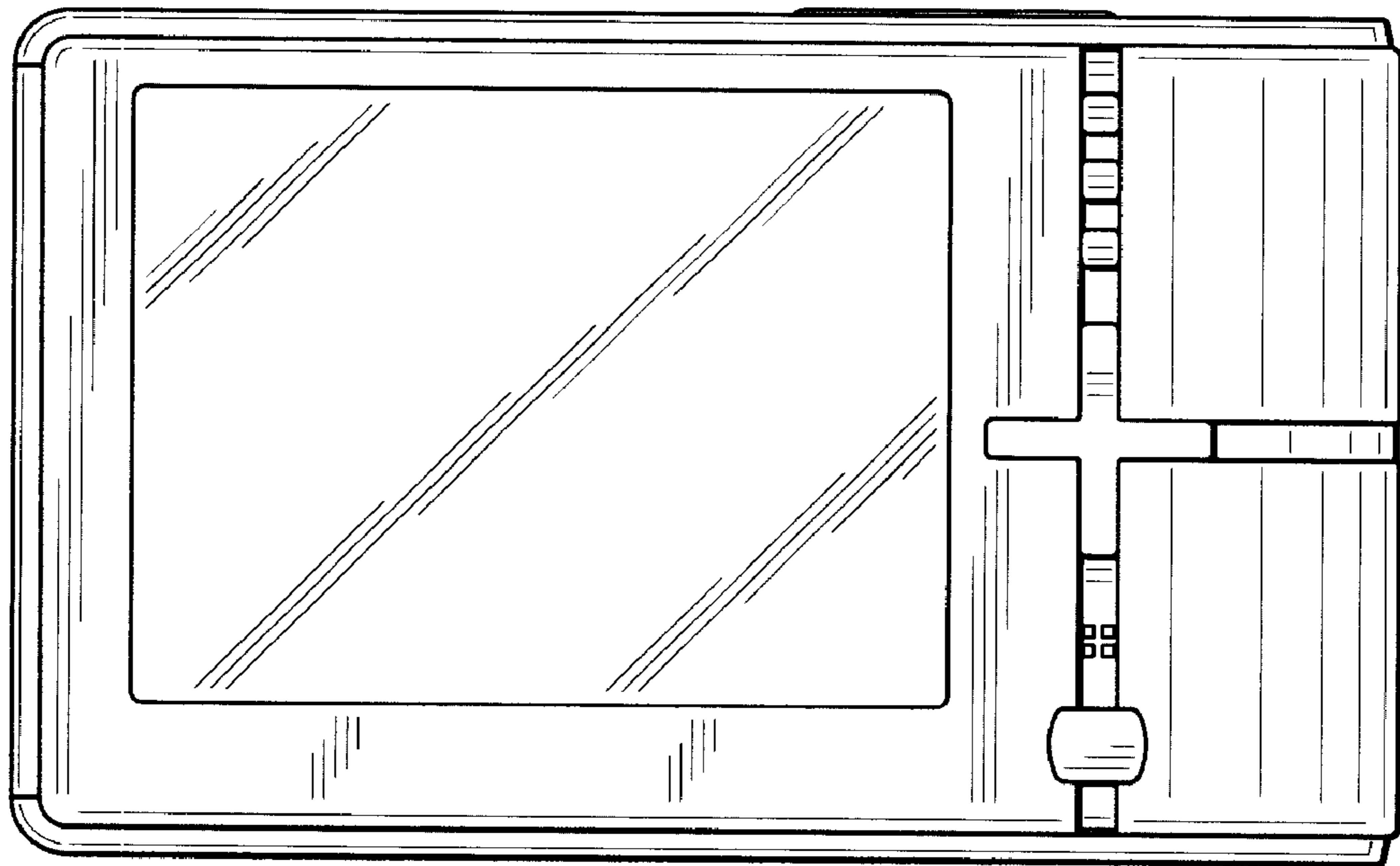

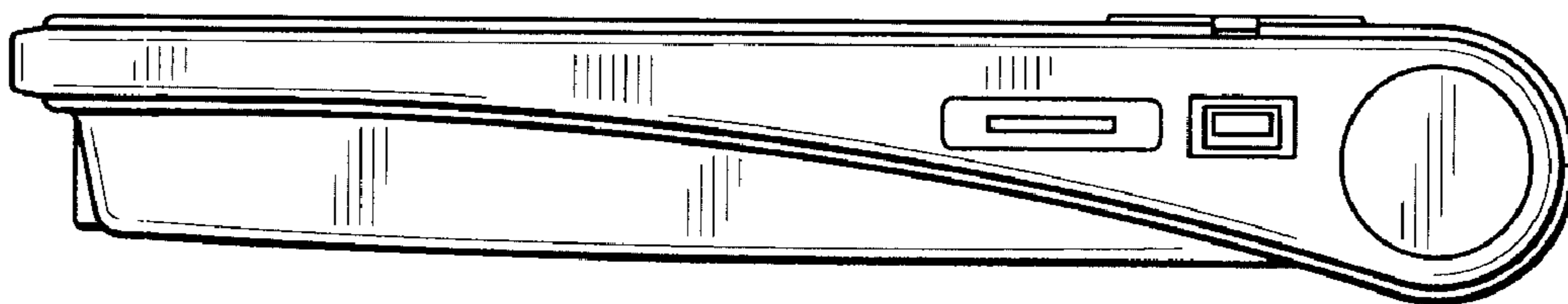

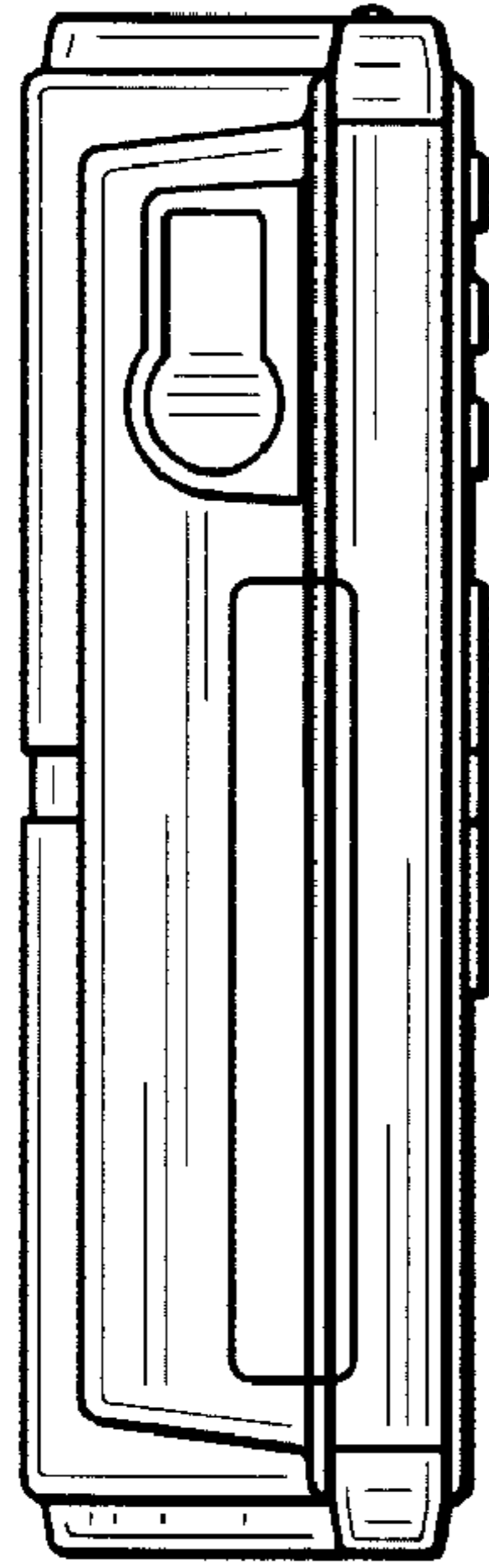

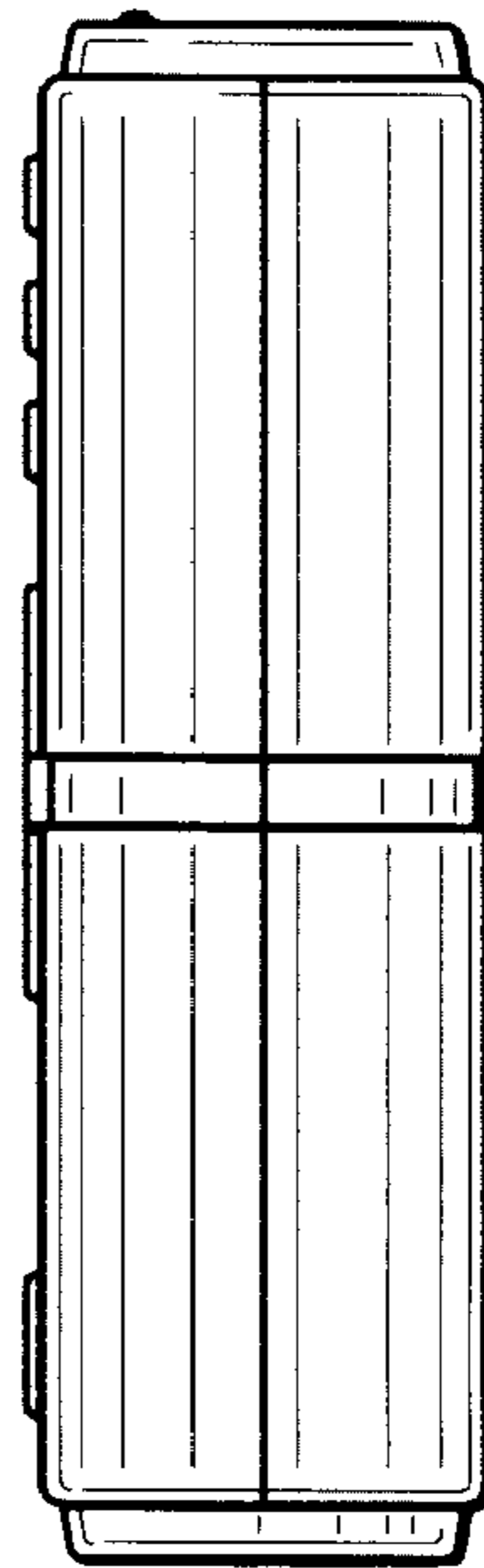

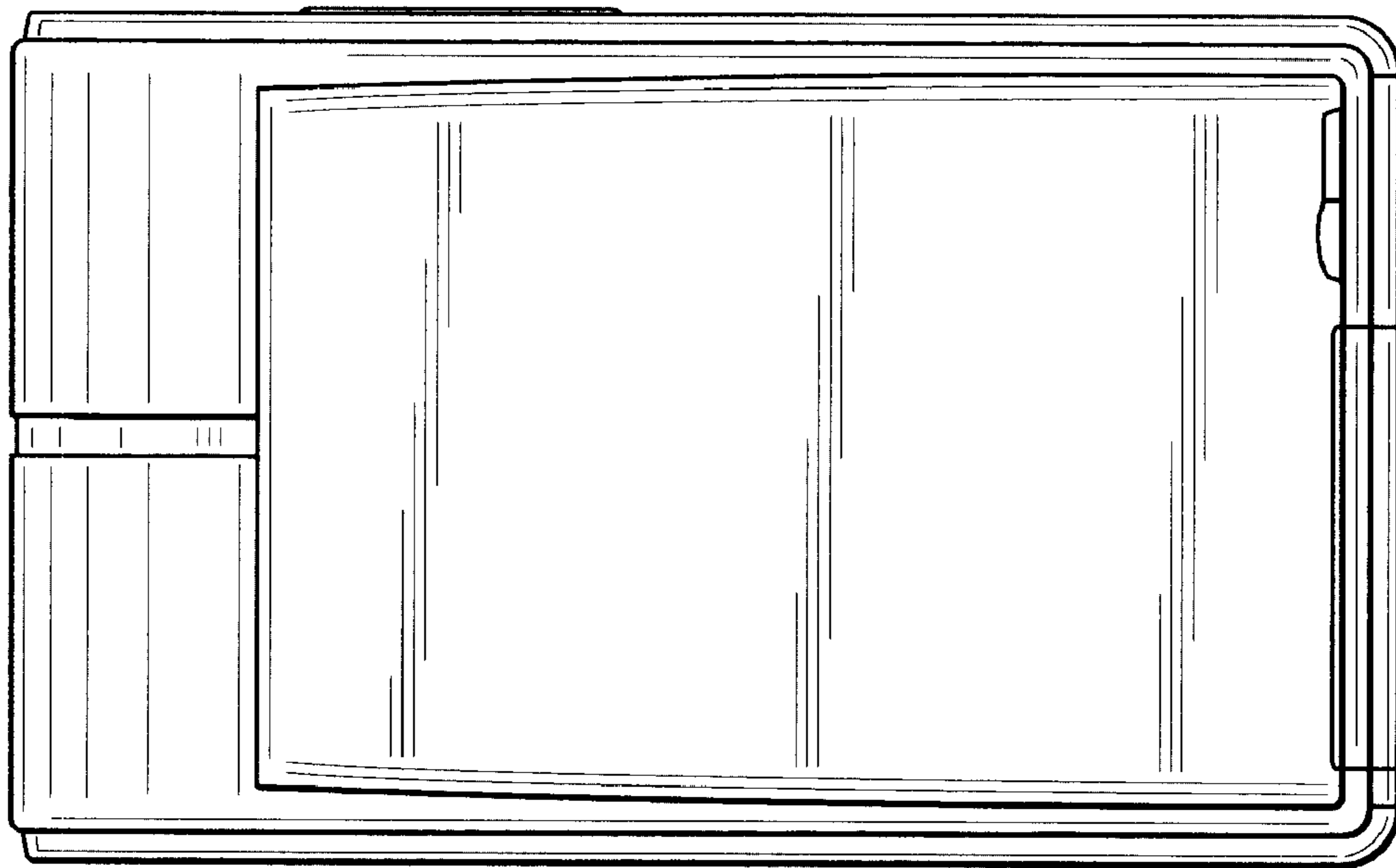
